FIG. 3 is a rear view of the new design;

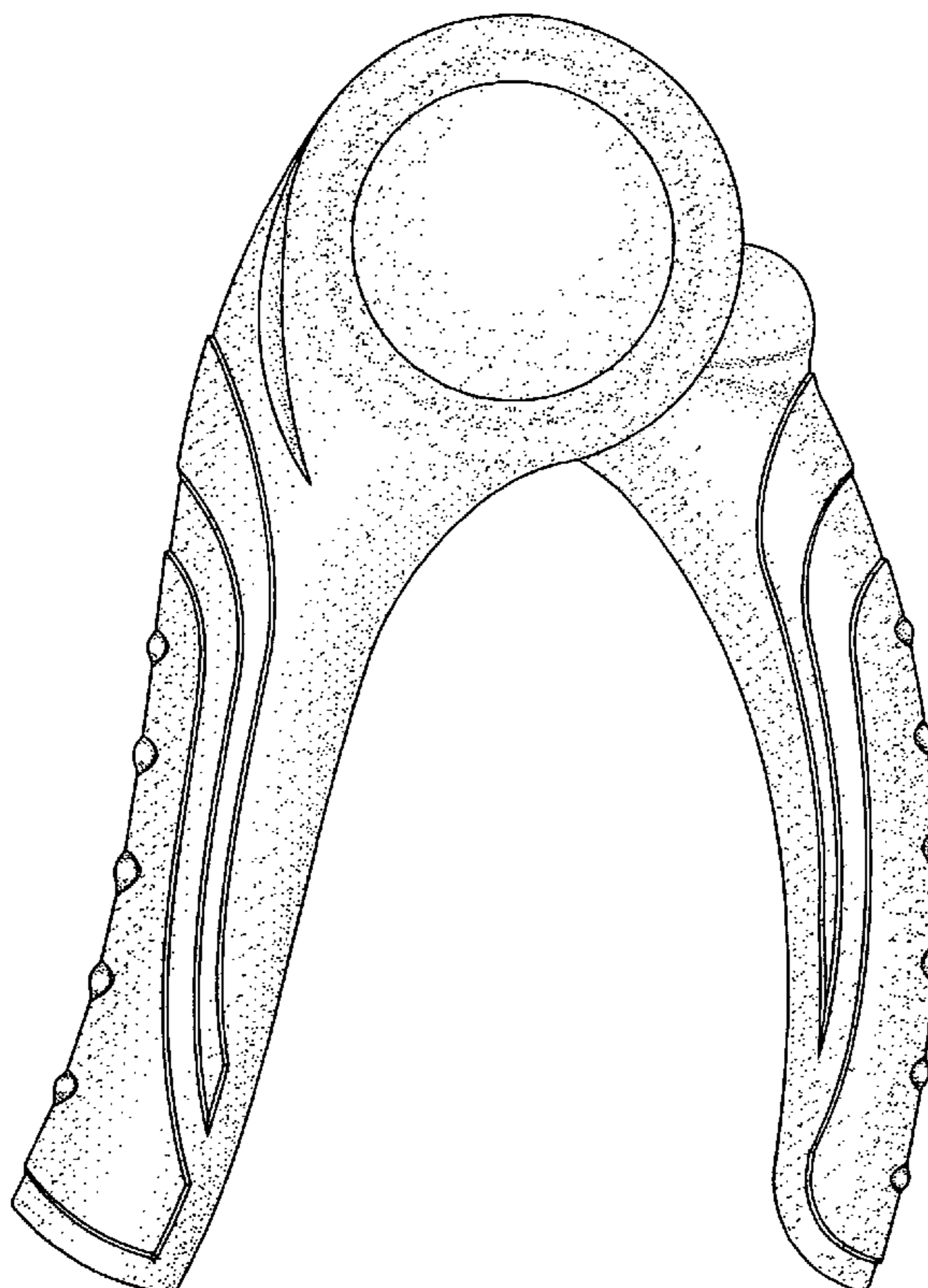
FIG. 4 is a left view of the new design;

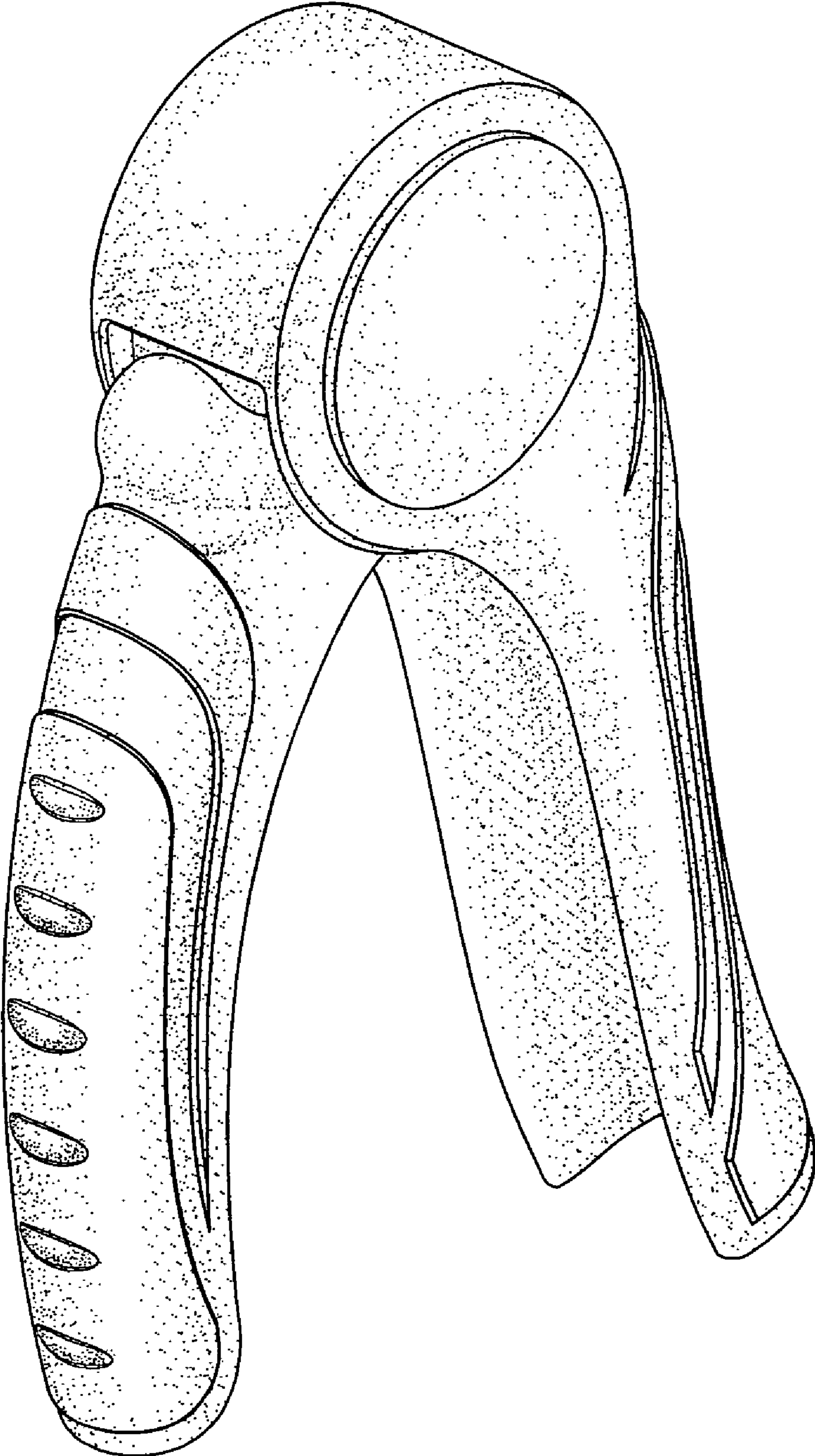

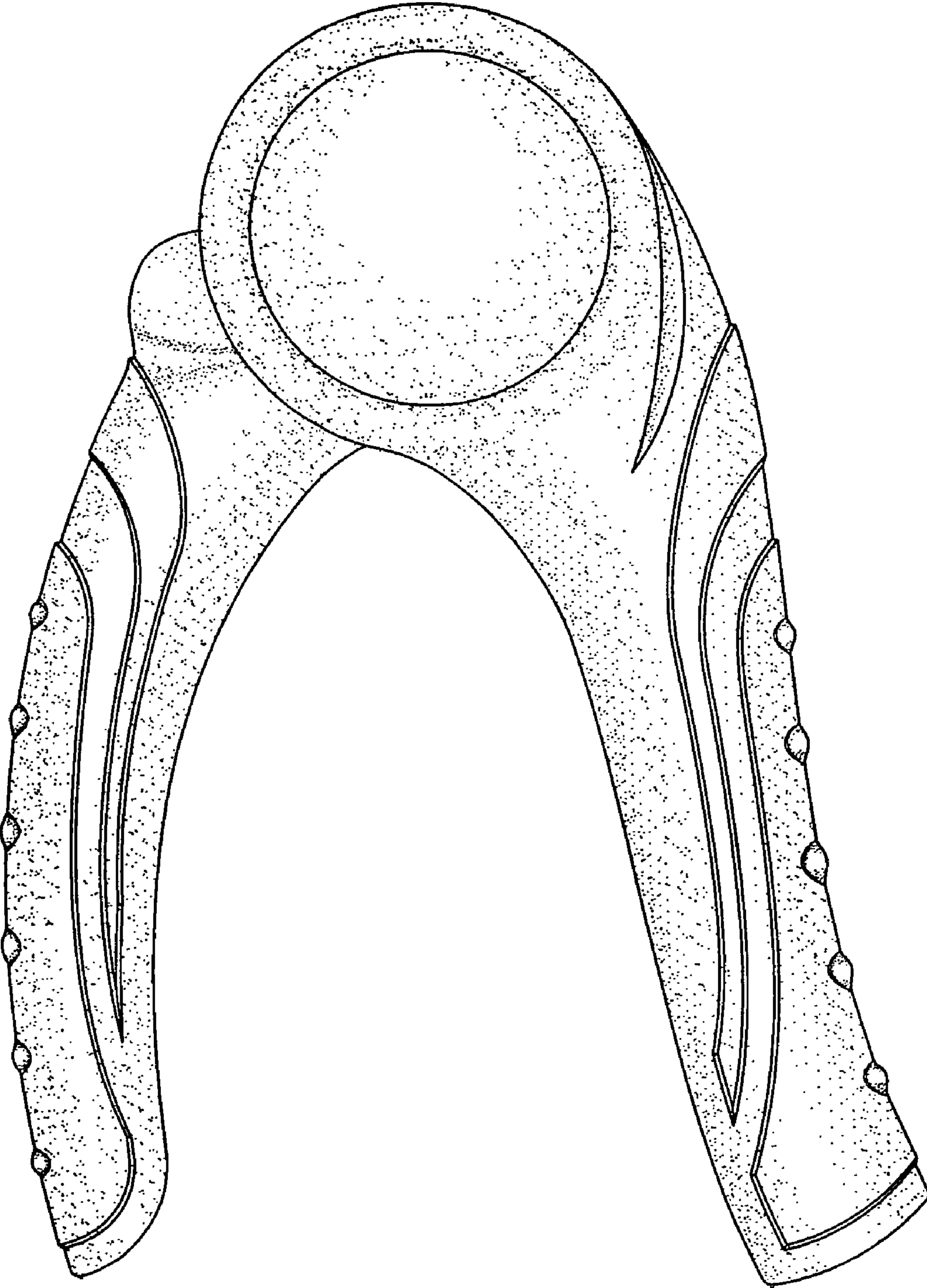

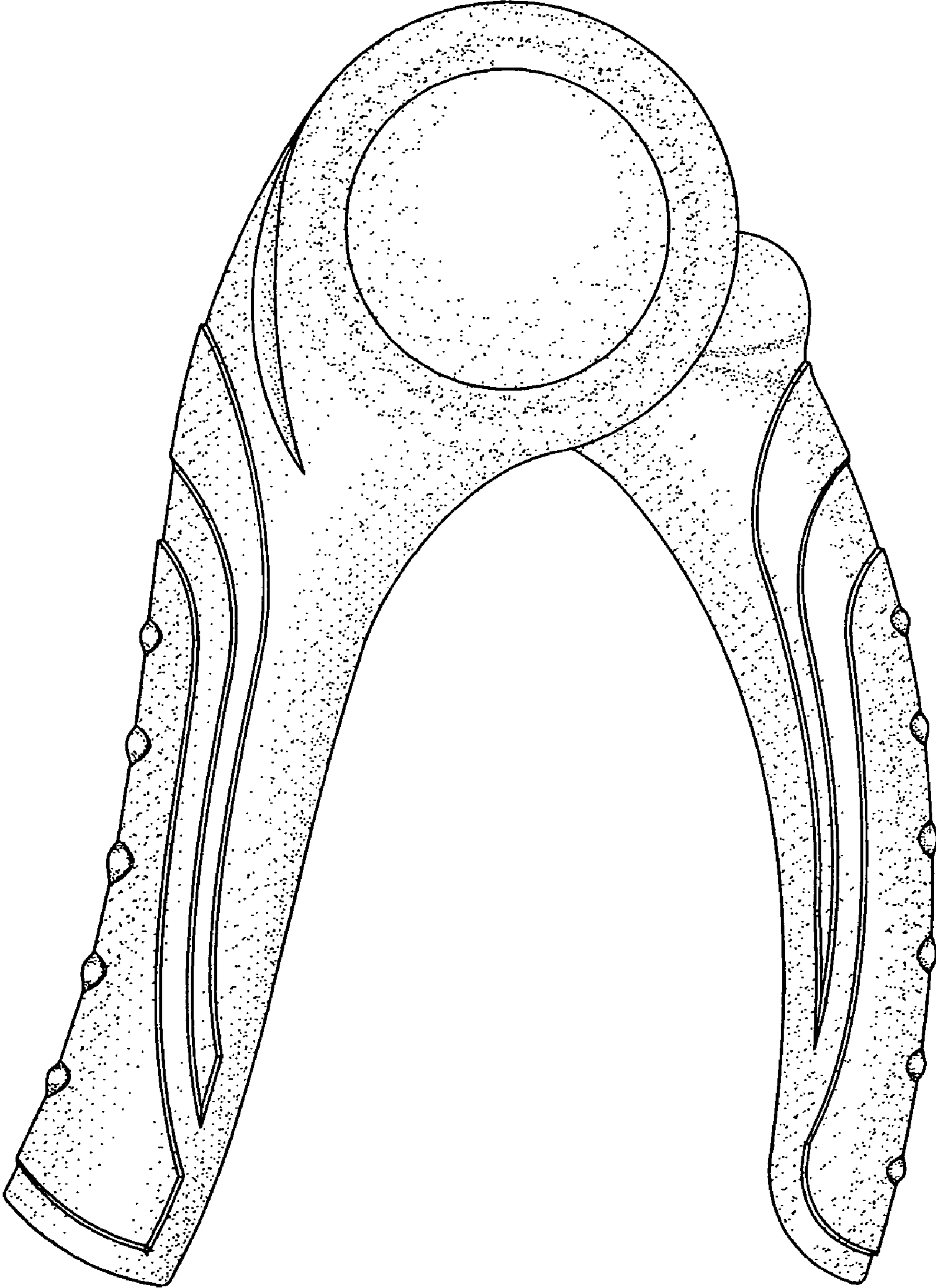

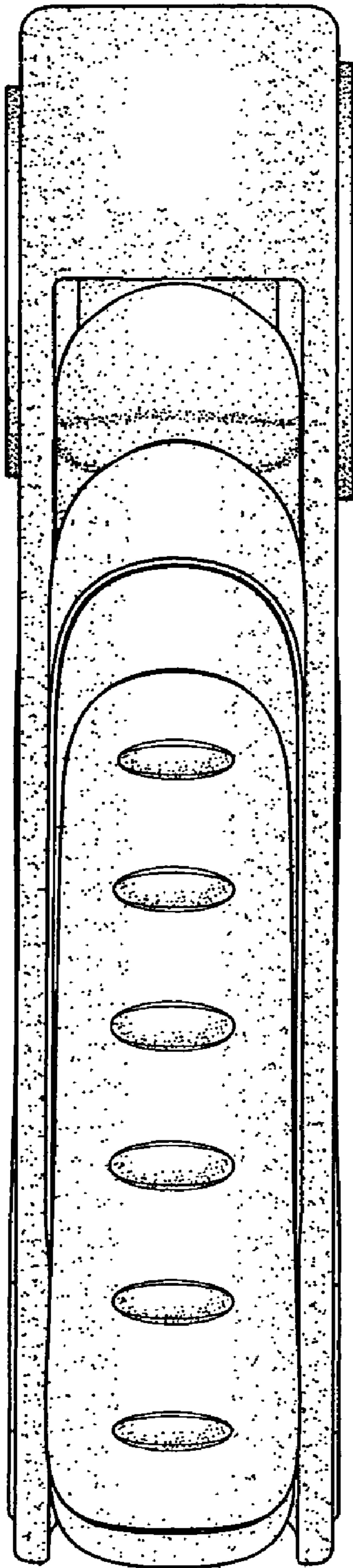

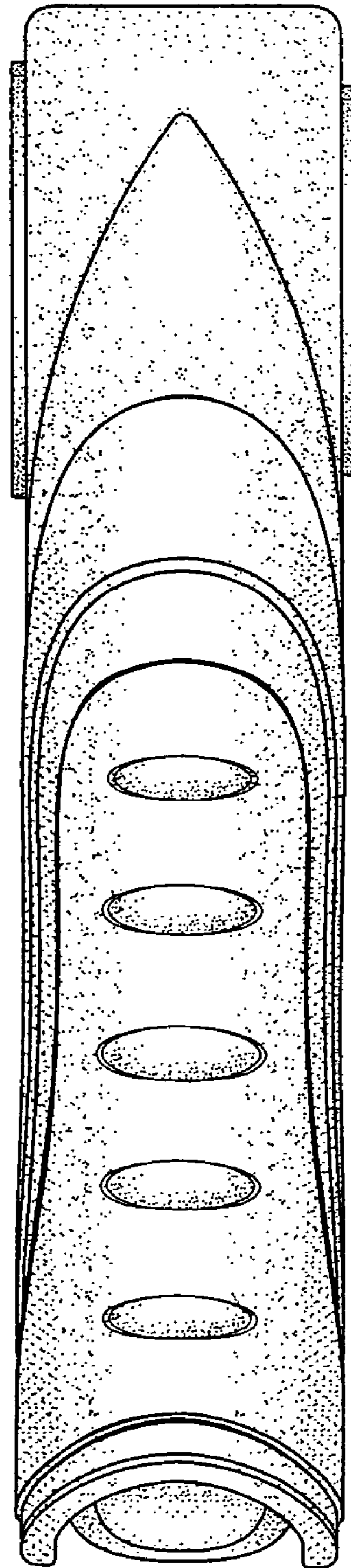

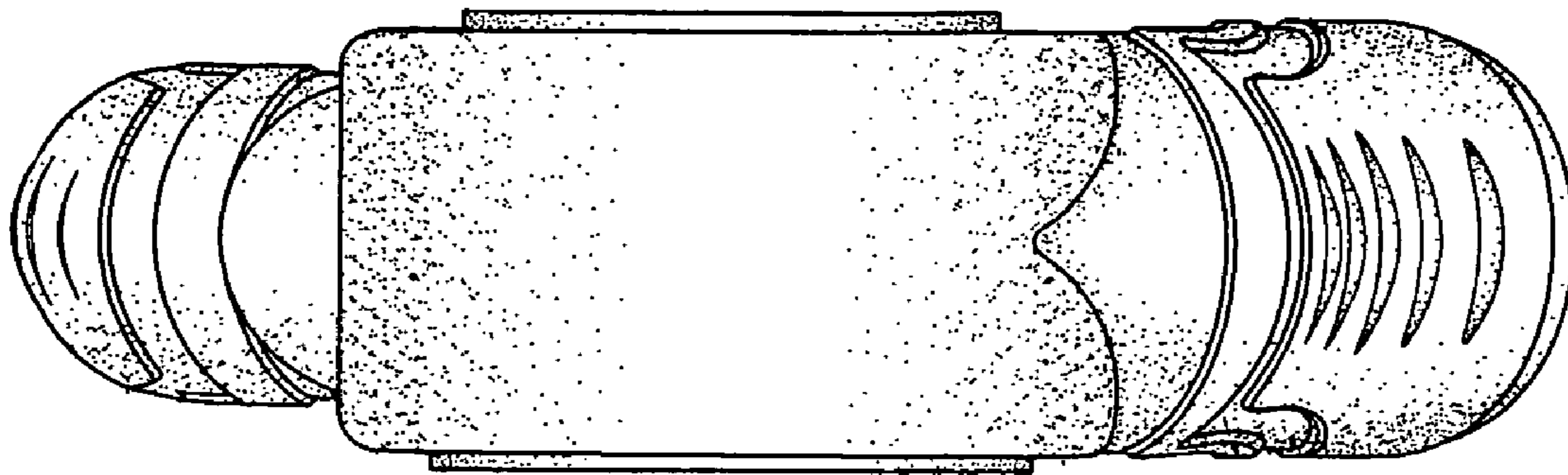

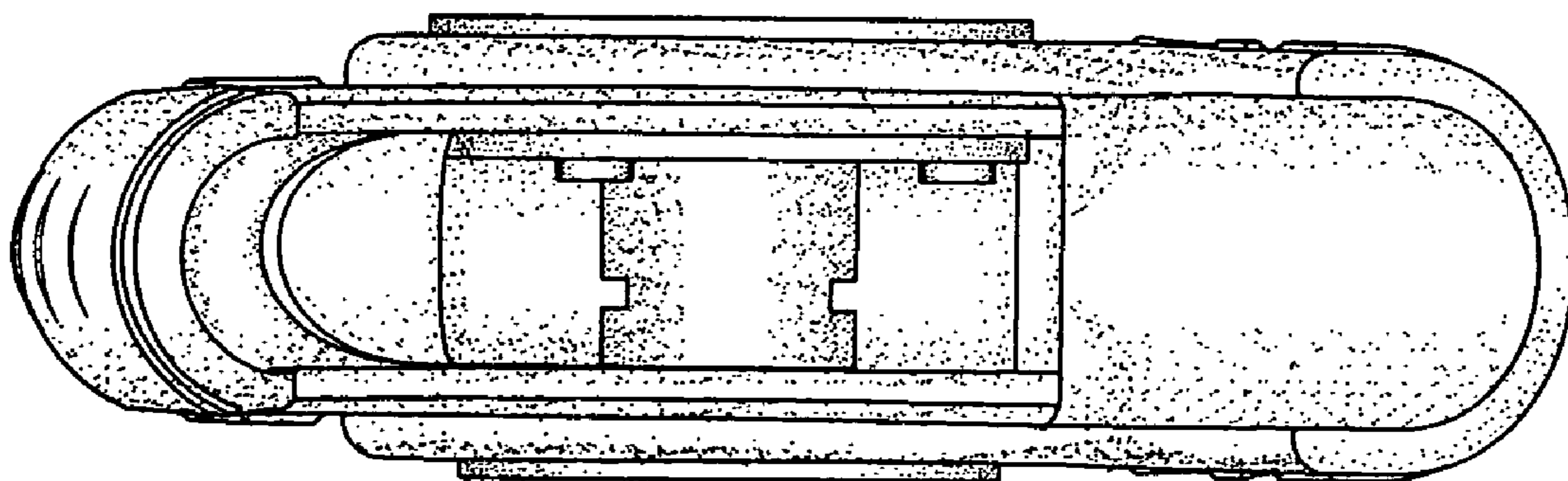
