FIG. 4 is a side elevation view thereof;

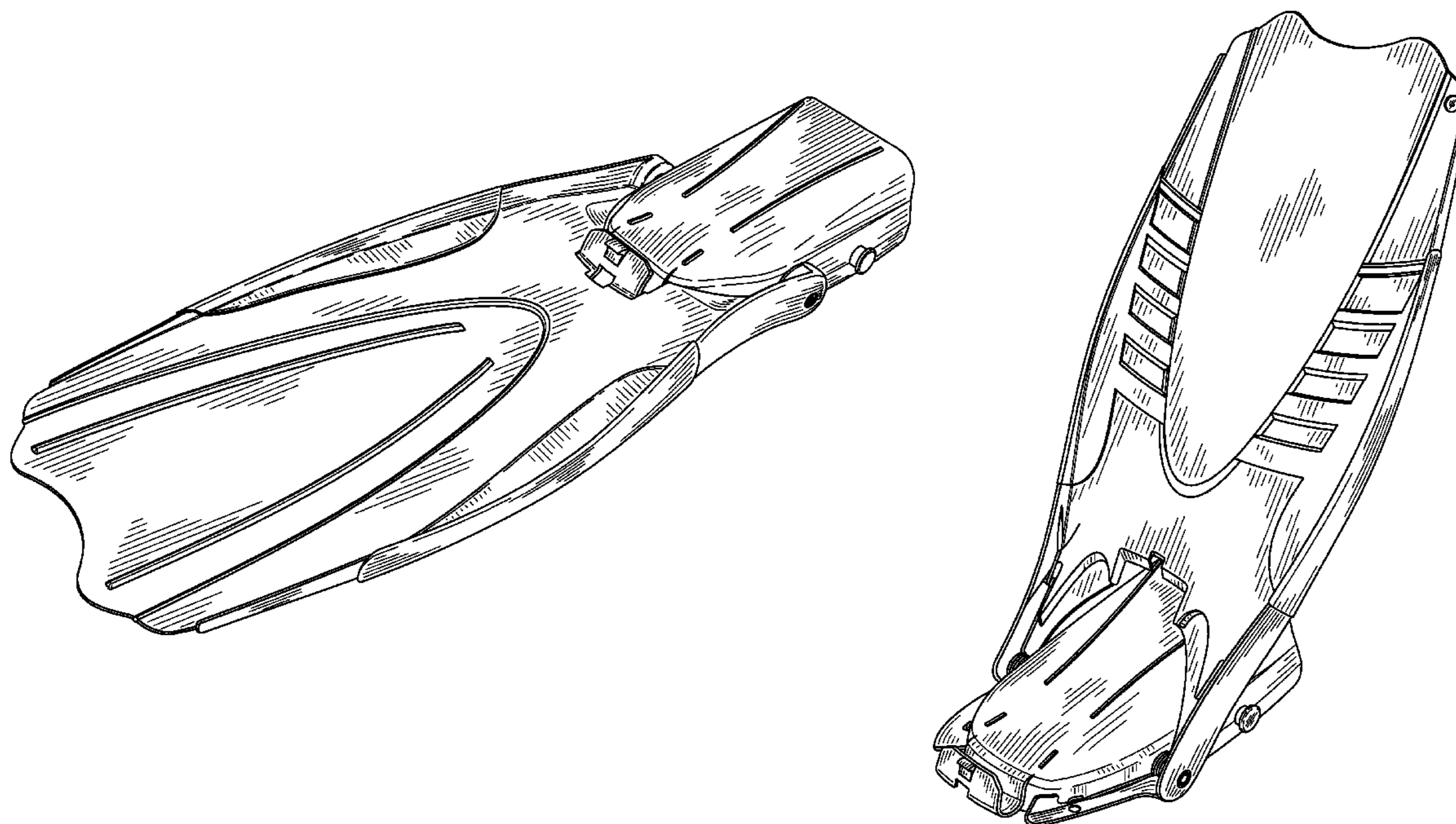
FIG. 5 is a second side elevation view thereof;

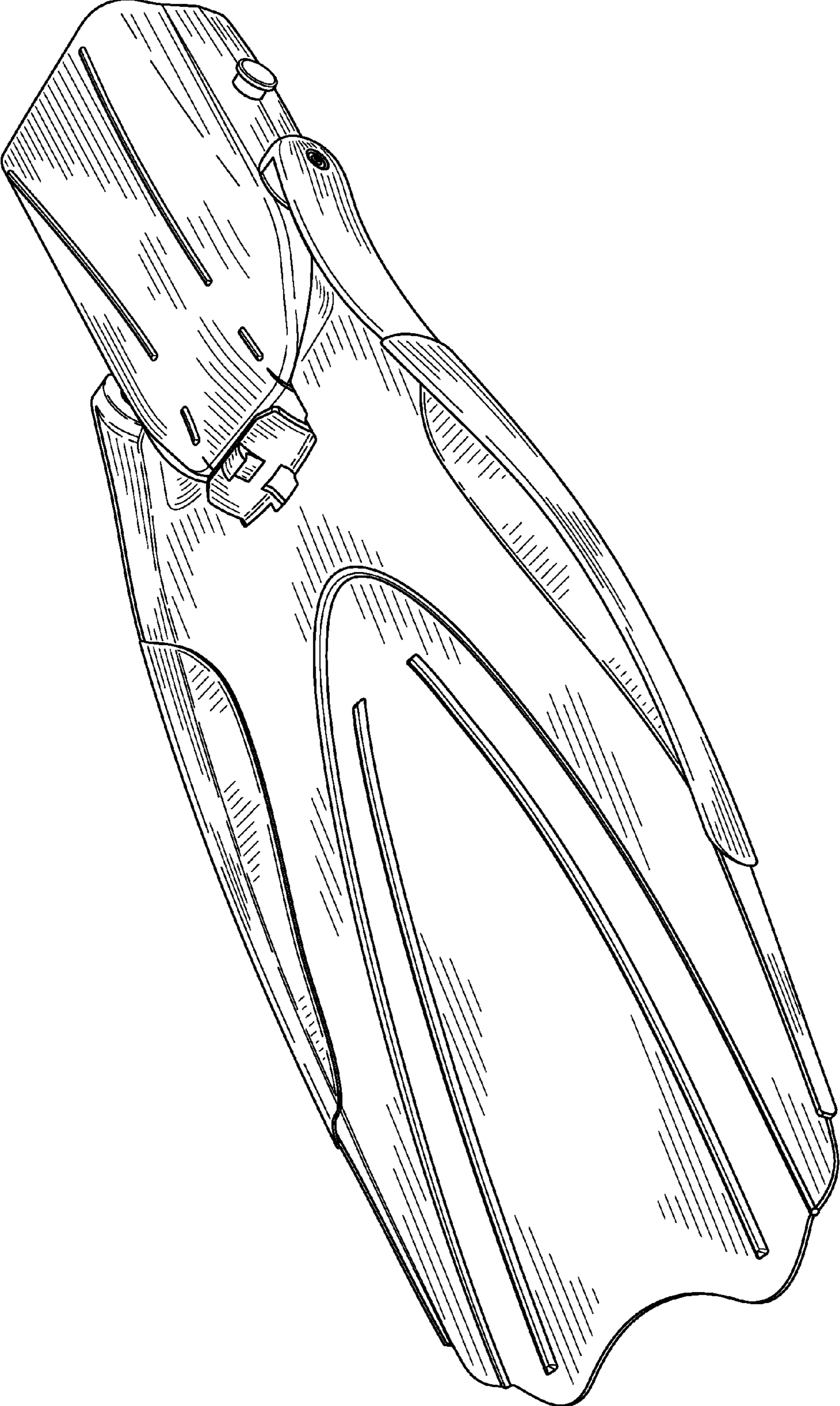

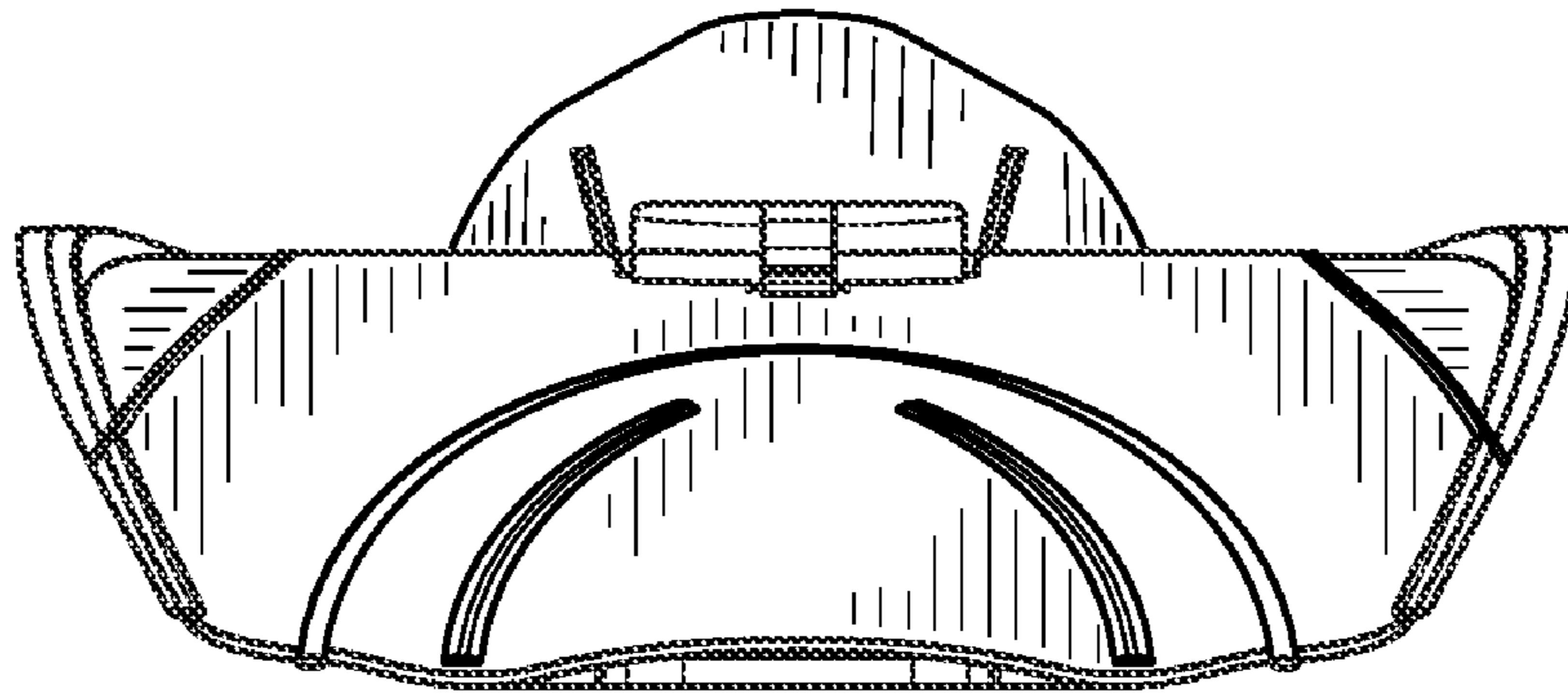

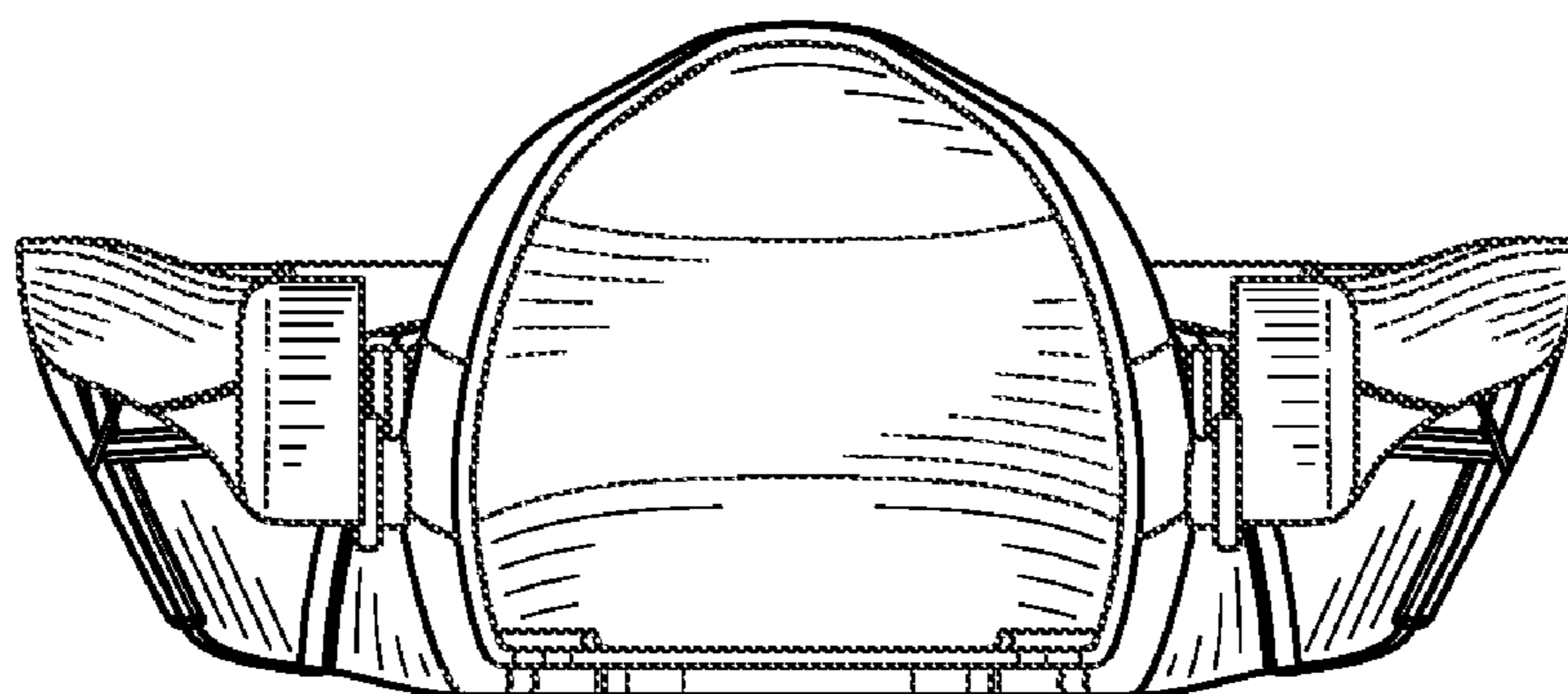

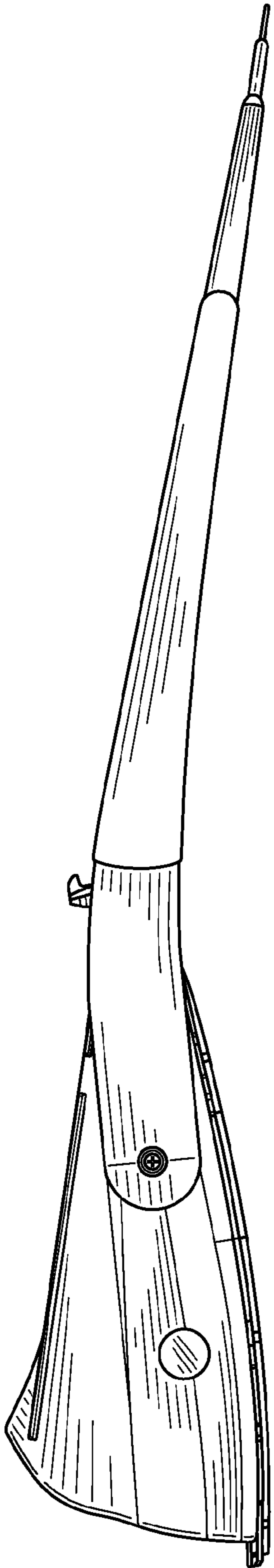

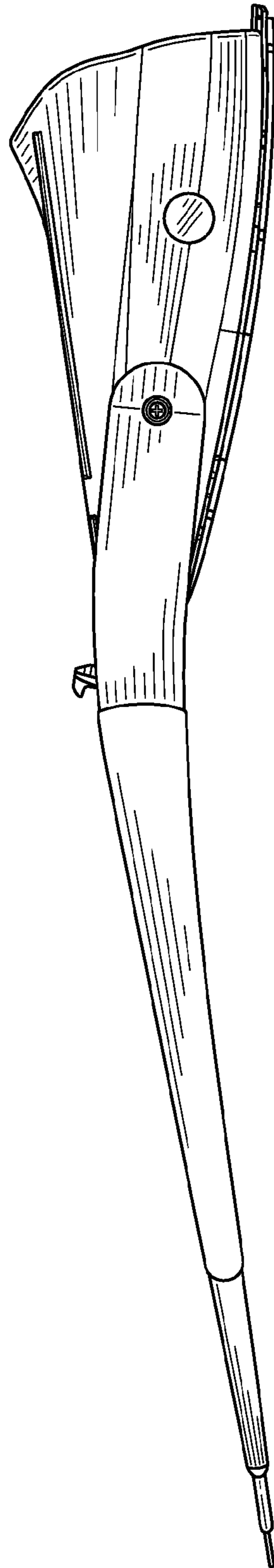

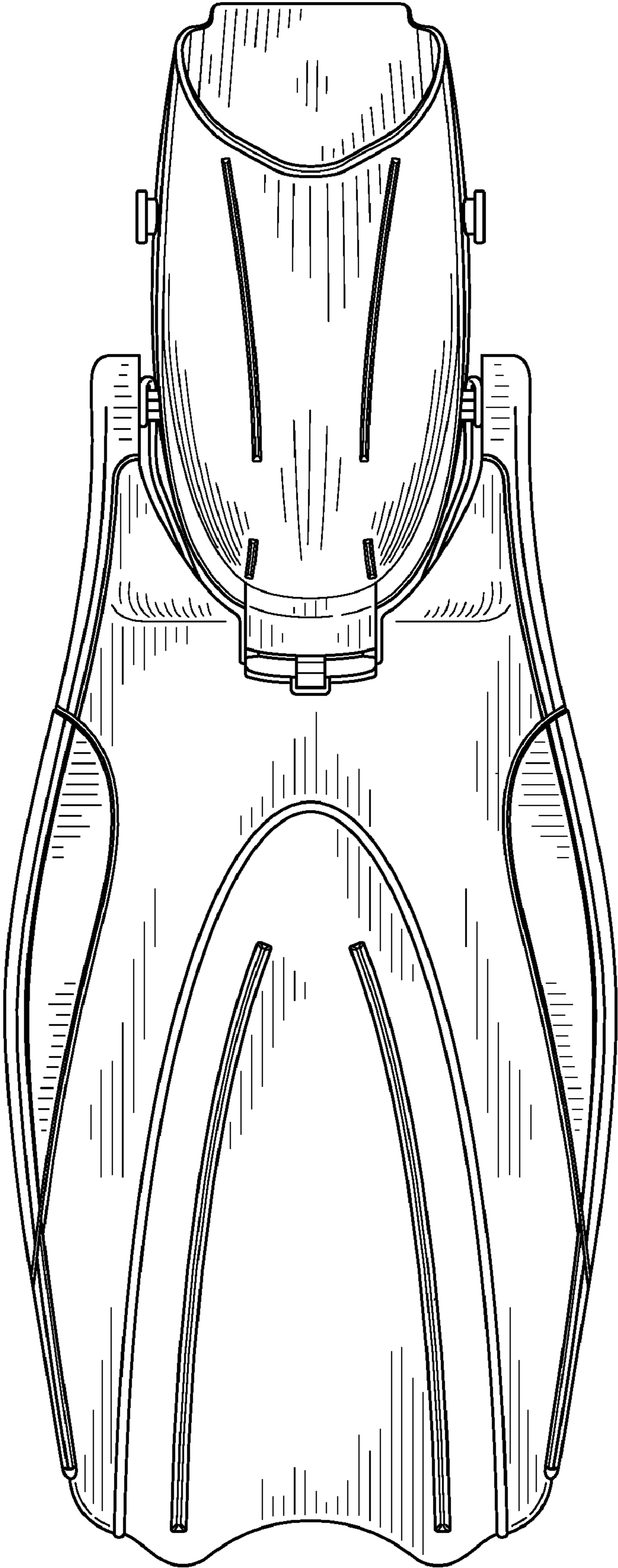

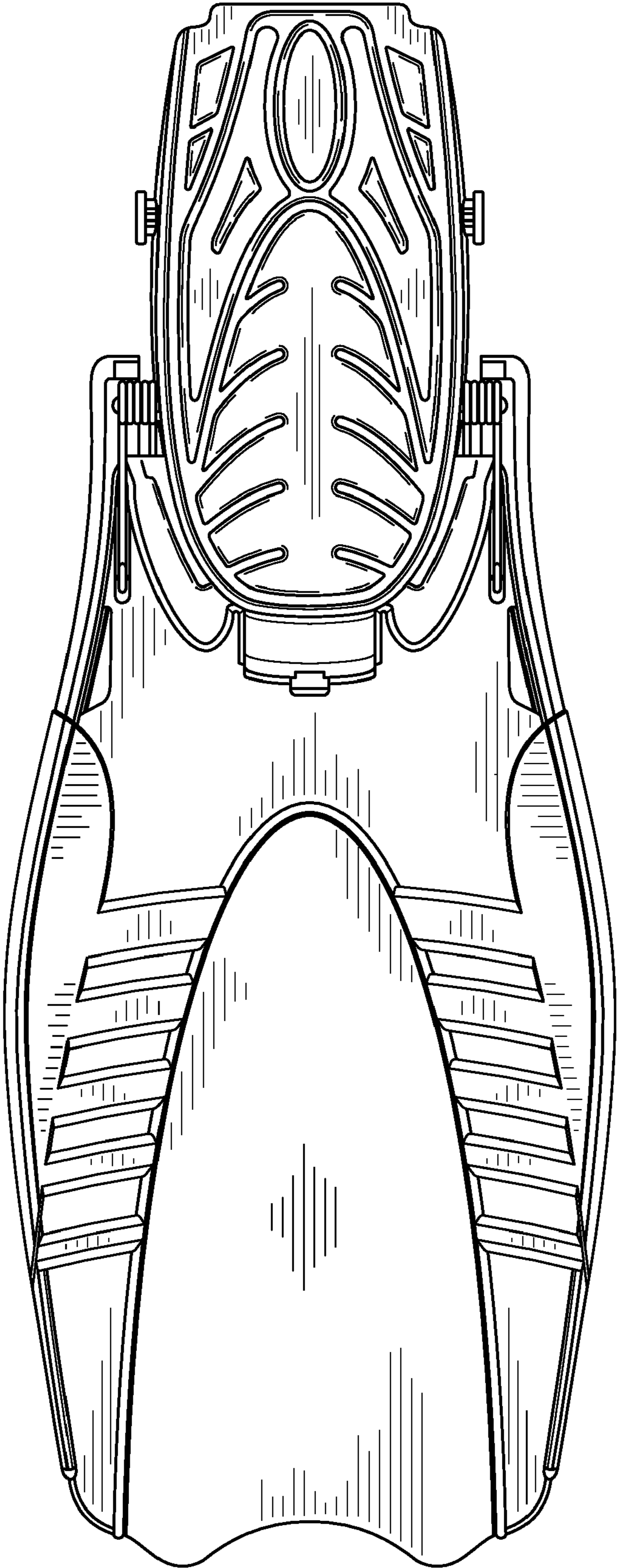

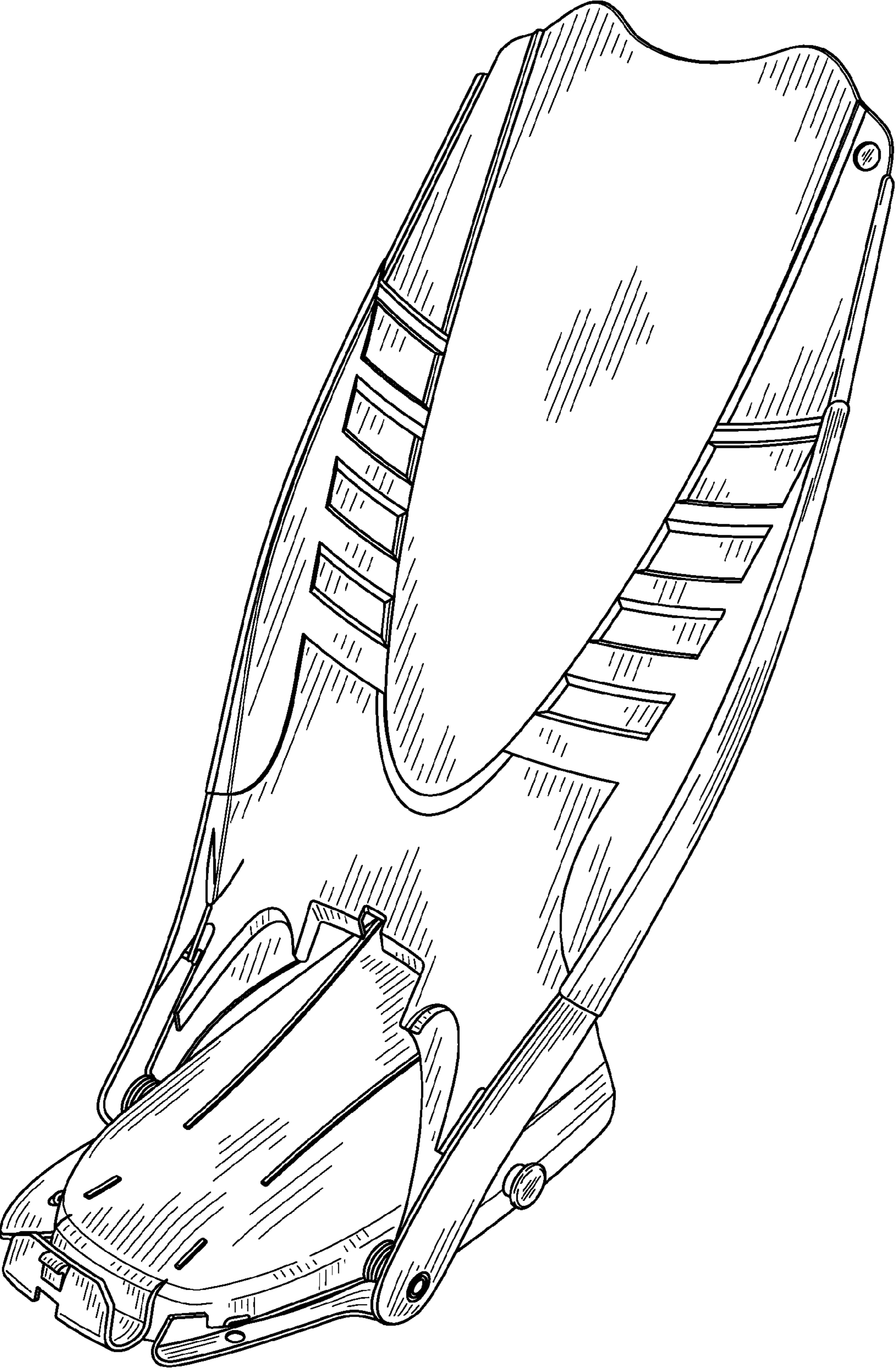
