(57) **CLAIM**

The ornamental design for a hair trimmer, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hair trimmer as it would appear with the cover on;

FIG. 2 is an elevation view of the front of the hair trimmer as it would appear with the cover on;

FIG. 3 is an elevation view of the rear of the hair trimmer as it would appear with the cover on;

FIG. 4 is a plan view of the bottom of the hair trimmer as it would appear with the cover on;

FIG. 5 is a plan view of the top of the hair trimmer as it would appear with the cover on;

FIG. 6 is an elevation view of one side of the hair trimmer as it would appear with the cover on;

FIG. 7 is an elevation view of the other side of the hair trimmer, as it would appear with the cover on;

FIG. 8 is a perspective view of the hair trimmer as it would appear with the cover removed;

FIG. 9 is an elevation view of the front of the hair trimmer as it would appear with the cover removed;

FIG. 10 is an elevation view of the rear of the hair trimmer as it would appear with the cover removed;

FIG. 11 is a plan view of the bottom of the hair trimmer as it would appear with the cover removed;

FIG. 12 is a plan view of the top of the hair trimmer as it would appear with the cover removed;

FIG. 13 is an elevation view of one side of the hair trimmer as it would appear with the cover removed; and,

FIG. 14 is an elevation view of the other side of the hair trimmer, as it would appear with the cover removed.

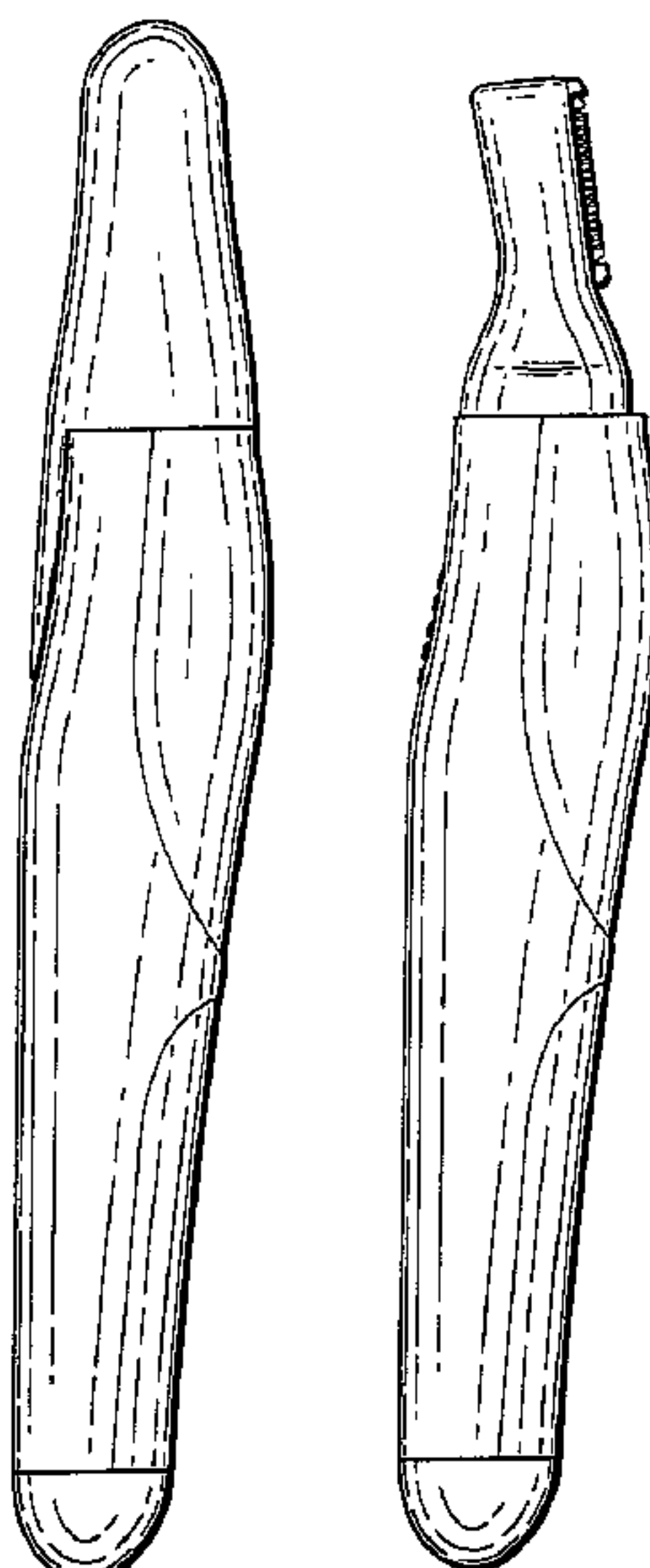

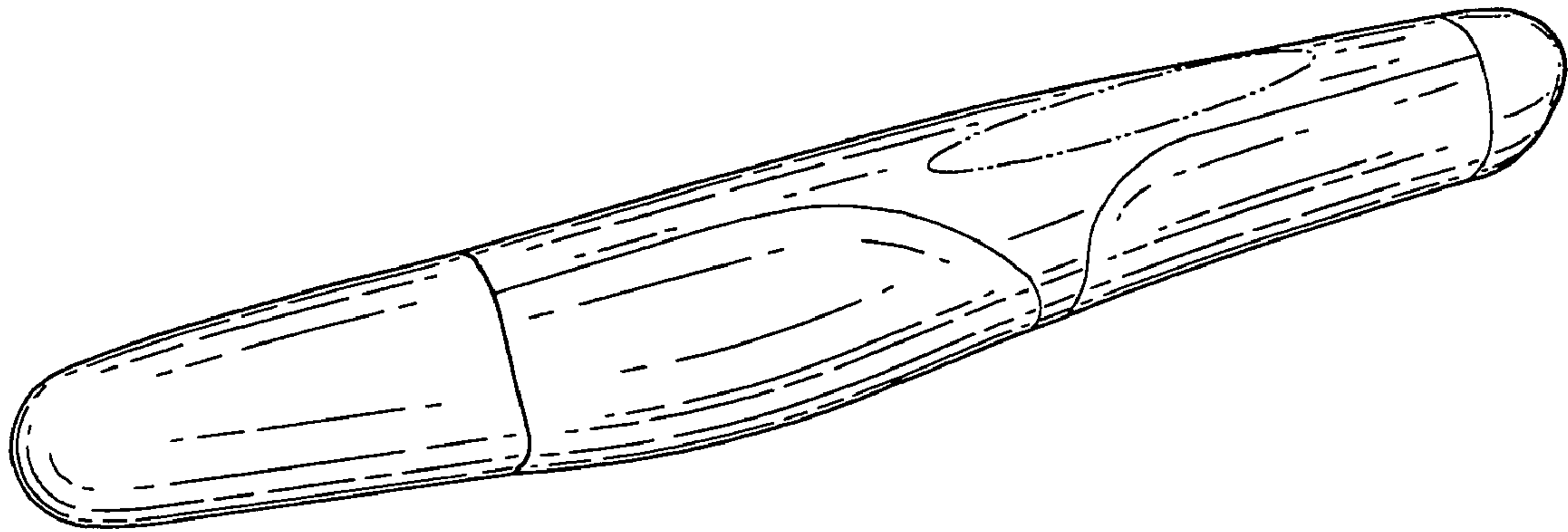

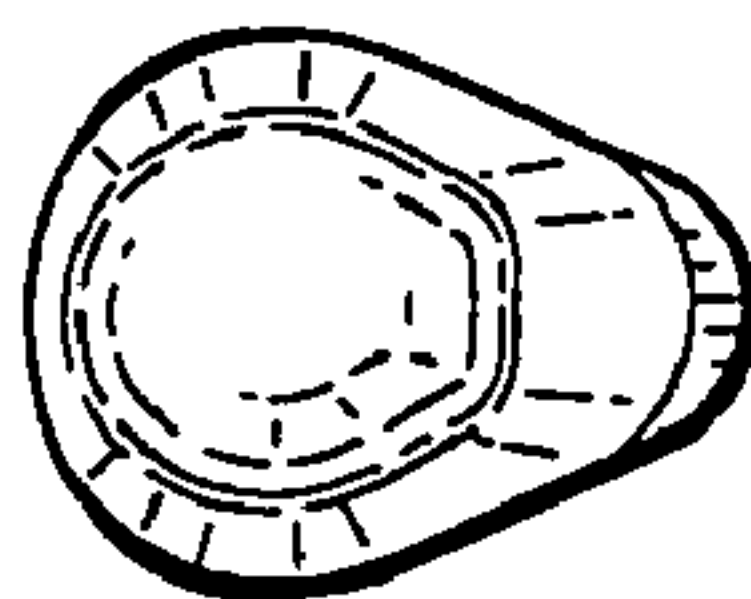

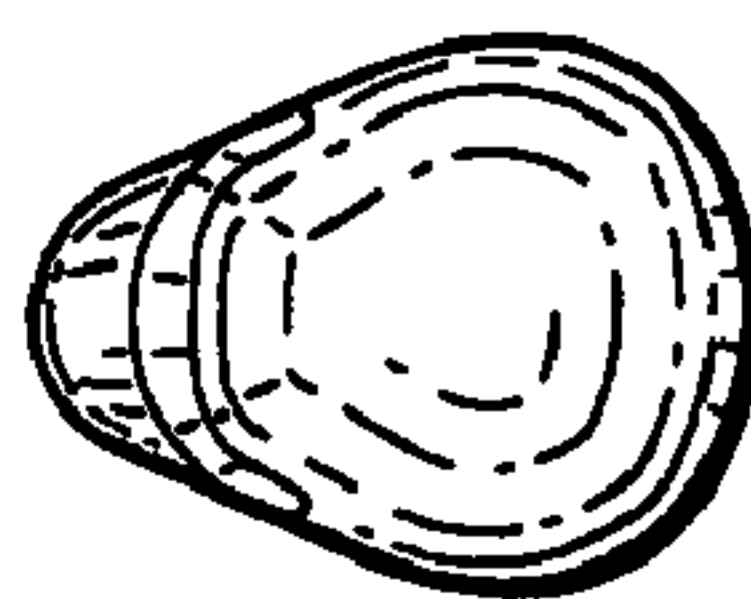

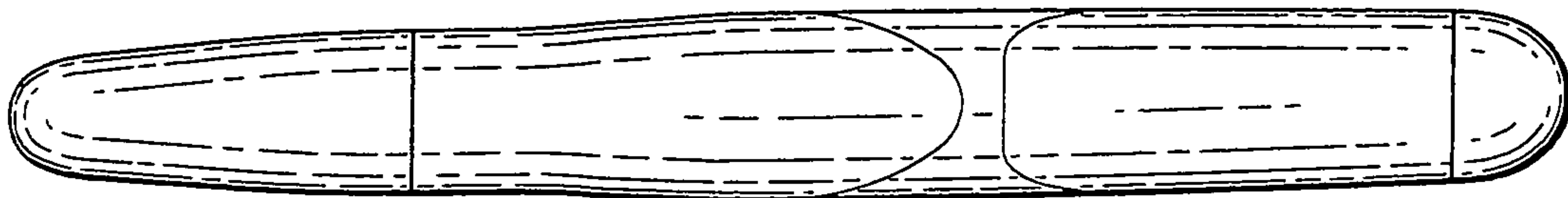

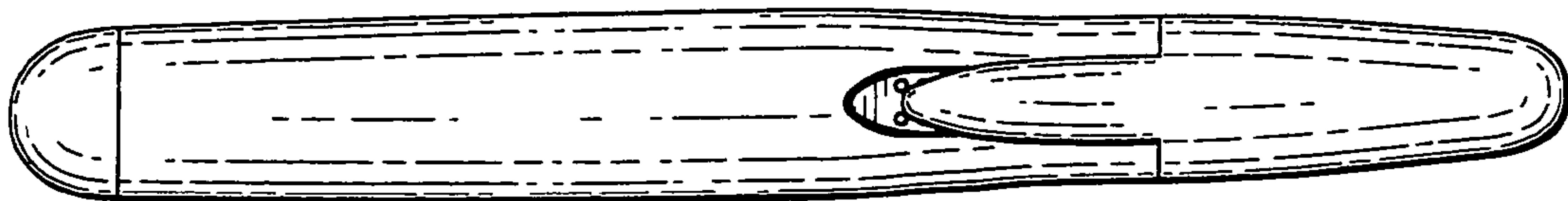

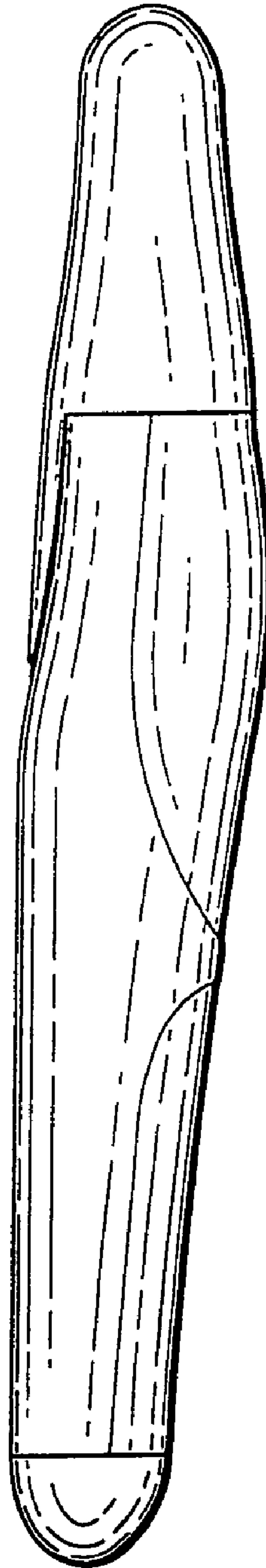

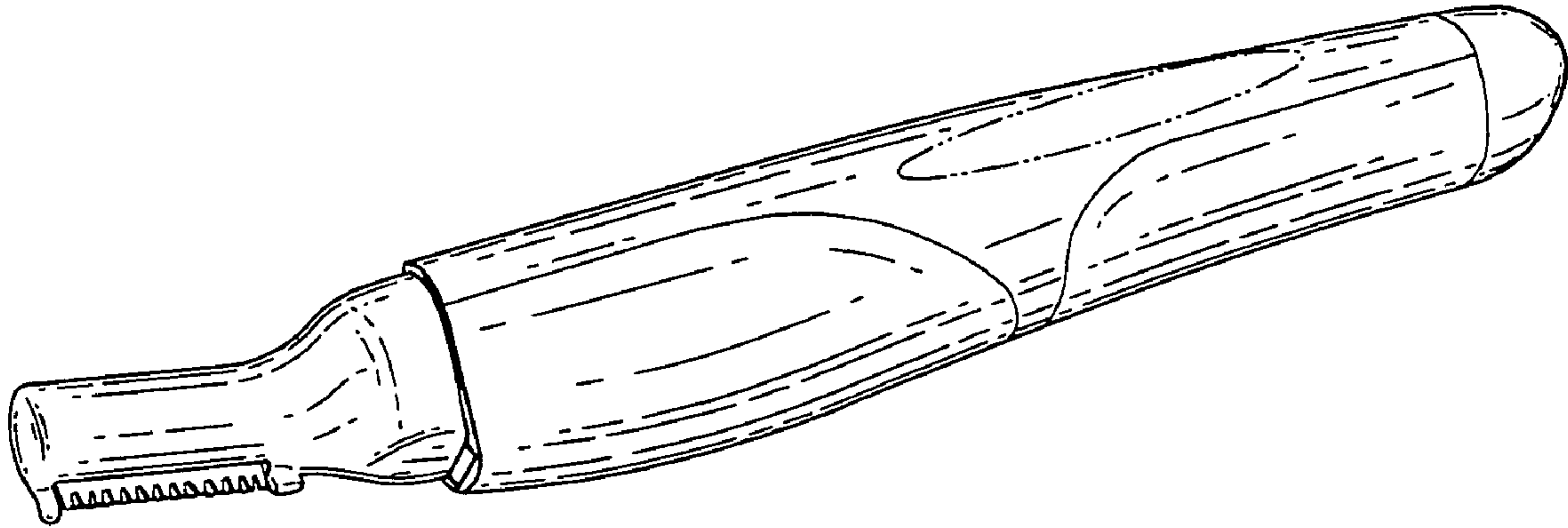

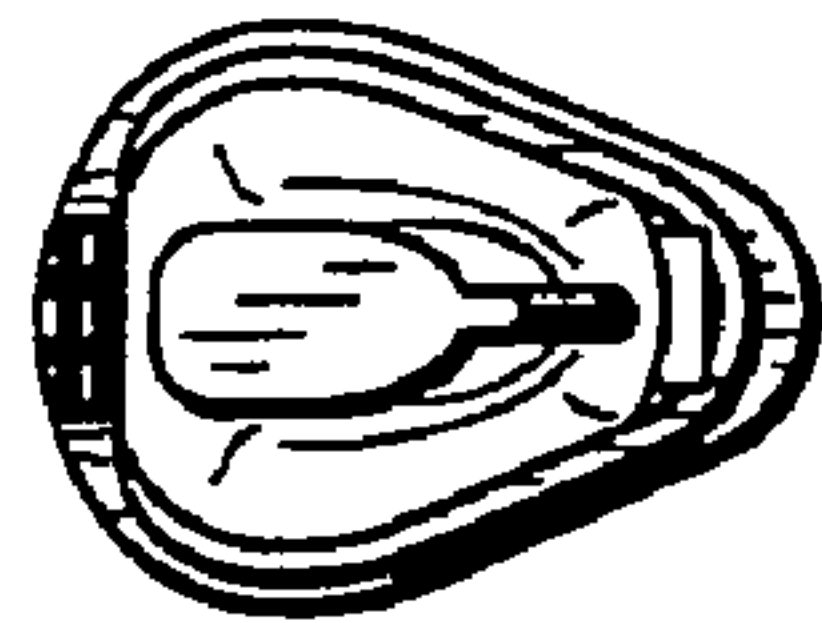

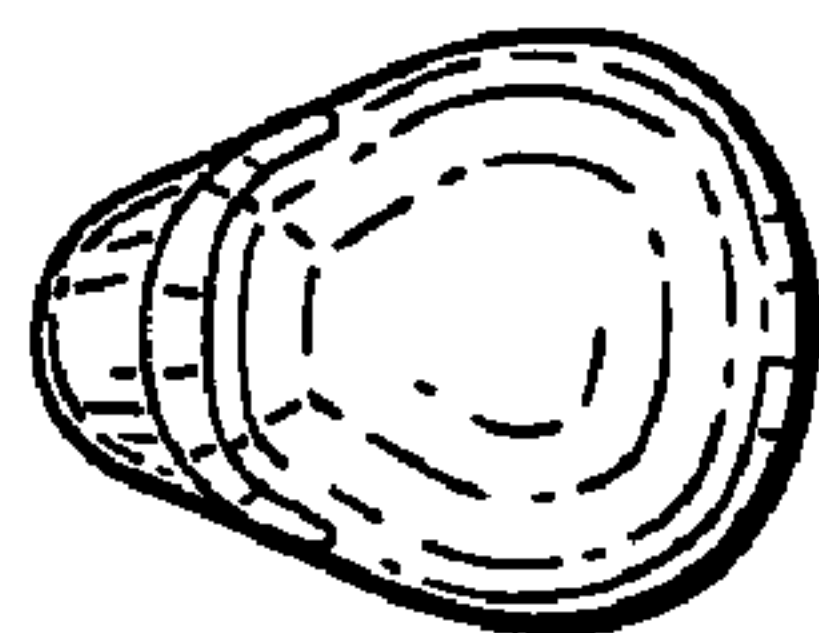

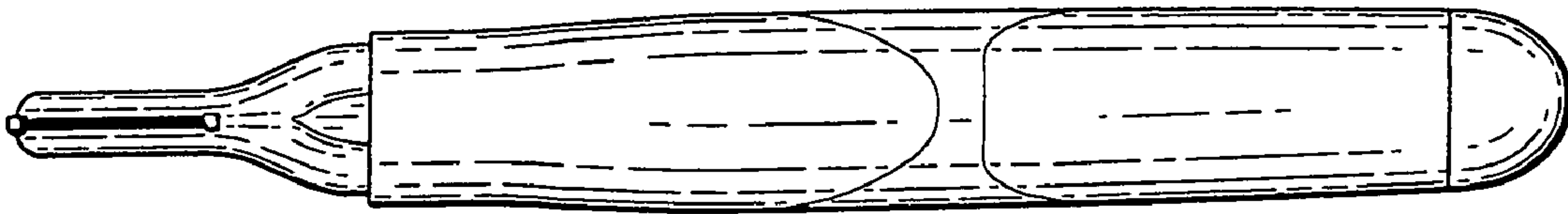

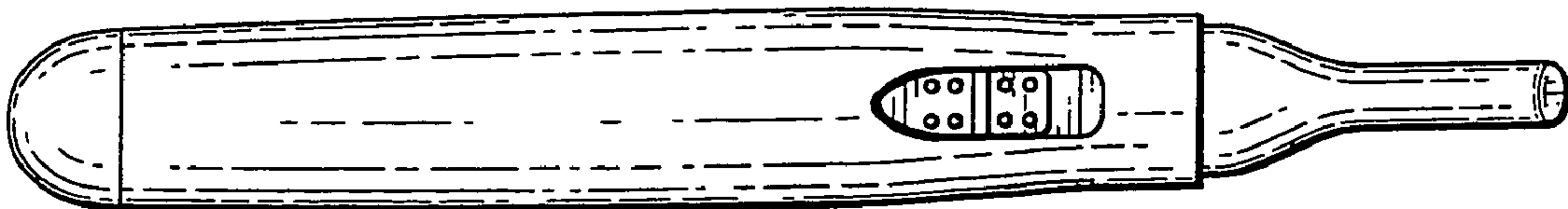

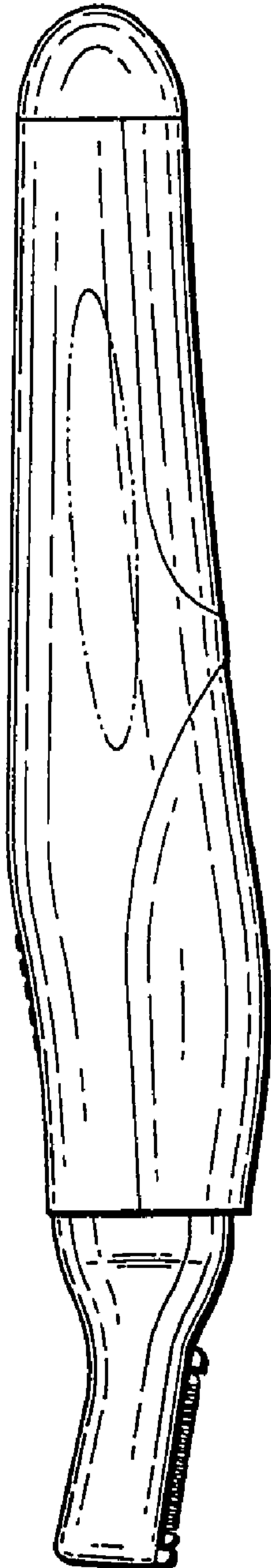
