(57) **CLAIM**

The ornamental design for a handle for a squeegee or the like, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper front left perspective view of a handle for a squeegee or the like showing our new design;

FIG. 2 is a right side elevational view thereof, the left side being a mirror image;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is an upper front left perspective view of a handle for a squeegee or the like showing another embodiment of our new design;

FIG. 8 is a right side elevational view of the design of FIG. 7, the left side being a mirror image;

FIG. 9 is a front elevational view of the design of FIG. 7;

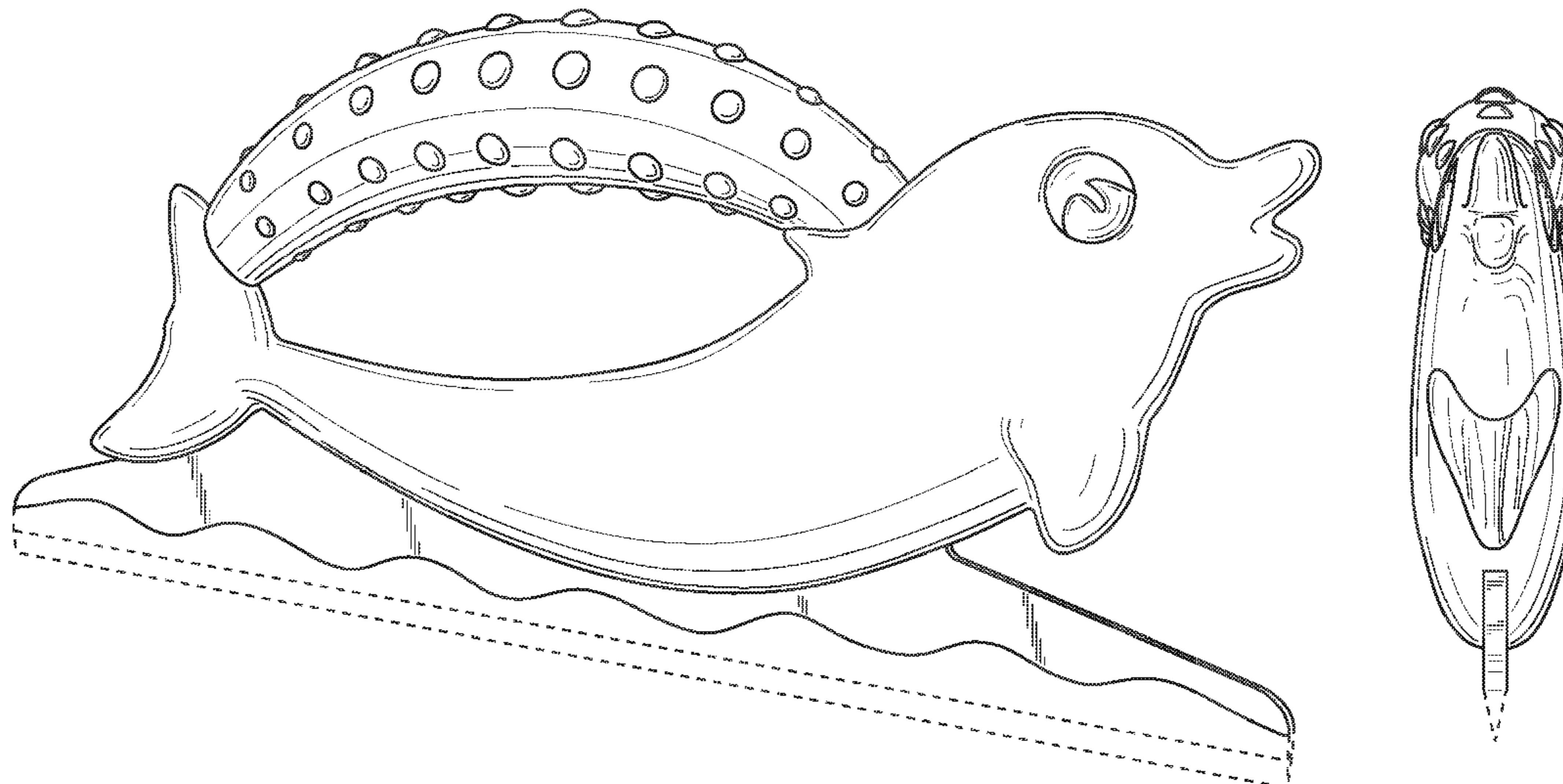
FIG. 10 is a rear elevational view of the design of FIG. 7;

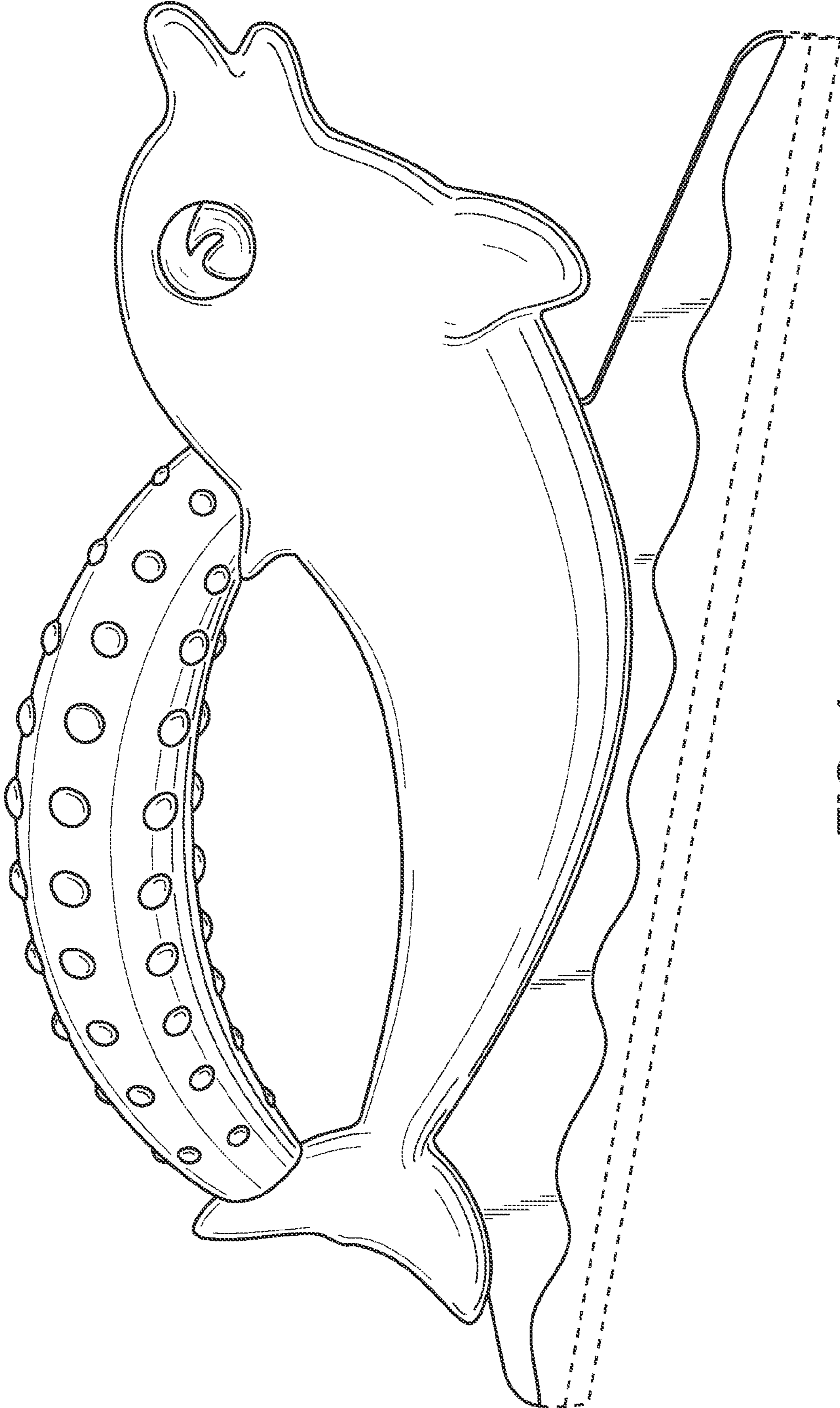

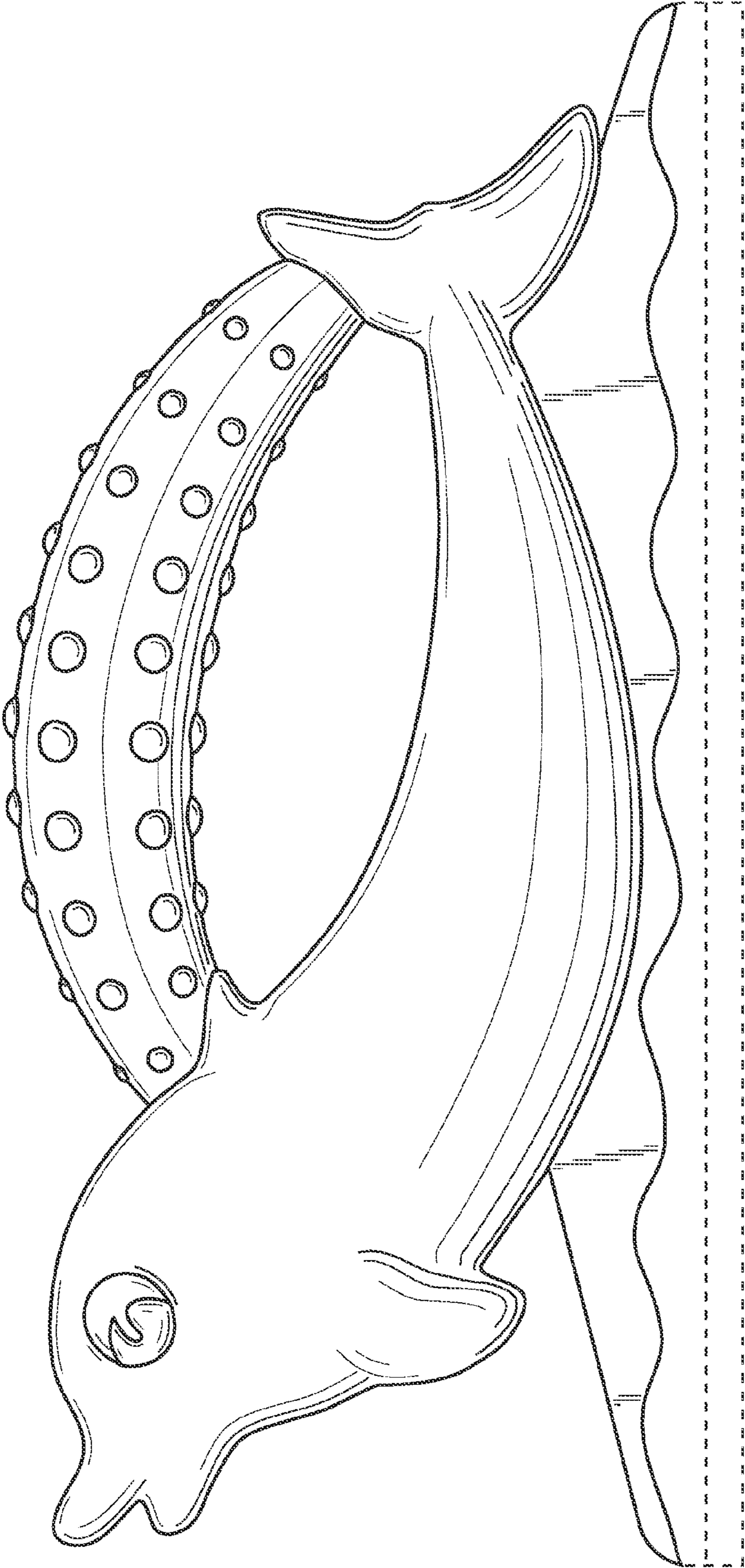
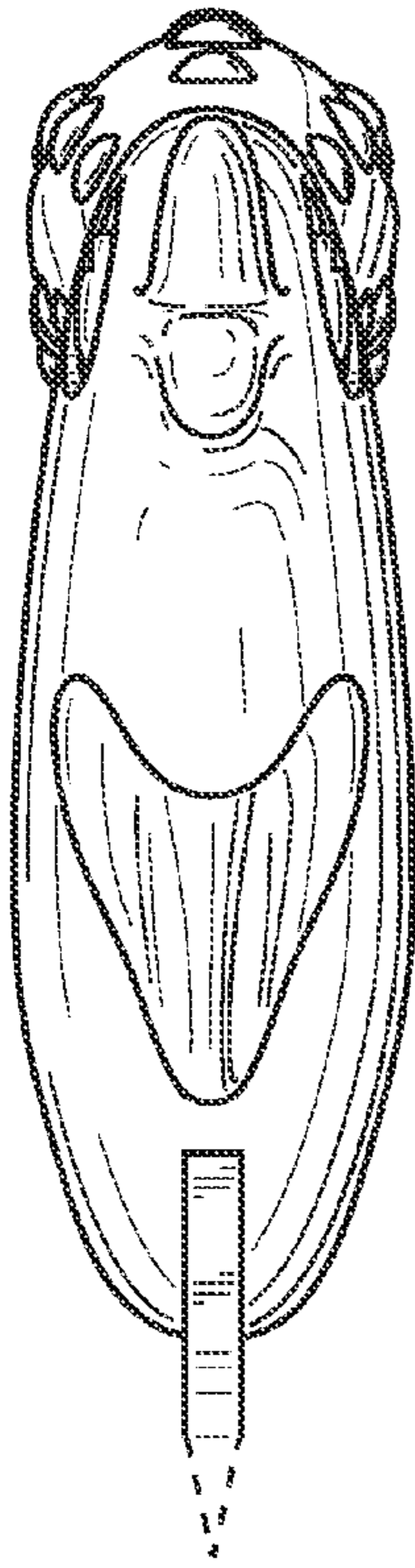
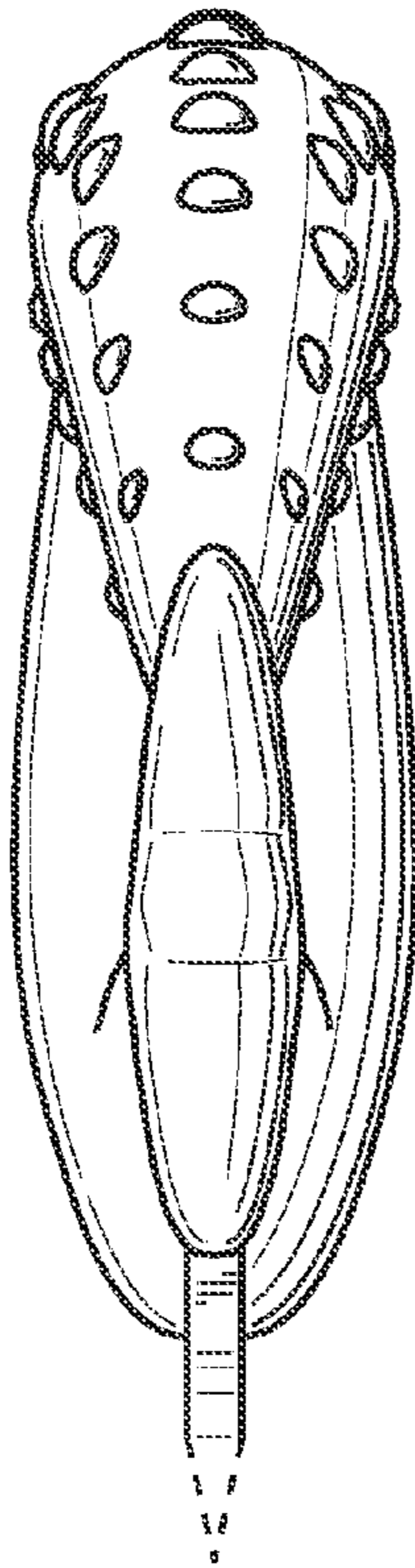


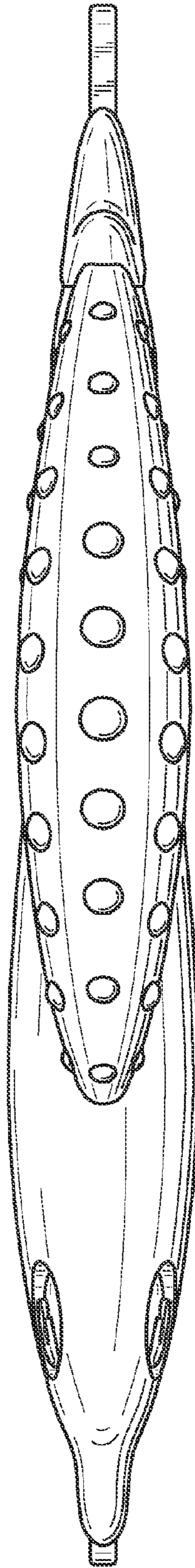

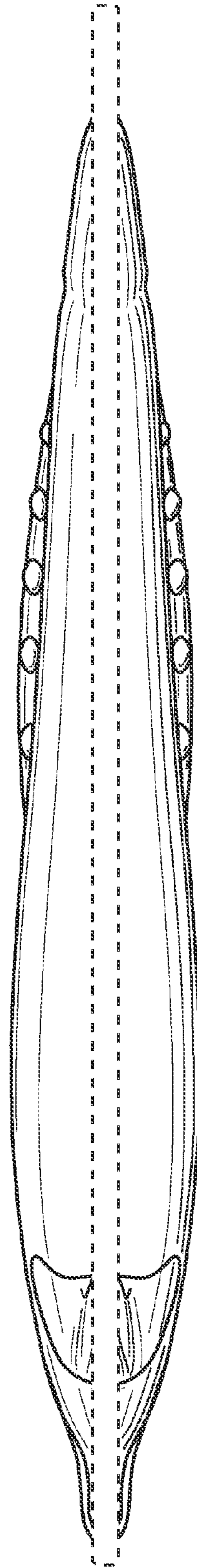

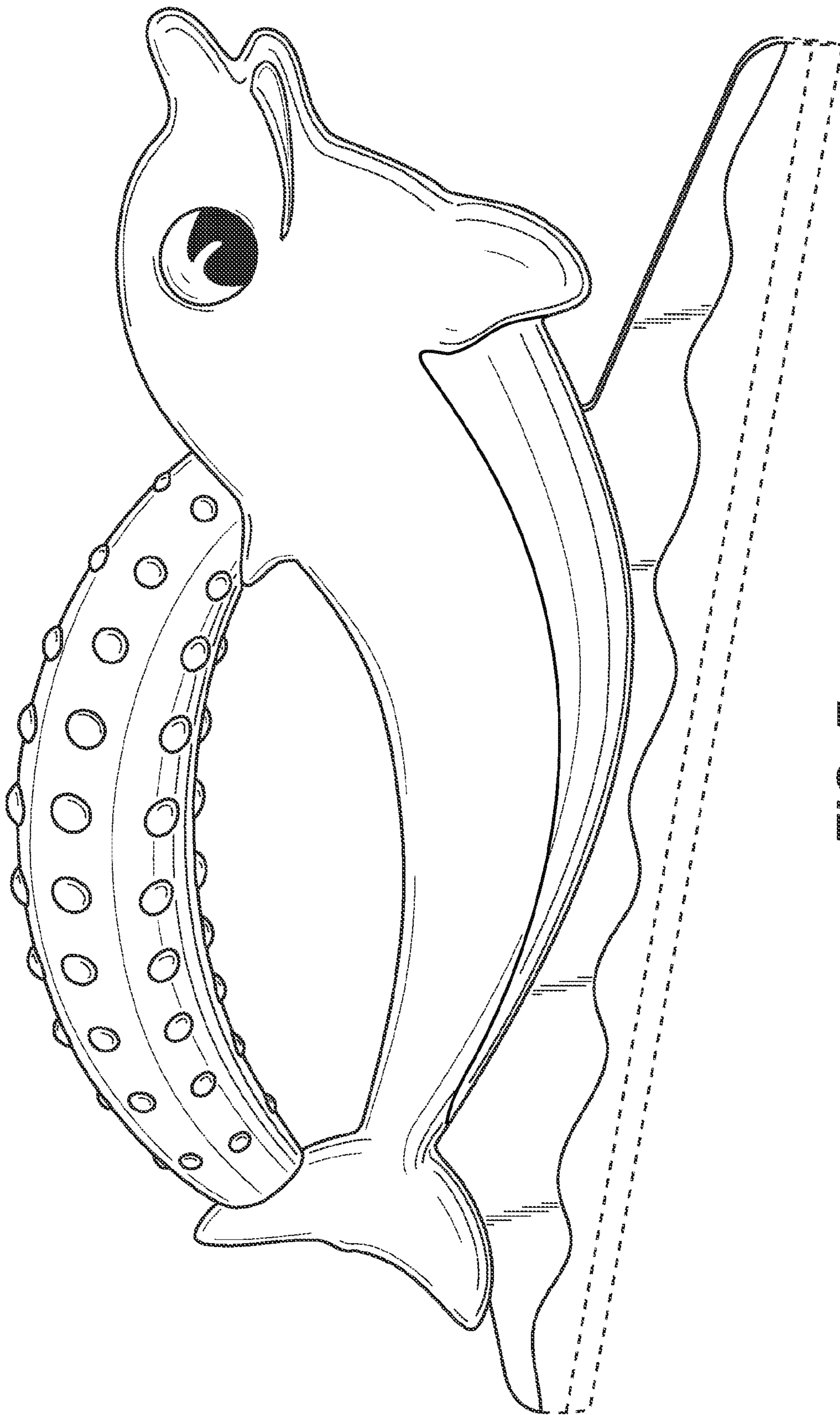

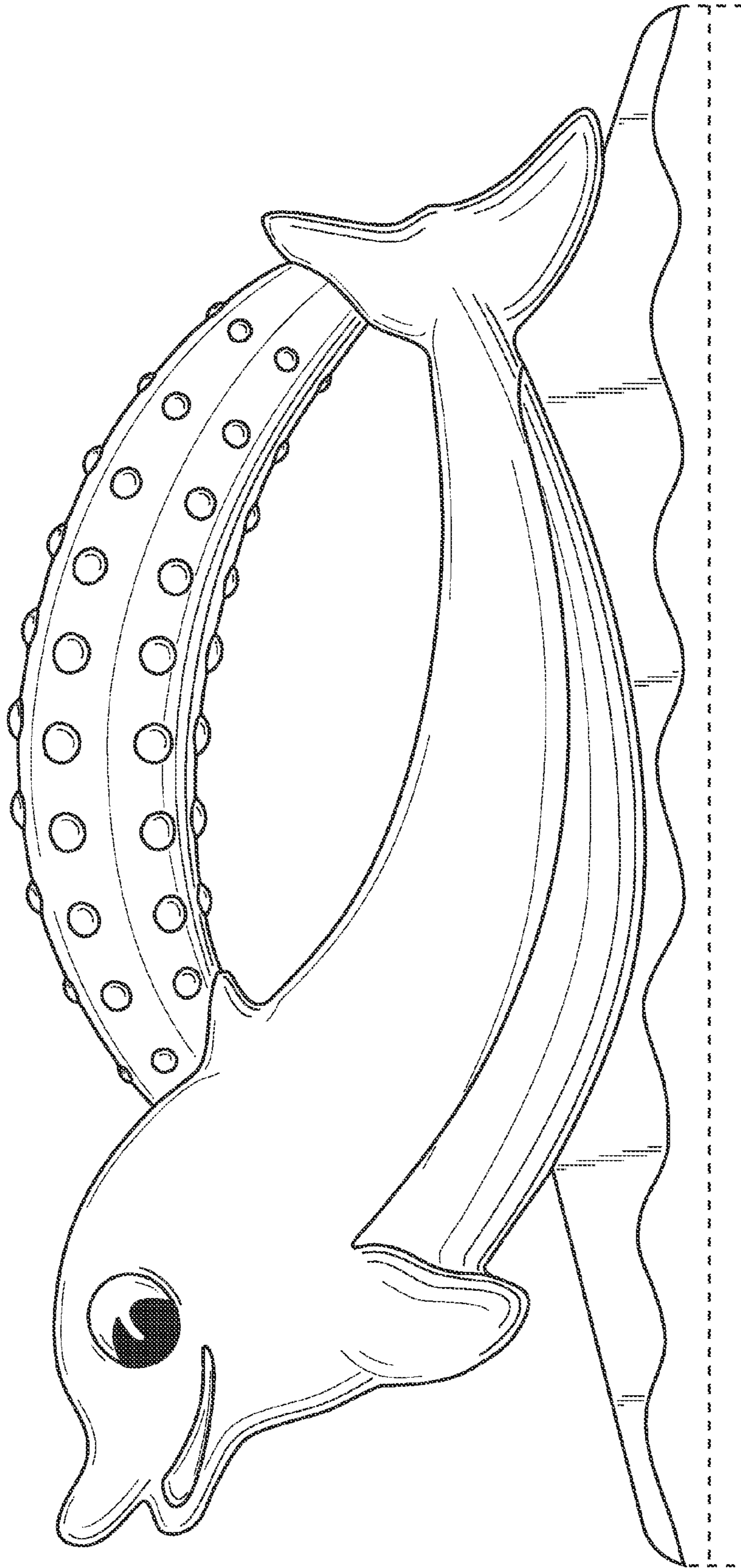
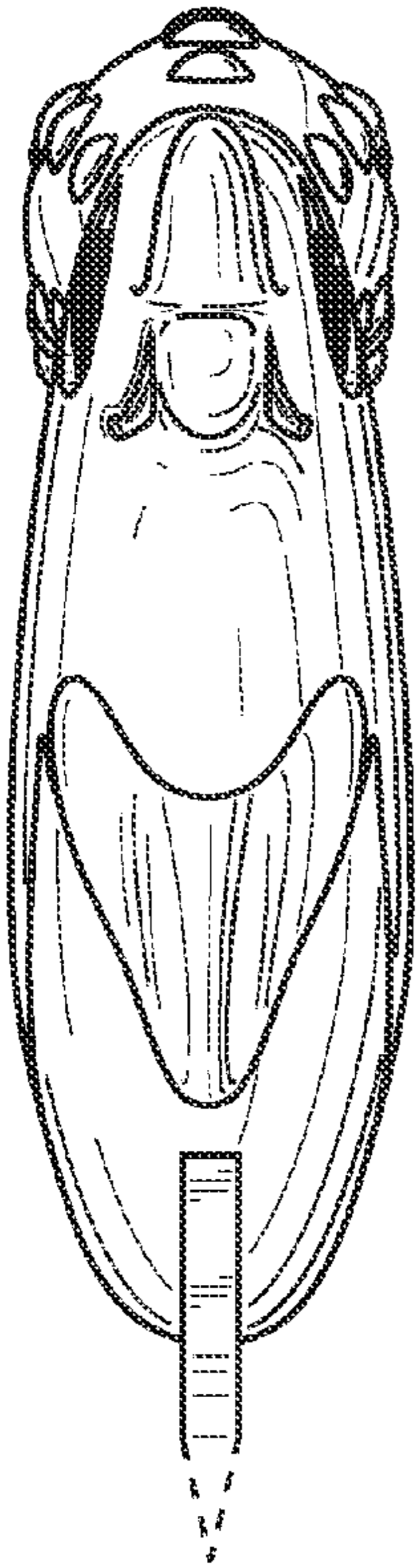
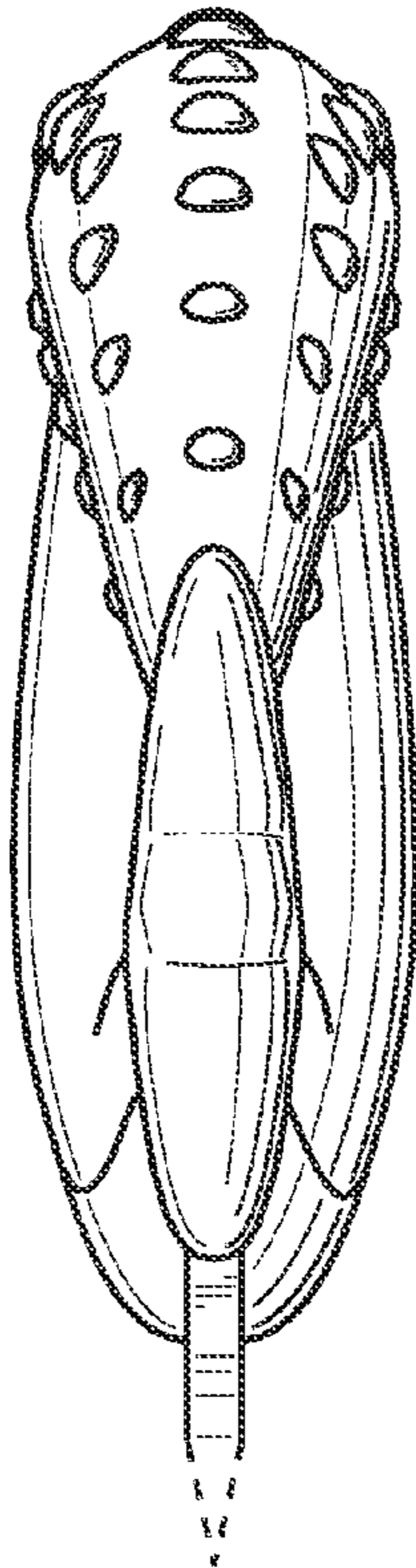

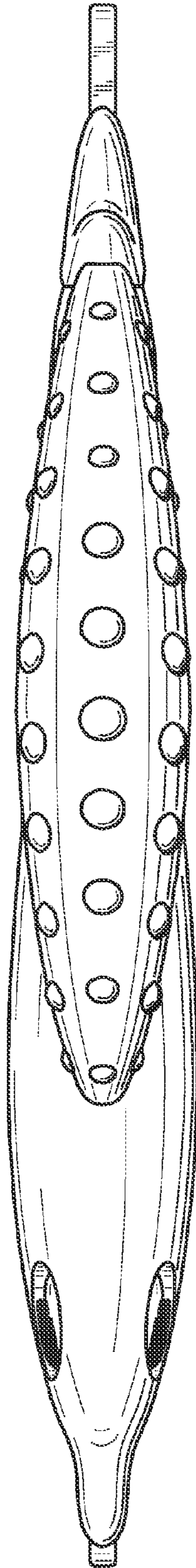




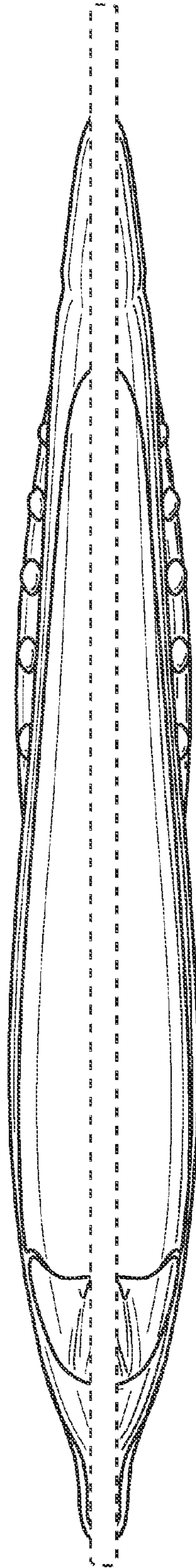
