The ornamental design for a knockdown cart, as shown and described.

DESCRIPTION

FIG. 12 is another rear elevational view thereof;

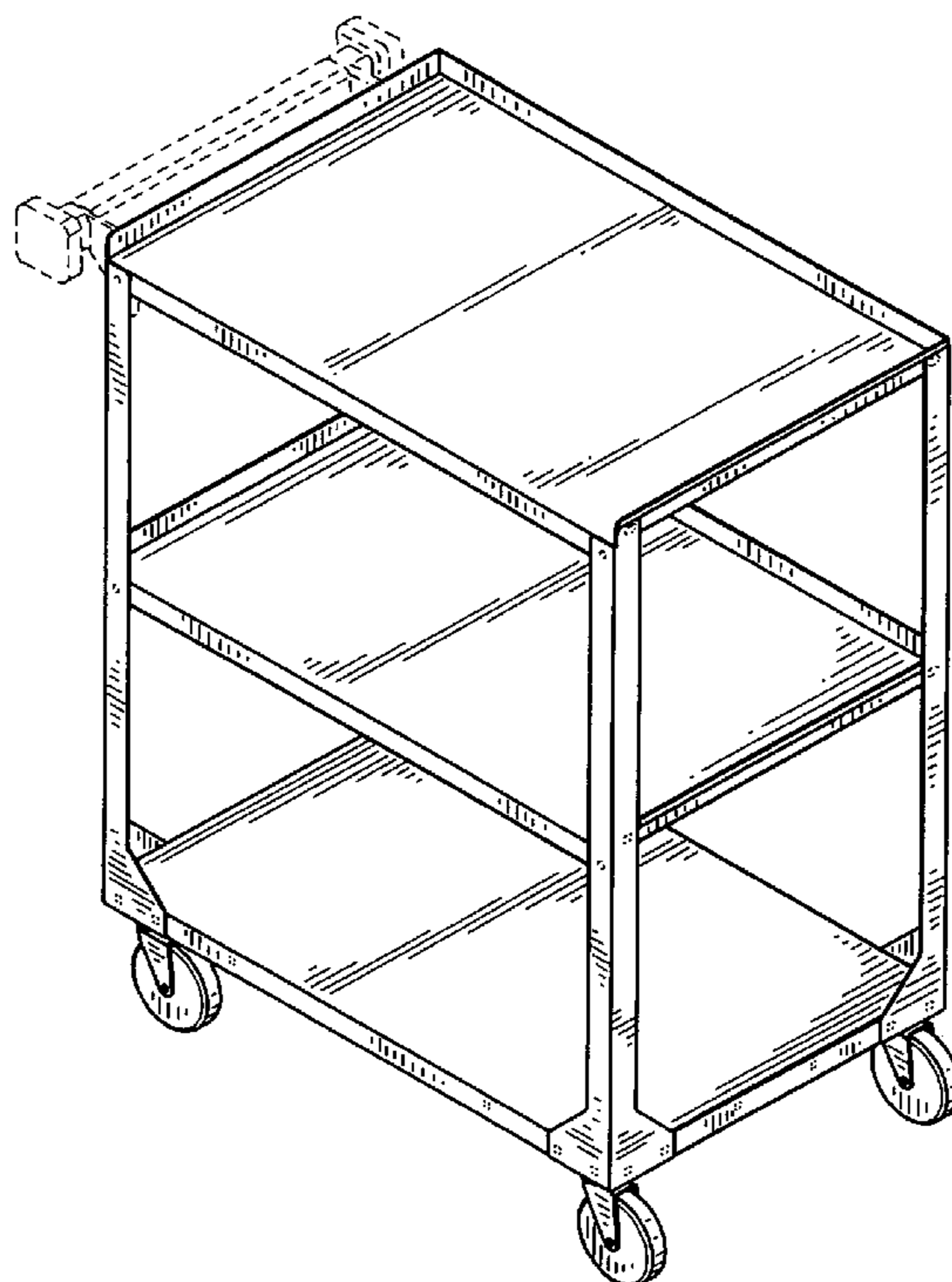
FIG. 13 is another right side elevational view thereof;

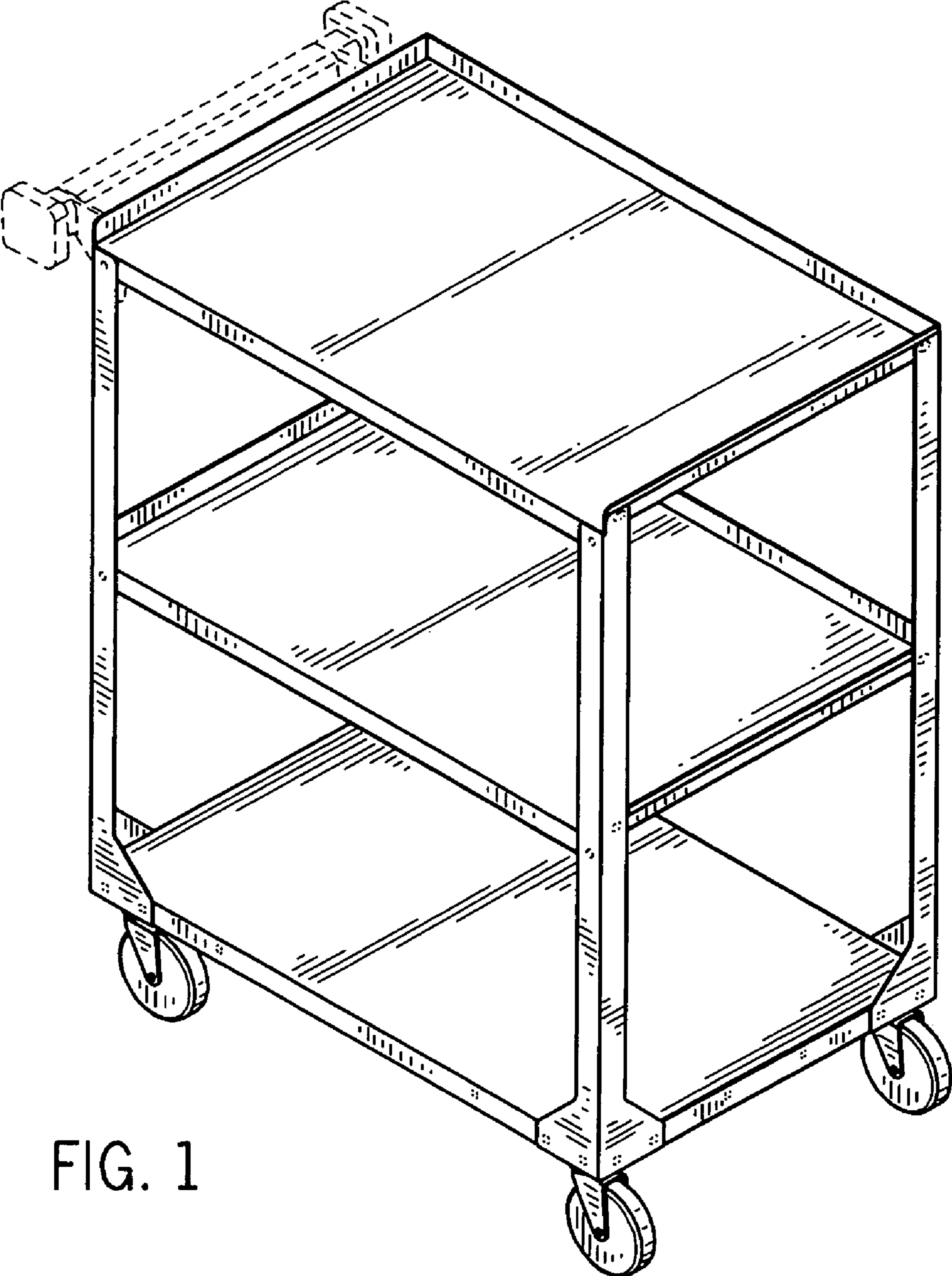

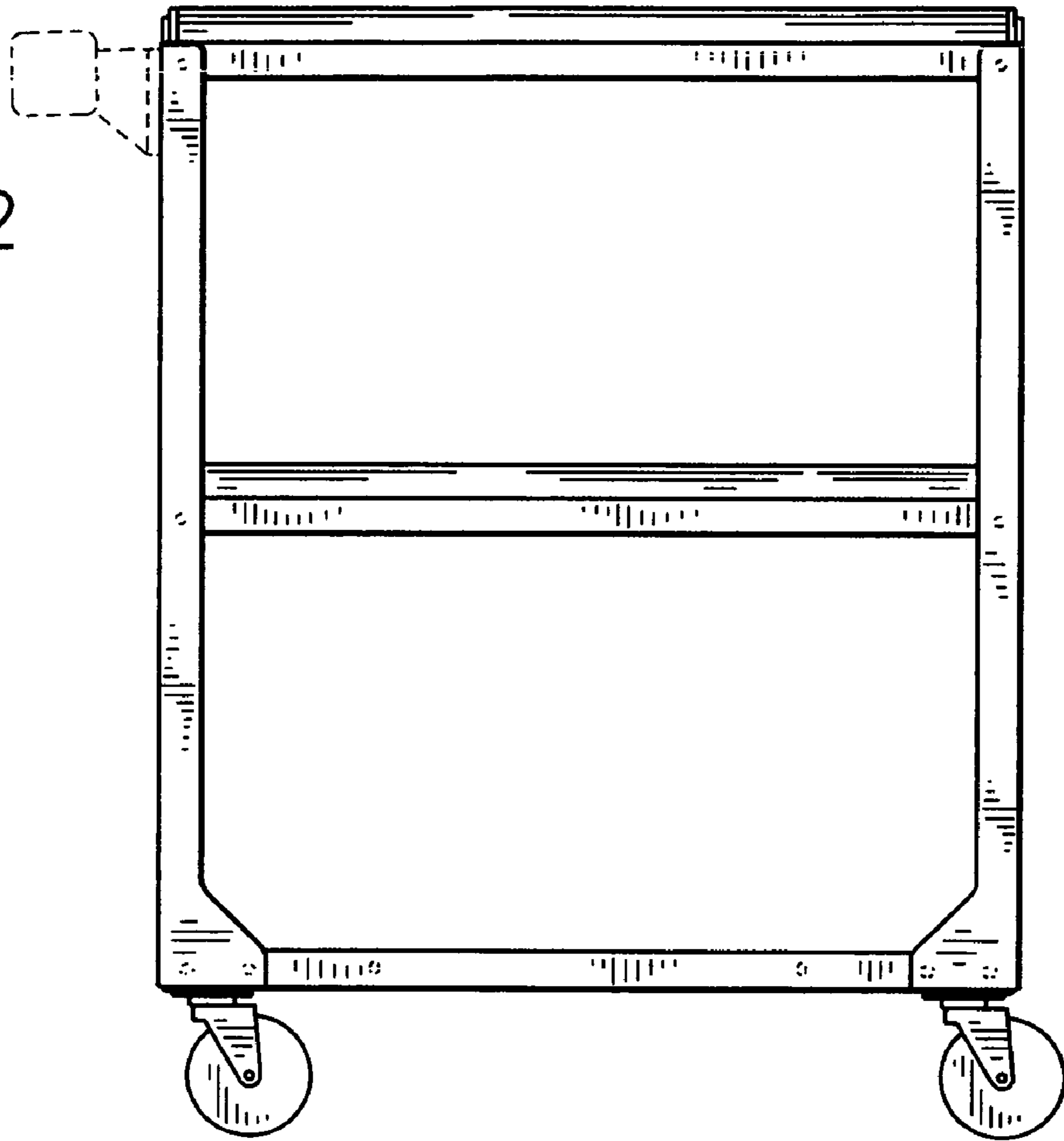
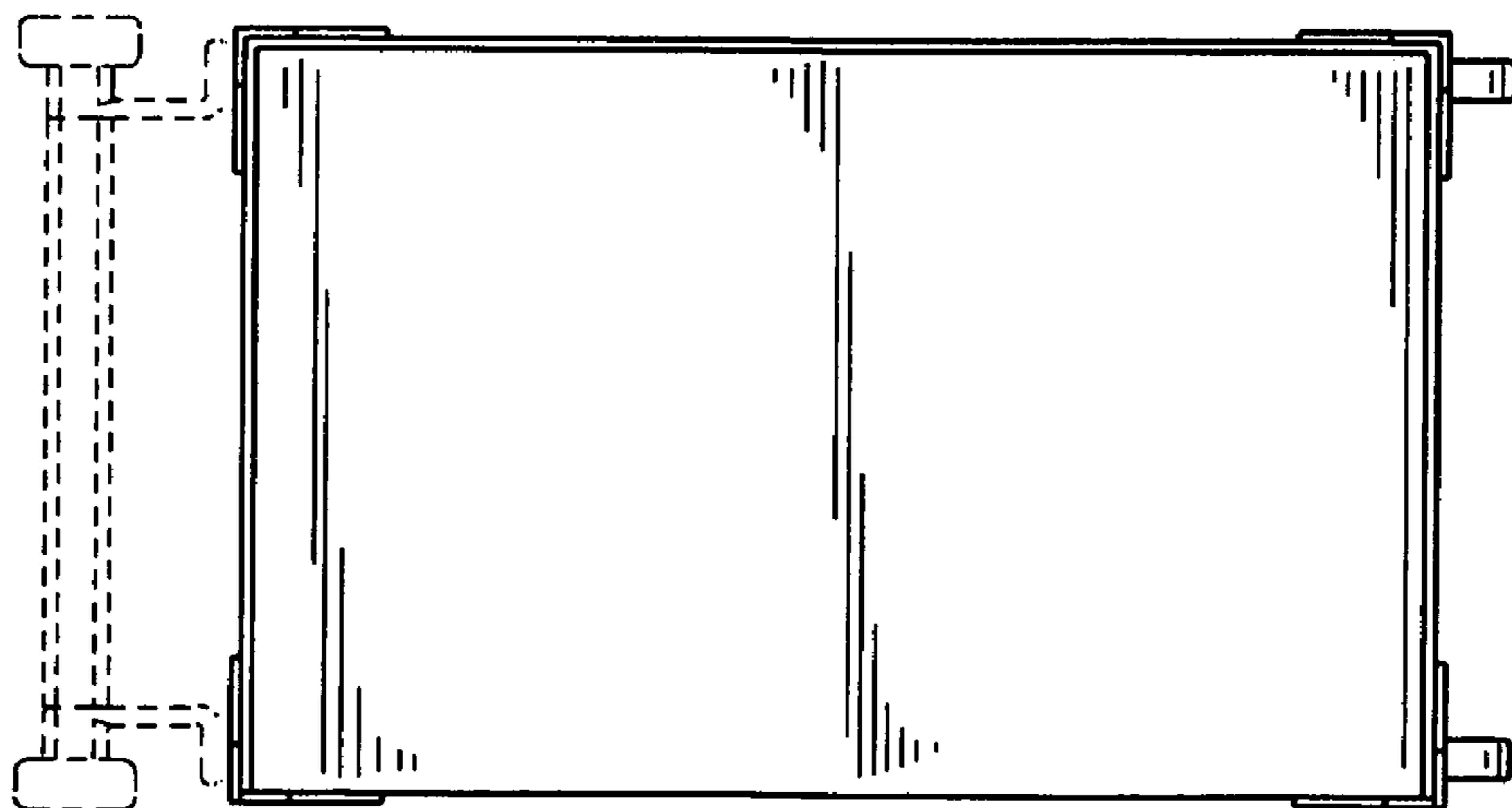

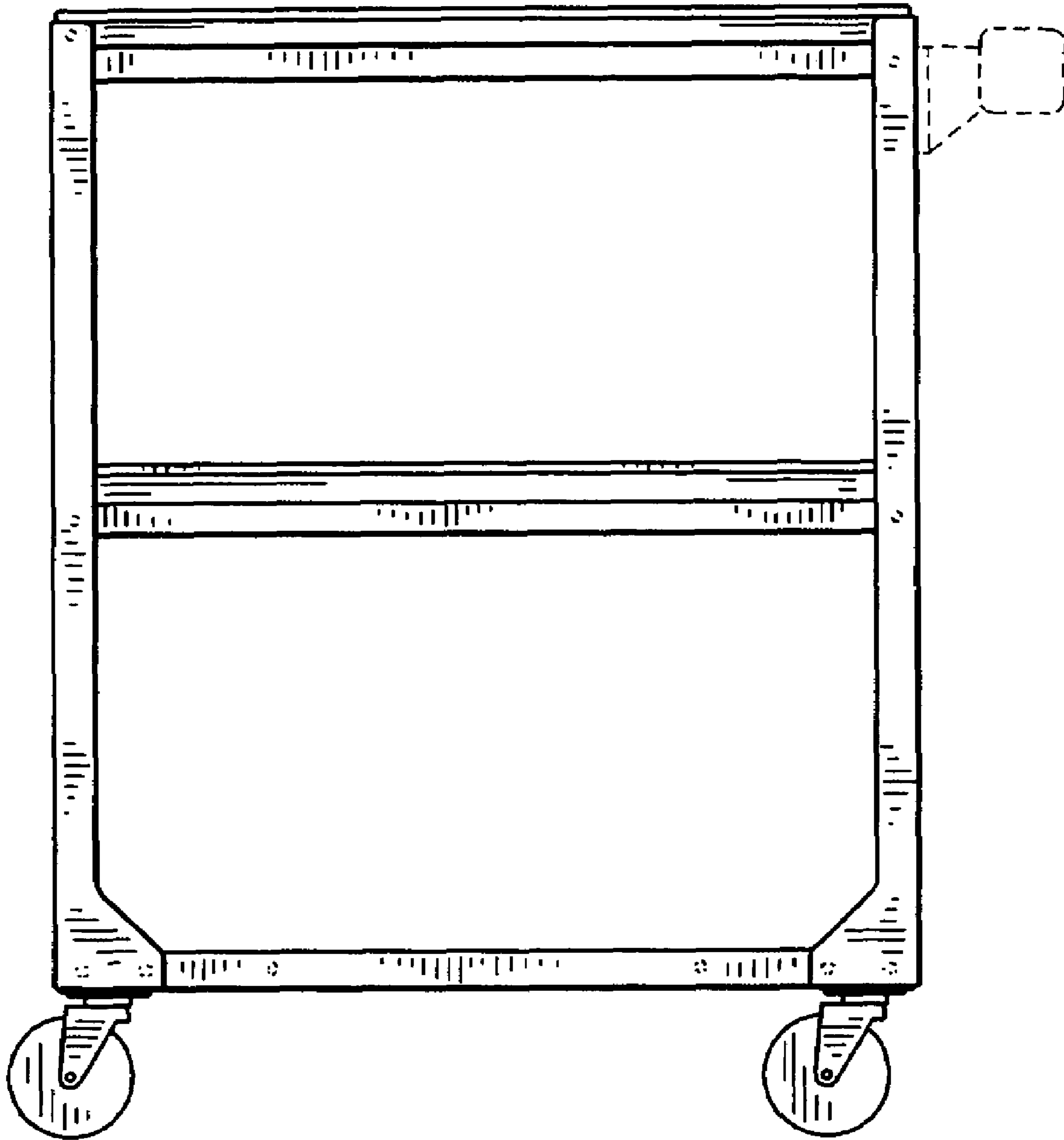

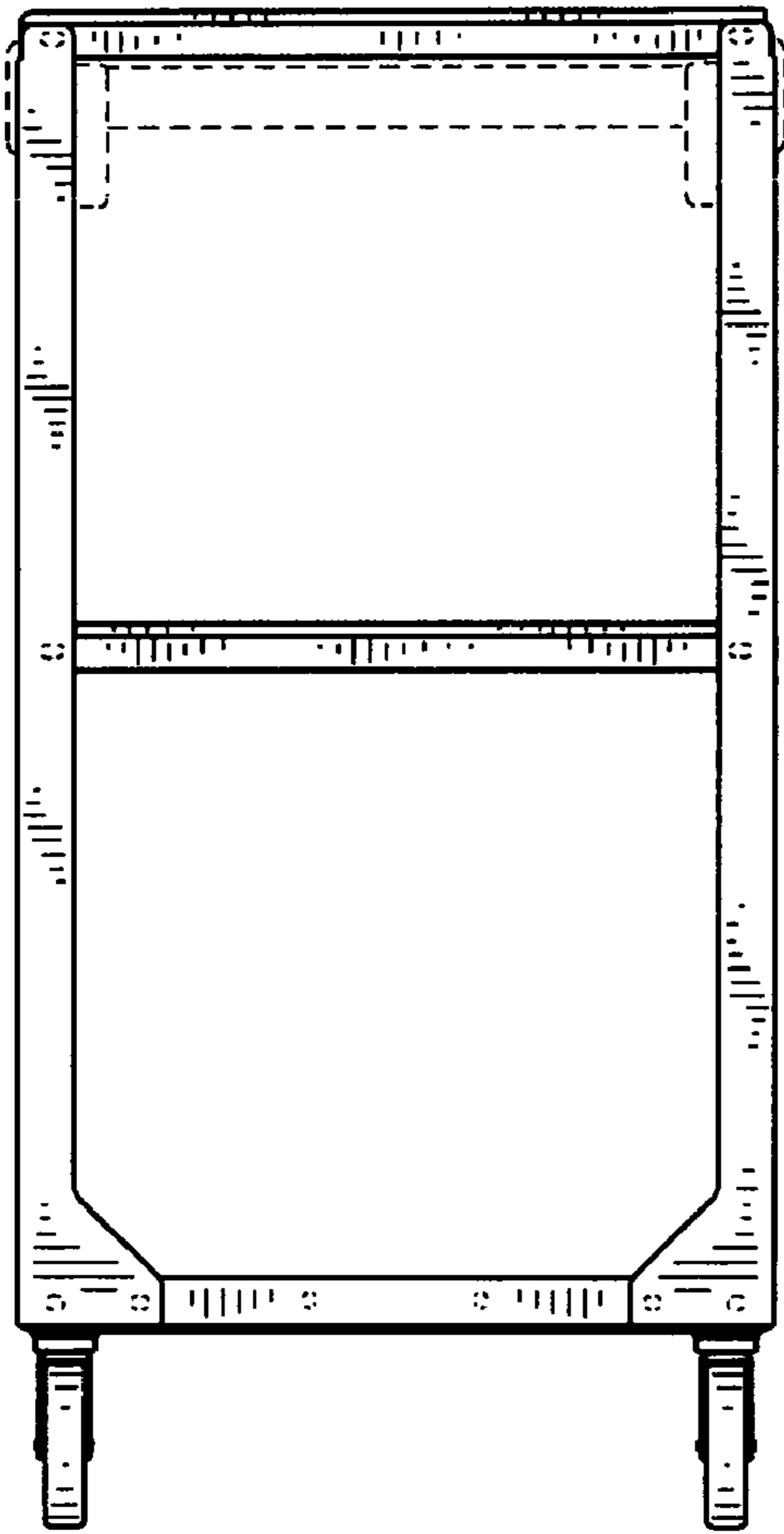
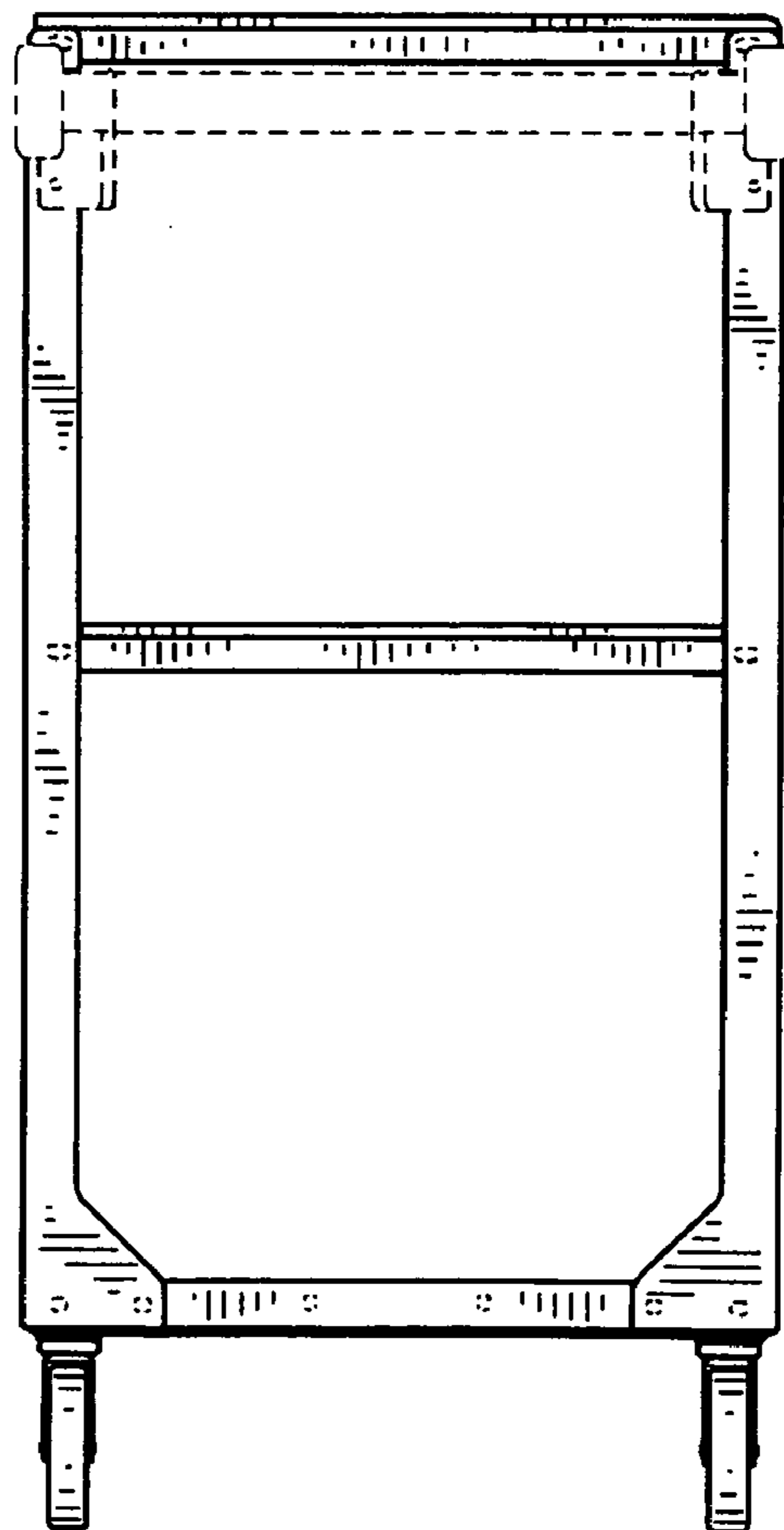

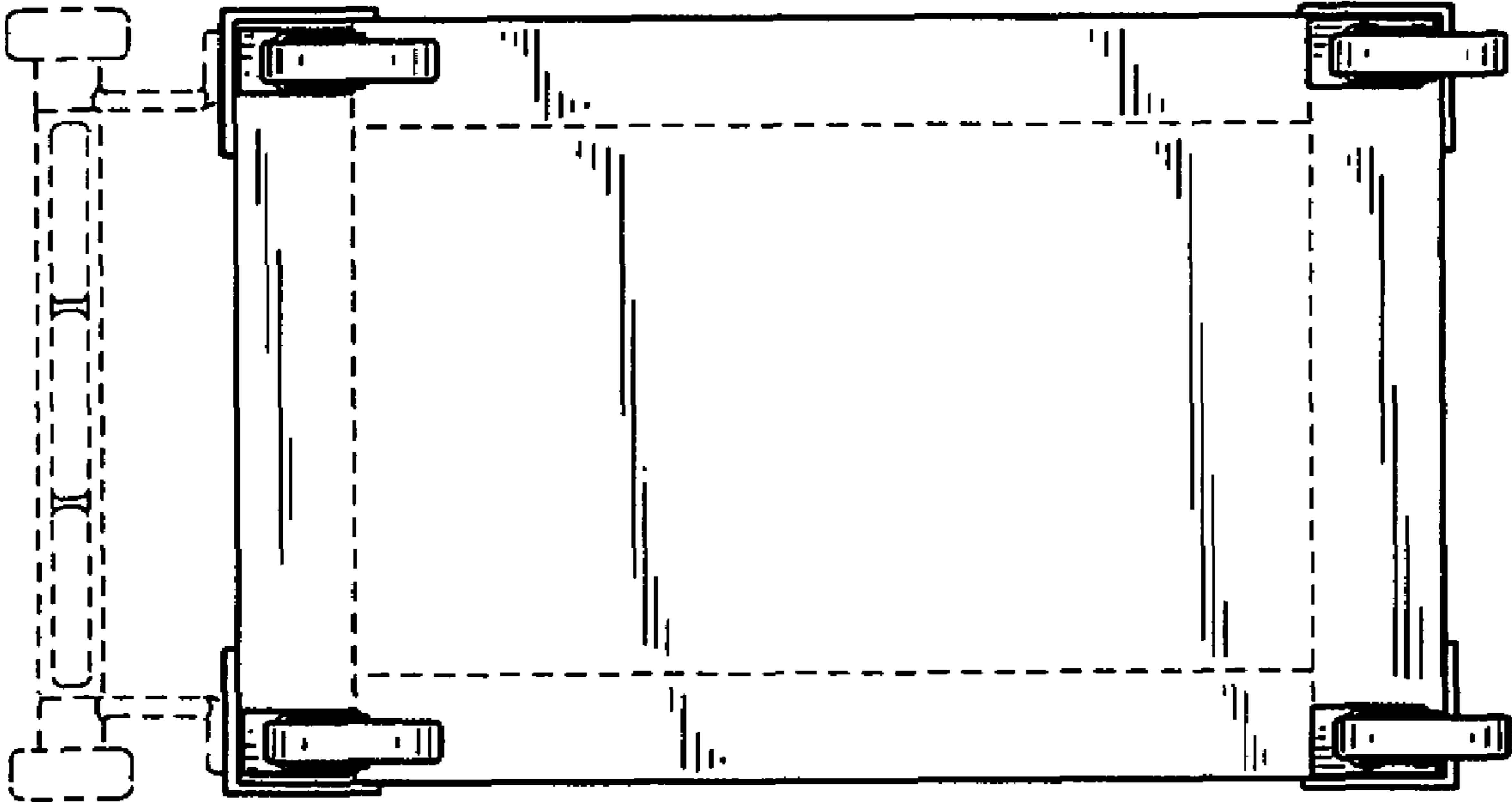

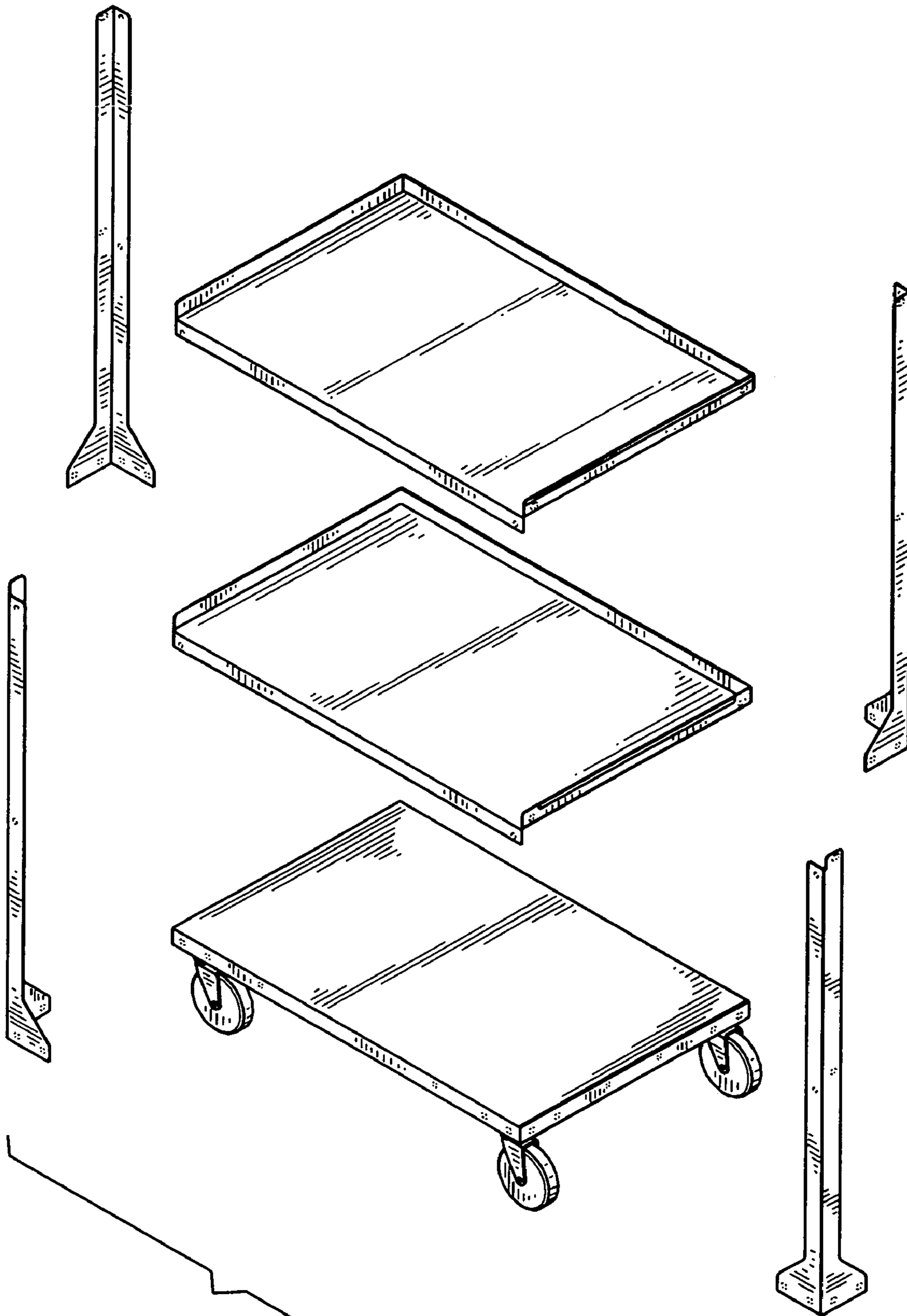

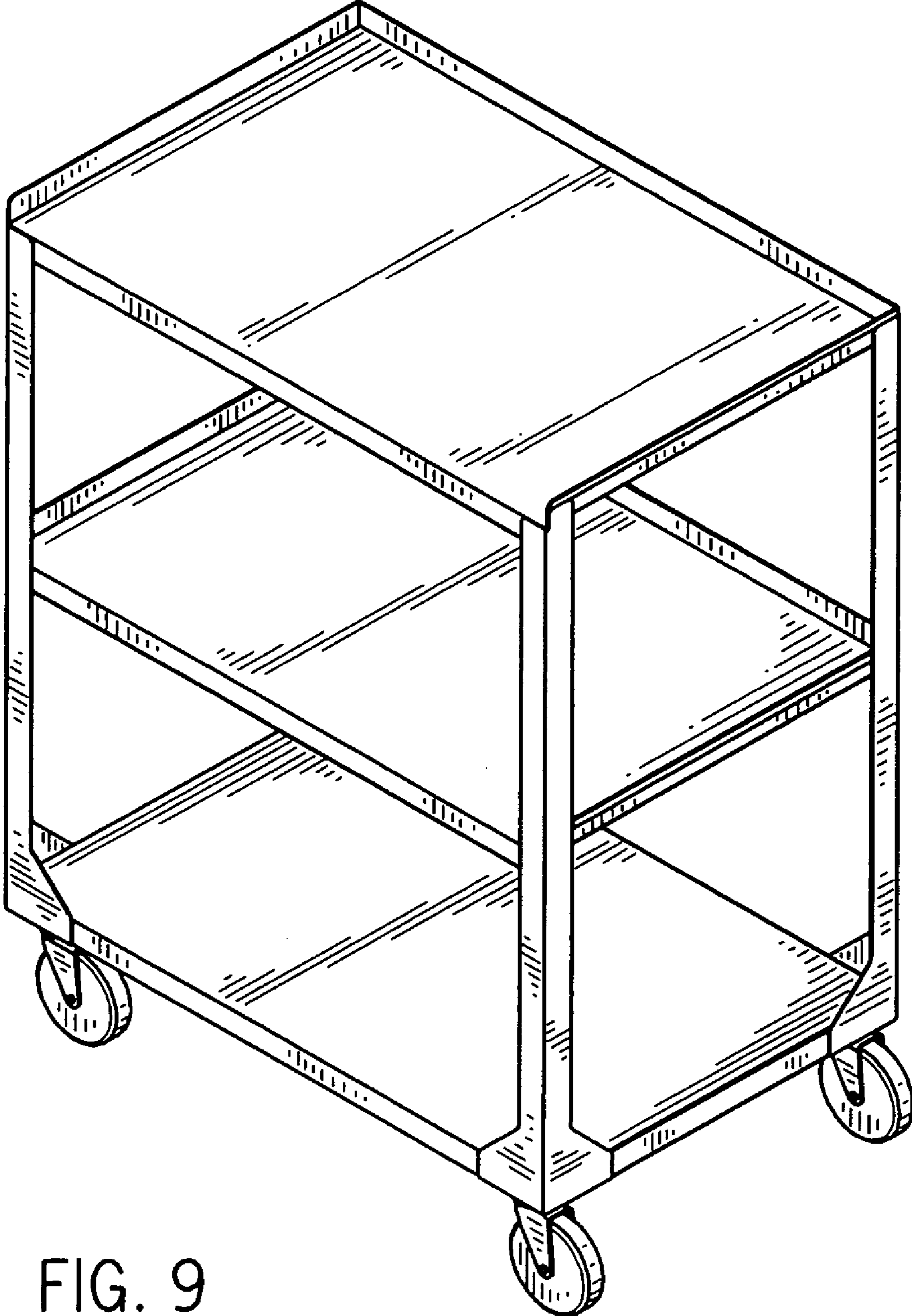

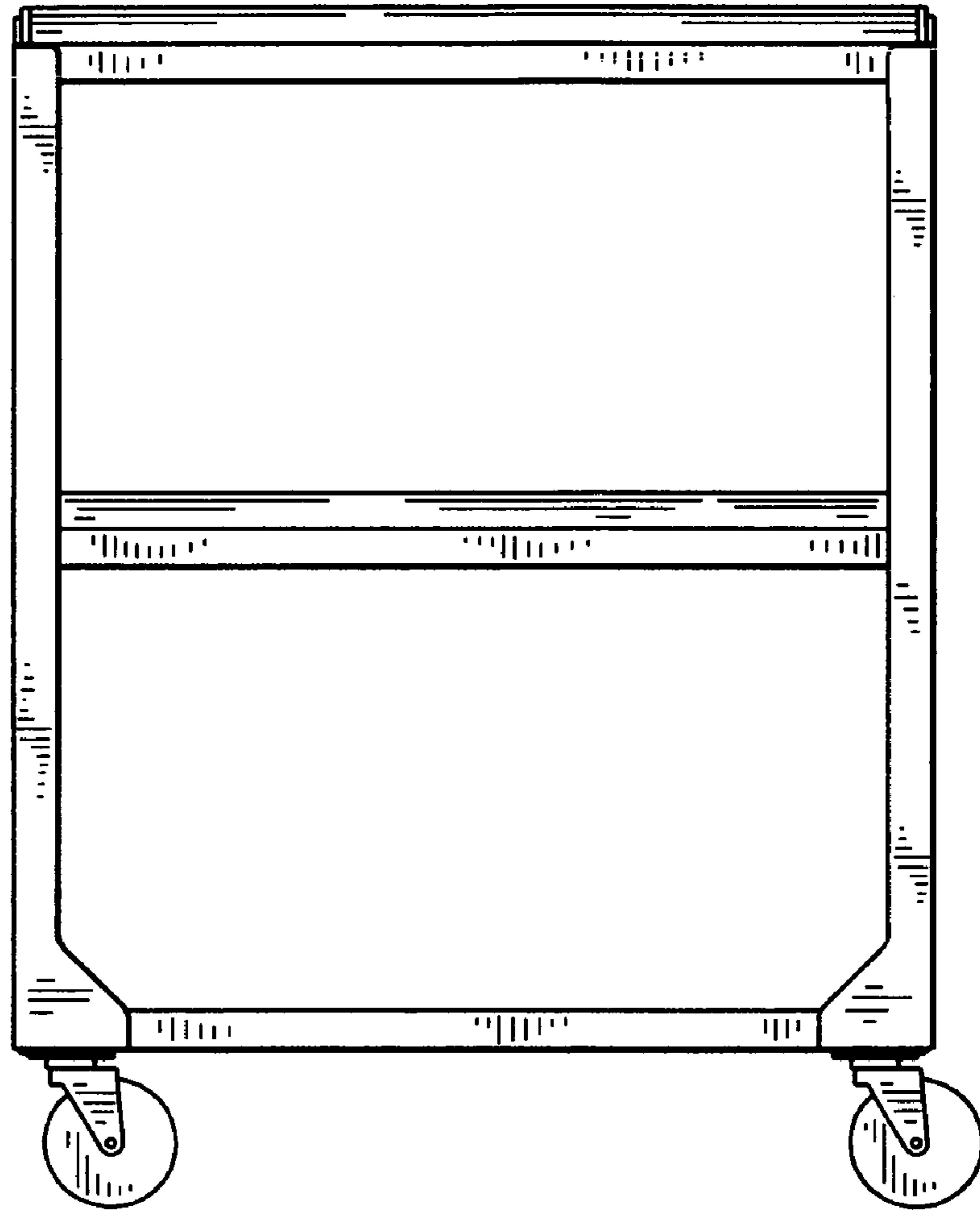
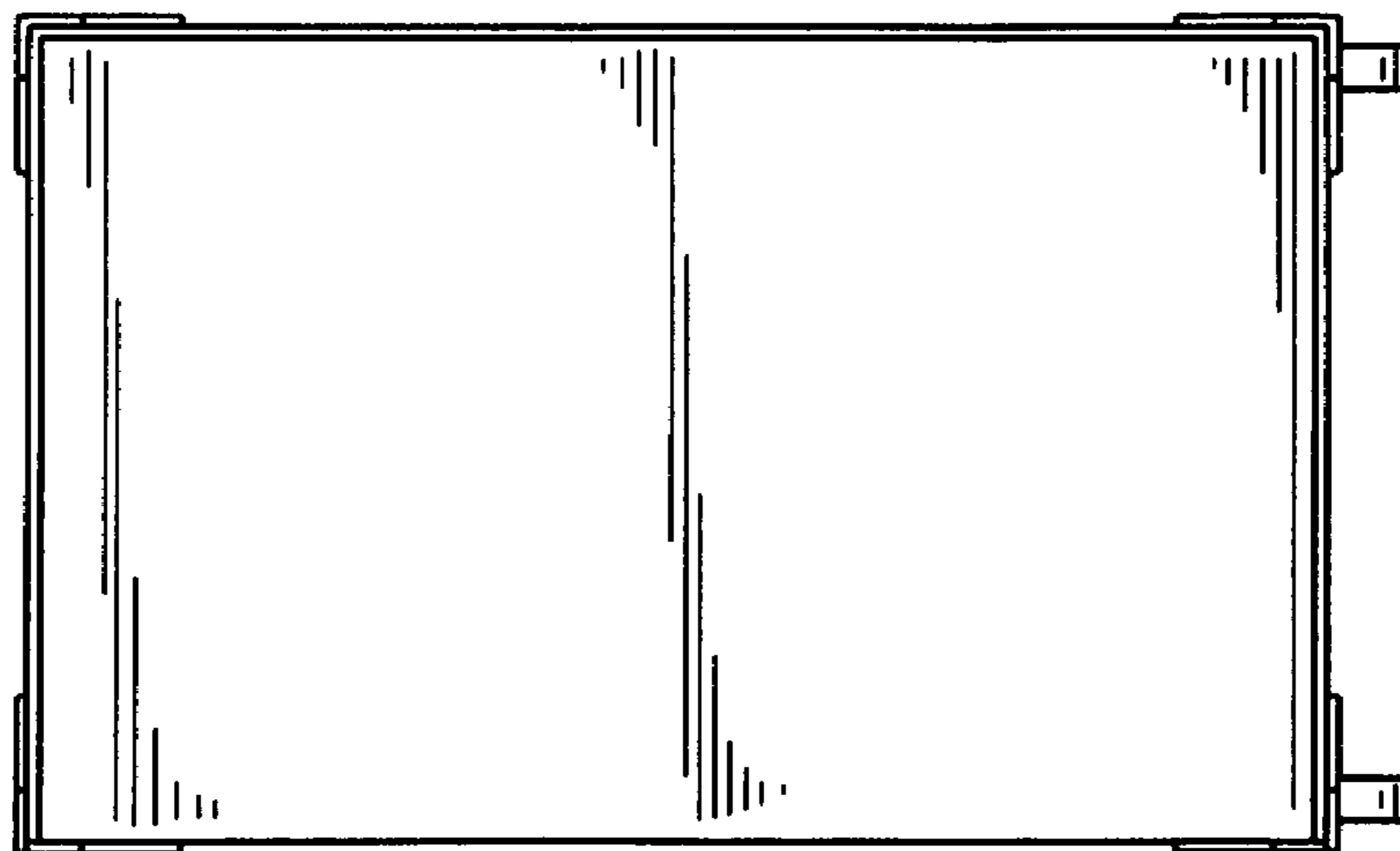

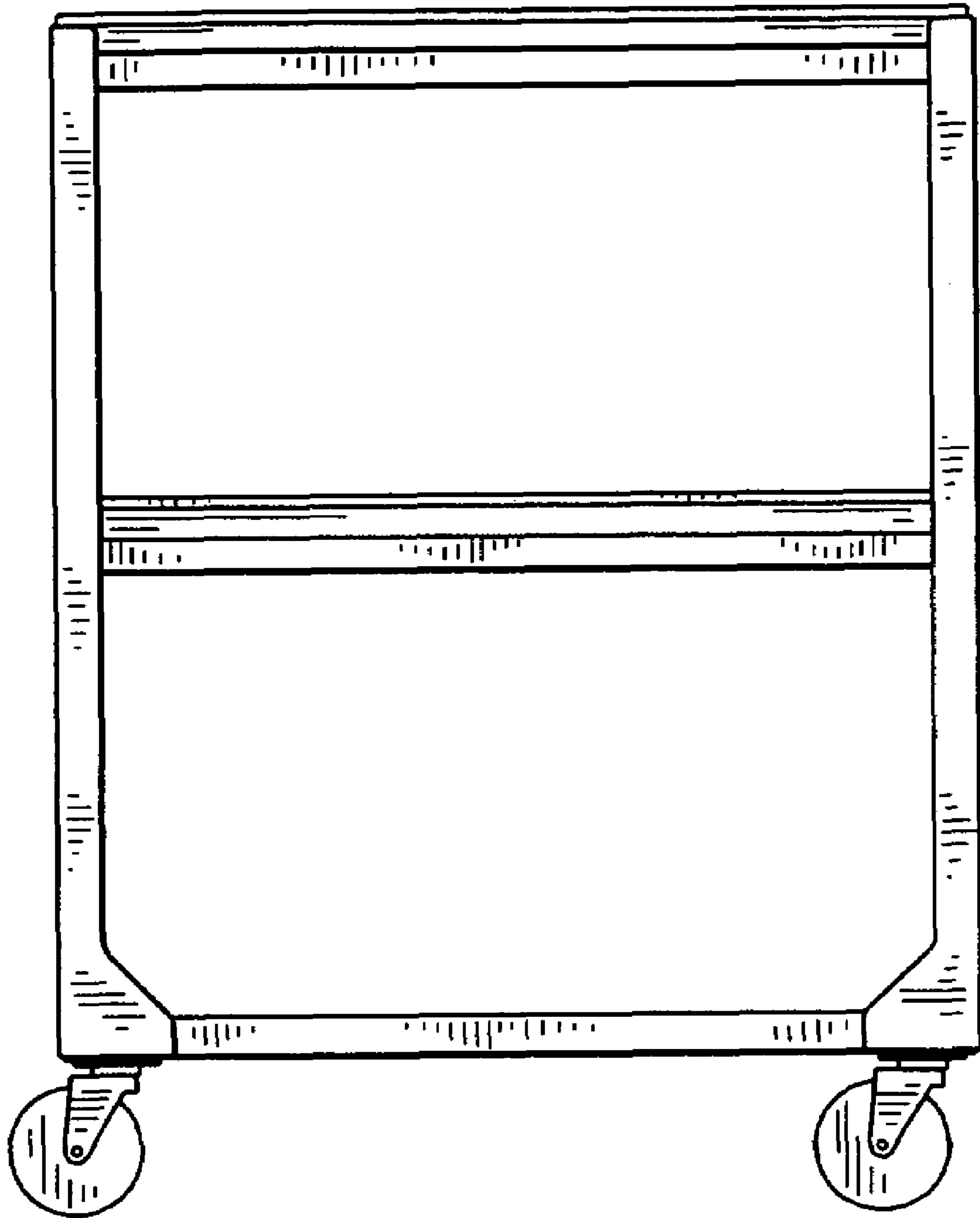

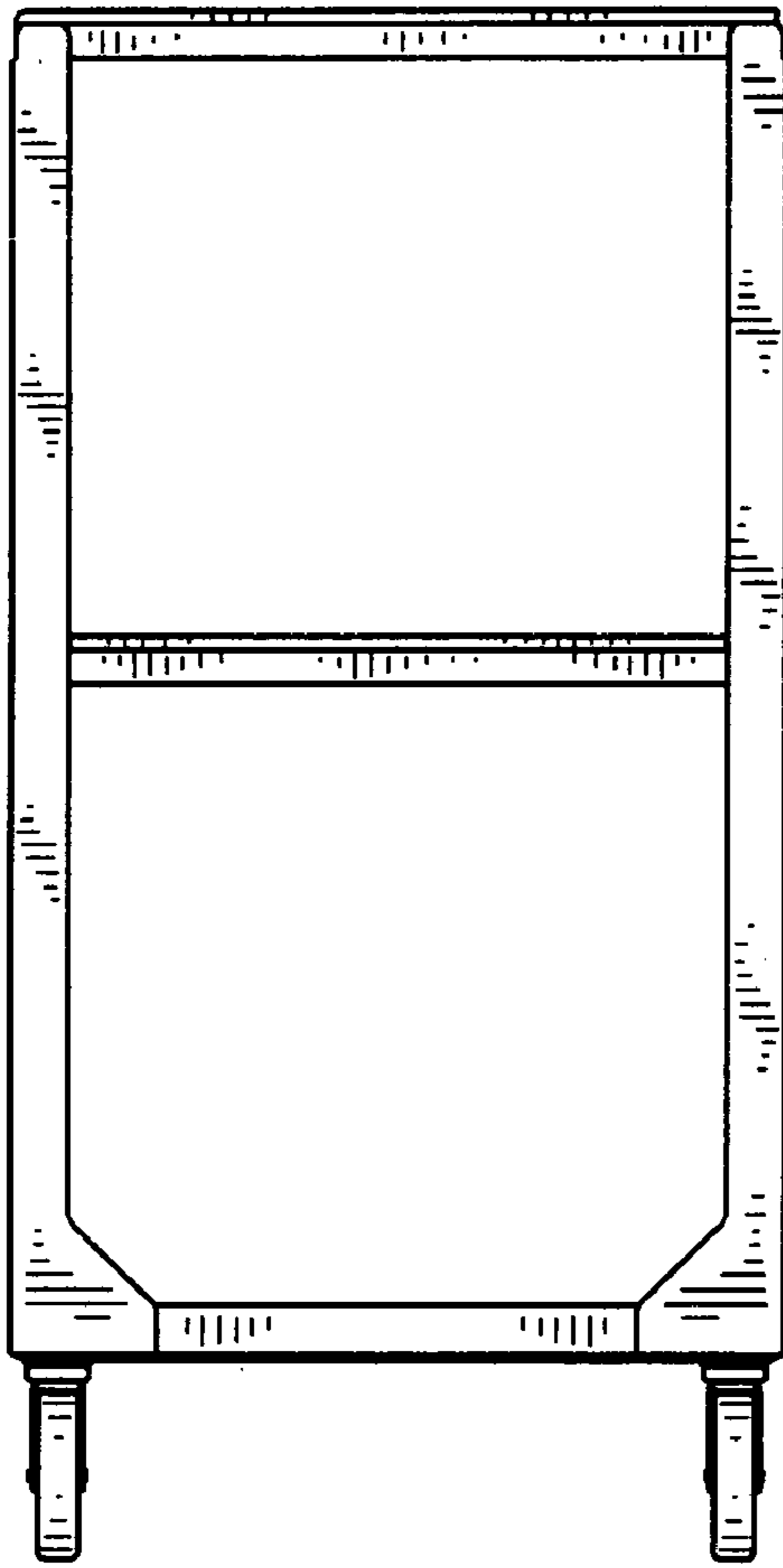

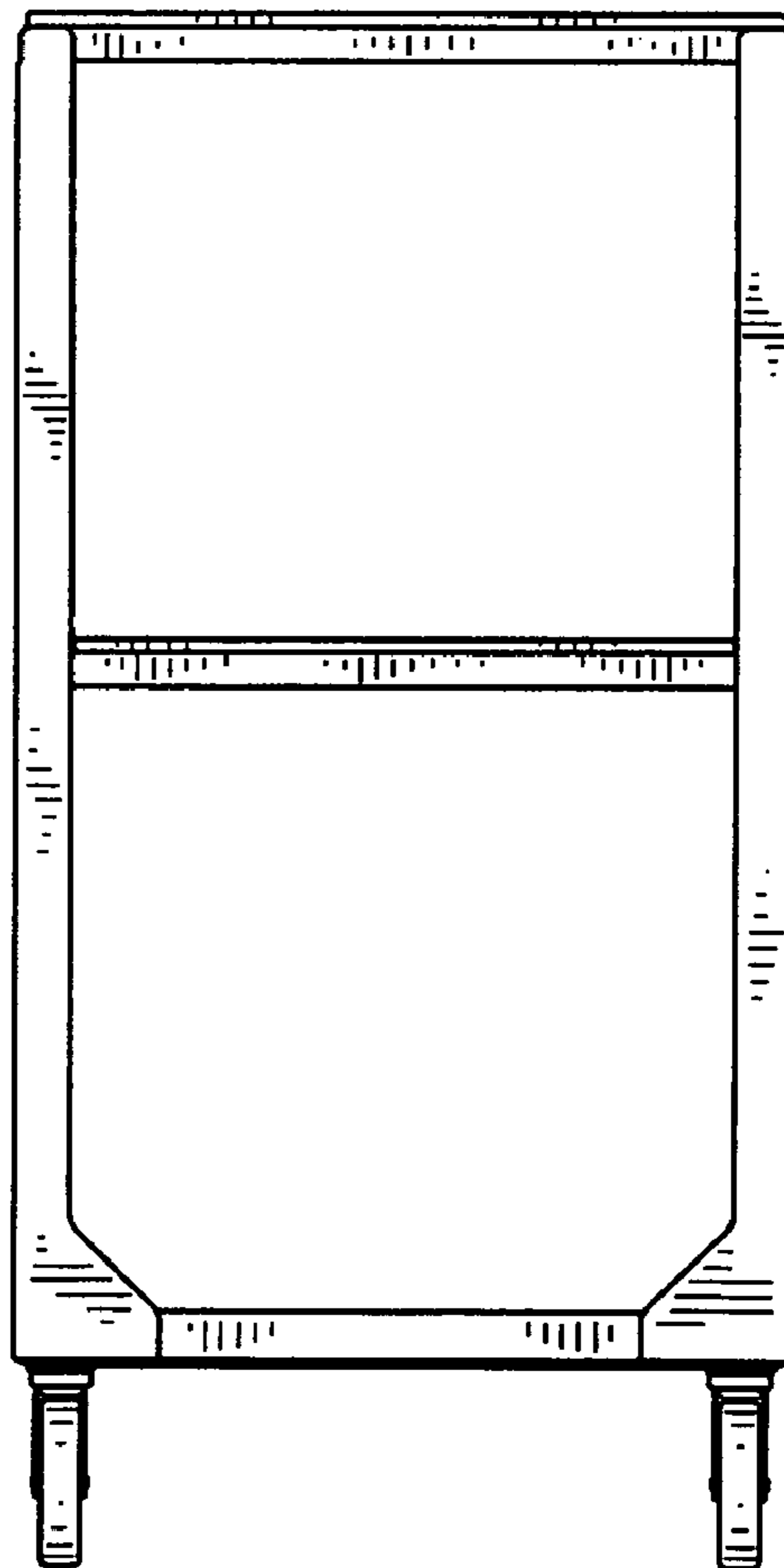

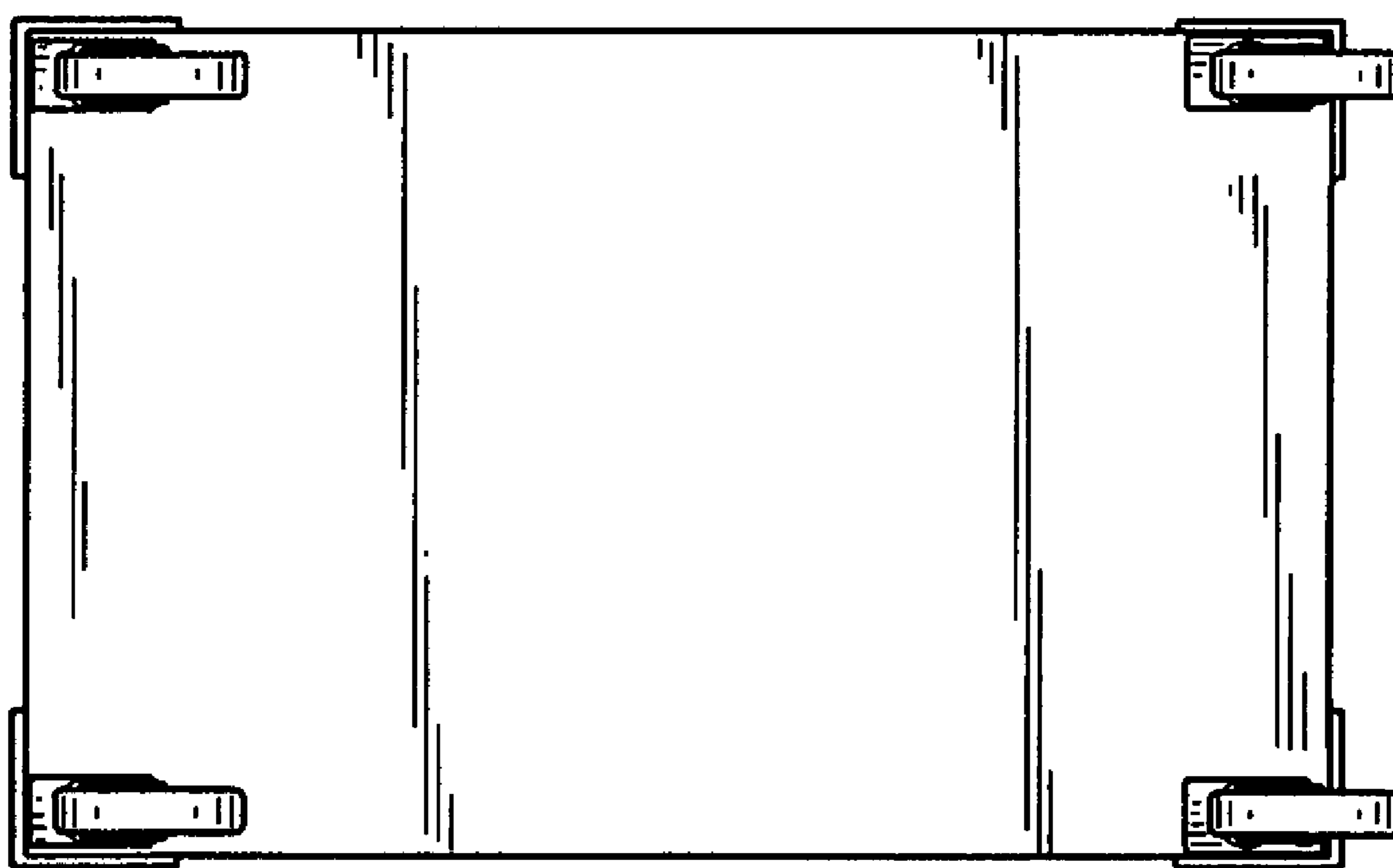
