FIG. 12 is a rear elevational view;

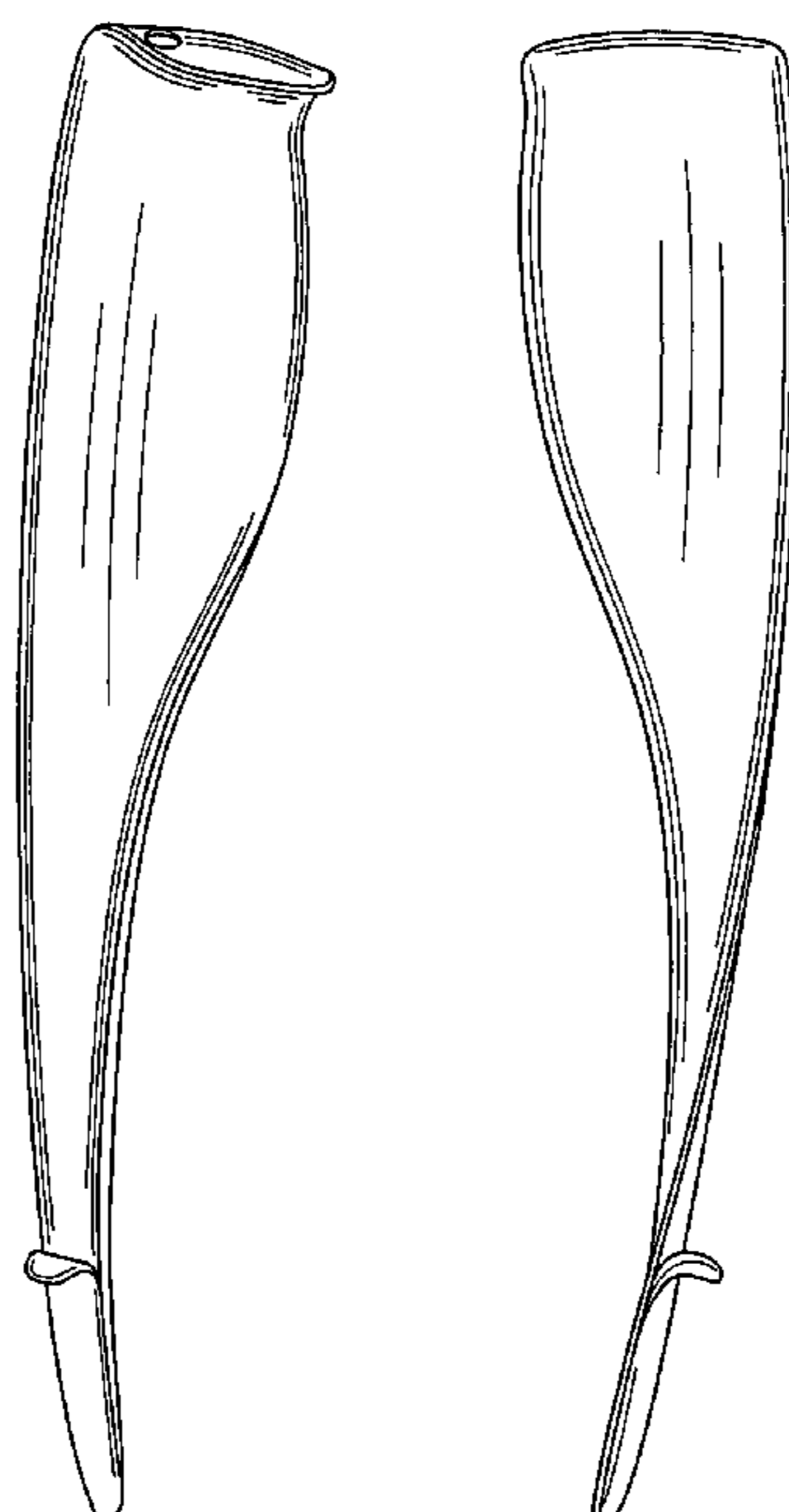
FIG. 13 is a right side elevational view;

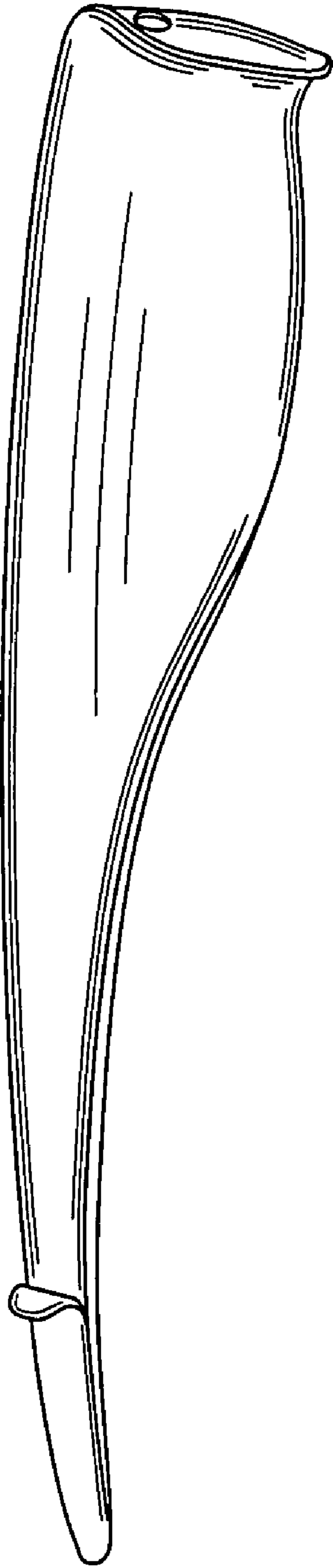

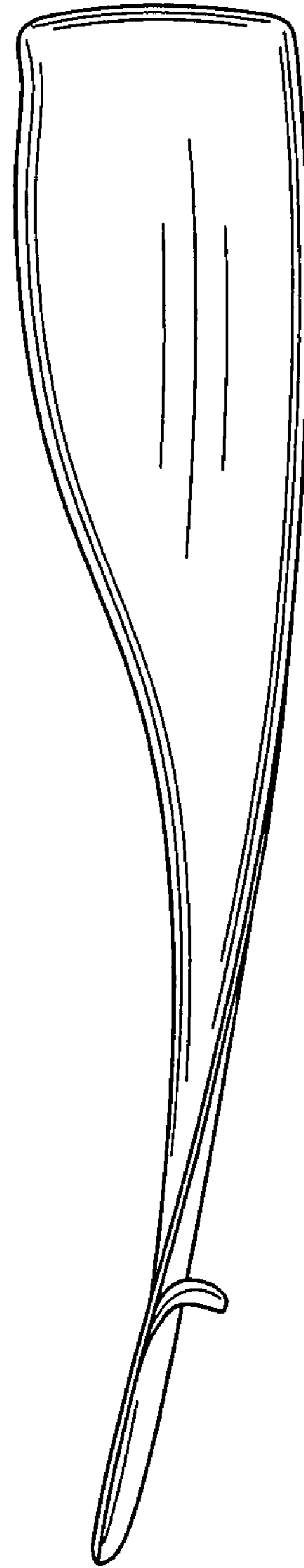

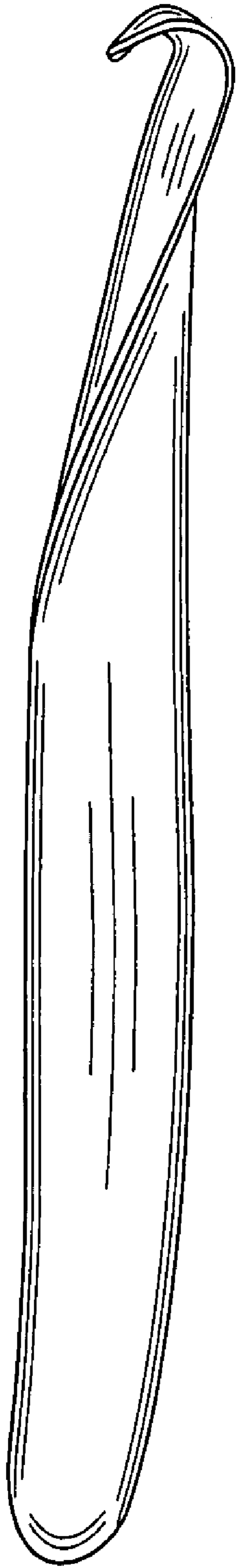

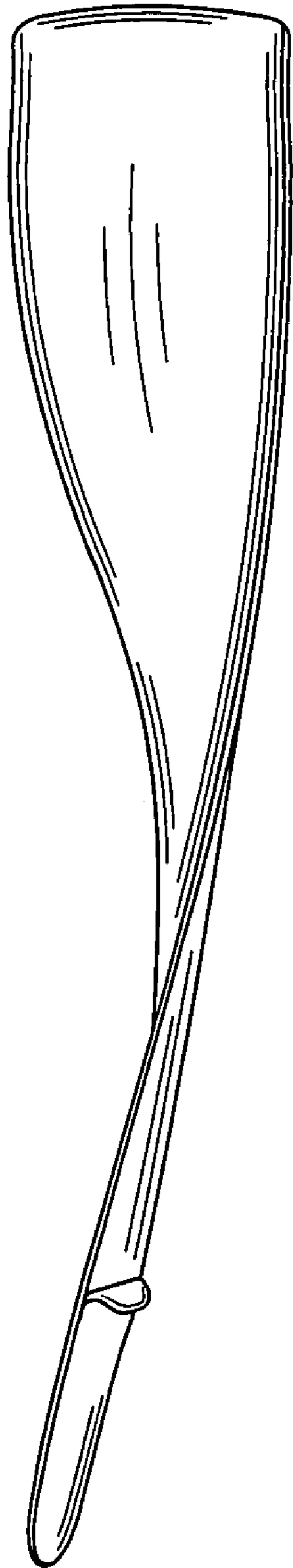

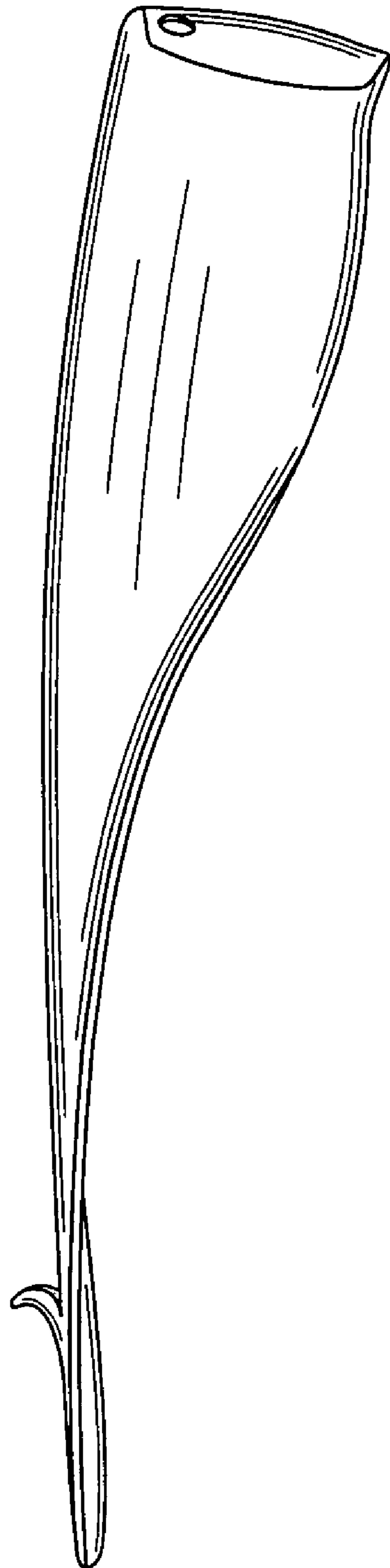

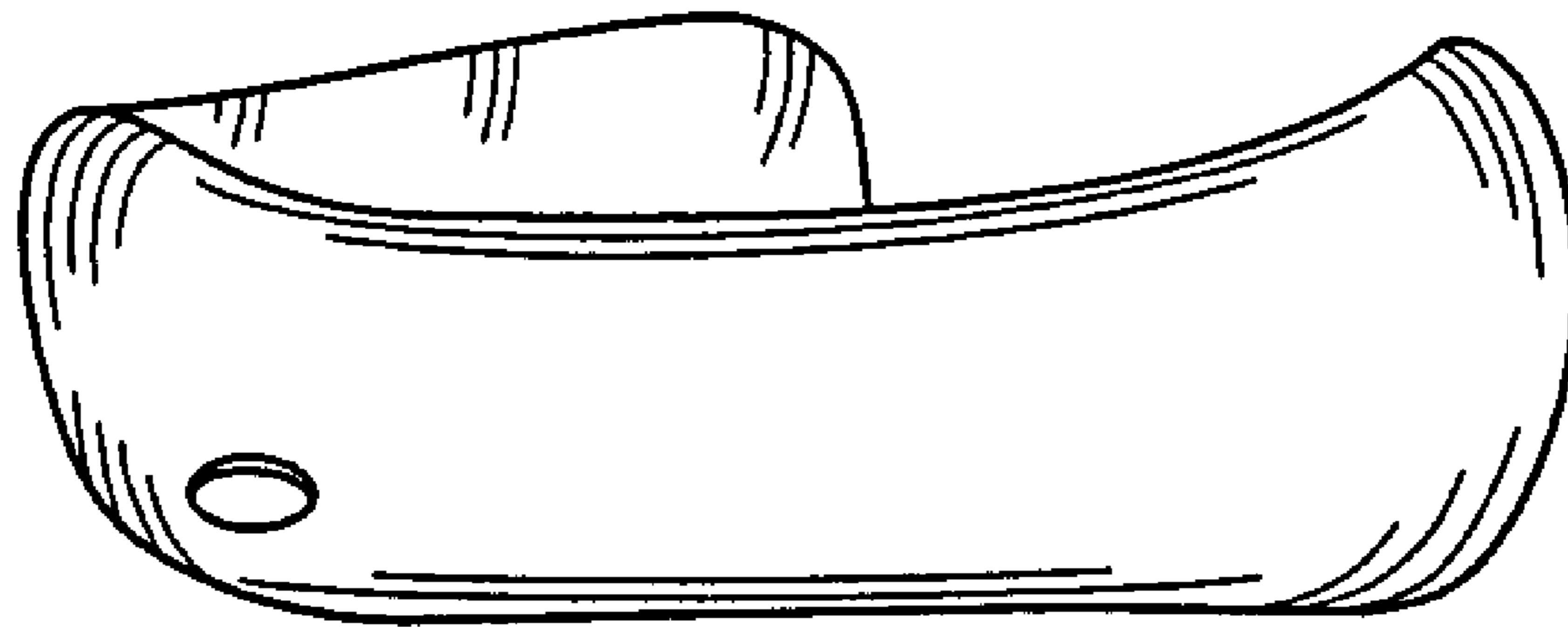

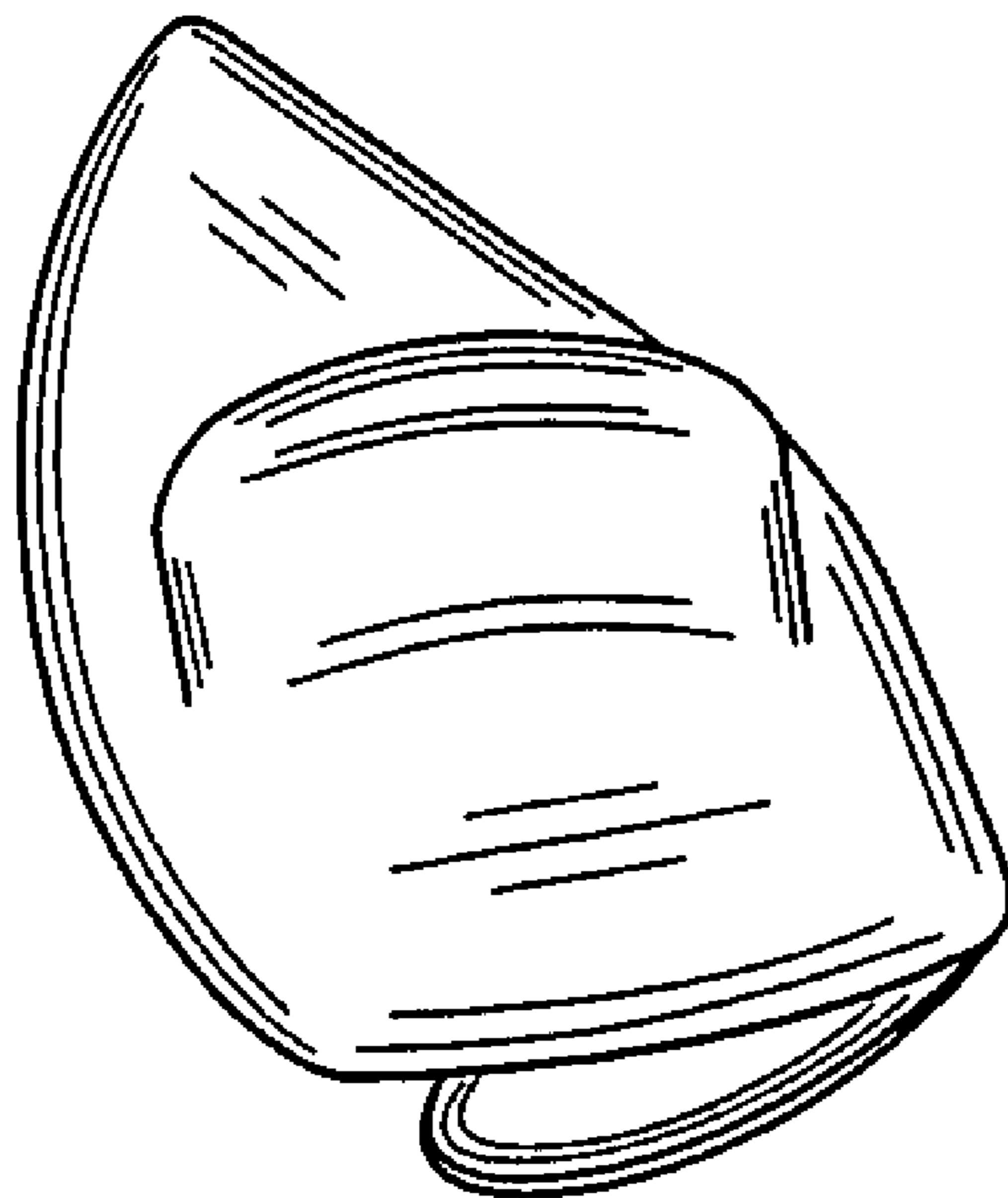

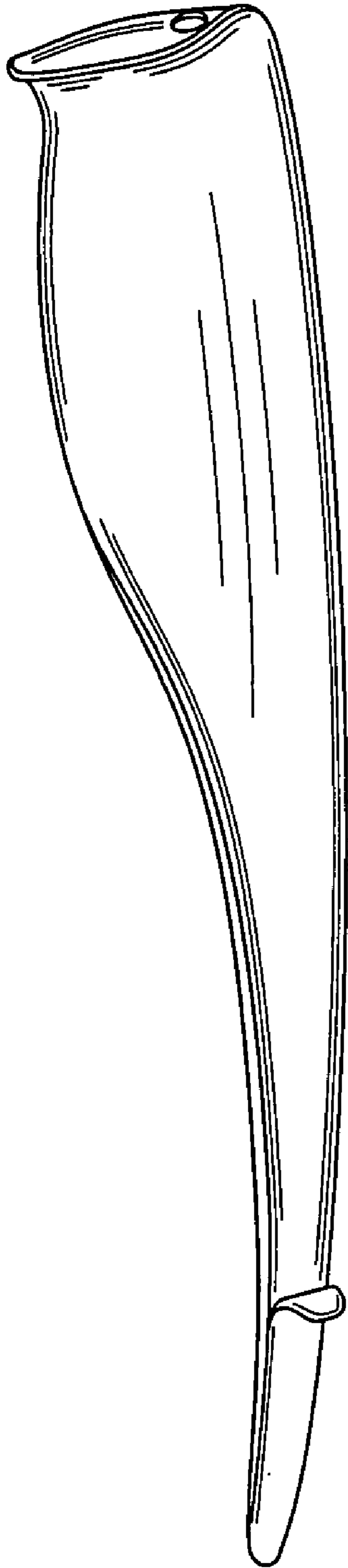

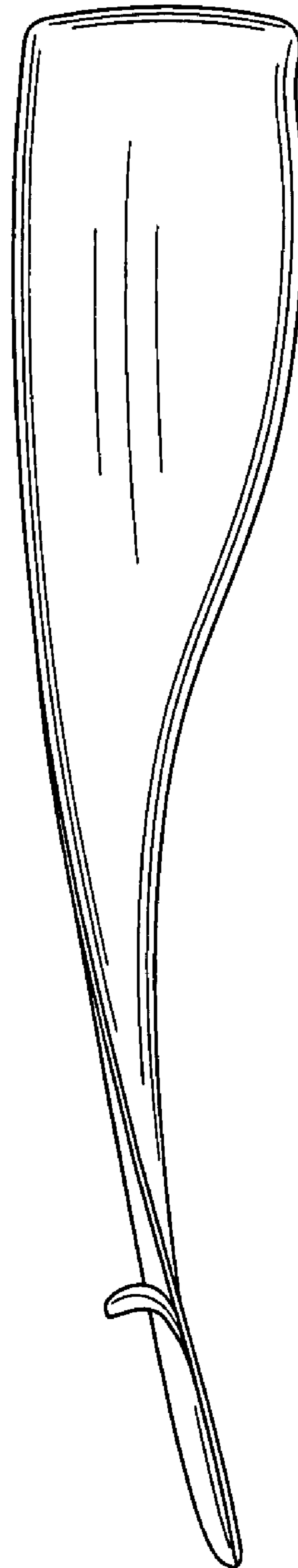

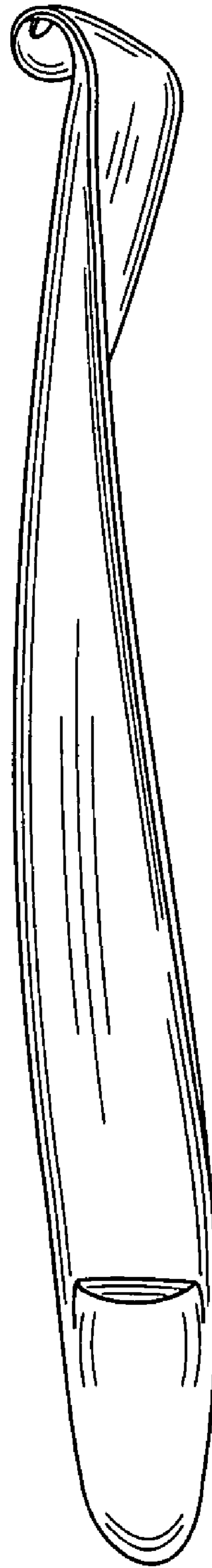

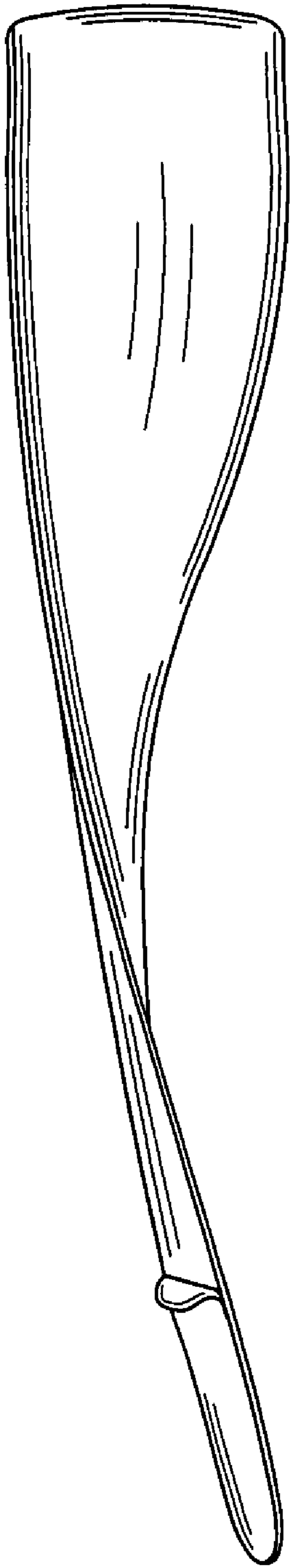

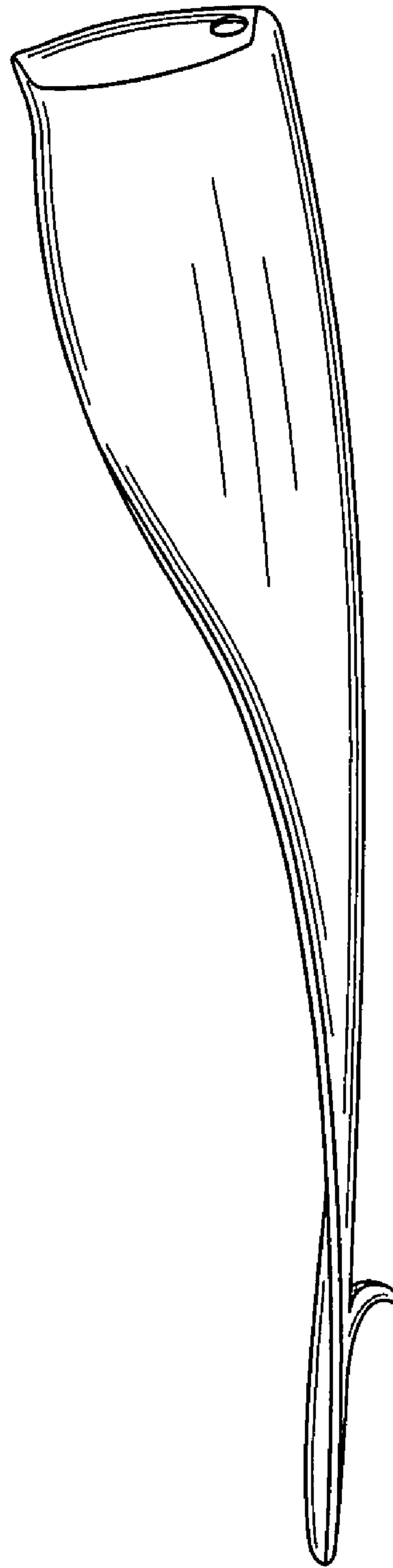

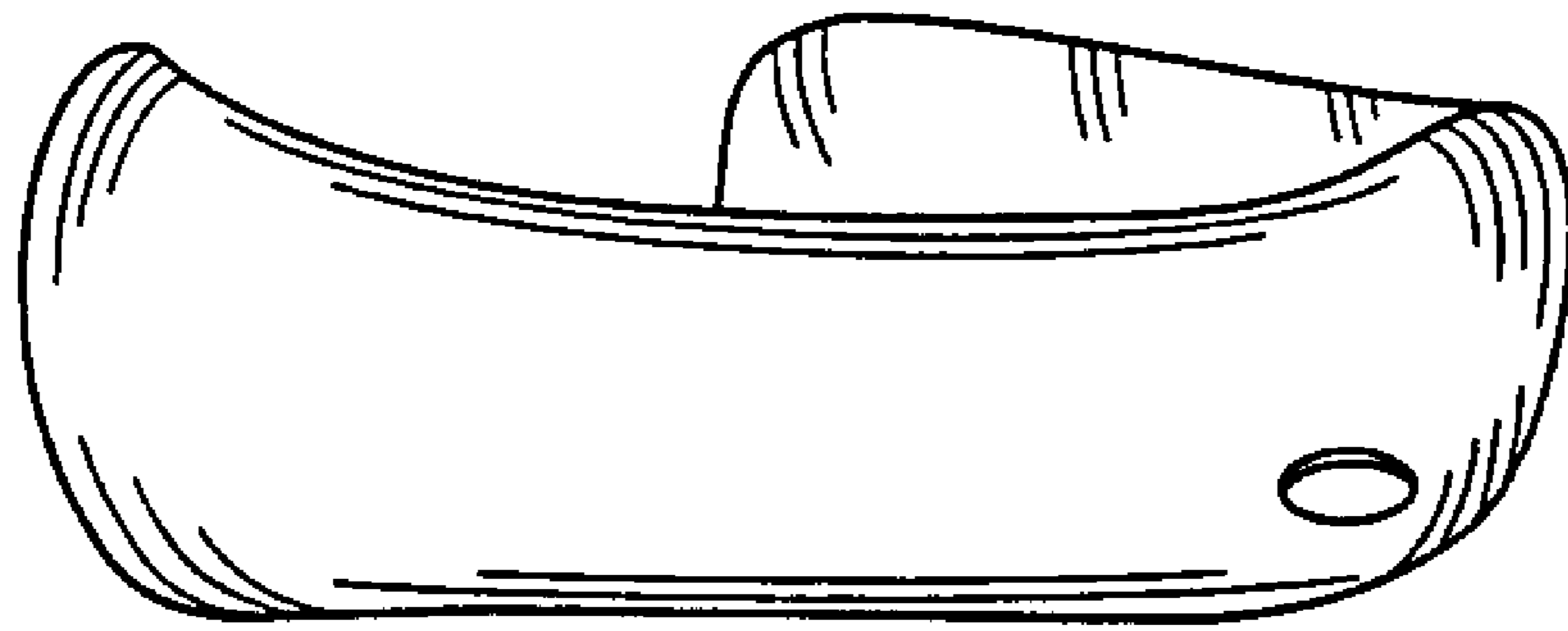

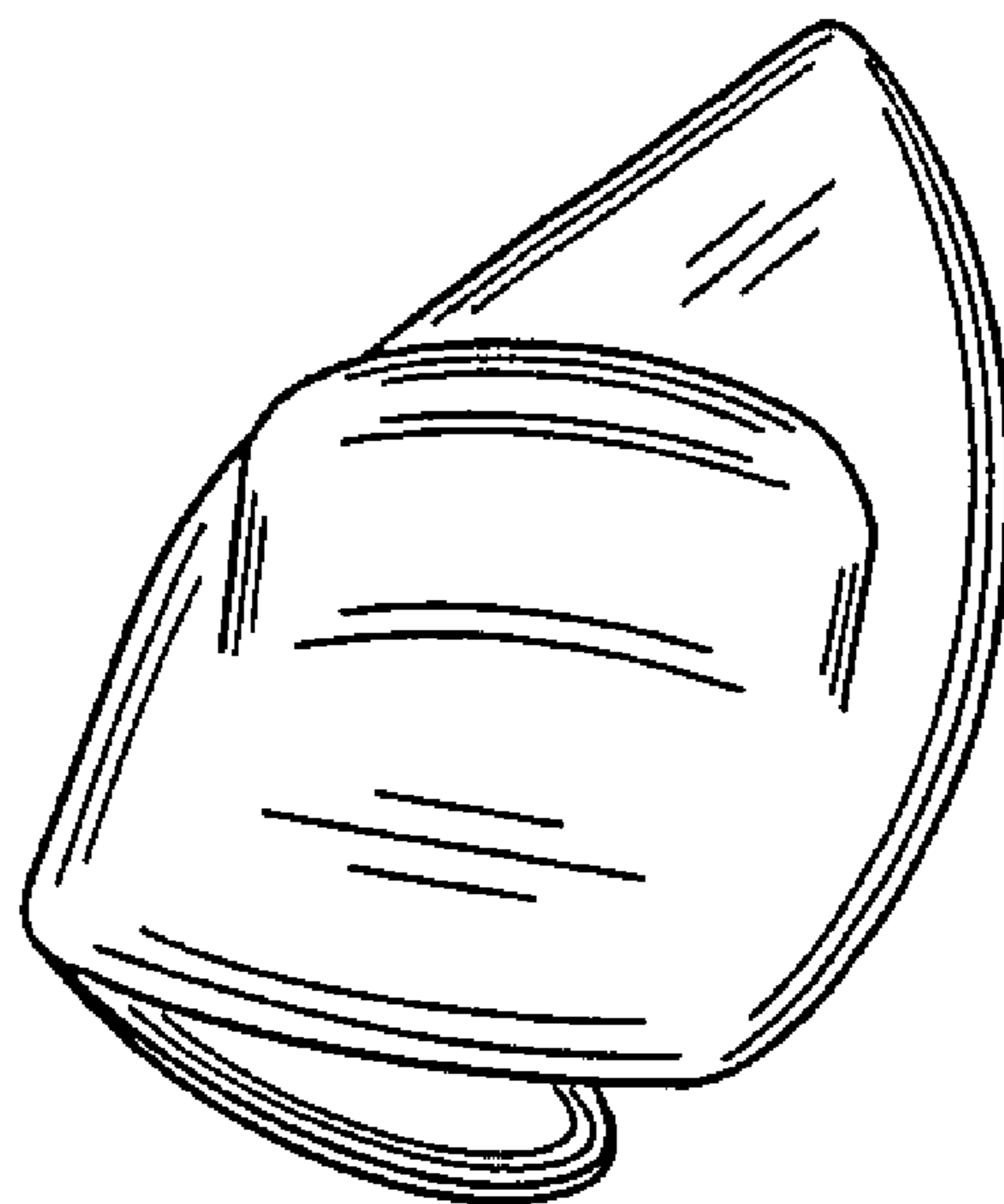
