(57) **CLAIM**

The ornamental design for shoe sole, as shown and described in the drawings.

**DESCRIPTION**

FIG. 1 is a right side, front and top perspective view of a shoe sole in accordance with the new design;  
FIG. 2 is a left side and top perspective view thereof;  
FIG. 3 is a right side and top perspective view thereof;  
FIG. 4 is a front and top perspective view thereof;  
FIG. 5 is a rear and top perspective view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

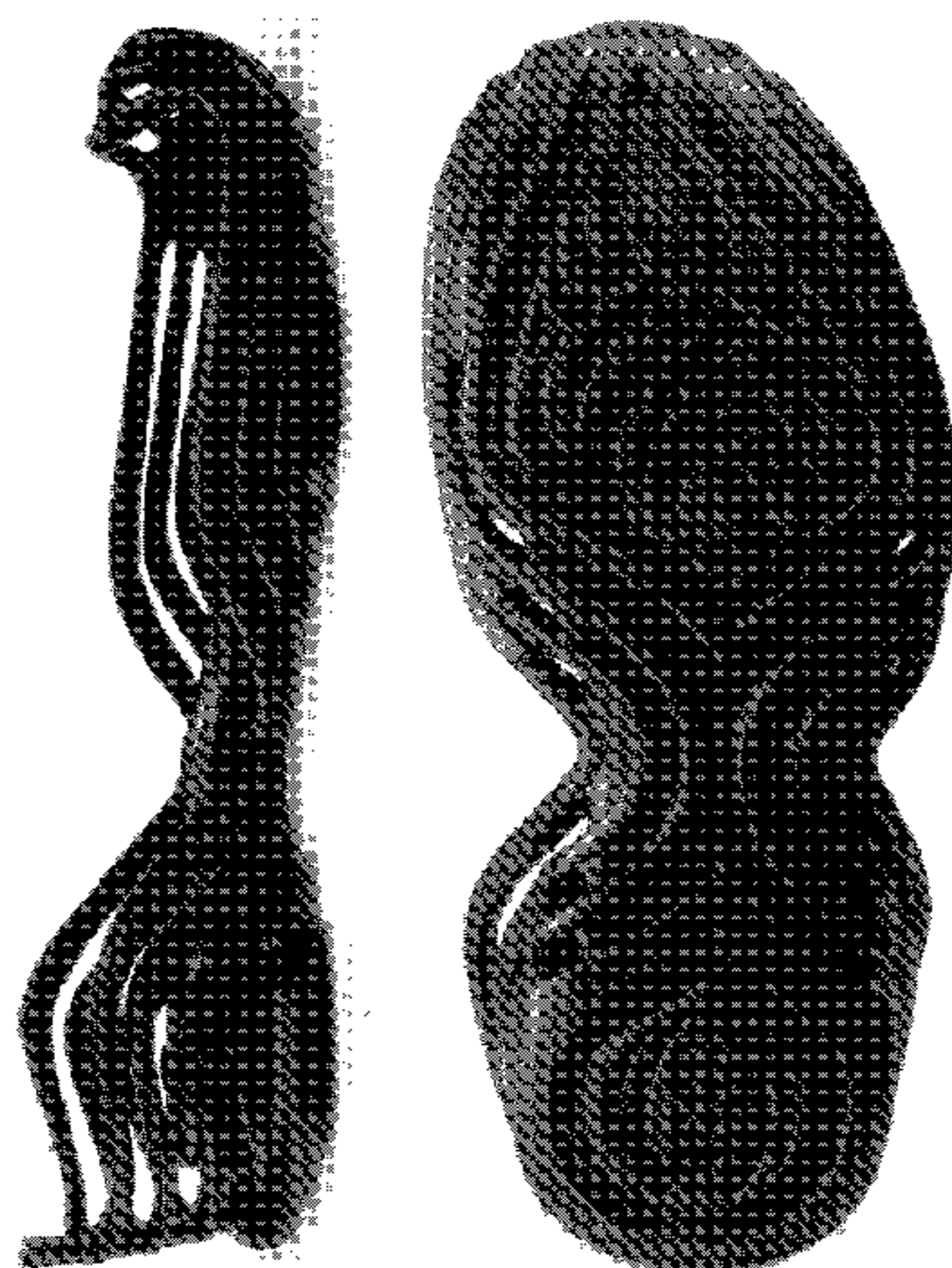

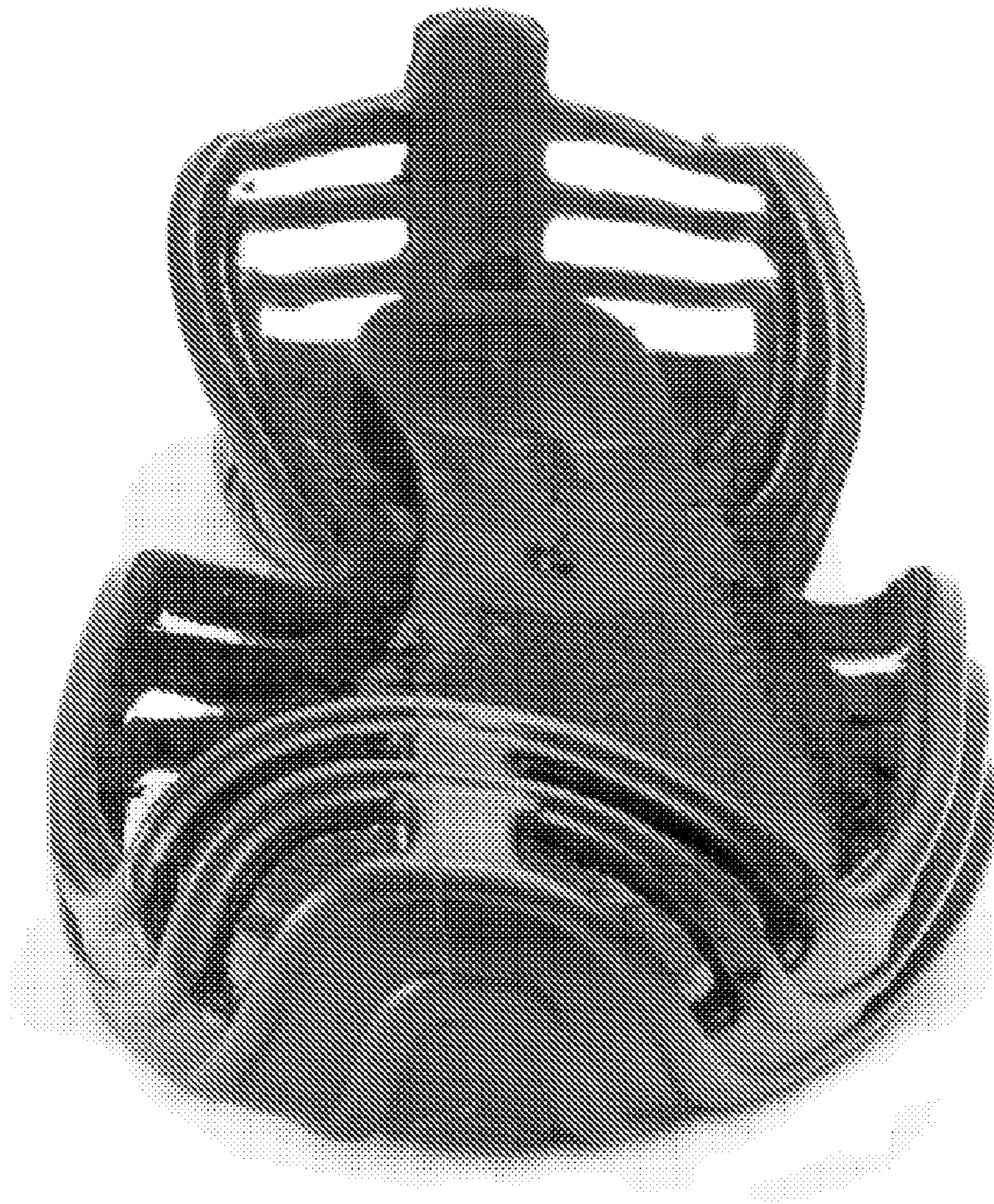

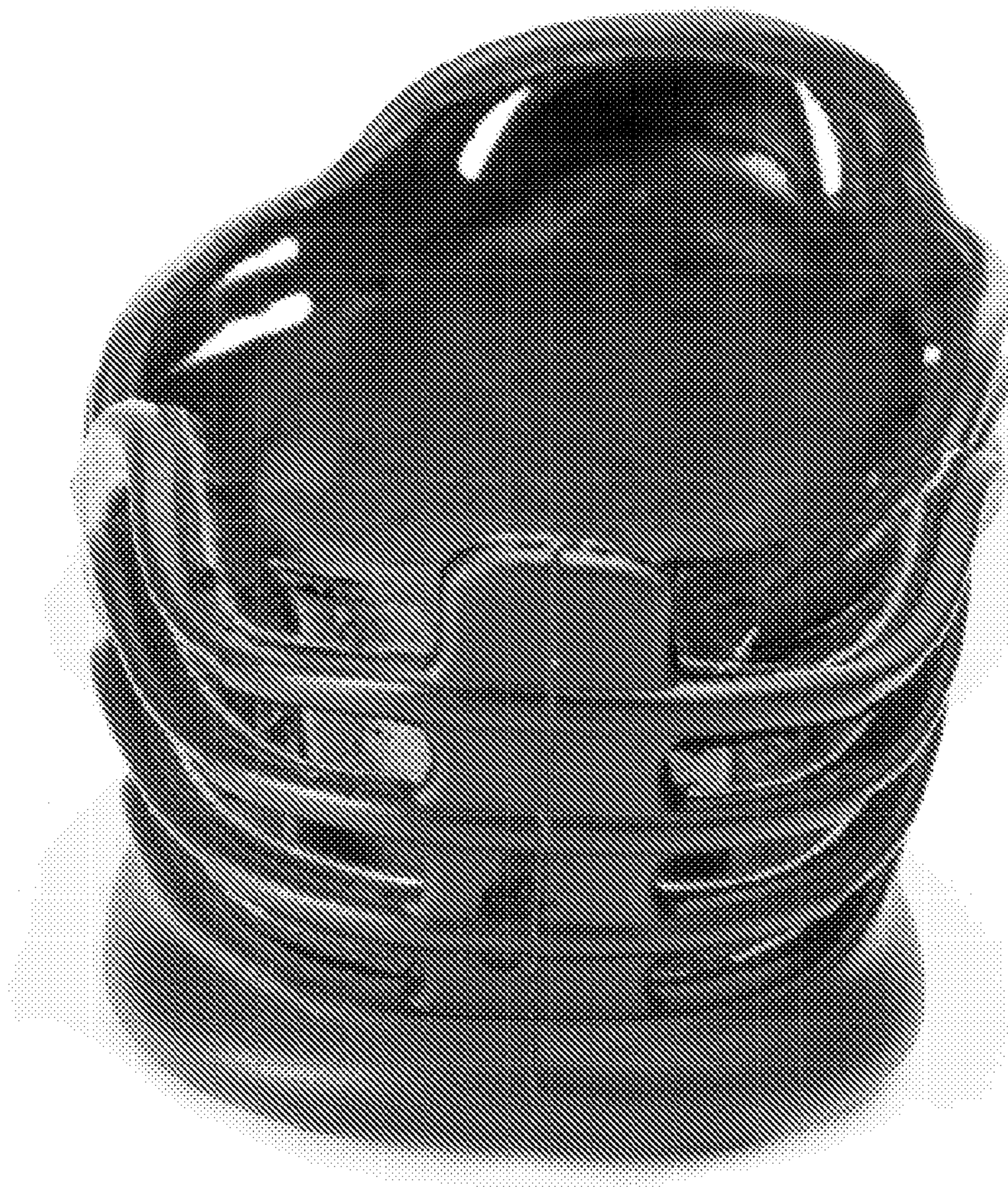

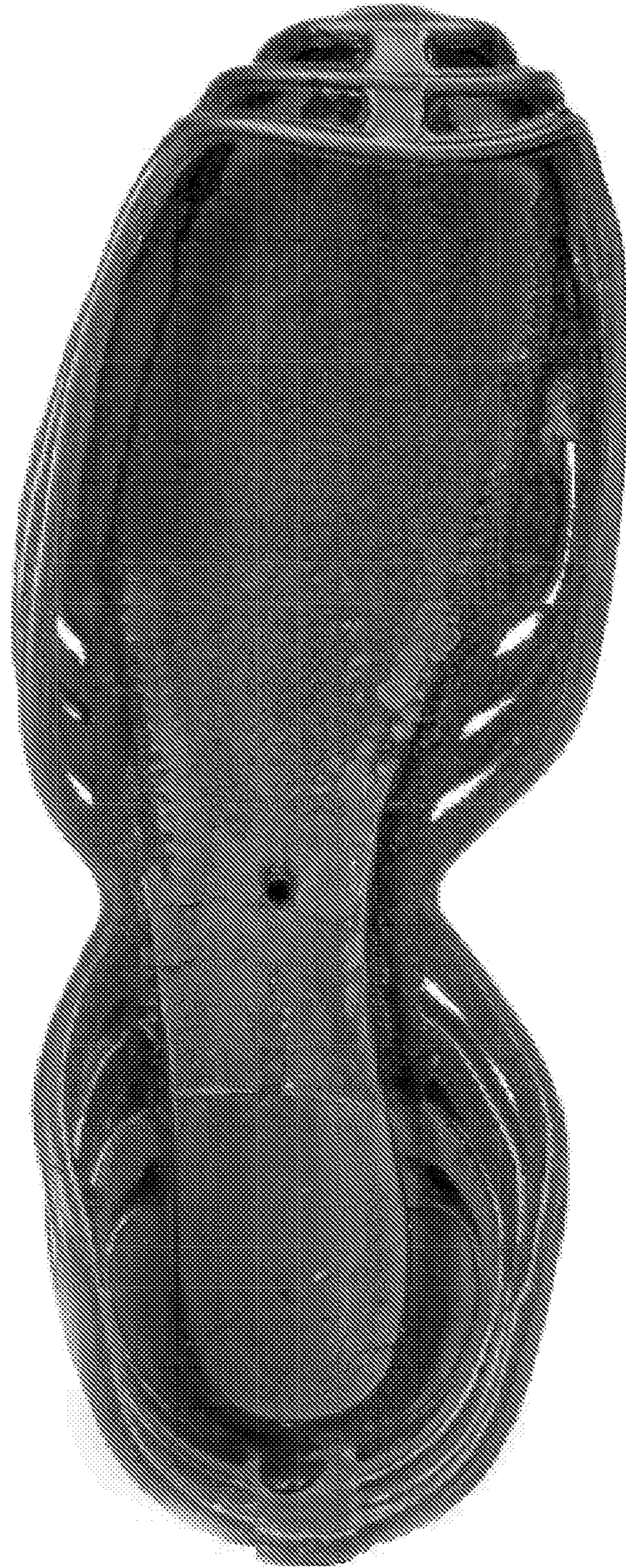
