DESCRIPTION

FIG. 1 is a perspective view of a snow brush showing my present design,

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left view thereof;

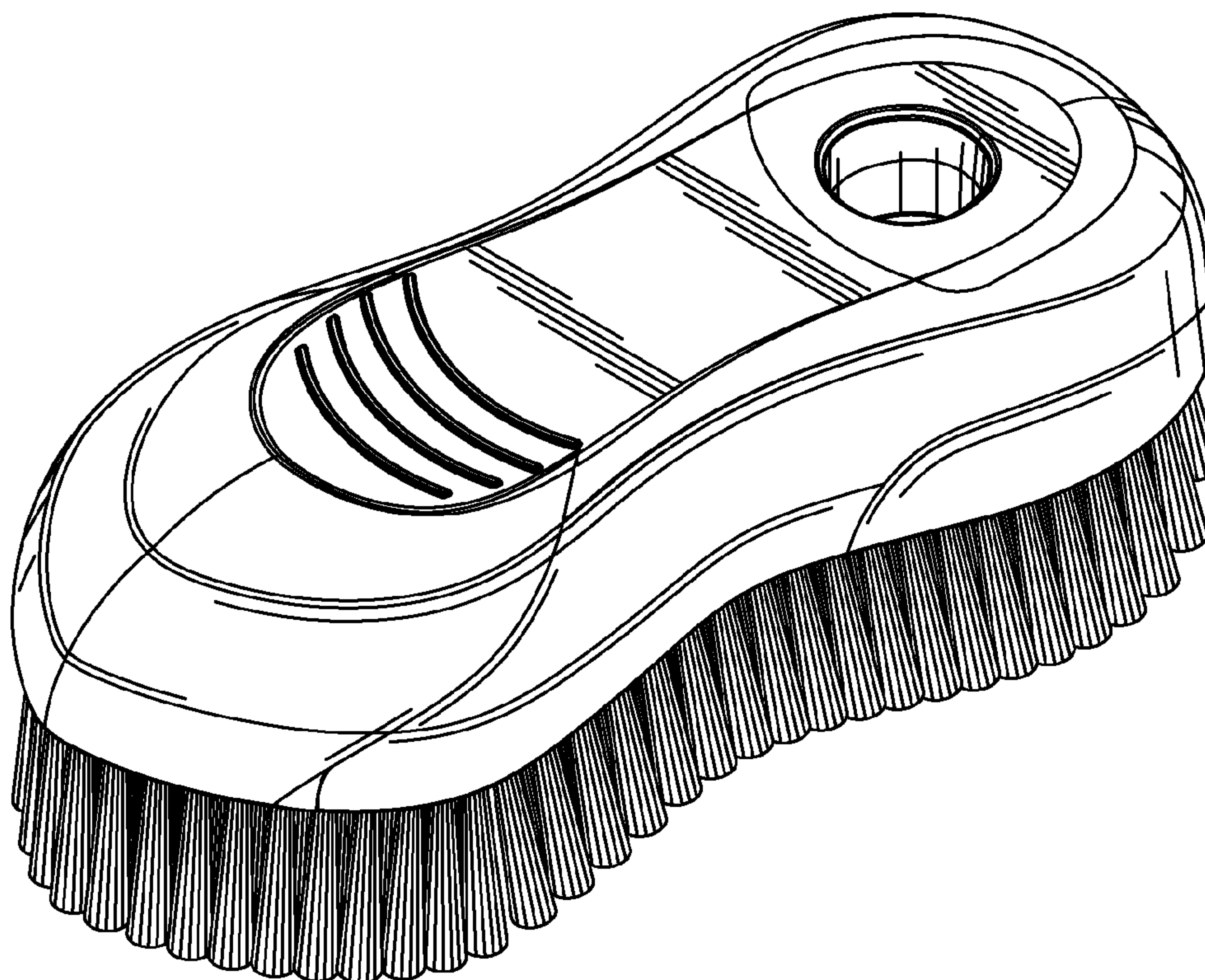
FIG. 5 is a right view thereof;

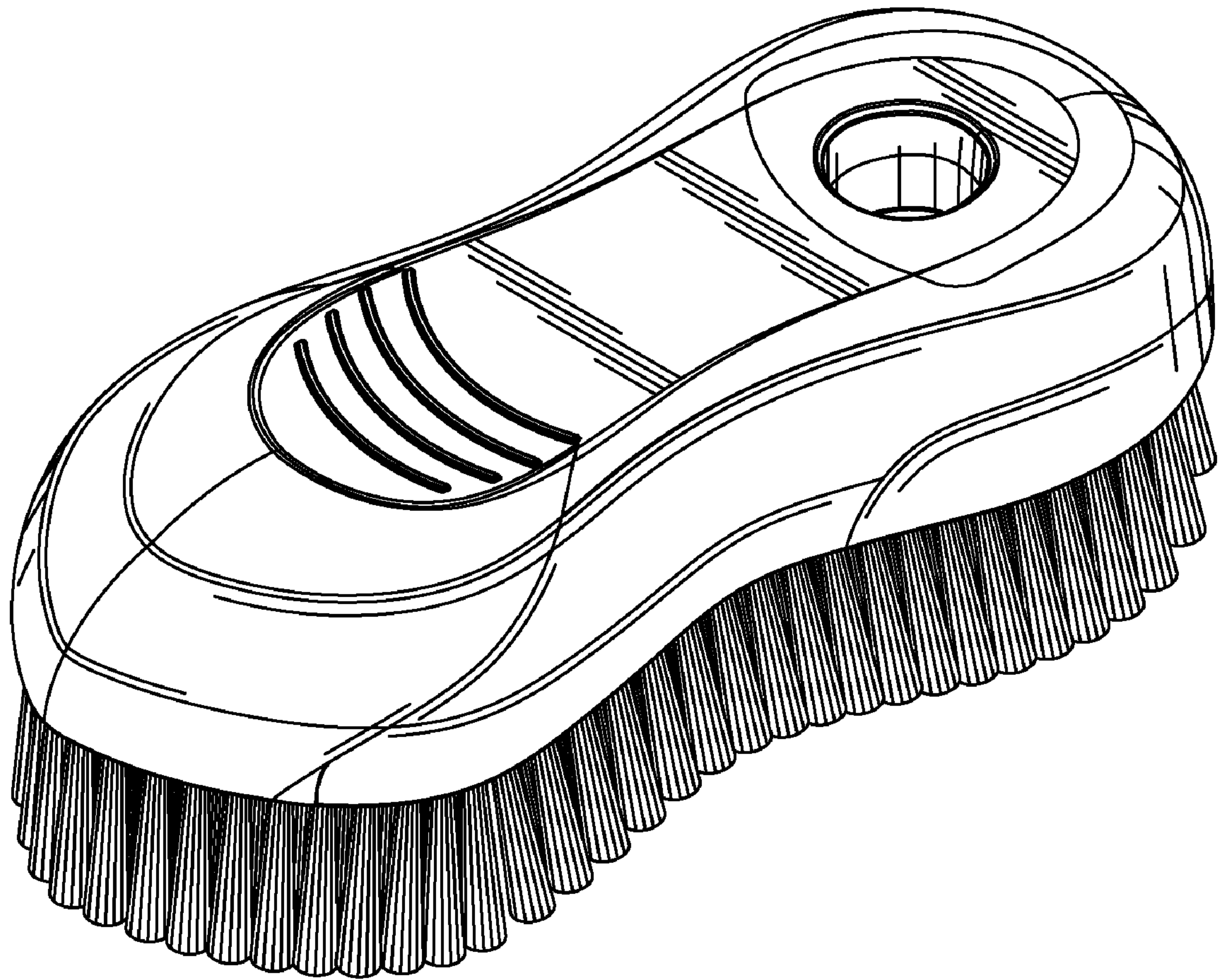

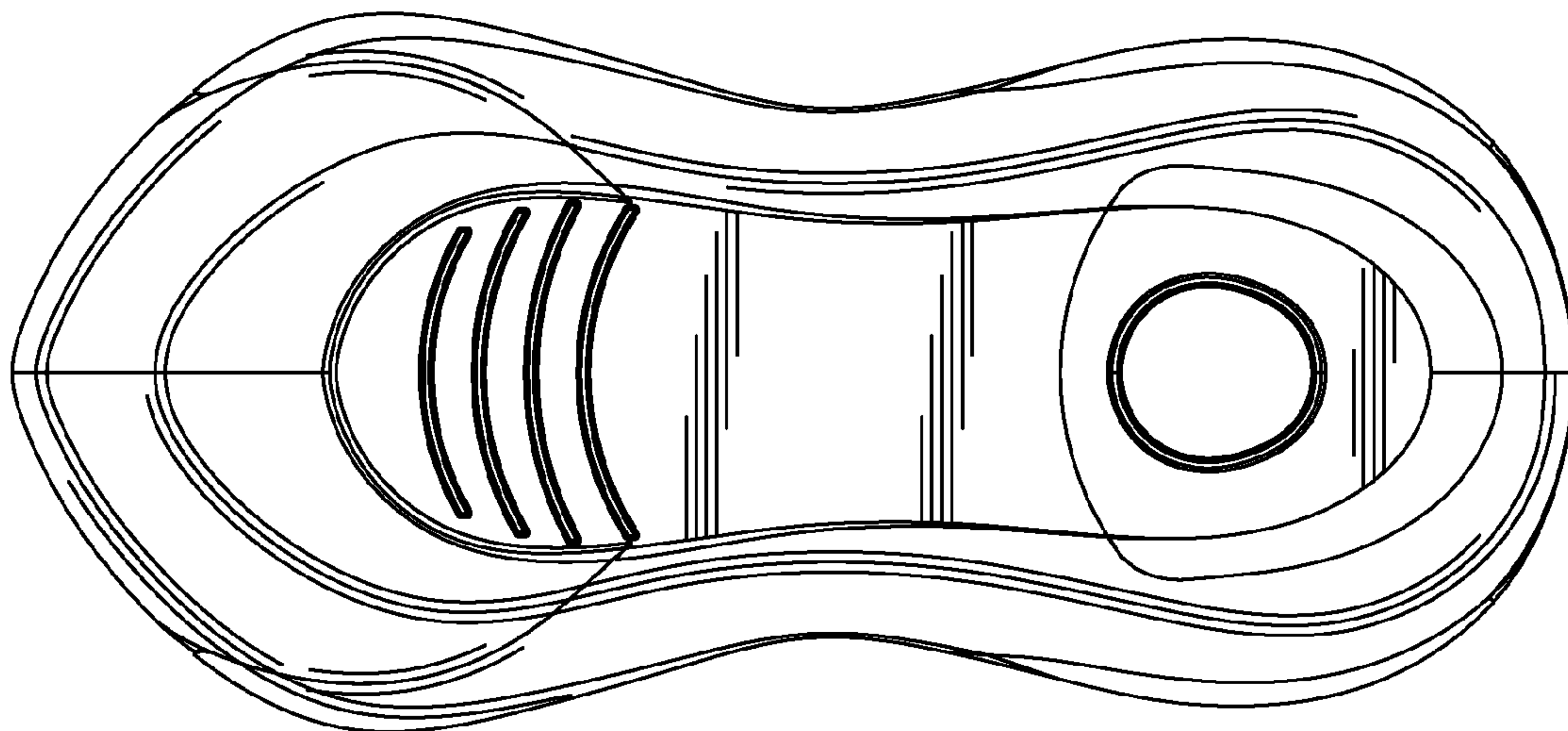

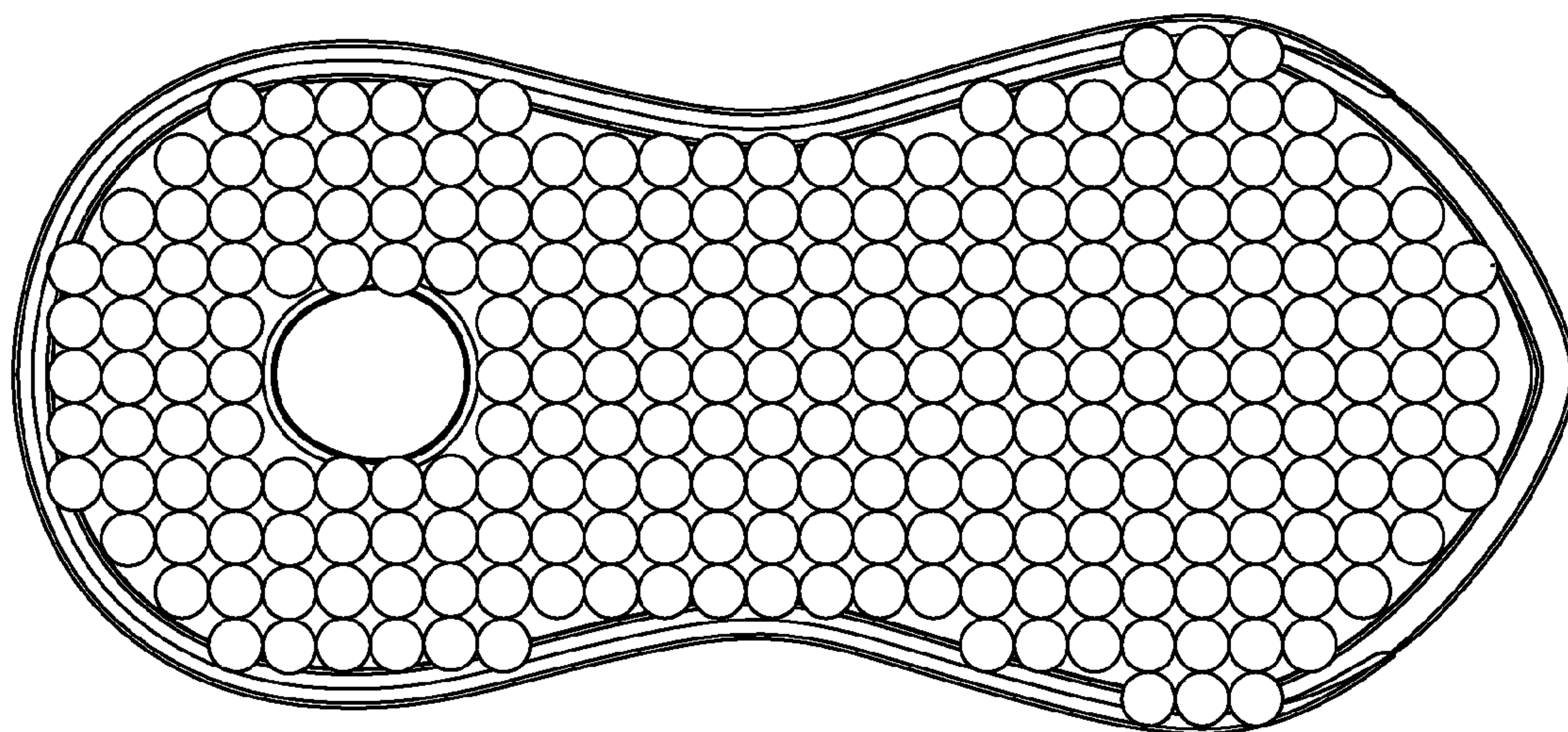

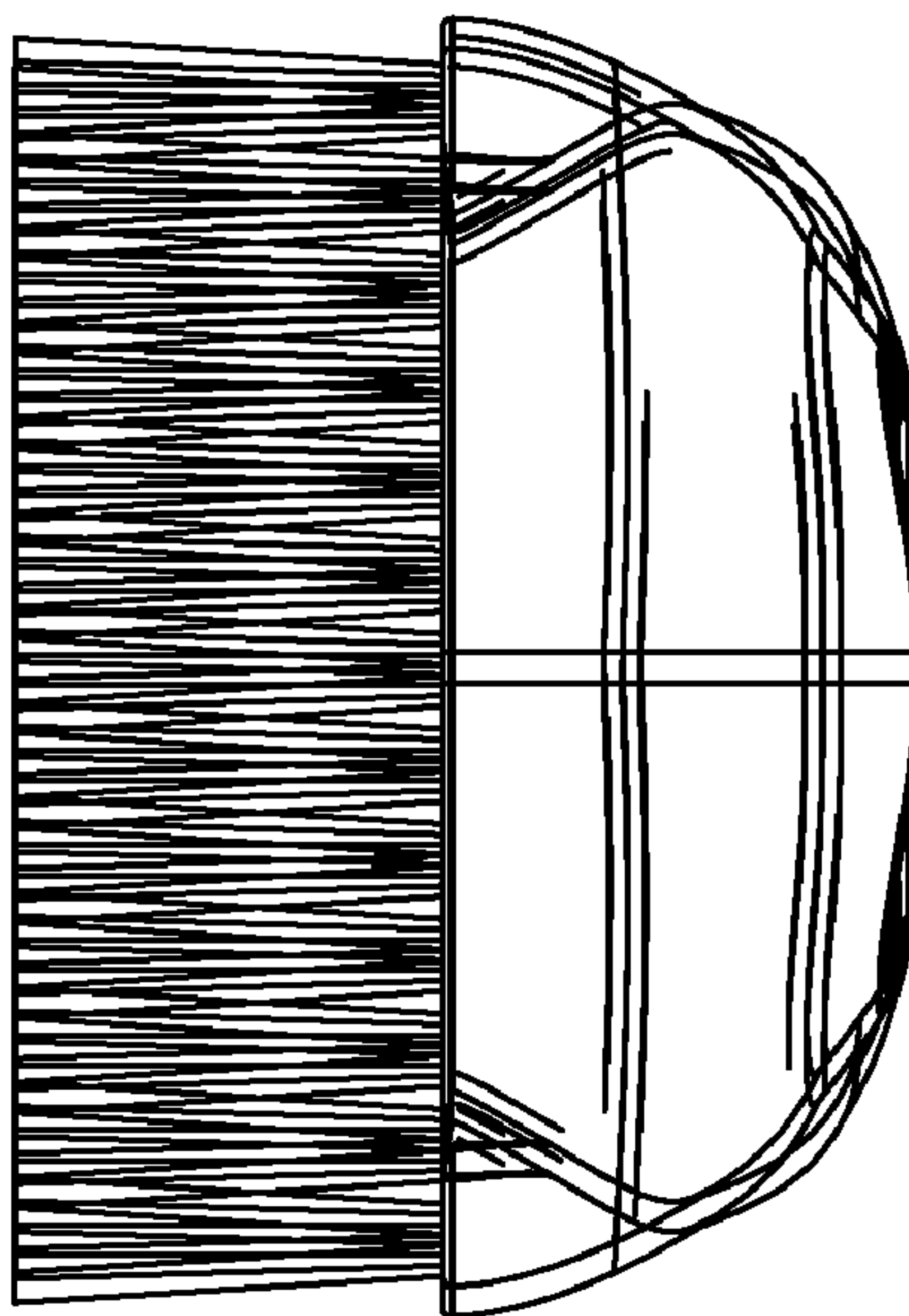

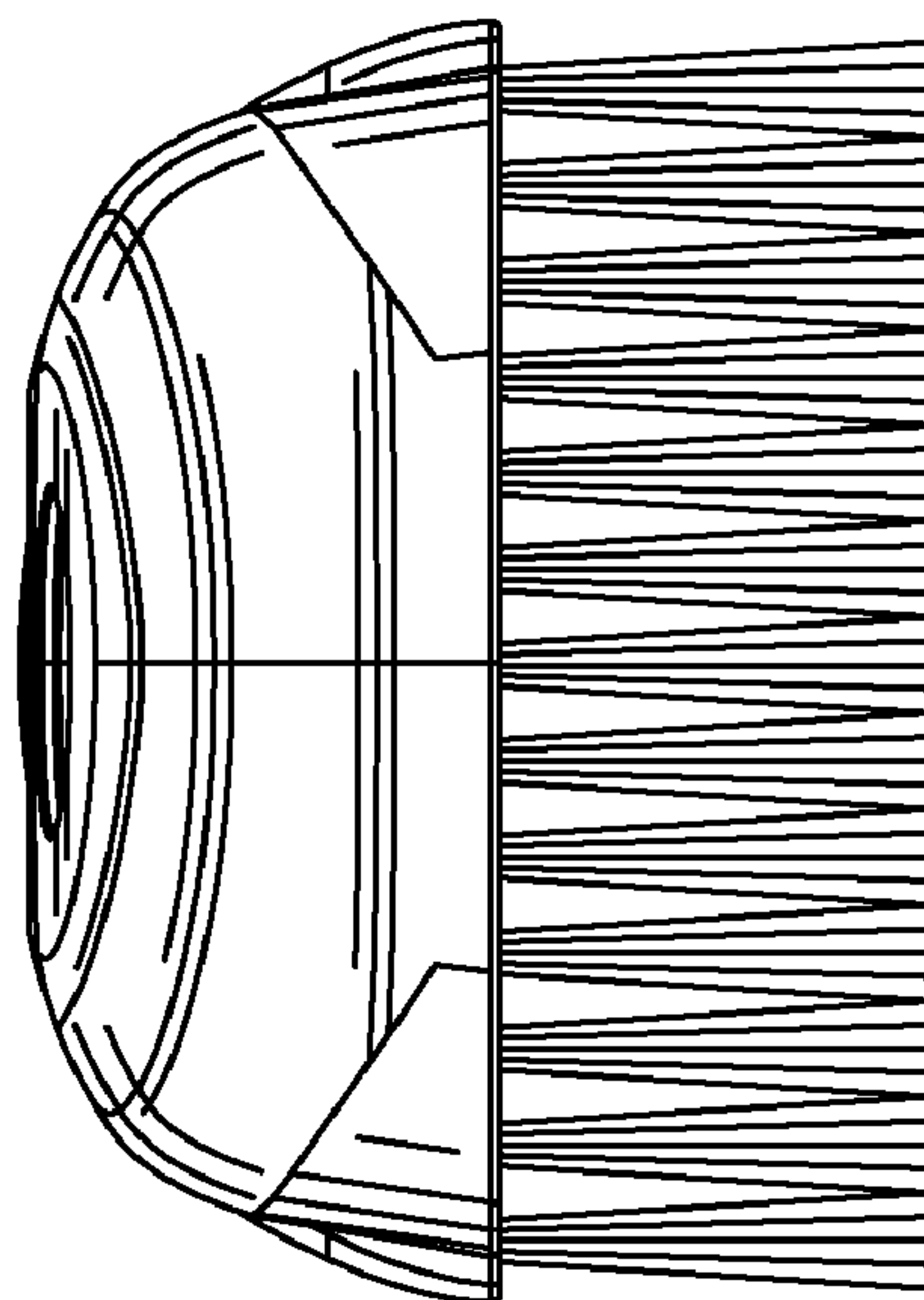

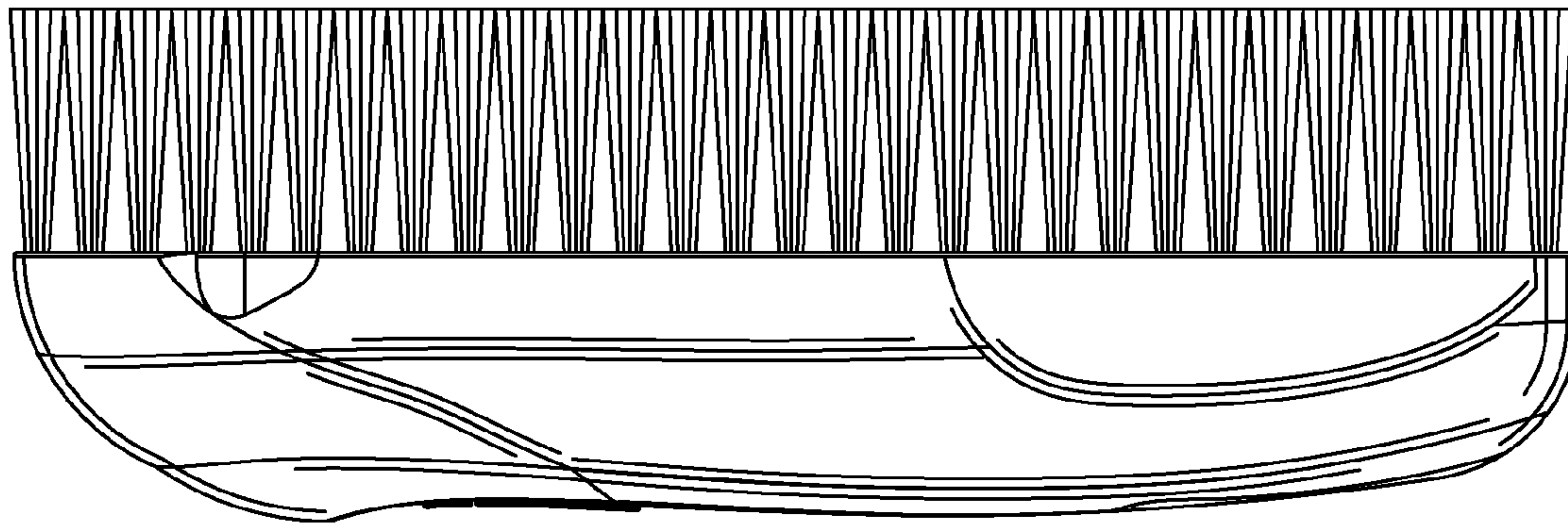

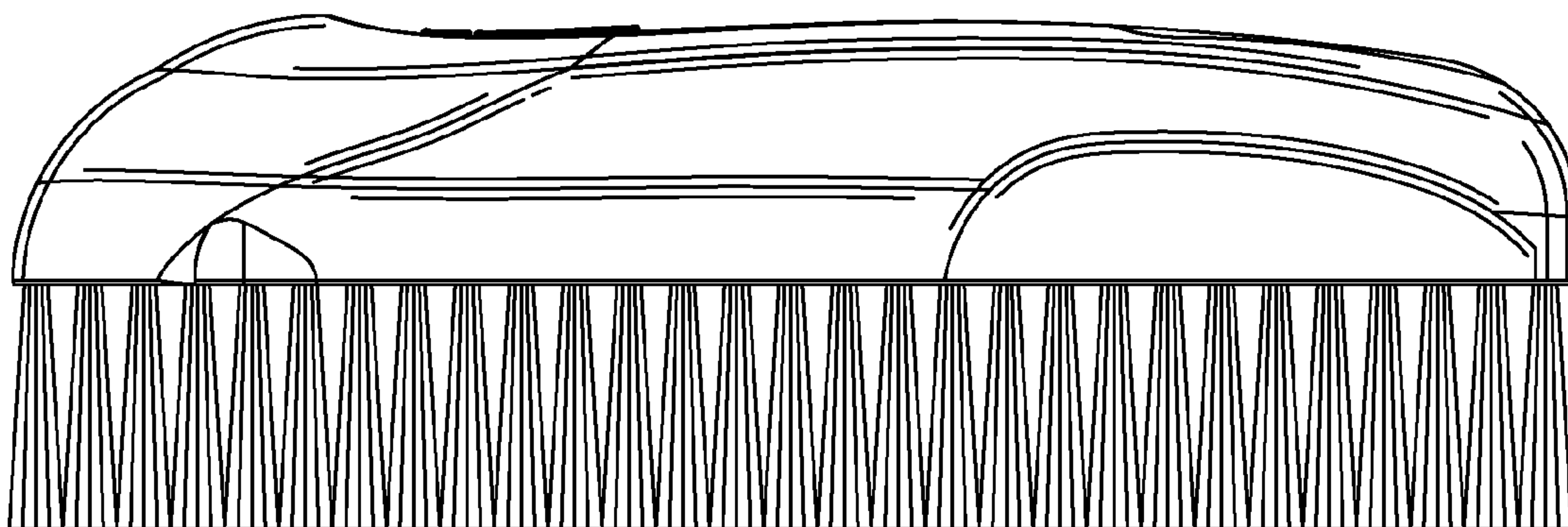
