(57) **CLAIM**

The ornamental design for a laundry worksurface, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of the ornamental design for a first embodiment laundry worksurface according to the invention;

FIG. 2 is a front elevational view of the laundry worksurface of FIG. 1;

FIG. 3 is a right side elevational view of the laundry worksurface of FIG. 1, the left side of which is a mirror image thereof;

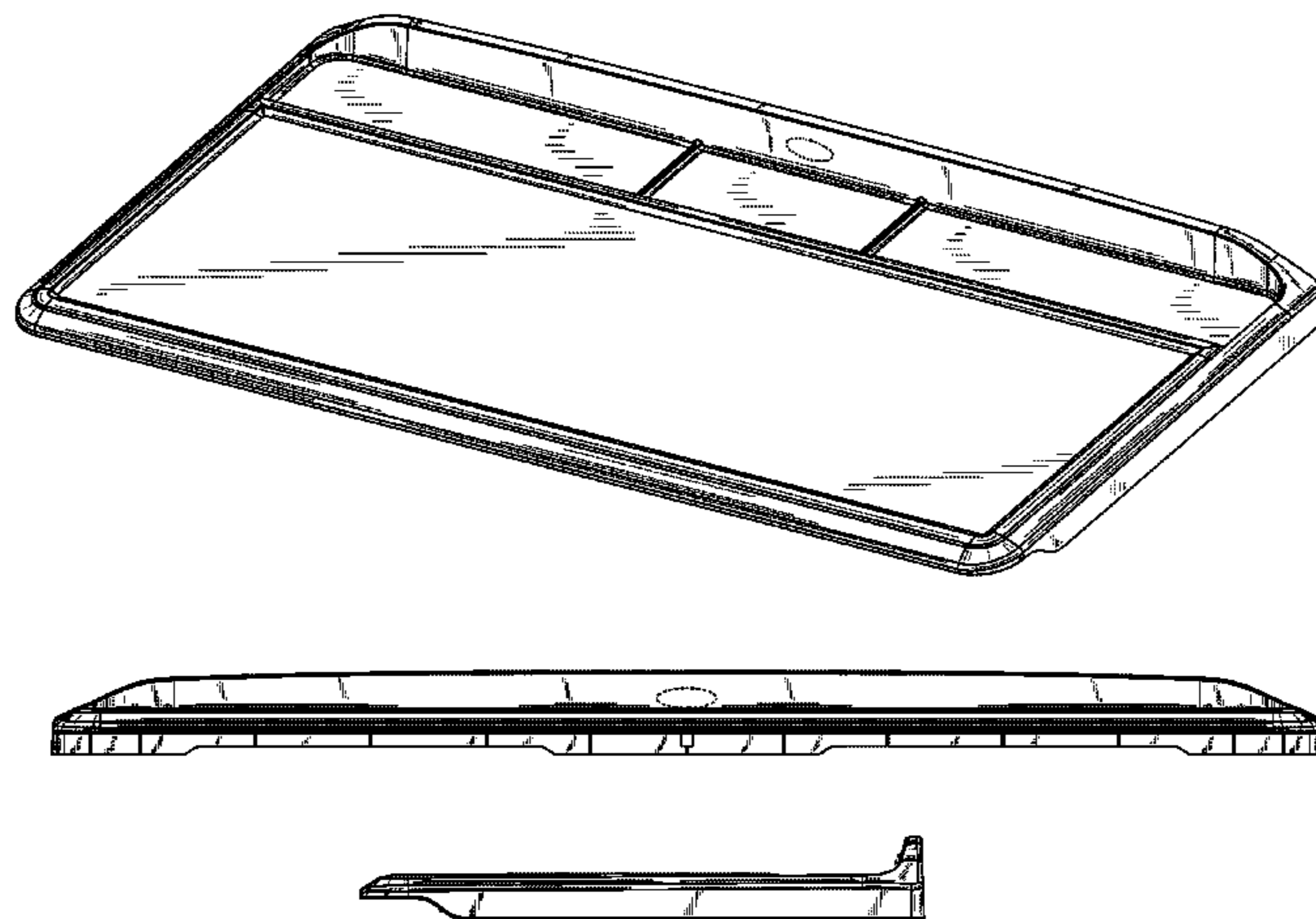
FIG. 4 is a top plan view of the laundry worksurface of FIG. 1;

FIG. 5 is a right front perspective view of the ornamental design for a second embodiment laundry worksurface according to the invention; and,

FIG. 6 is a right front perspective view of the ornamental design for a third embodiment laundry worksurface according to the invention.

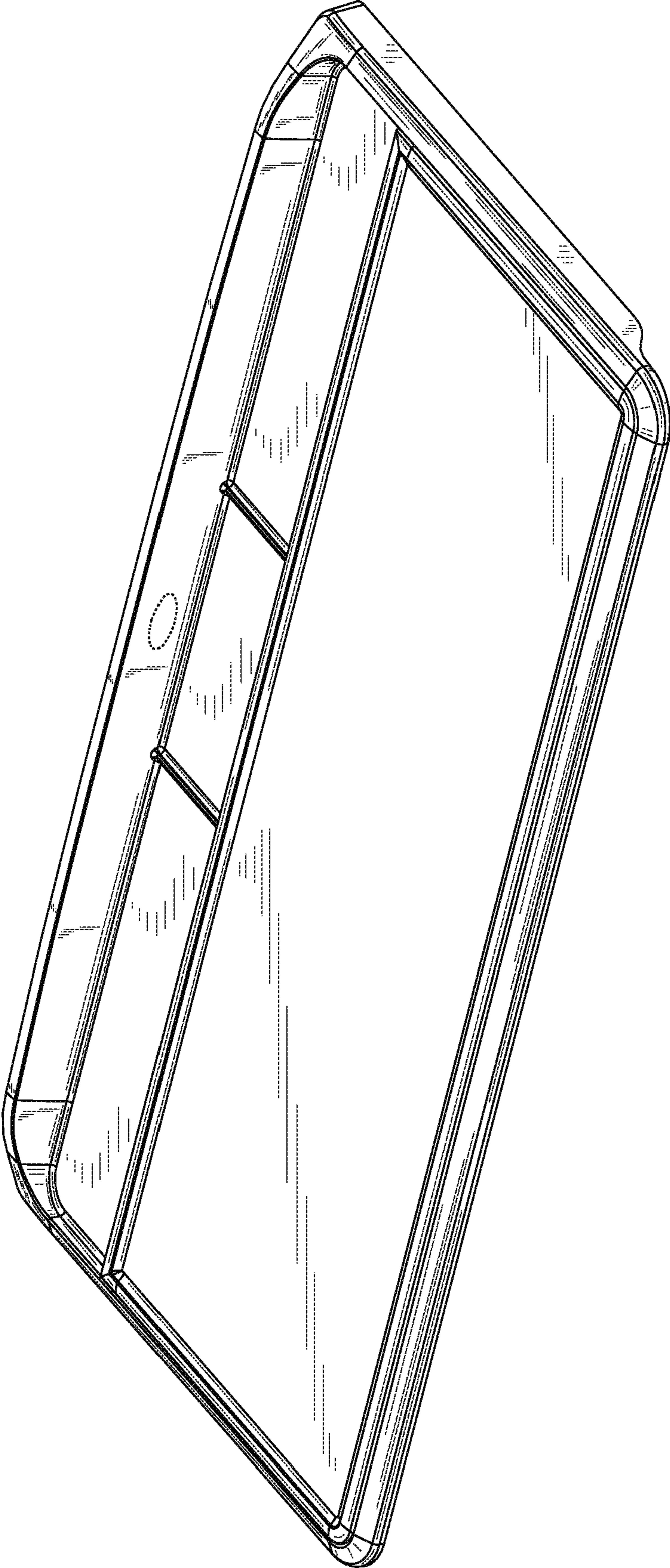

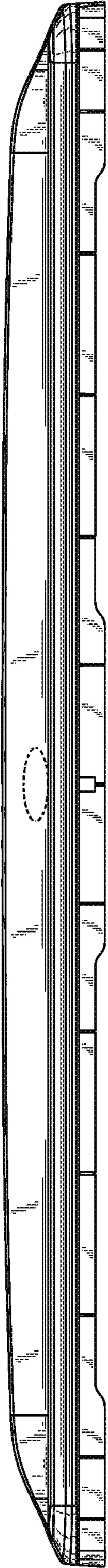

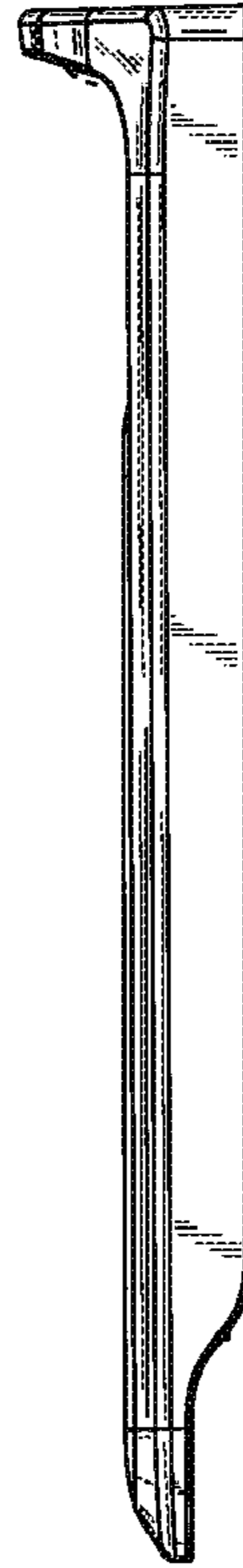

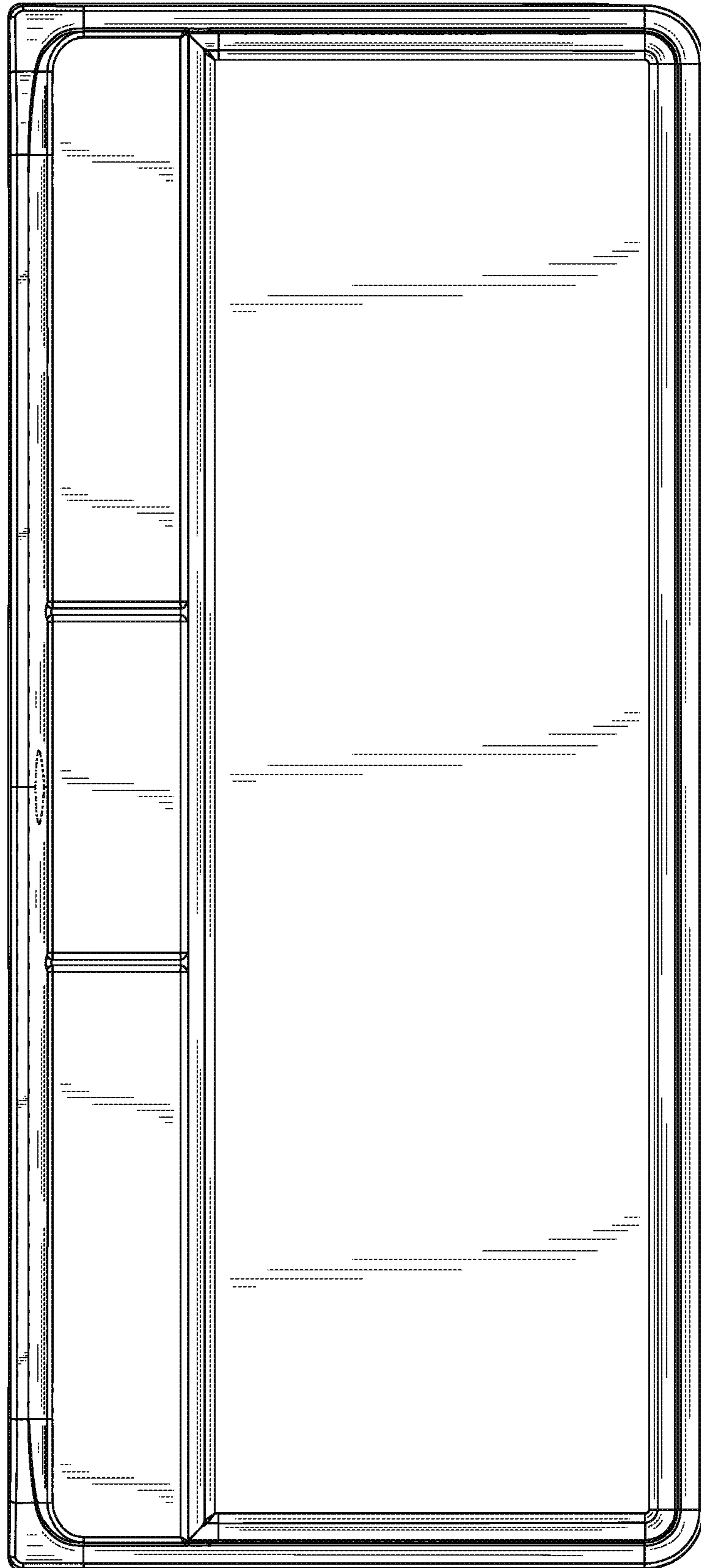

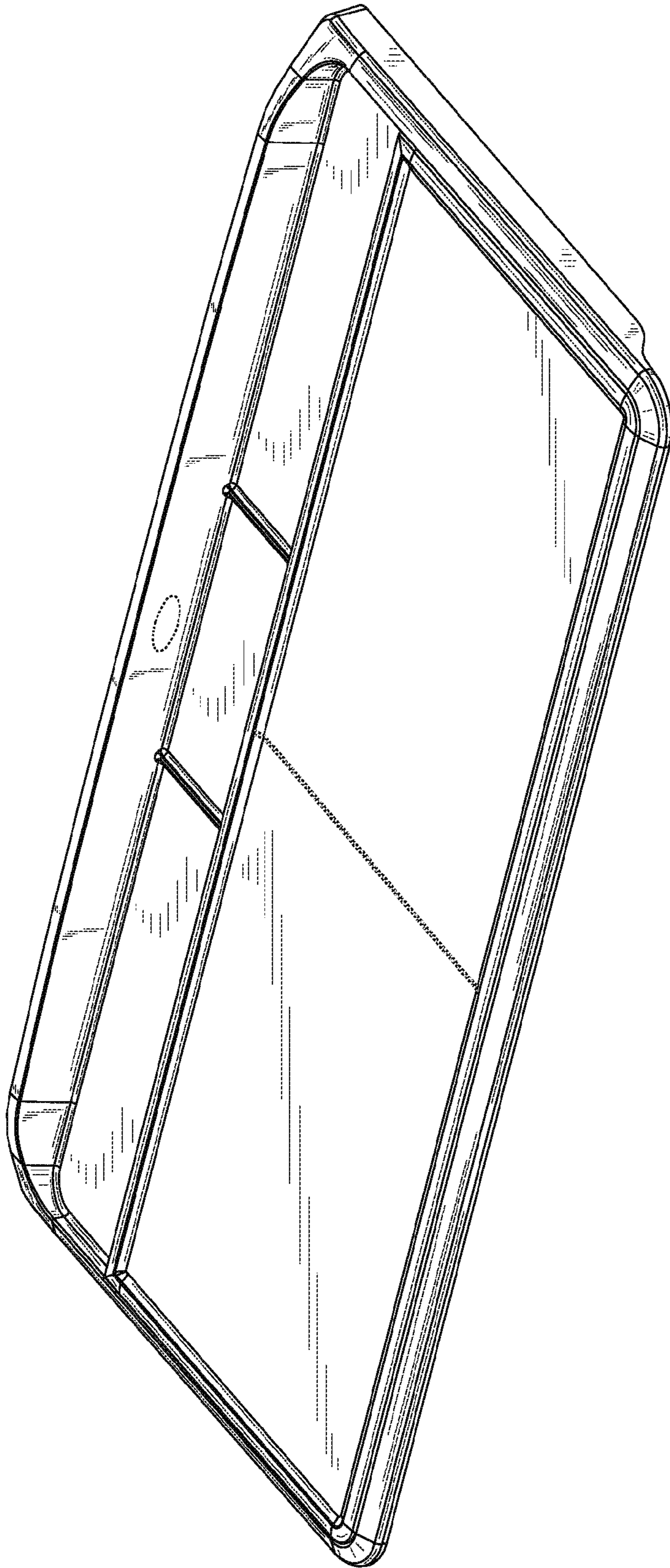

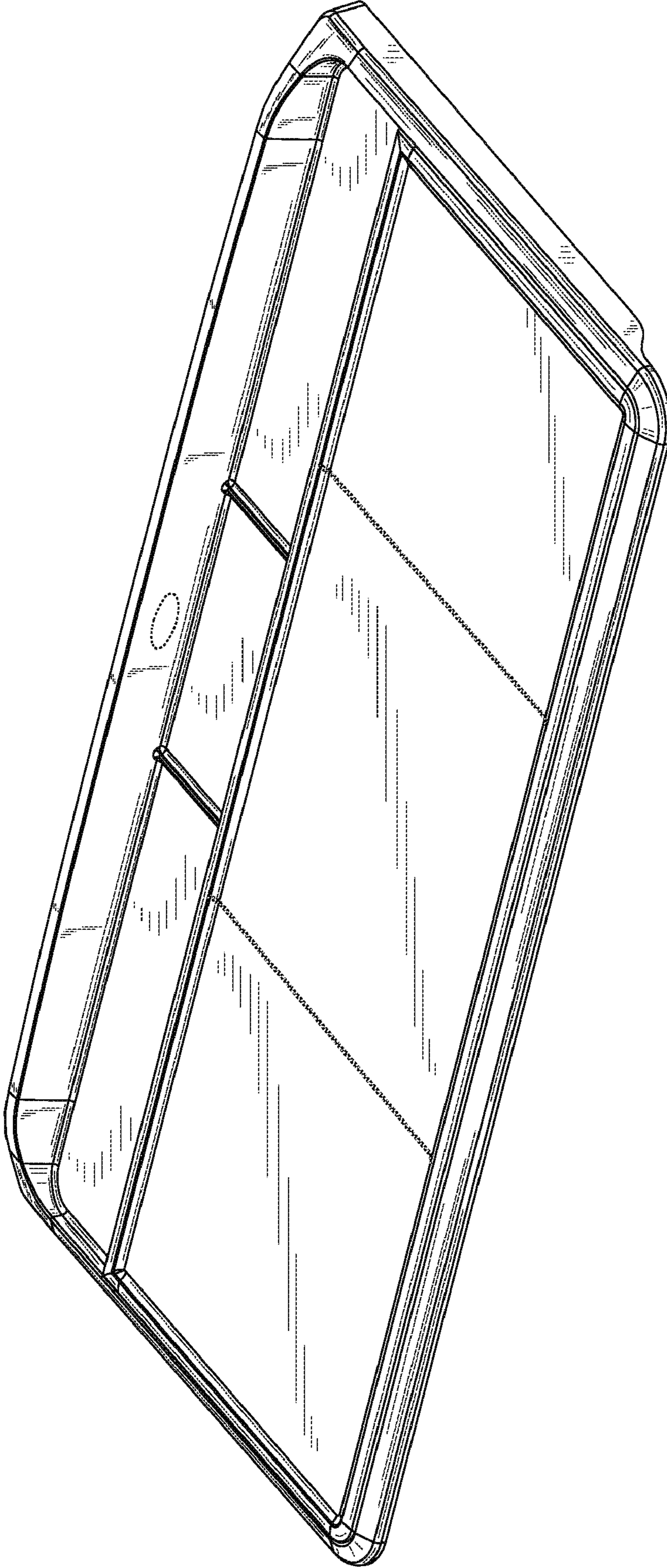
