(57) **CLAIM**

The ornamental design for a wall plate, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a first embodiment of a wall plate showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

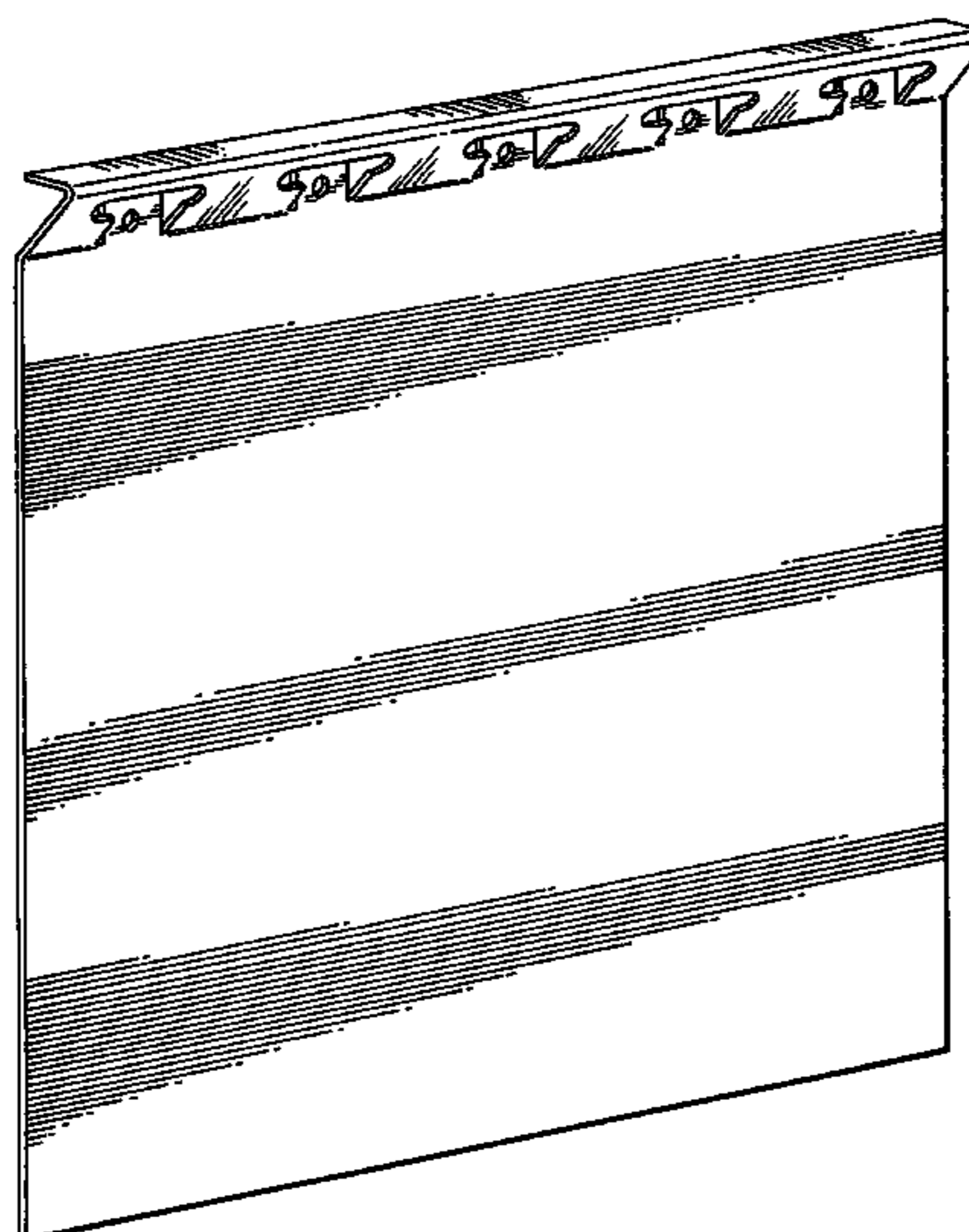
FIG. 6 is a top plan view thereof;

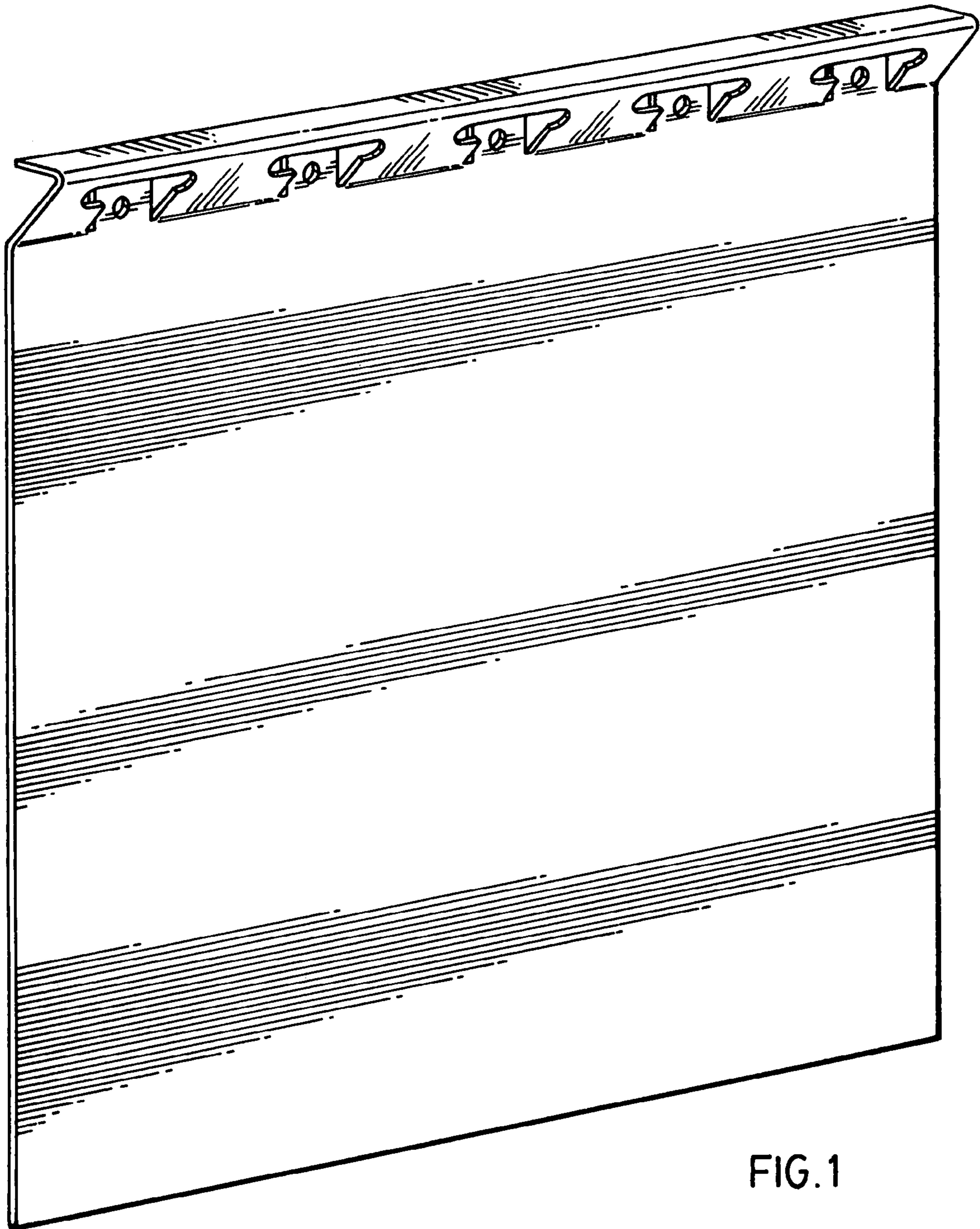

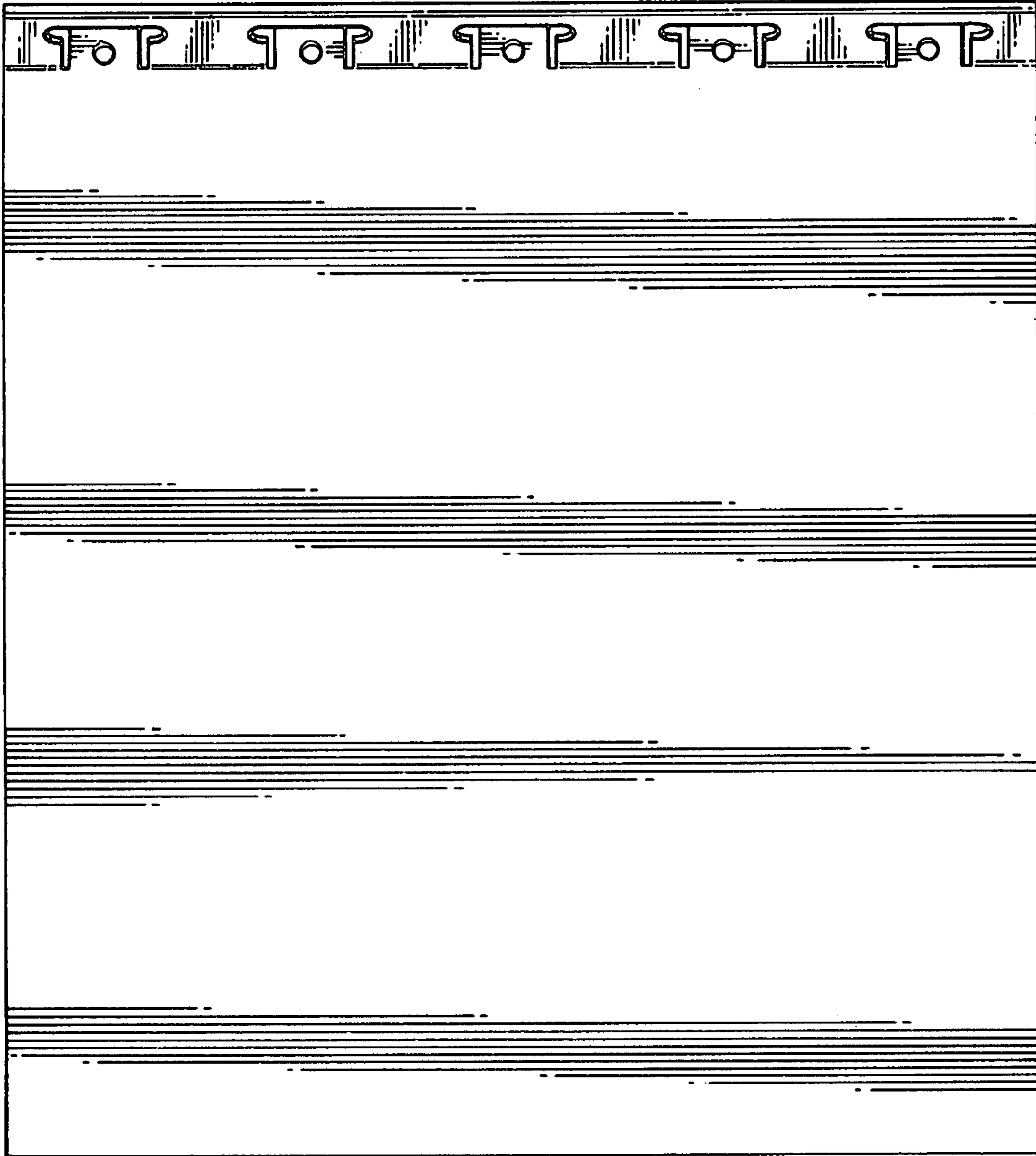

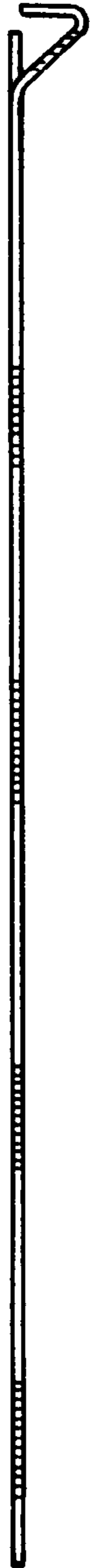
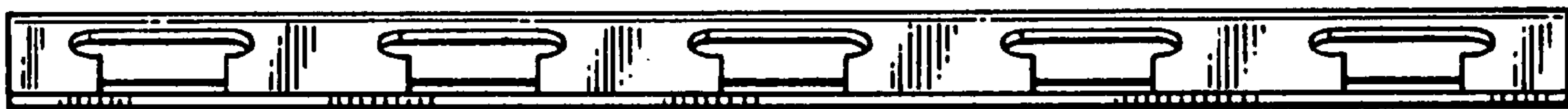

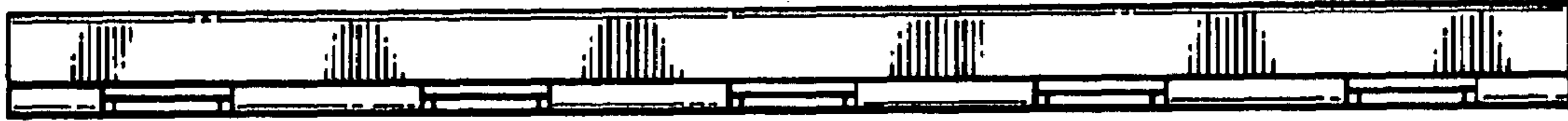

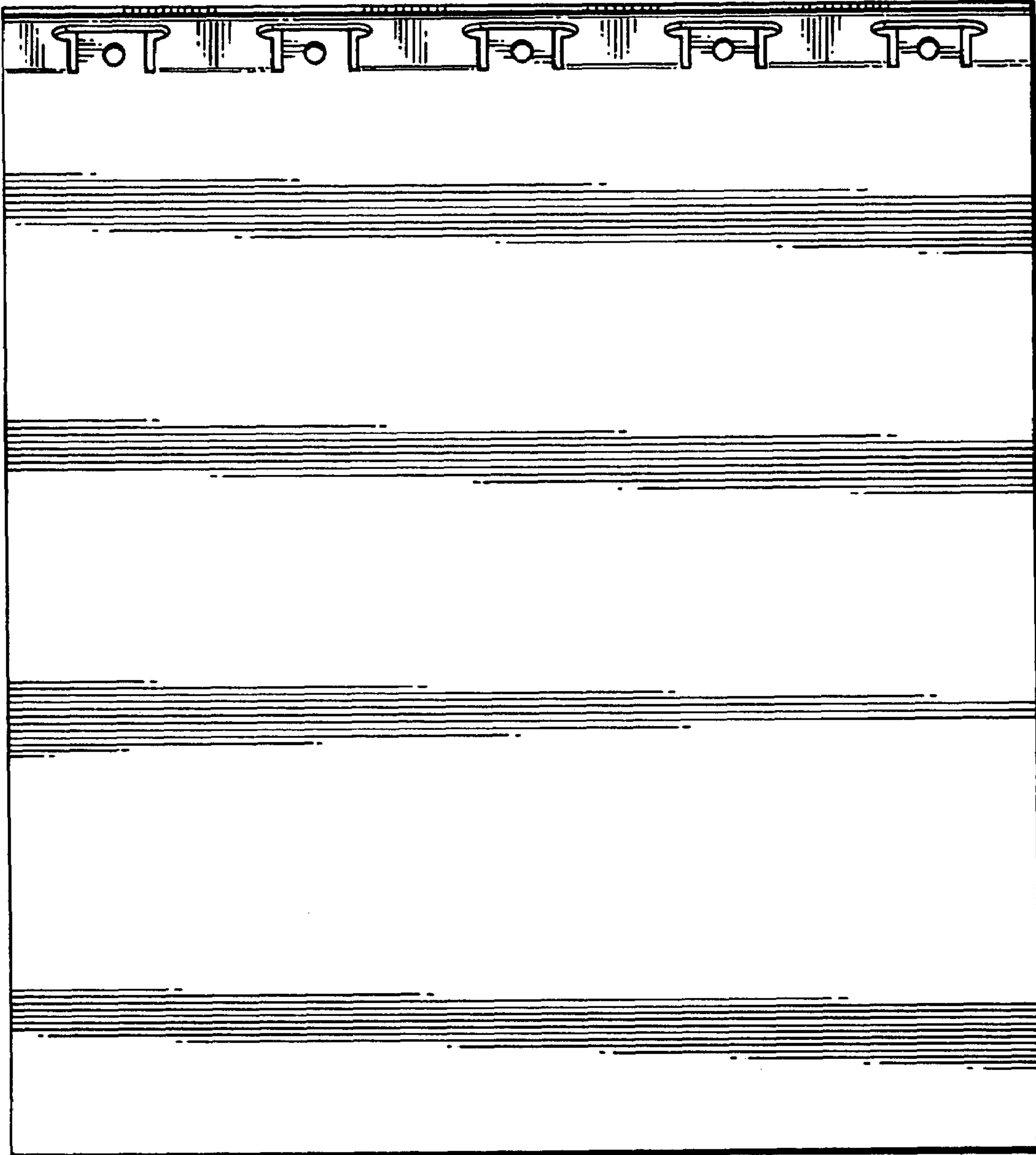

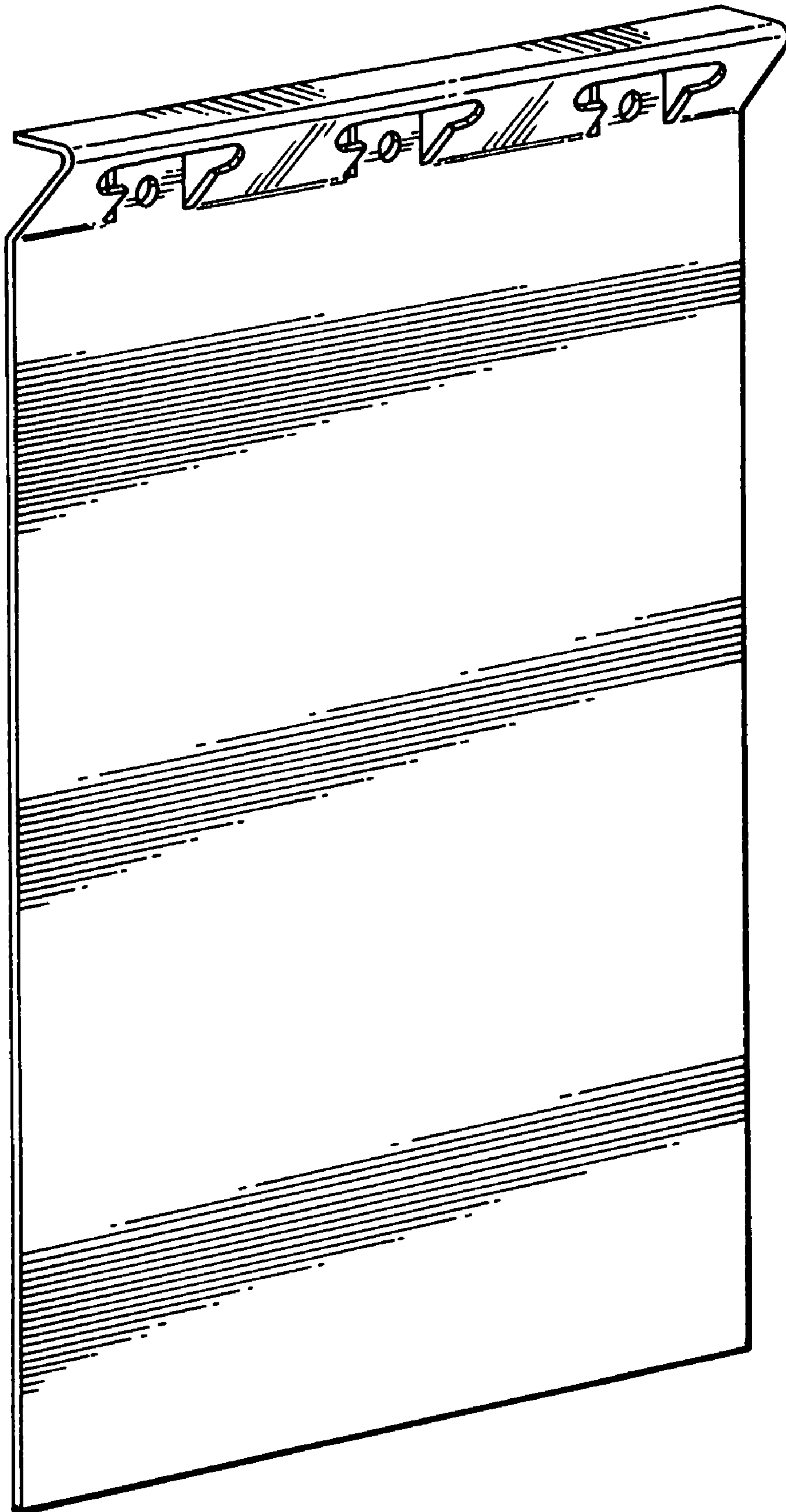

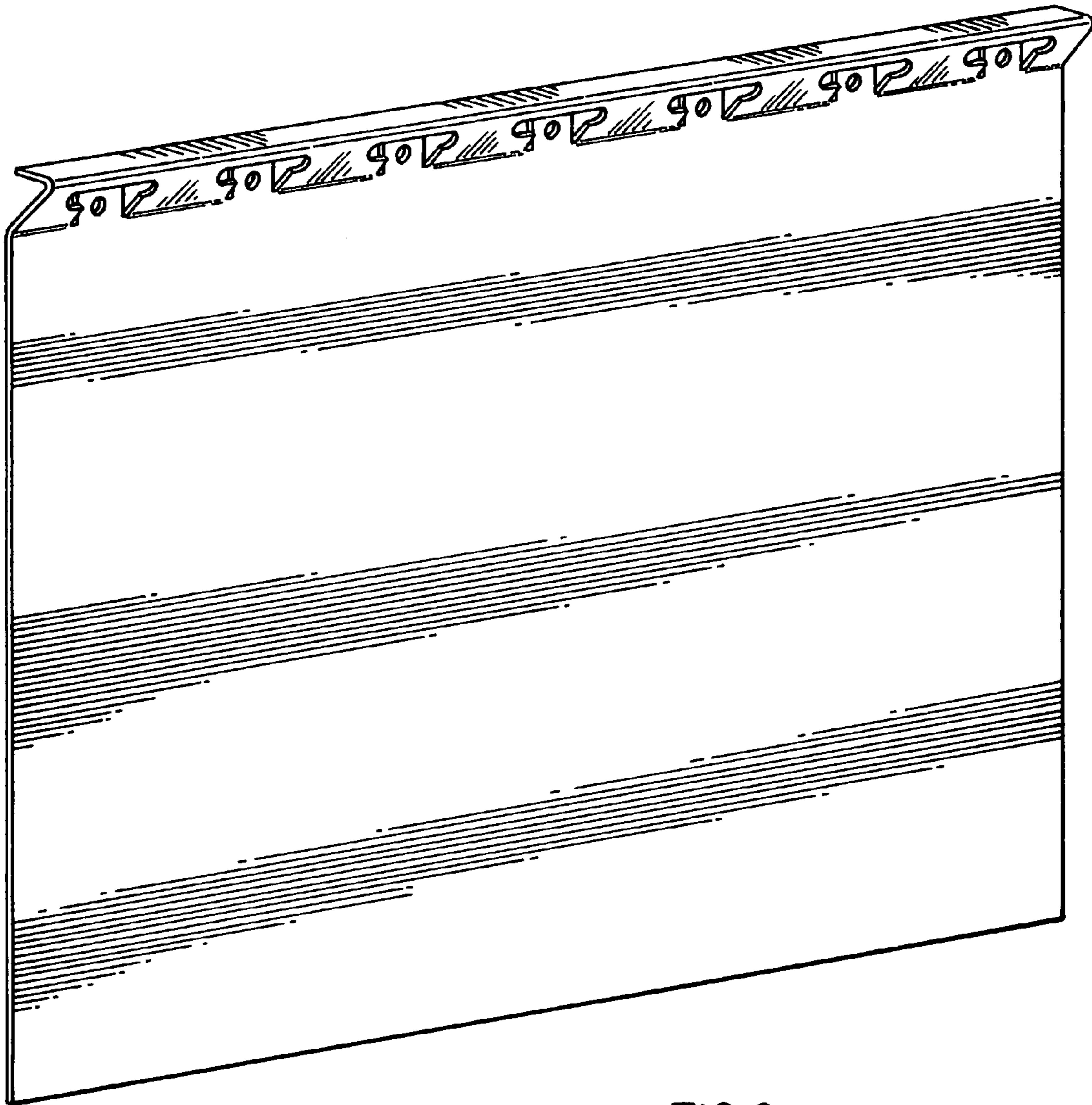
