We claim the ornamental design for a case for storing
recording media such as CDs or DVDs, as shown and
described.

claim.

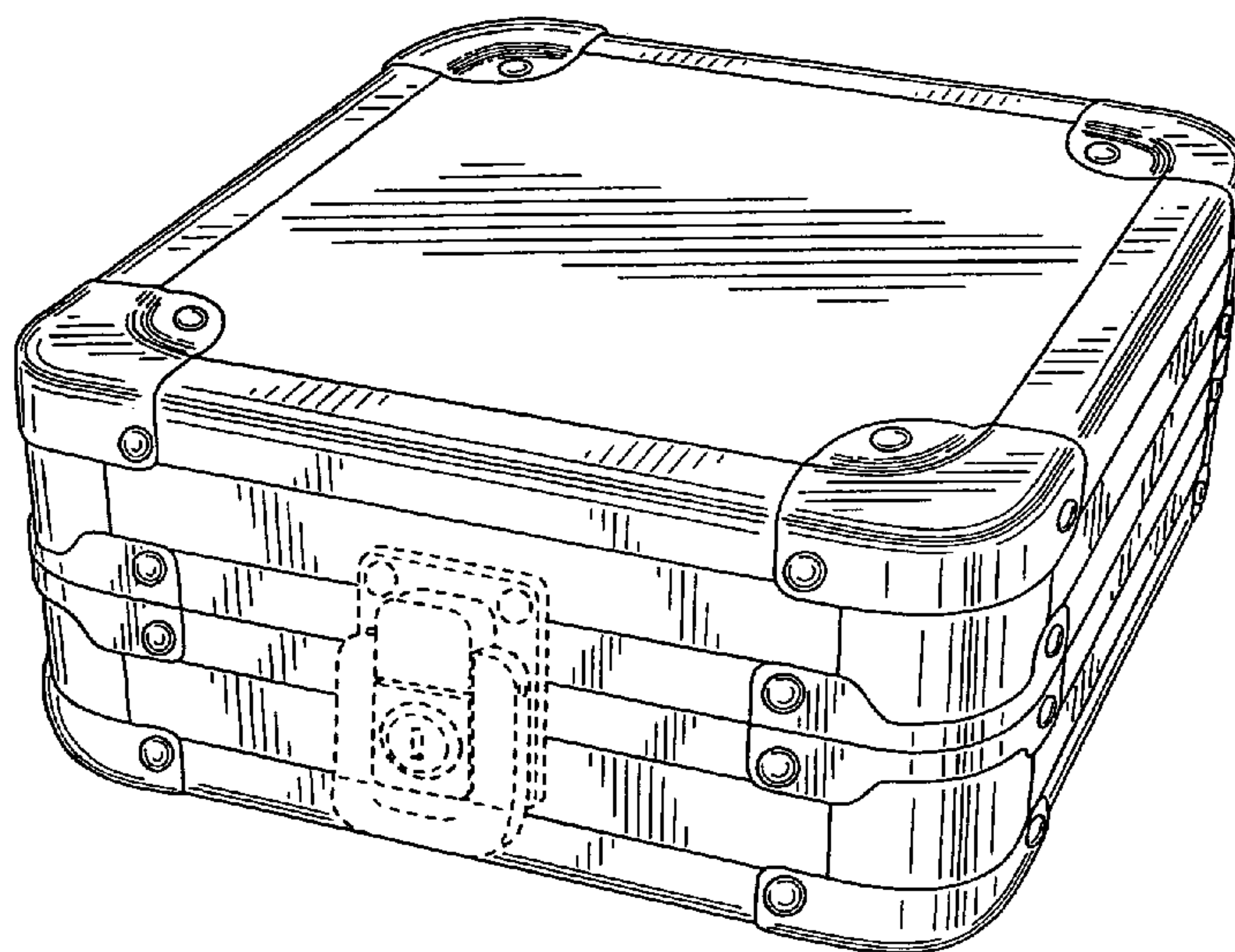
FIG. 2 is a front elevational view of the case of FIG. 1;

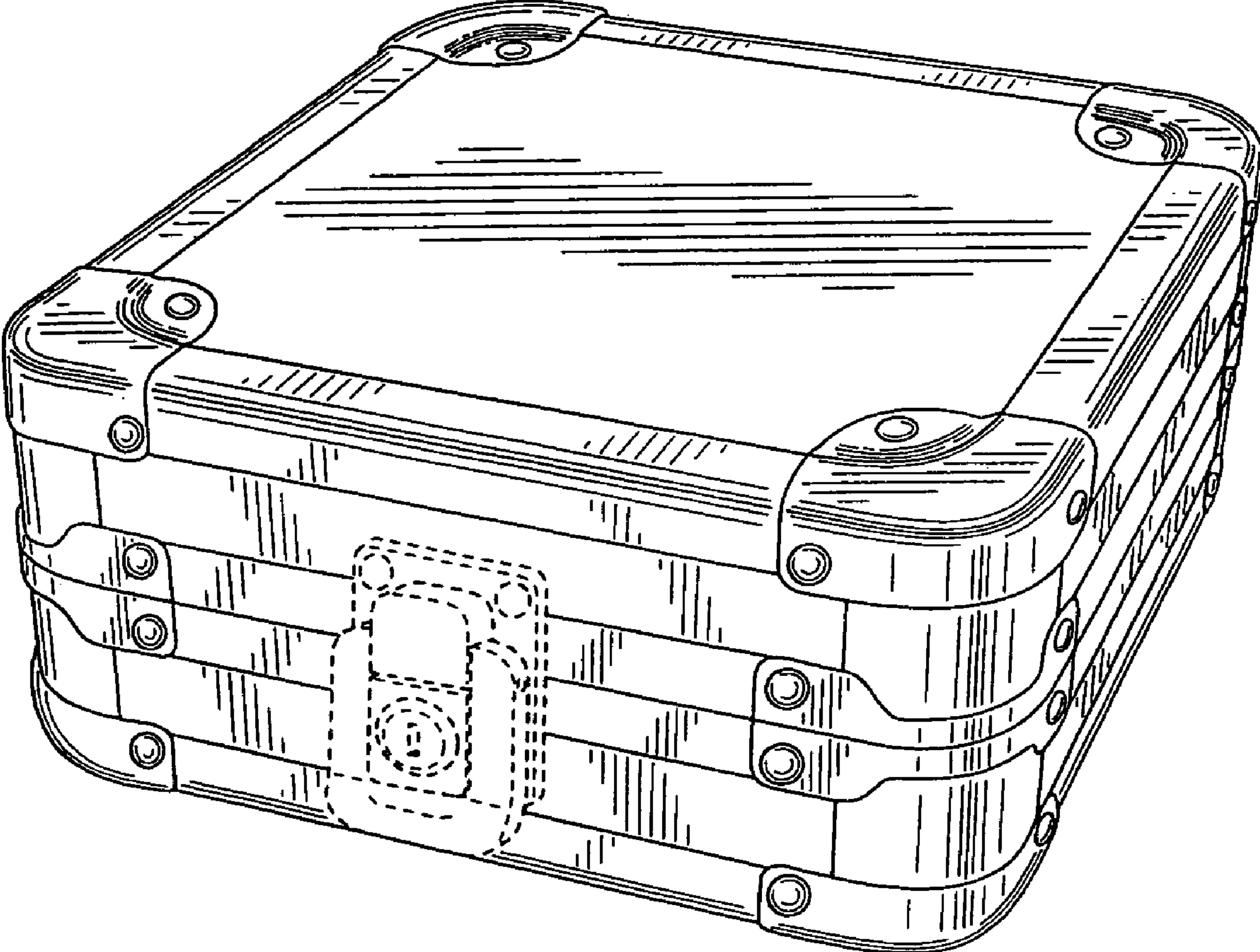

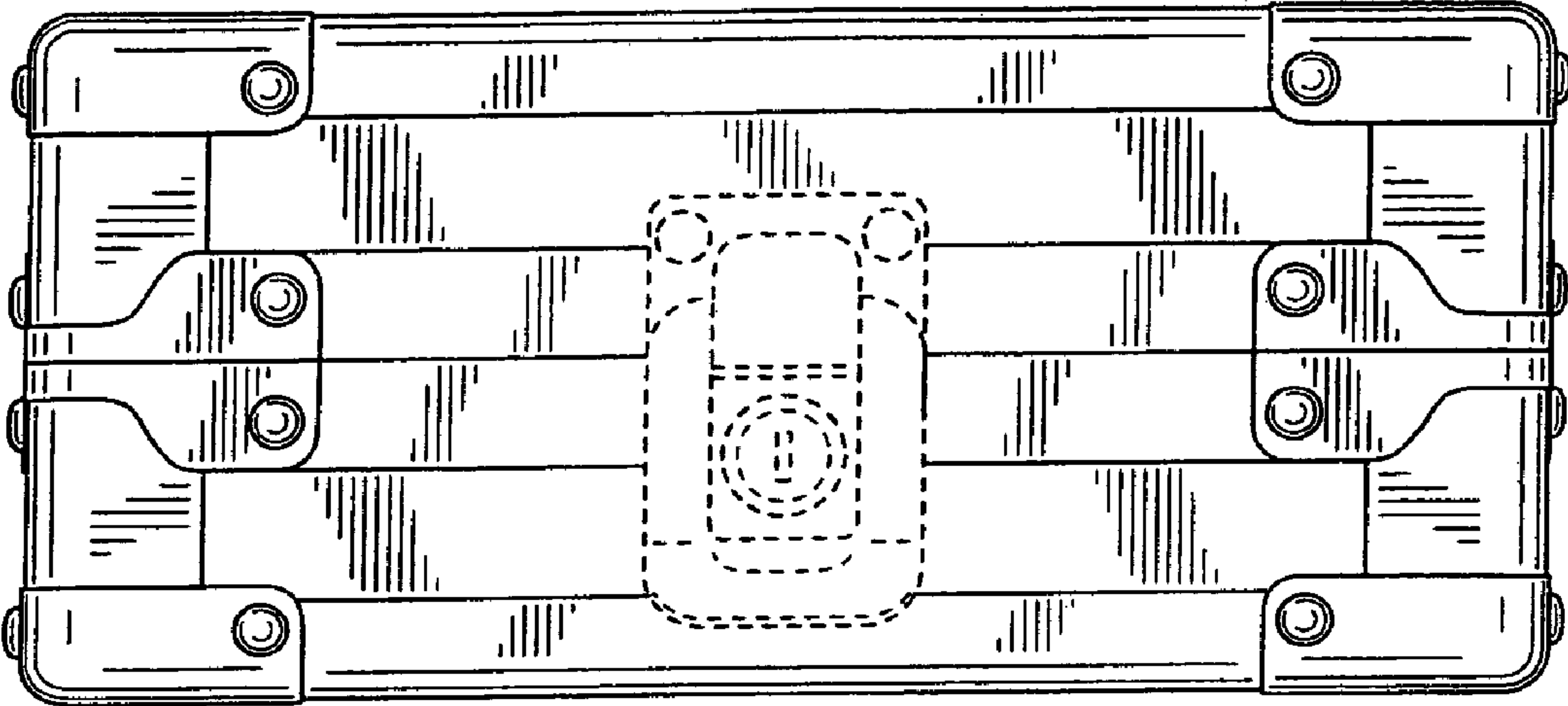

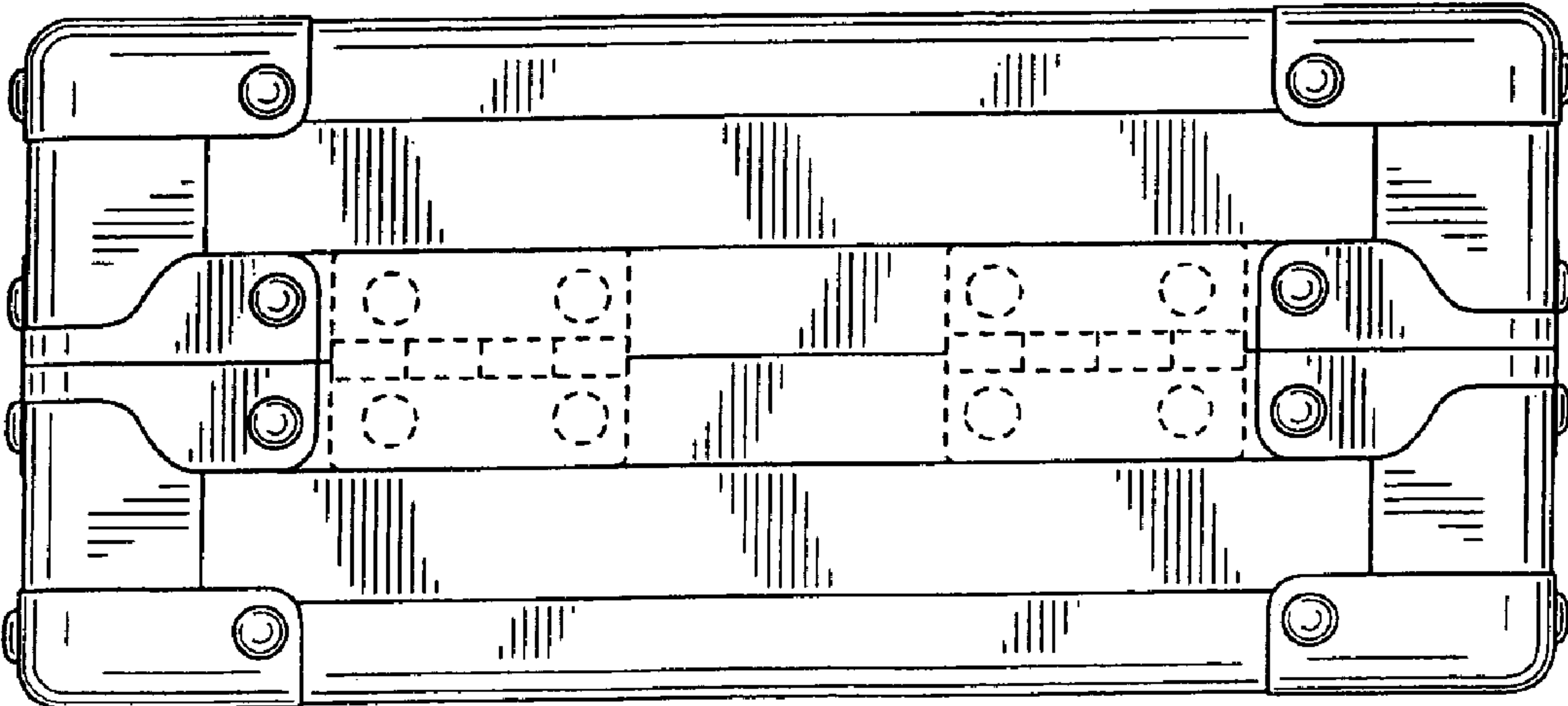

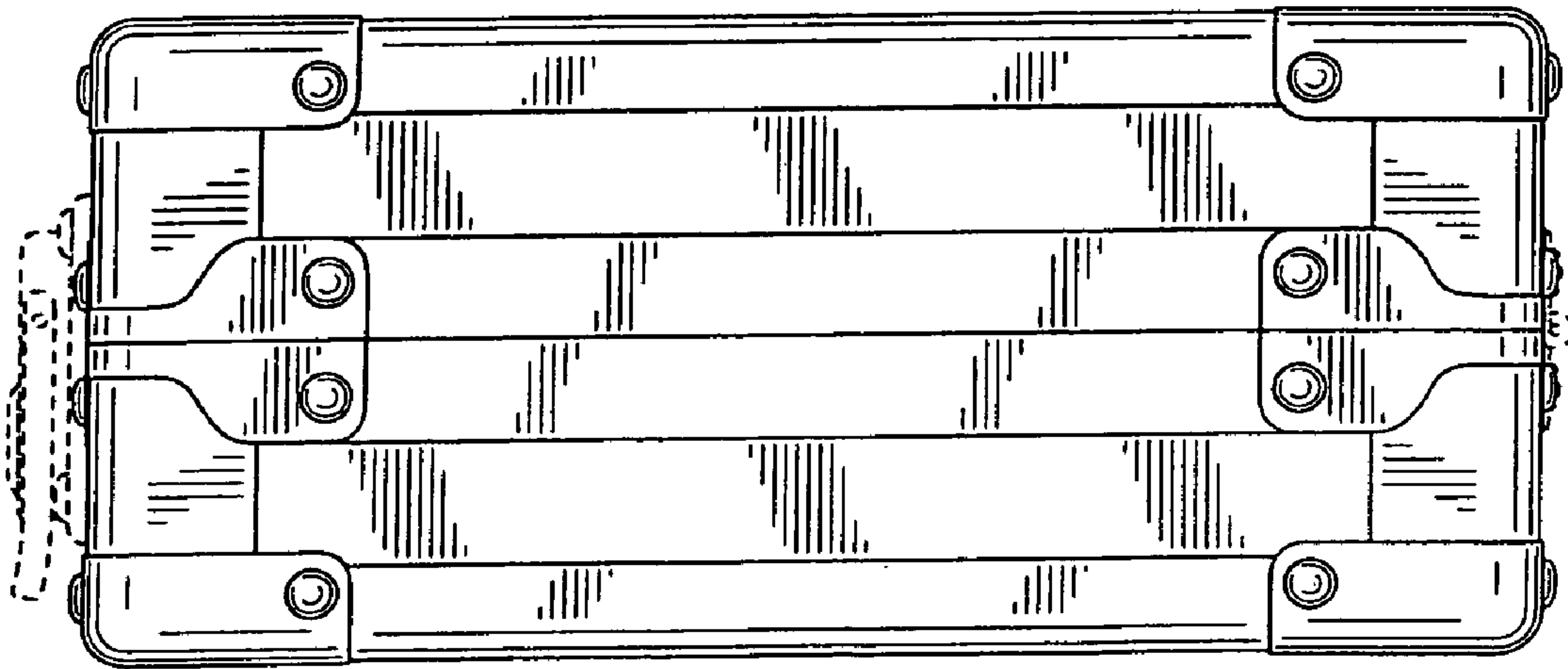

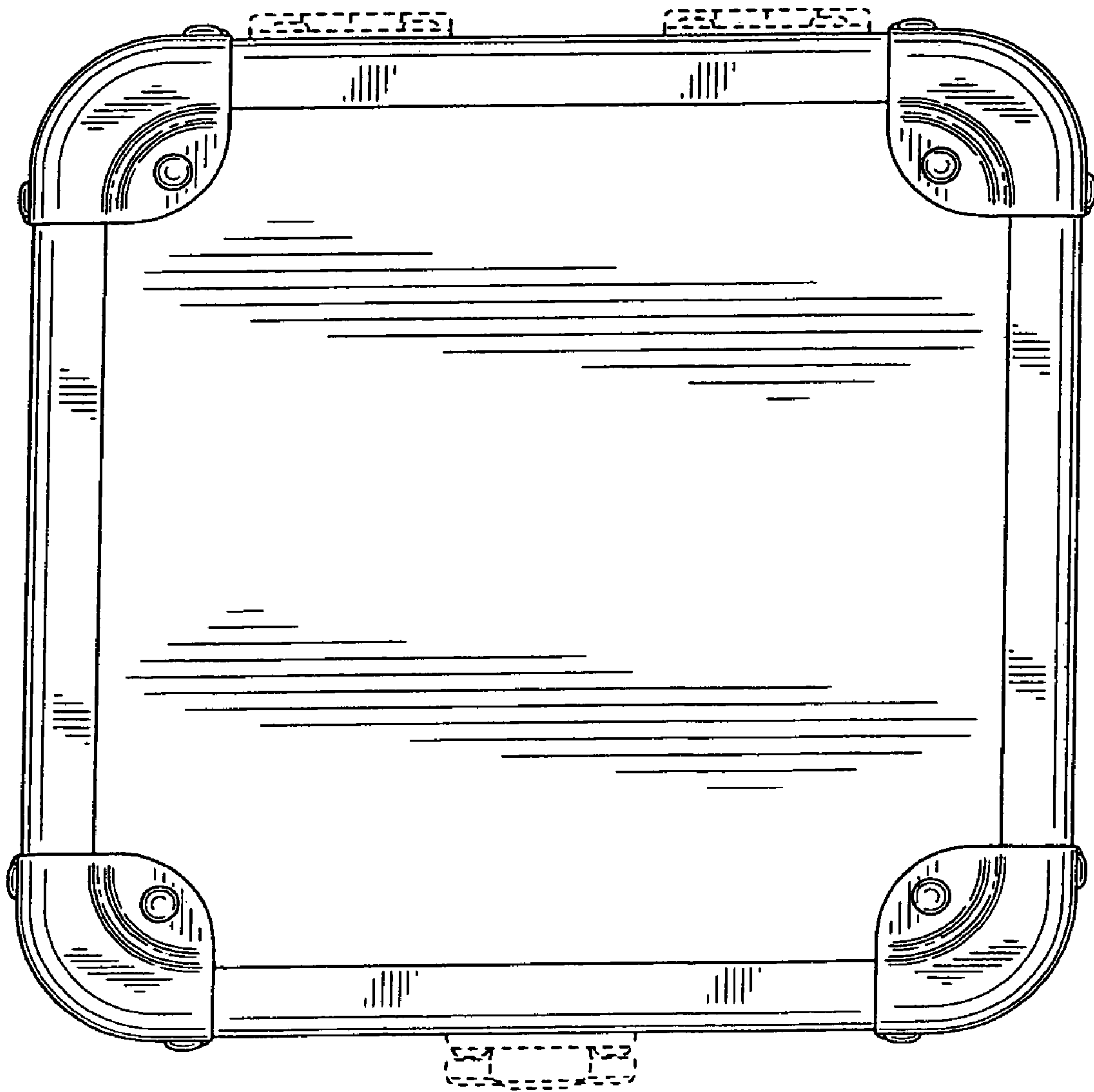
