FIG. 3 is a front view of the football vessel.

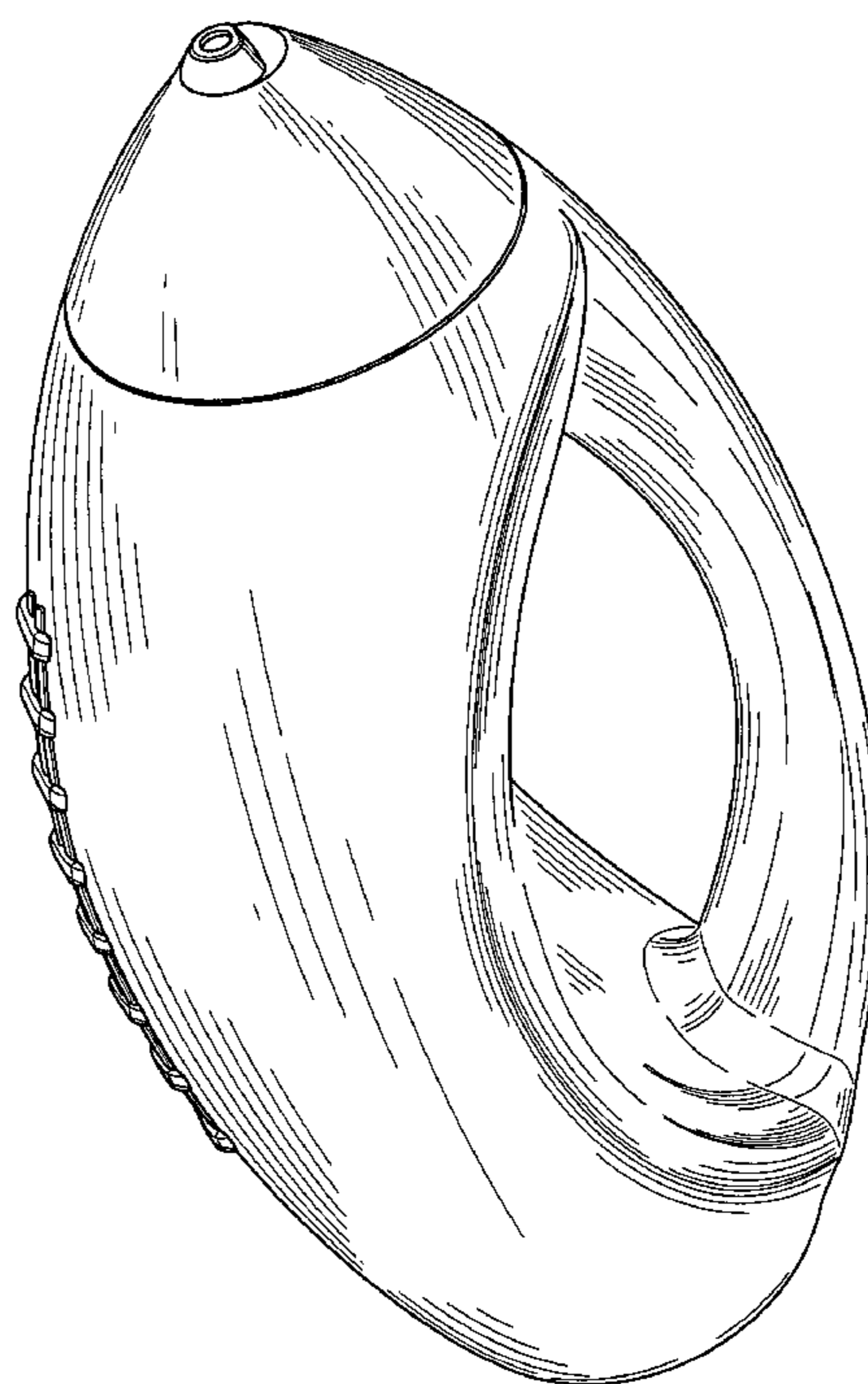
FIG. 4 is a right side view of the football vessel.

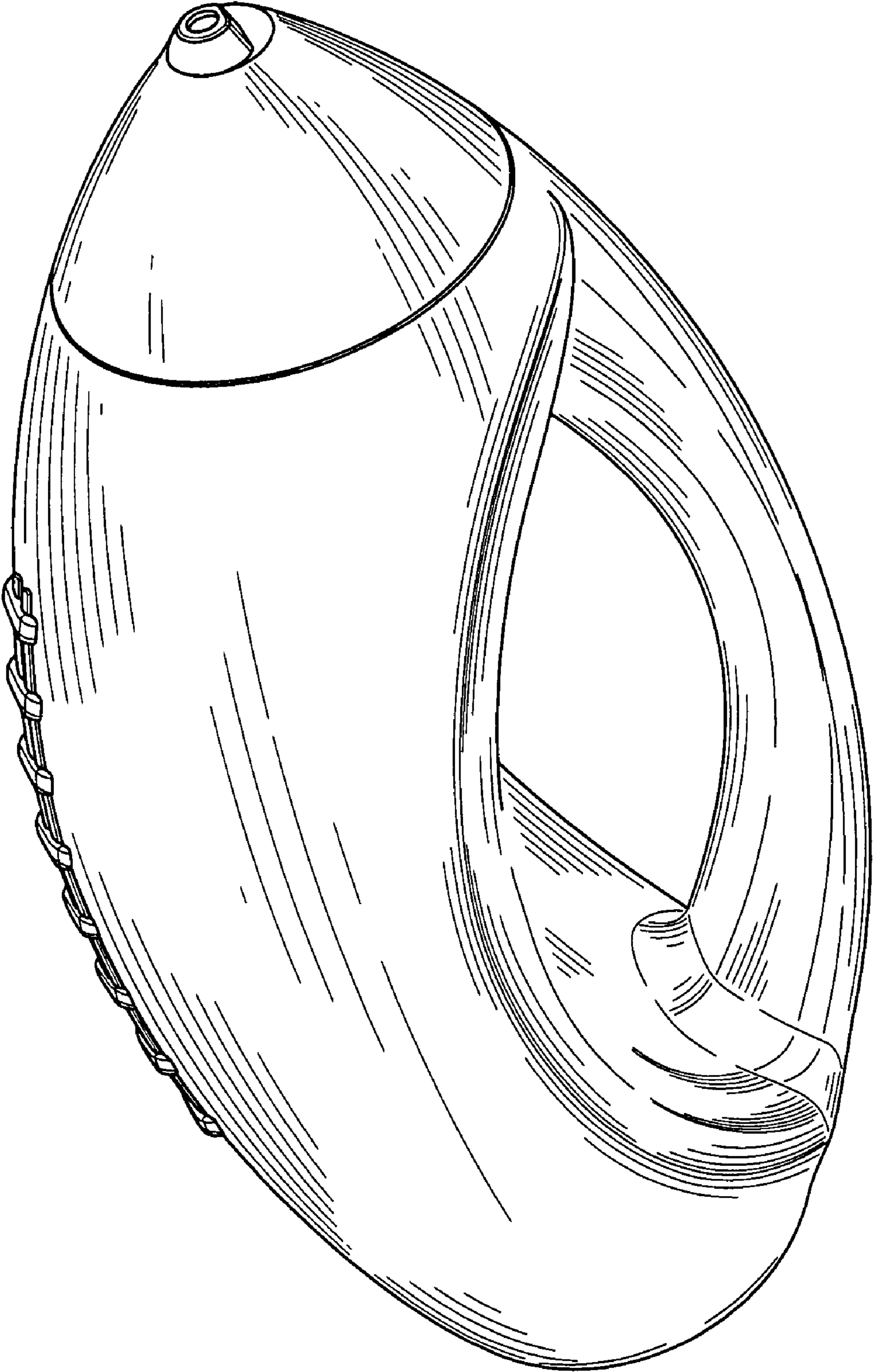

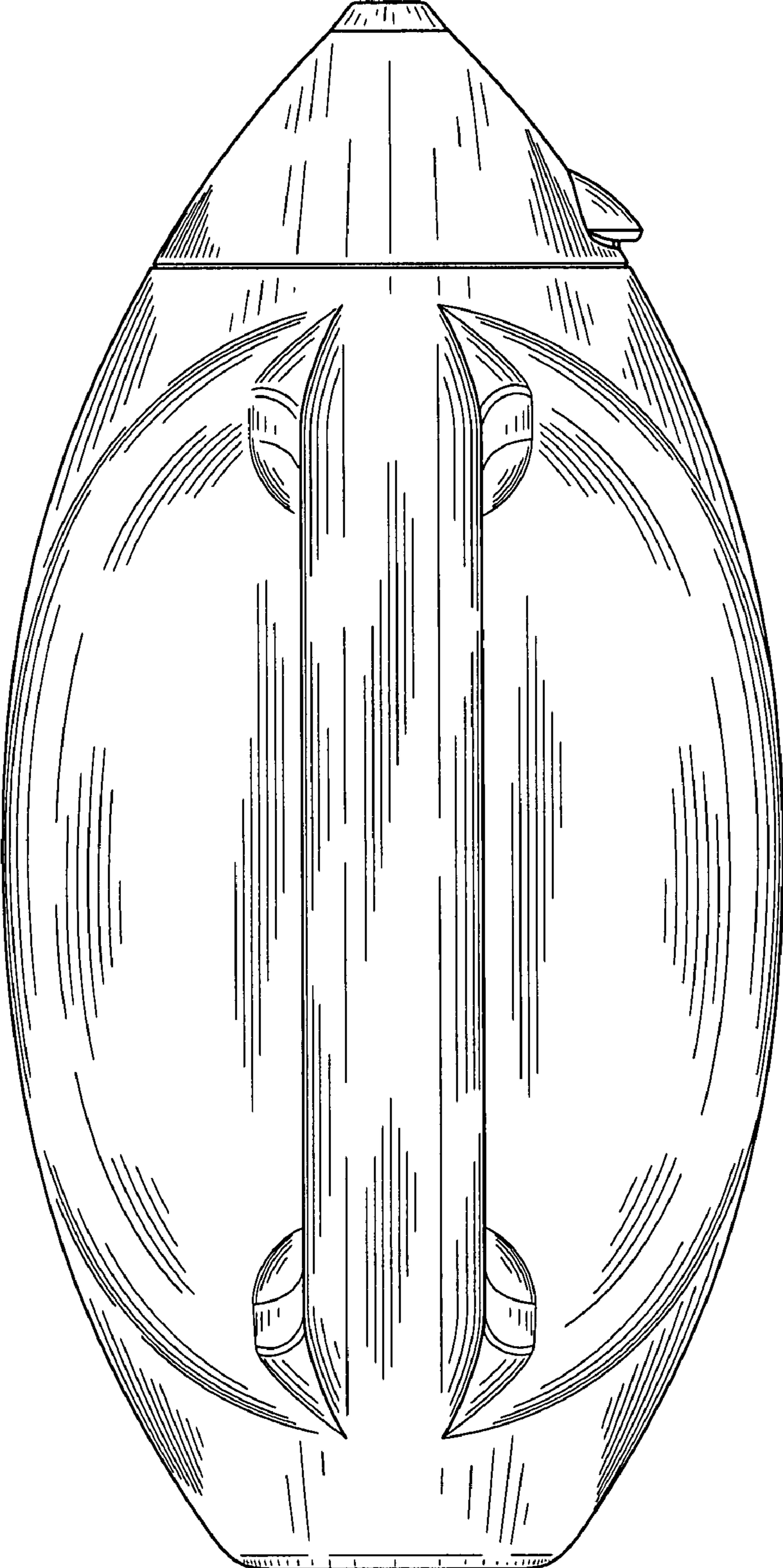

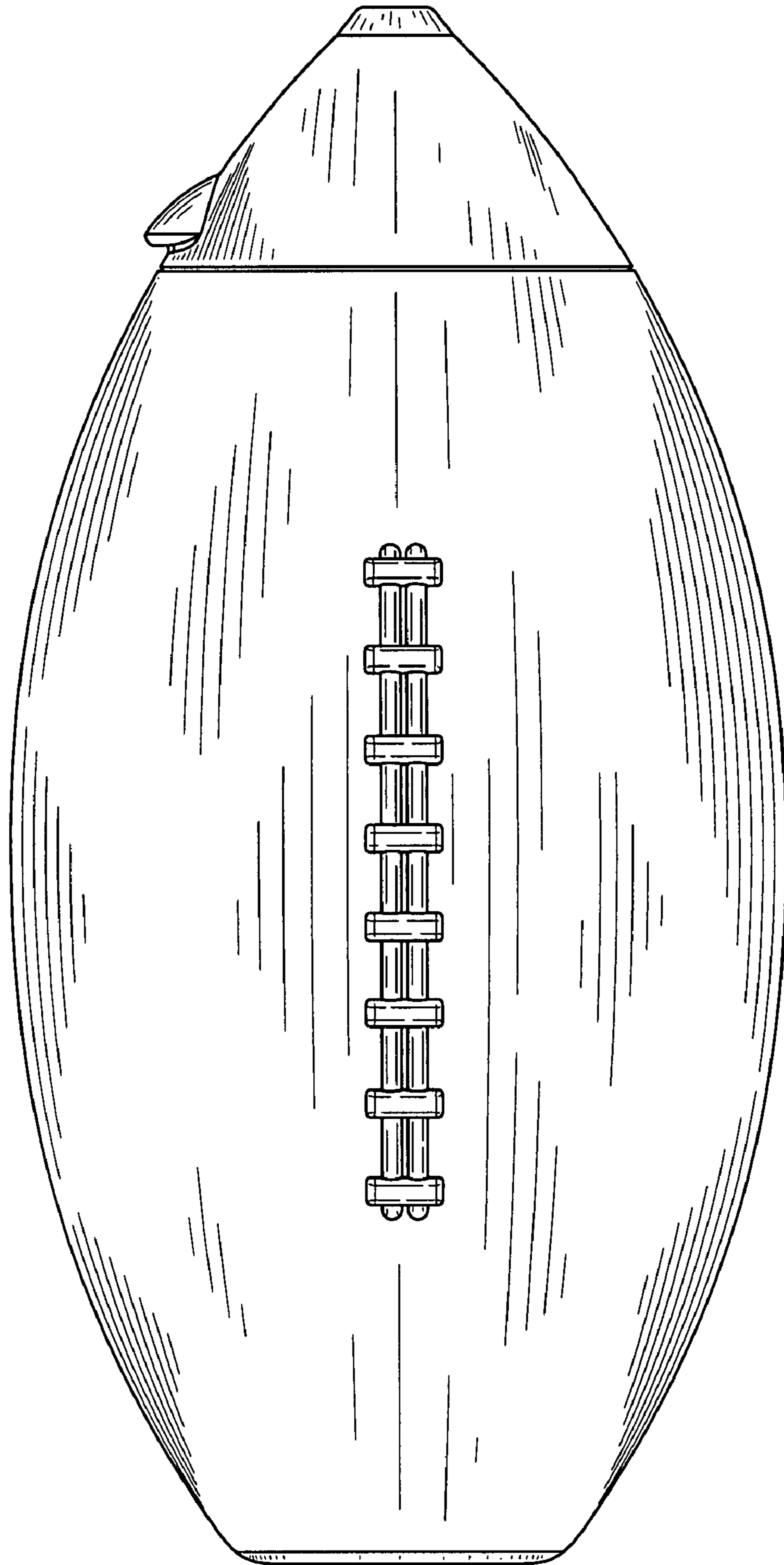

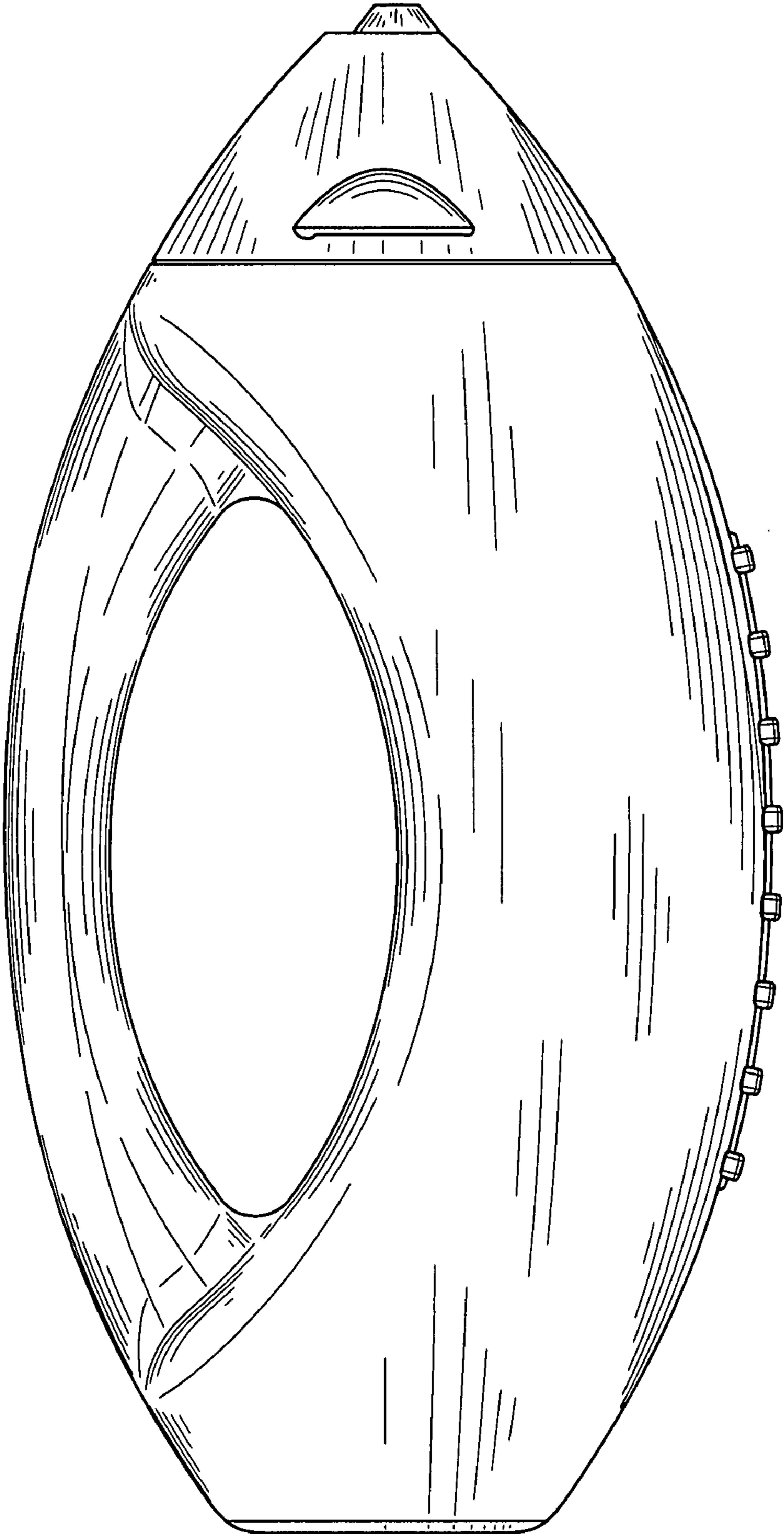

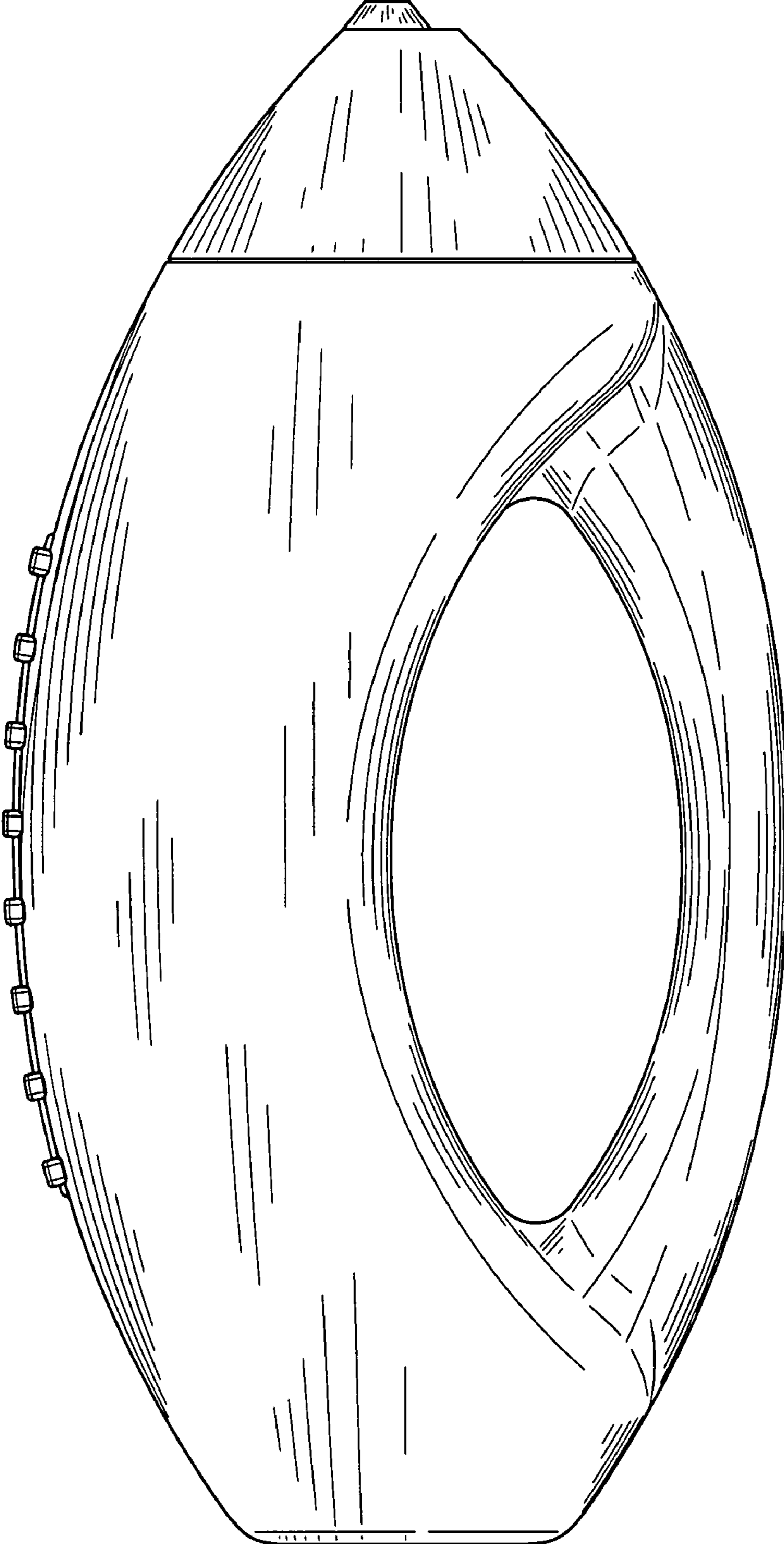

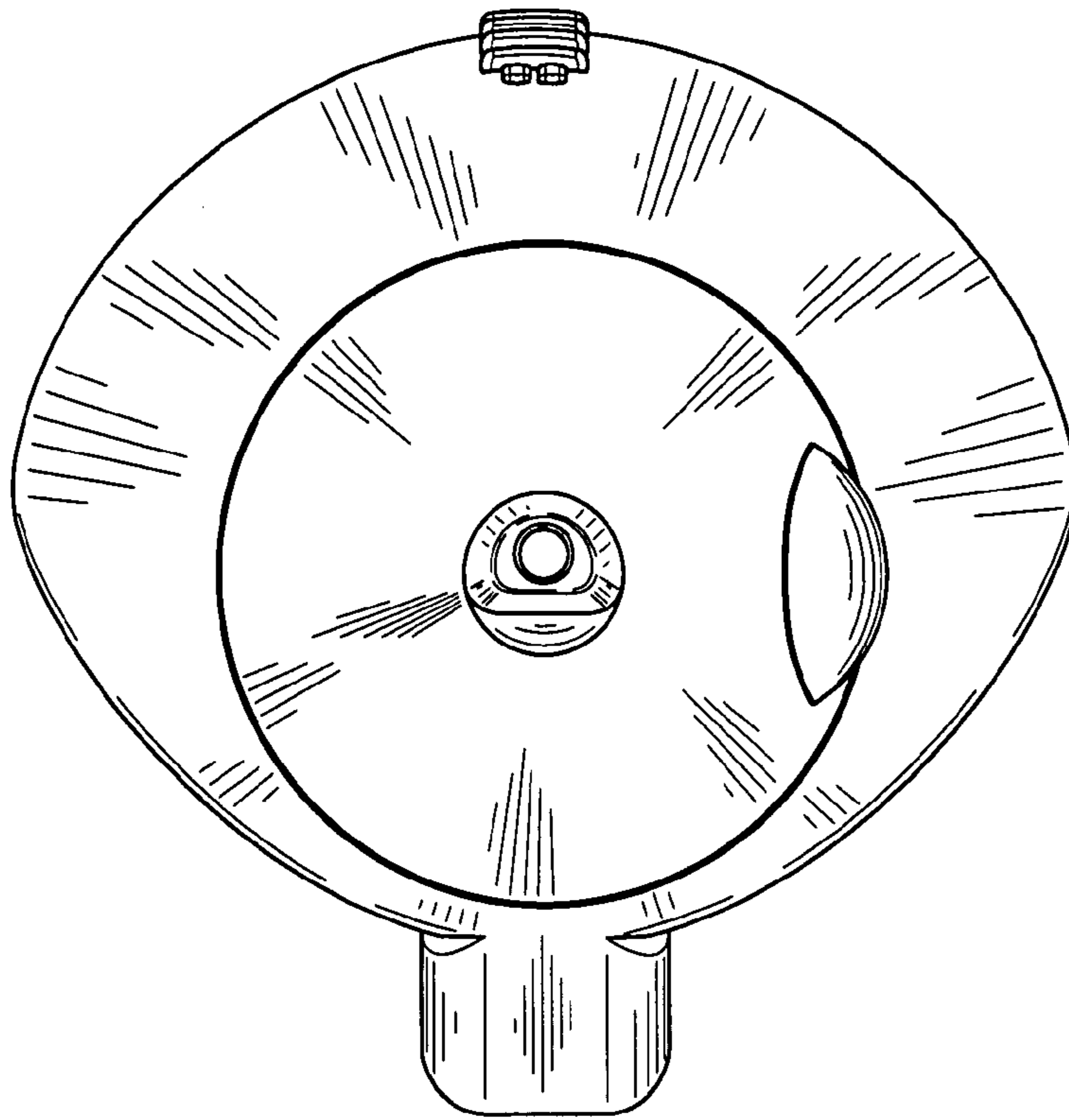

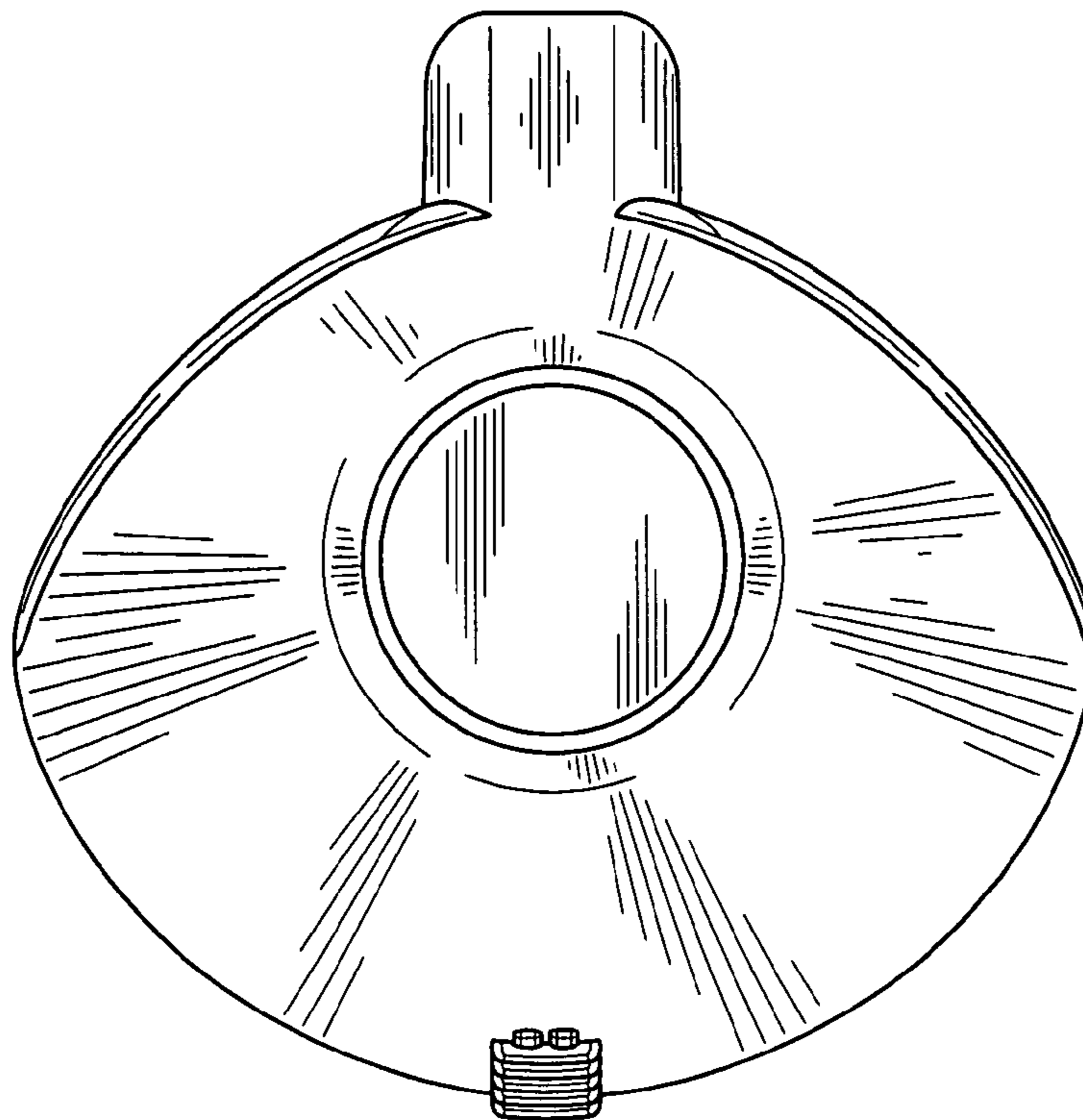
