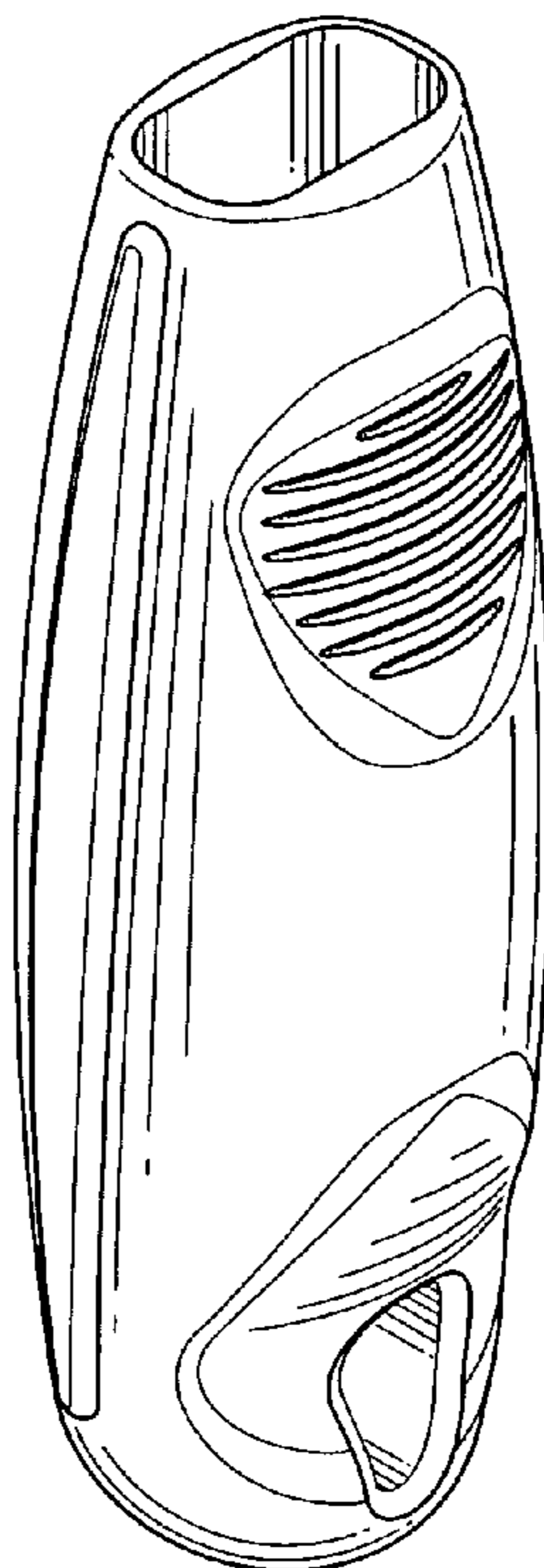
DESCRIPTION

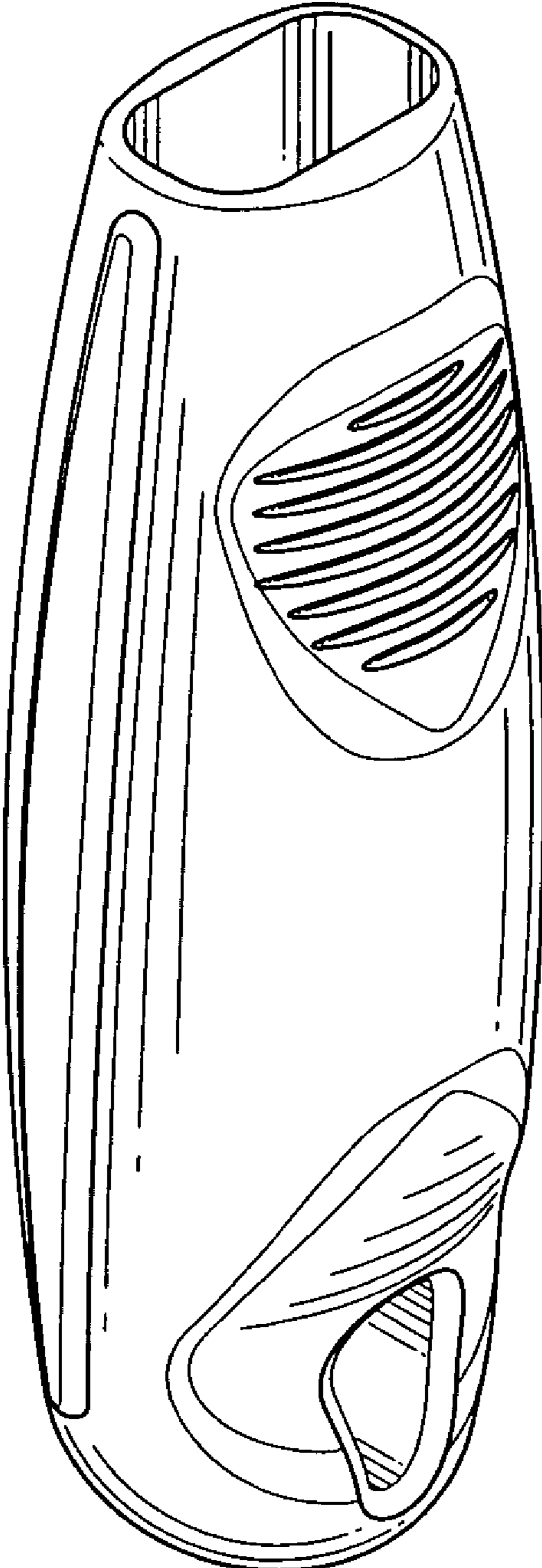

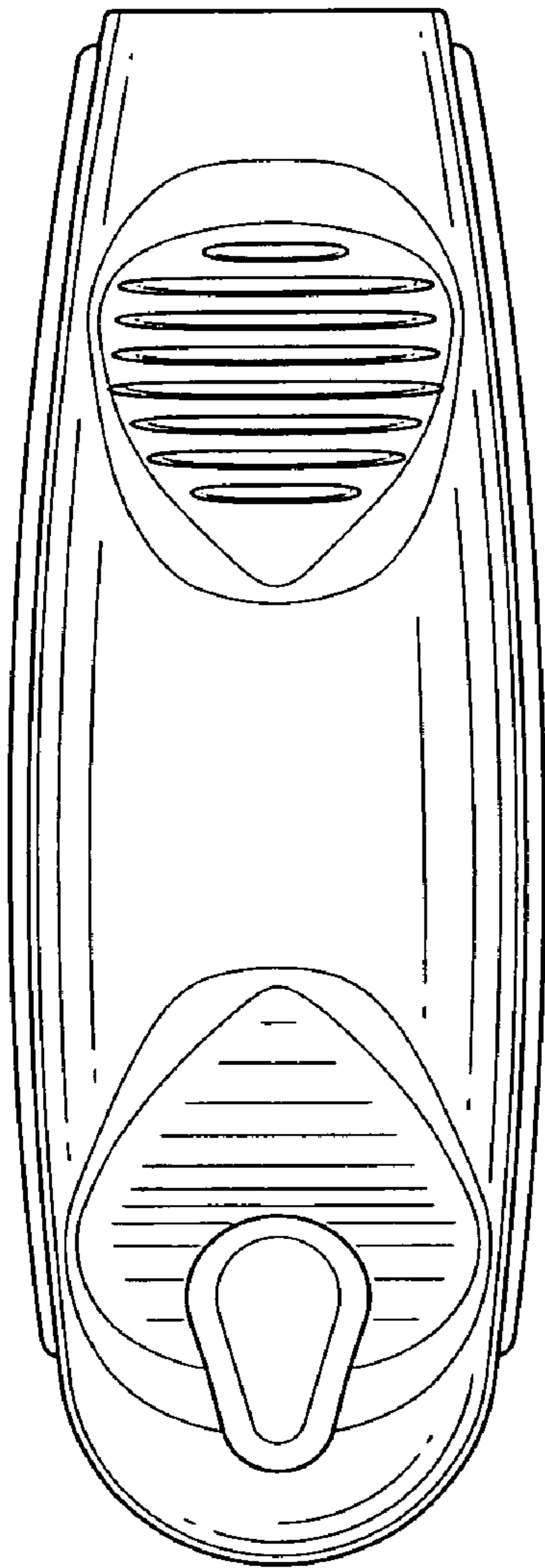

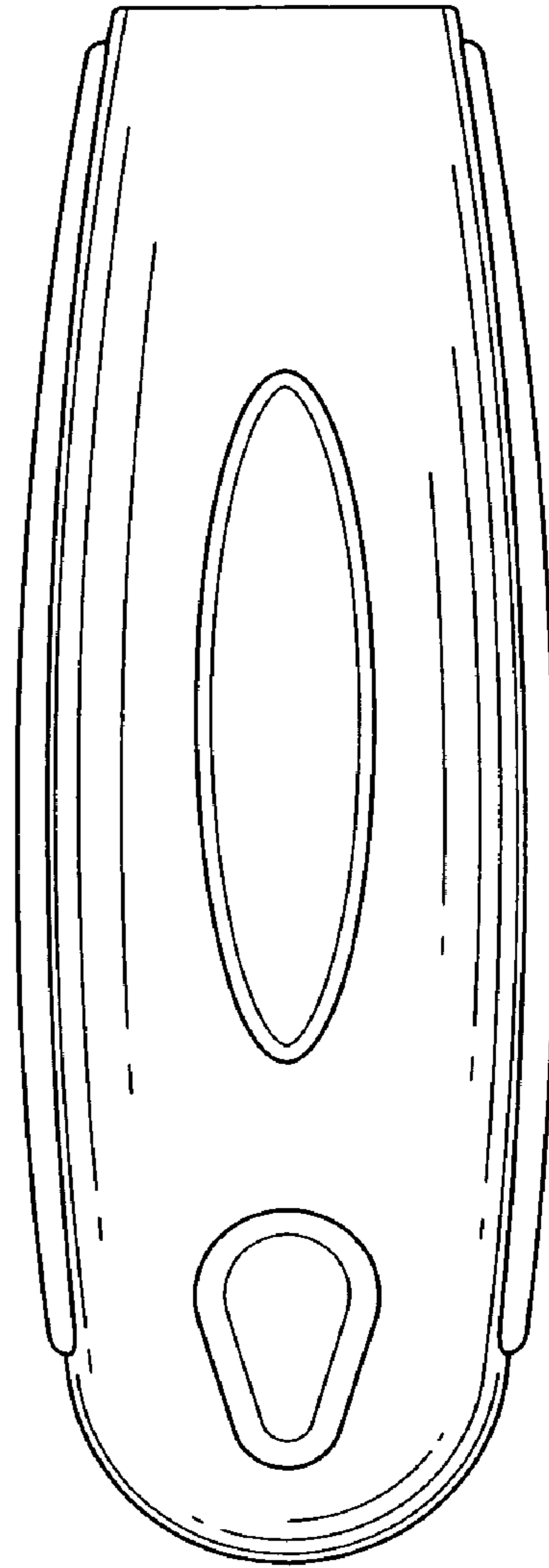

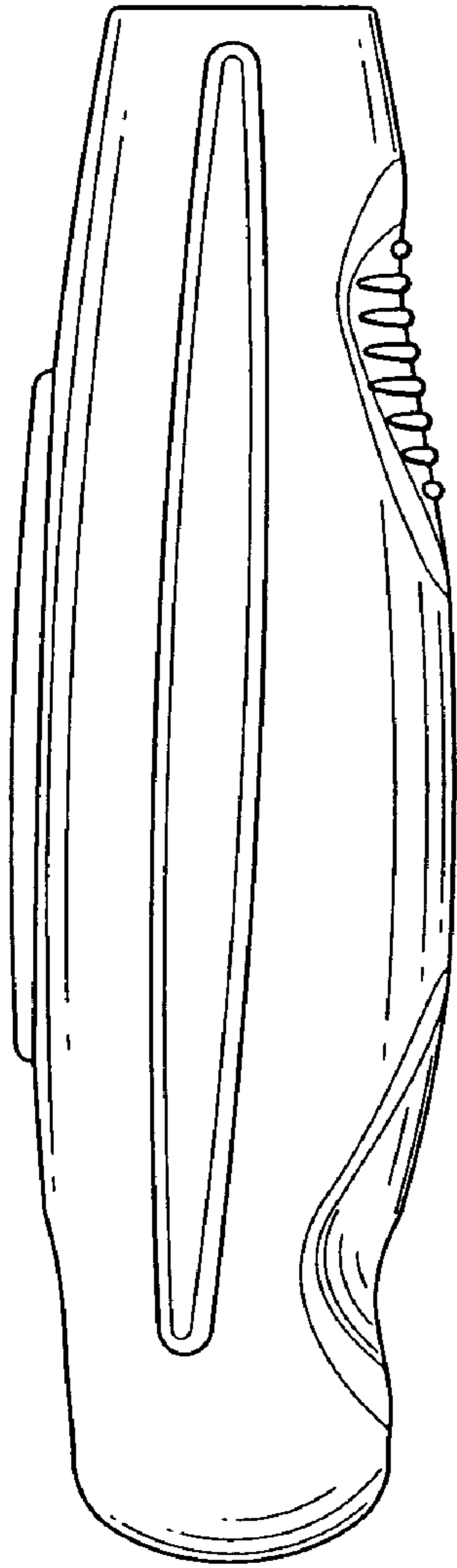

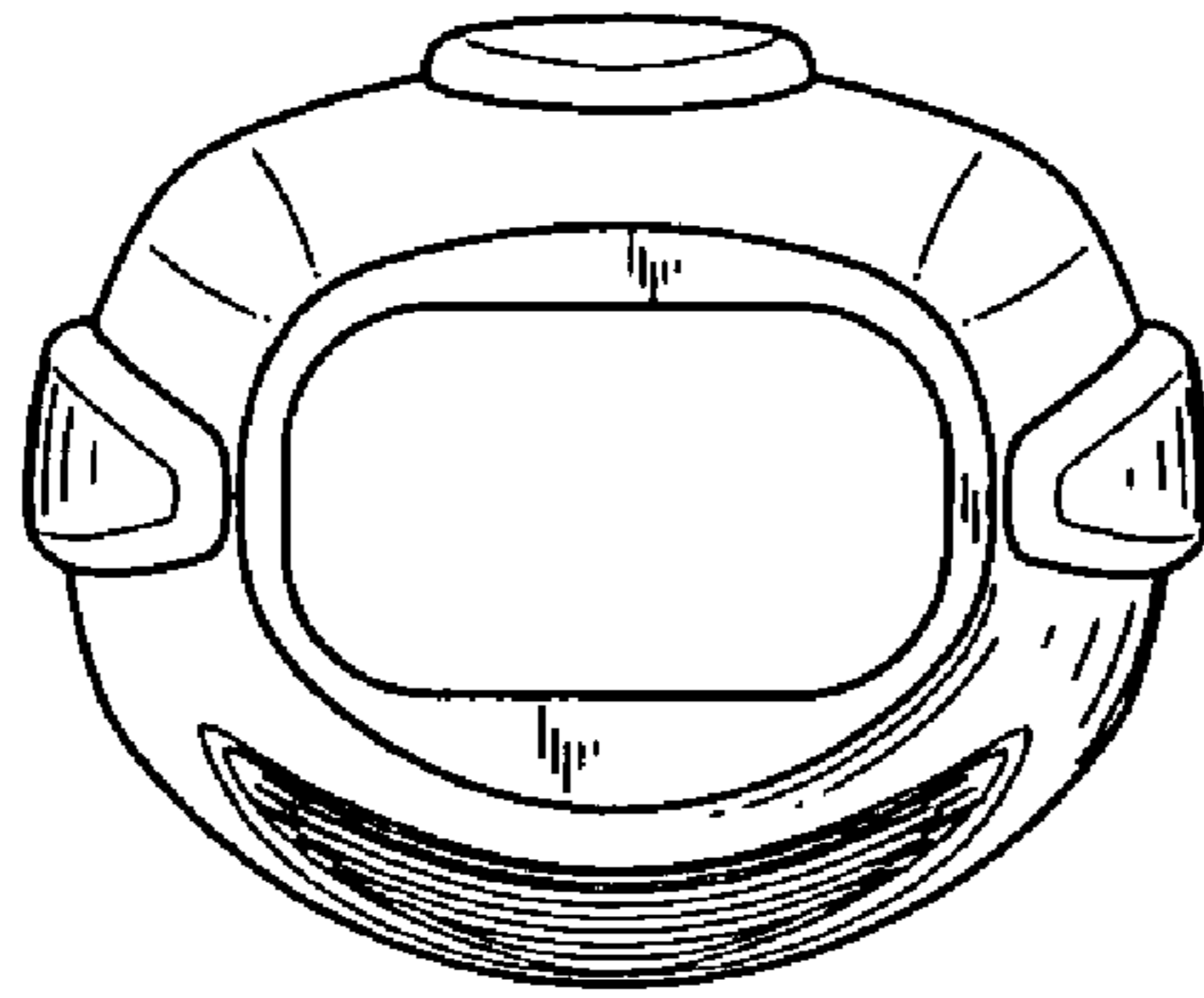

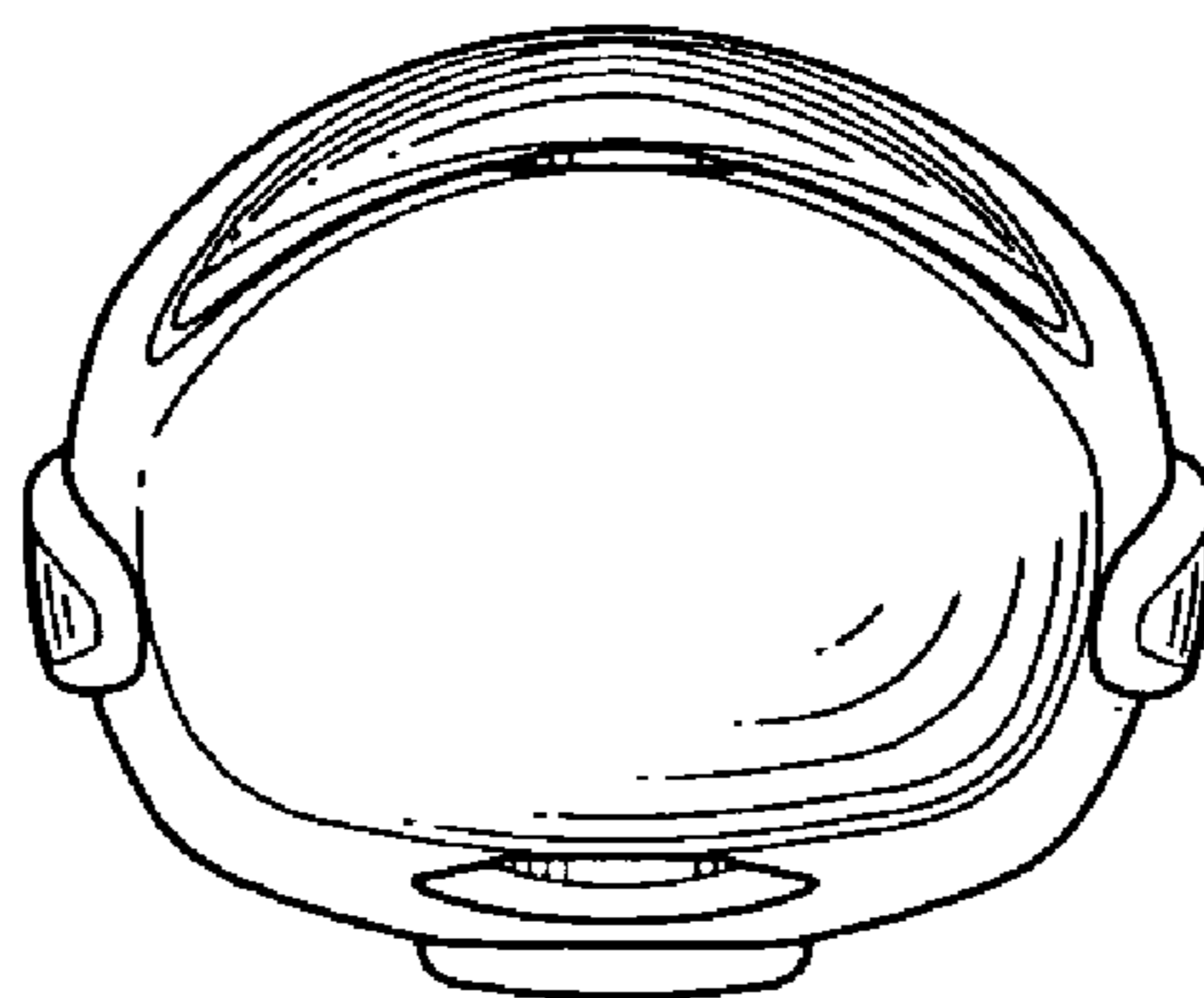
