DESCRIPTION

FIG. 1 is a front perspective view of a handle showing my new design;

FIG. 2 is a front elevational view thereof;

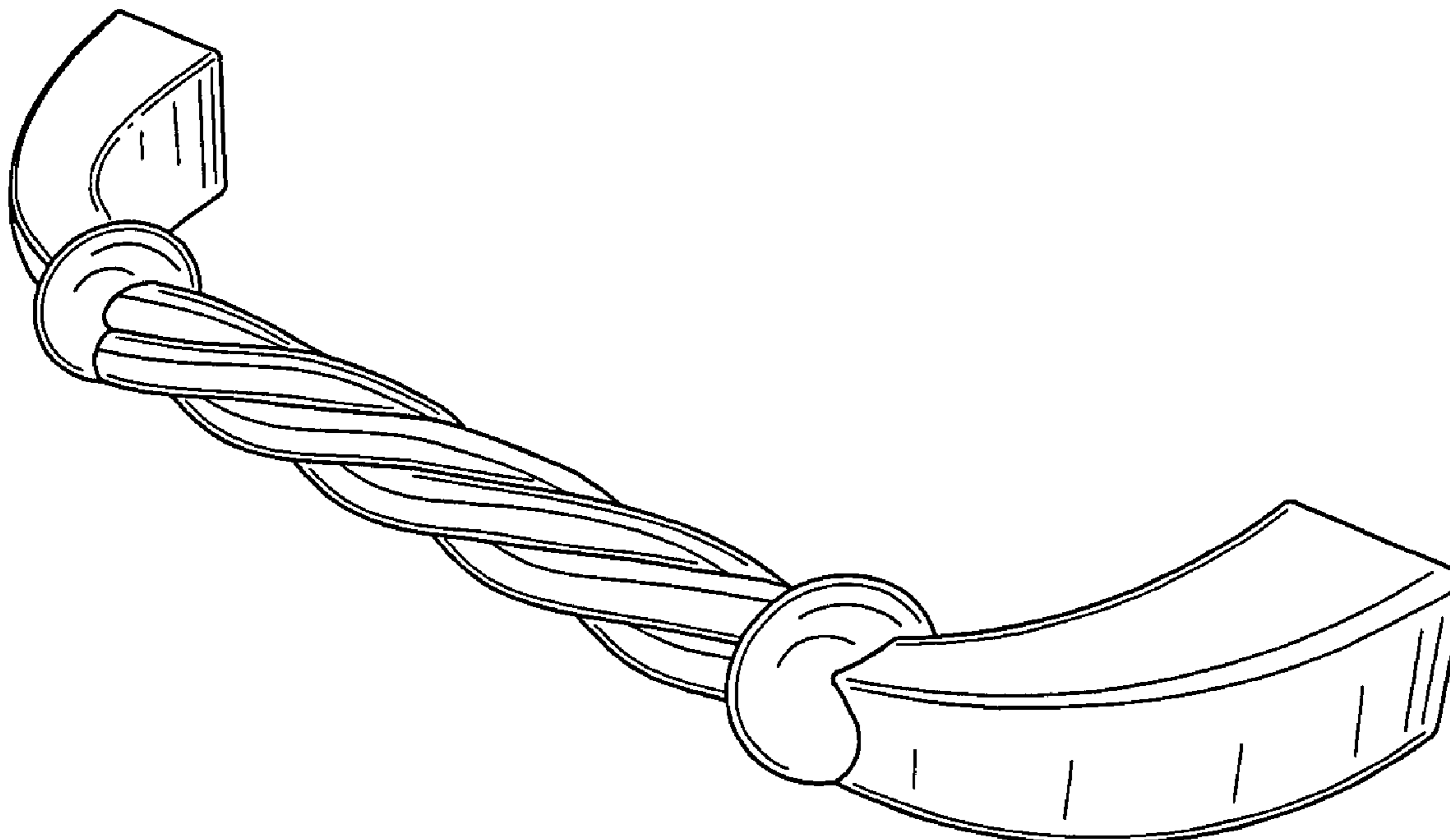

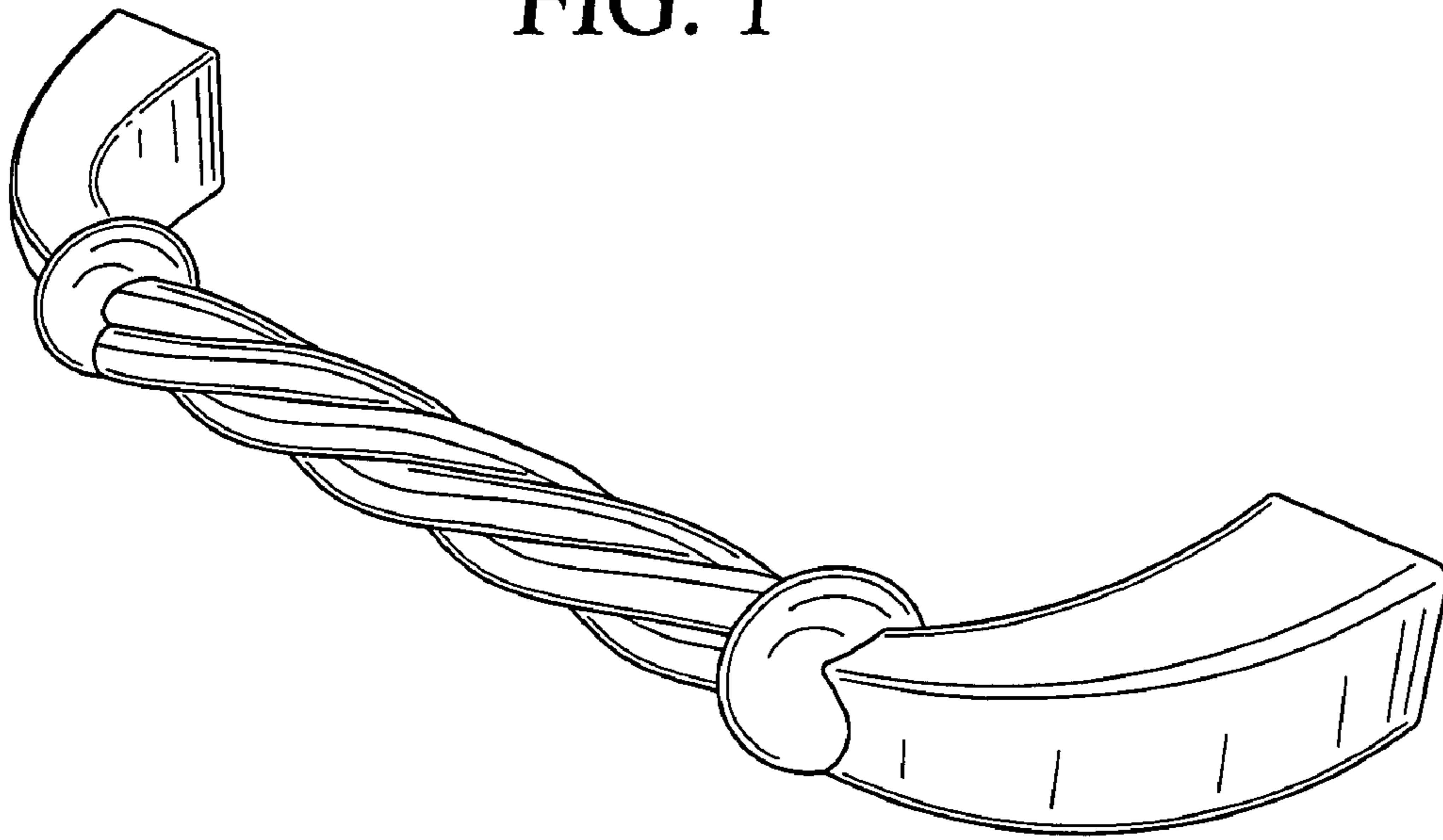

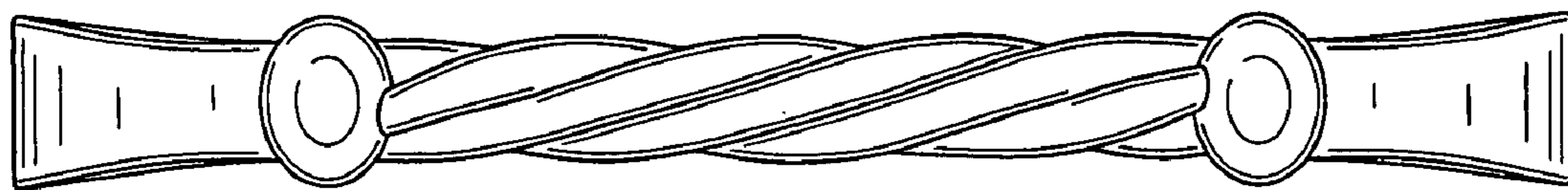

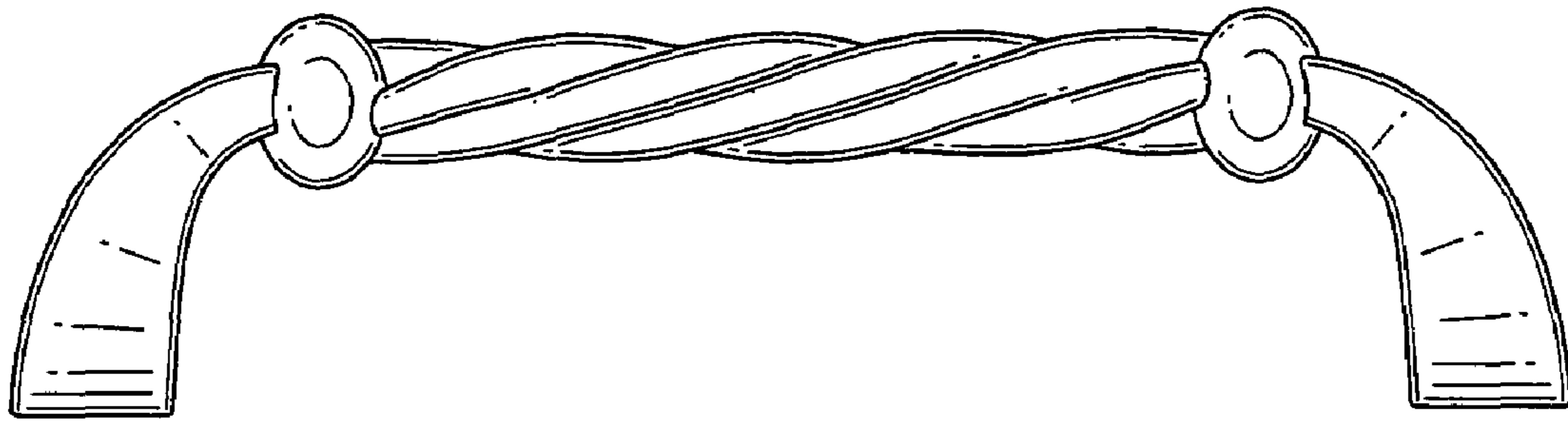

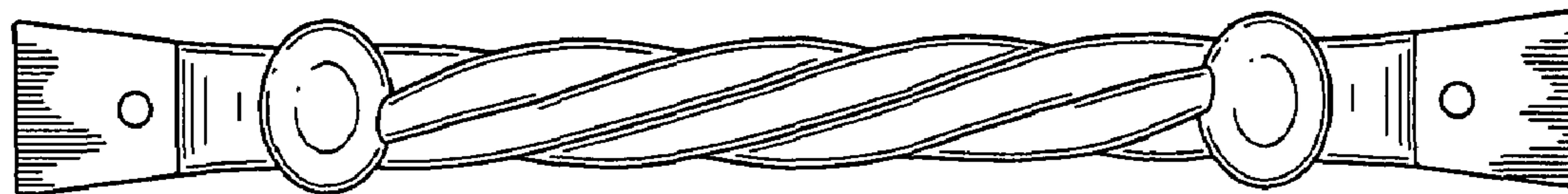
