The shading lines shown in the drawing(s) represent the three-dimensional contour of the design, and are not intended to indicate surface decoration.

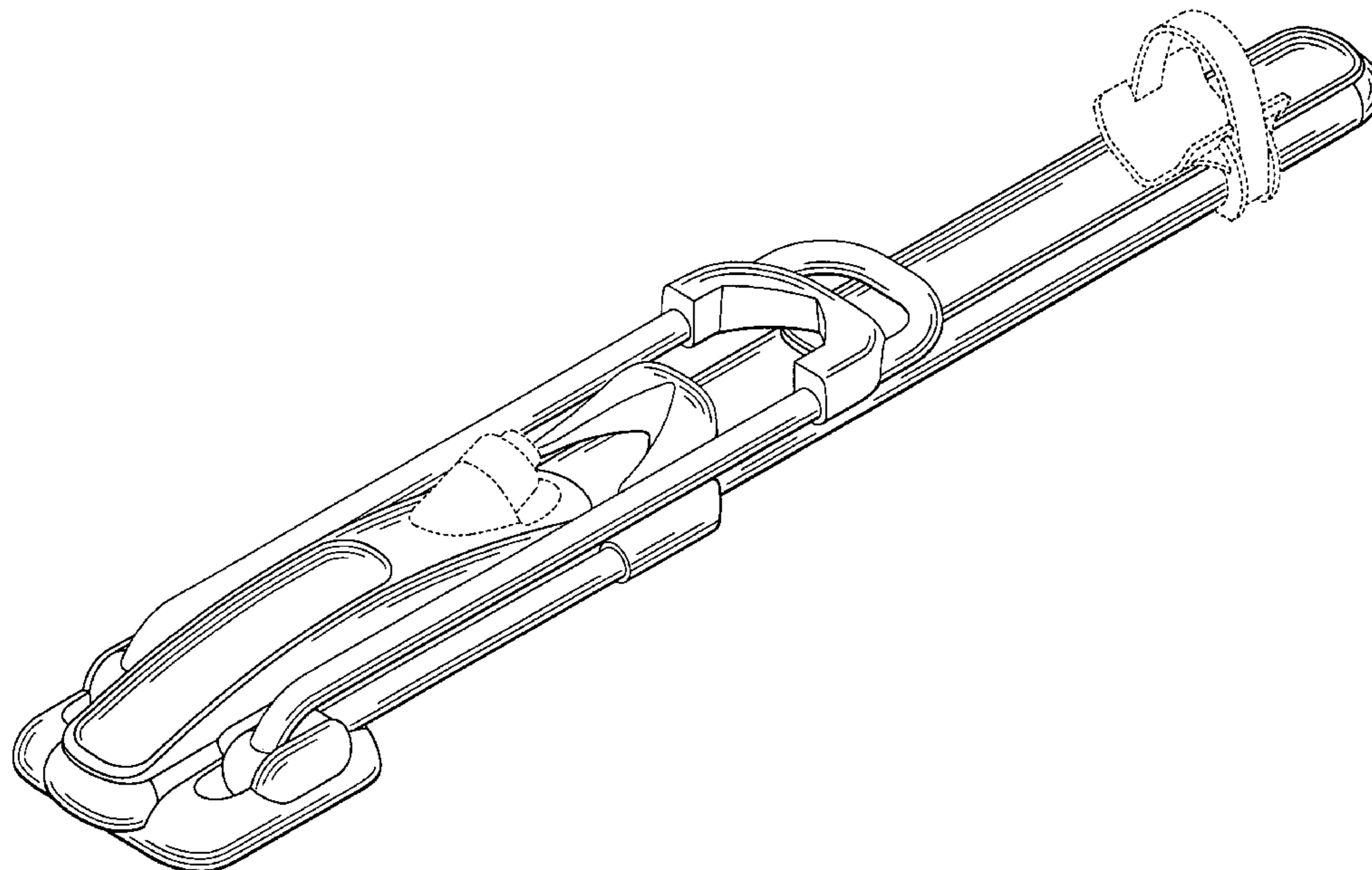

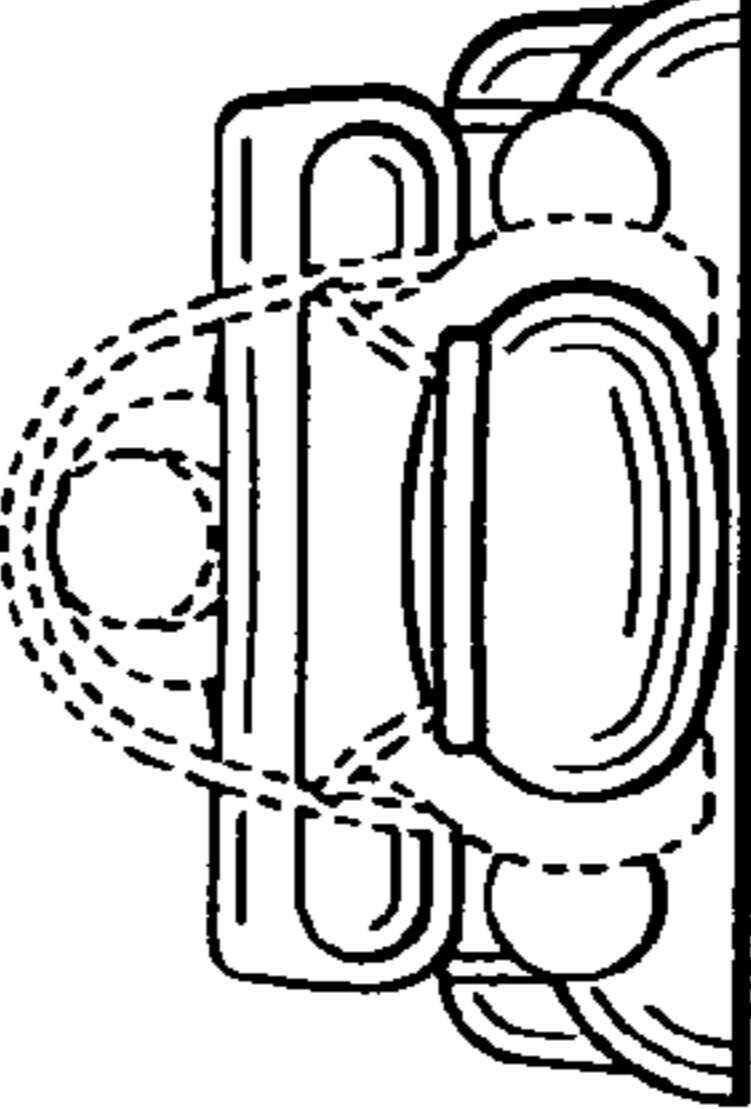
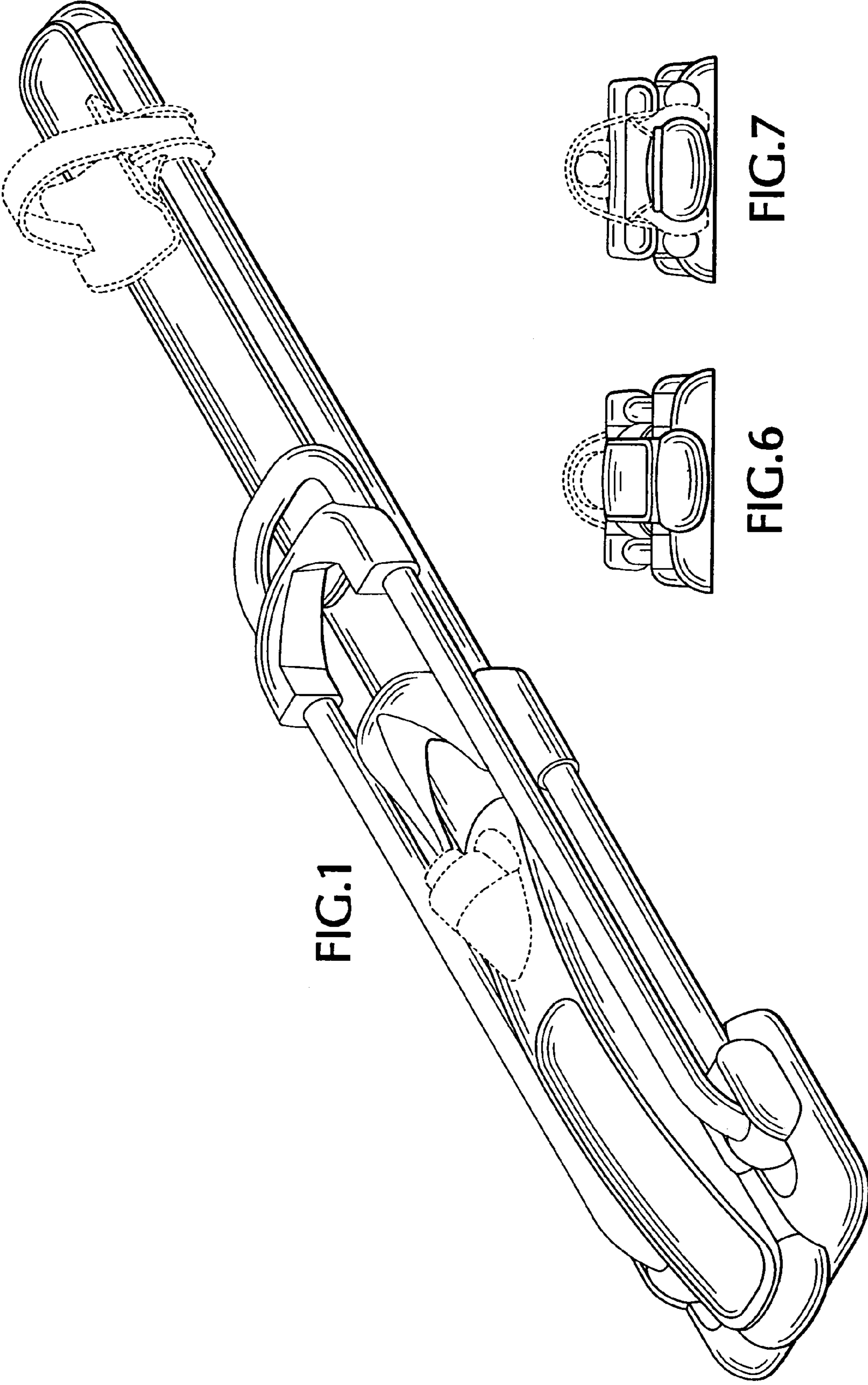

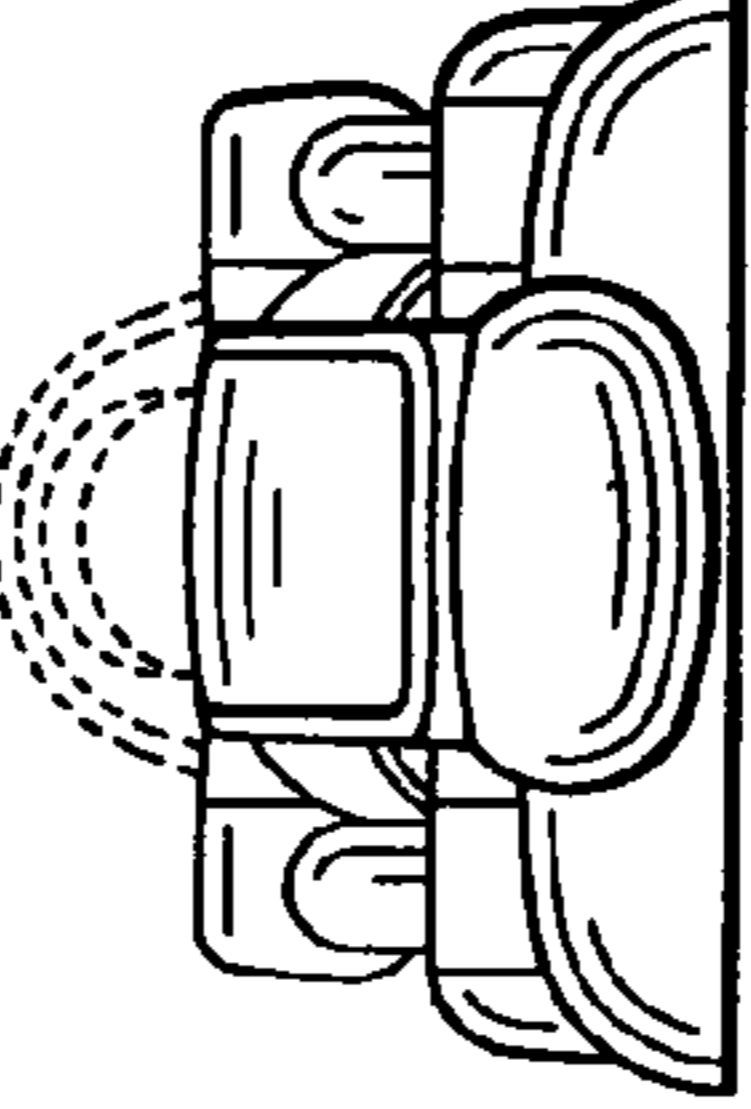

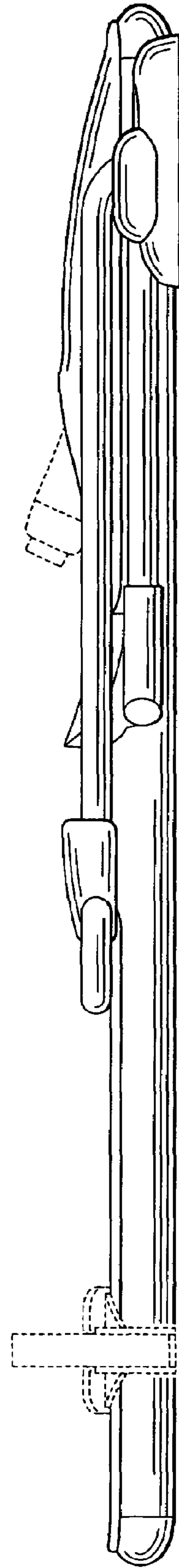
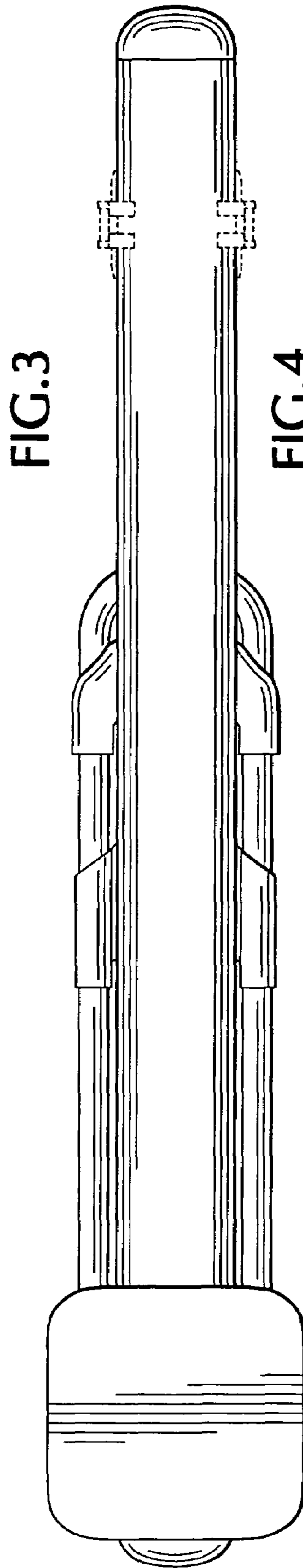
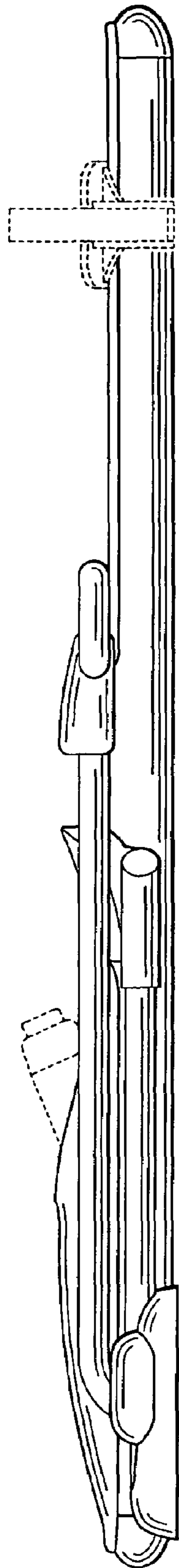
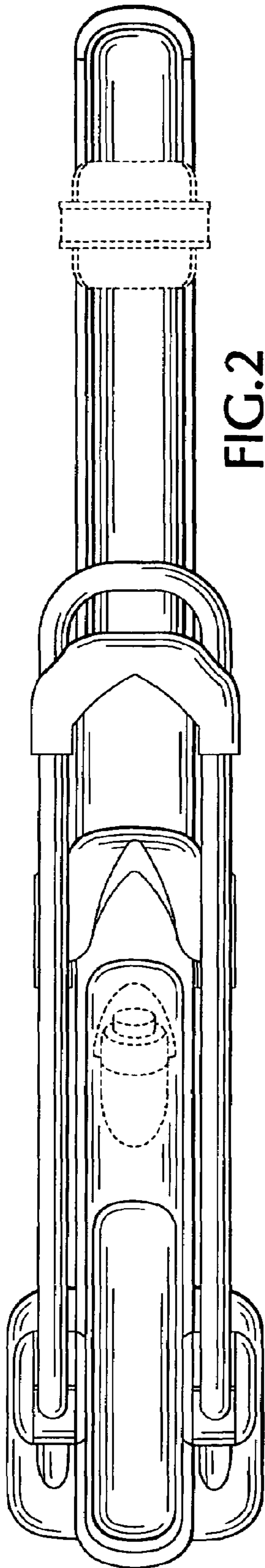
