The dark stippled shading in the drawings represent the recessed portions of the tread groove, as best seen at the top and bottom of FIGS. 2, 3, 6 & 7.

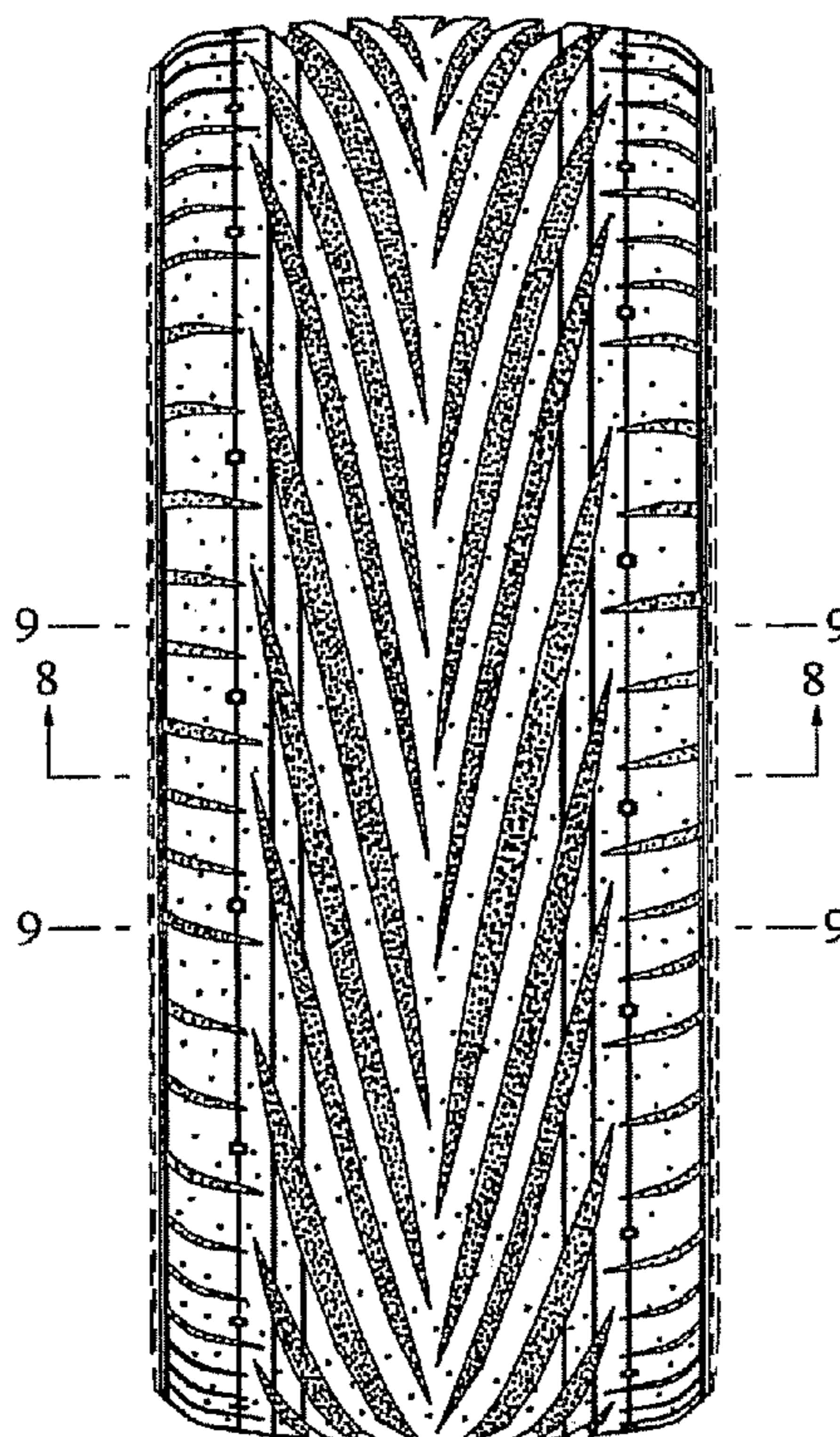

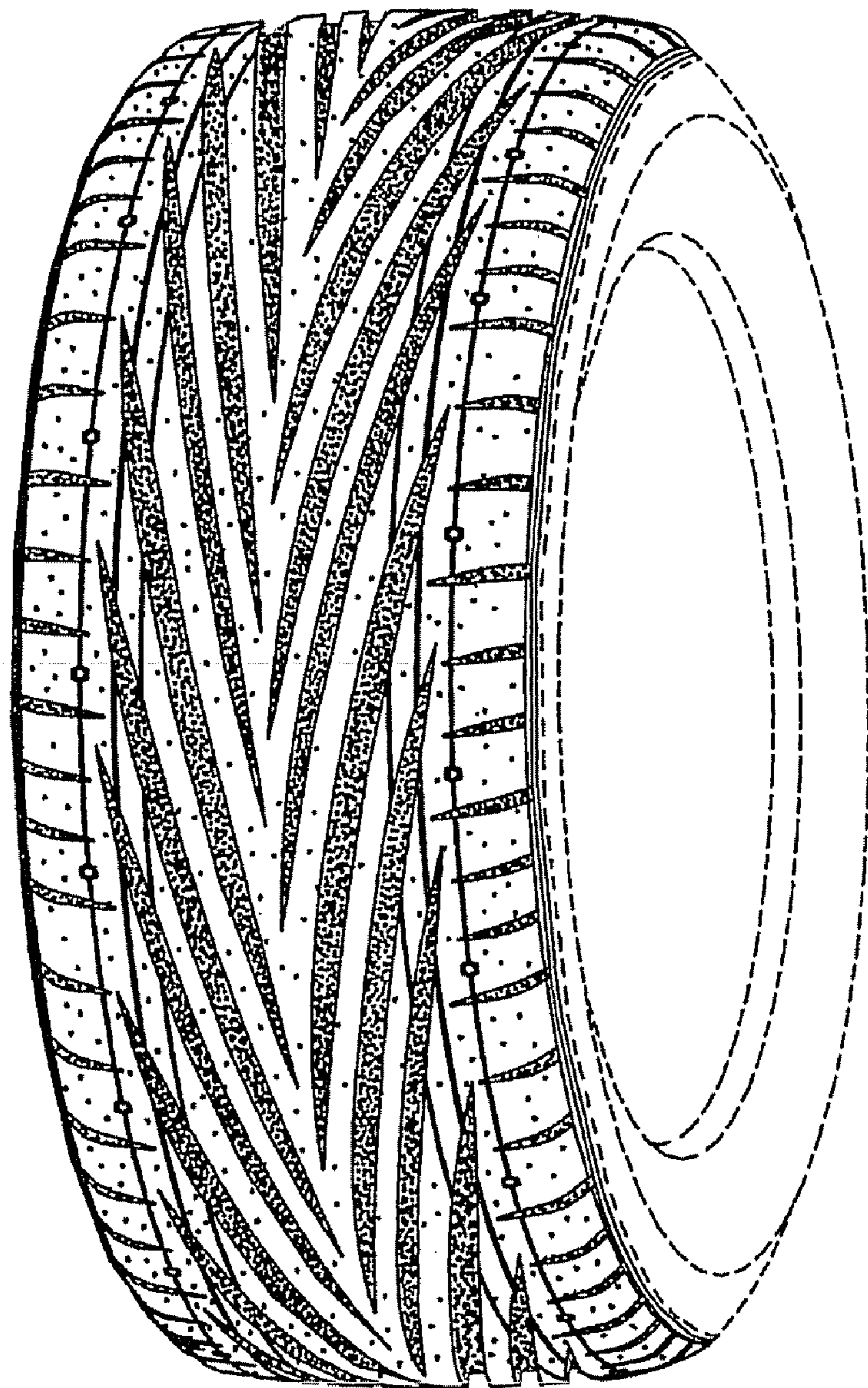

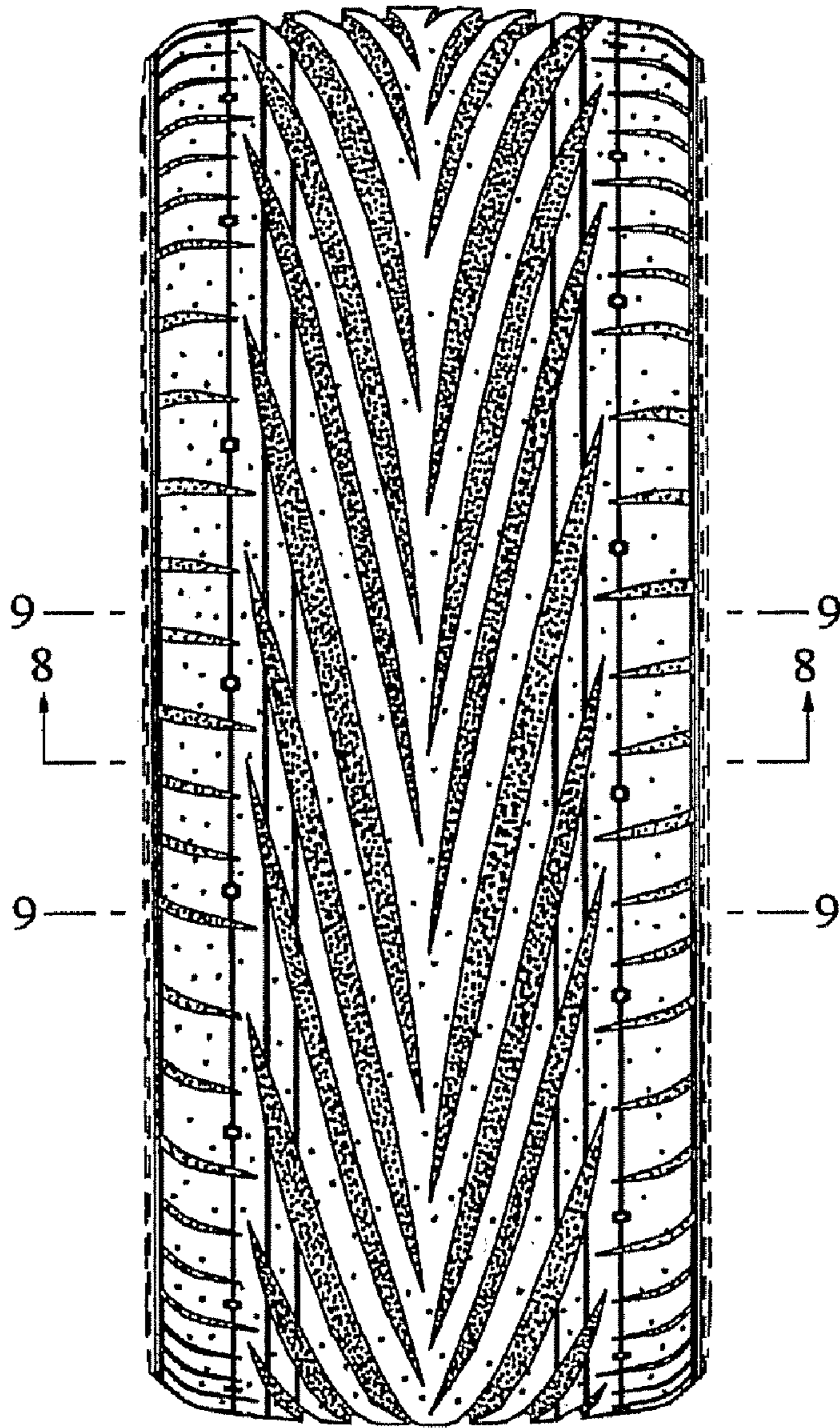

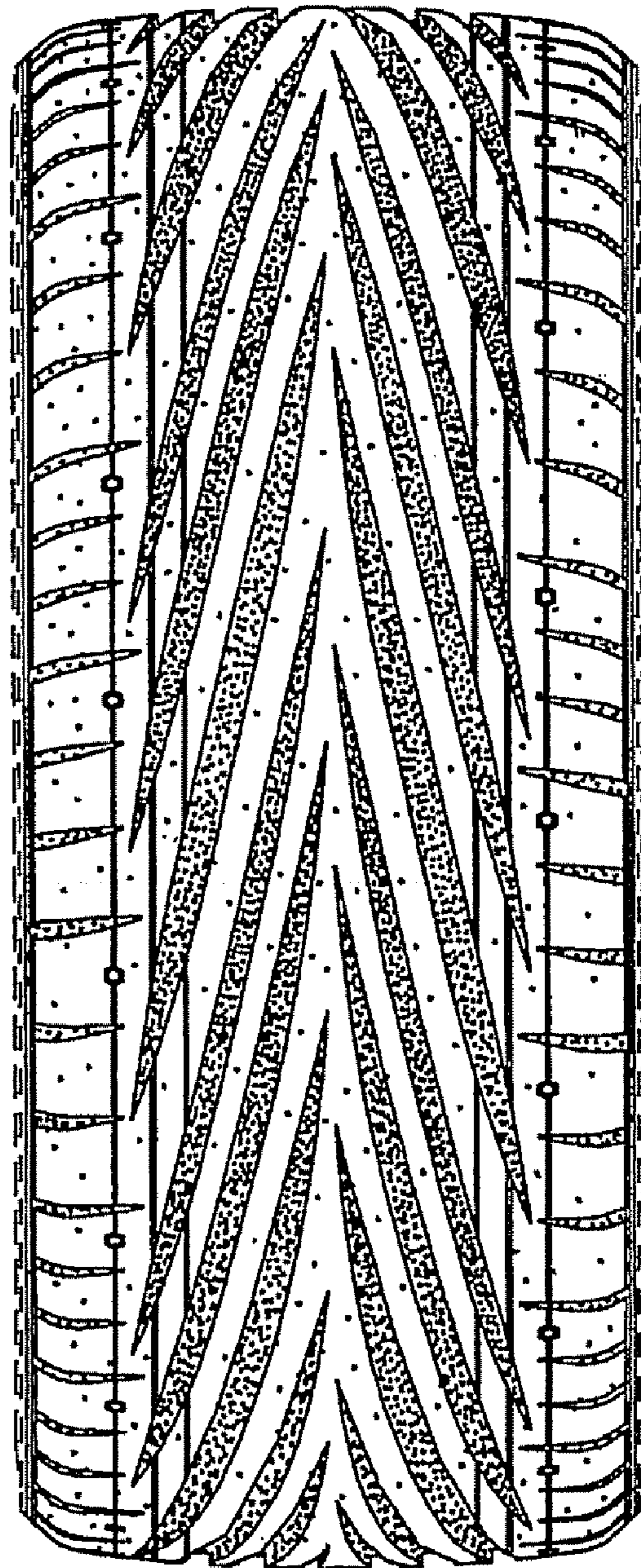

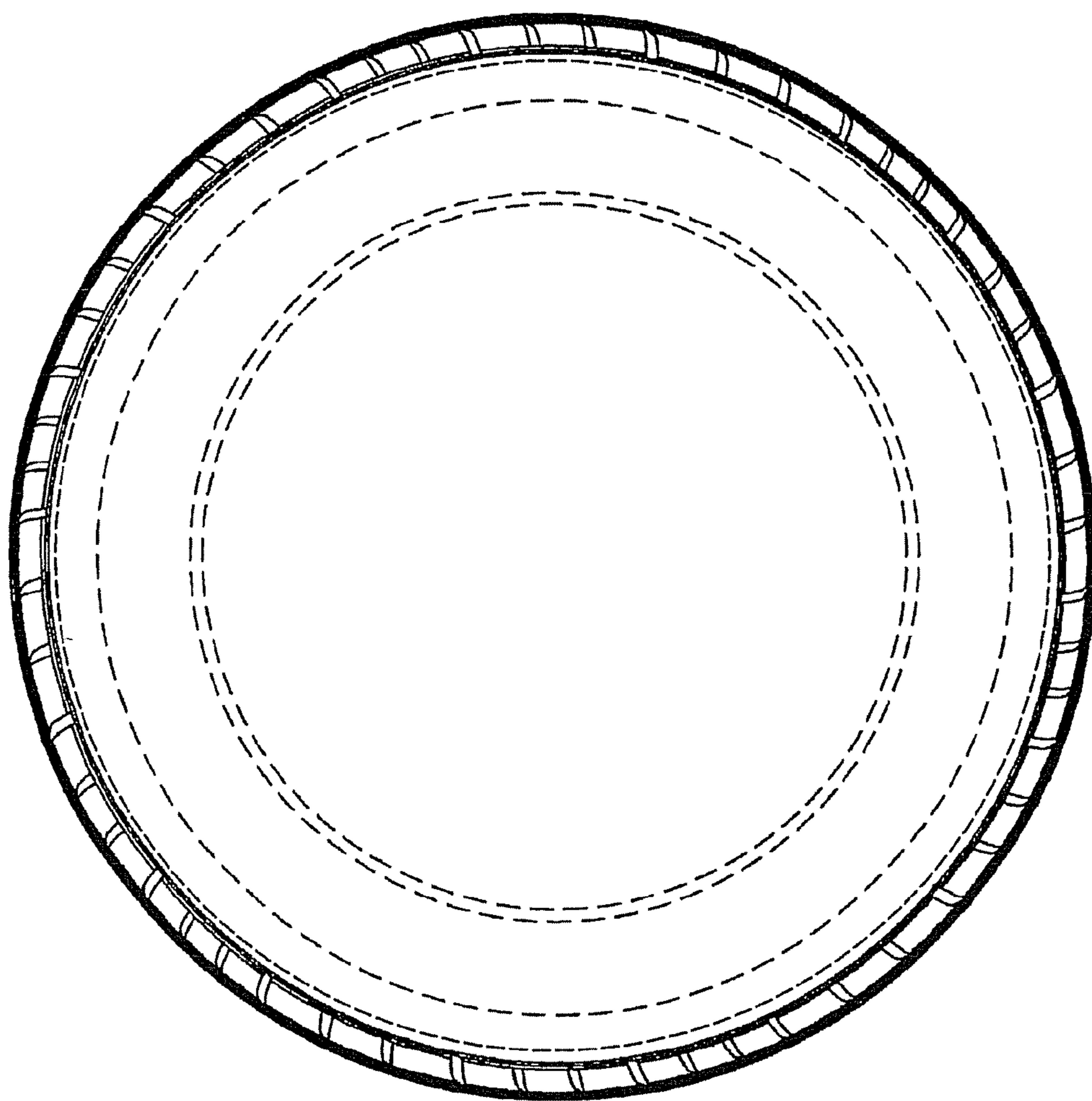

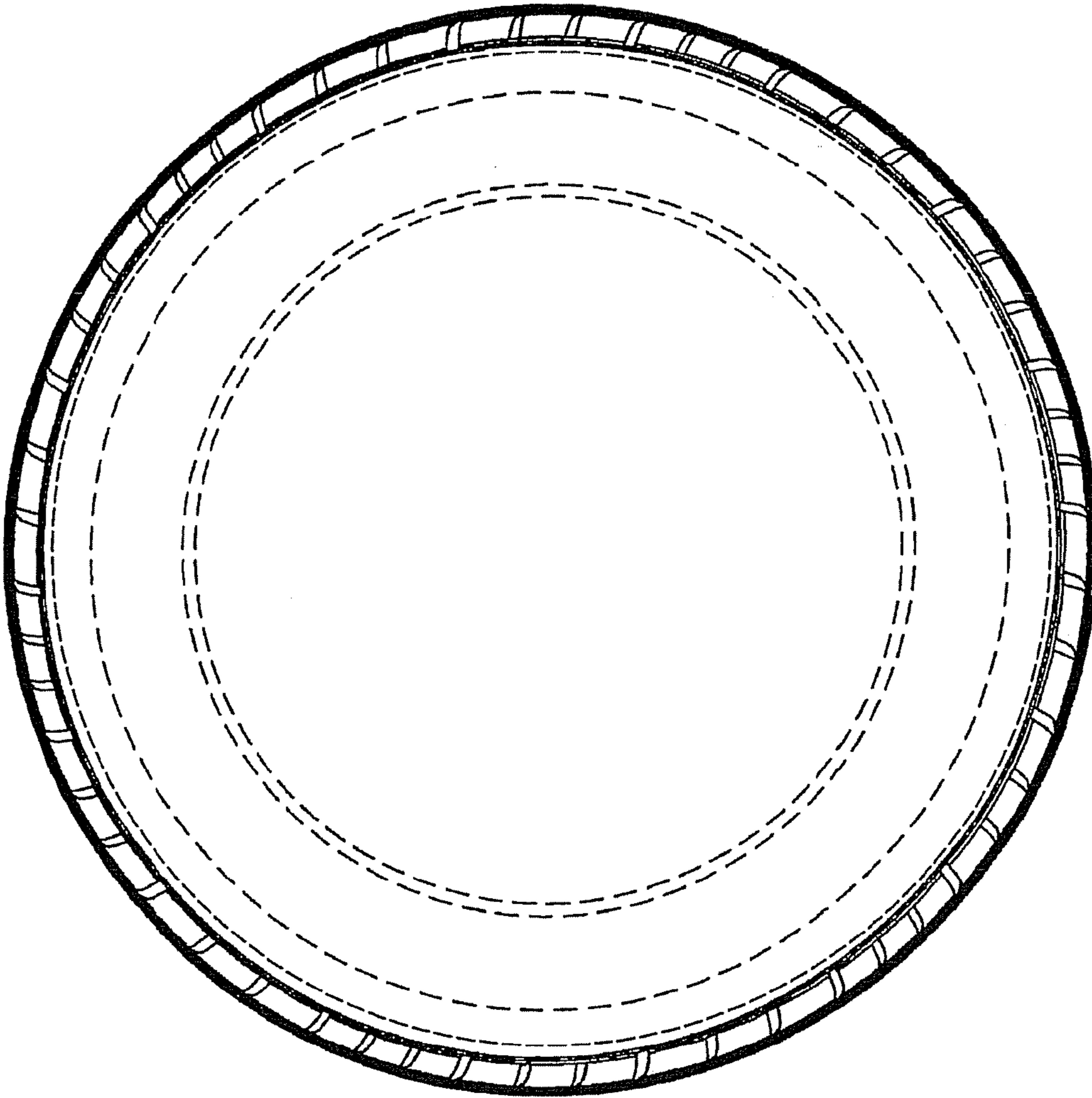

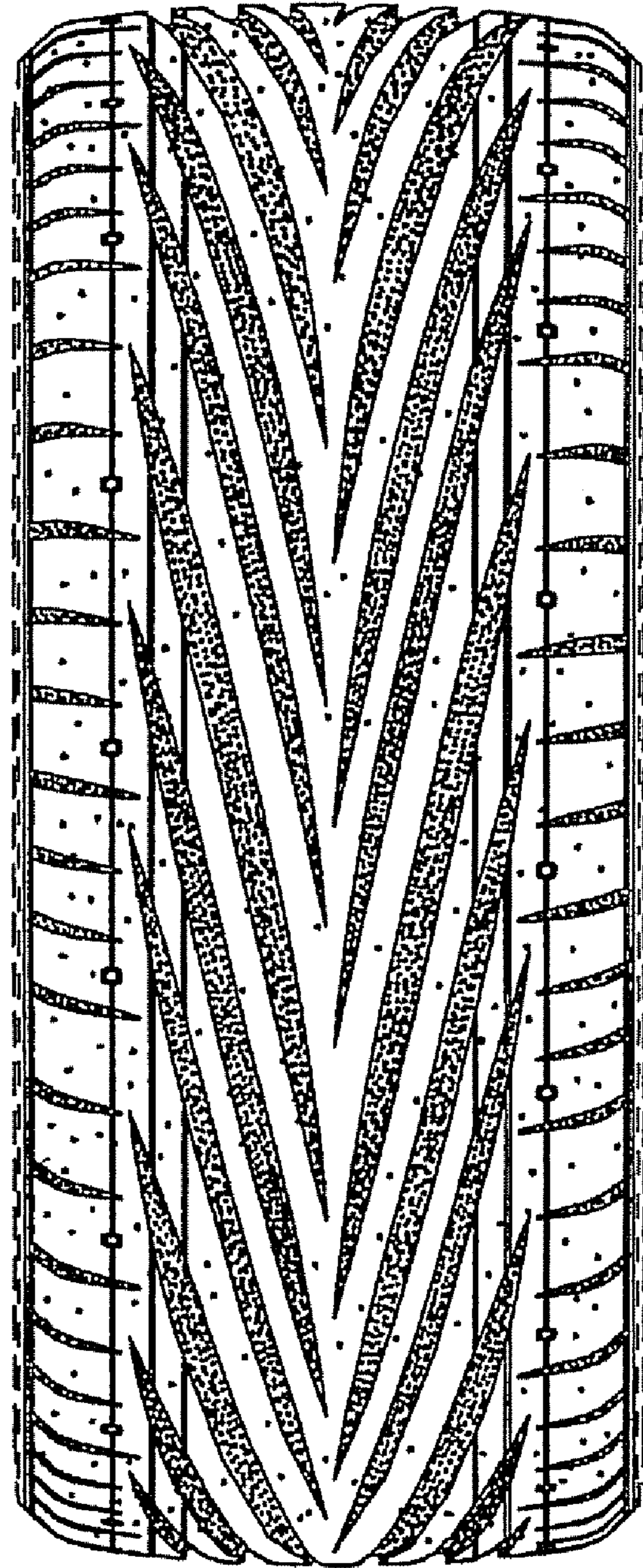

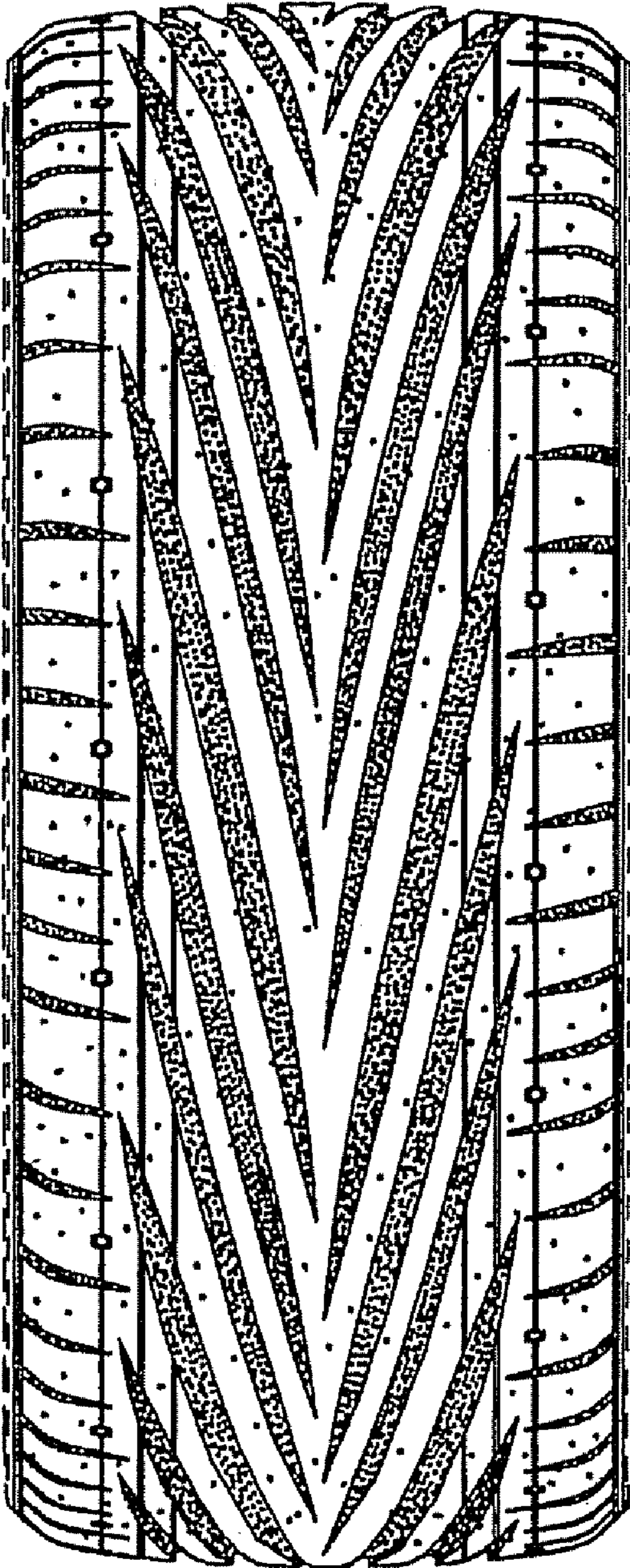

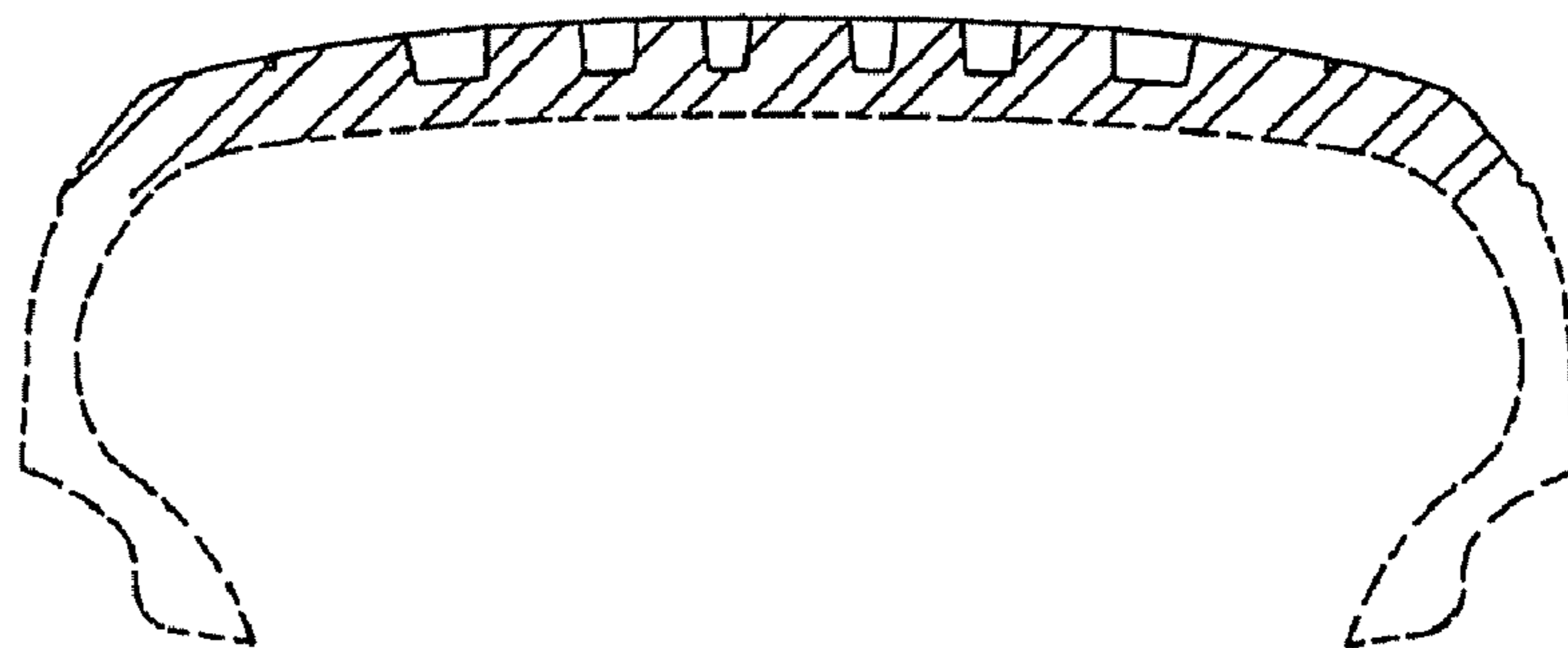
