FIG. 3 is a left-side view of the device.

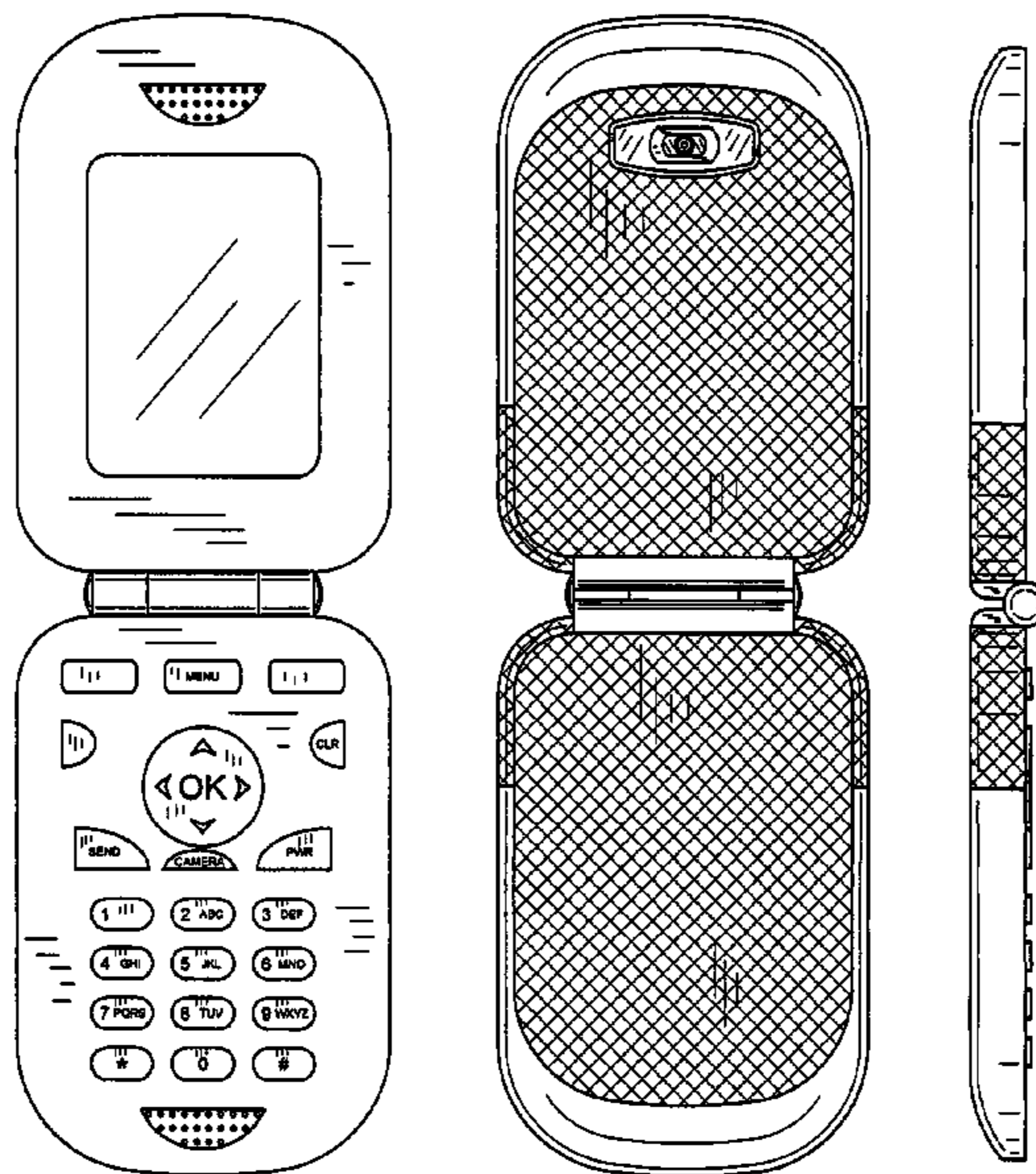
FIG. 4 is a right-side view of the device.

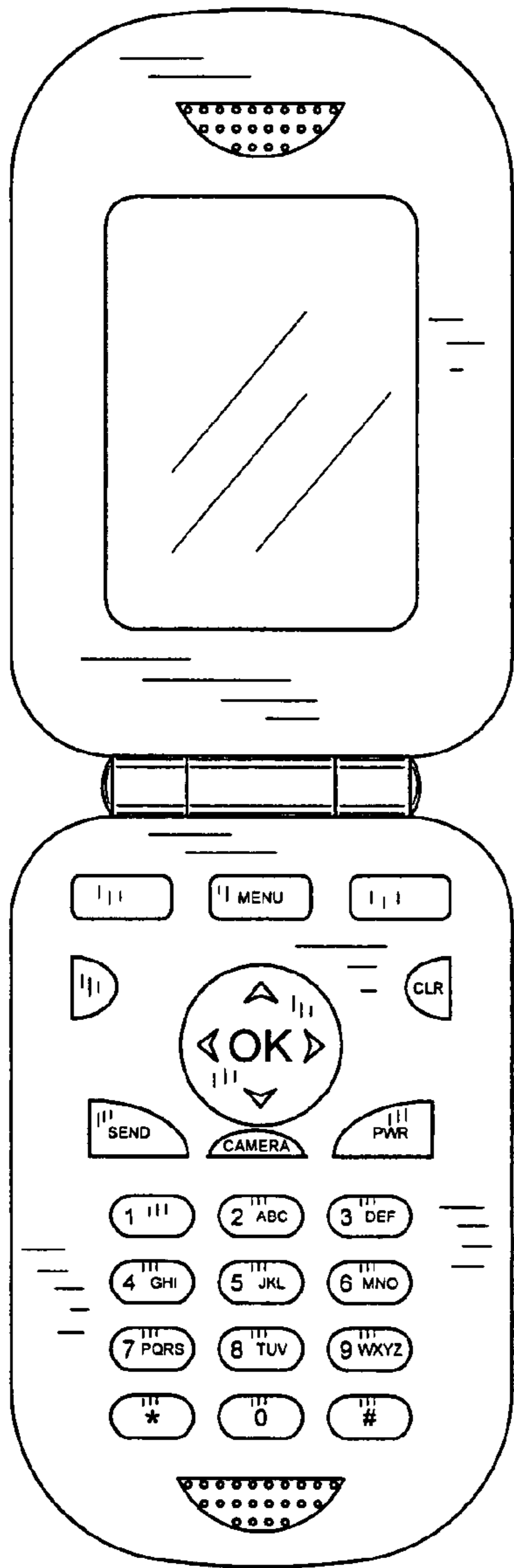

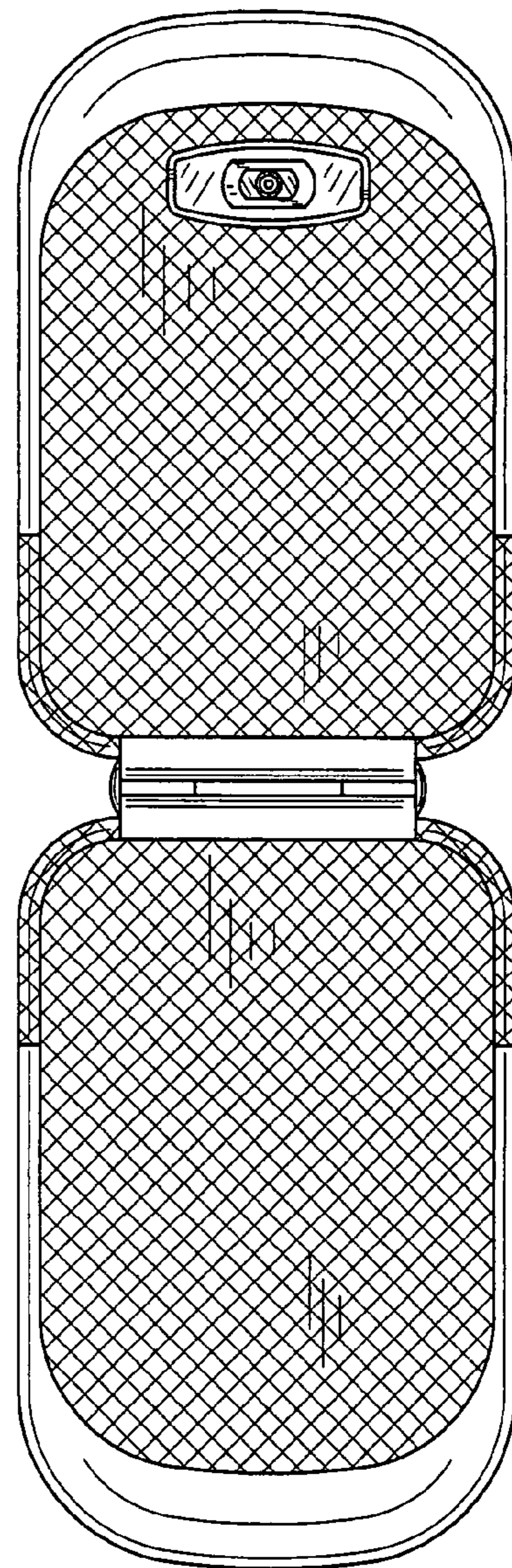

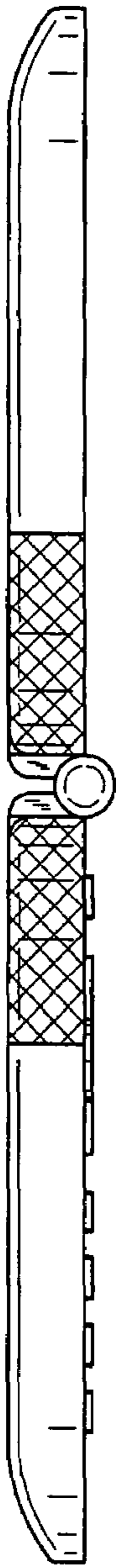

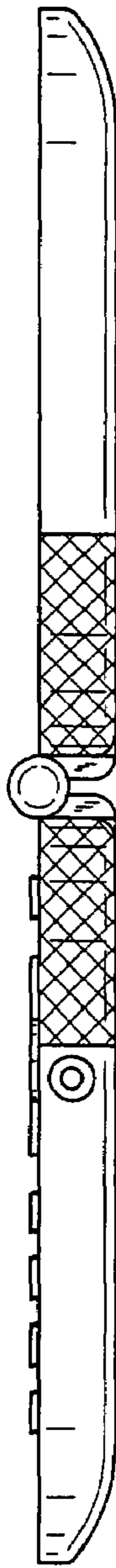

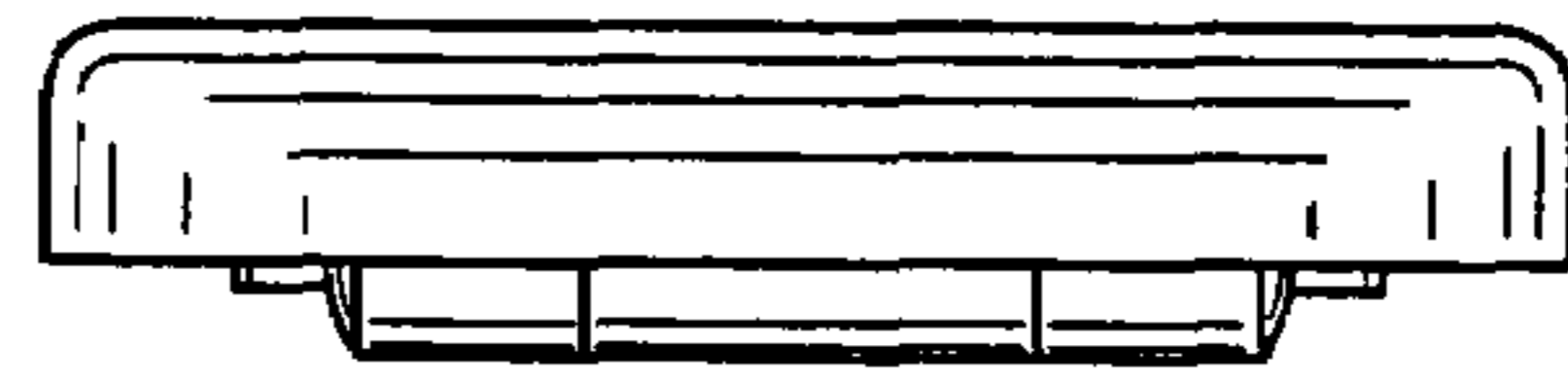

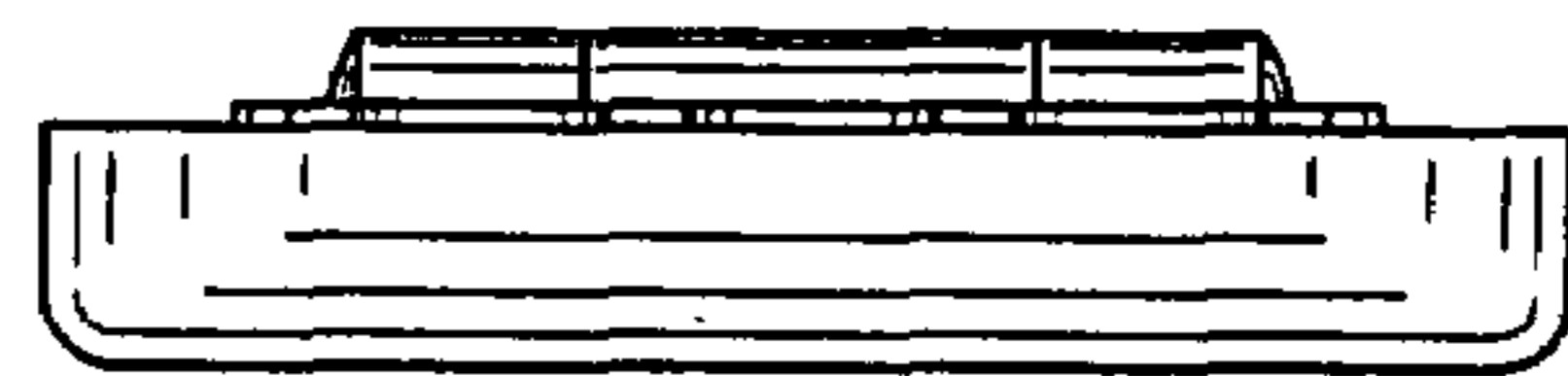

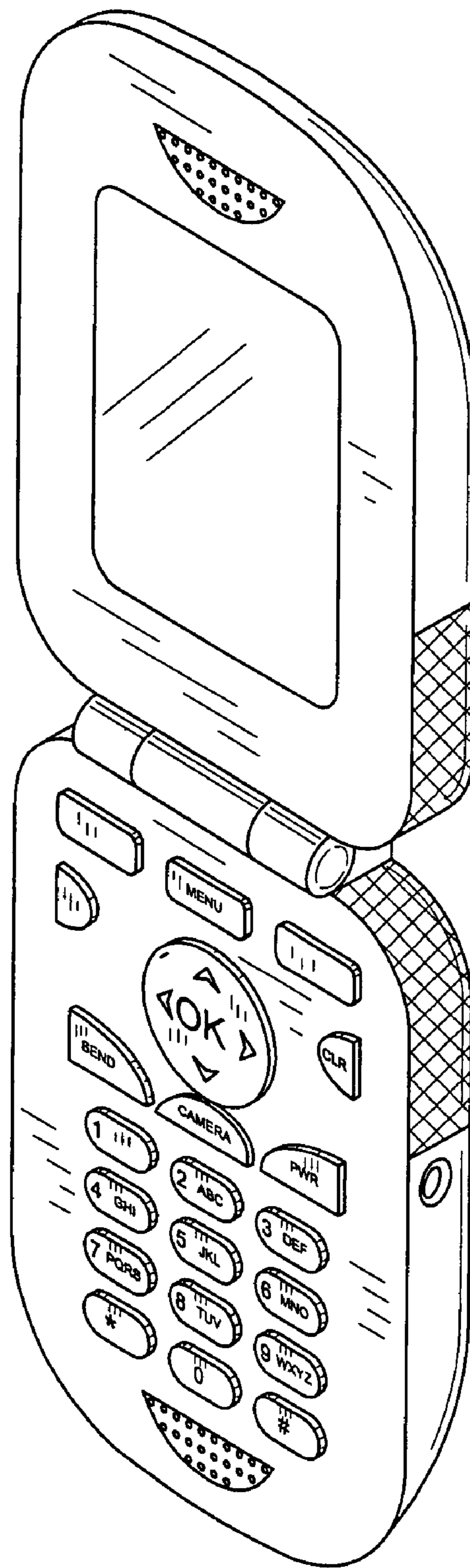
