FIG. 2 is a front view of the second image thereof.

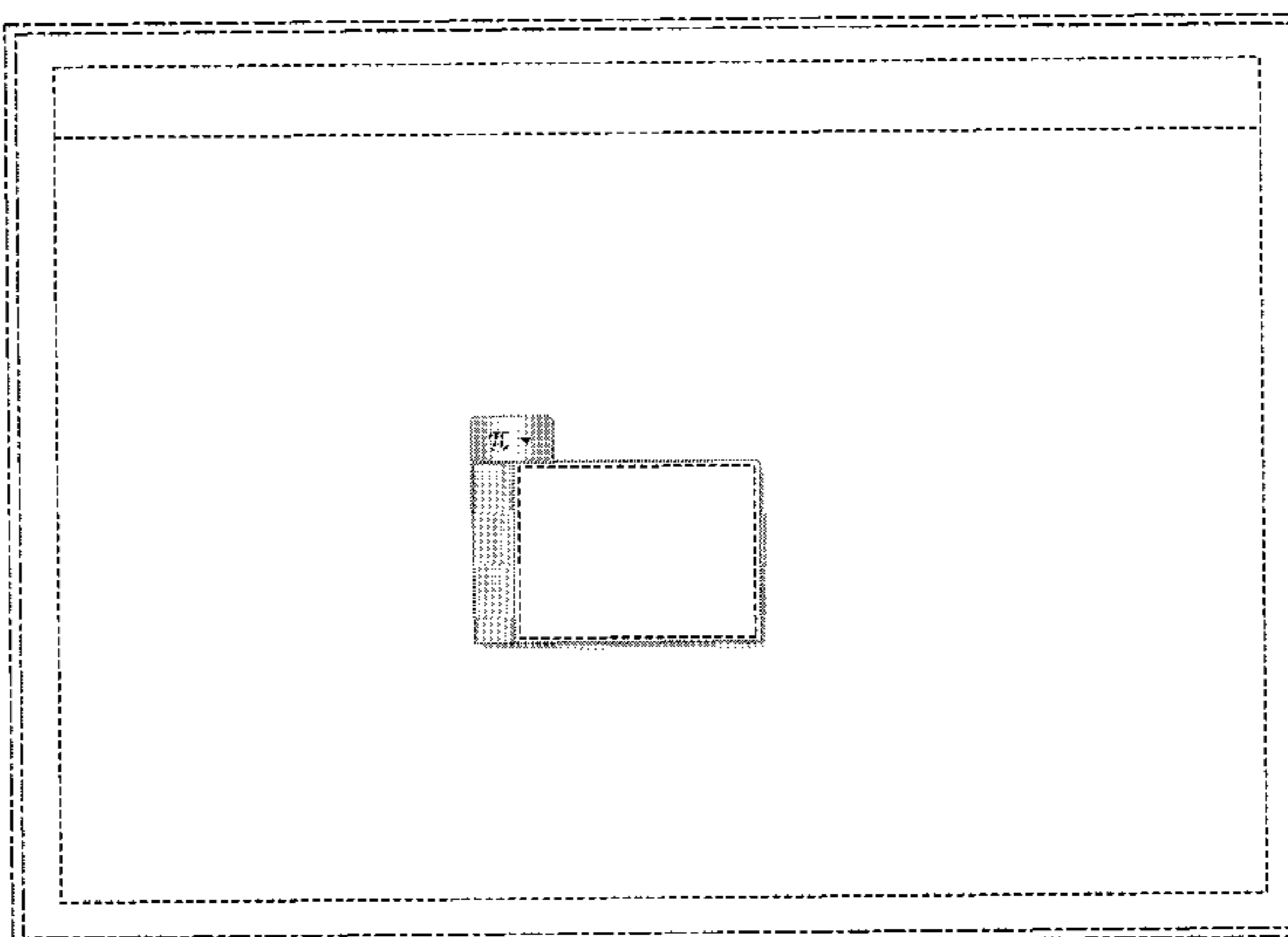
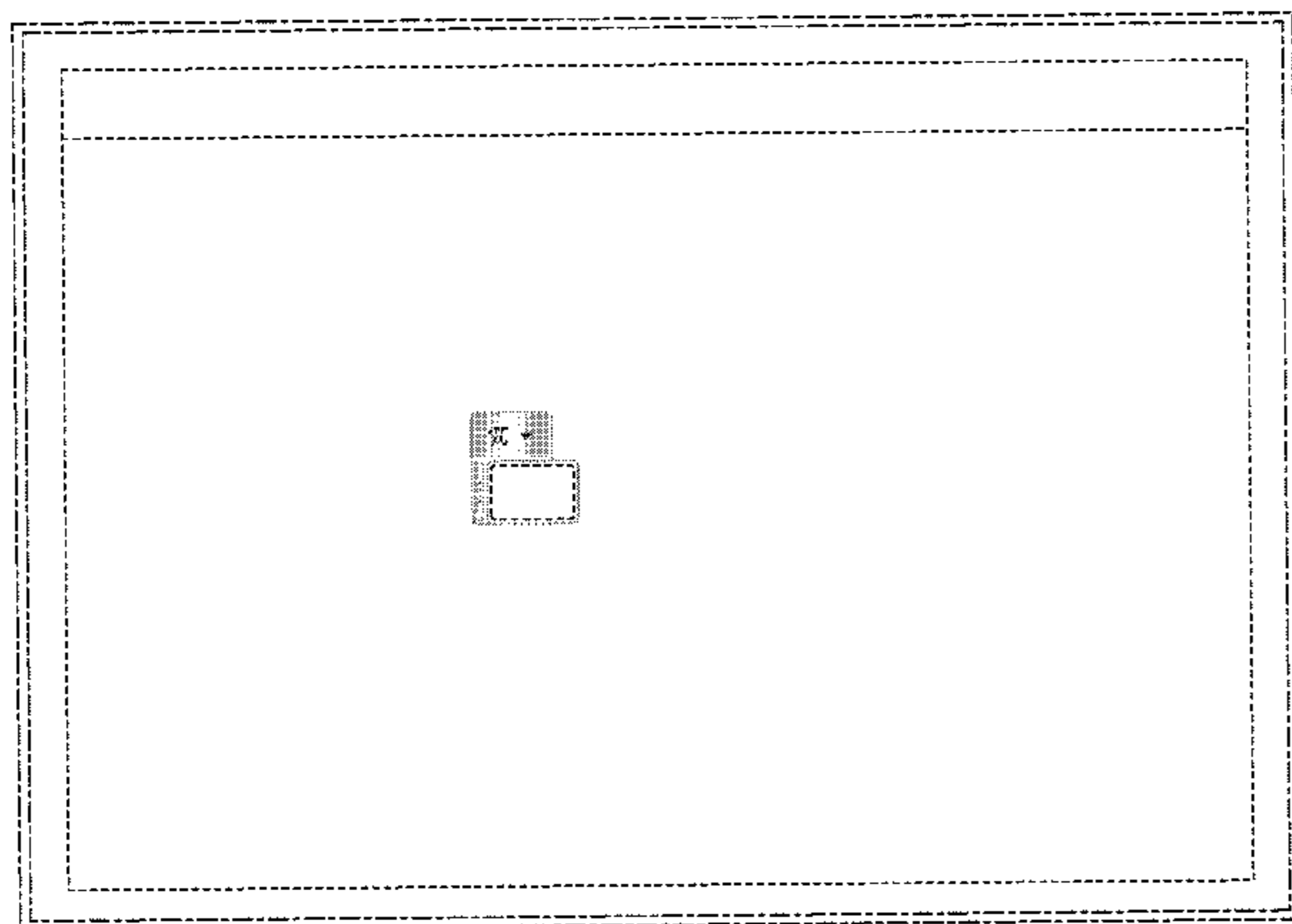

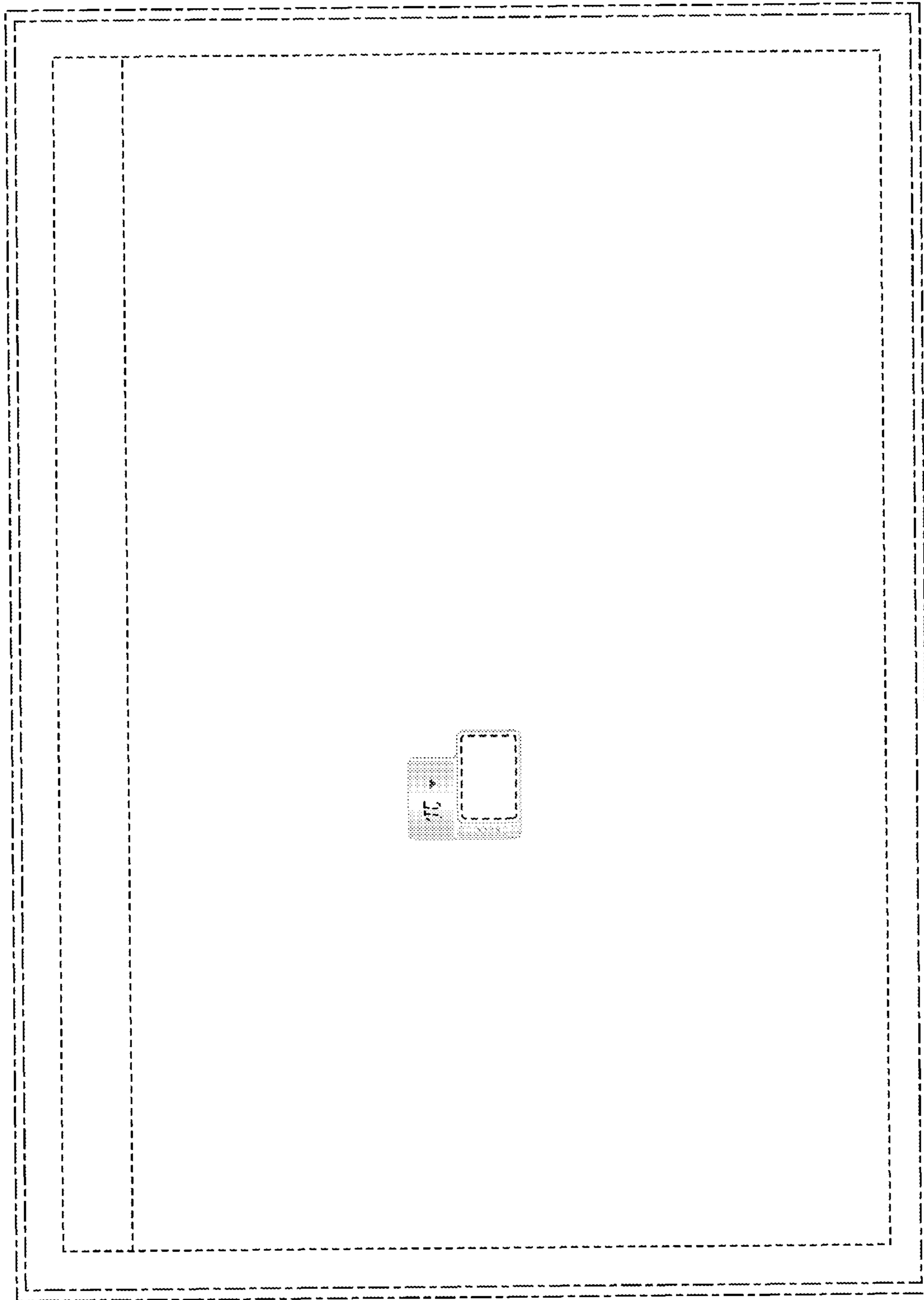

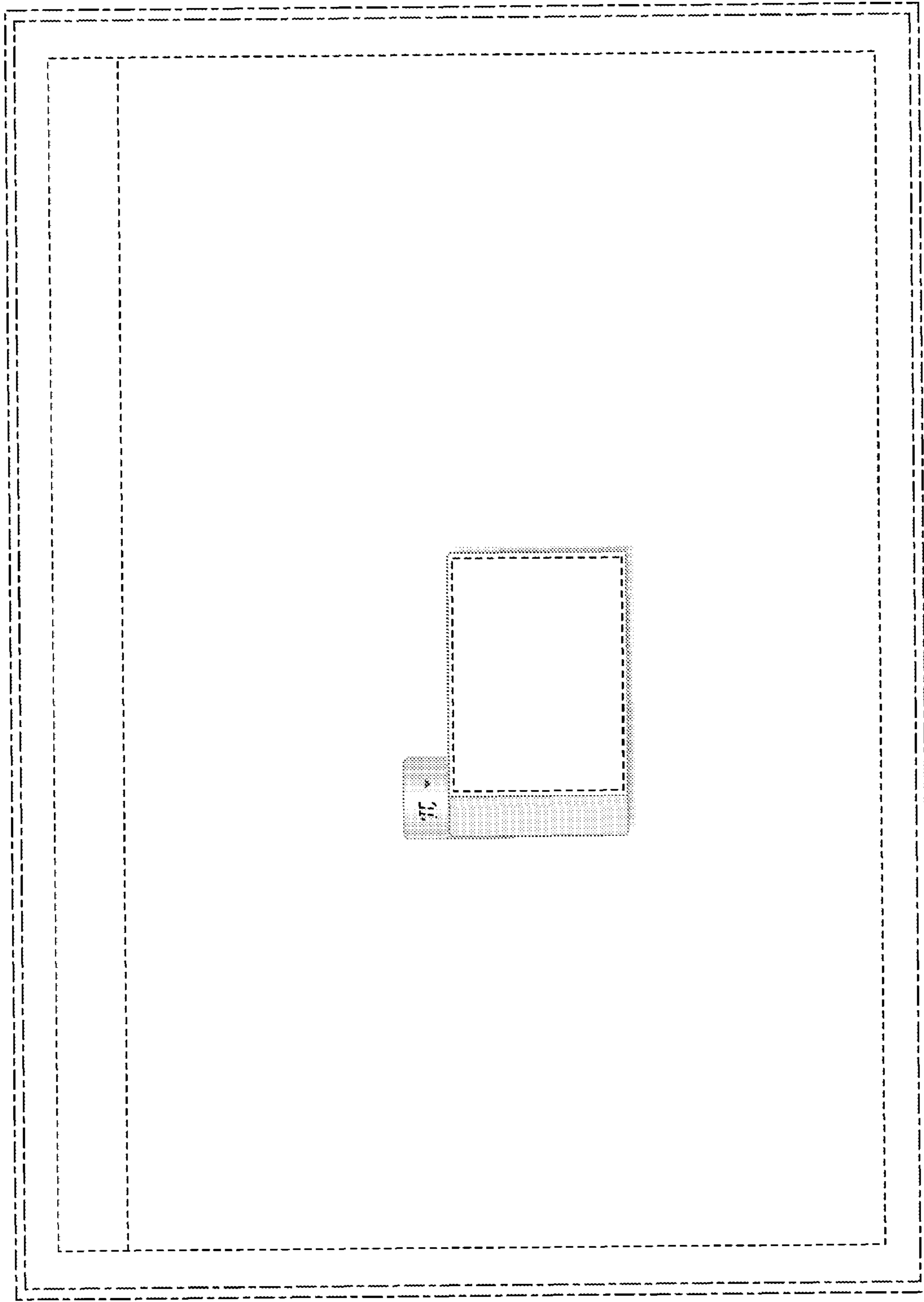
