The ornamental design for handrail for a tractor, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a handrail for a tractor showing my new design;

FIG. 2 is a rear view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is an enlarged left side view thereof;

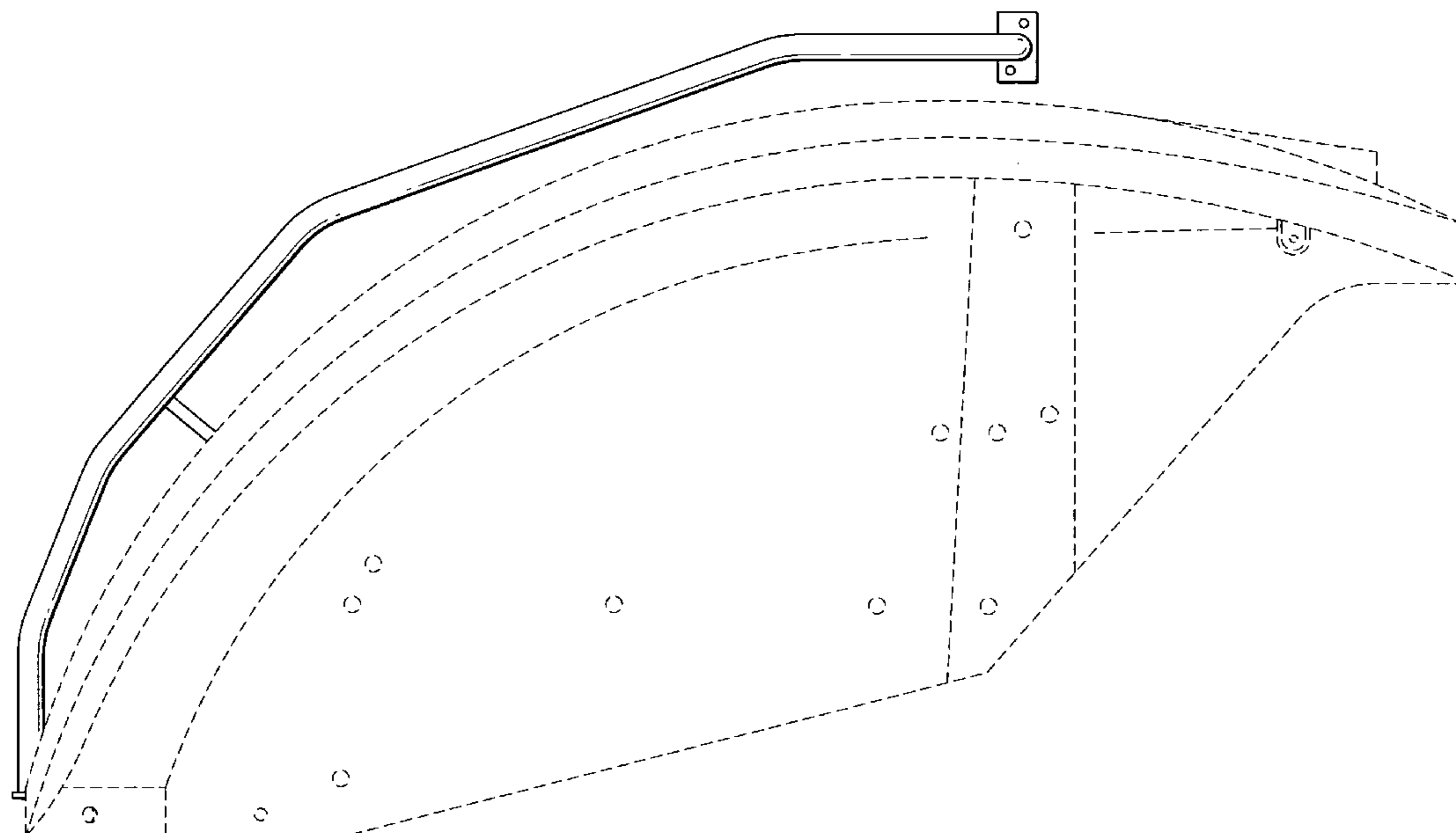
FIG. 6 is an enlarged right side view thereof;

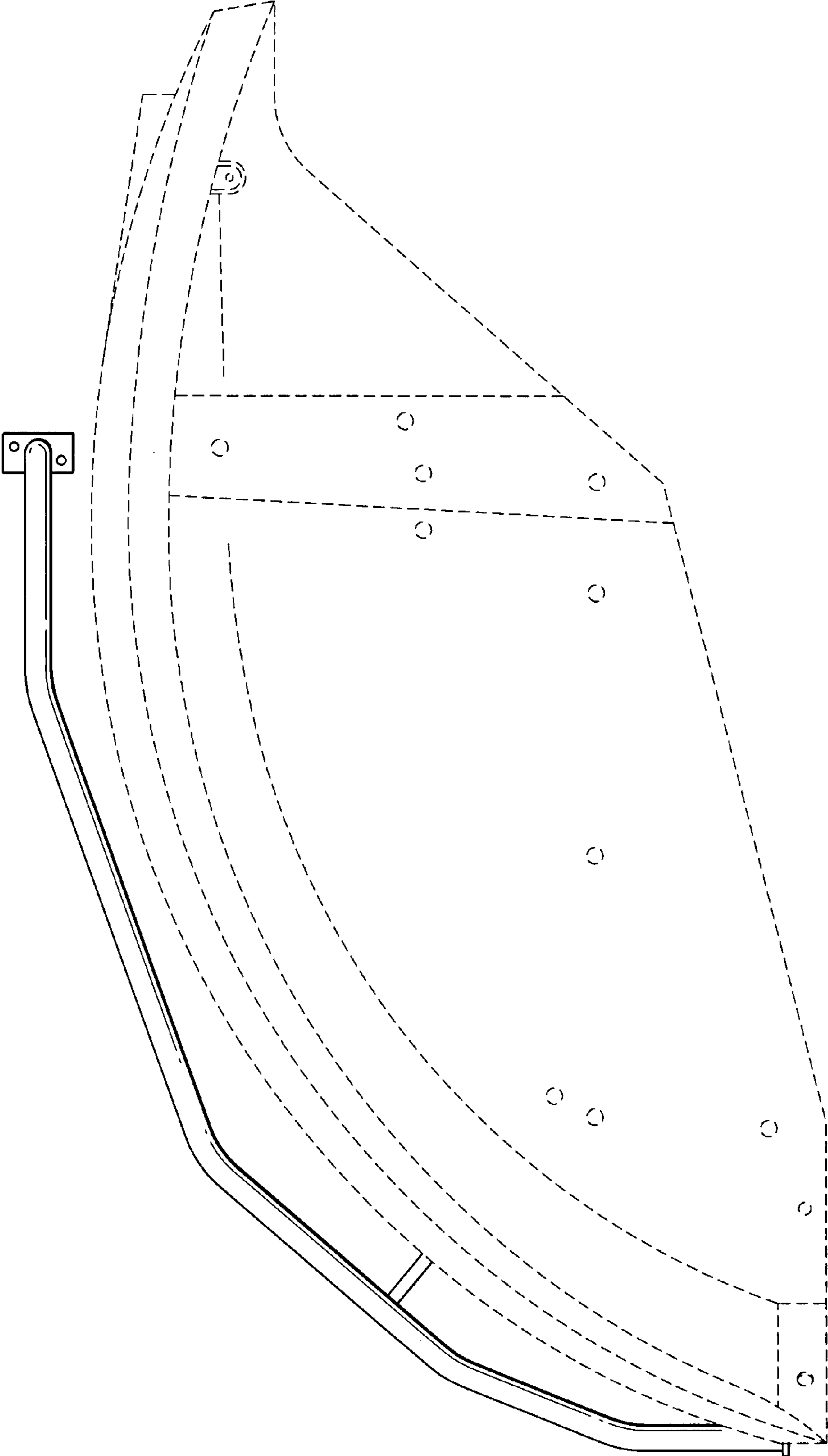

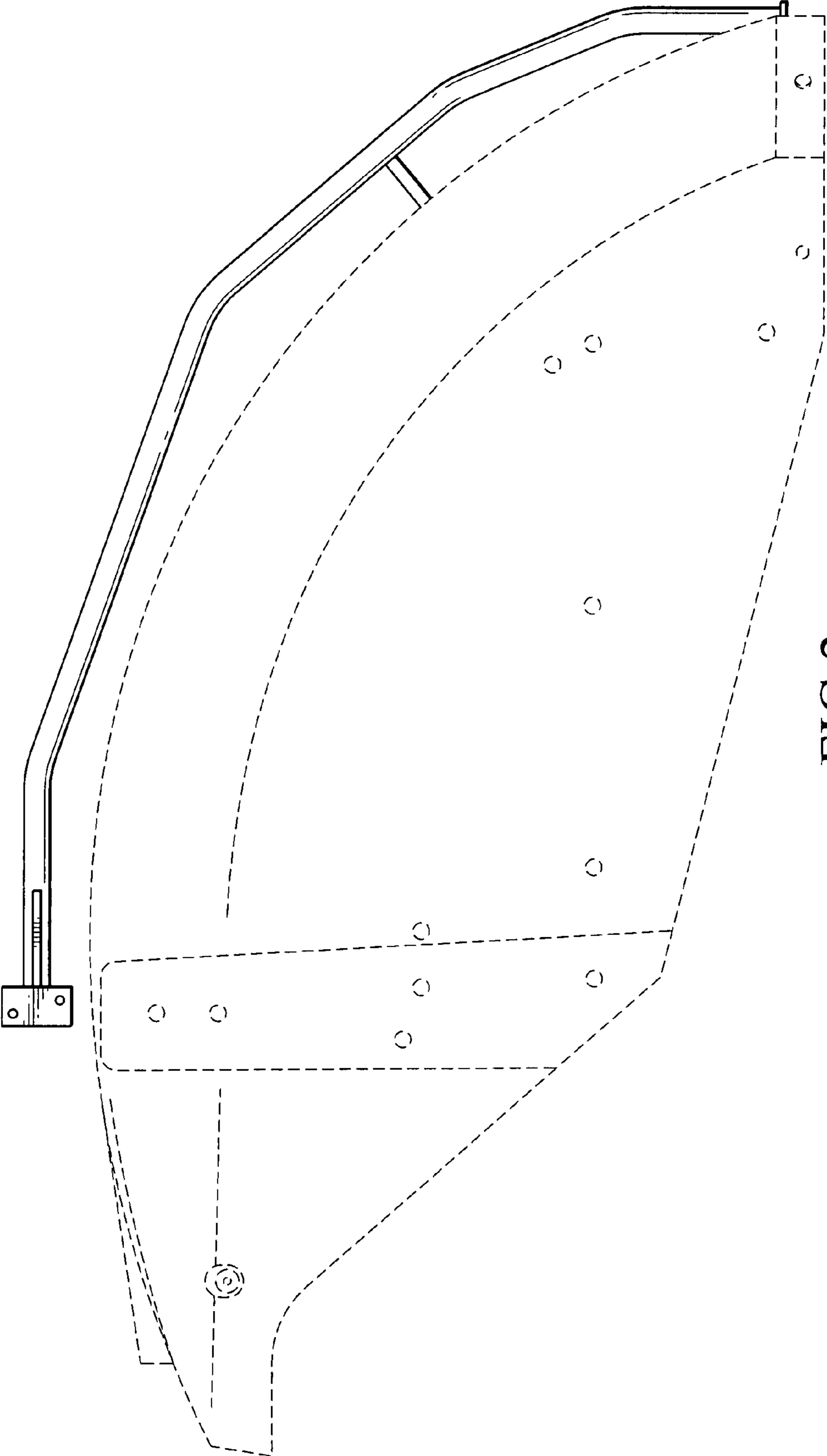

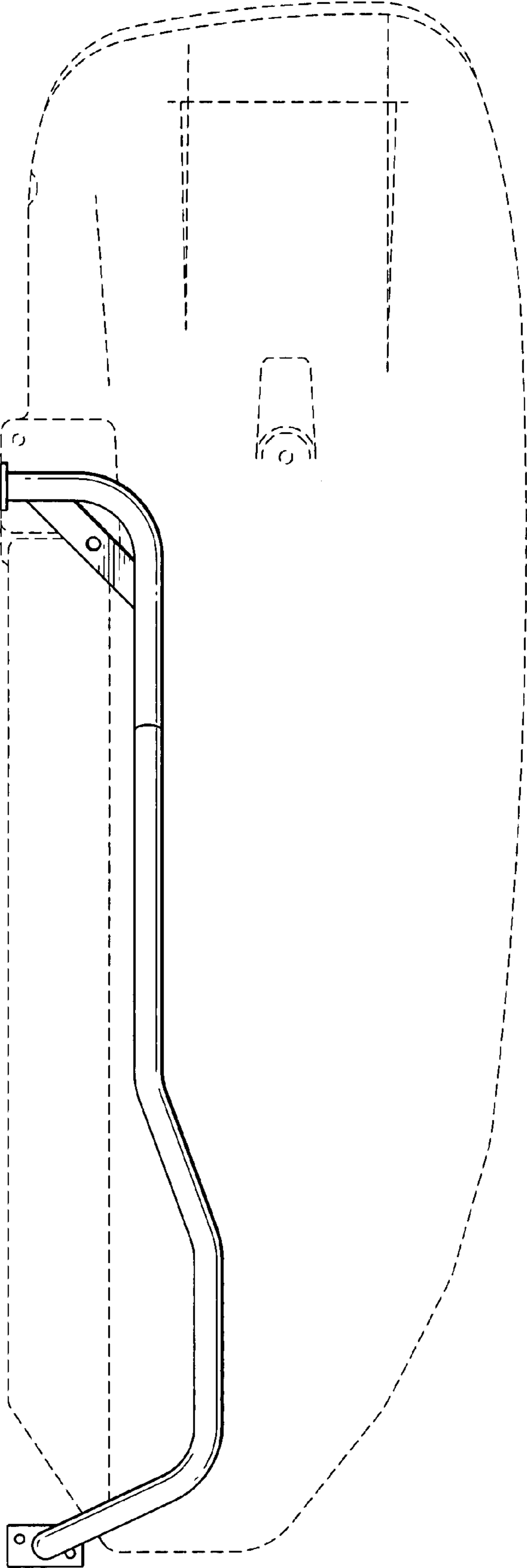

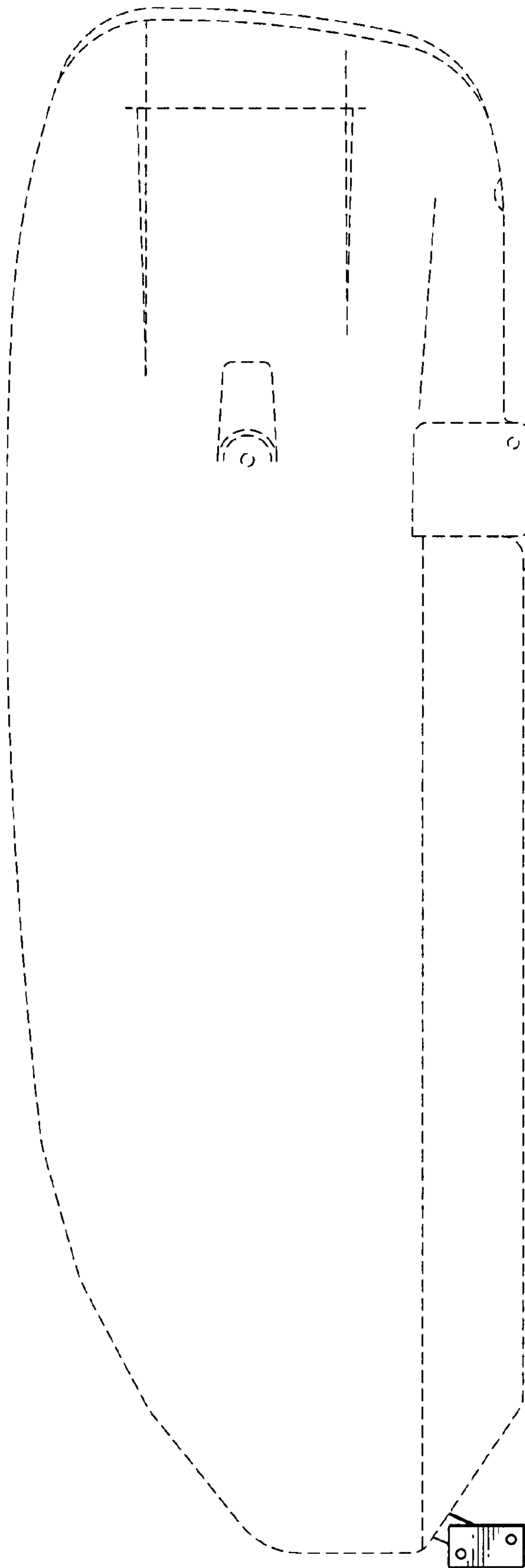

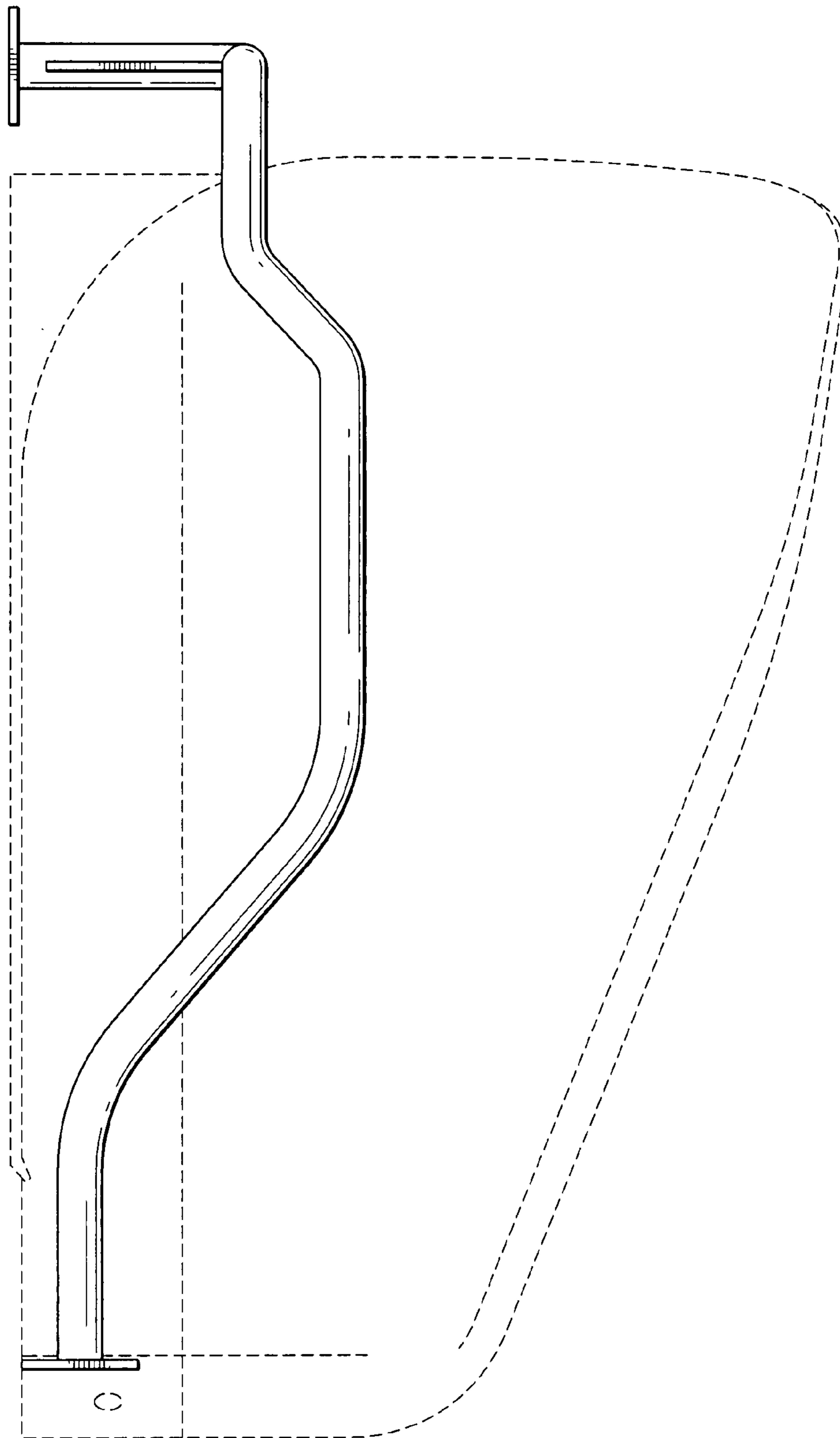

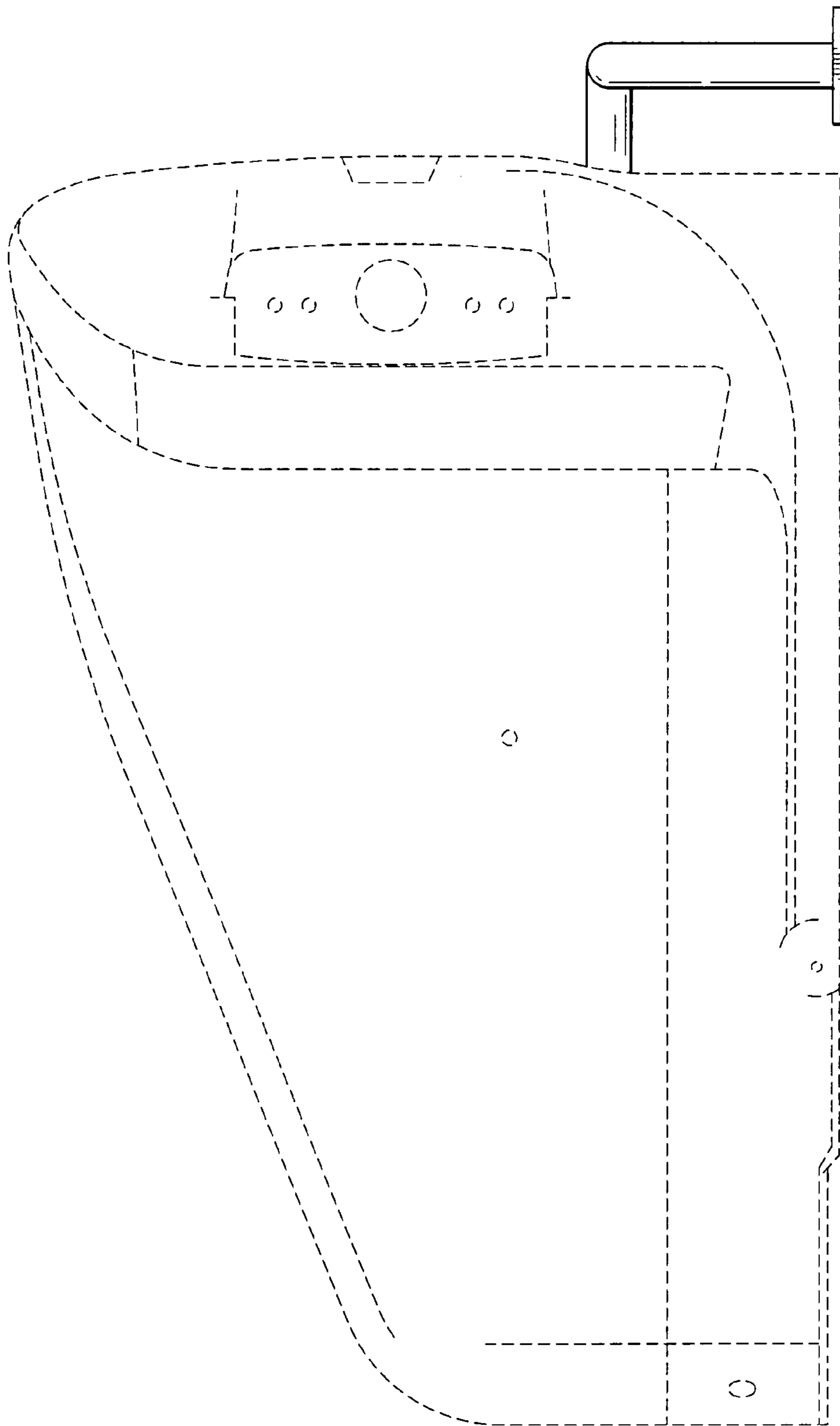
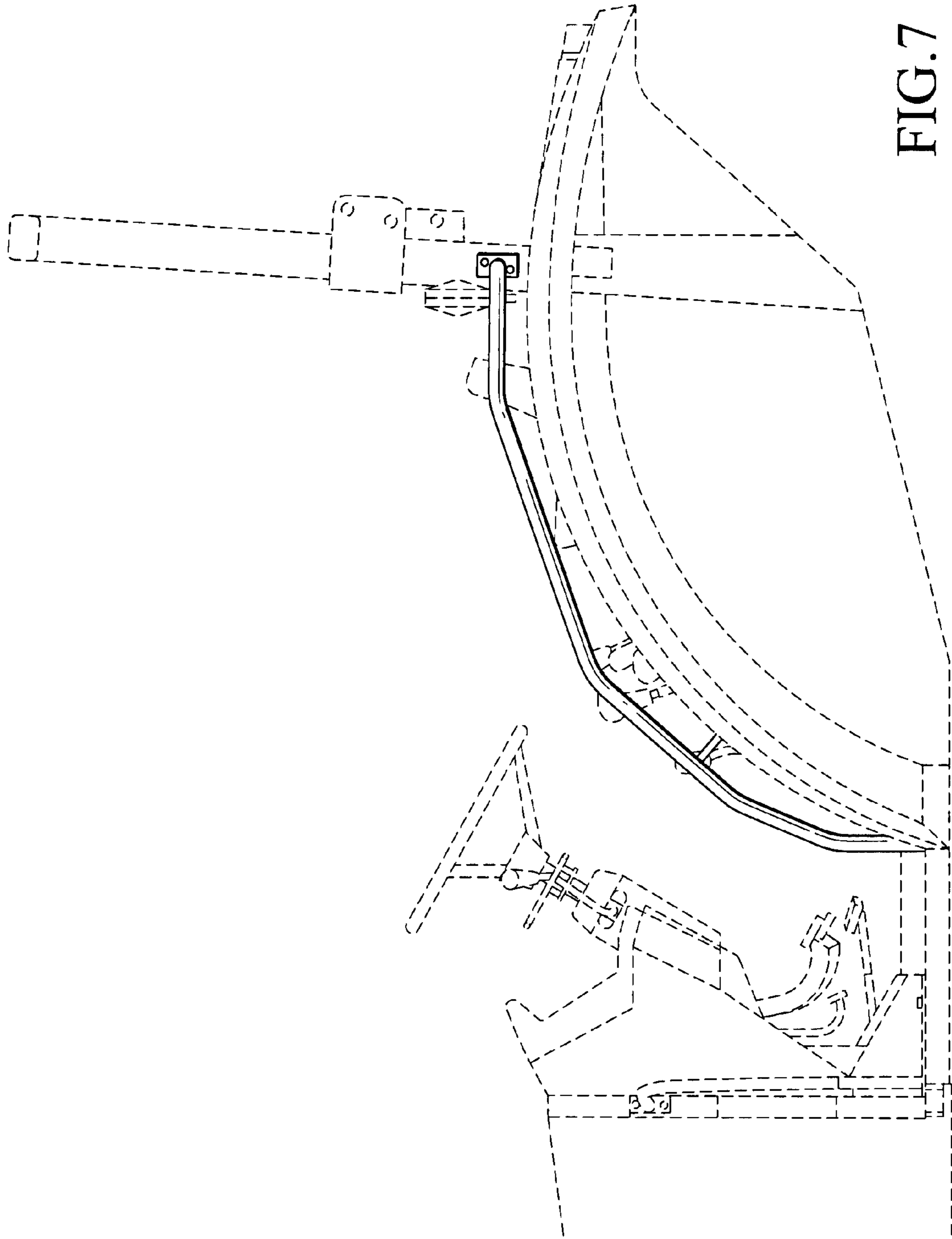

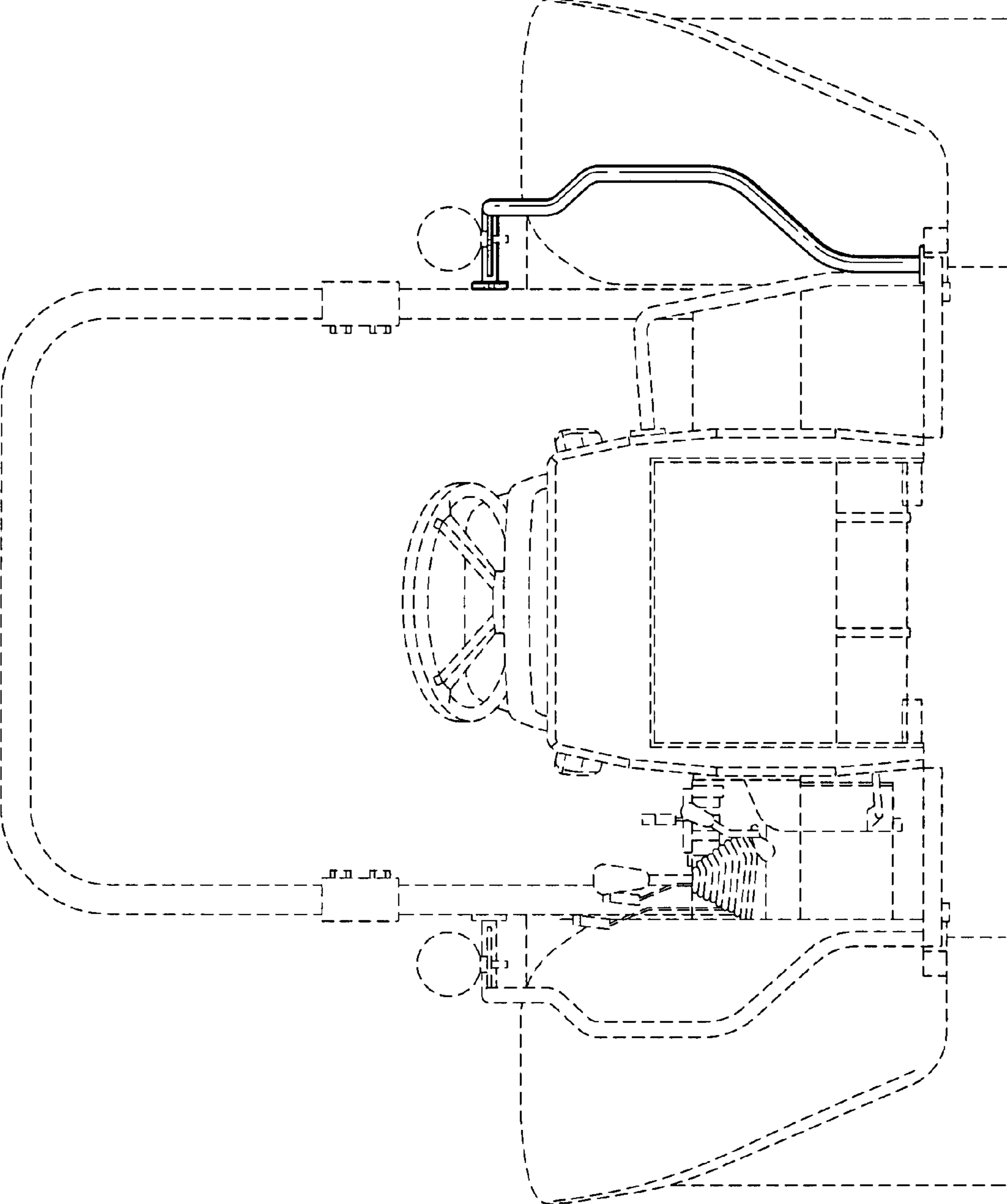
