FIG. 5 is a right-side elevational view thereof;

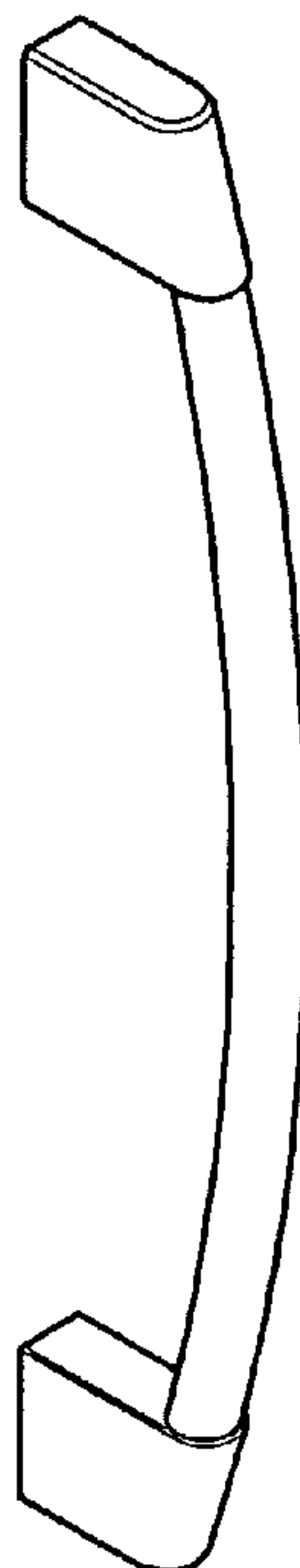
FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

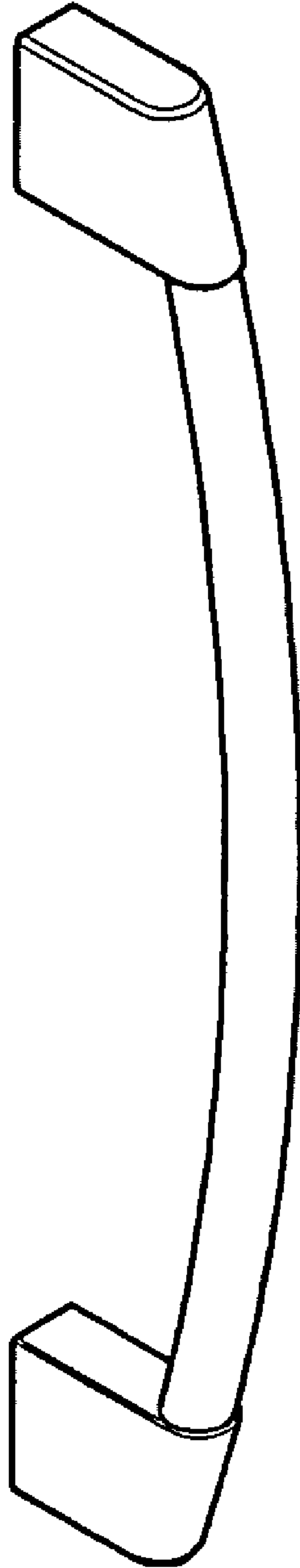
FIG. 8 is a reduced front, left-side, top perspective view thereof, shown in condition of use.

The broken lines shown in the drawing disclosure are for illustrative purposes only and form no part of the claimed design.

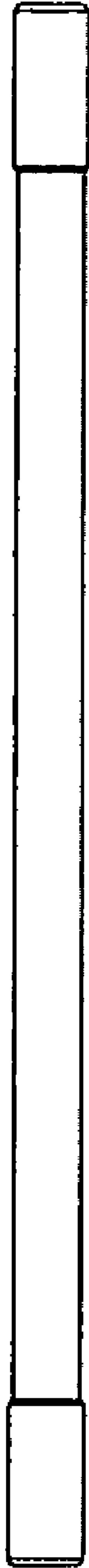

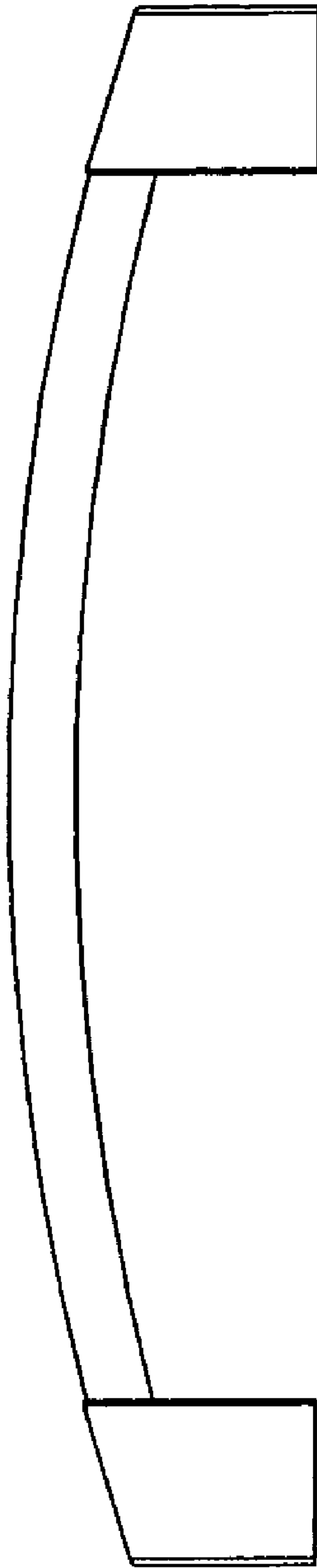

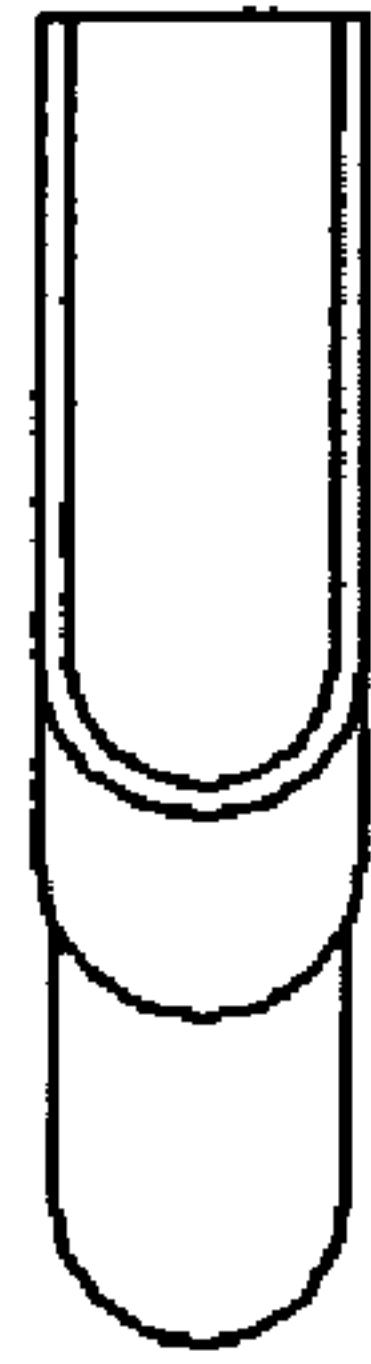
