(57) **CLAIM**

We claim the ornamental design for a toy wagon, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the toy wagon;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

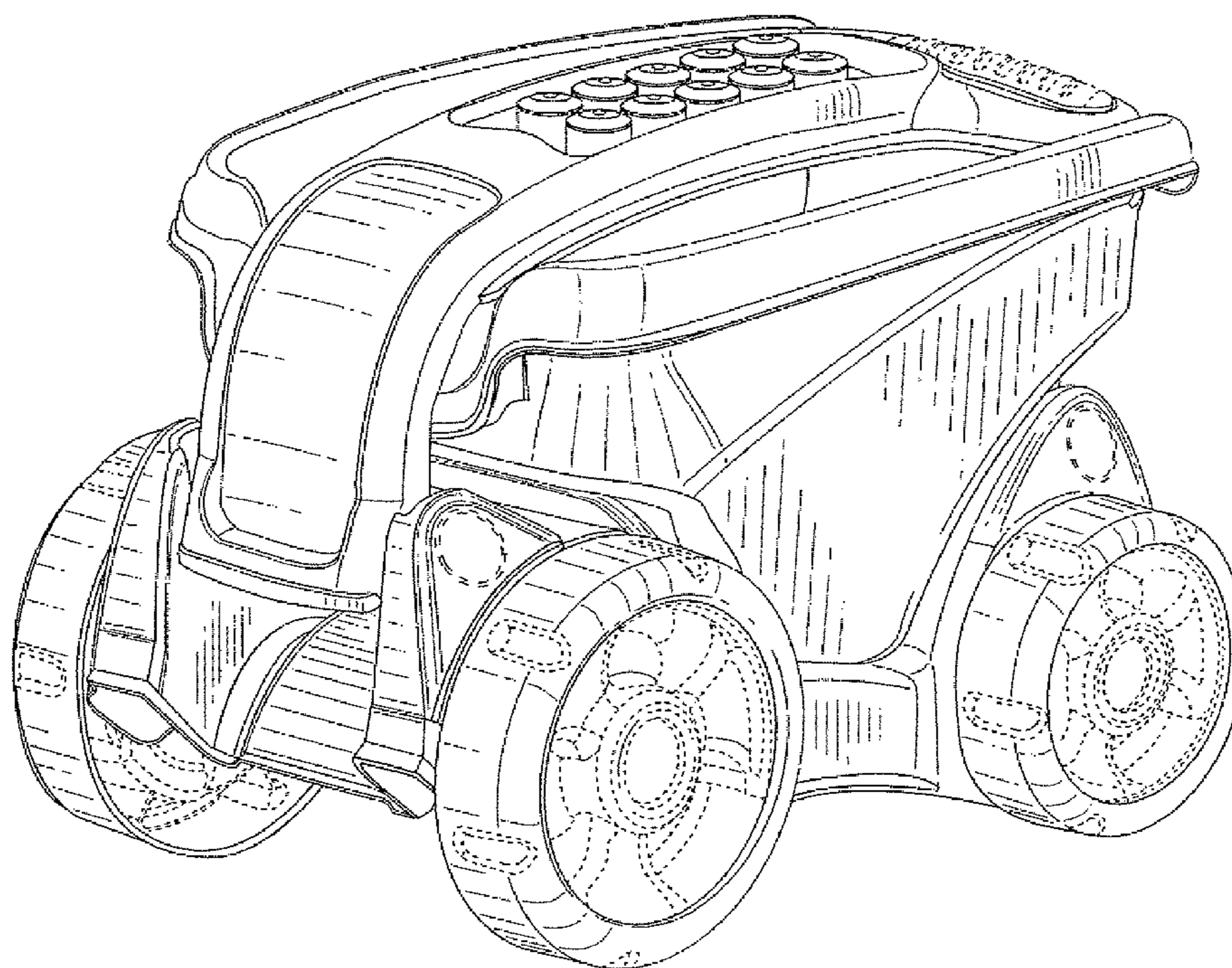
FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof; and,

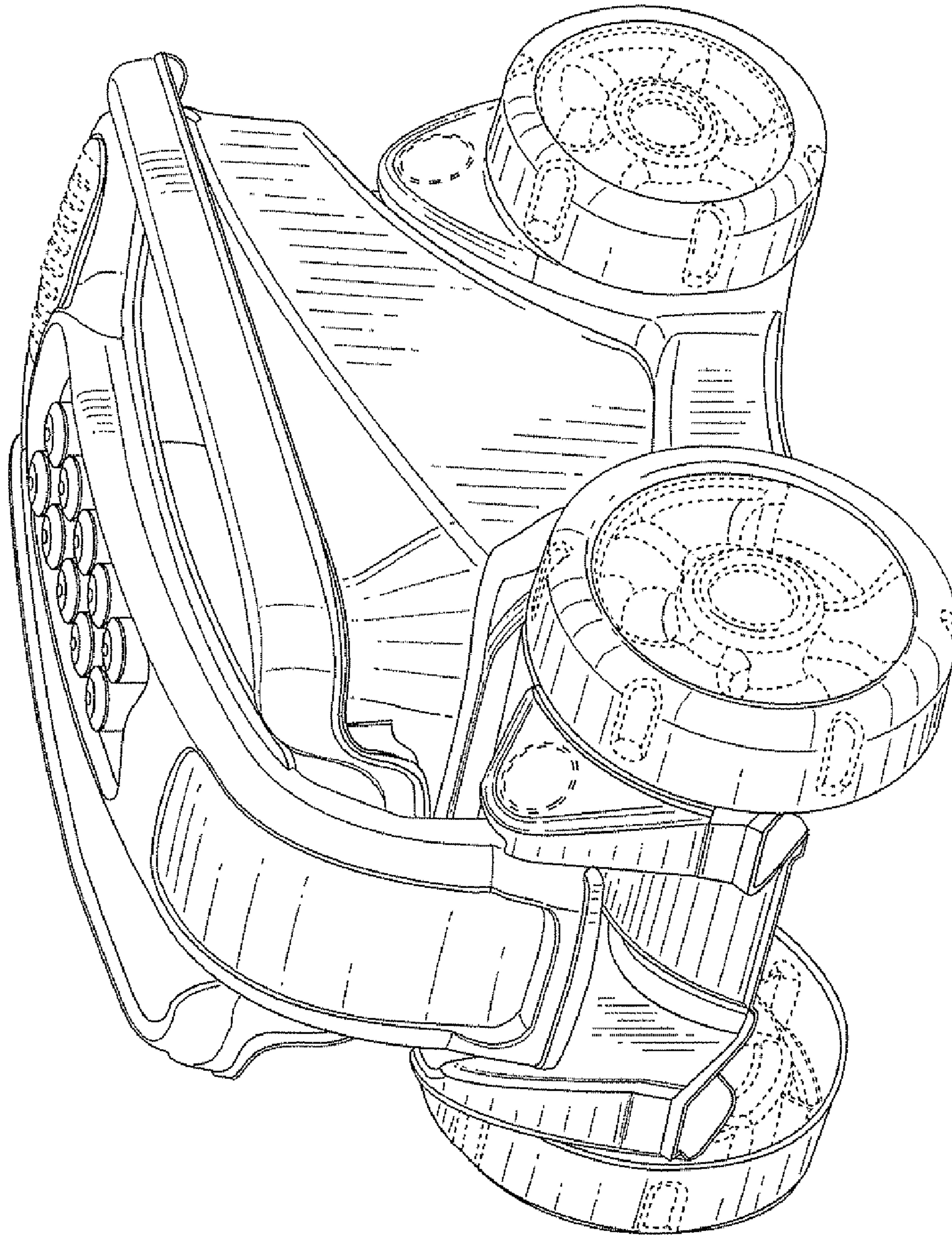

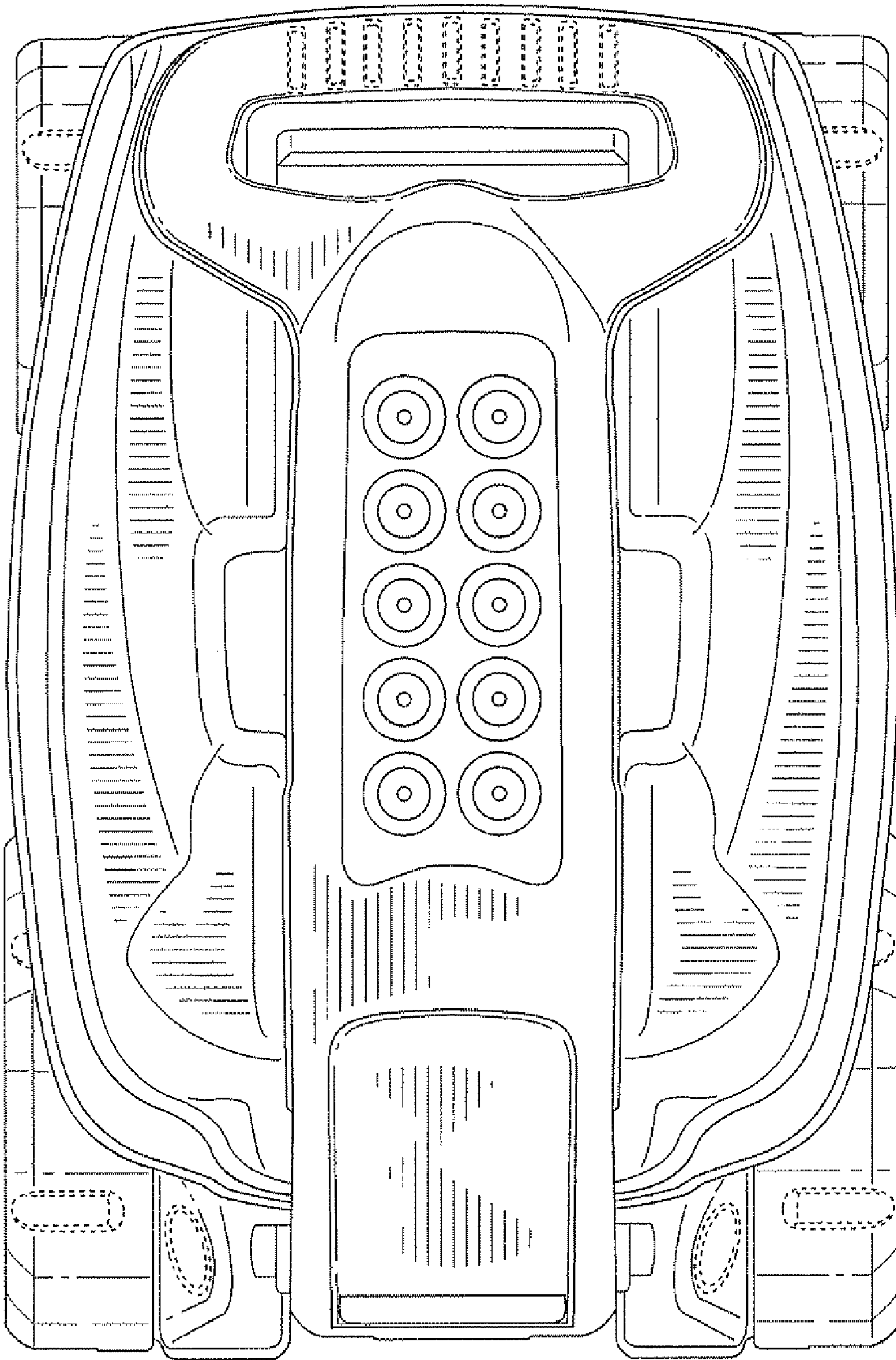

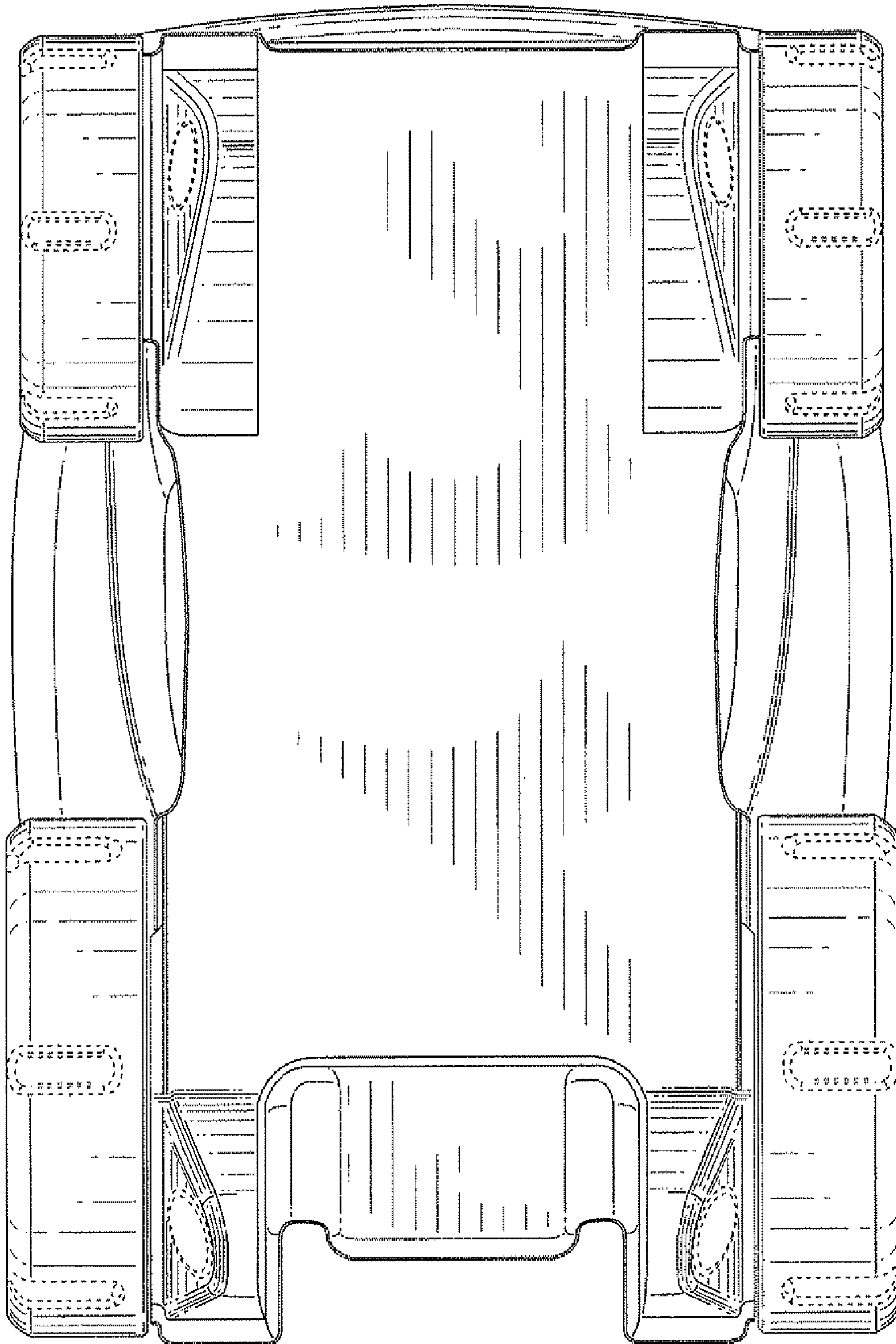

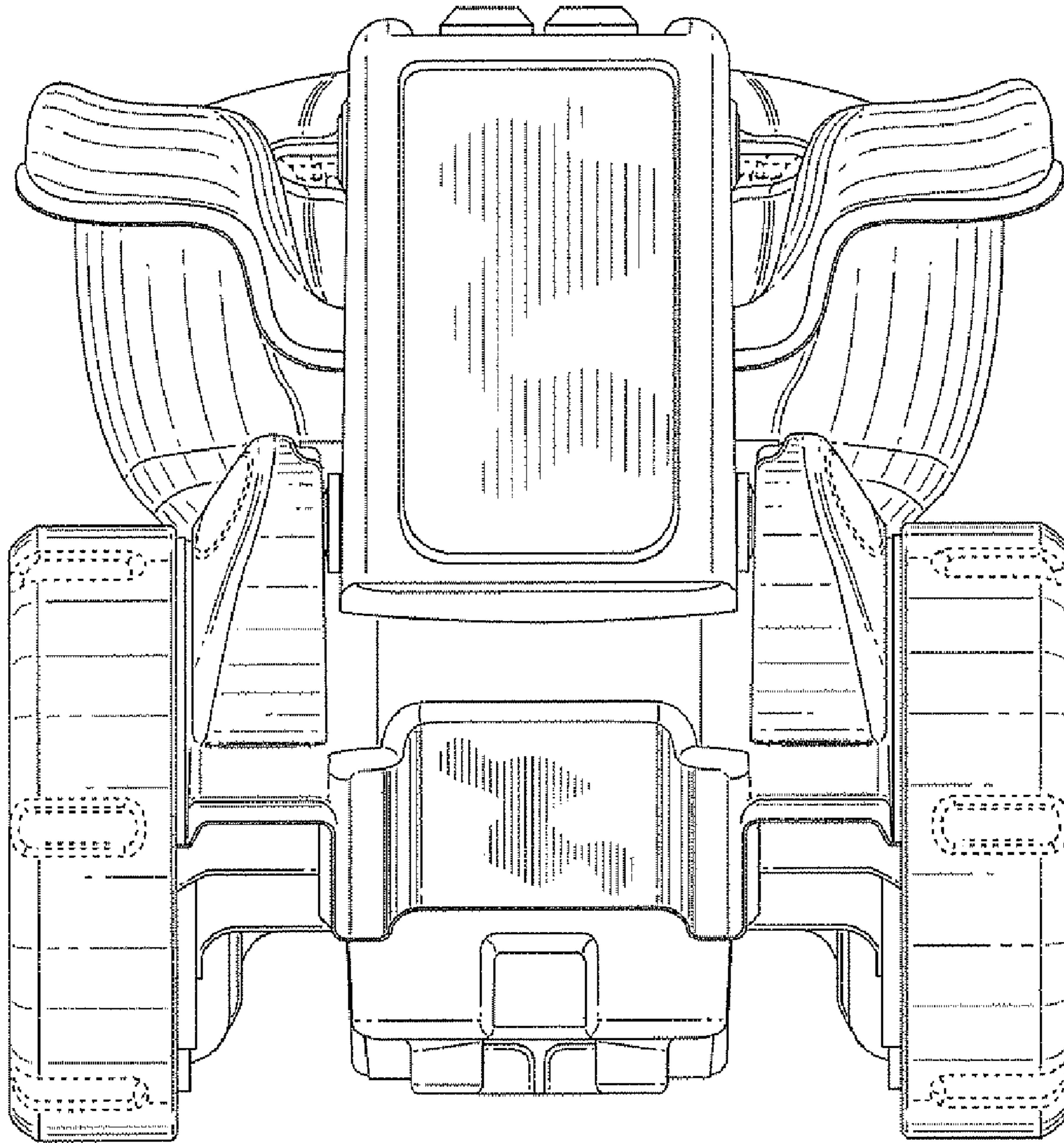

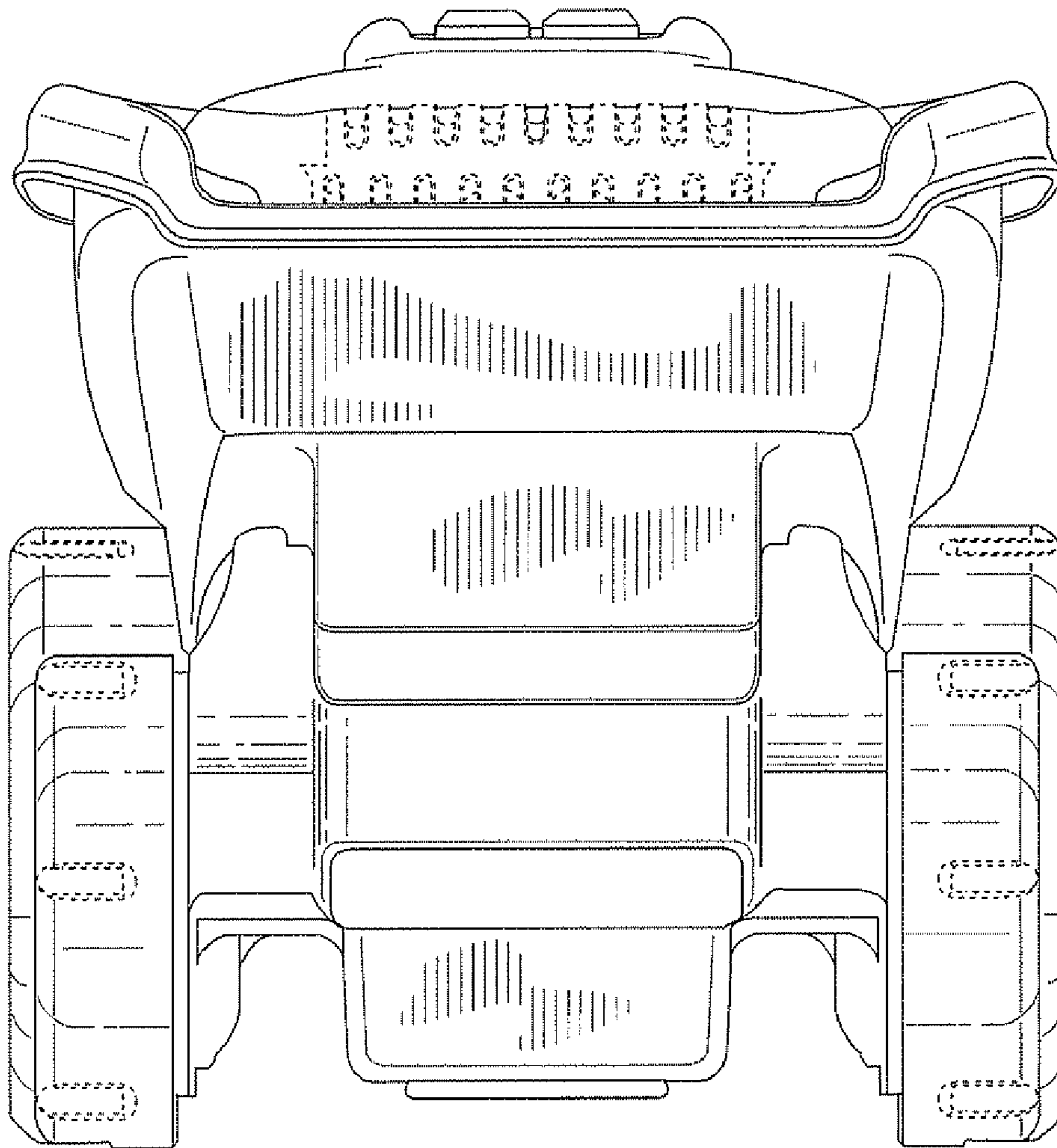

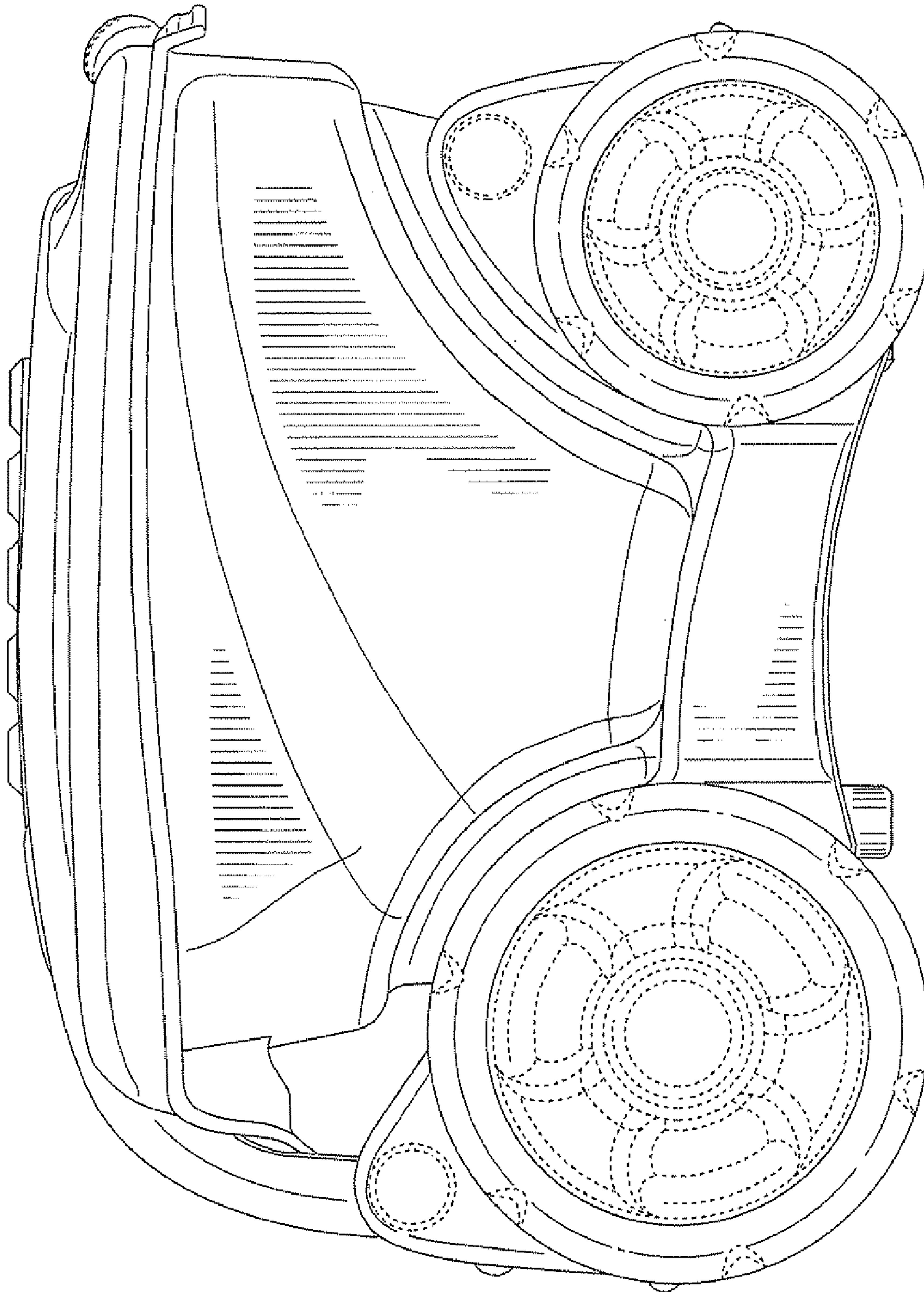
