FIG. 8 is a front/left-side/top perspective view thereof showing the aspect when the present design is connected to a hose of vacuum cleaner.

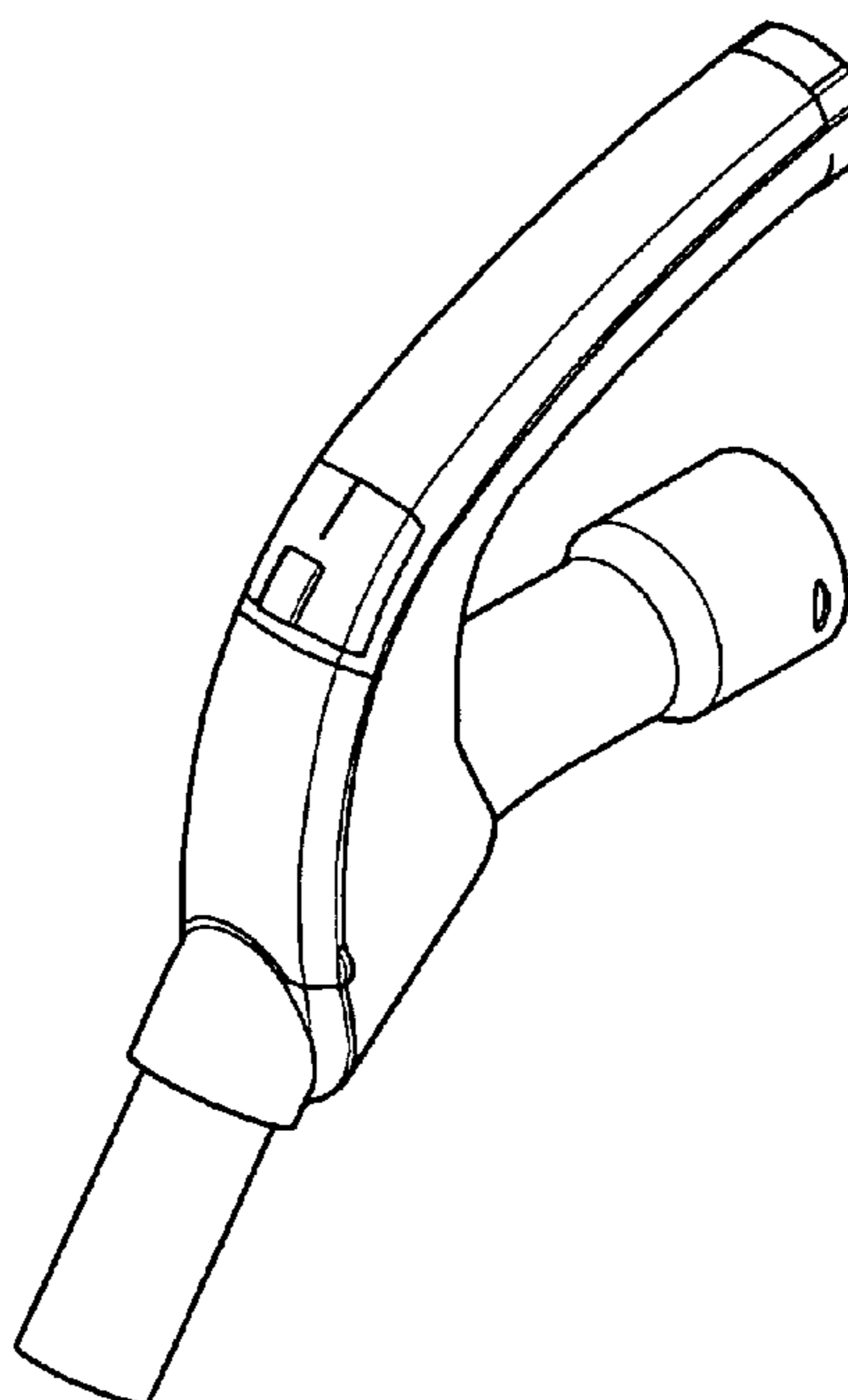

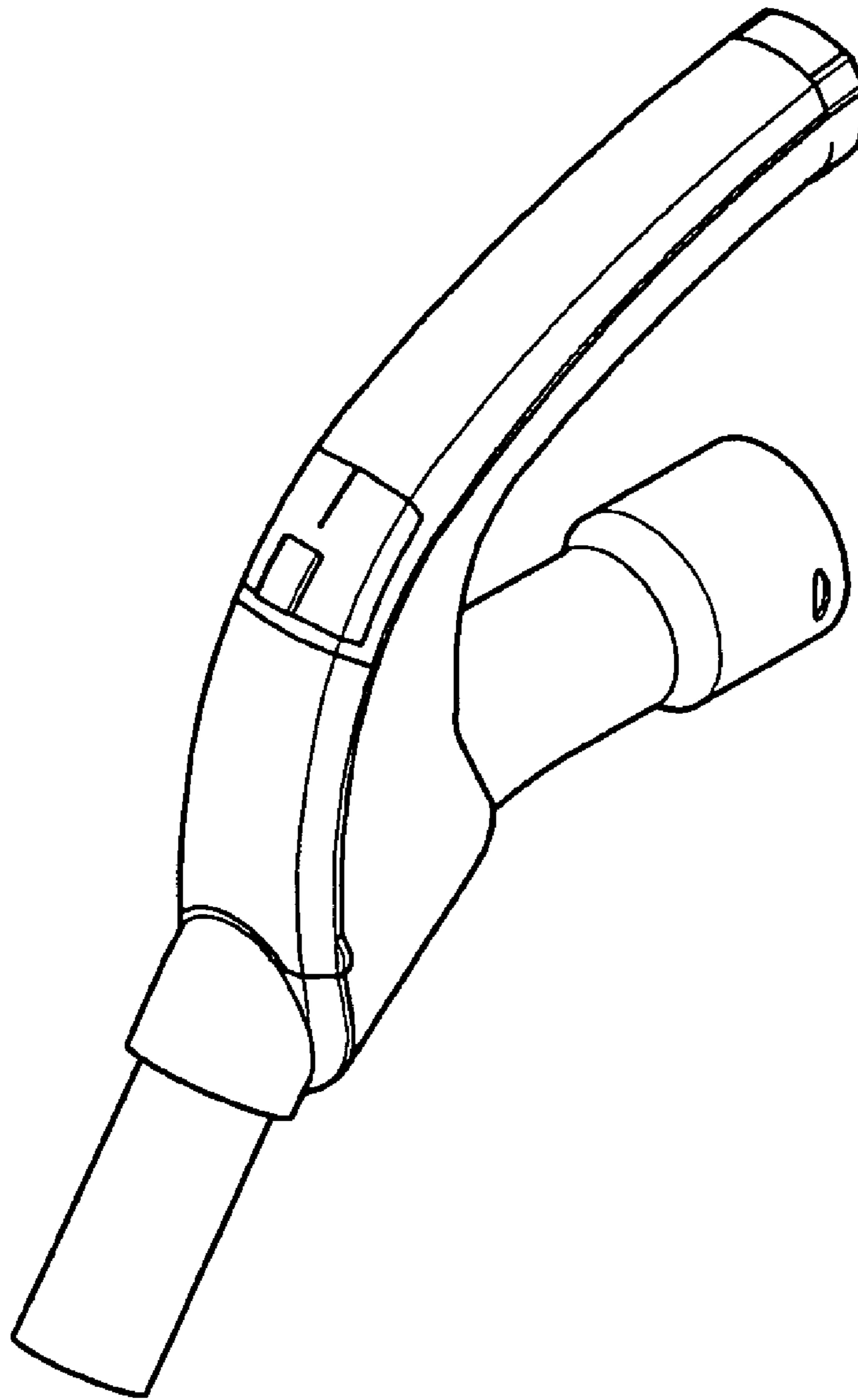

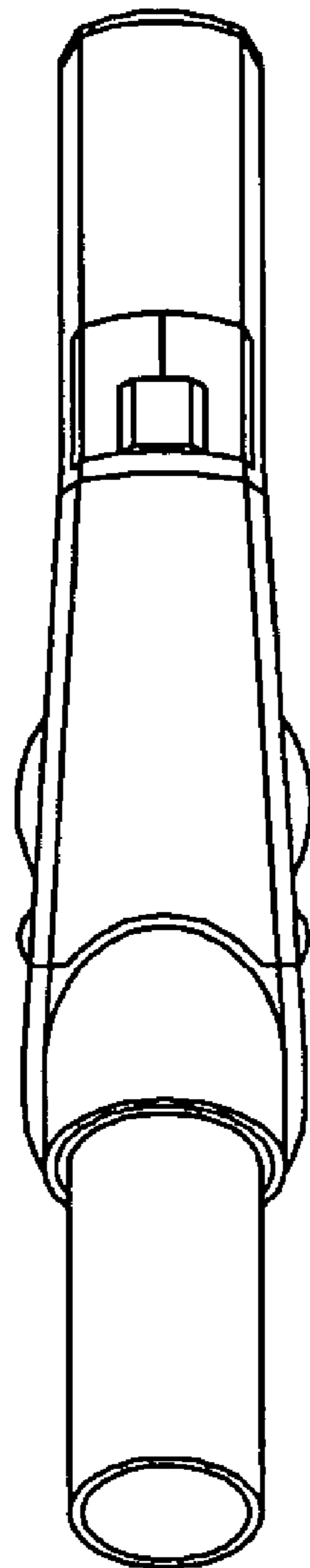

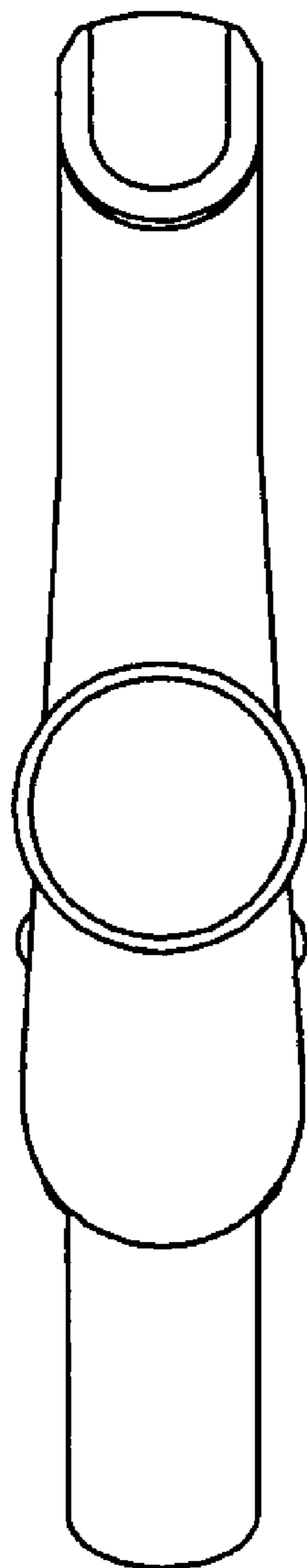

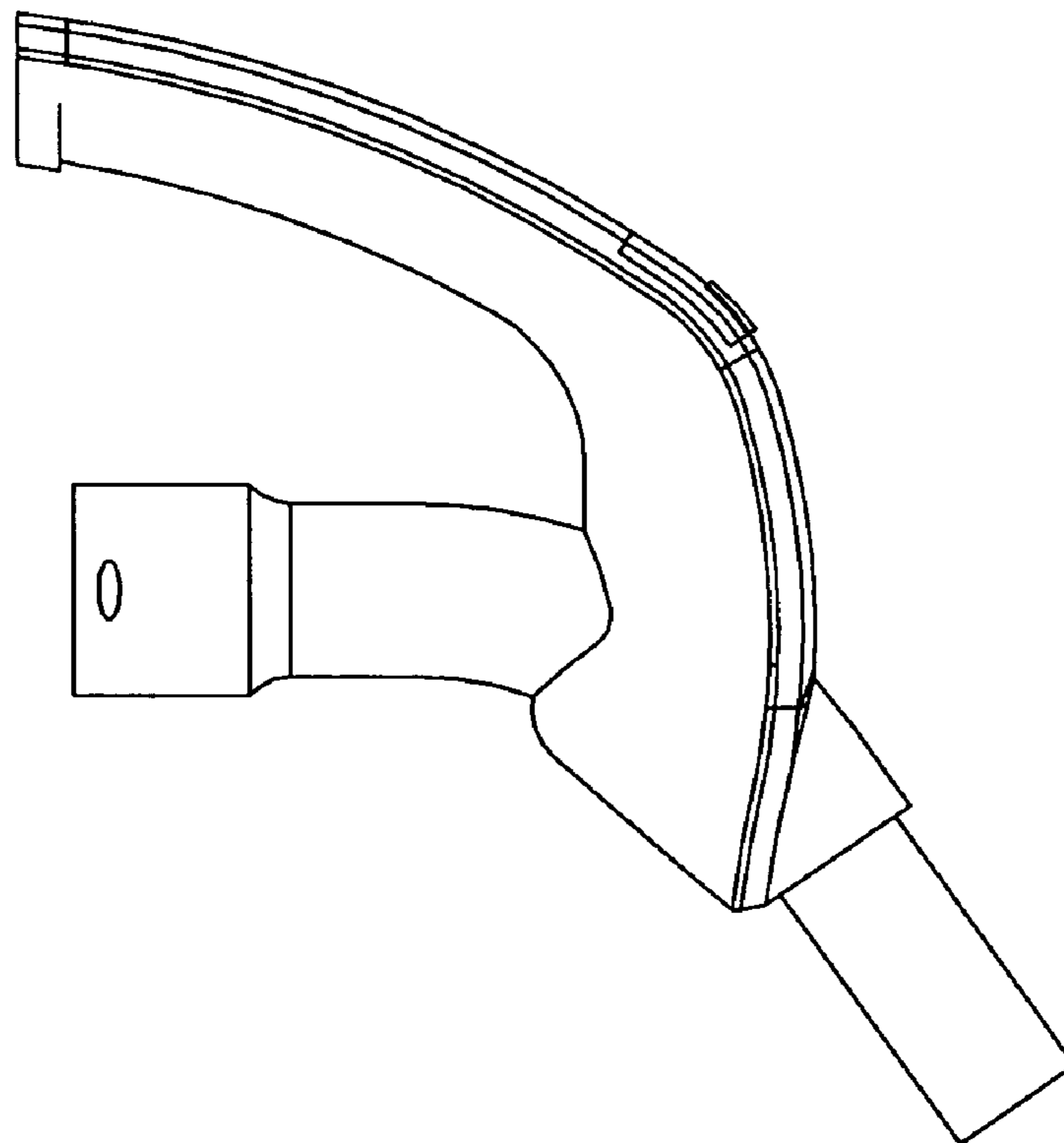

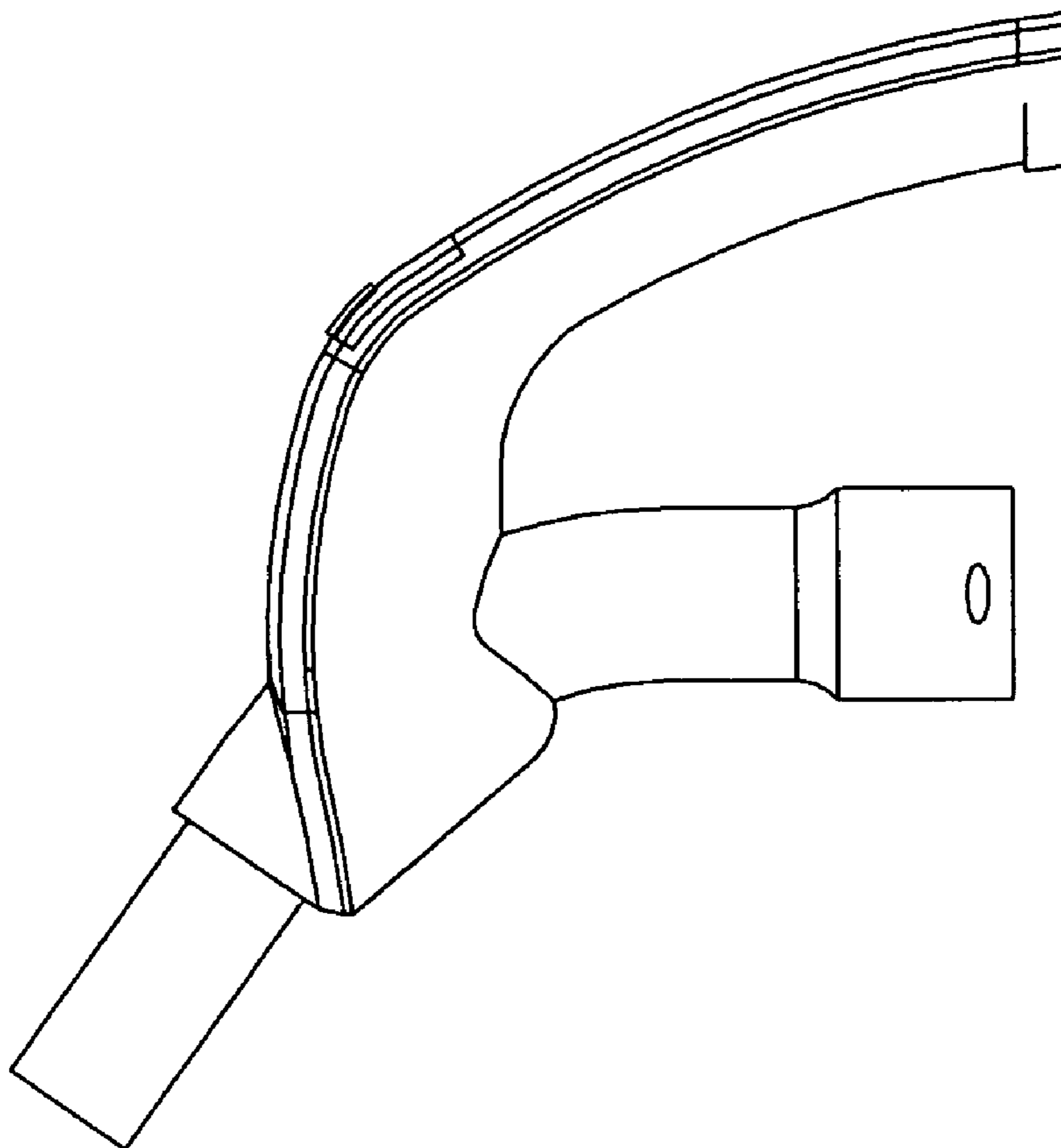

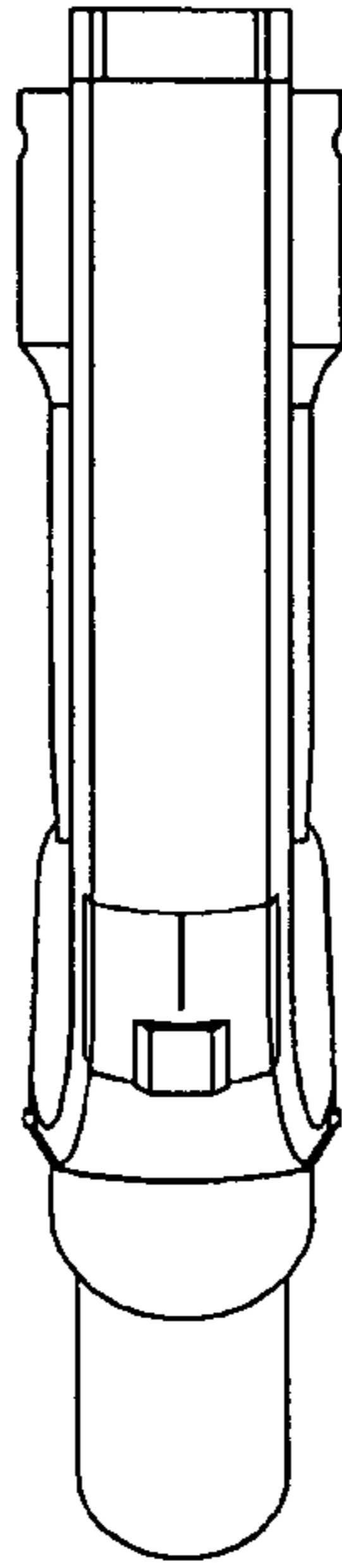

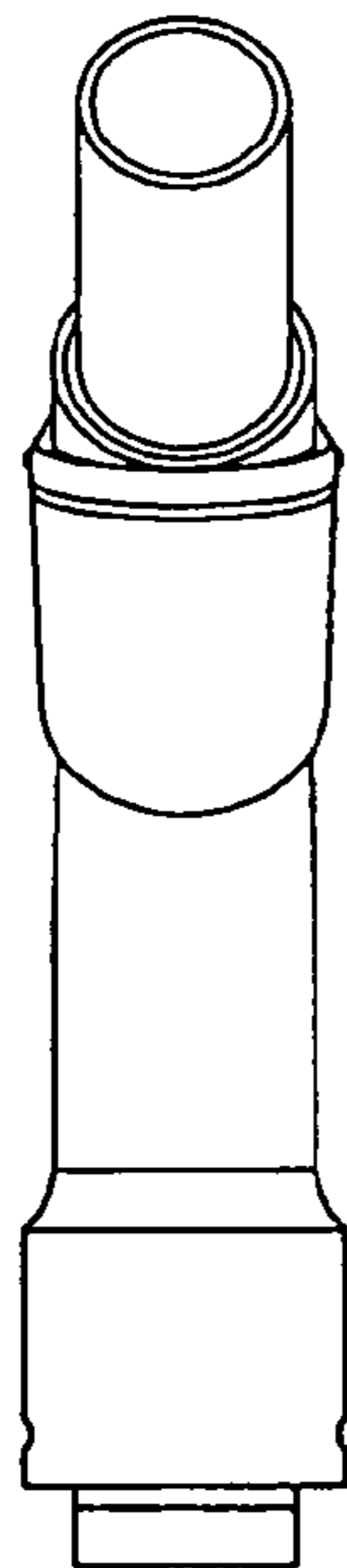
