(57) **CLAIM**

The ornamental design for a grip of a handle for a squeegee or the like, as shown and described.

DESCRIPTION

FIG. 1 is an upper front left perspective view of a grip of a handle for a squeegee or the like showing our new design;

FIG. 2 is an upper front left perspective view of the design of FIG. 1;

FIG. 3 is a top plan view of the design of FIG. 1;

FIG. 4 is a right side elevational view of the design of FIG. 1, the left side being a mirror image;

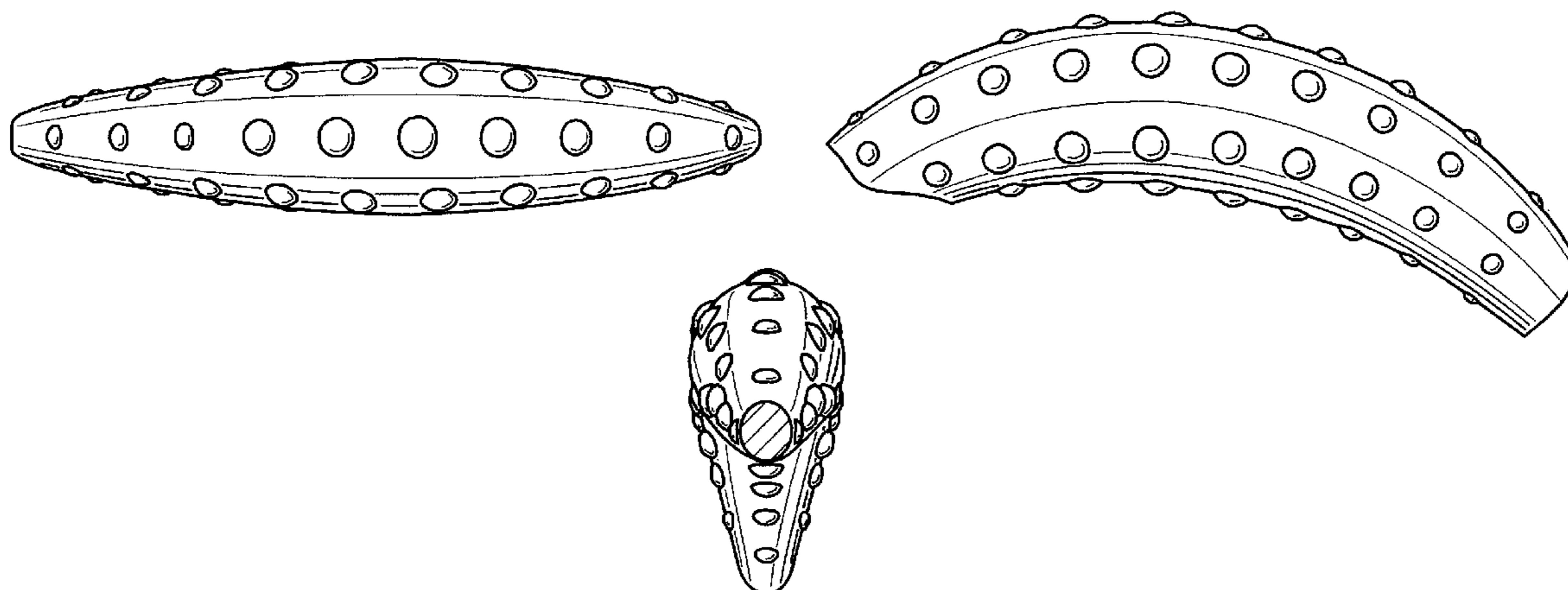
FIG. 5 is a bottom plan view of the design of FIG. 1;

FIG. 6 is a front elevational view of the design of FIG. 1; and,

FIG. 7 is a rear elevational view of the design of FIG. 1.

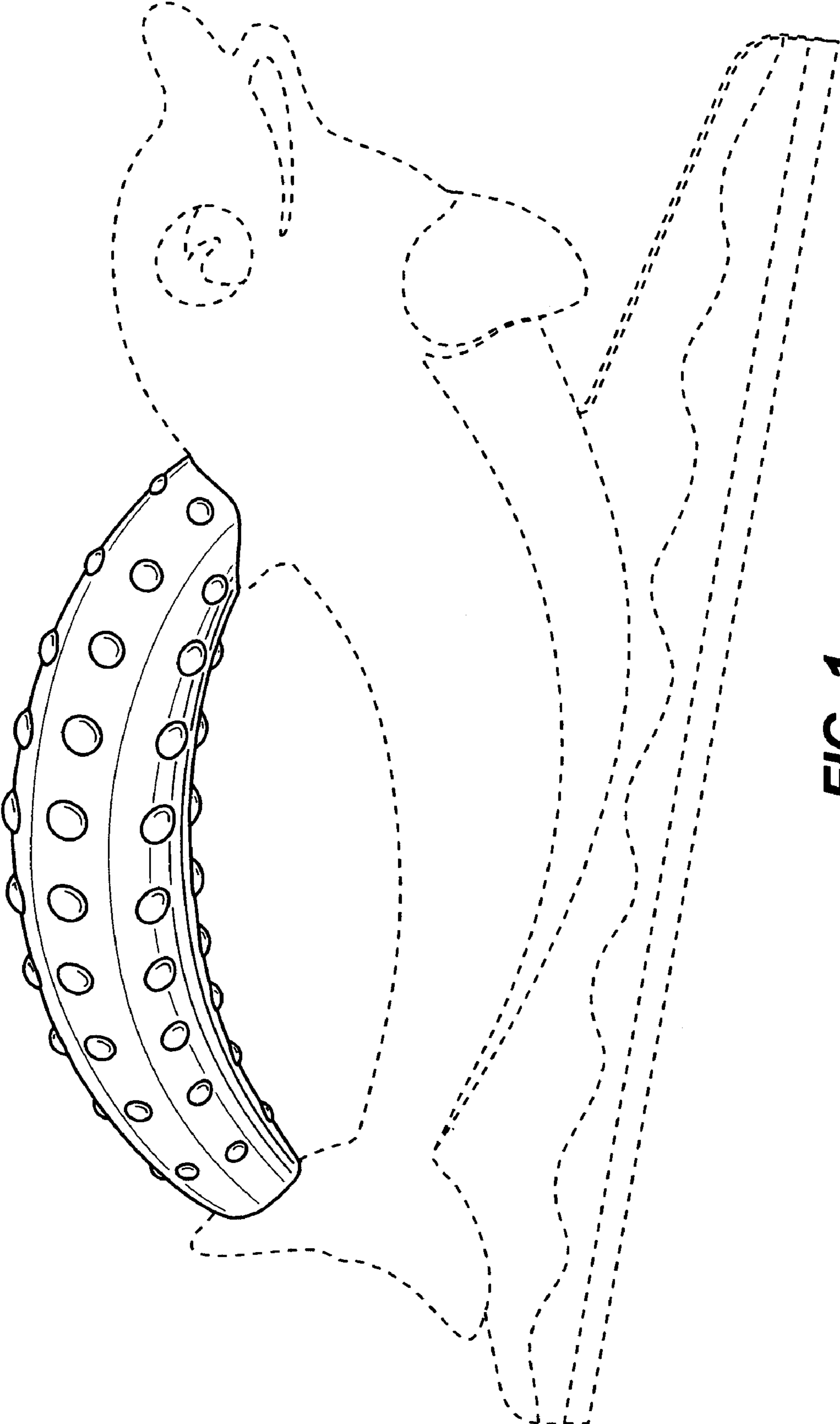

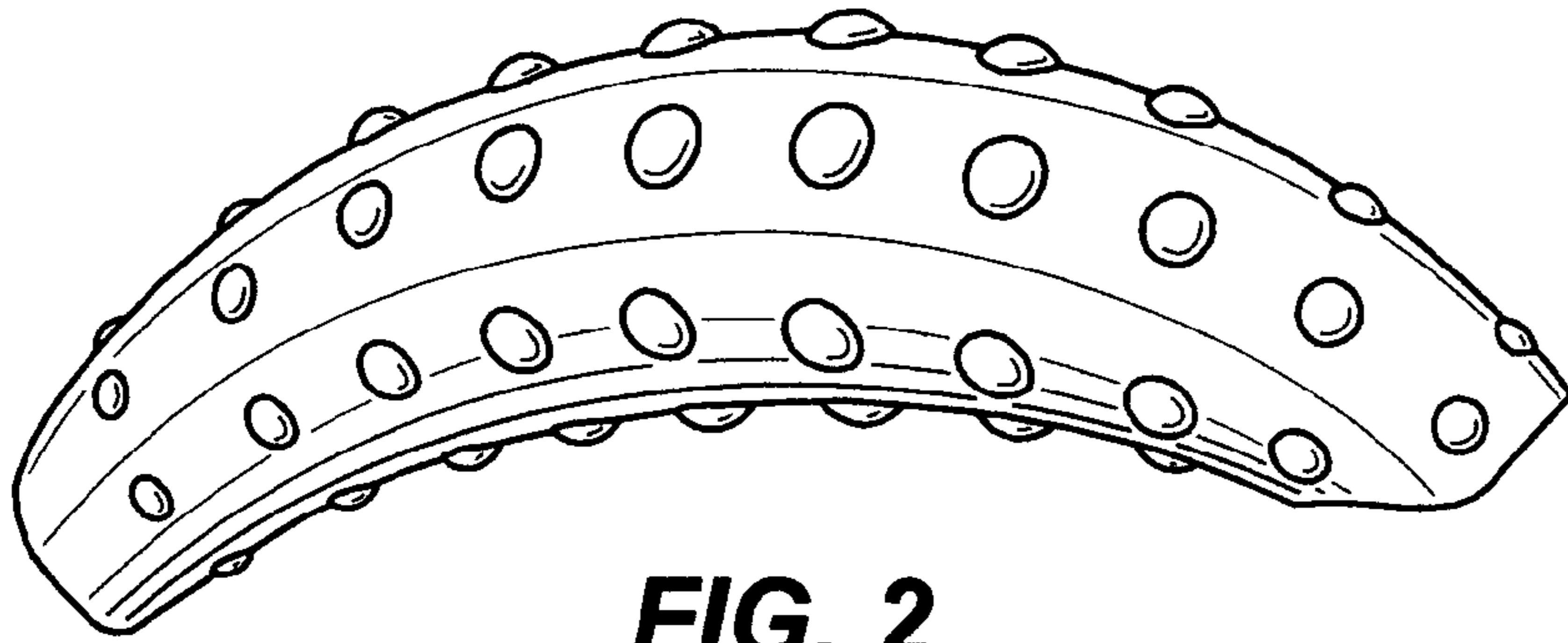

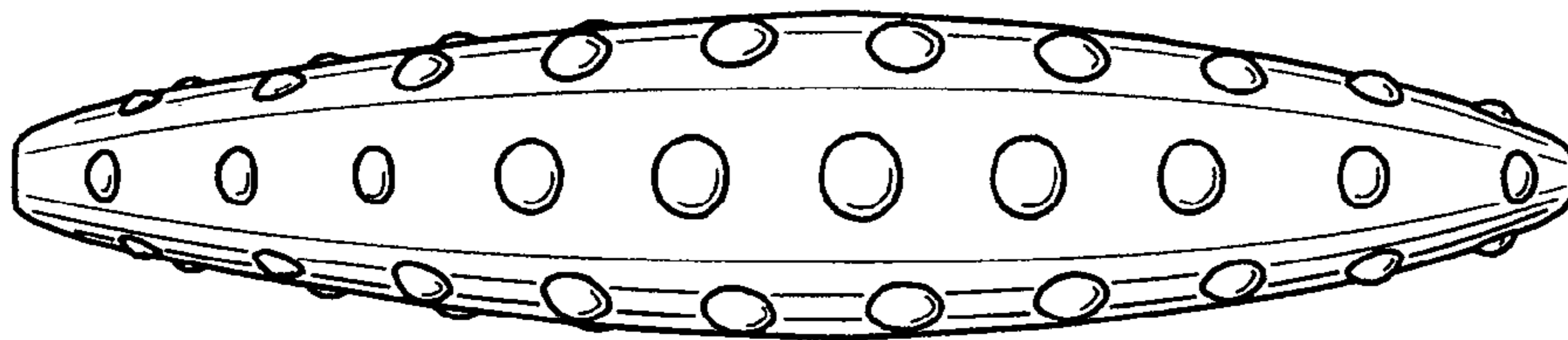

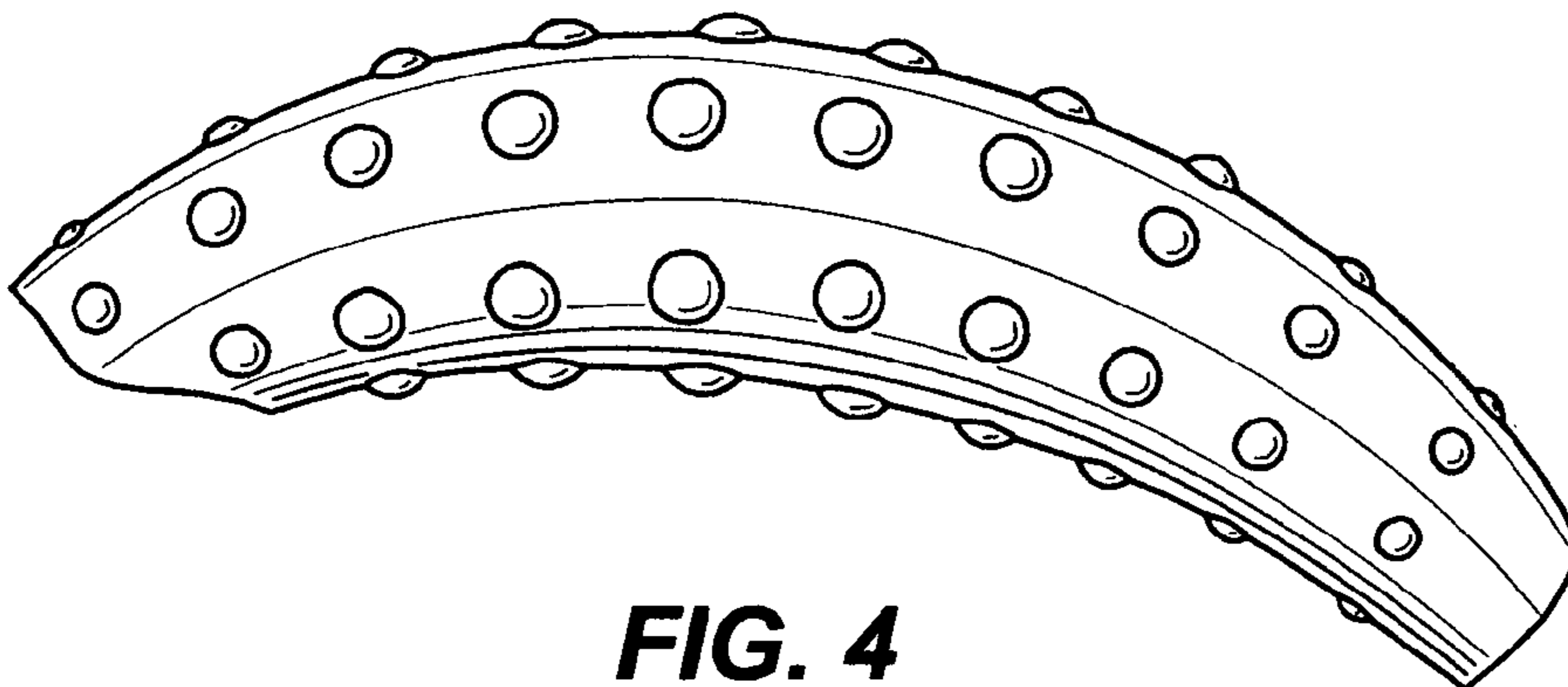

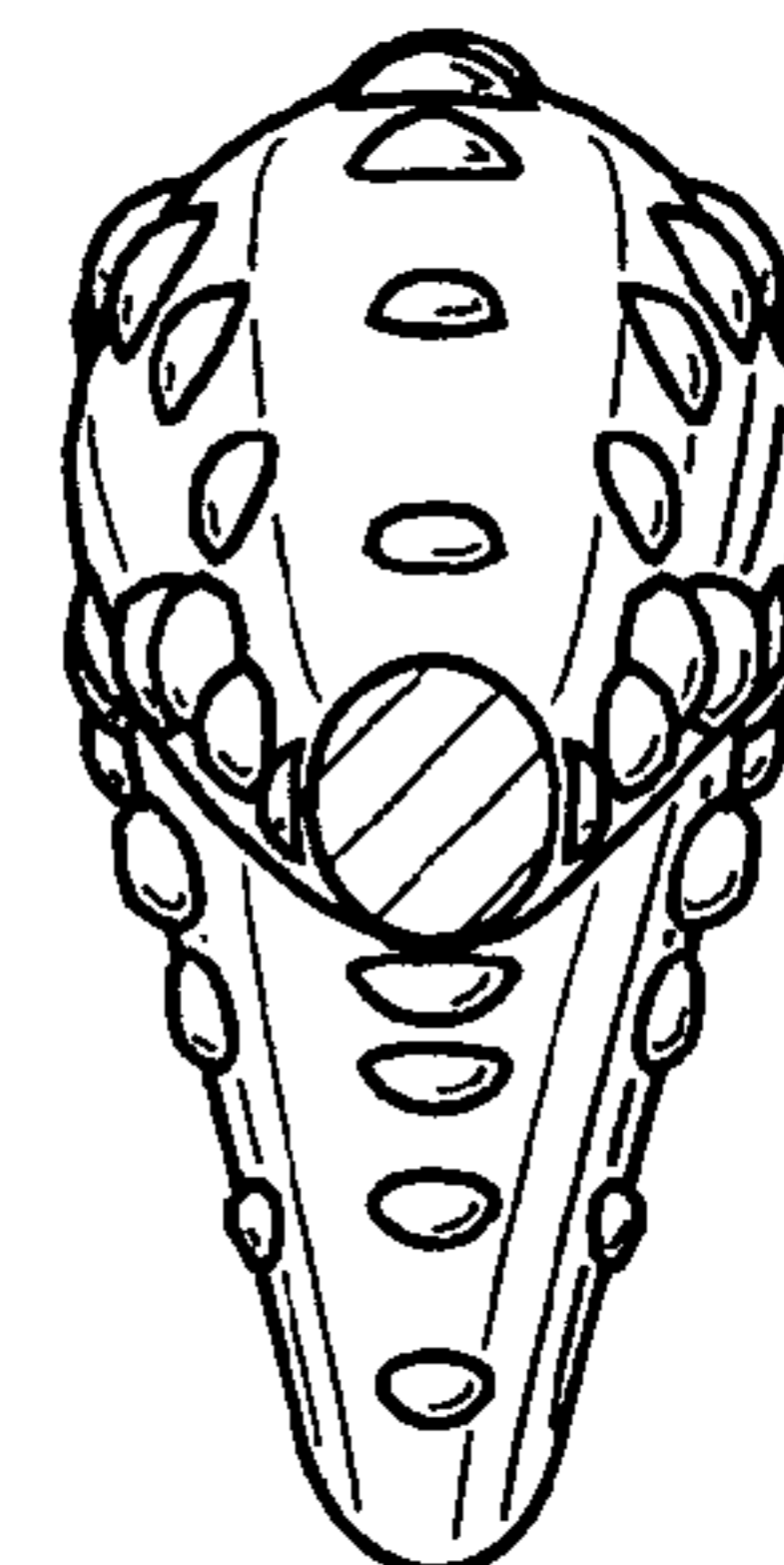

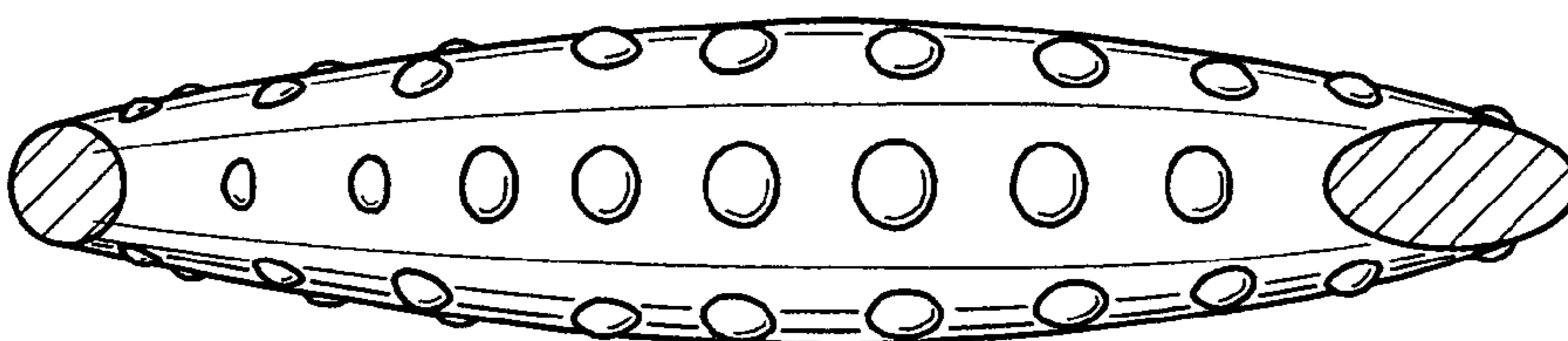

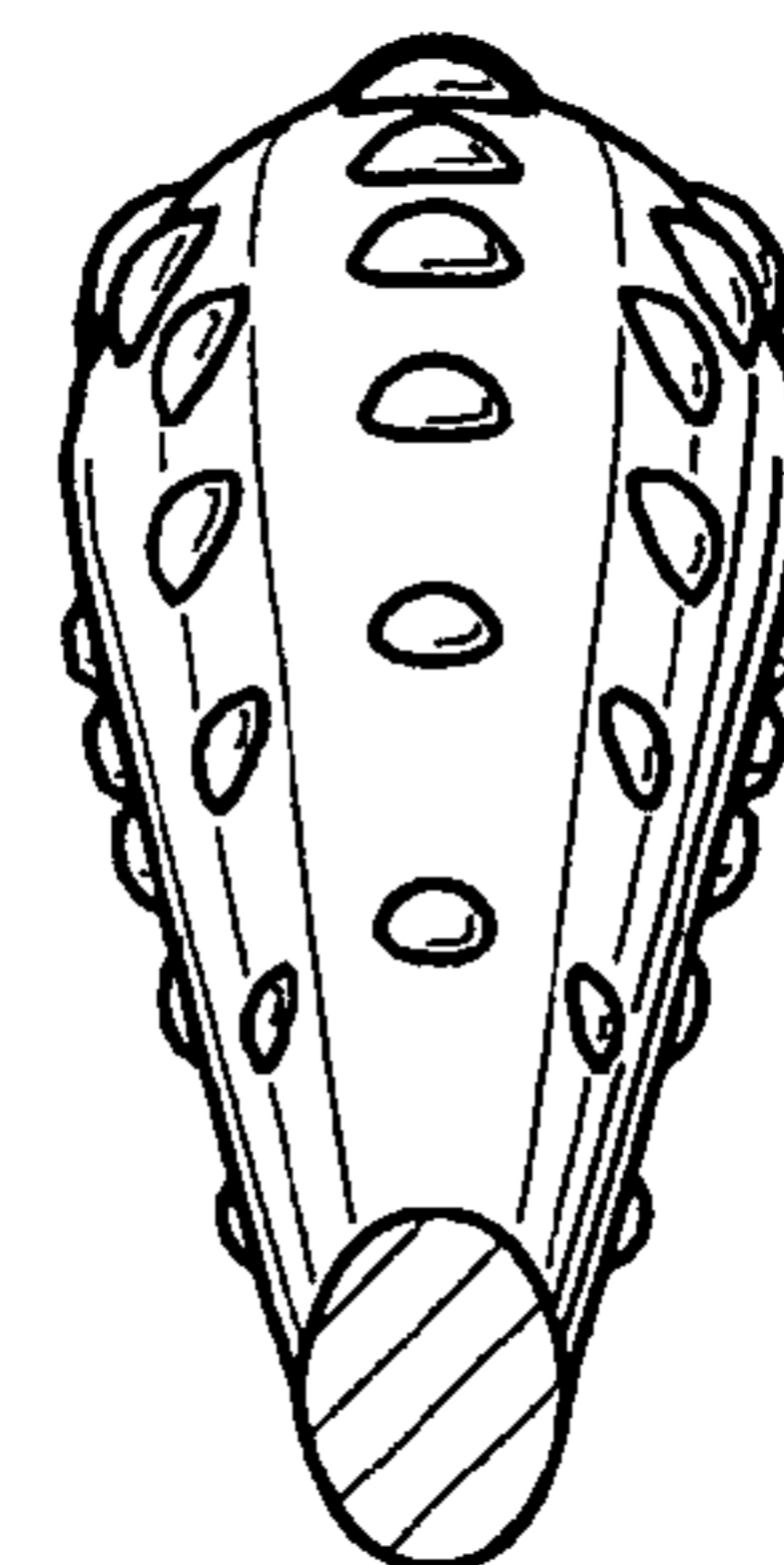
