The ornamental design for a fireman boot stocking, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fireman boot stocking, showing my new design;

FIG. 2 is a front elevational view of the invention;

FIG. 3 is a rear elevational view of the invention;

FIG. 4 is a left-side elevational view of the invention;

FIG. 6 is a right-side elevational view of the invention;

FIG. 6 is a top plan view of the invention; and,

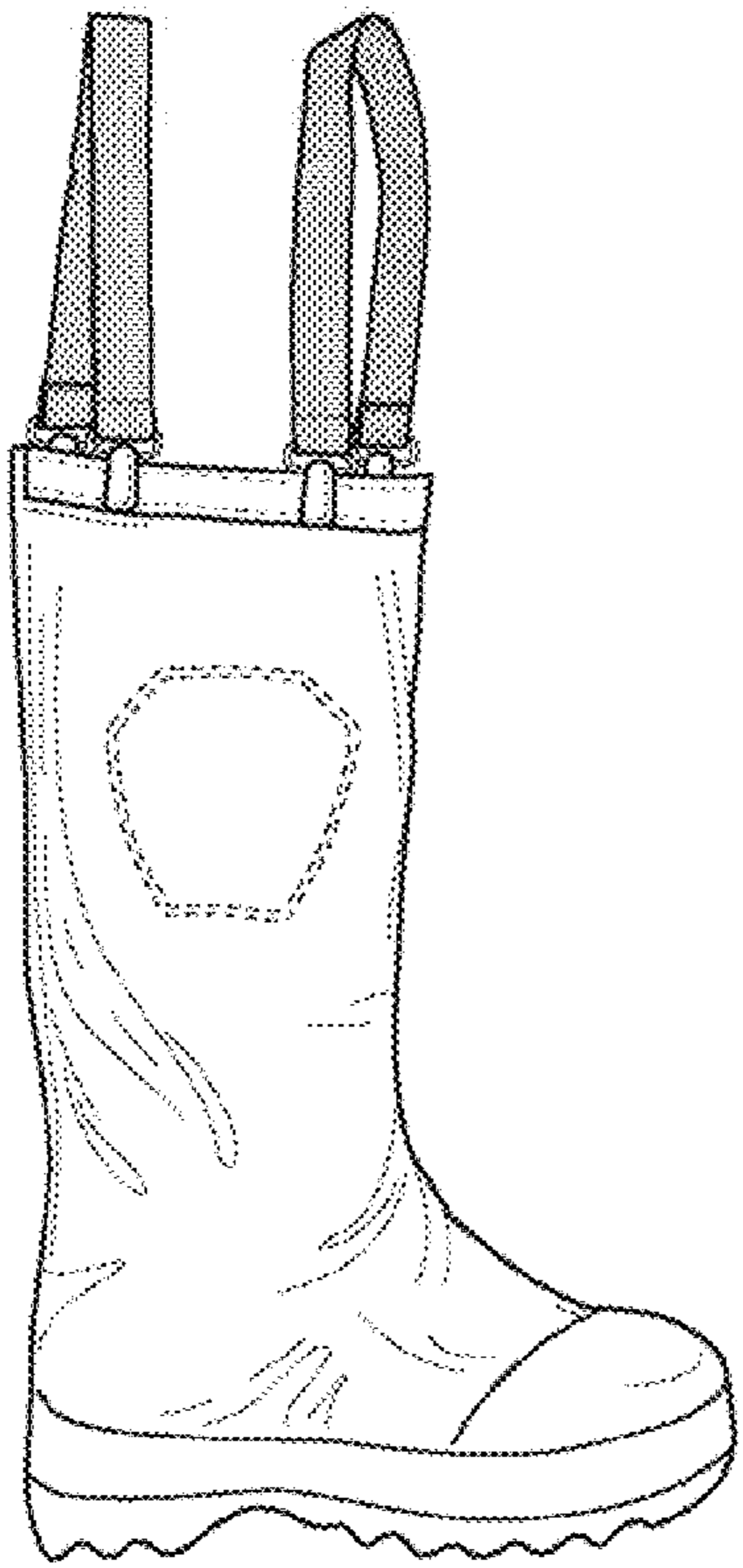

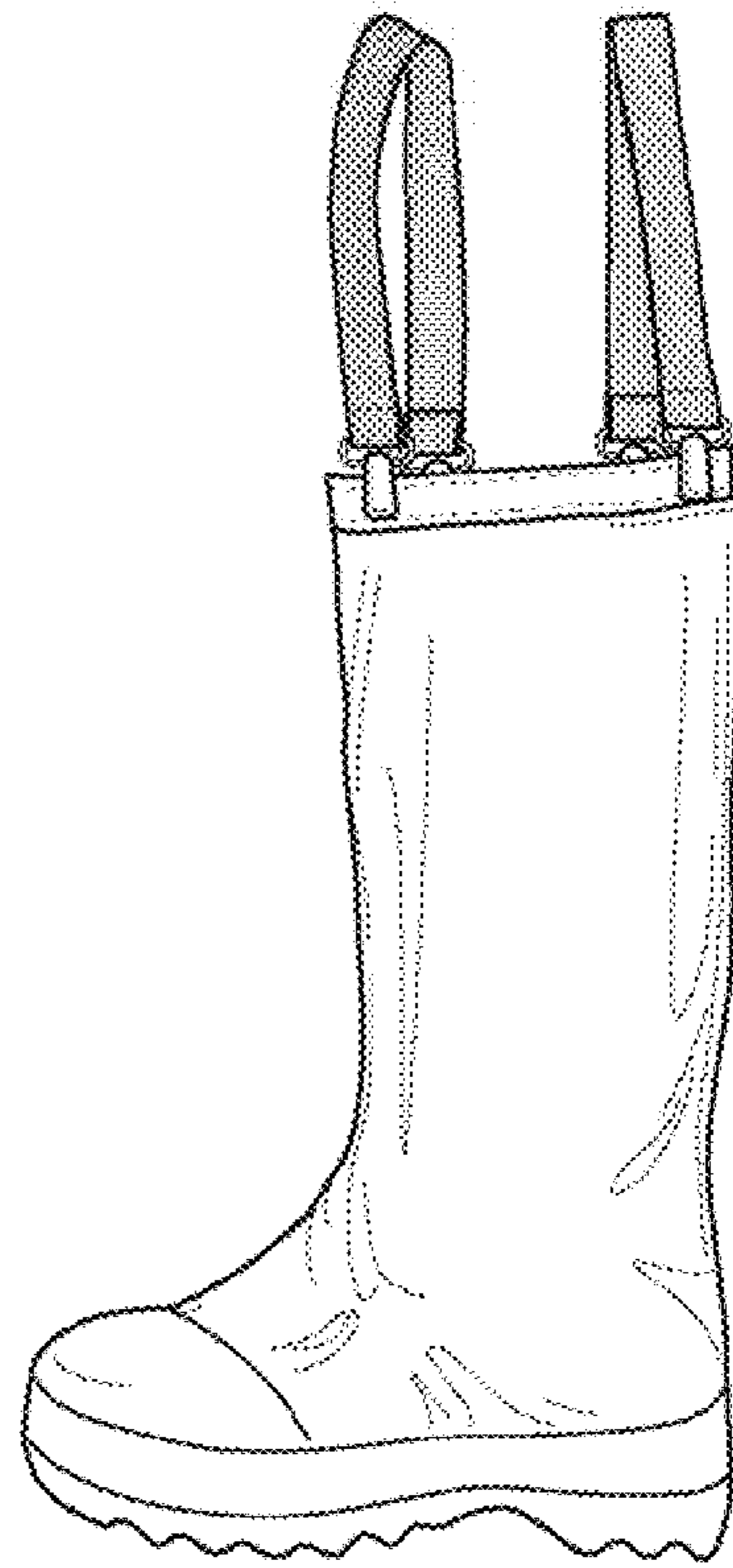

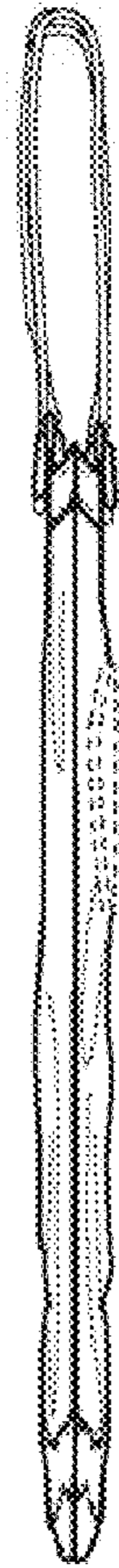
