FIG. 3. is a rear view thereof;

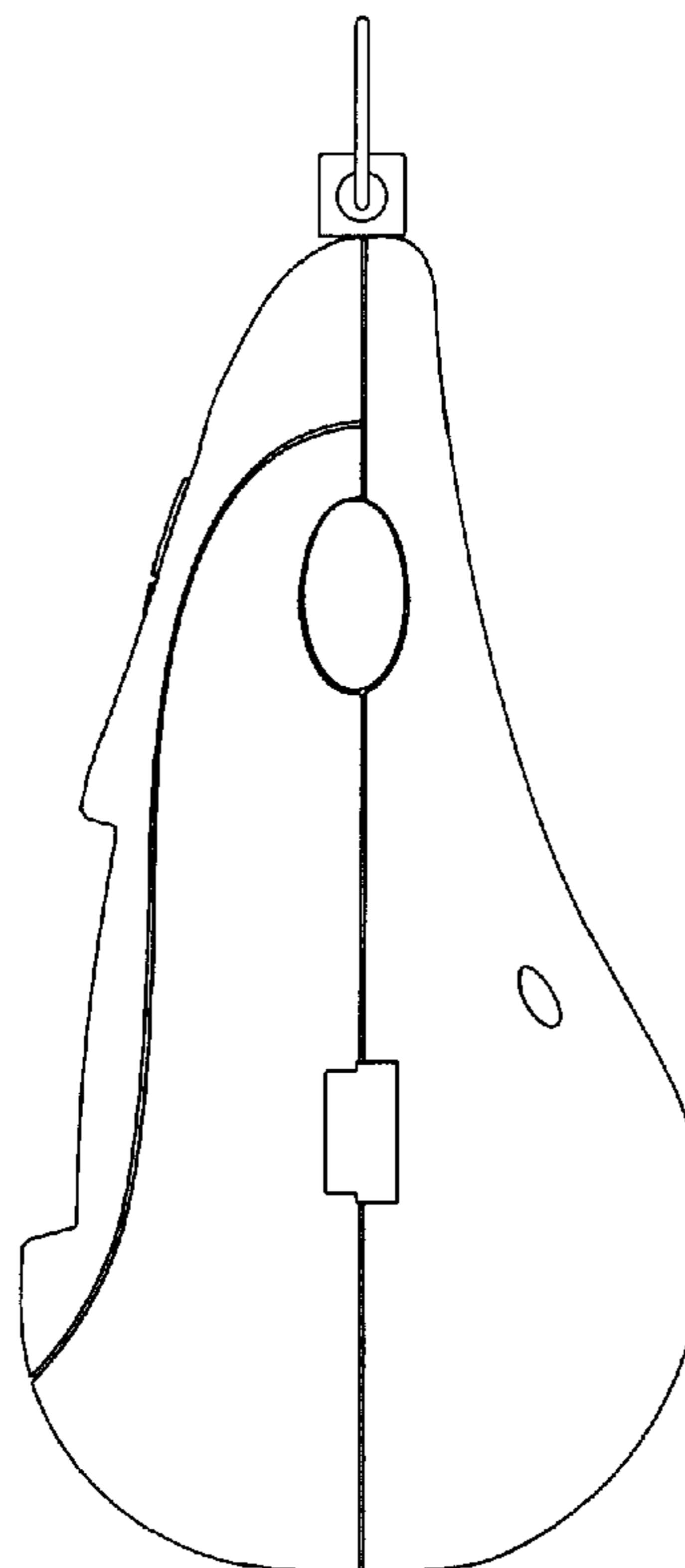
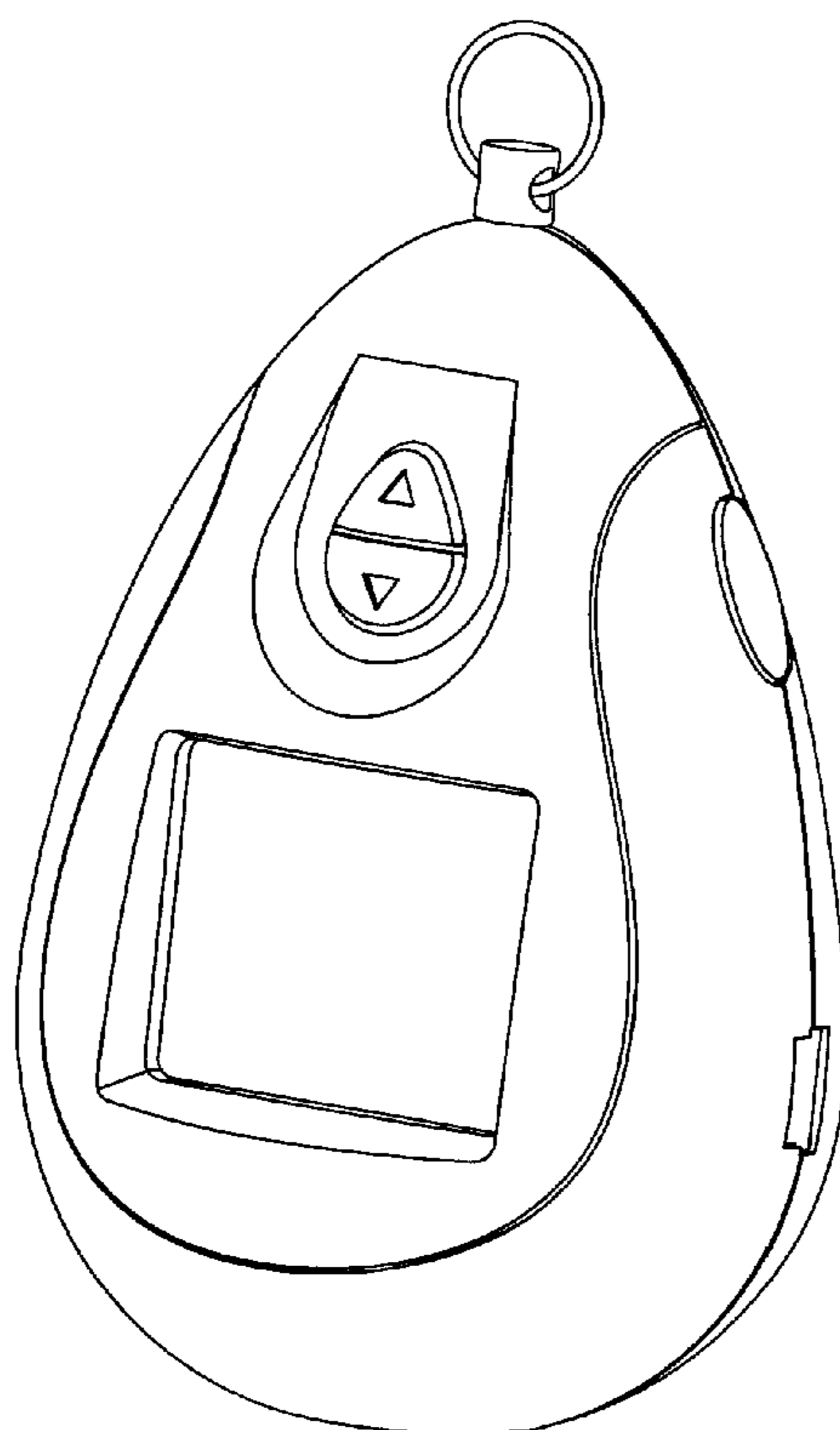
FIG. 4. is a left side view thereof;

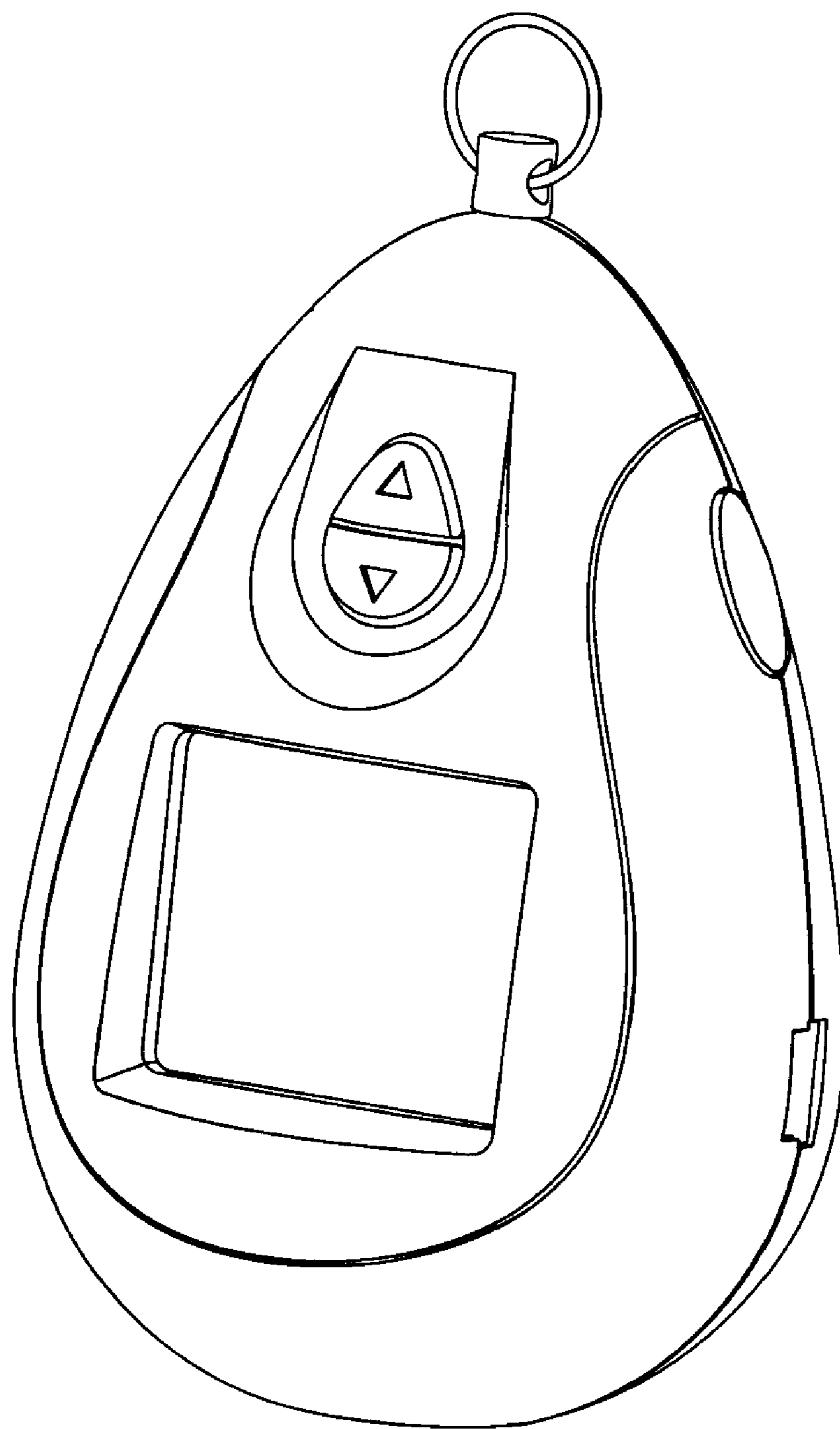

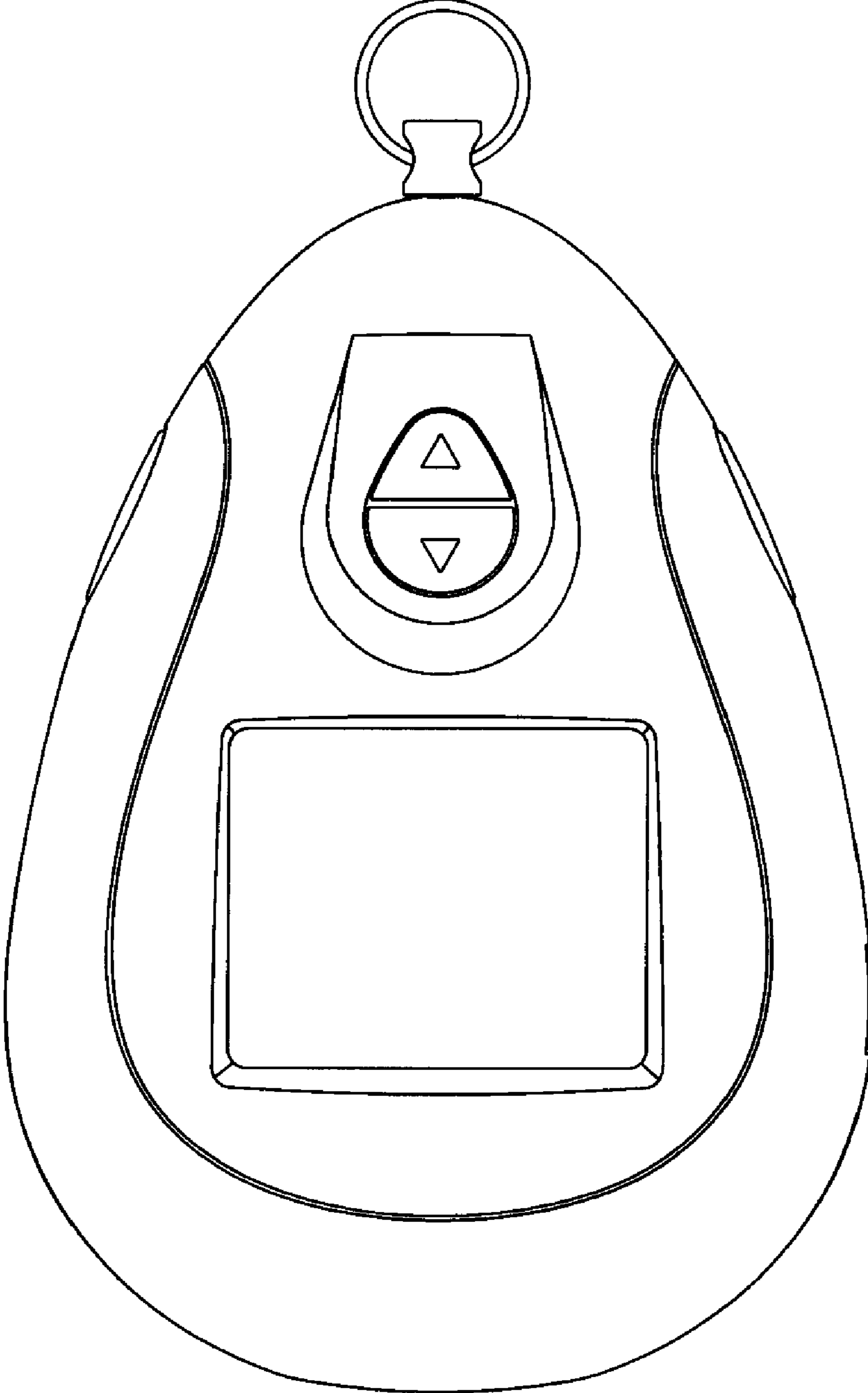

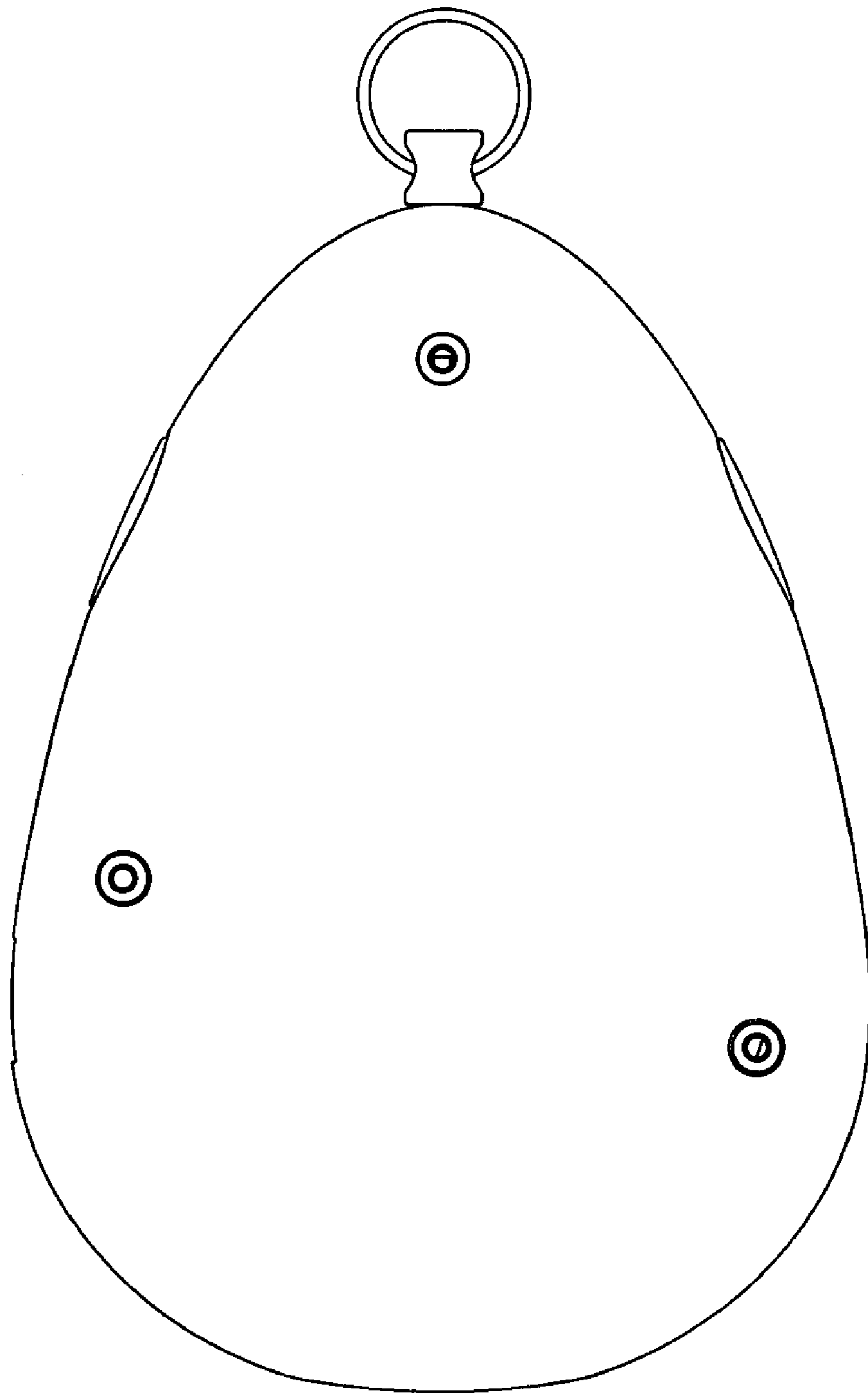

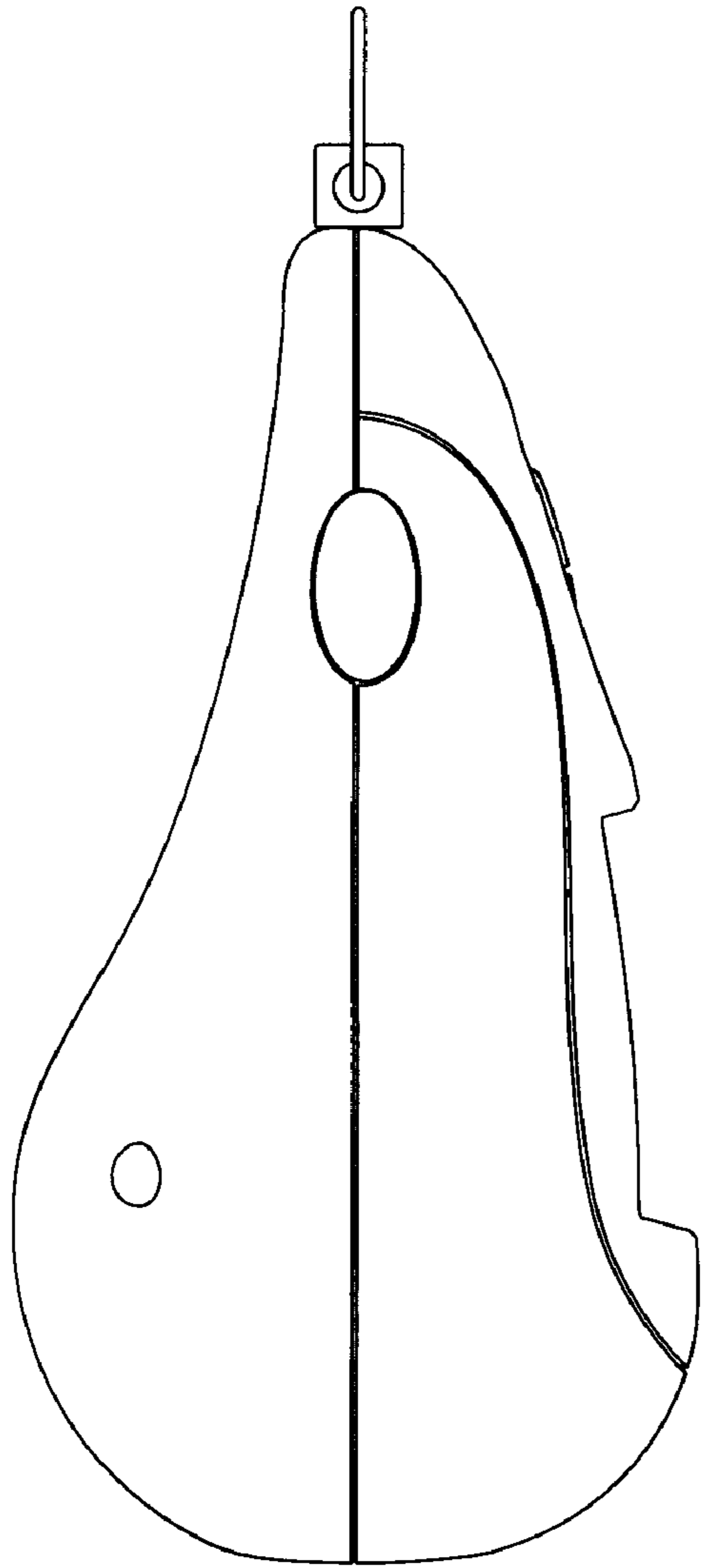

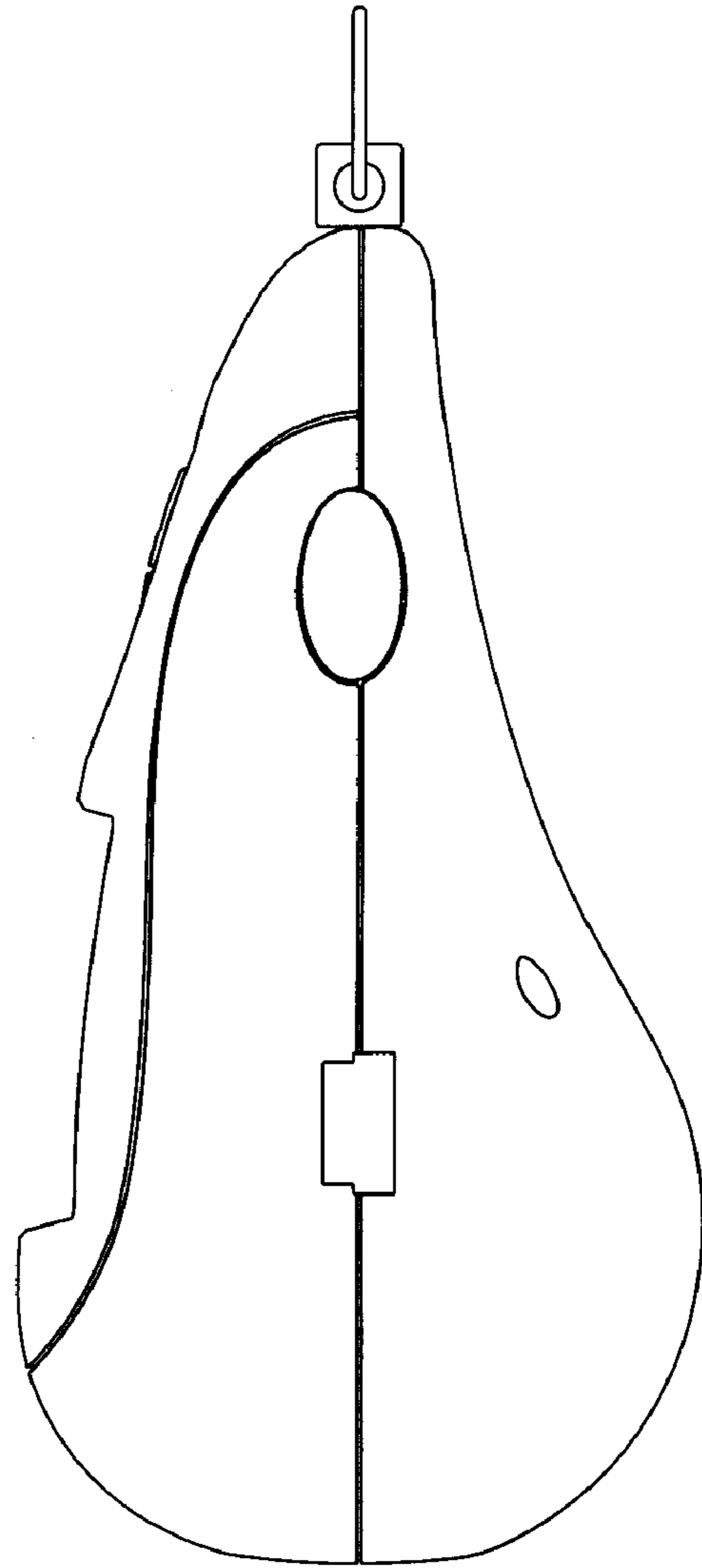

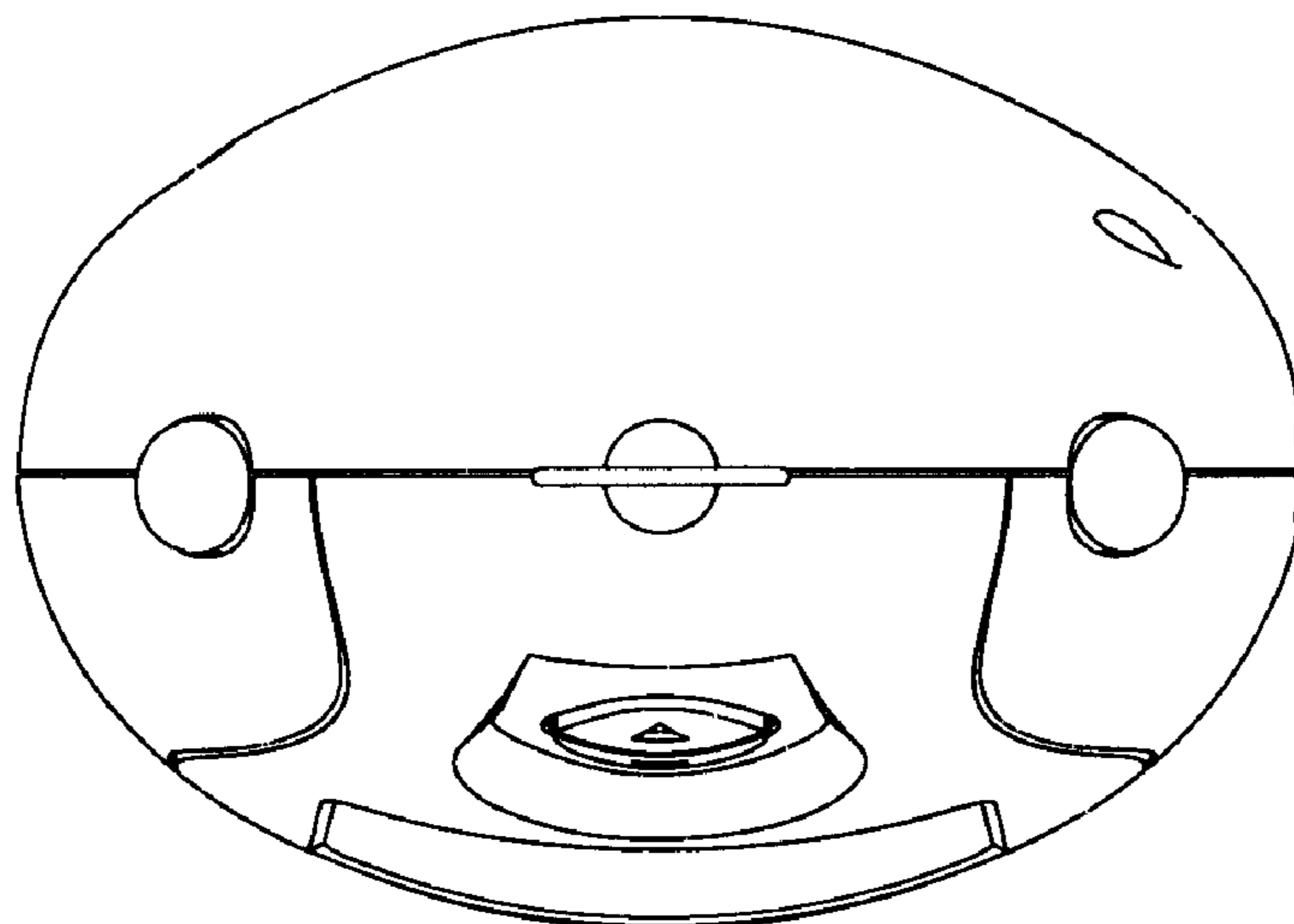

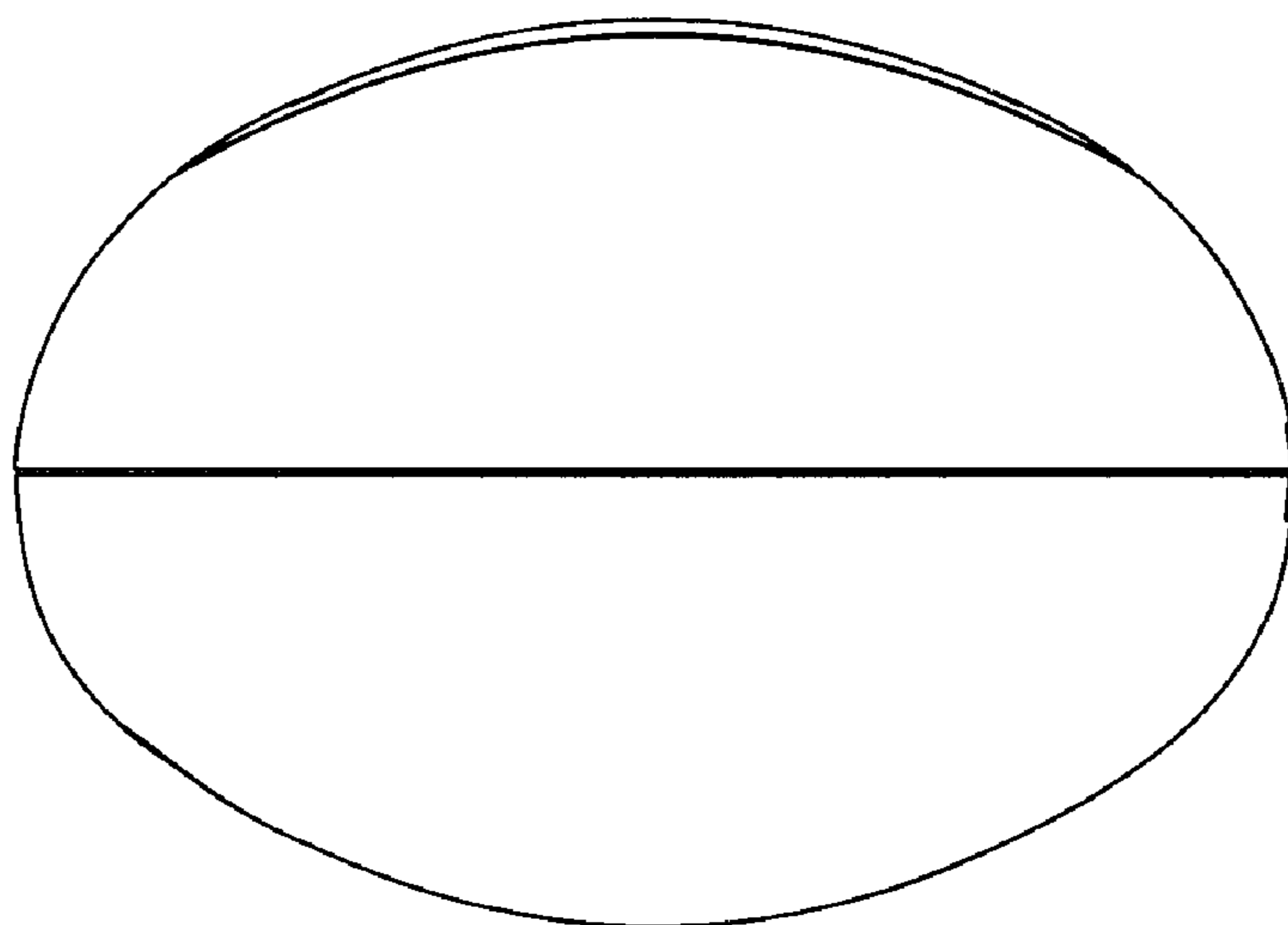
