FIG. 10 is a perspective view of an alternative arrangement of the ornamental design of FIG. 1;

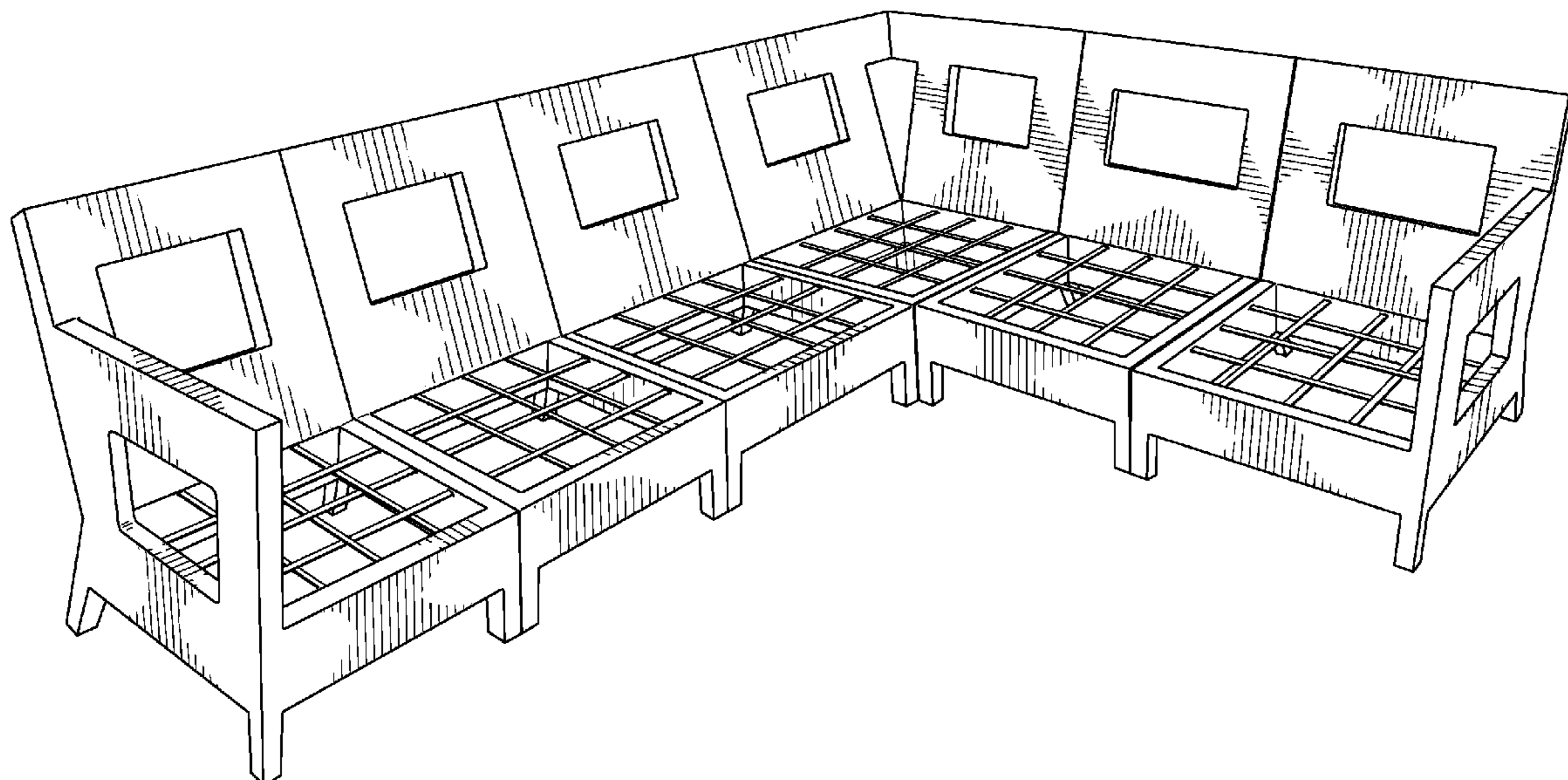
FIG. 11 is a perspective view of an alternative arrangement of the ornamental design of FIG. 1;

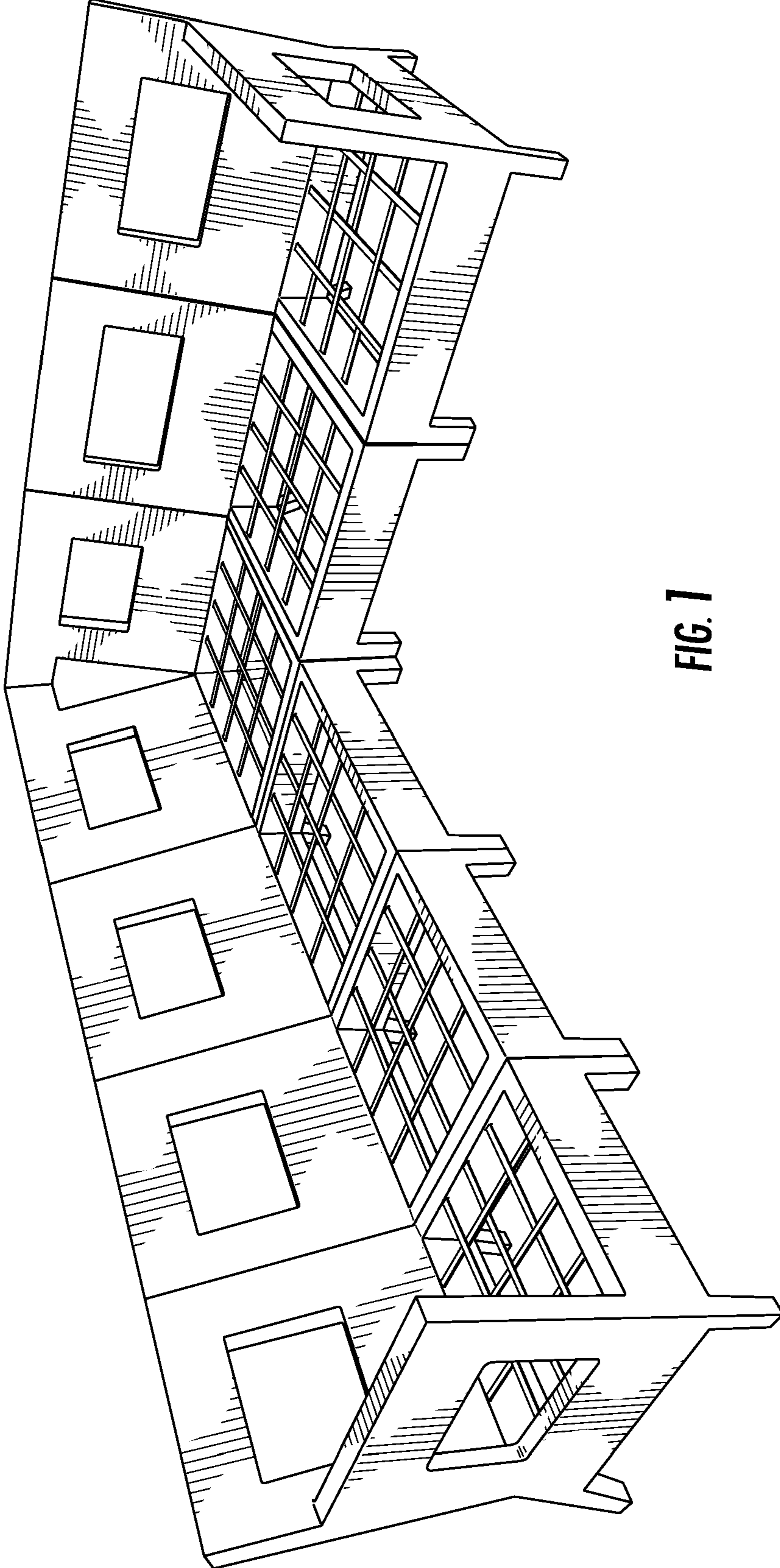

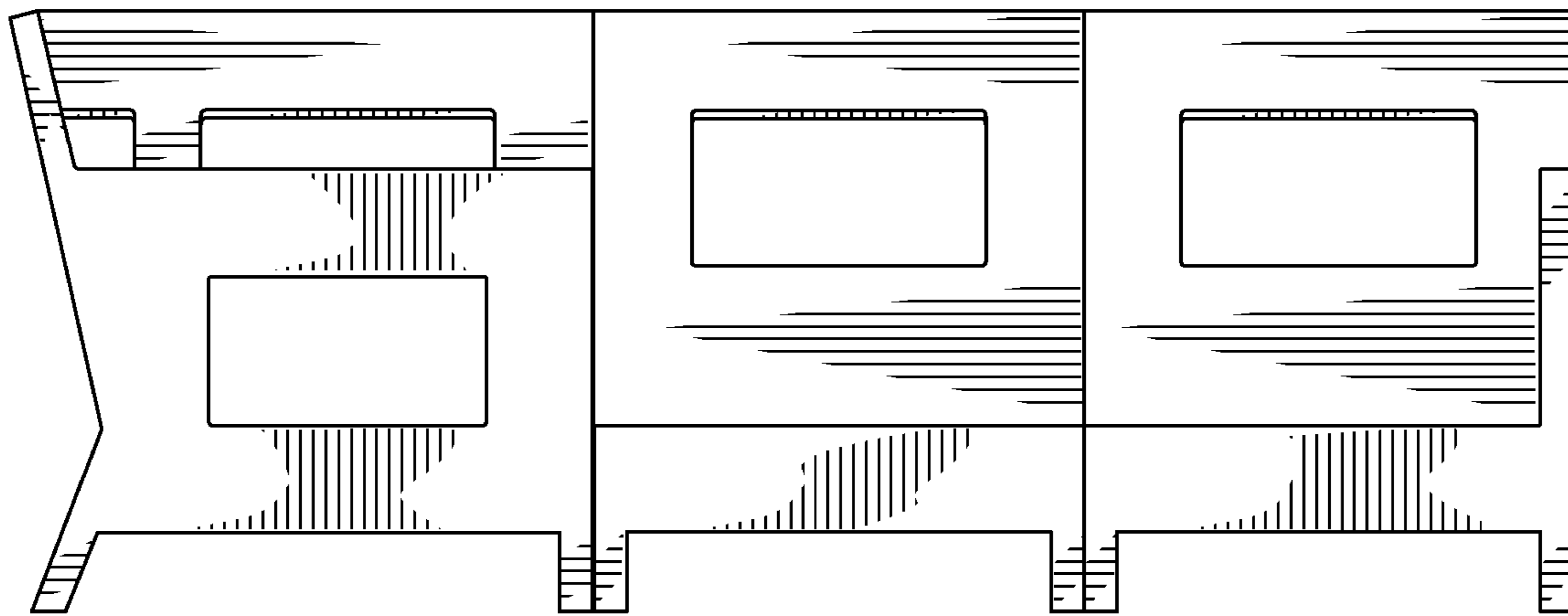

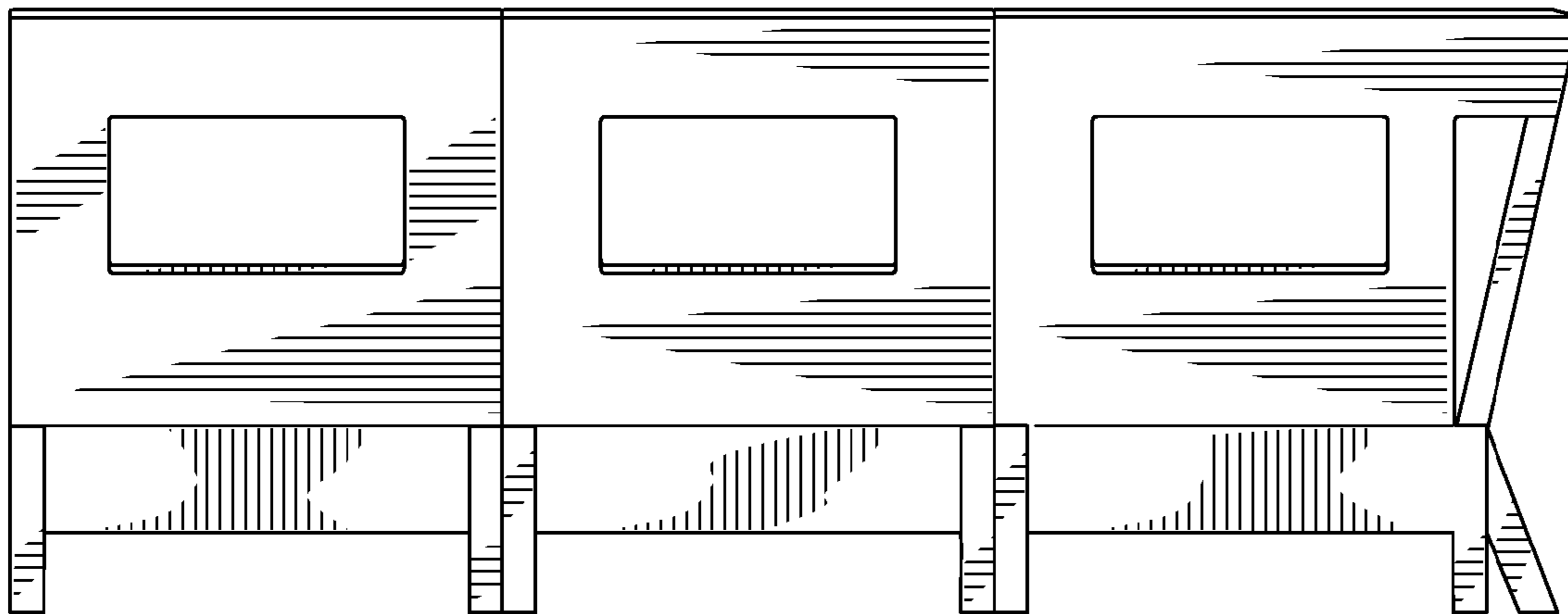

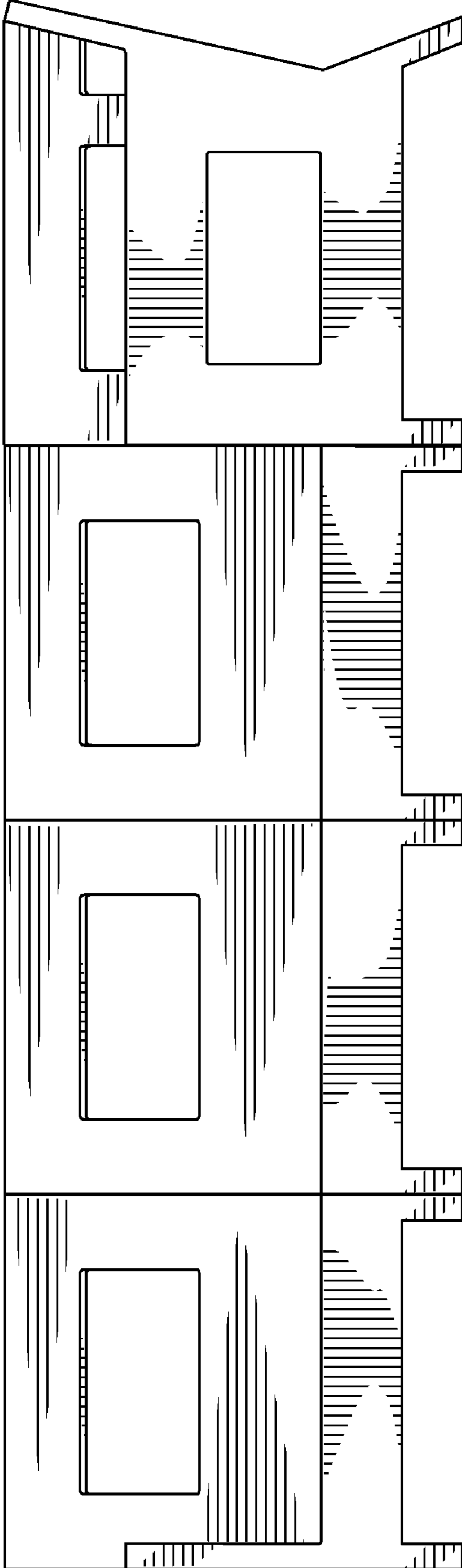

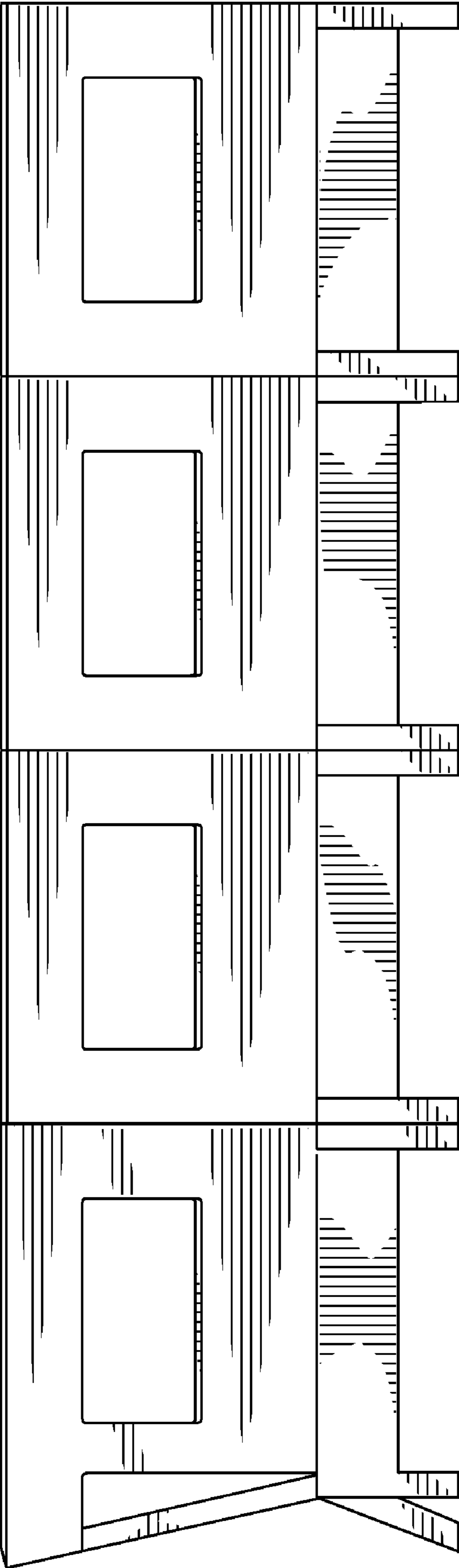

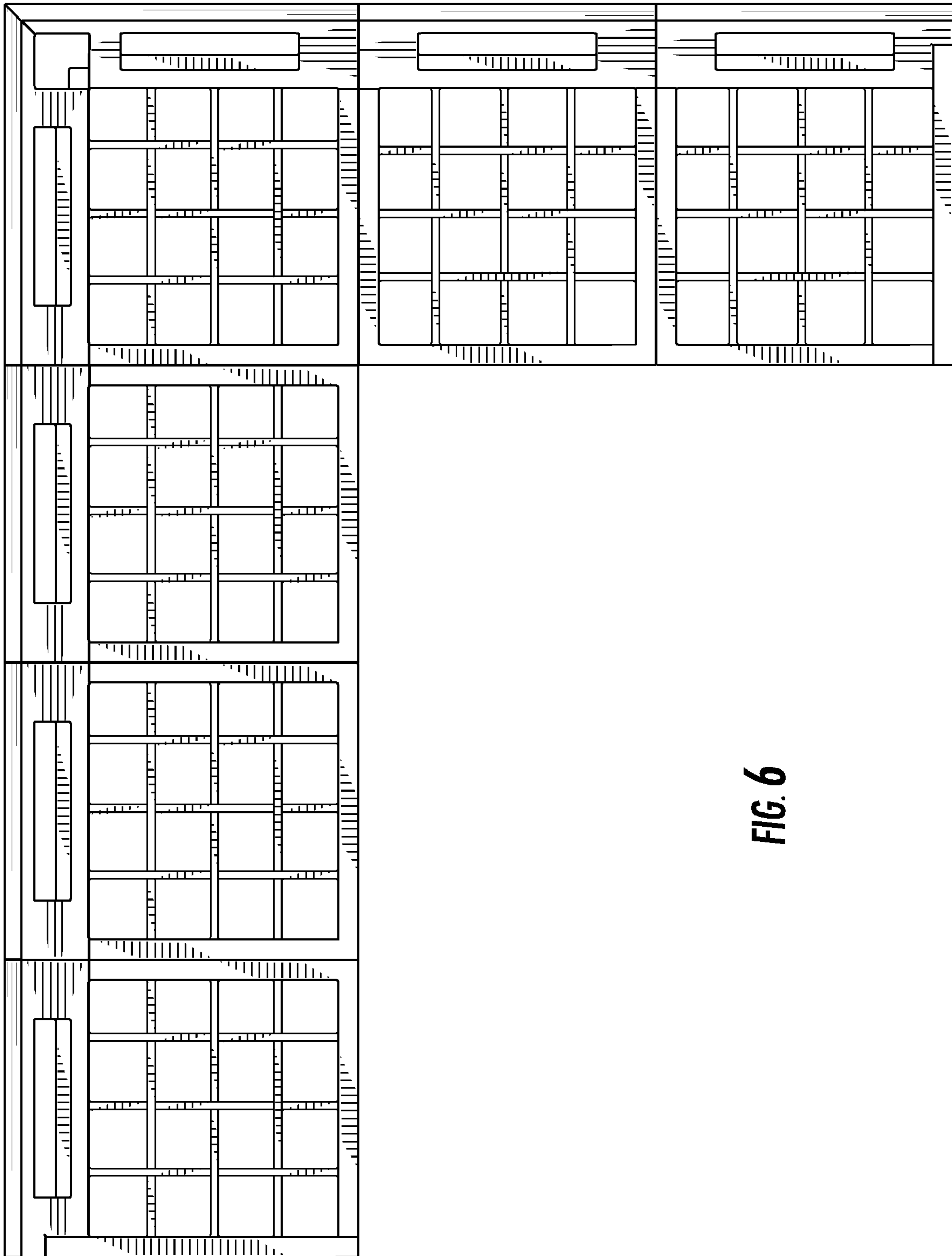

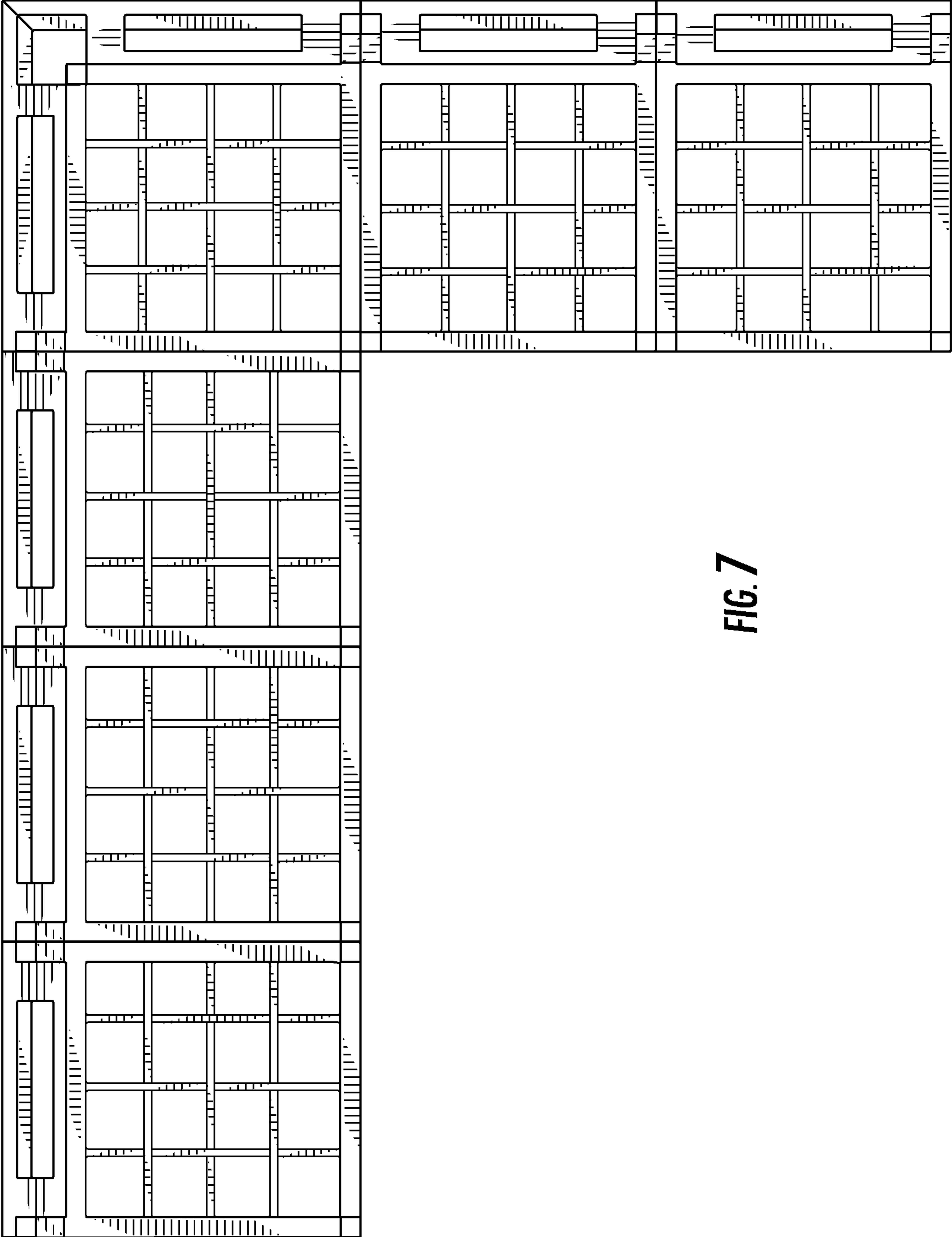

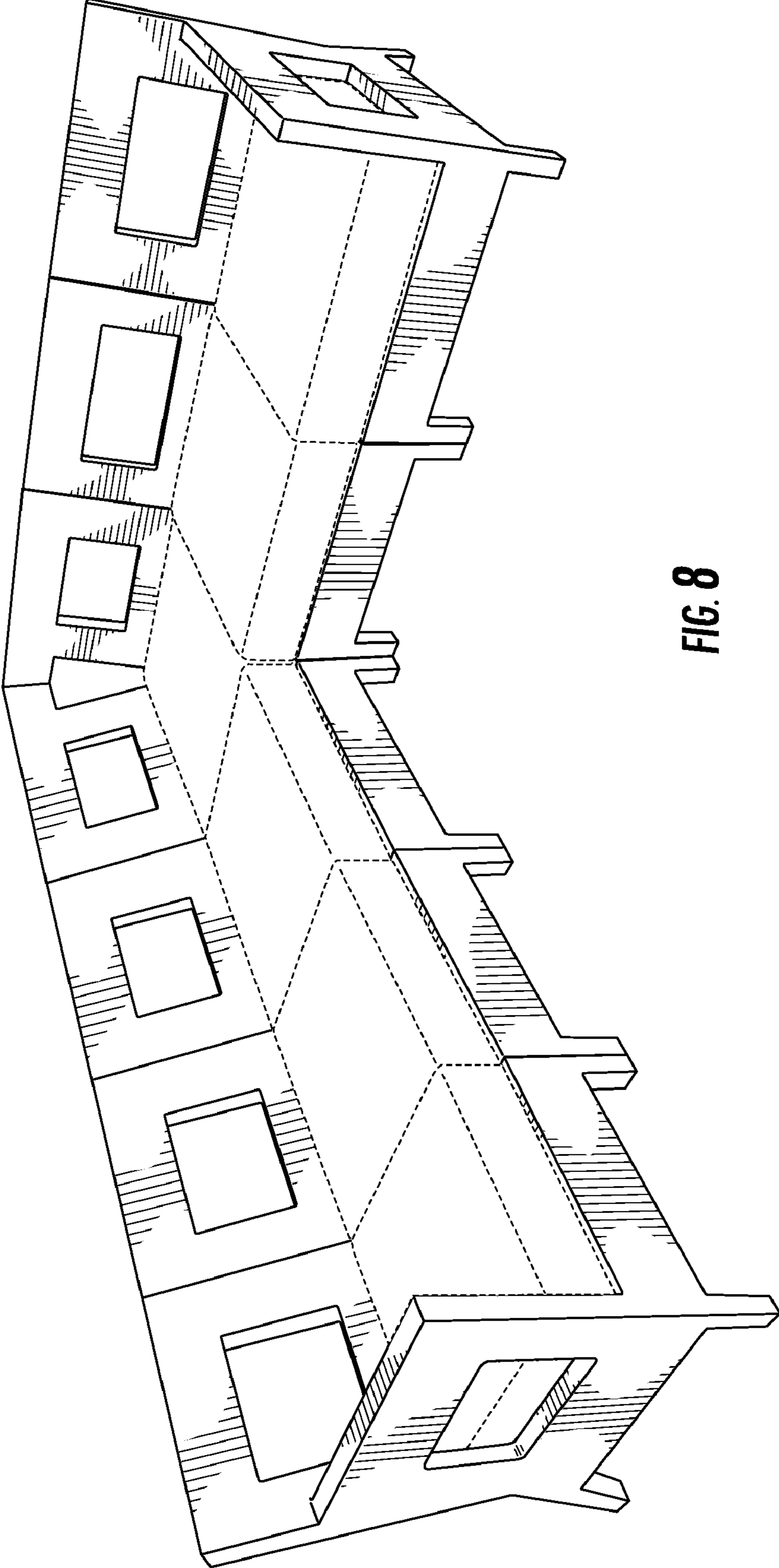

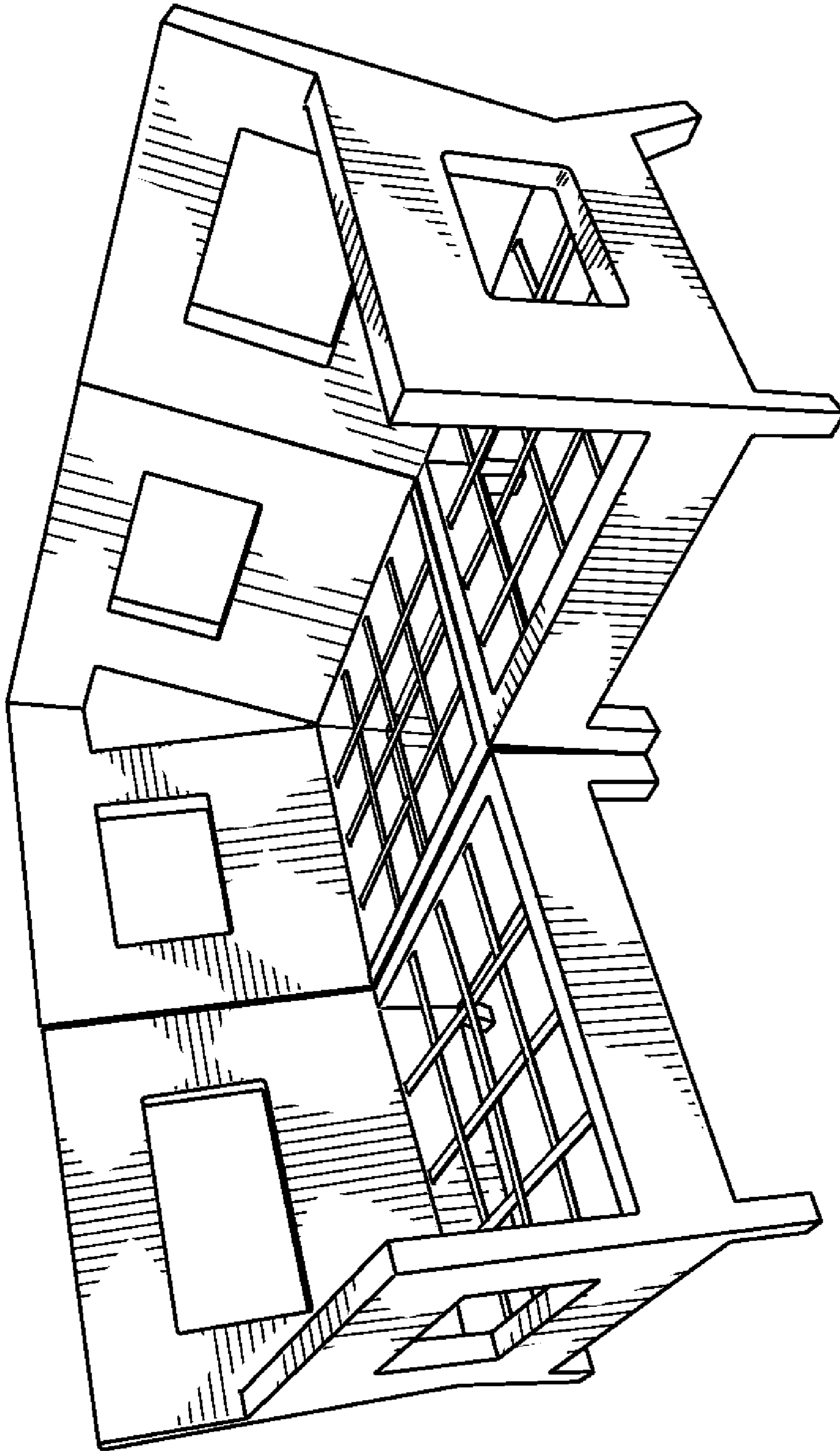

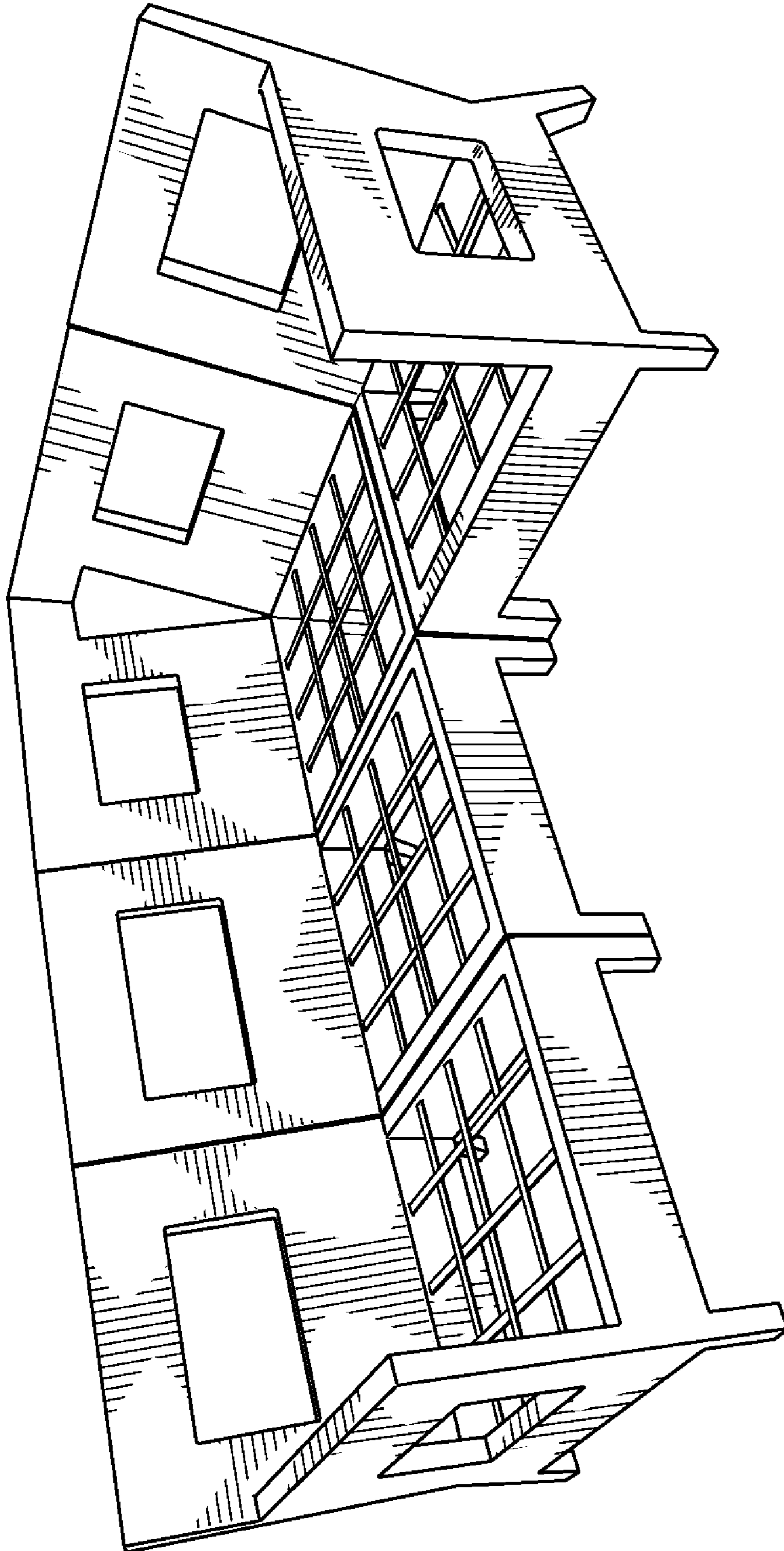

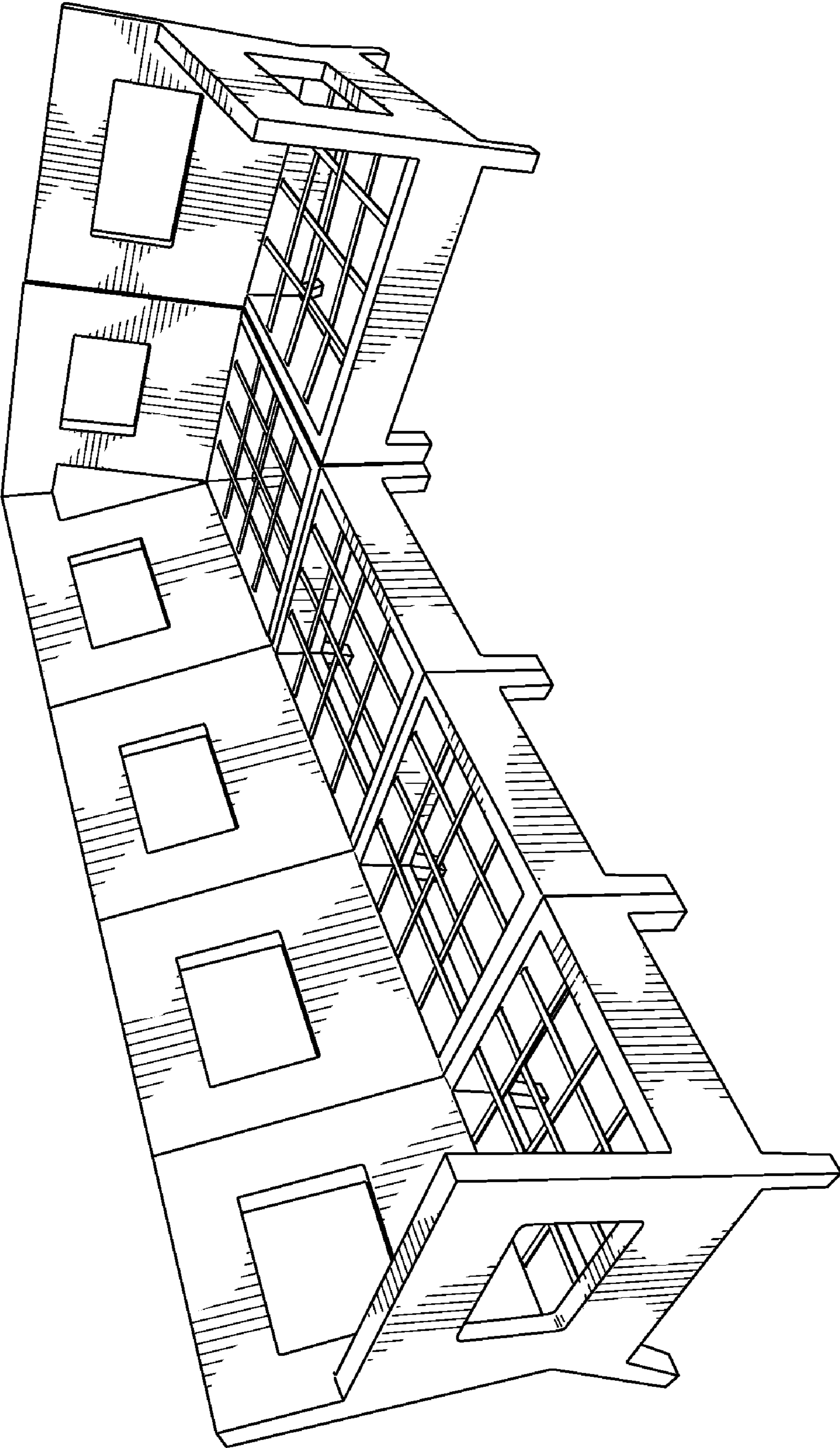

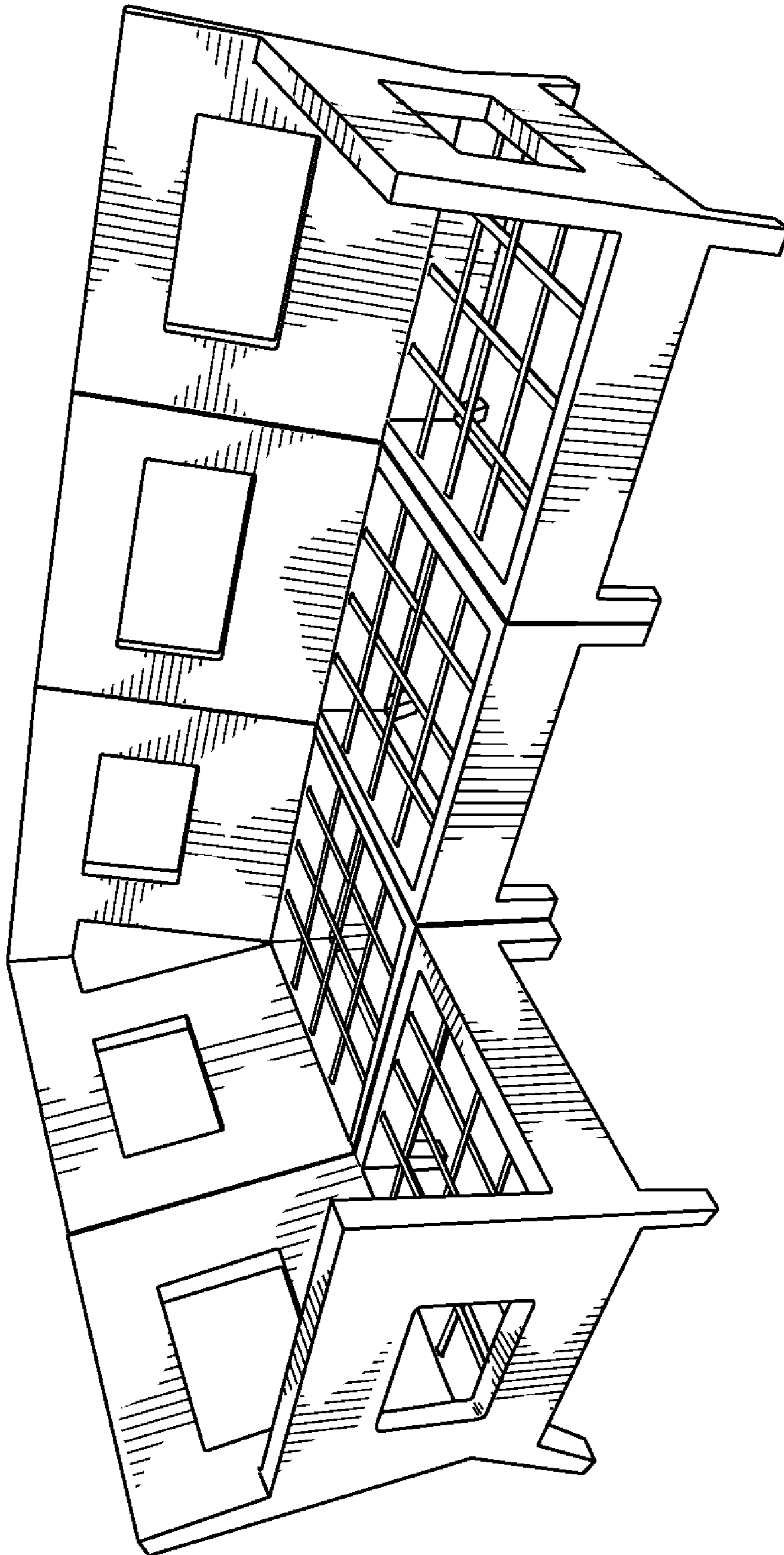

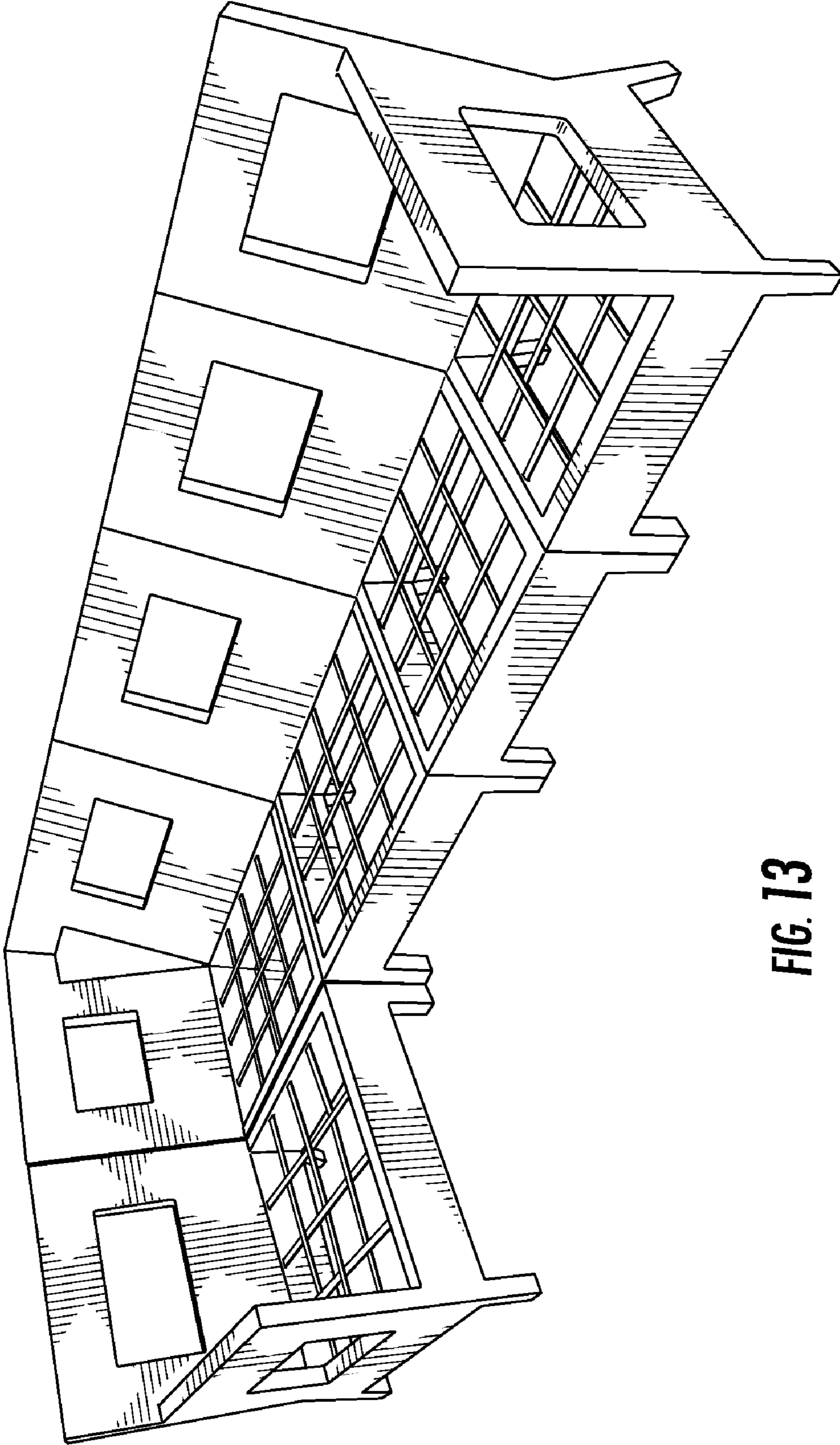

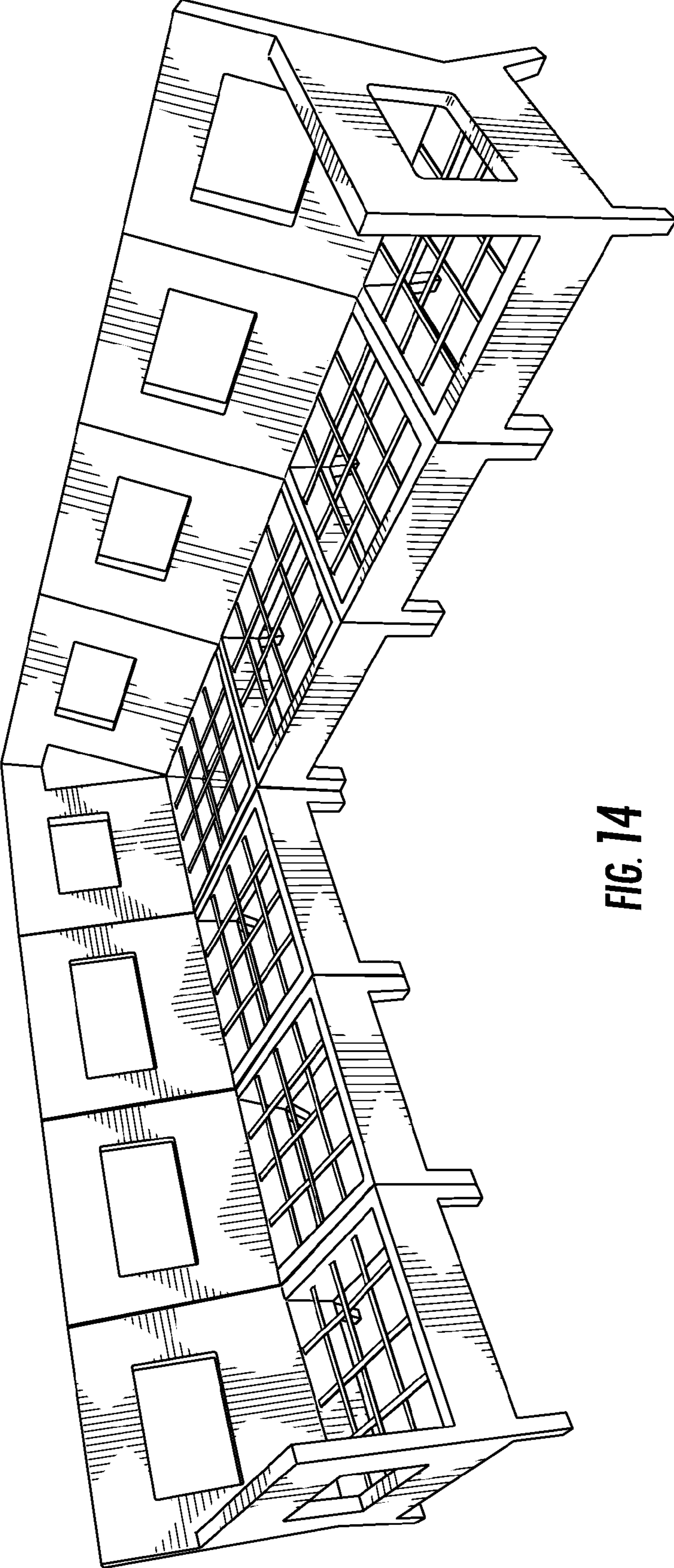
