DESCRIPTION

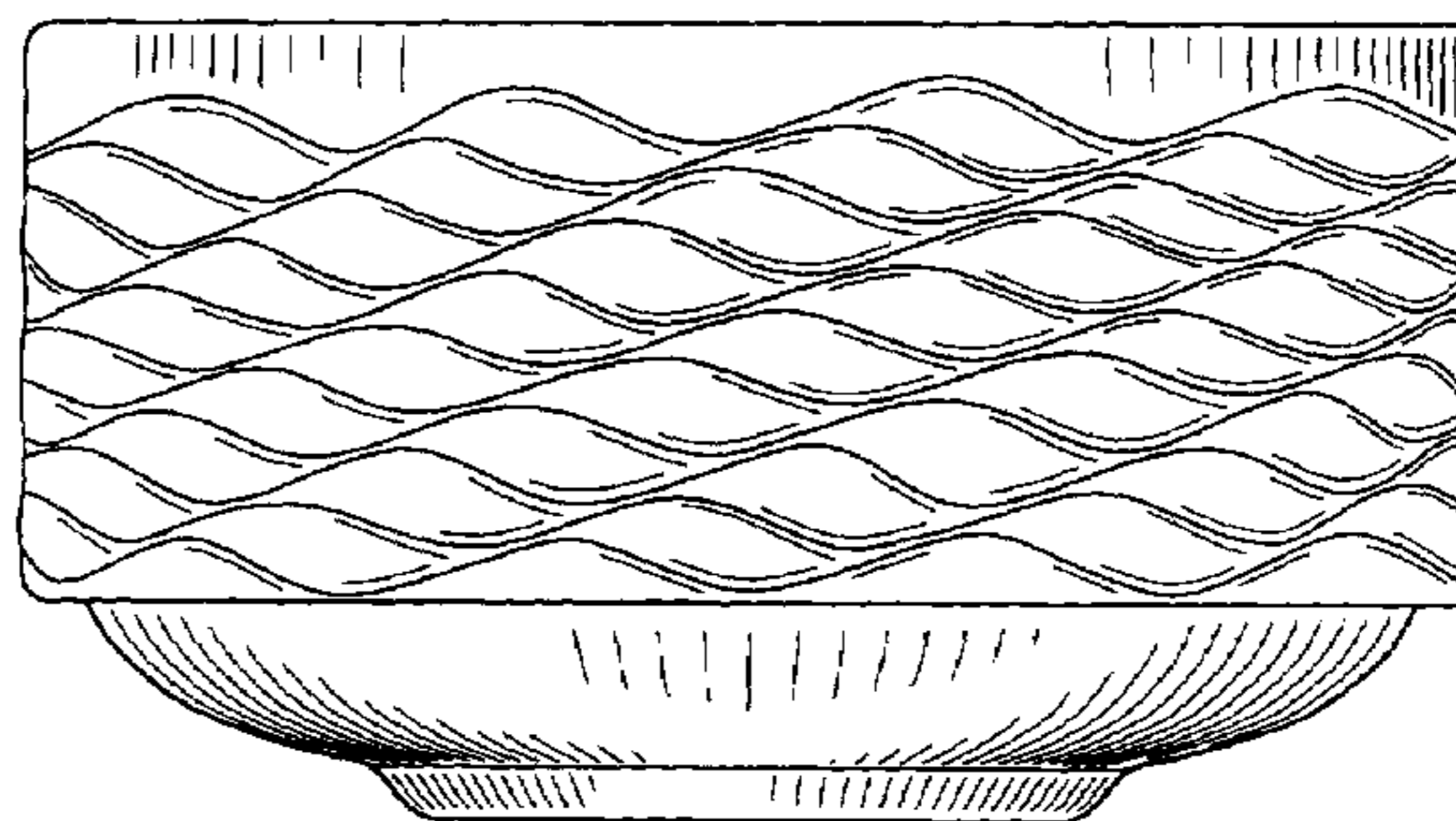
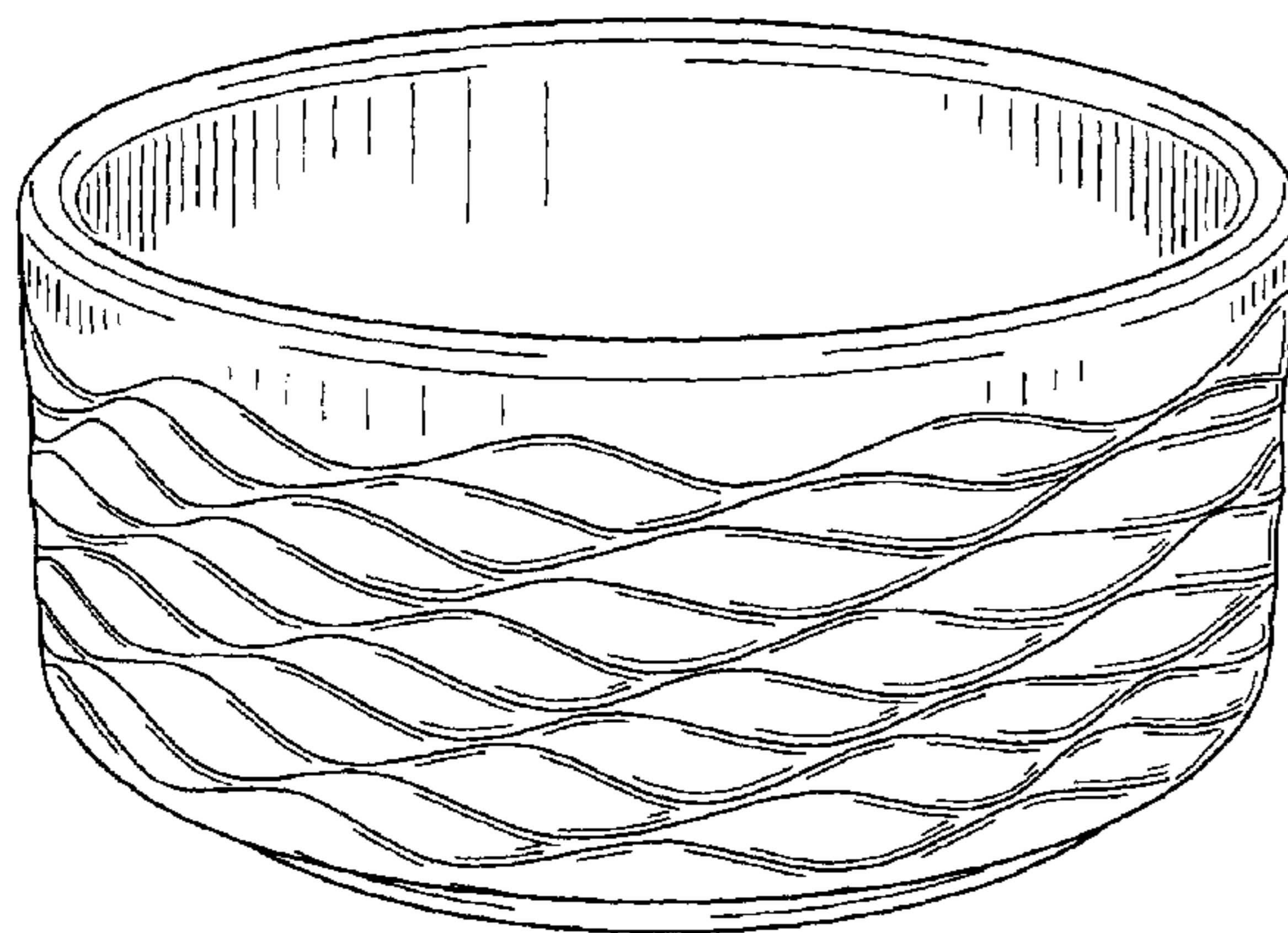
FIG. 1 is a perspective view of a bouillon cup showing our new design.

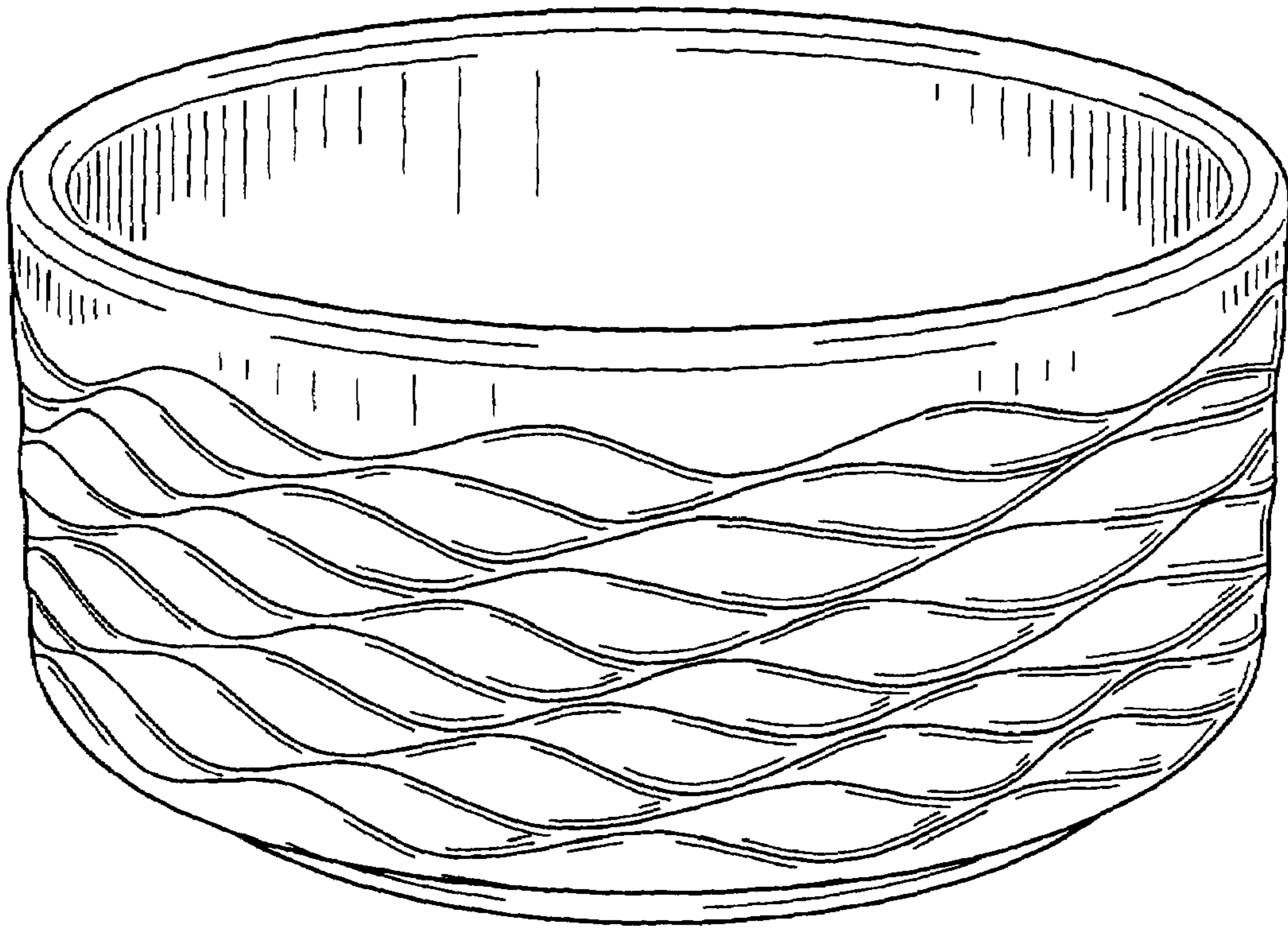

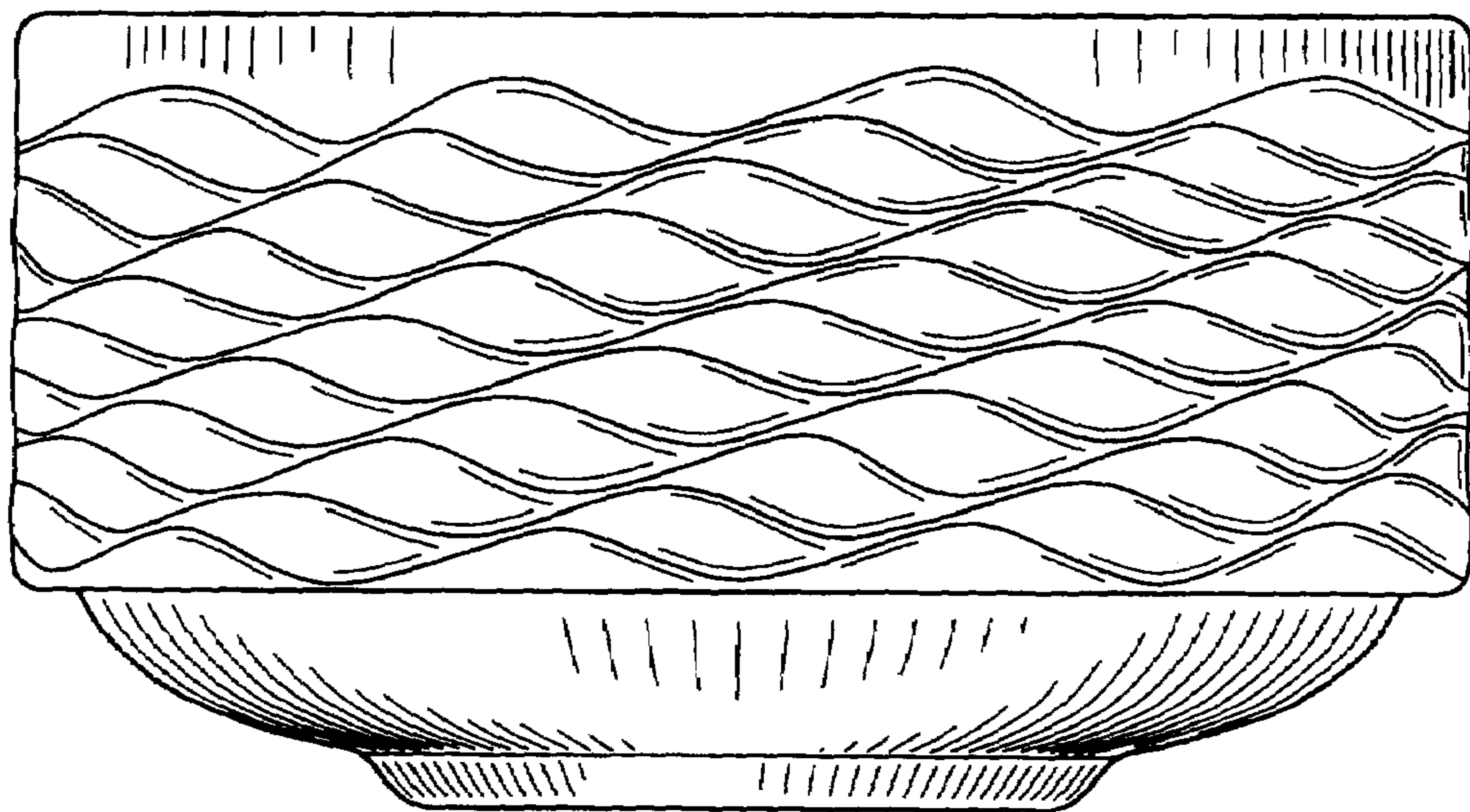

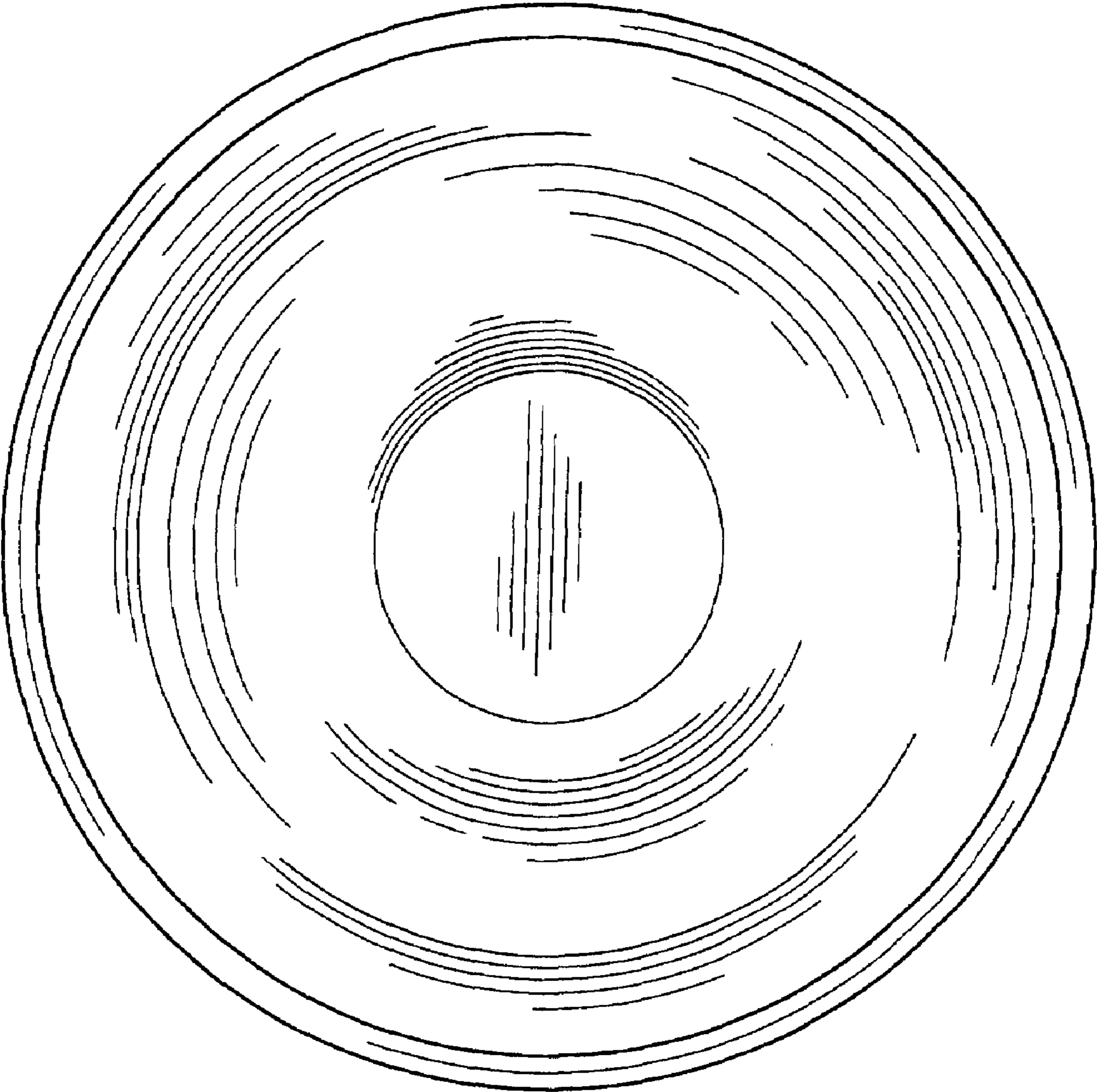

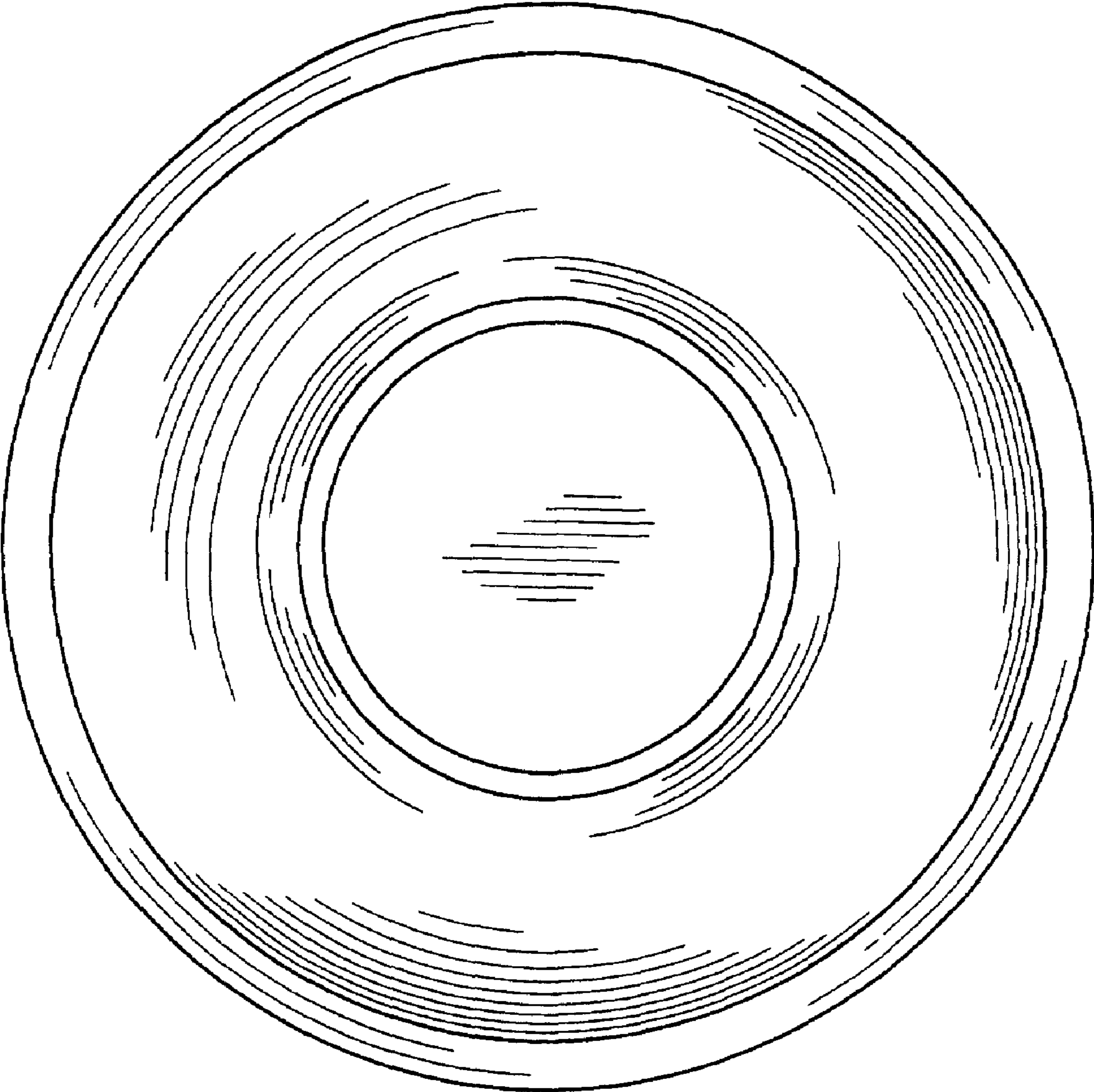
