The ornamental design for a product container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a product container showing my new design;

FIG. 2 is a top plan view thereof;

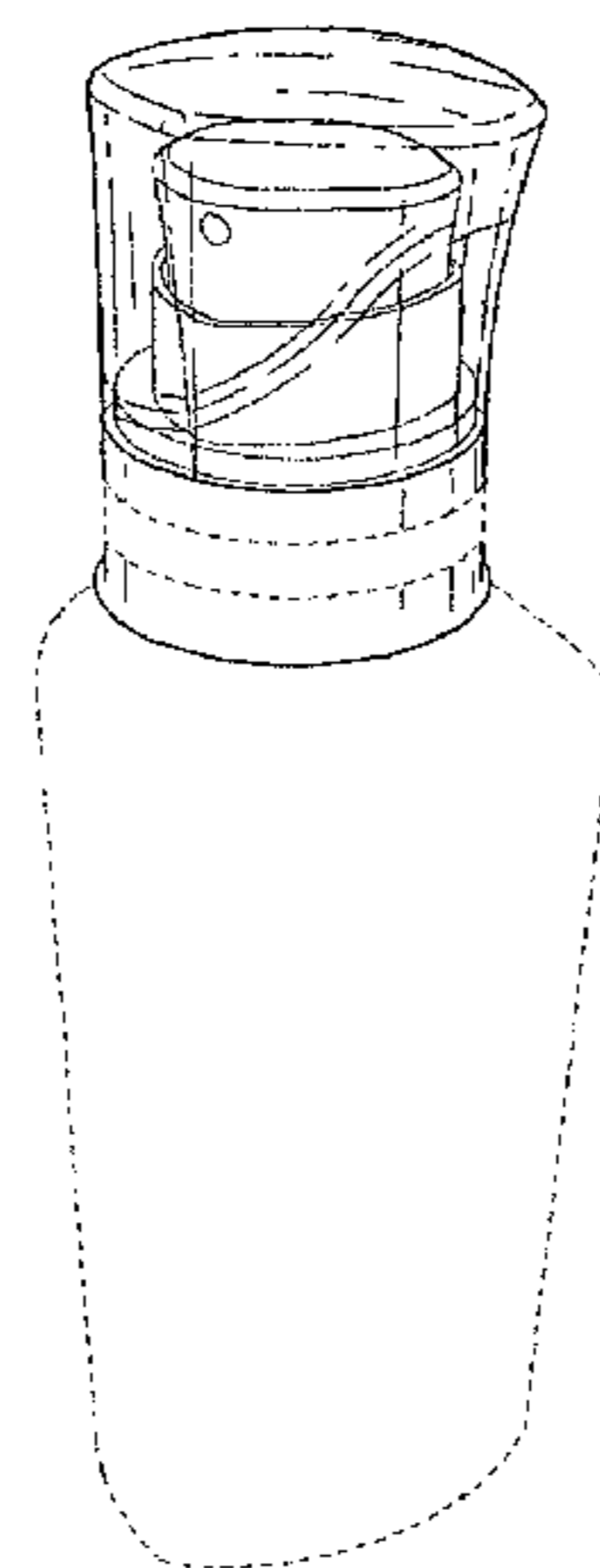
FIG. 3 is a front view thereof;

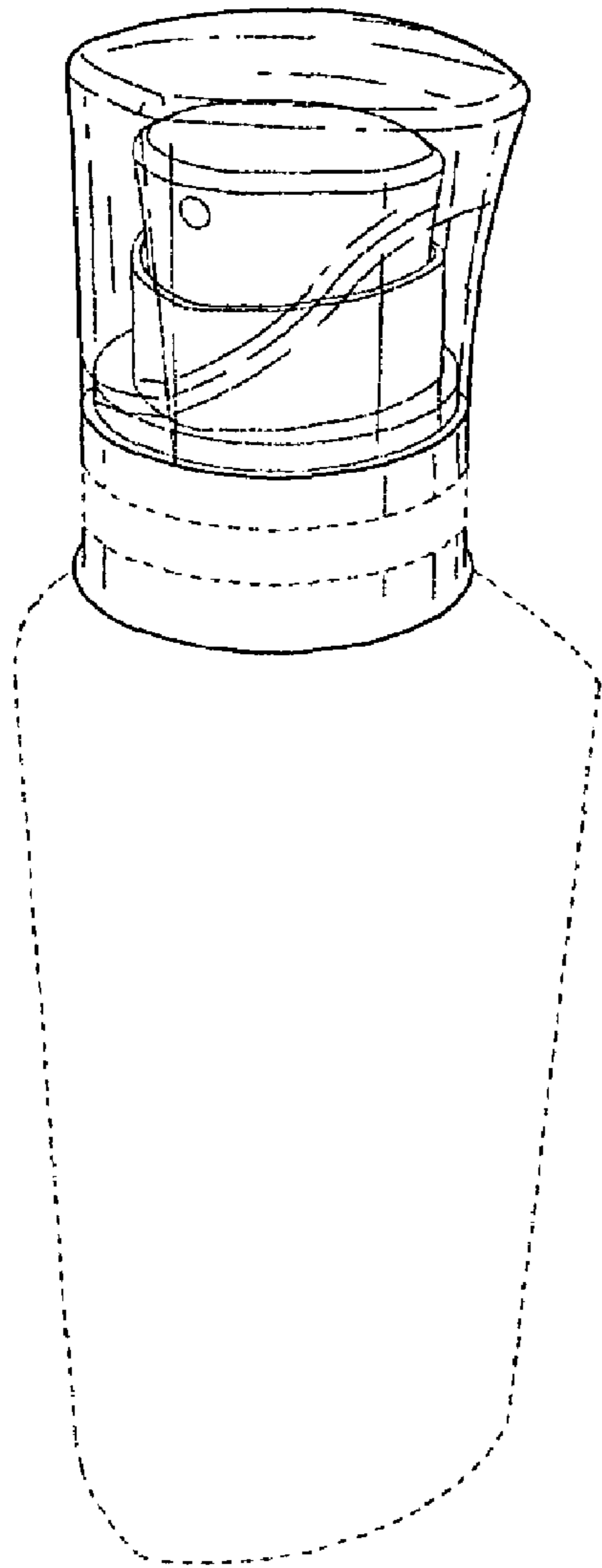

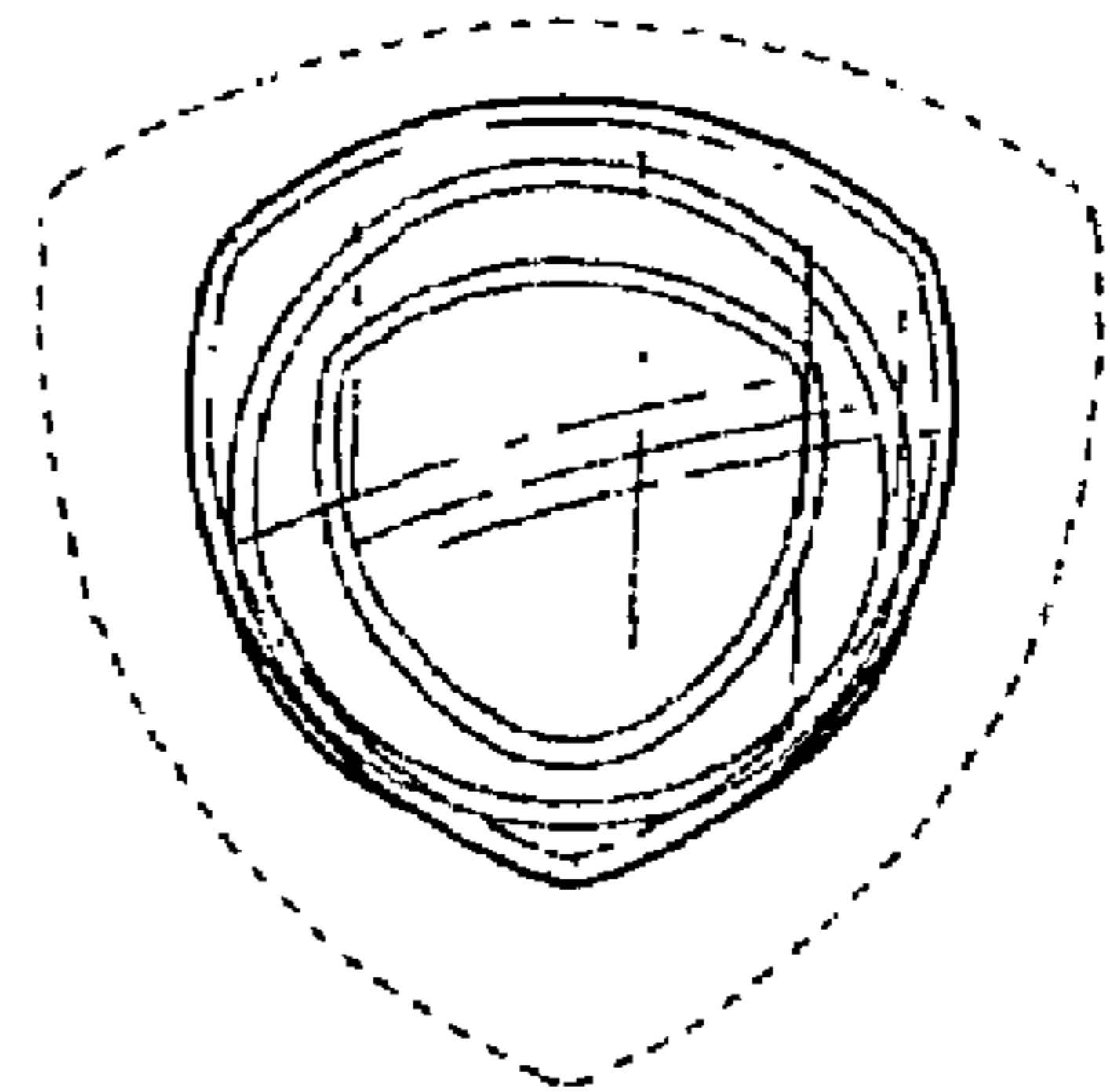

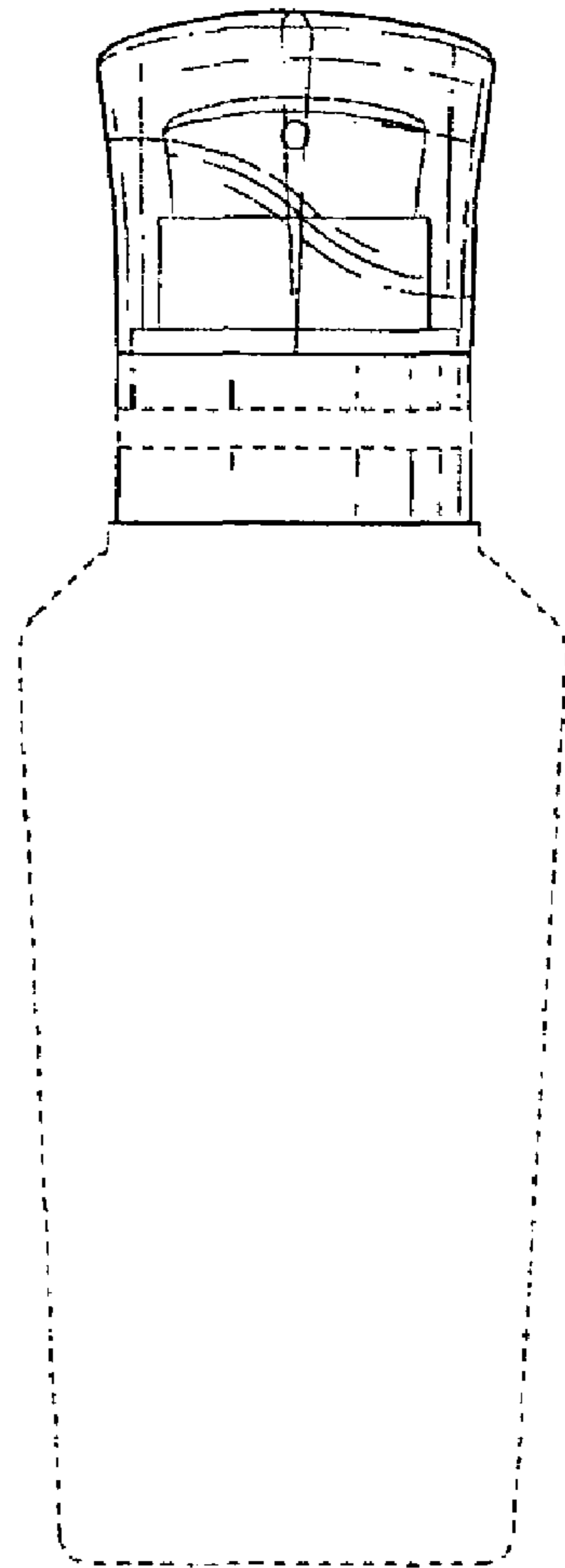

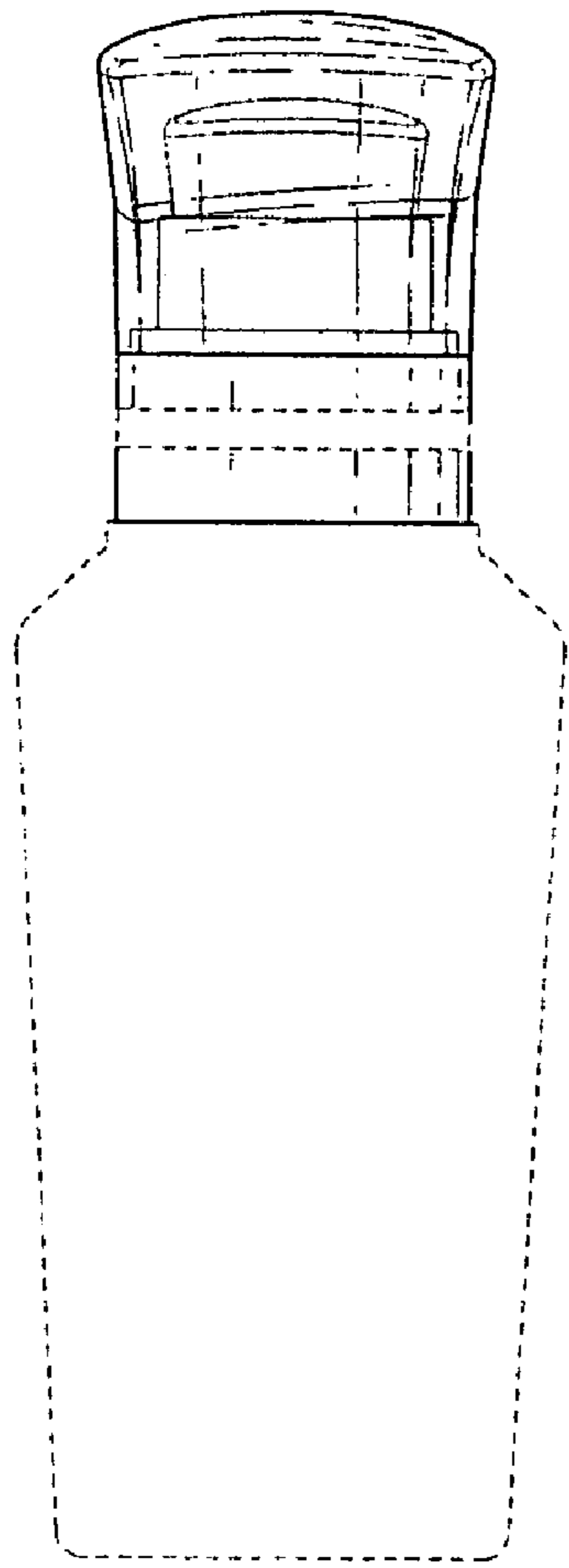

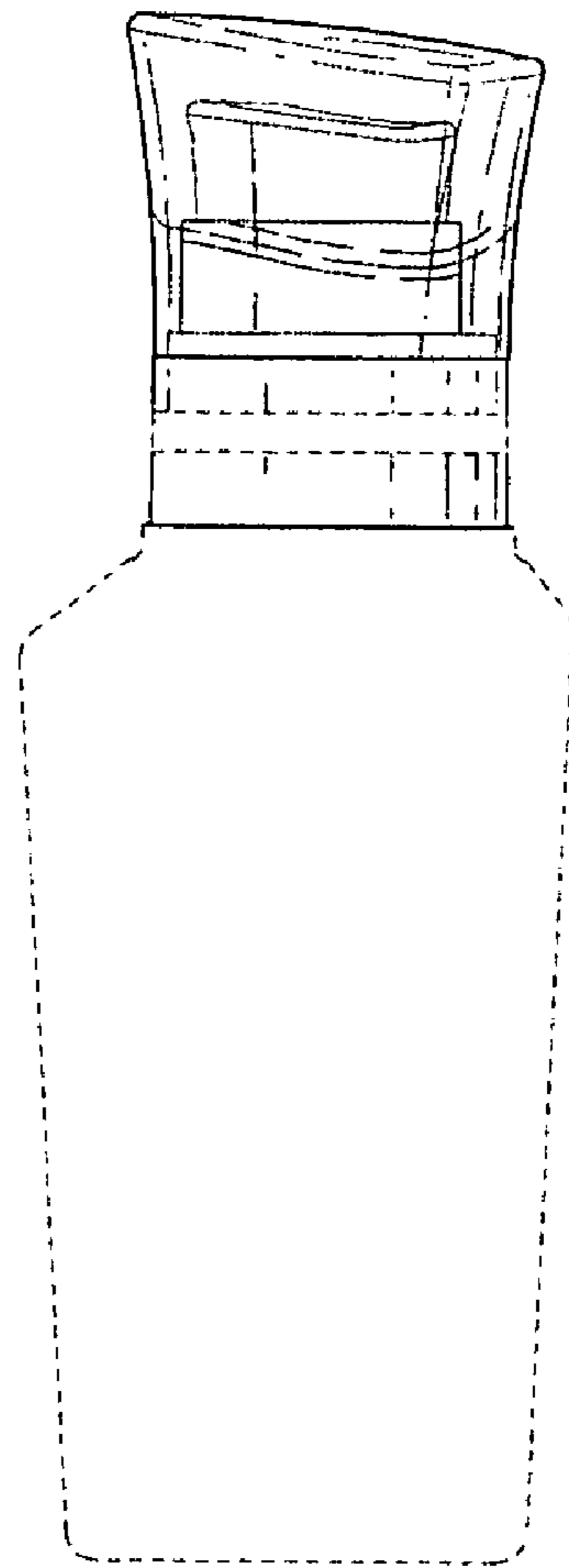
