FIG. 3 is a front view of my design for the wet tissue dispenser shown in FIG. 1.

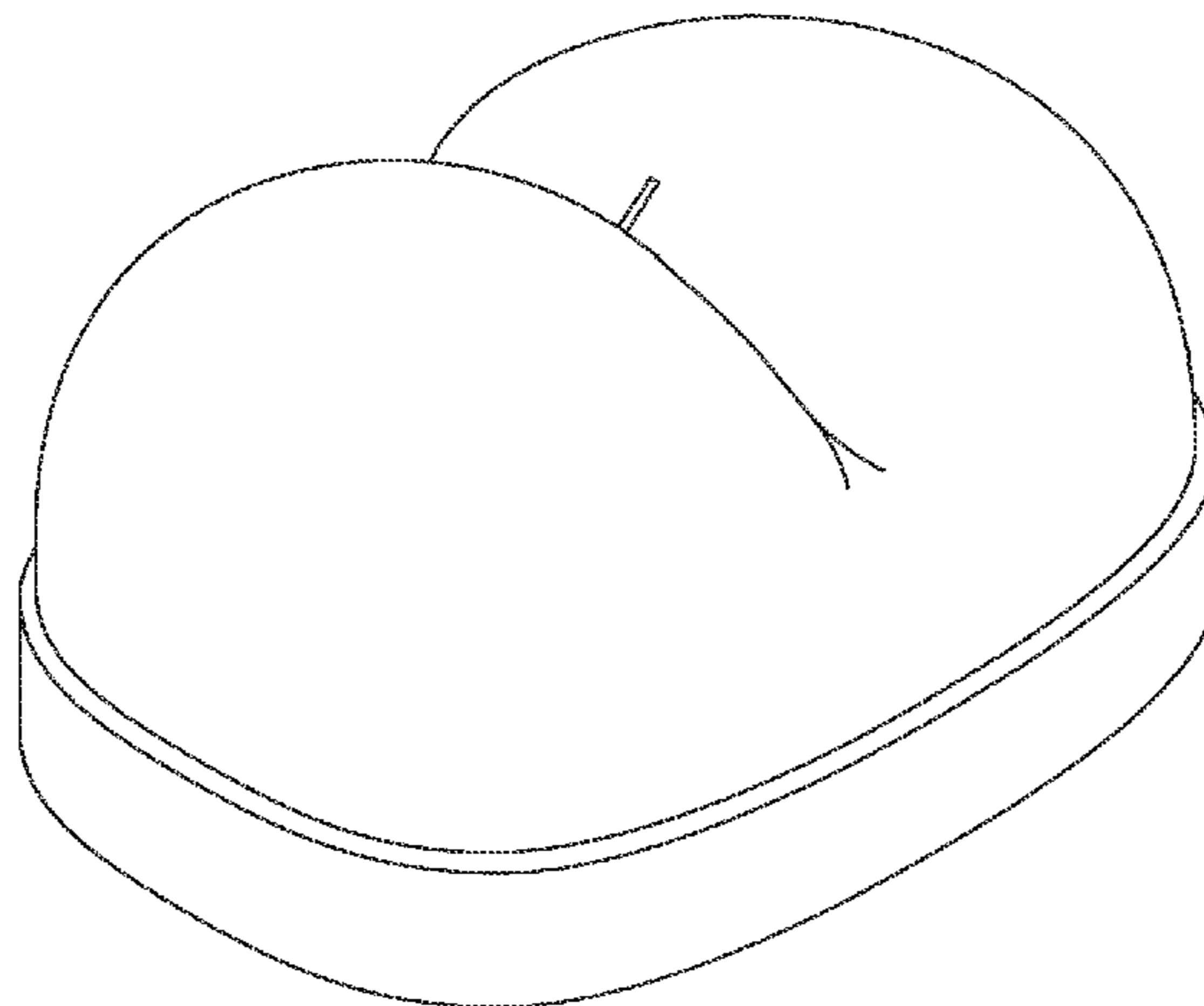
FIG. 4 is a top view of my design for the wet tissue dispenser shown in FIG. 1.

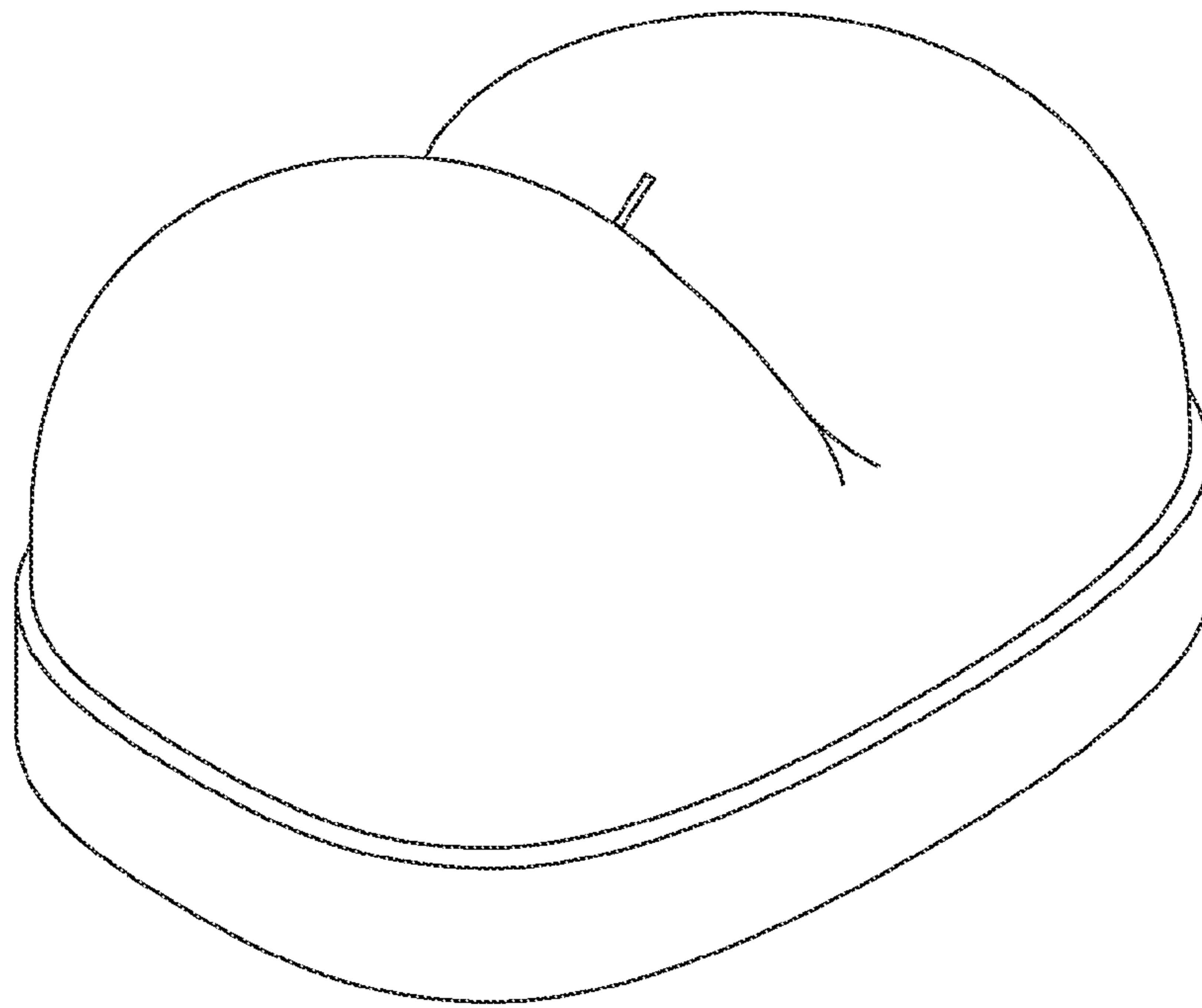

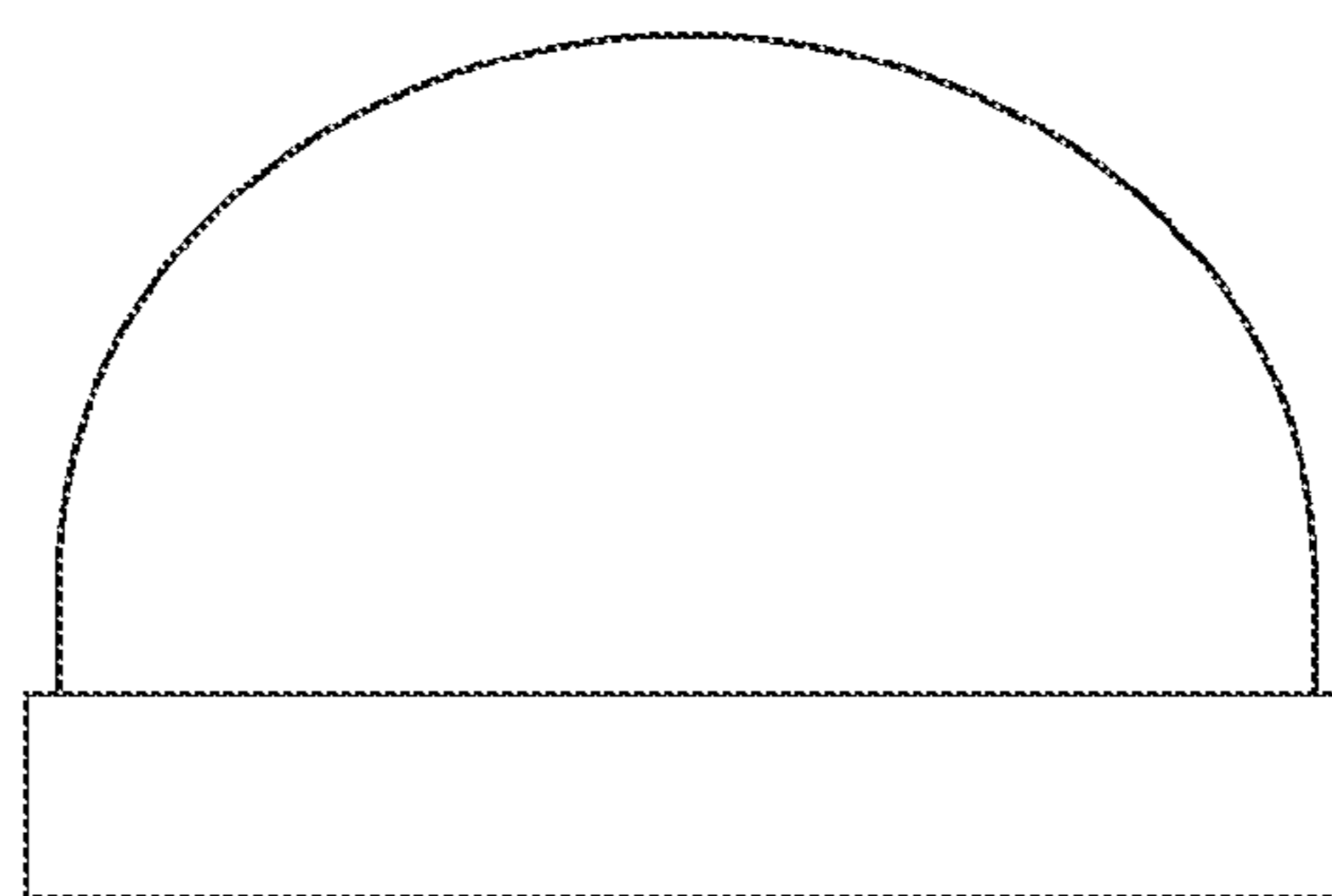

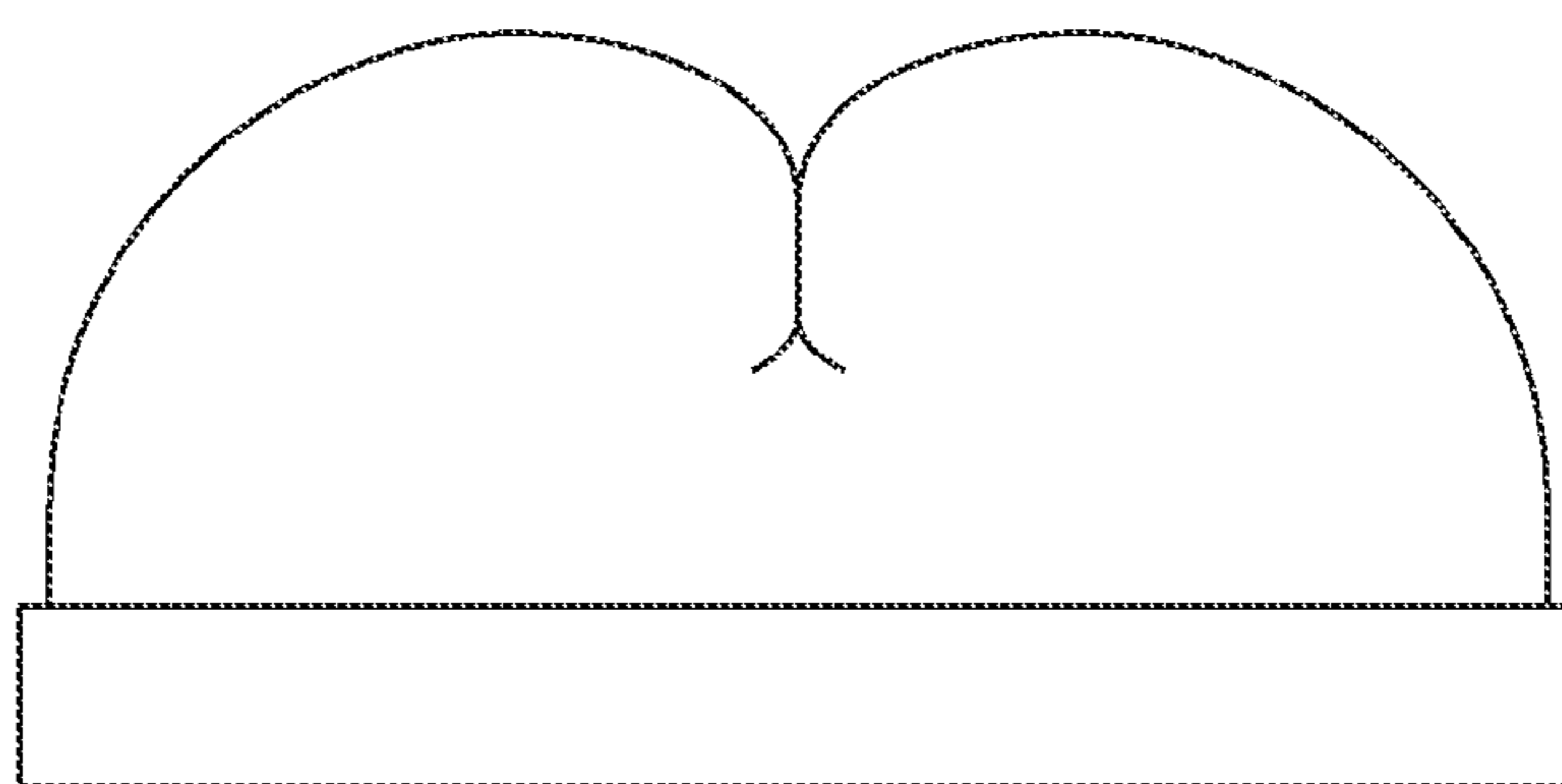

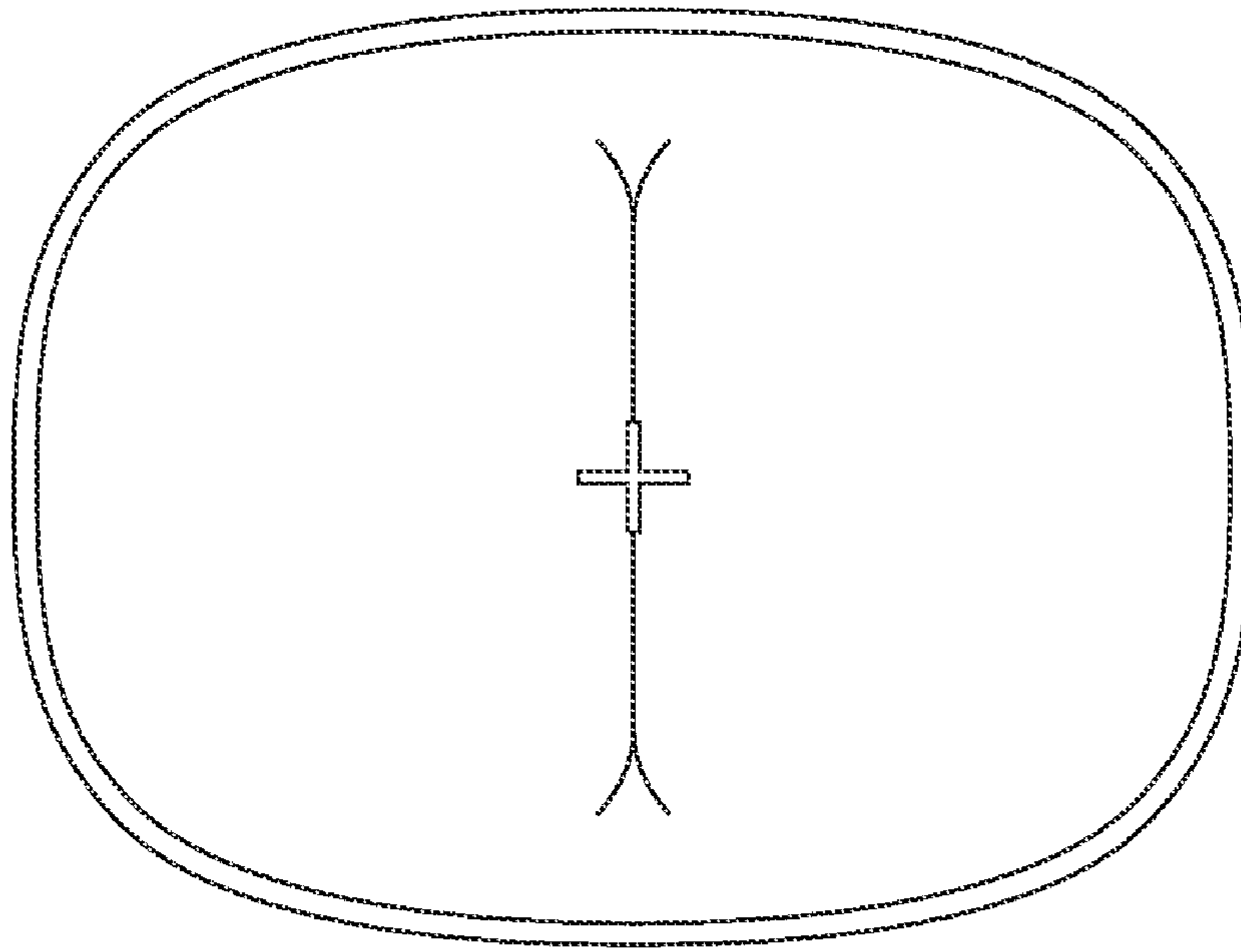

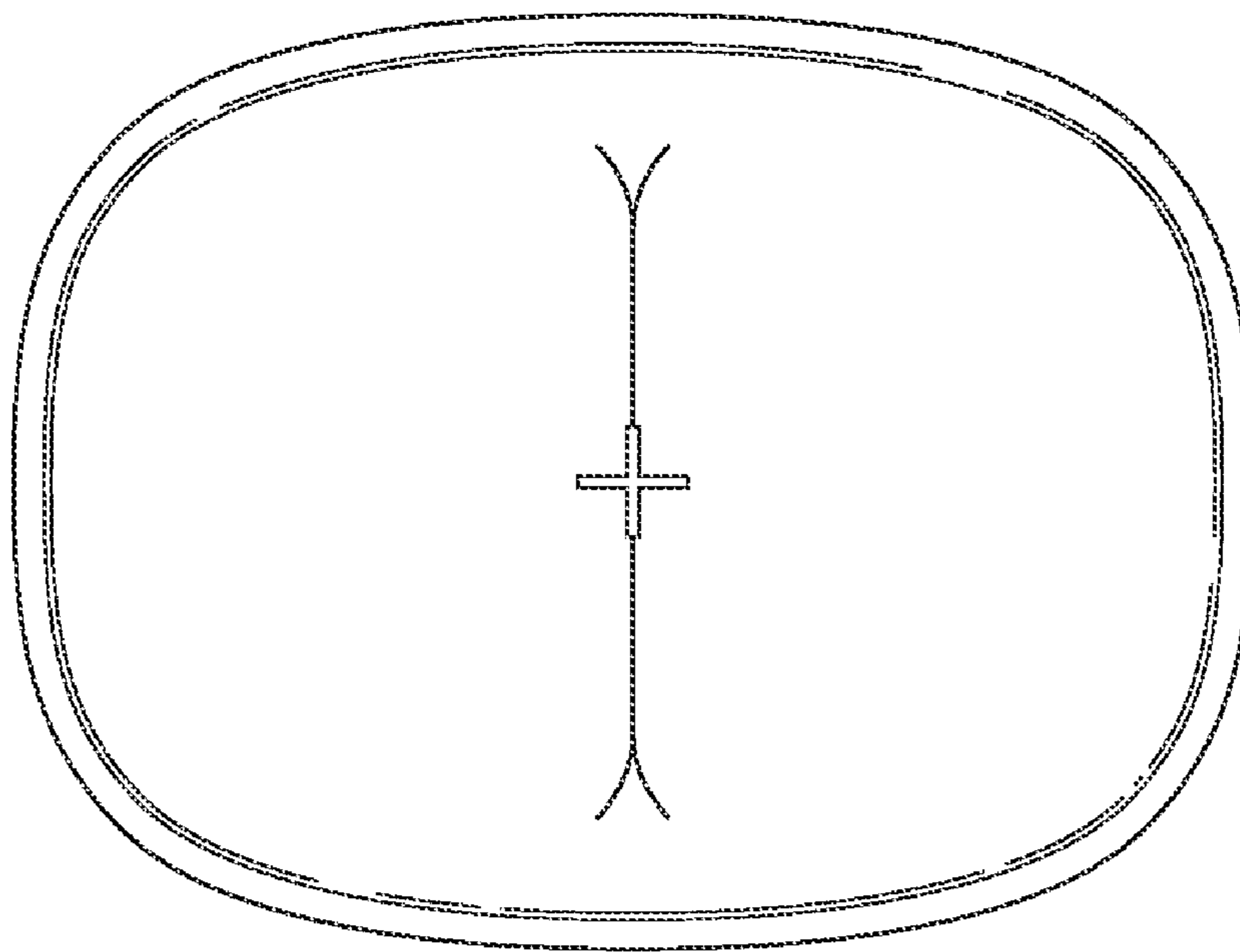

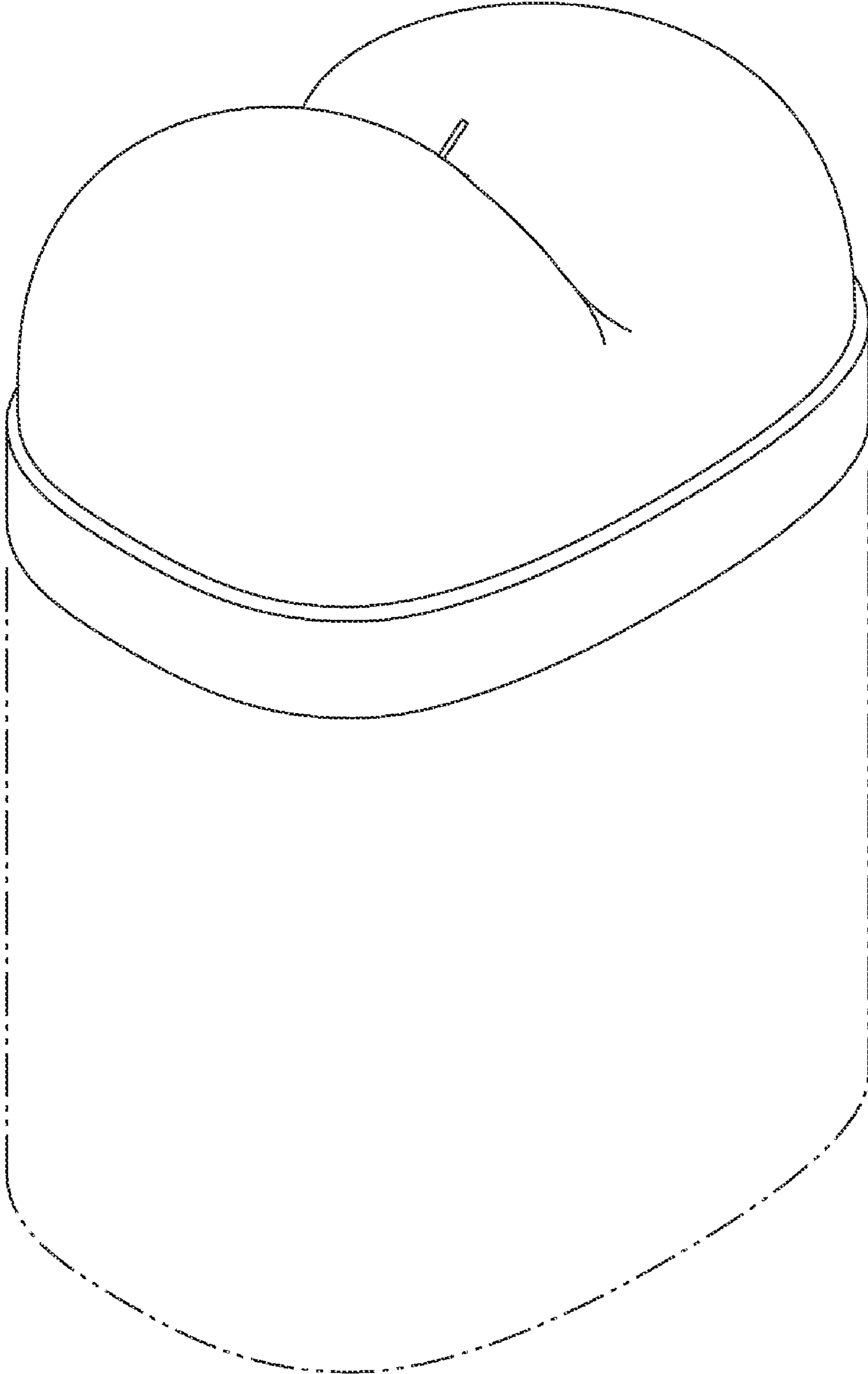
