The ornamental design for bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bottle showing our design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of a second embodiment of the bottle of FIG. 1, the differences being in the shorter length of the cap closure on the figurative arm of the bottle body;

FIG. 9 is a front elevational view thereof;

FIG. 10 is a rear elevational view thereof;

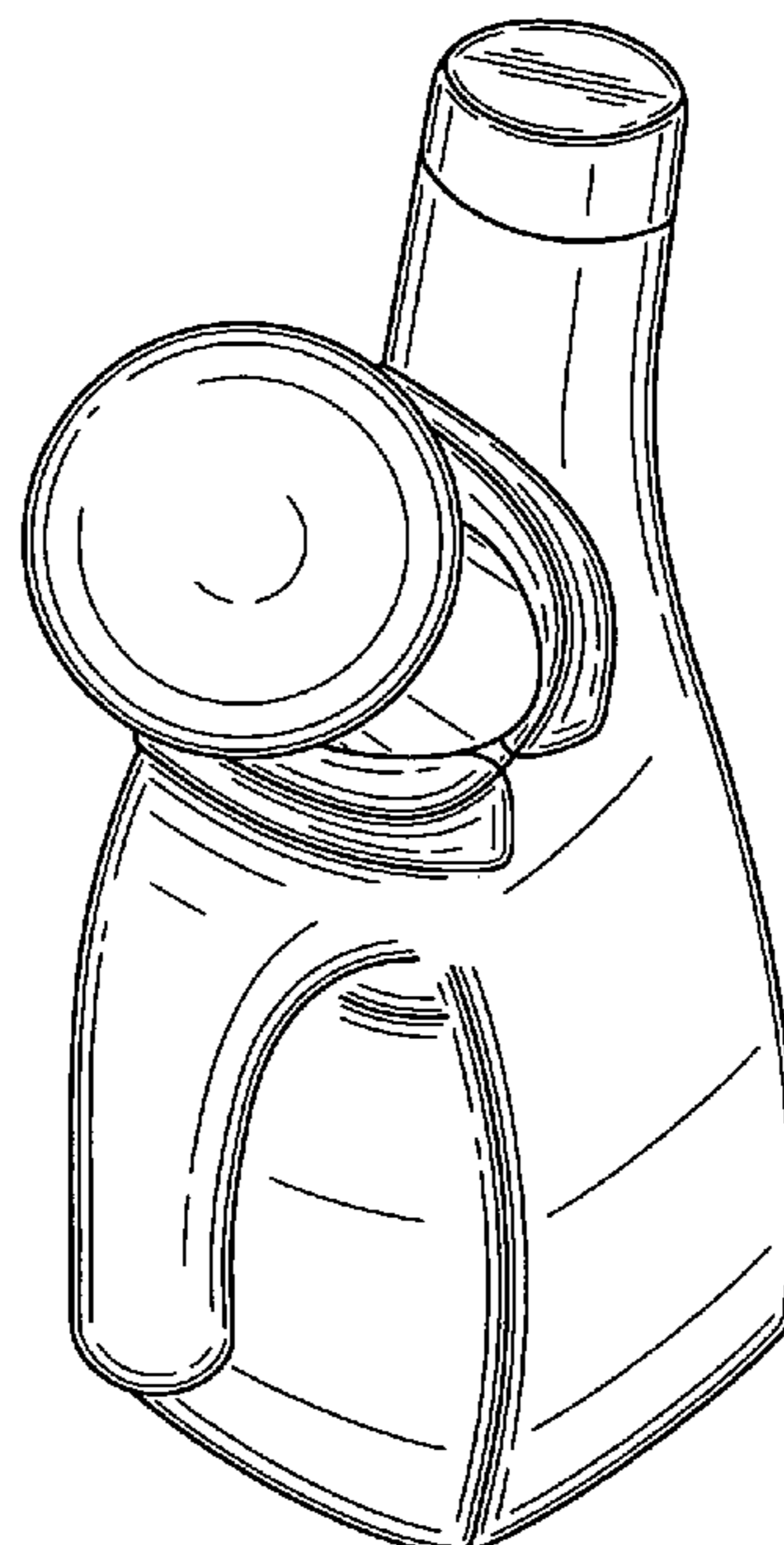
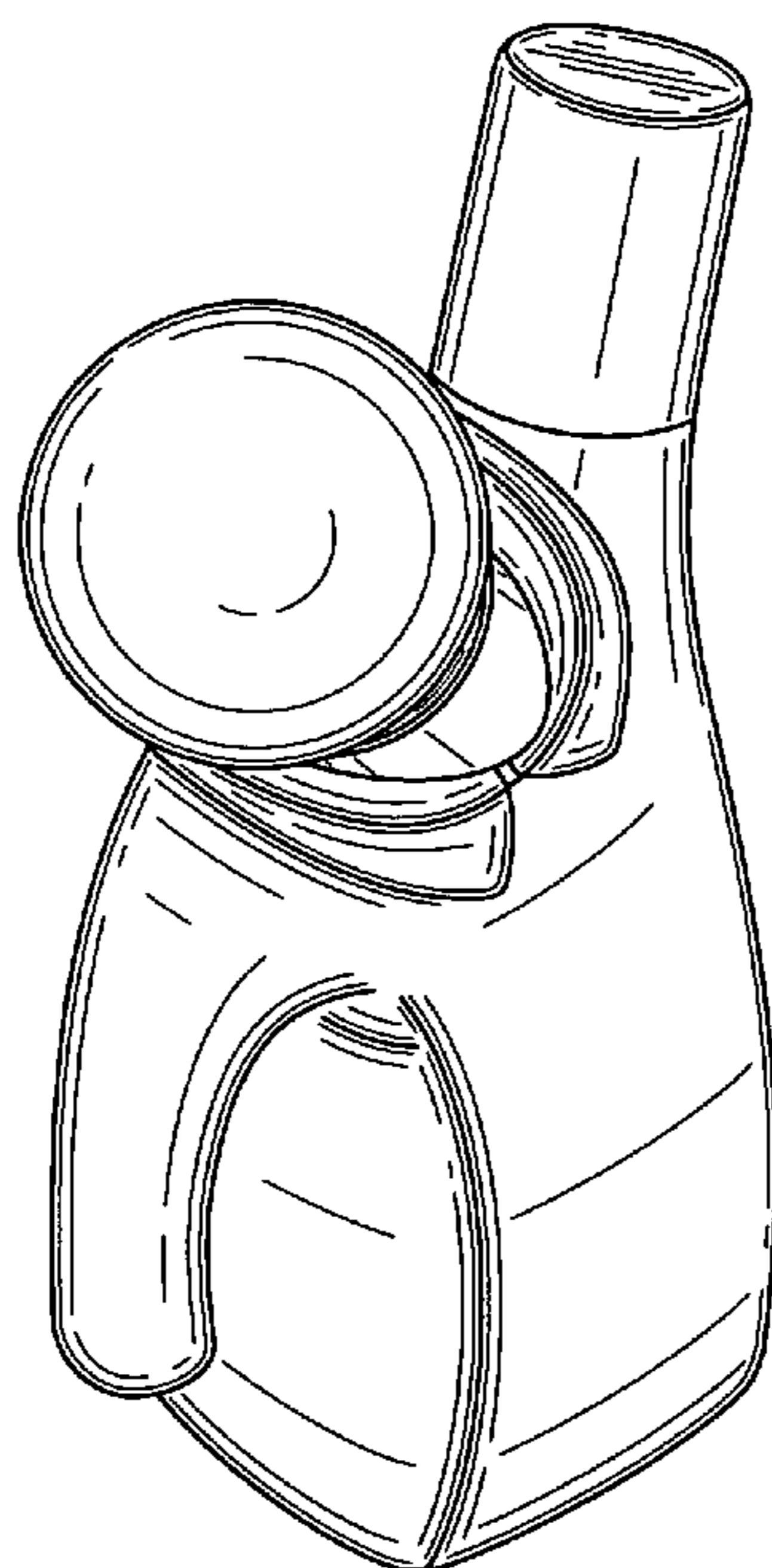
FIG. 11 is a left side elevational view thereof;

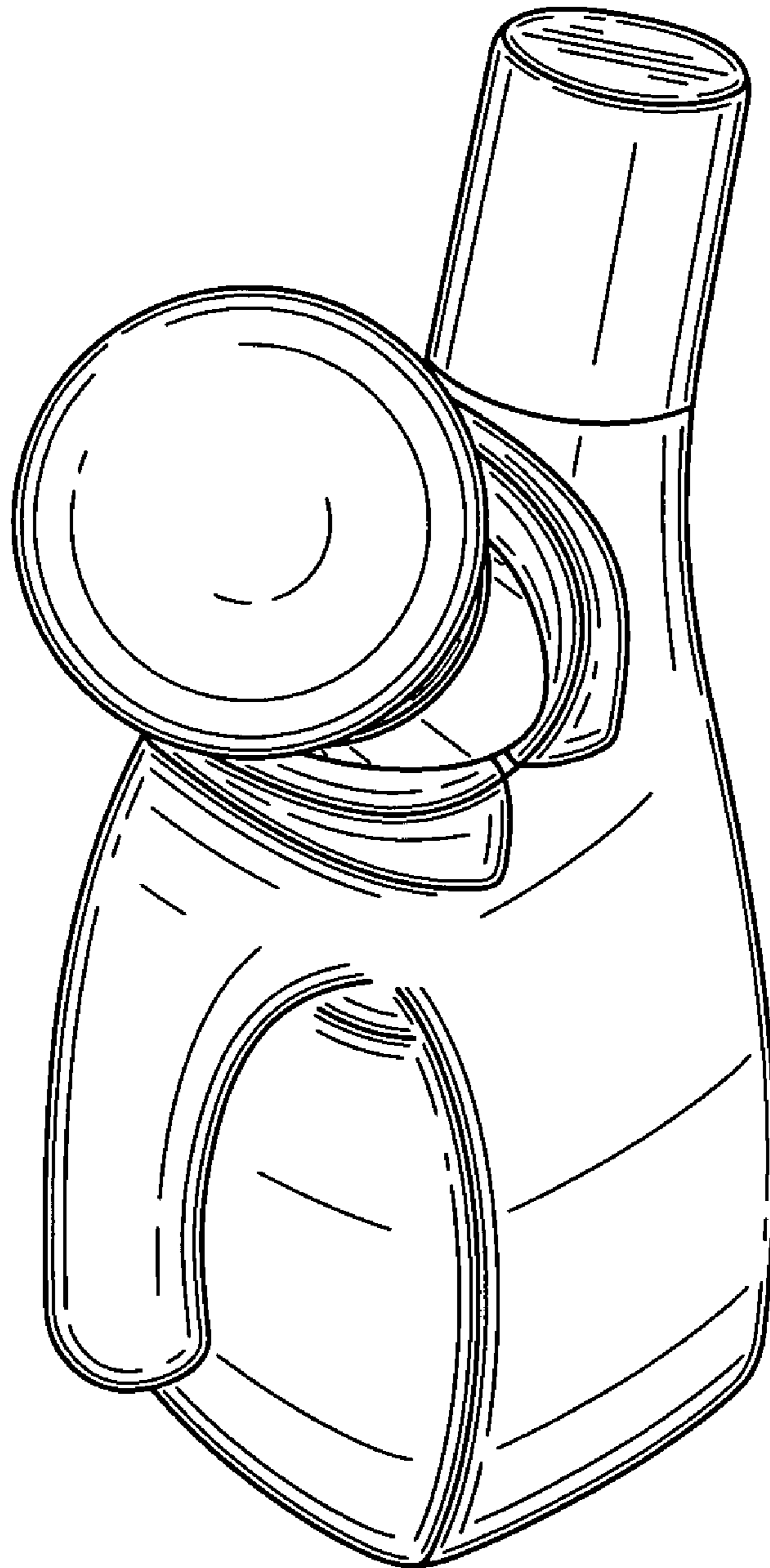

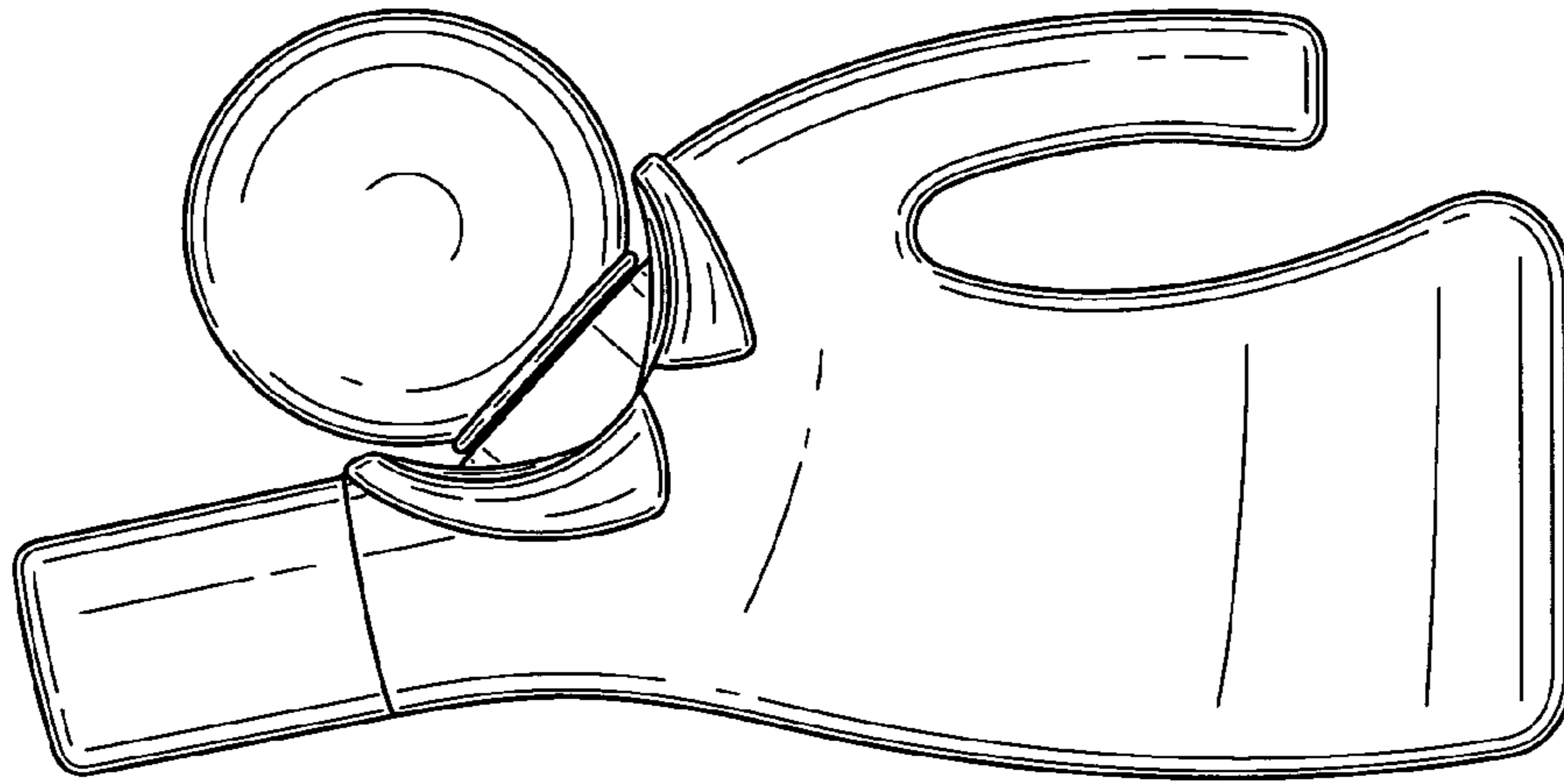

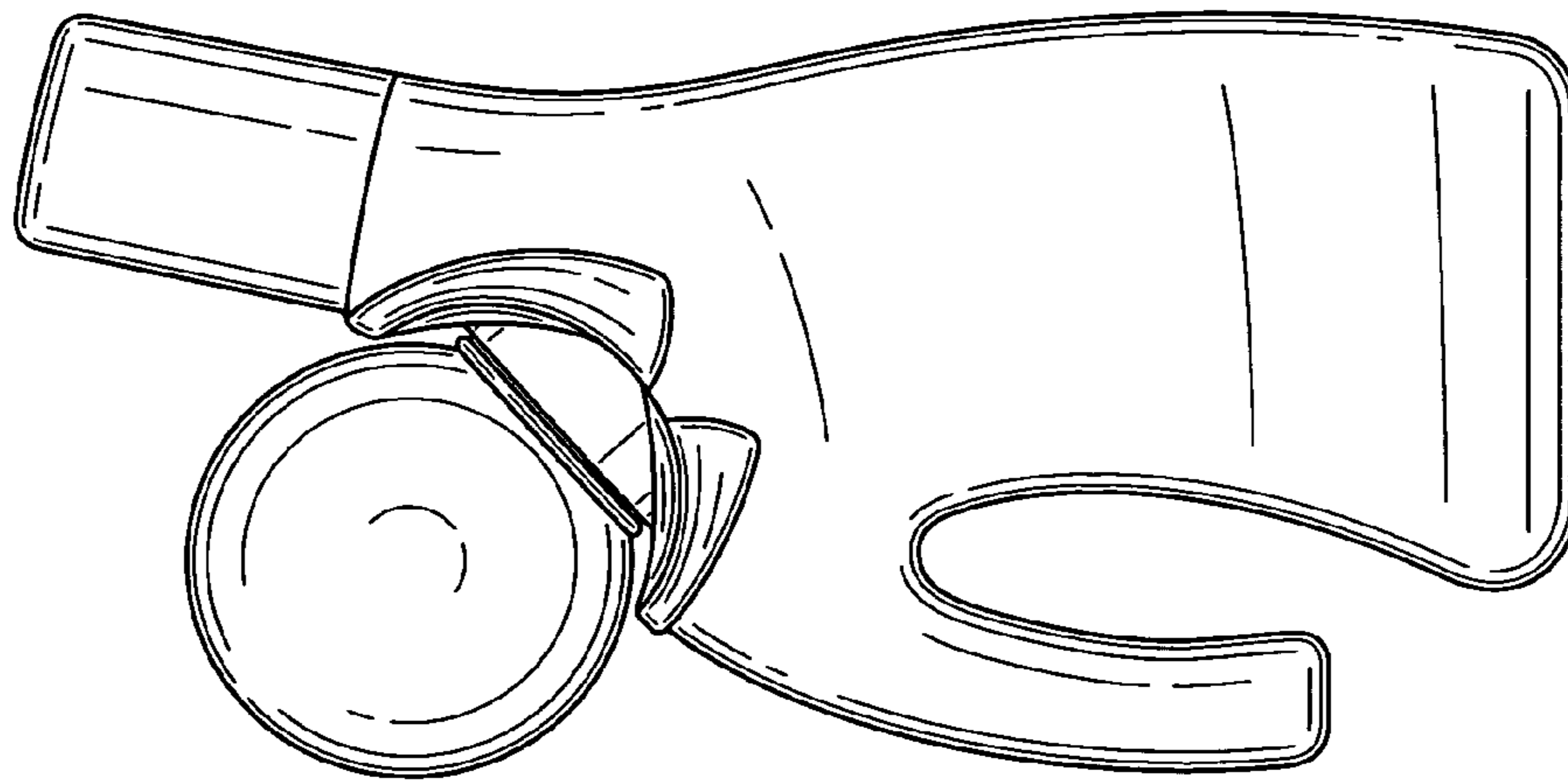

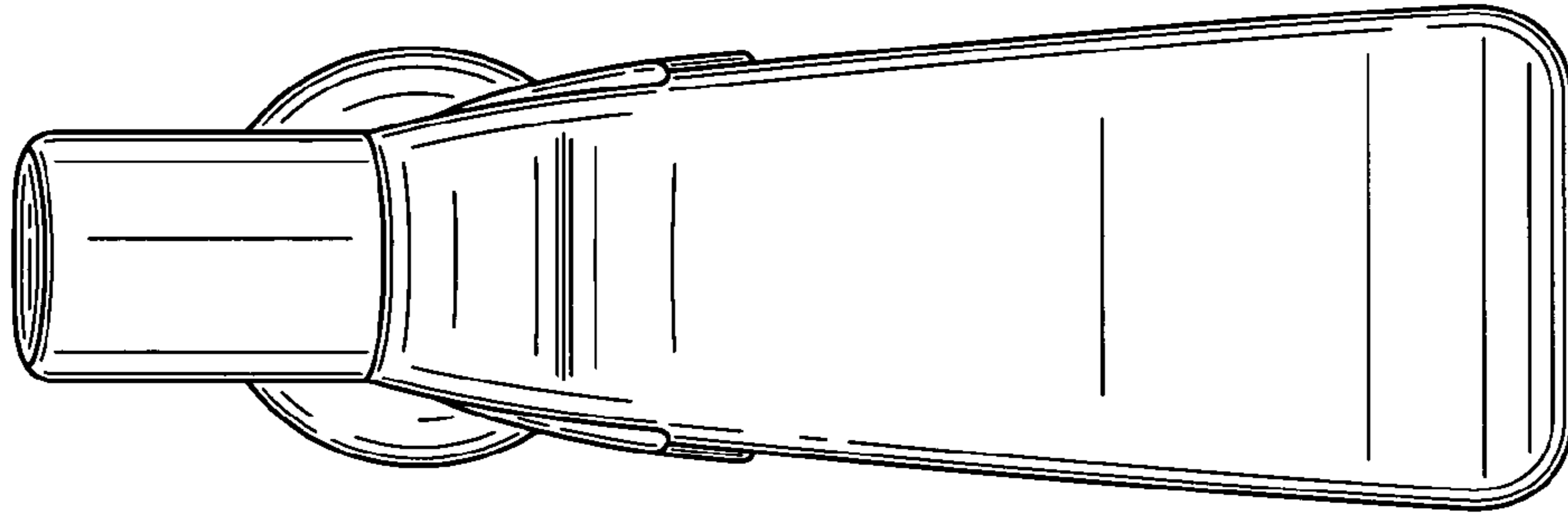

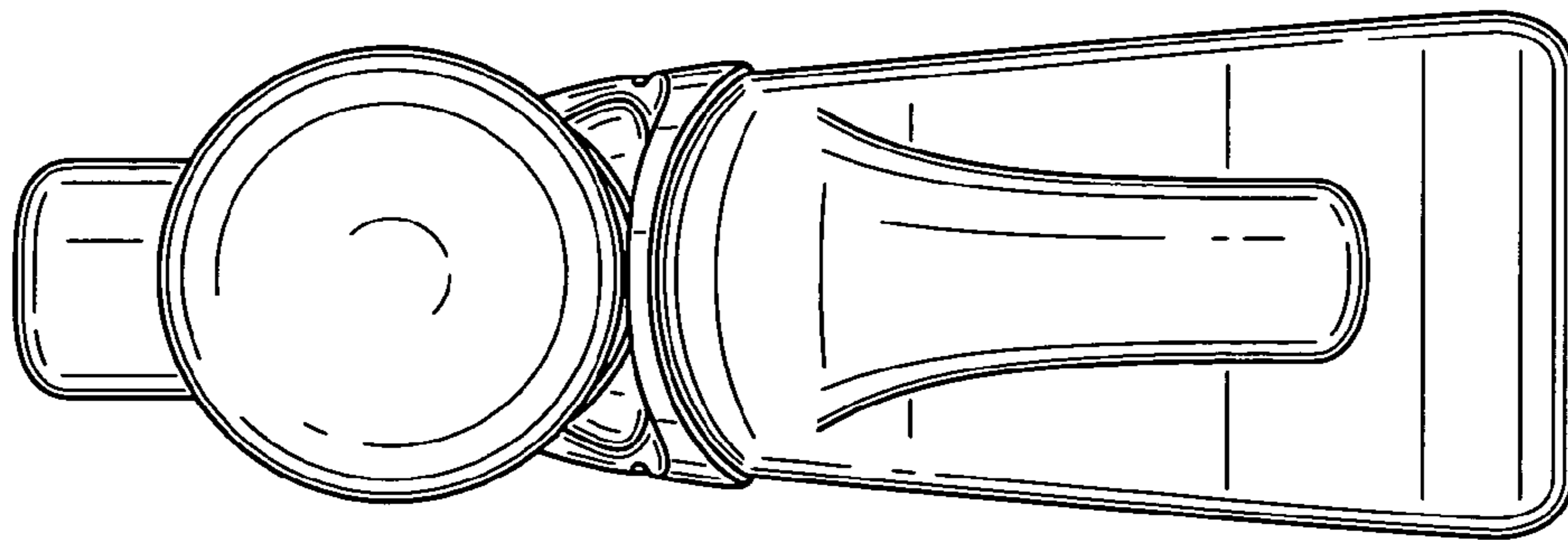

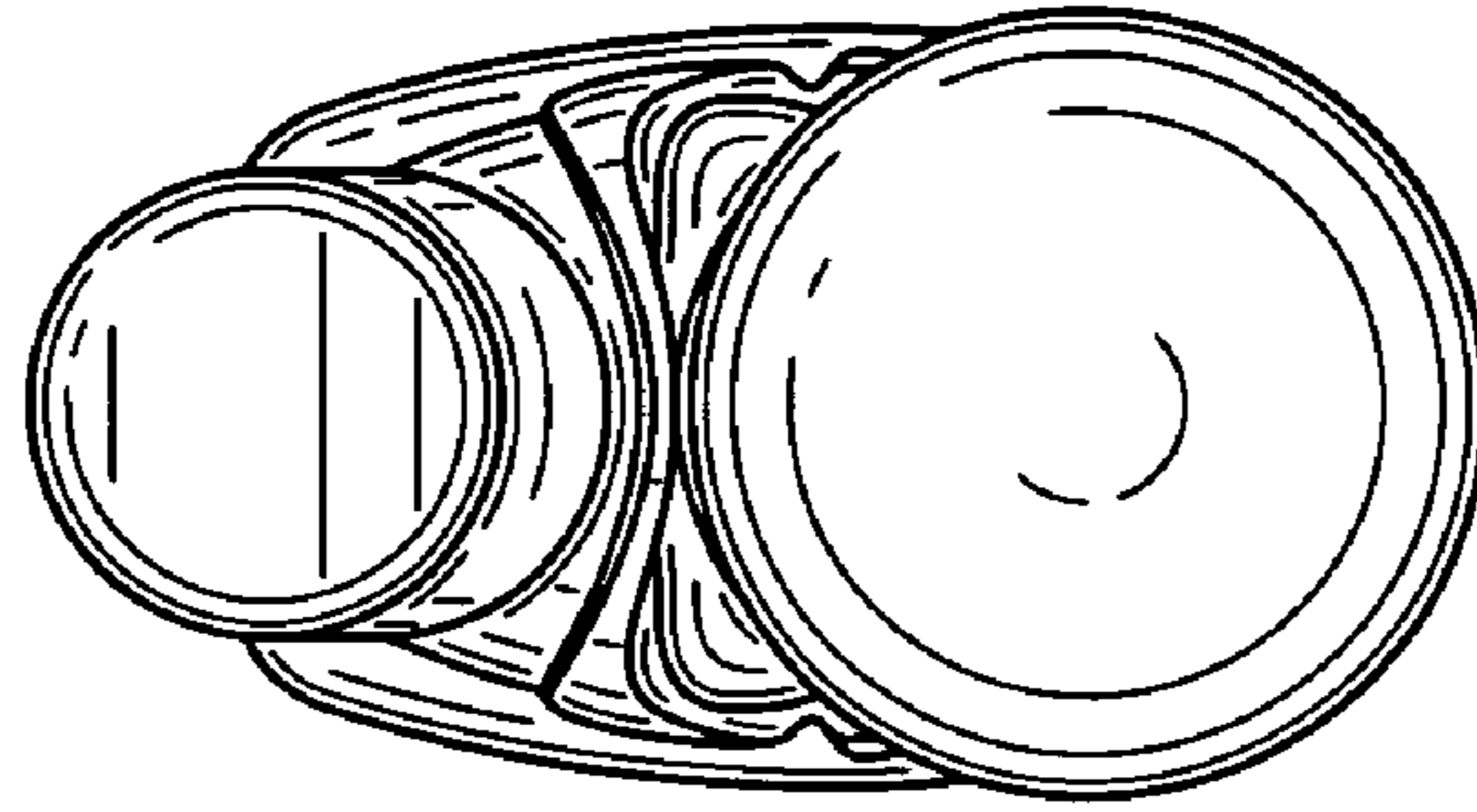

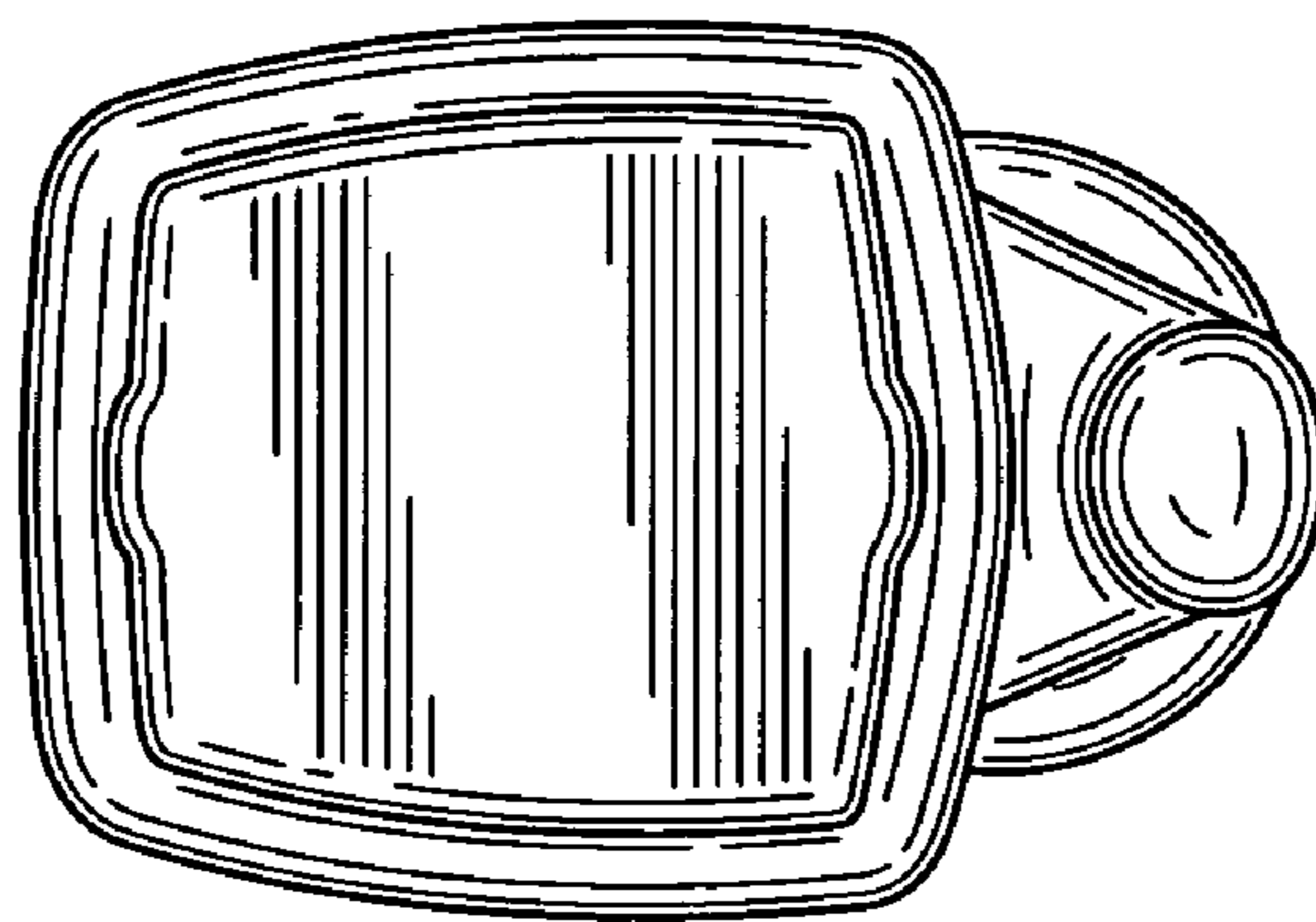

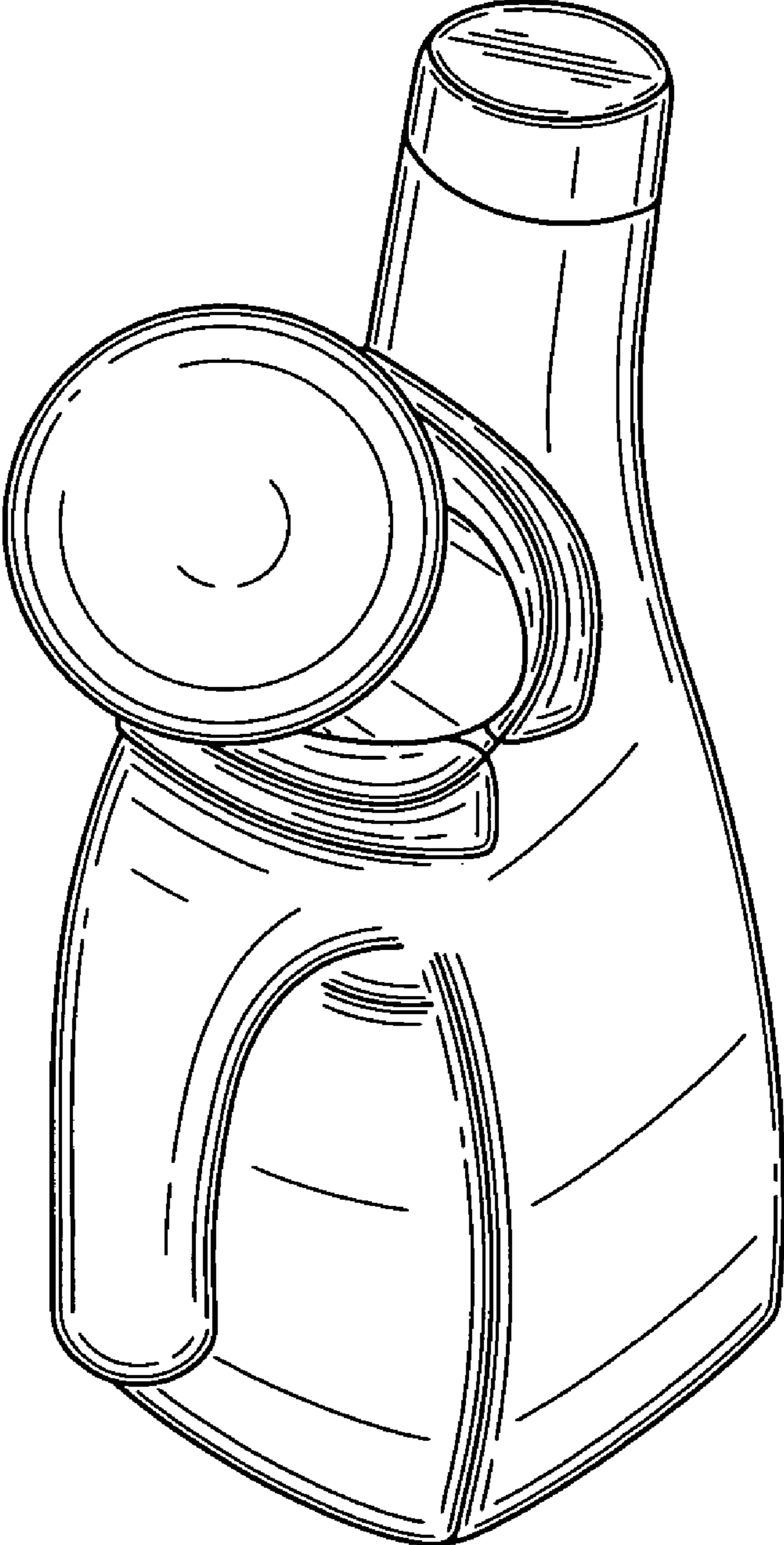

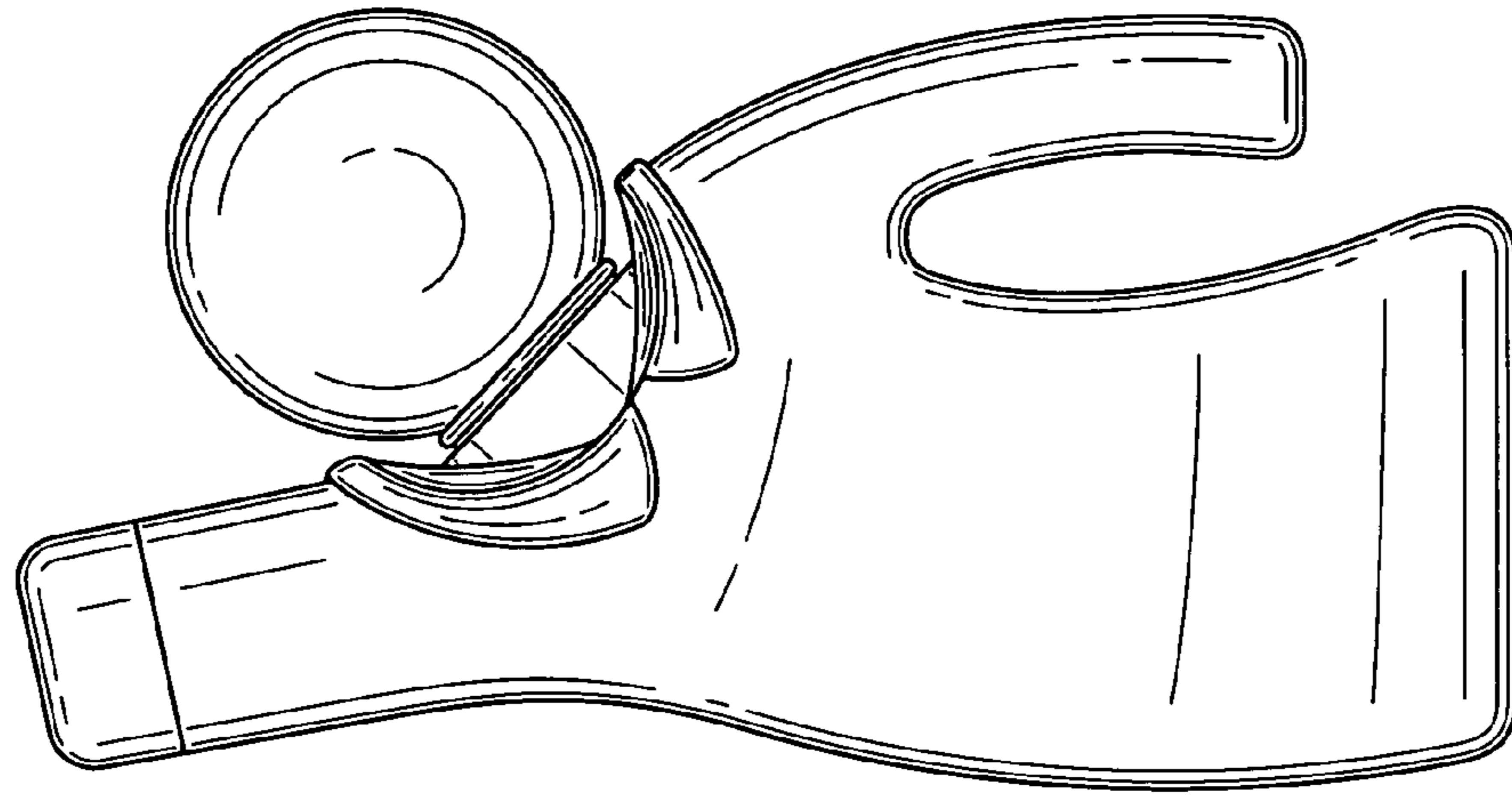

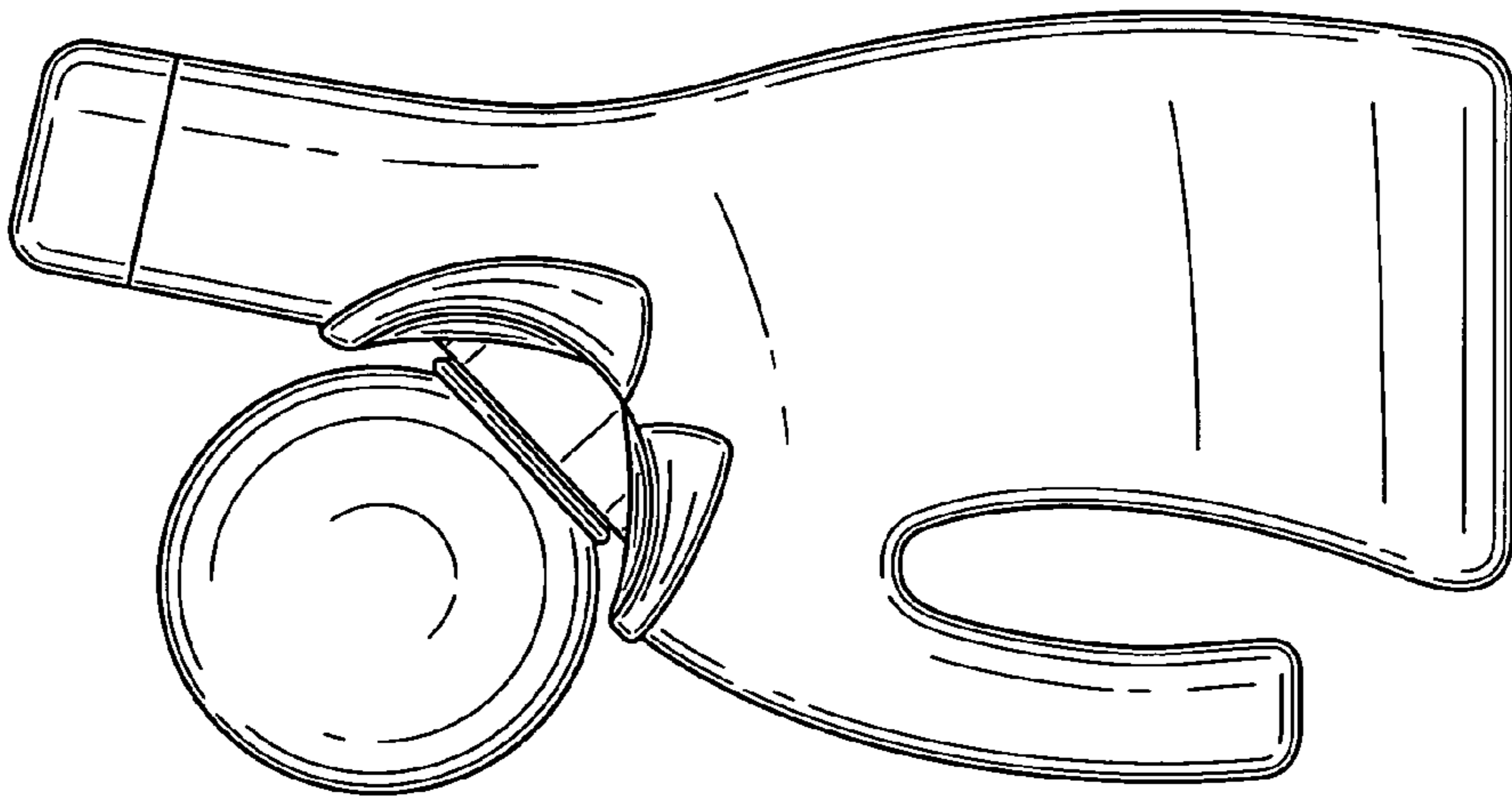

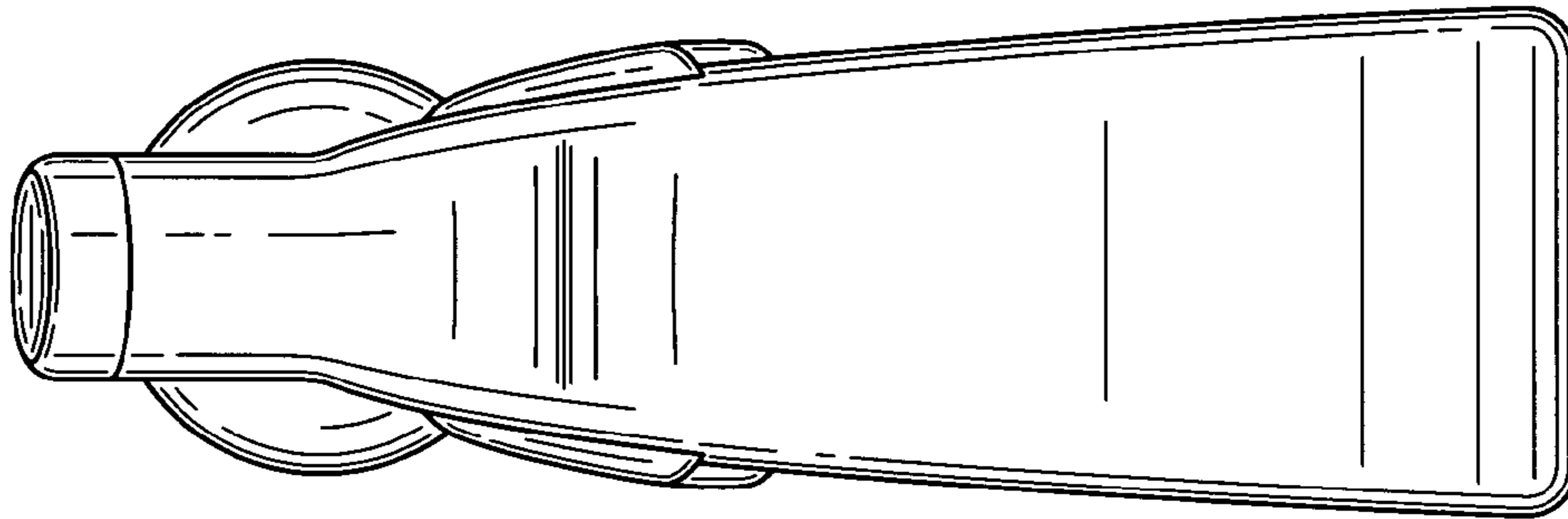

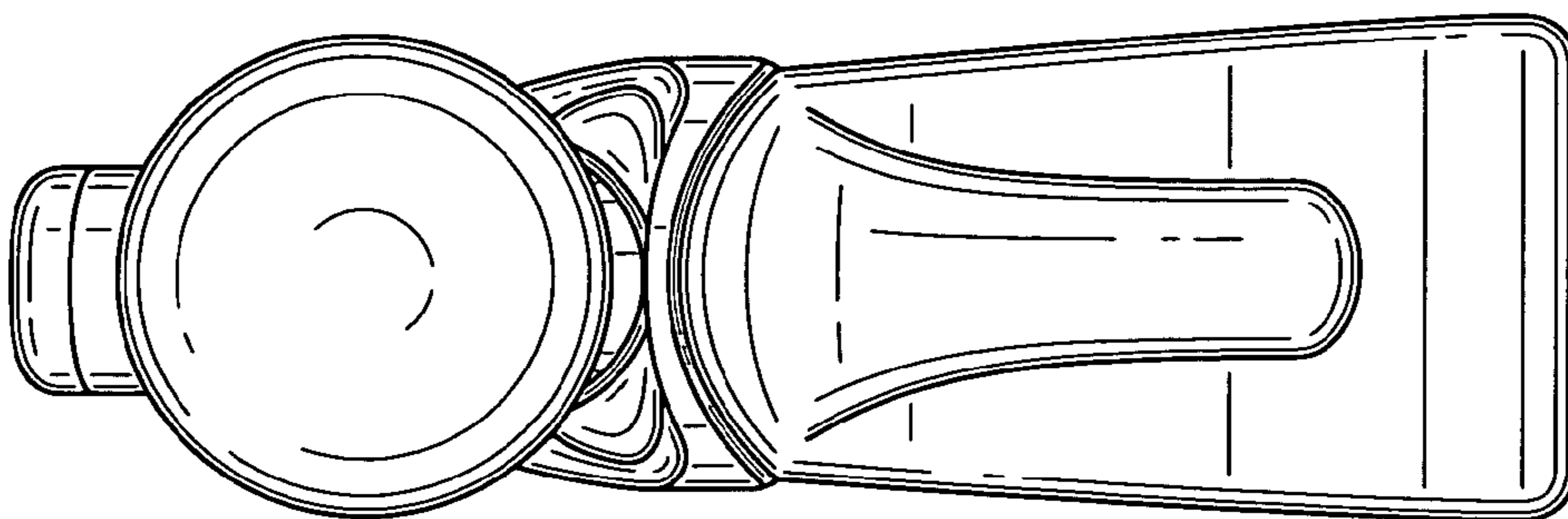

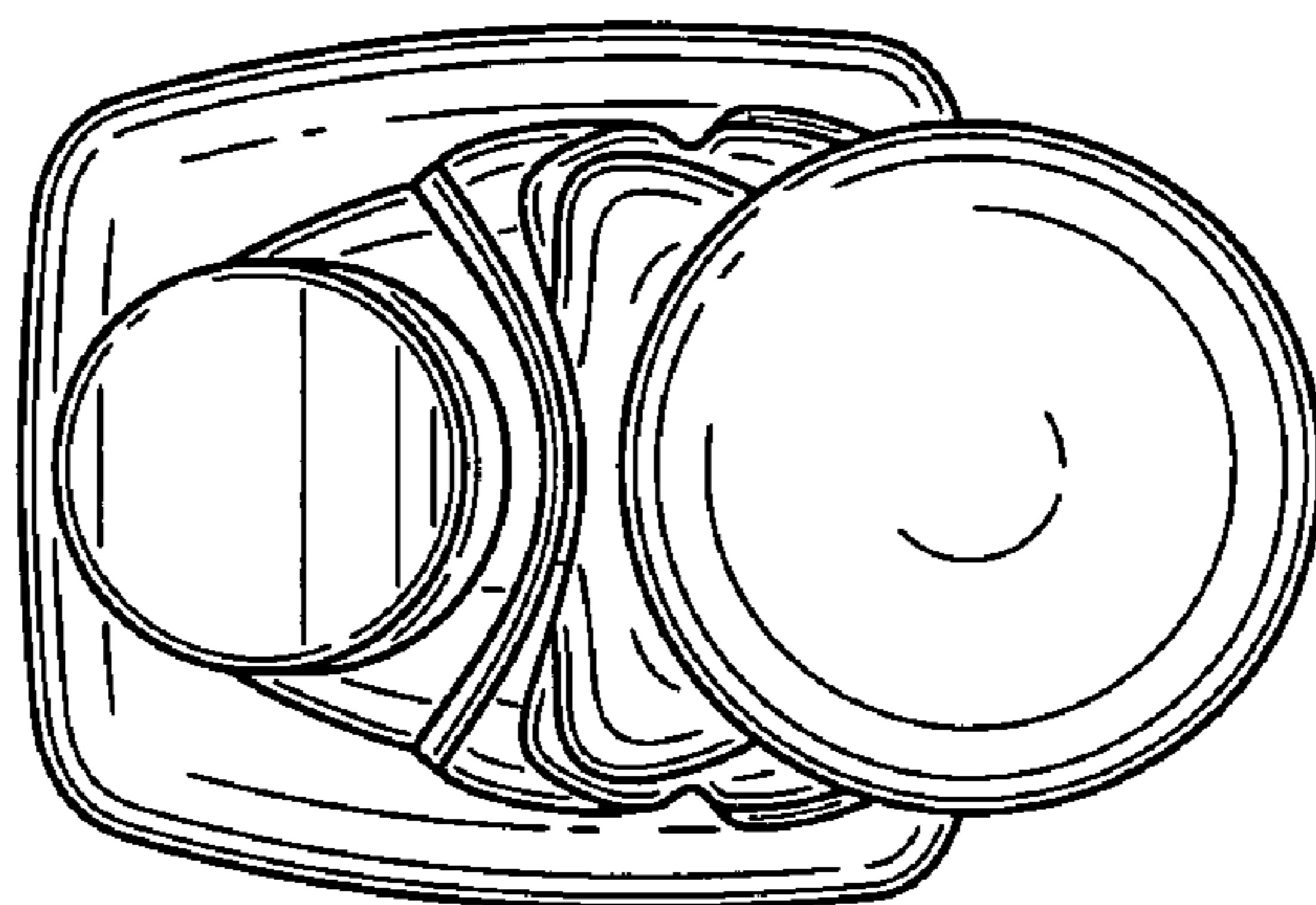

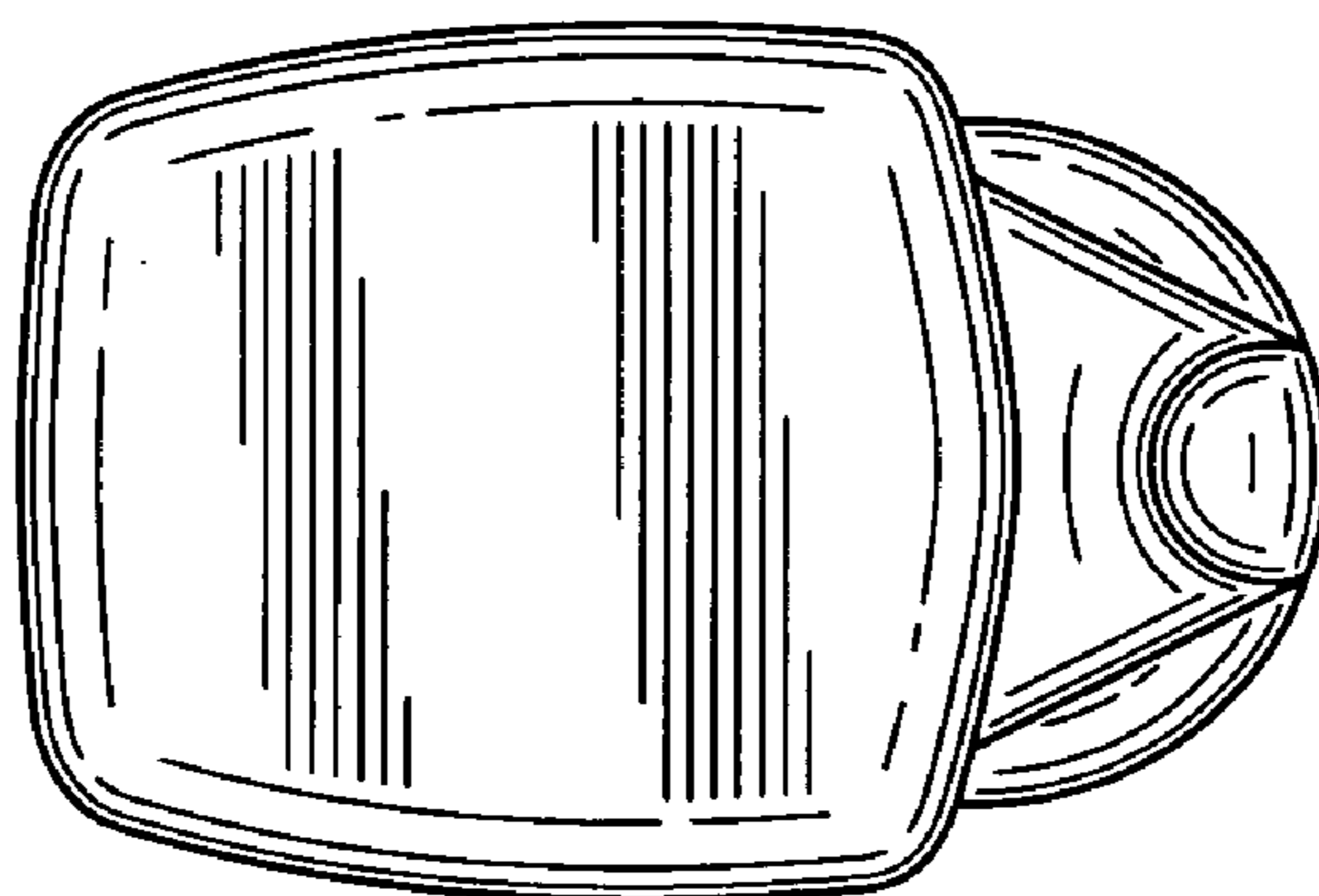
