DESCRIPTION

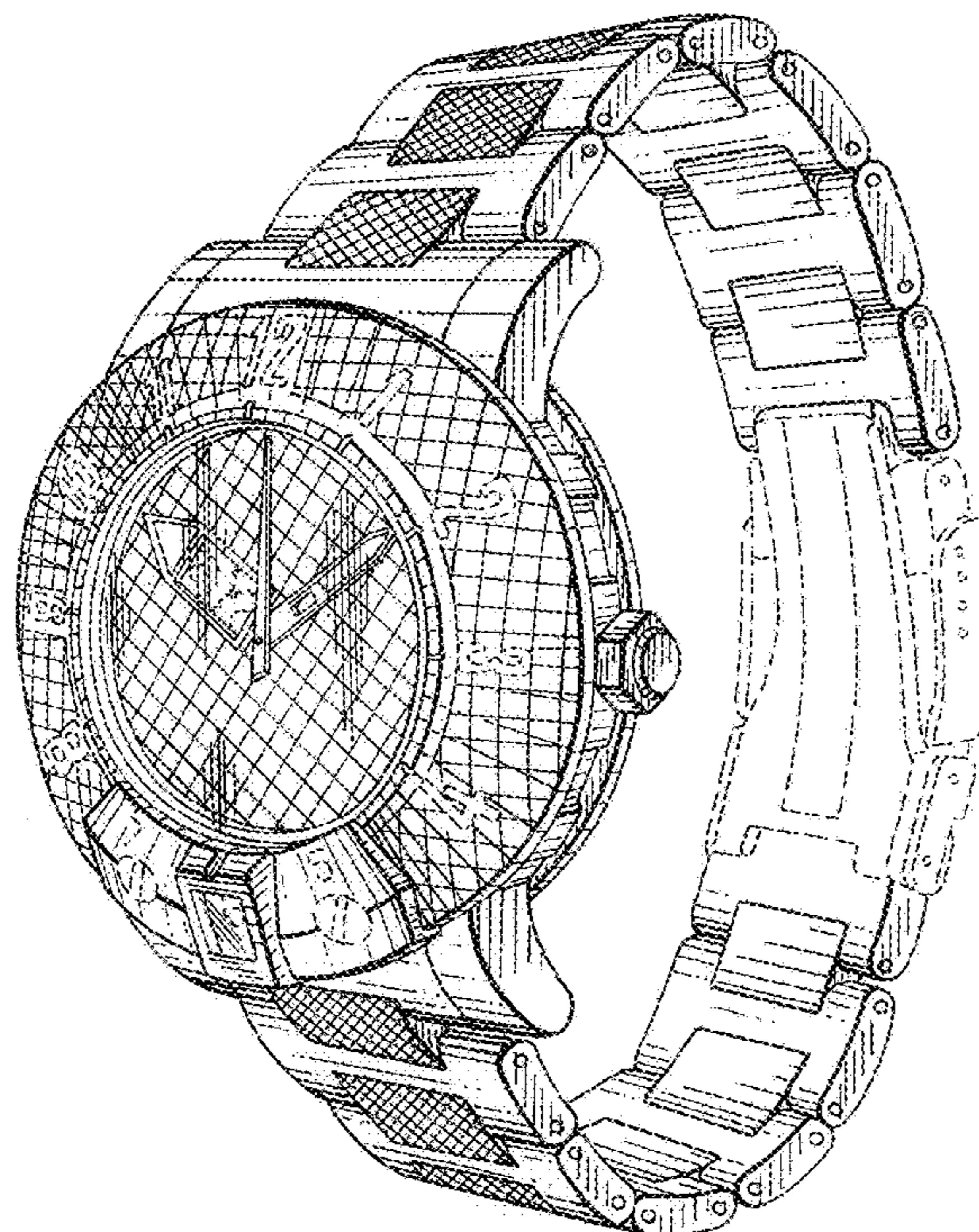
FIG. 1 is a perspective view of a combined watch and band showing my new design;

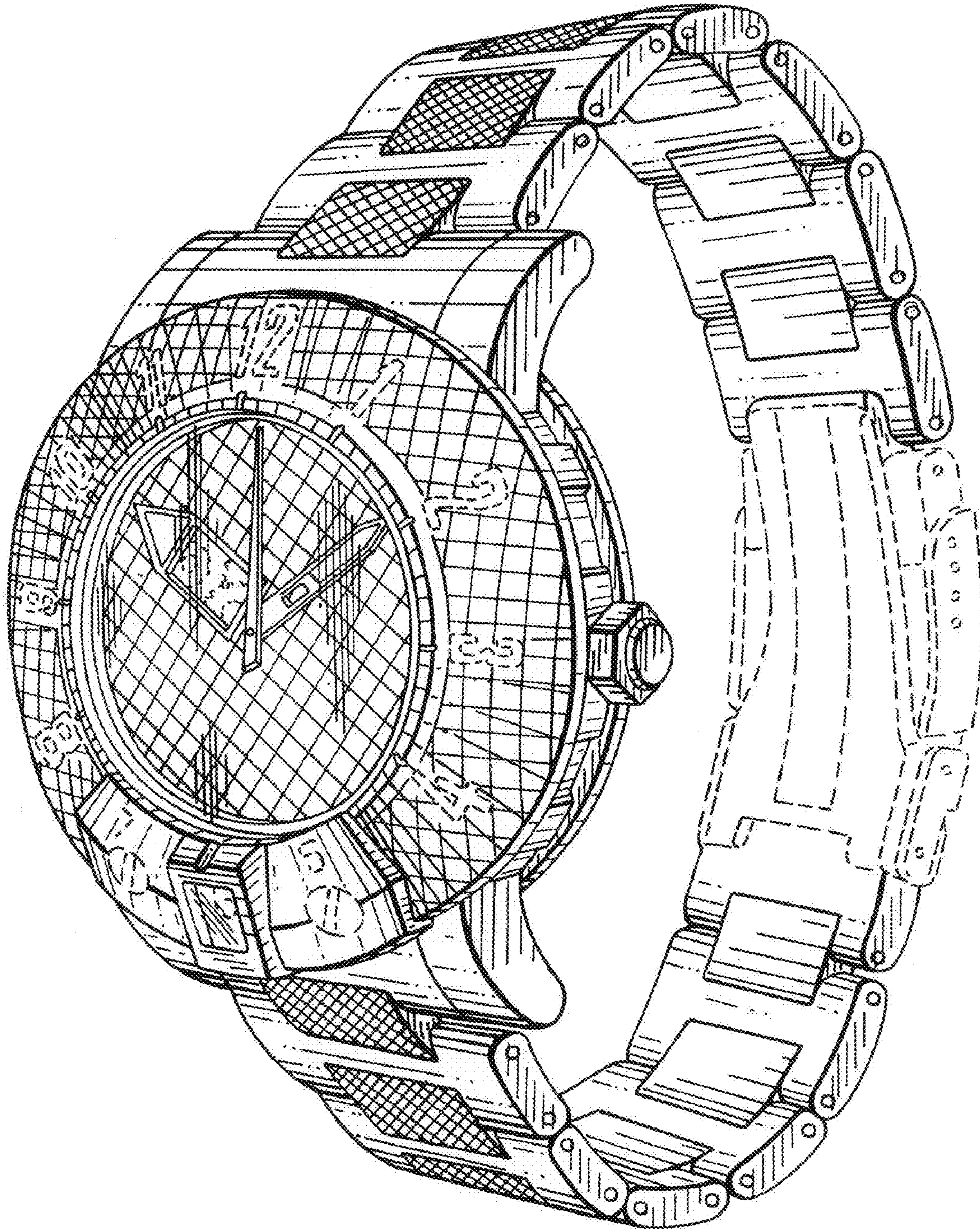

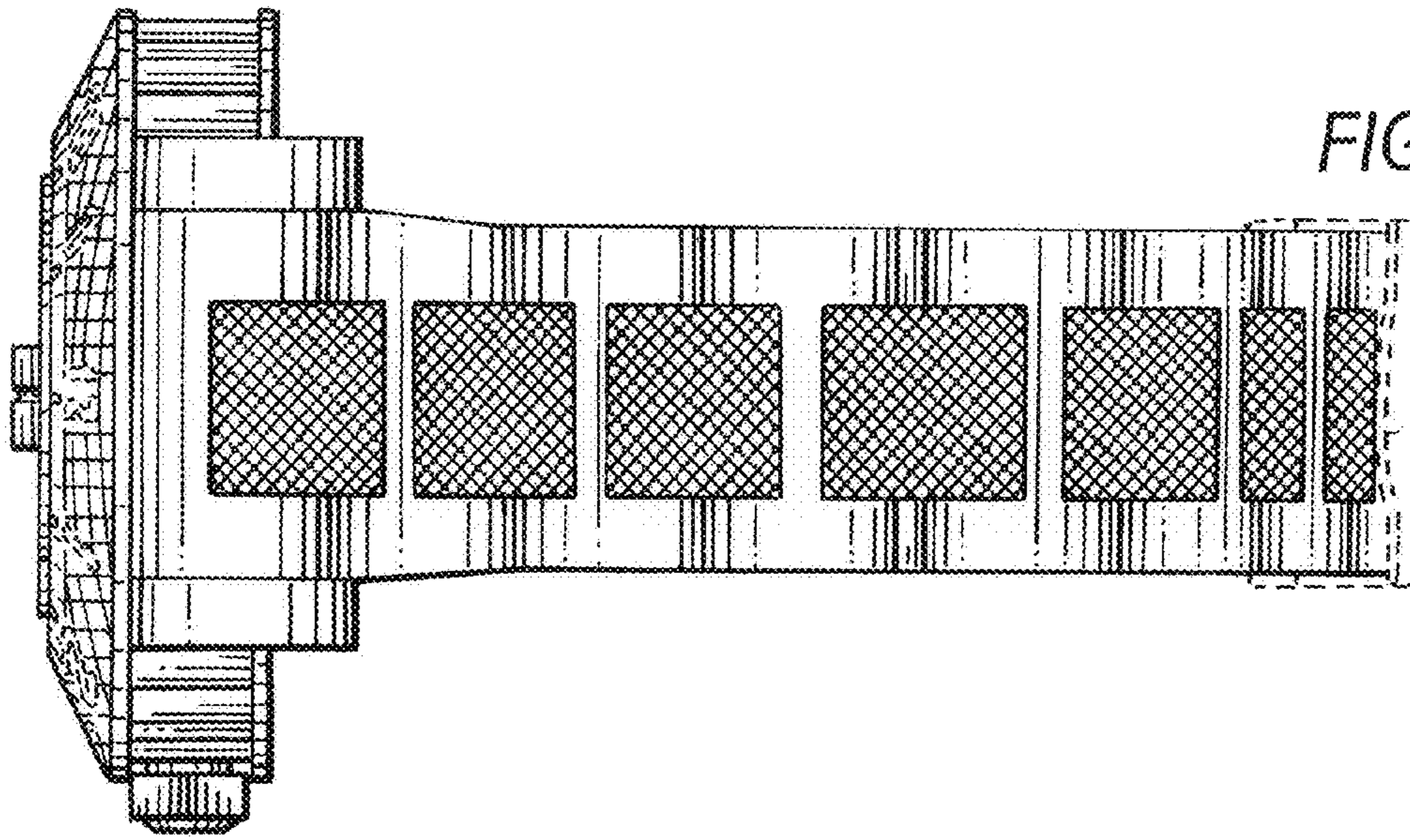

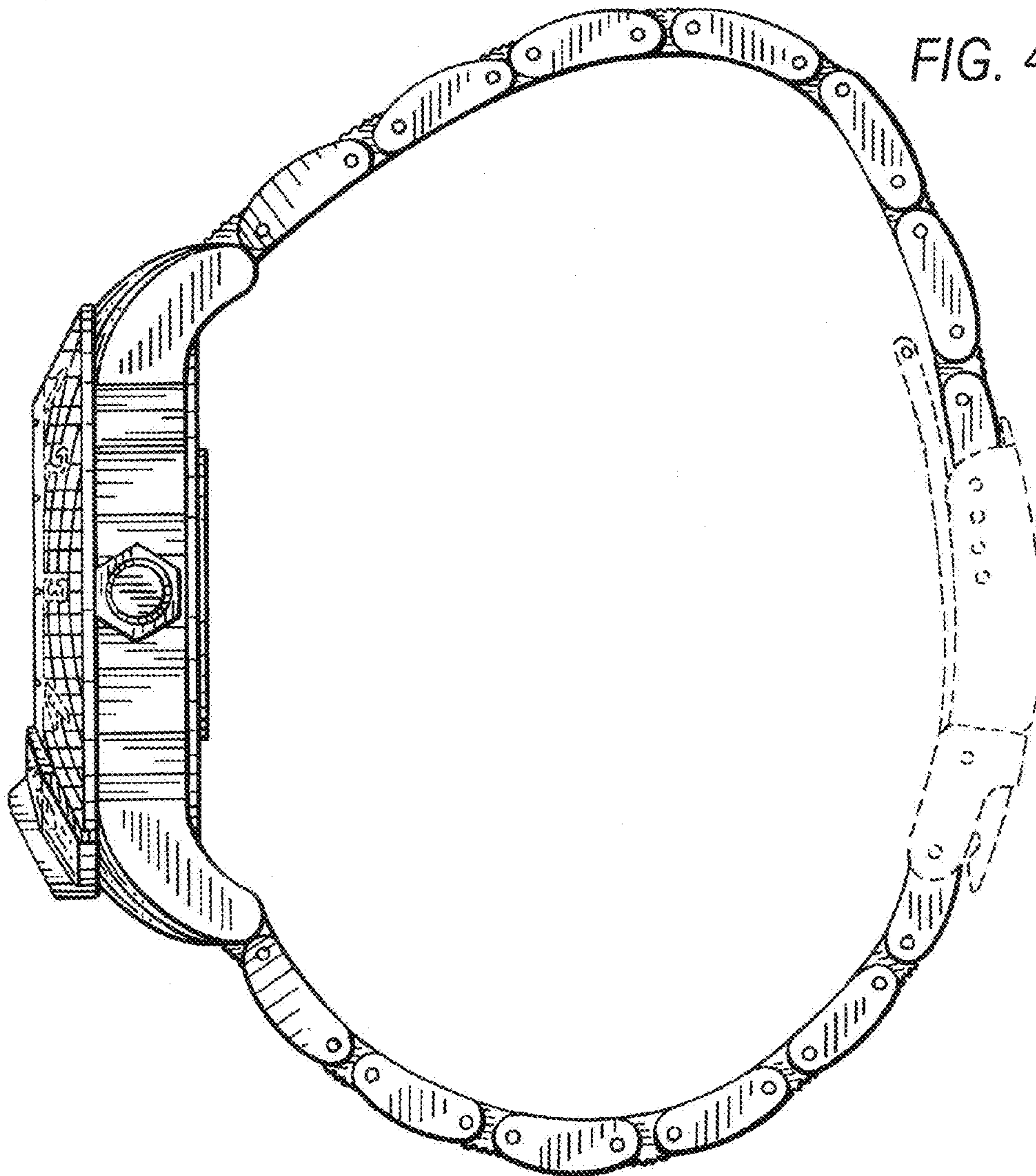

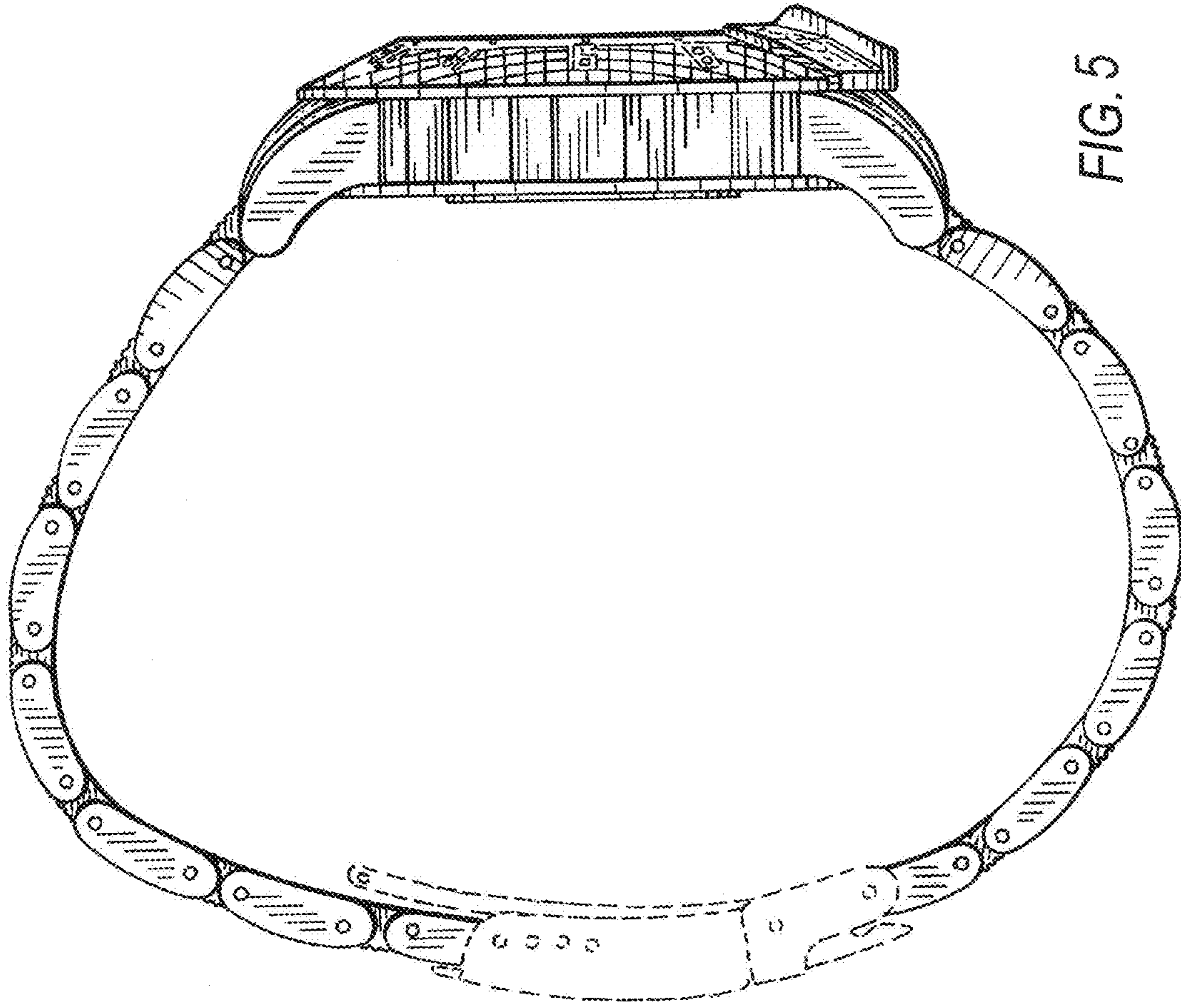

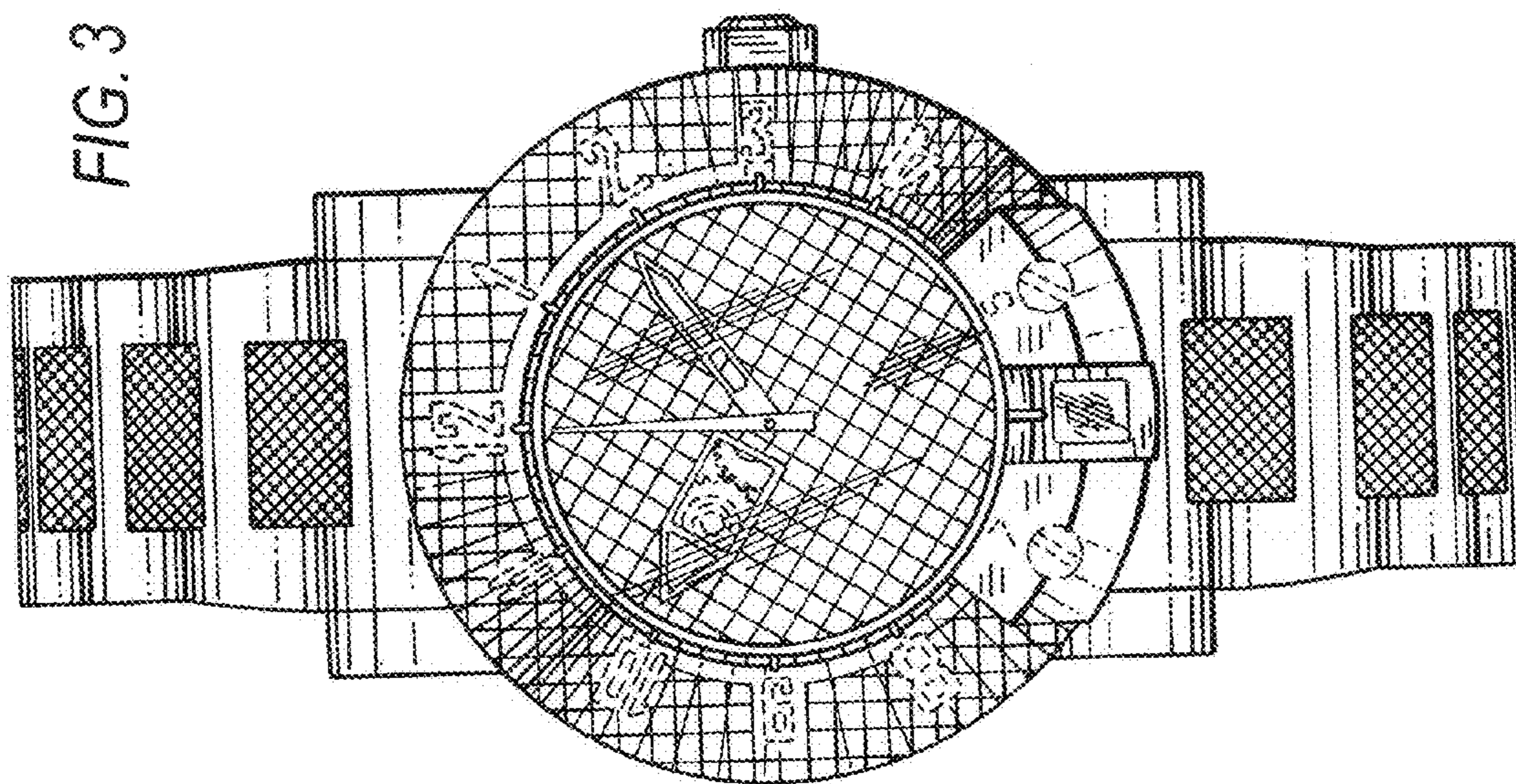

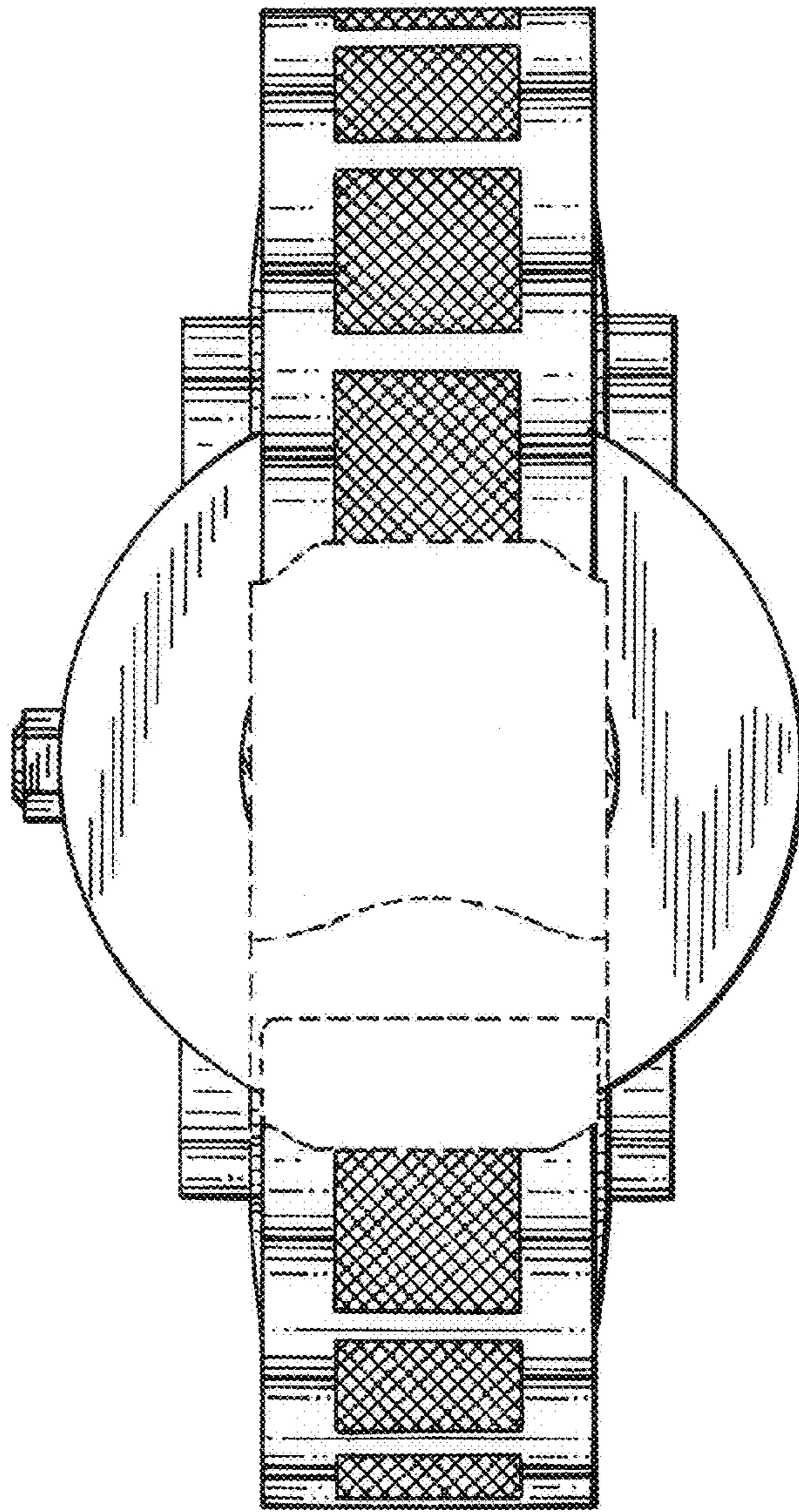

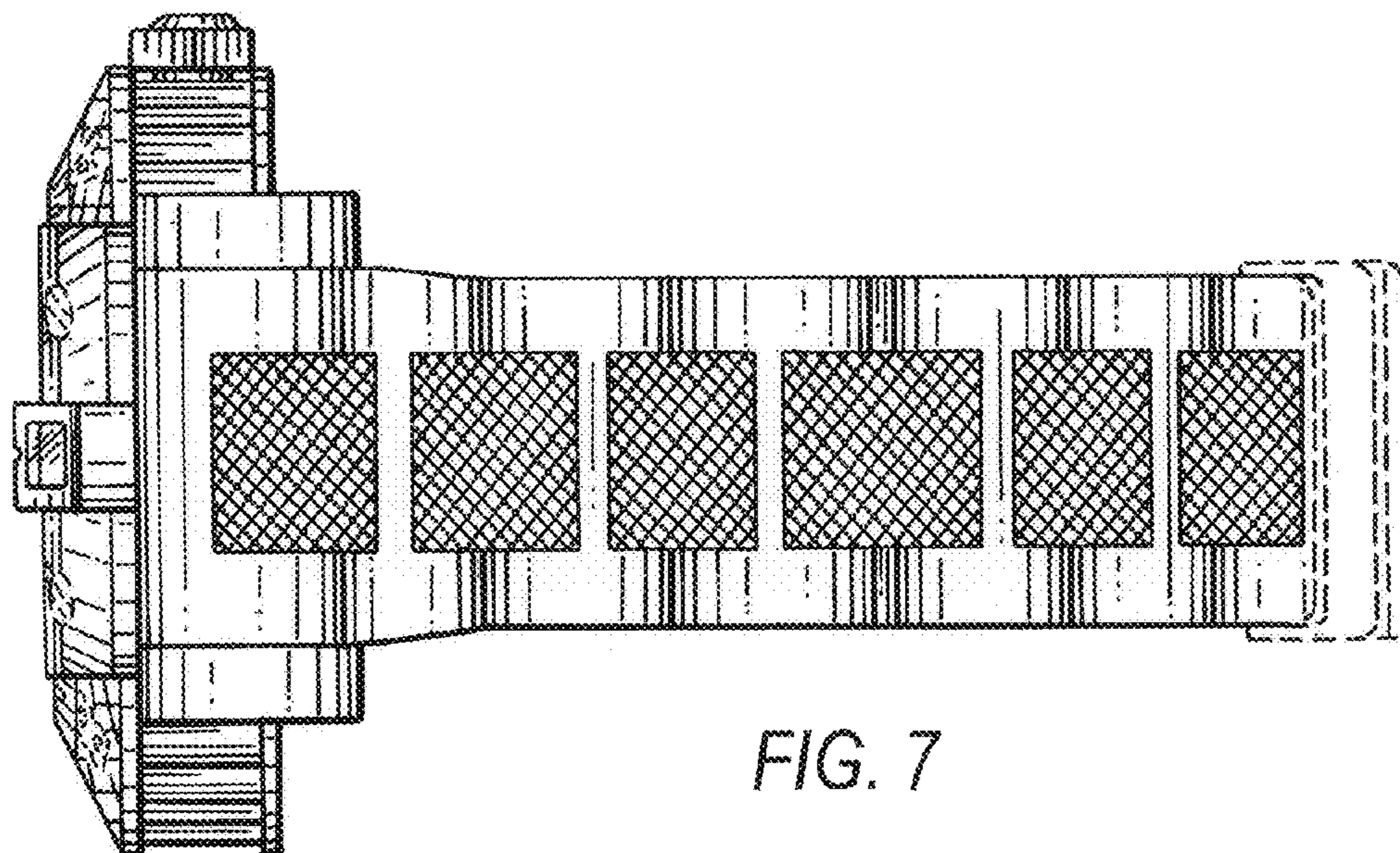
