**DESCRIPTION**

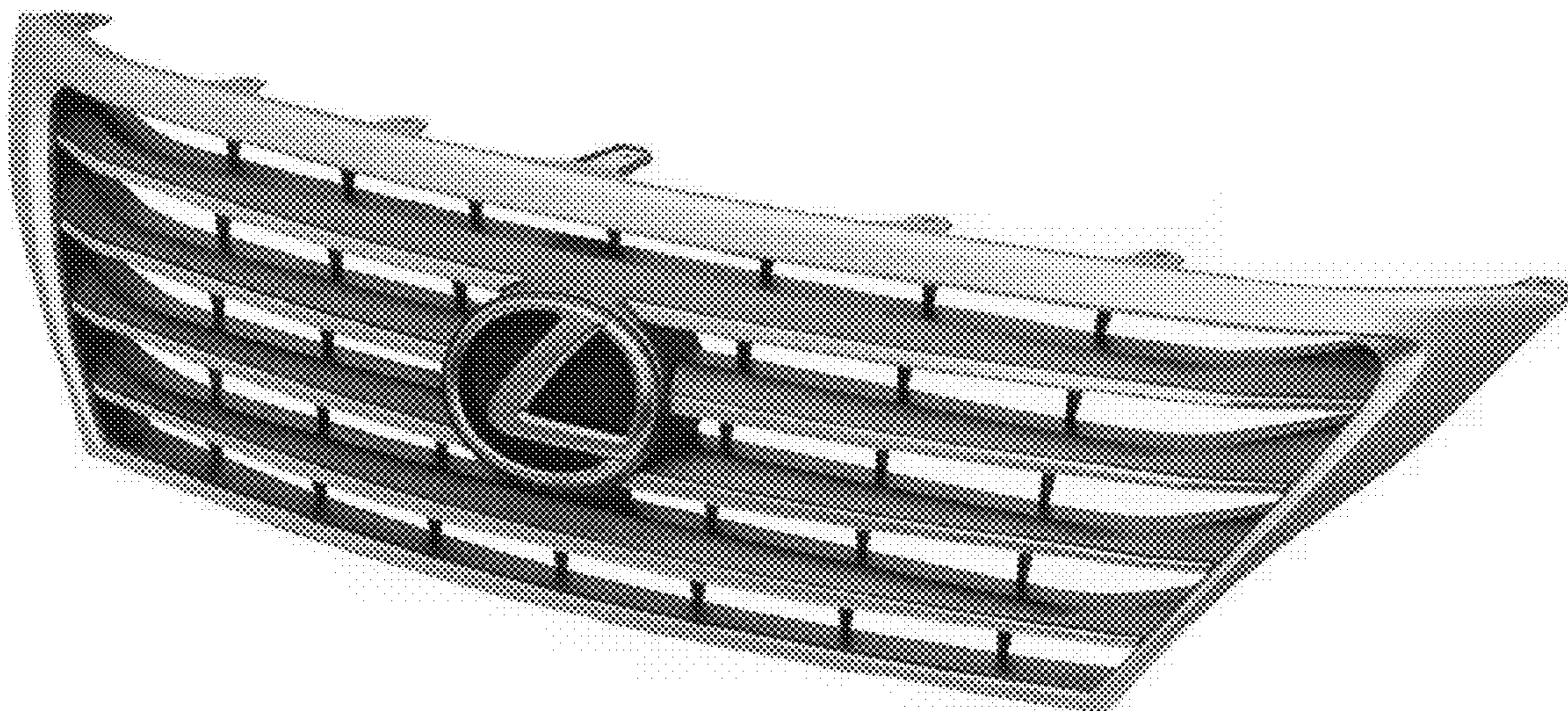
FIG. 1 is a front perspective view of a front grille for an automobile showing our new design;

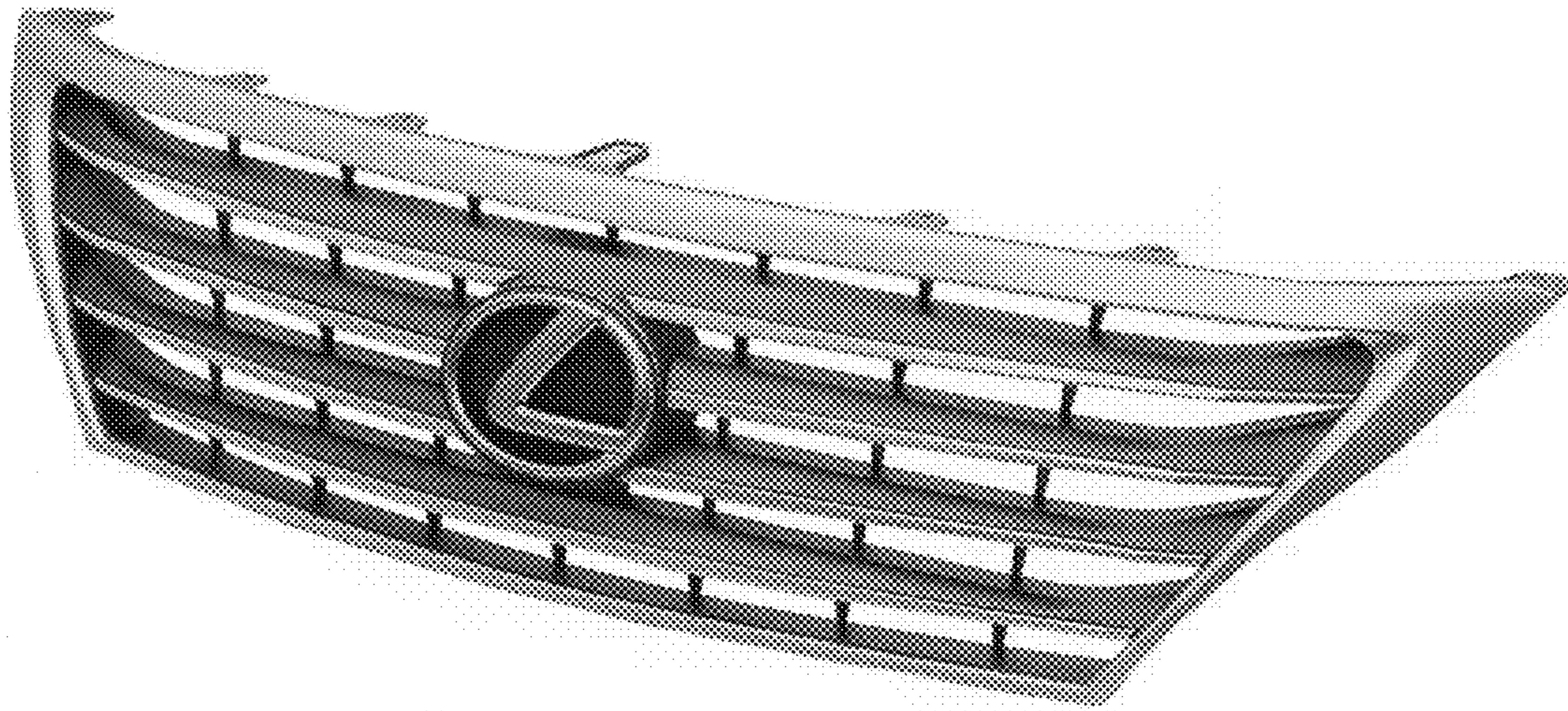

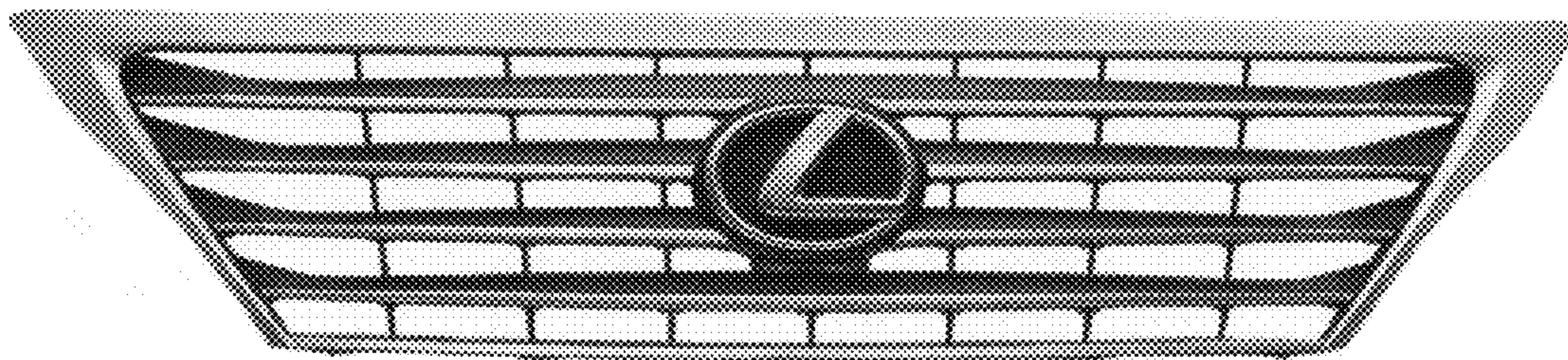

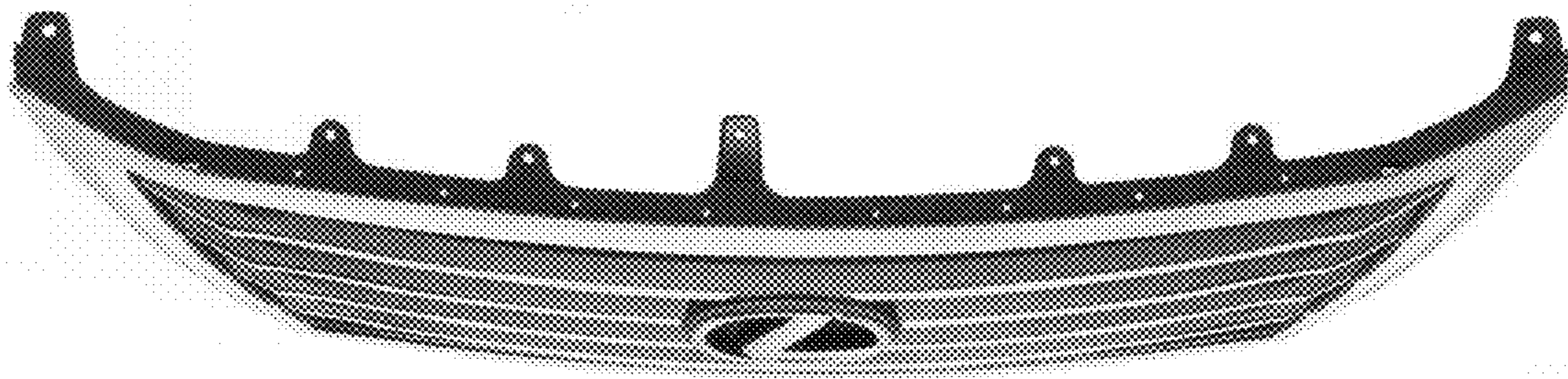

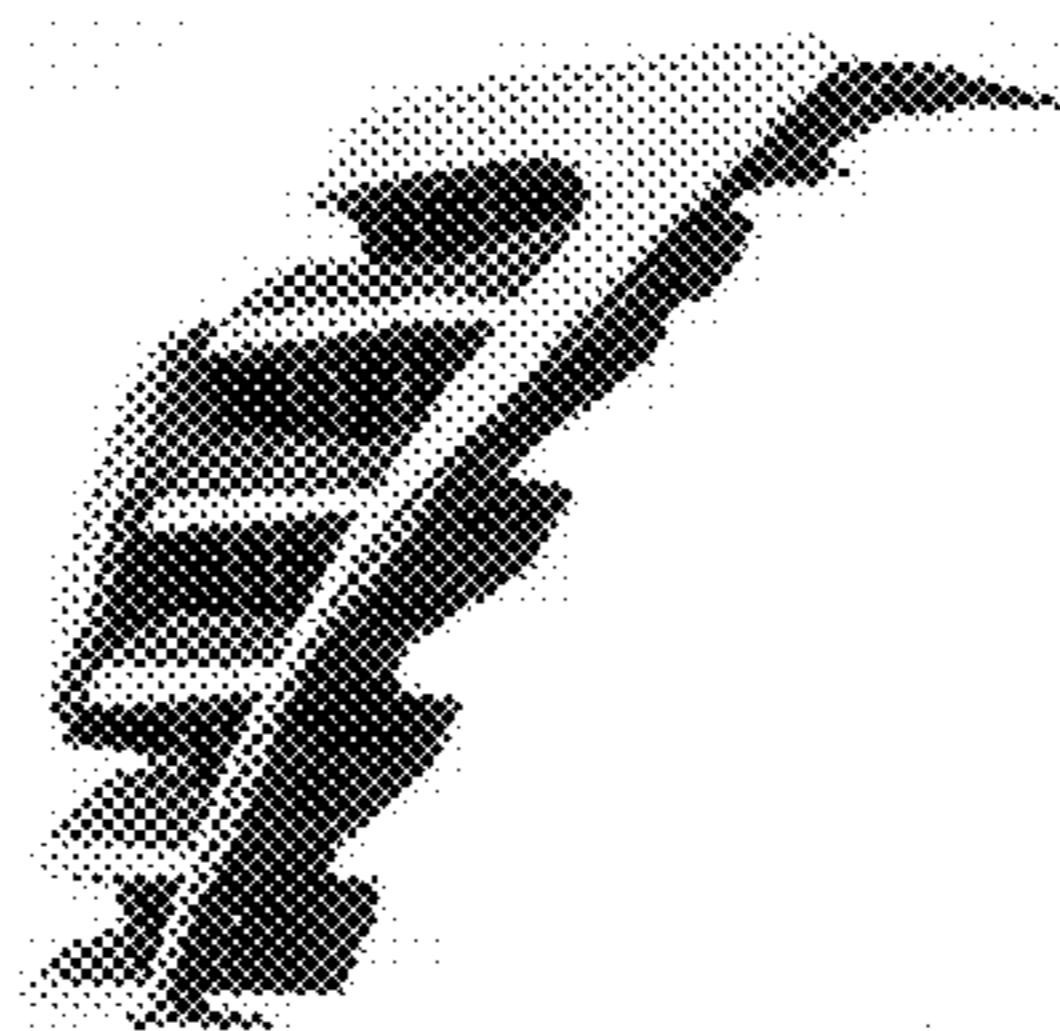
