FIG. 9 is a front view of the handset of FIGS. 1-8 in an in-use open position;

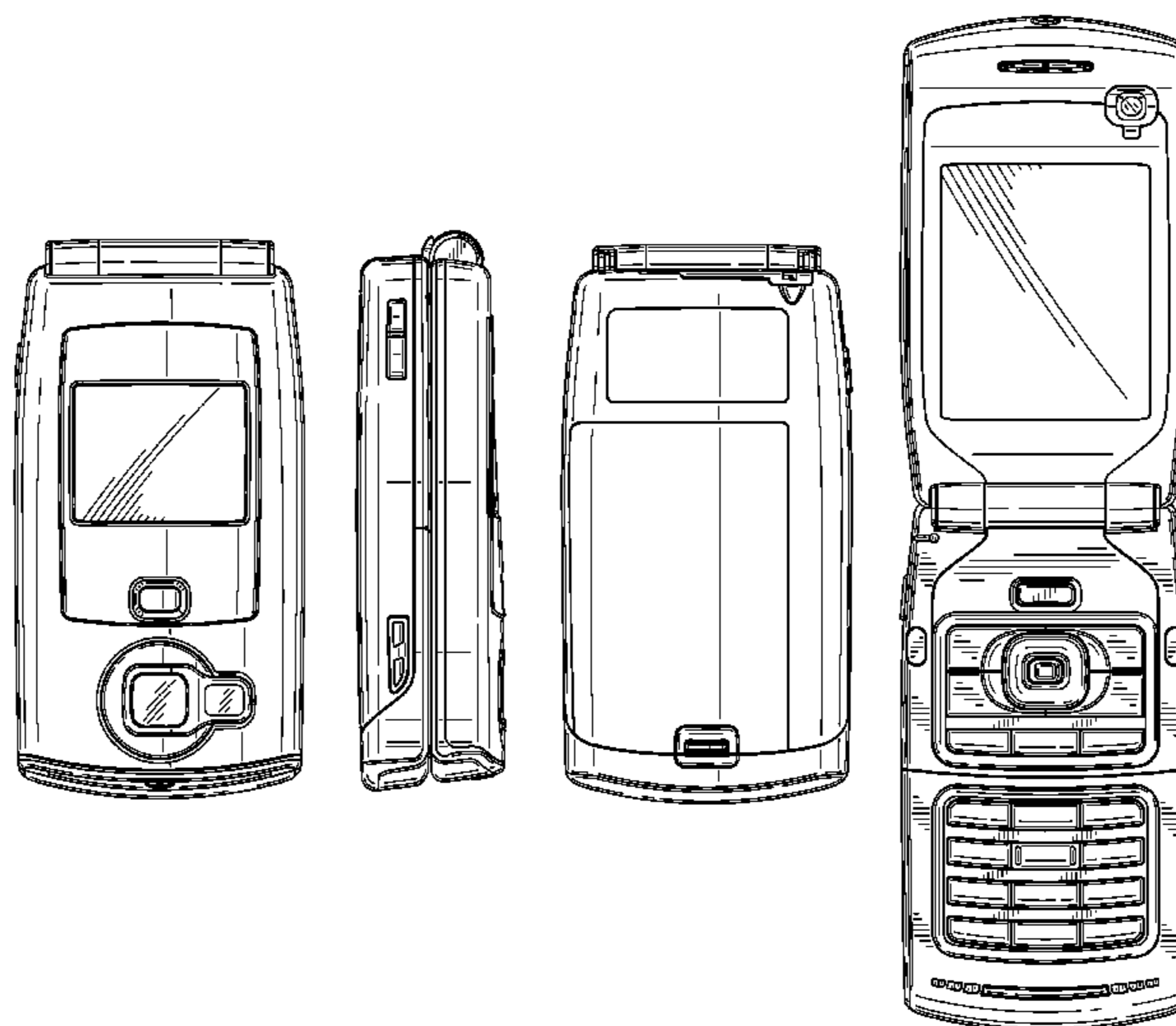
FIG. 10 is a perspective front view of the handset of FIGS. 1-8 in an in-use open position;

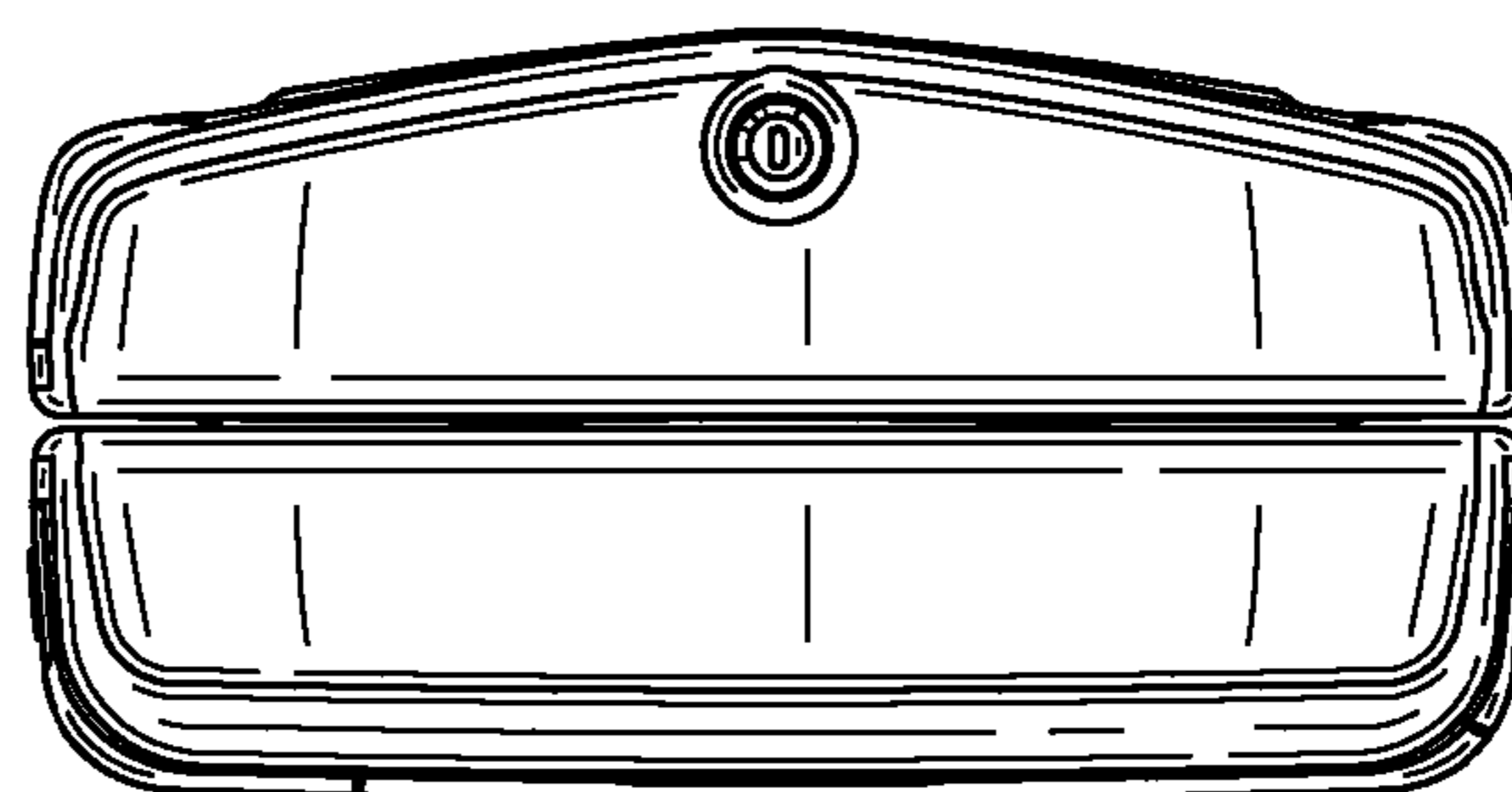

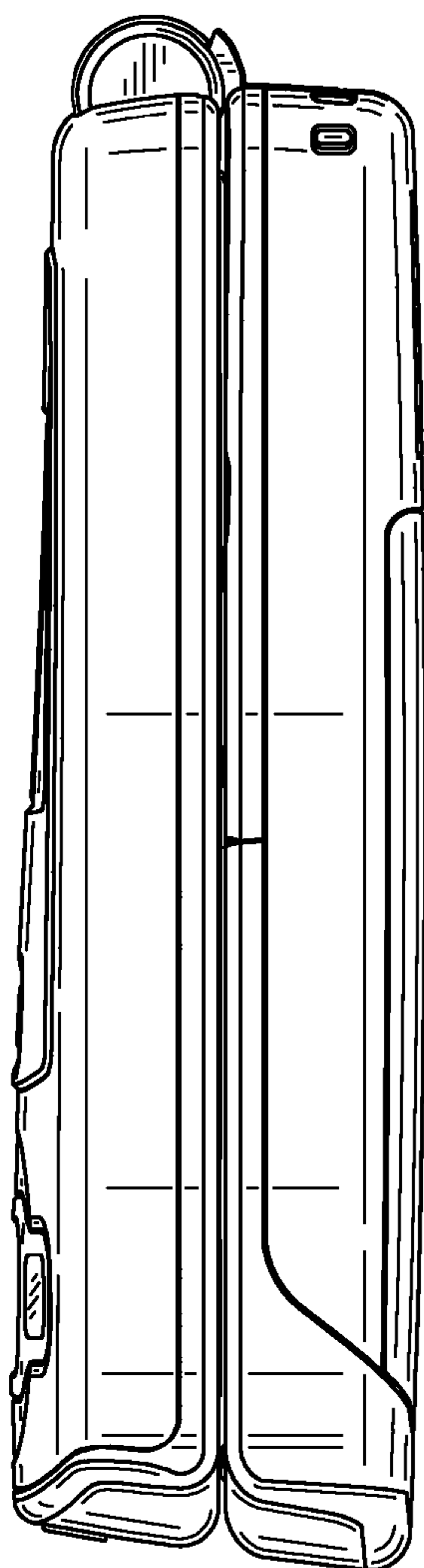

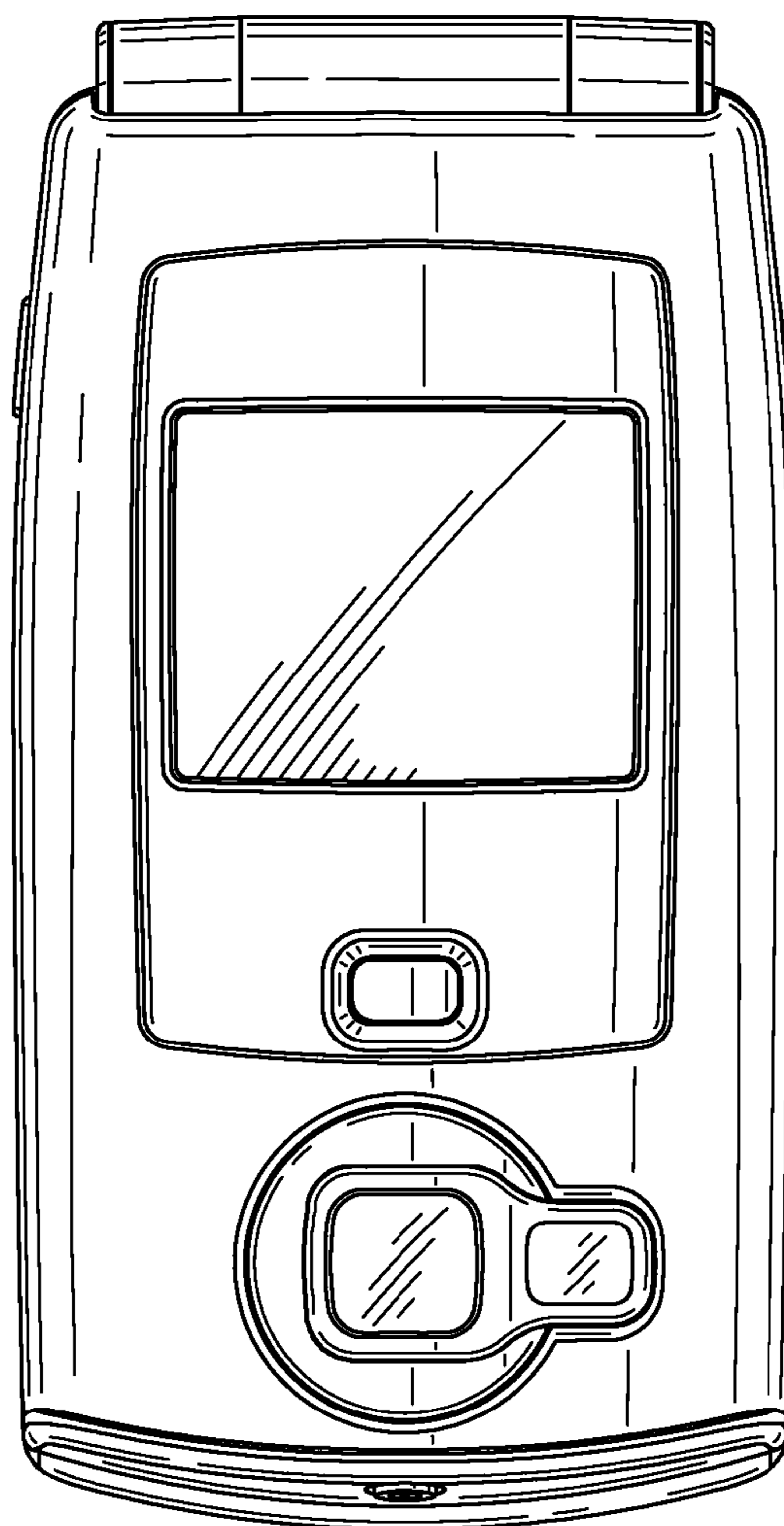

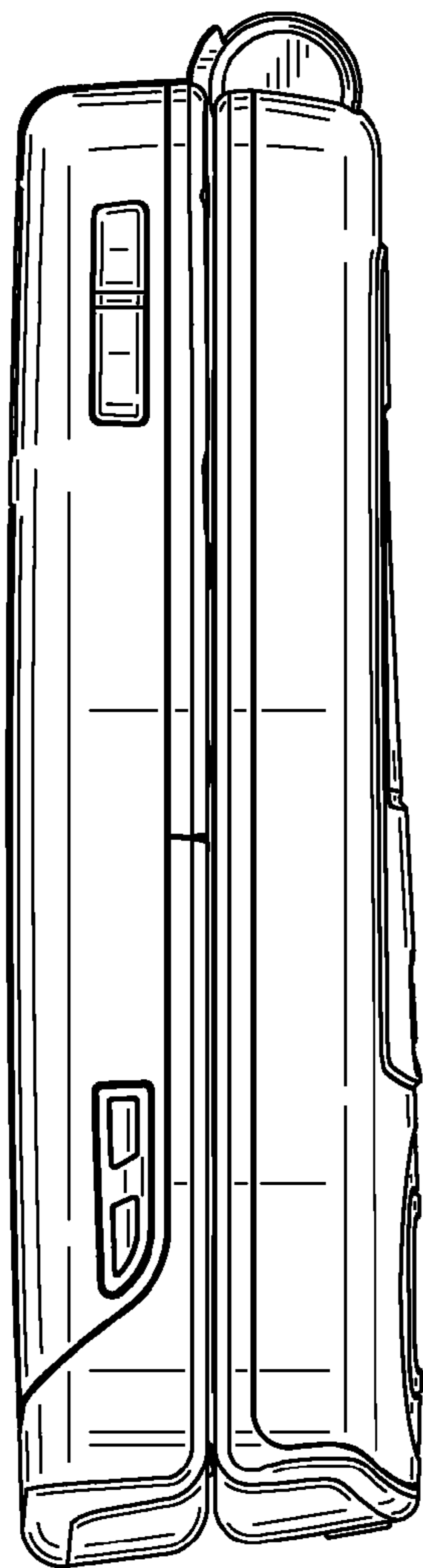

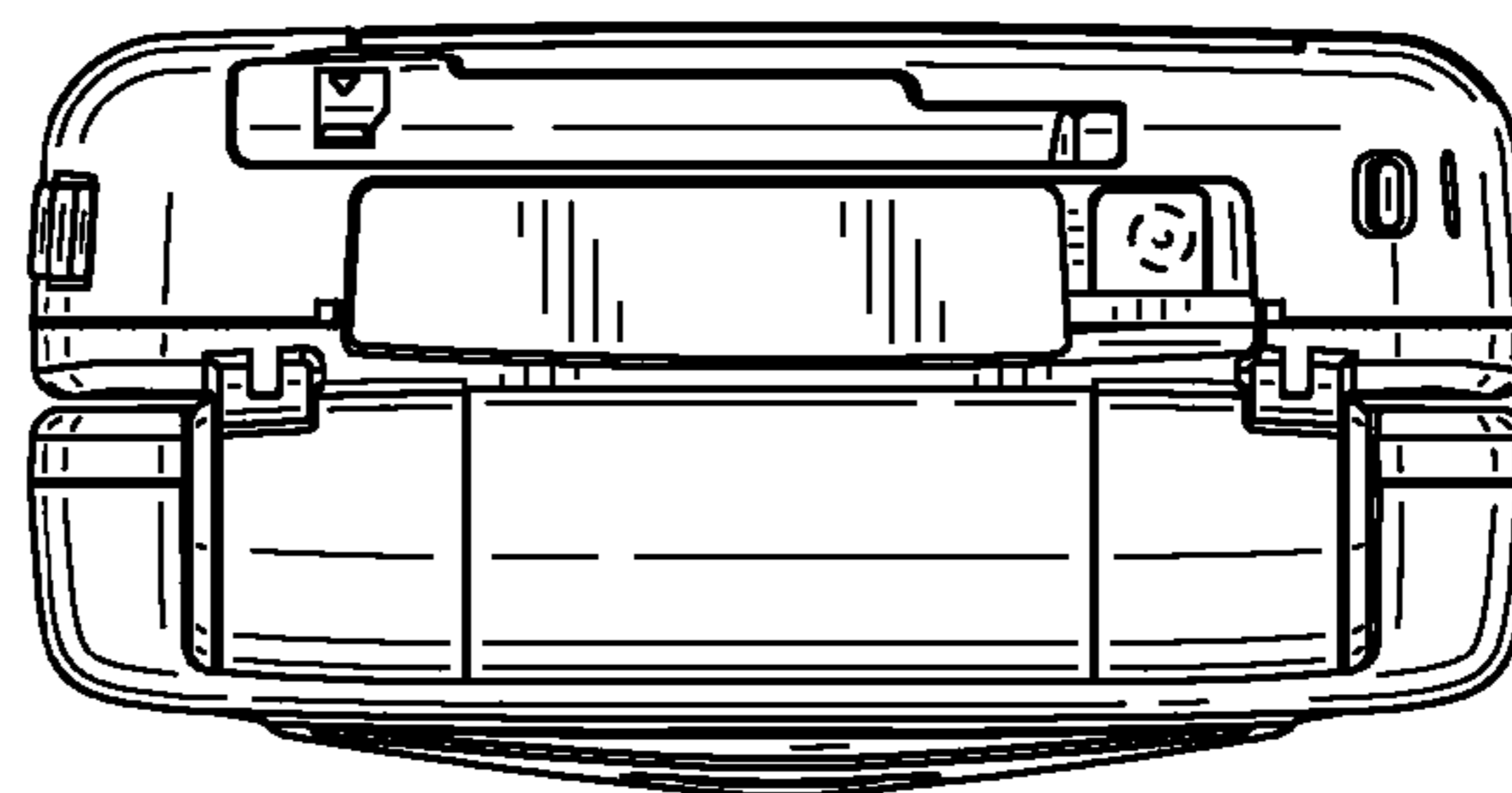

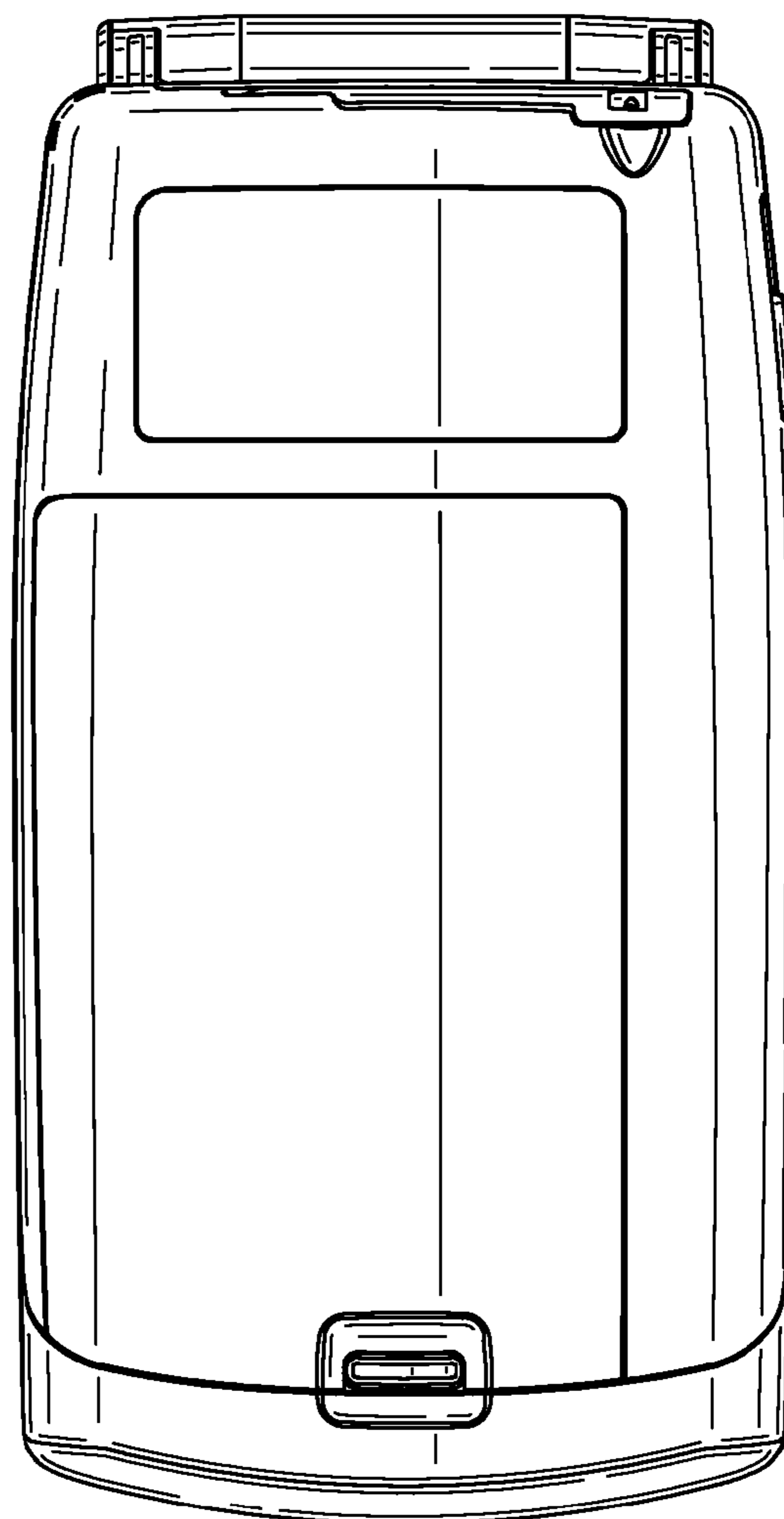

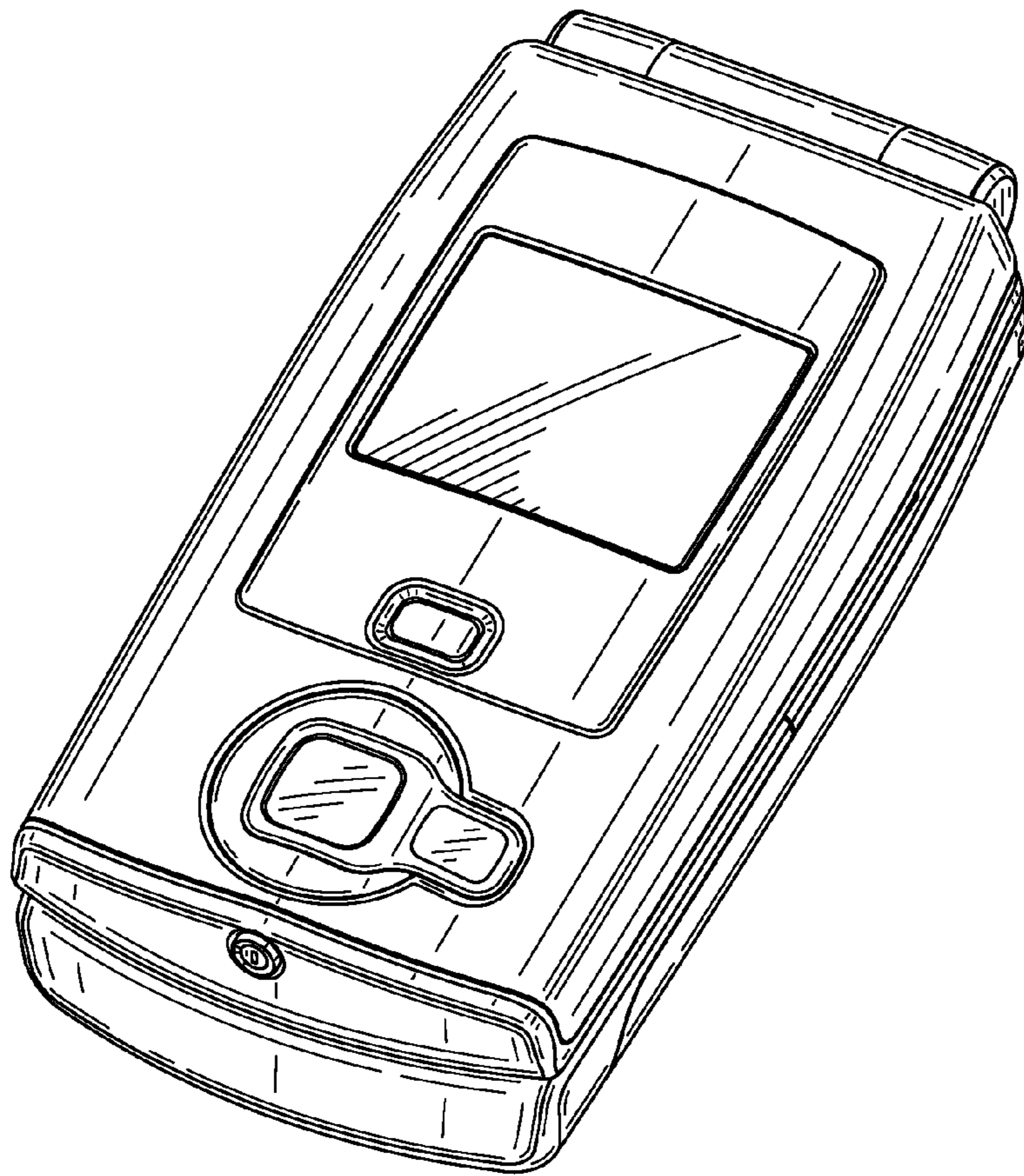

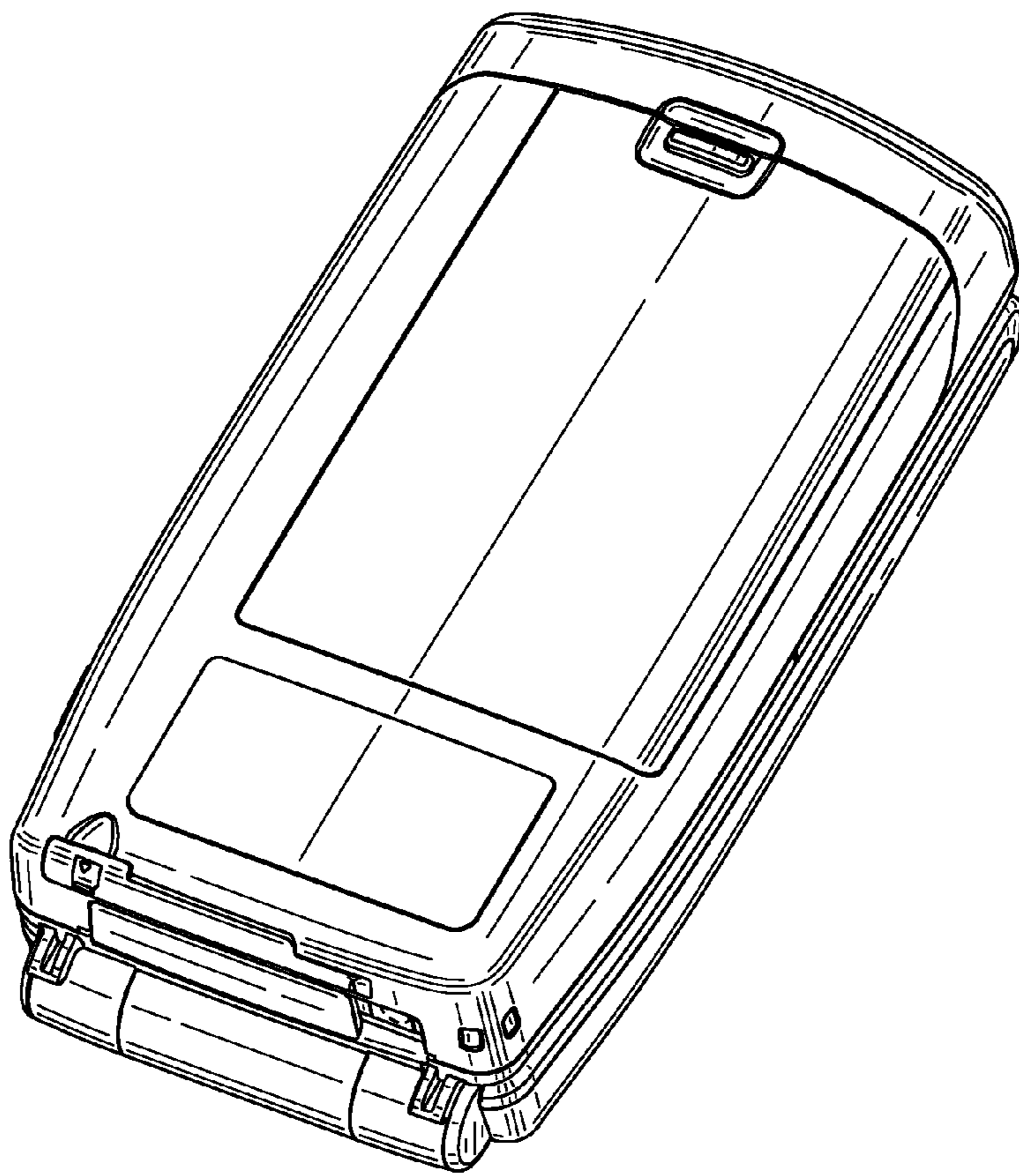

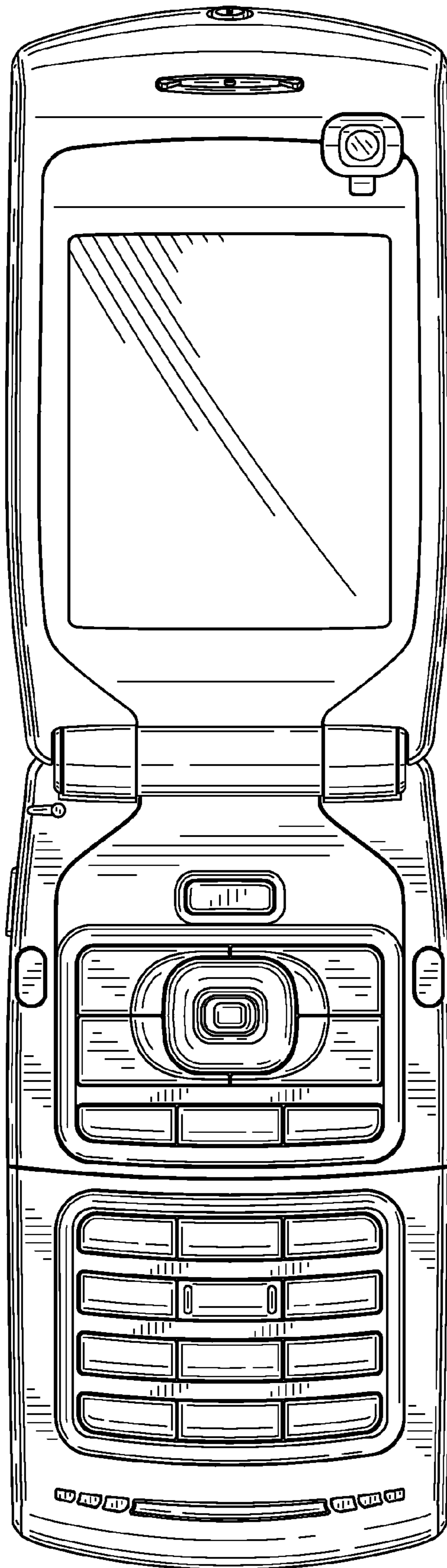

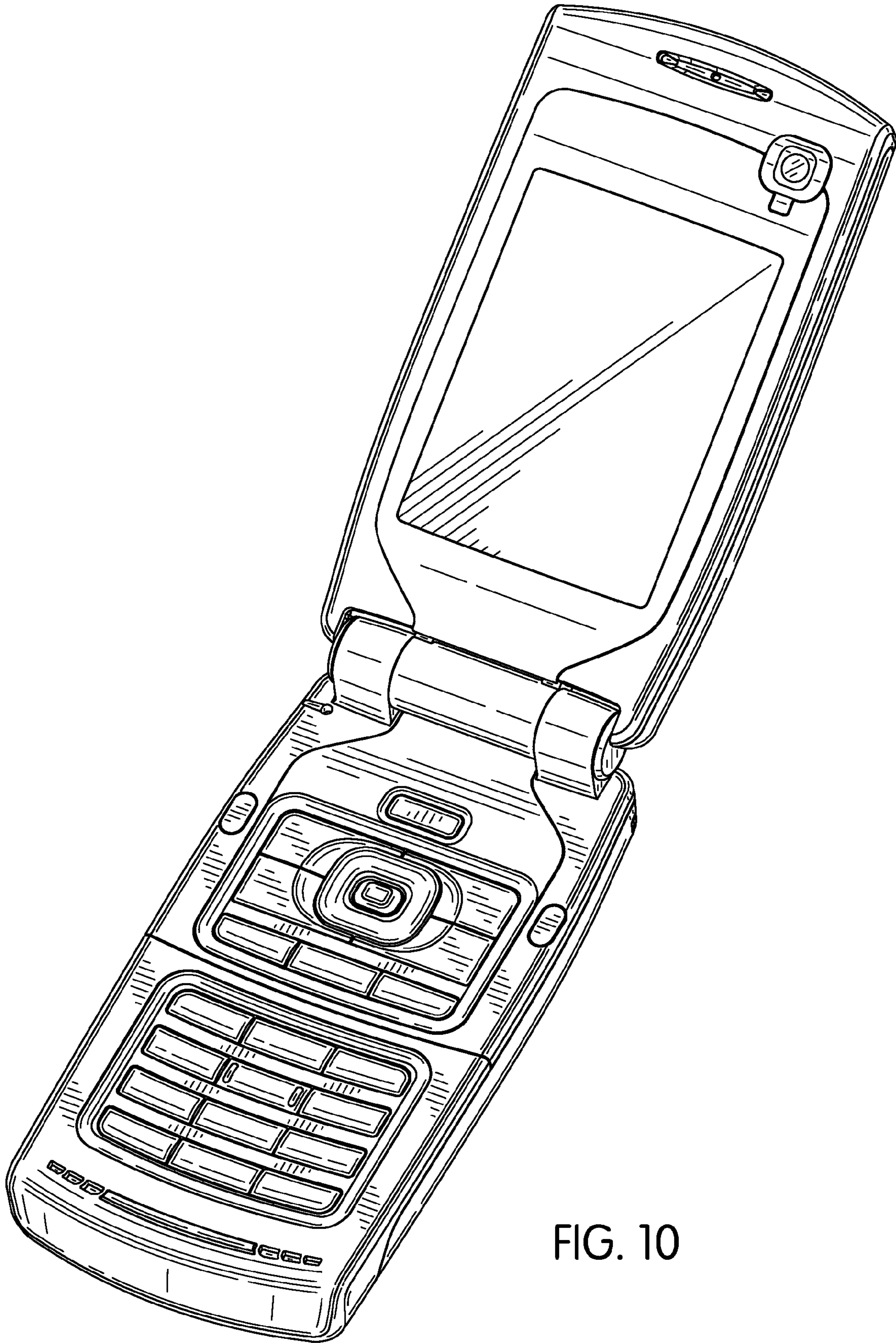

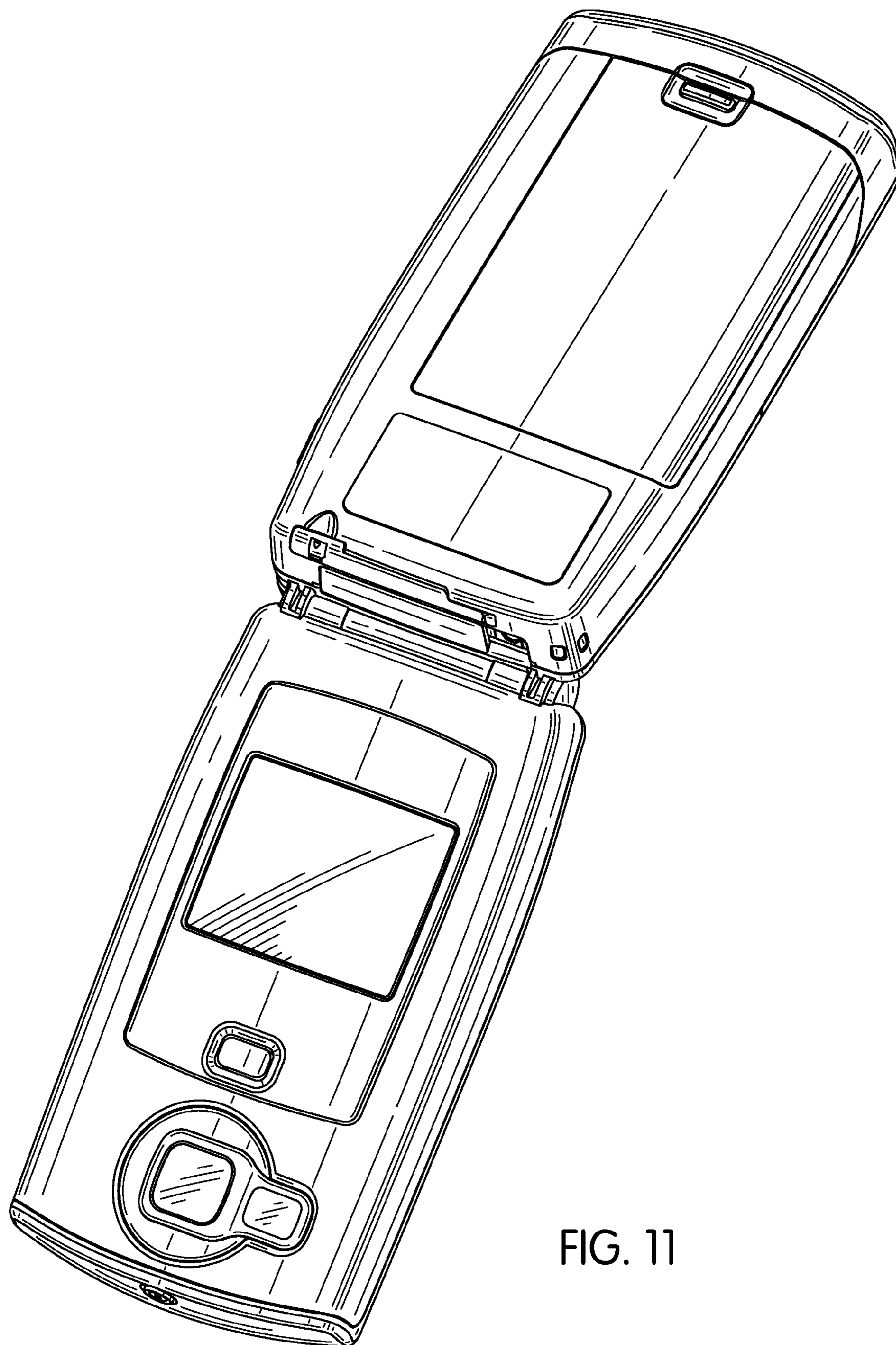

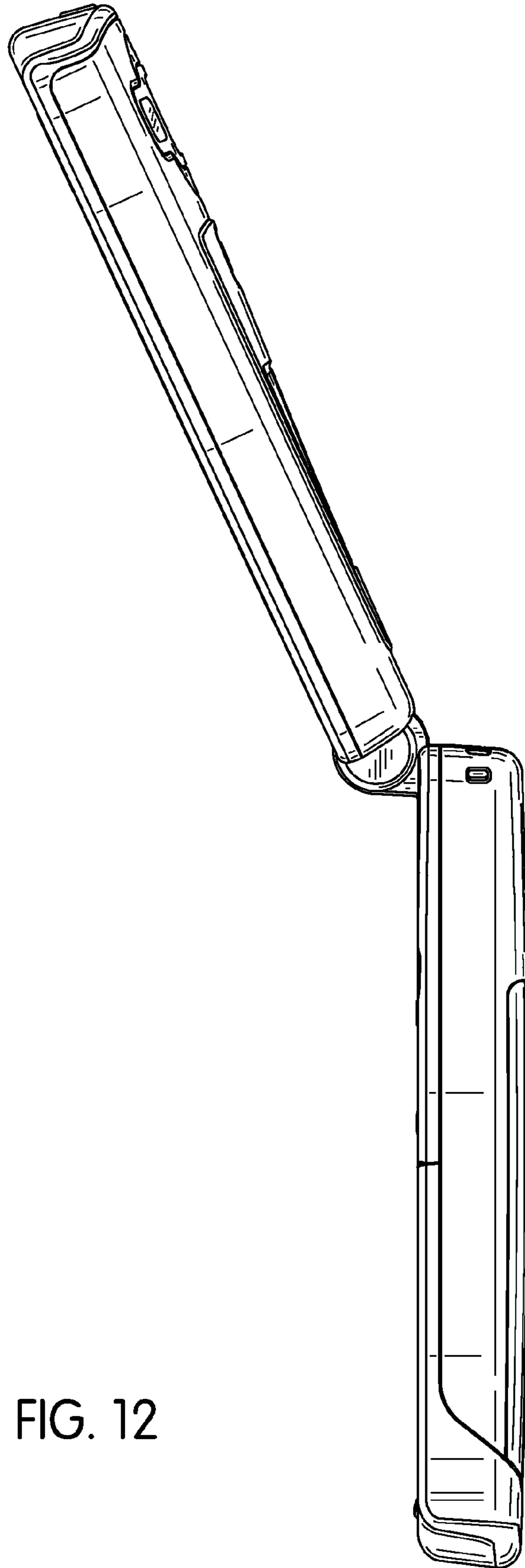

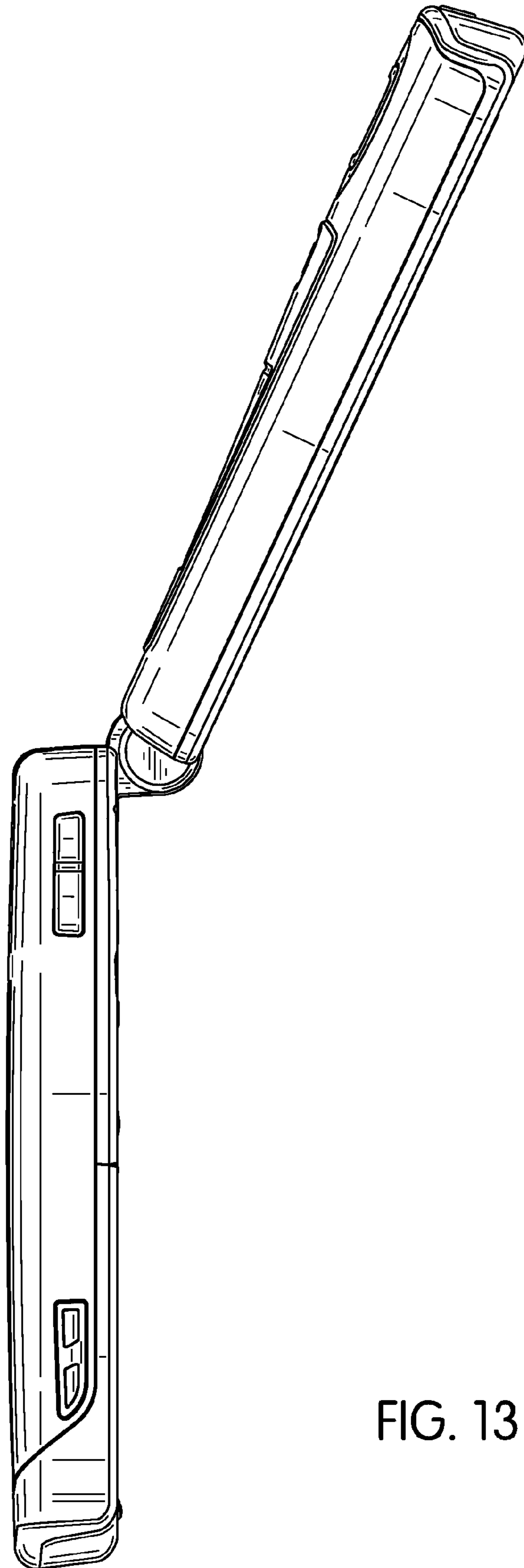
