FIG. 4 is a side view of the phone base of FIG. 1;

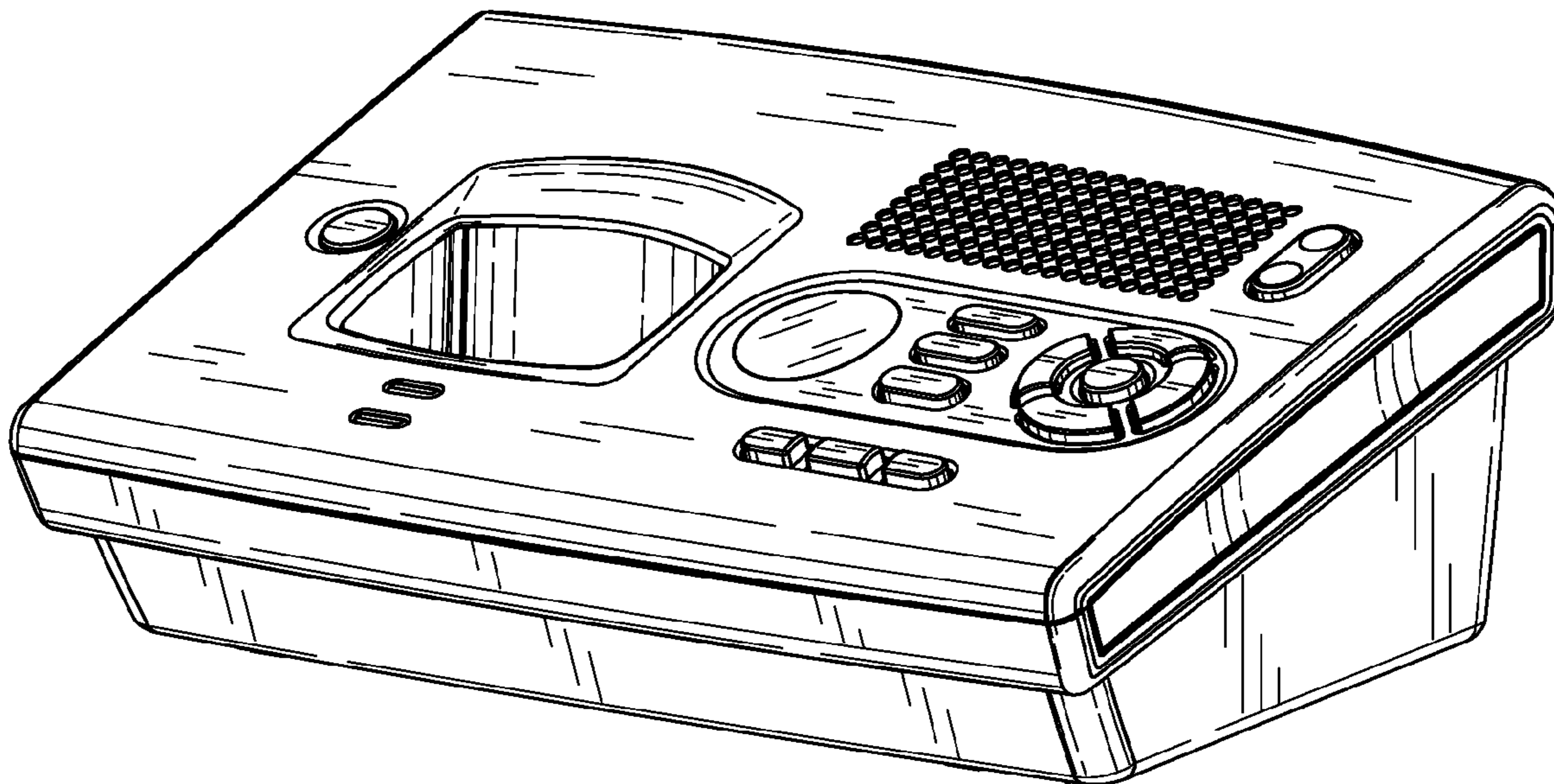
FIG. 5 is a side view of the phone base of FIG. 1;

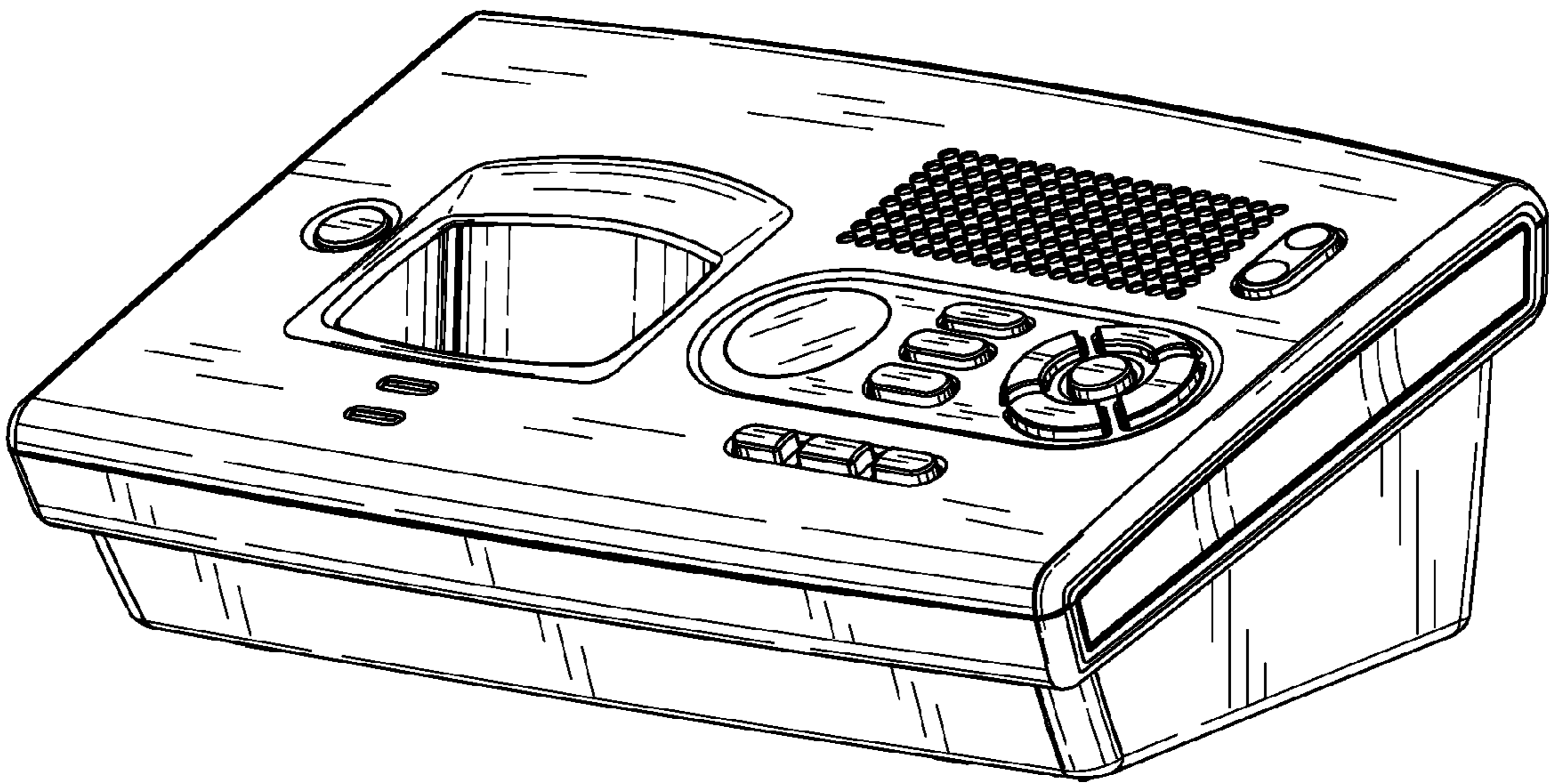
FIG. 6 is a rear view of the phone base of FIG. 1; and,

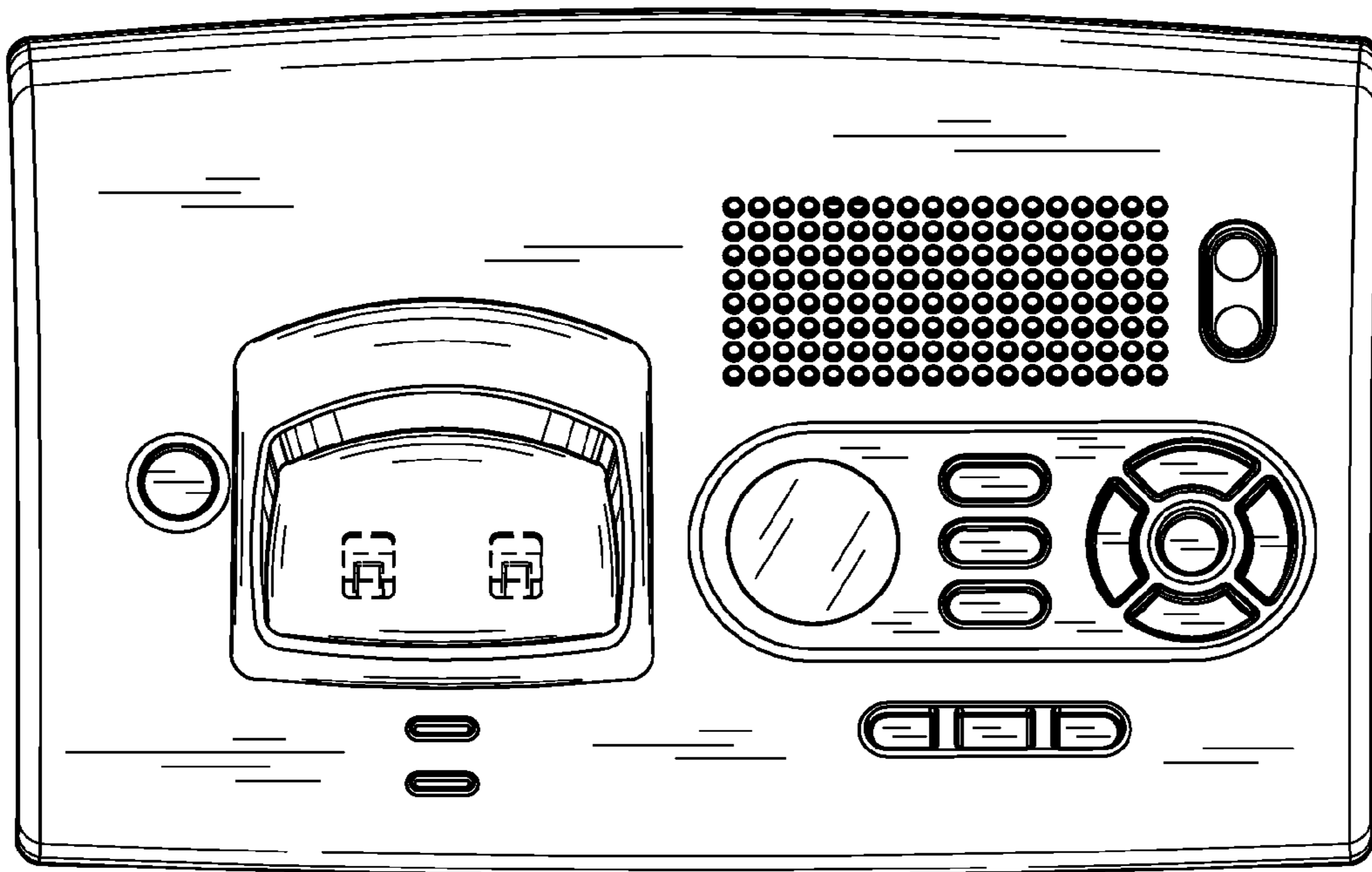

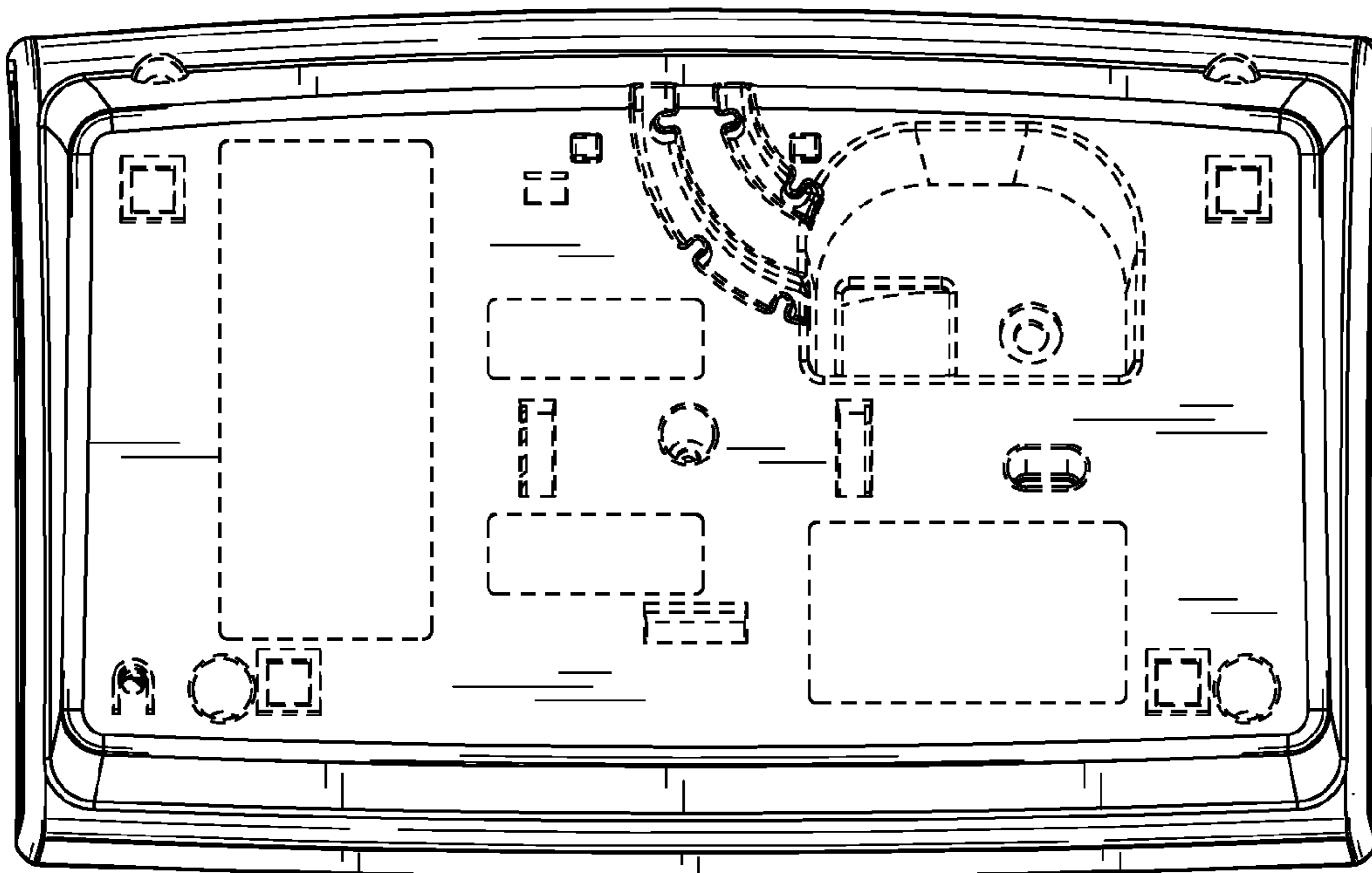
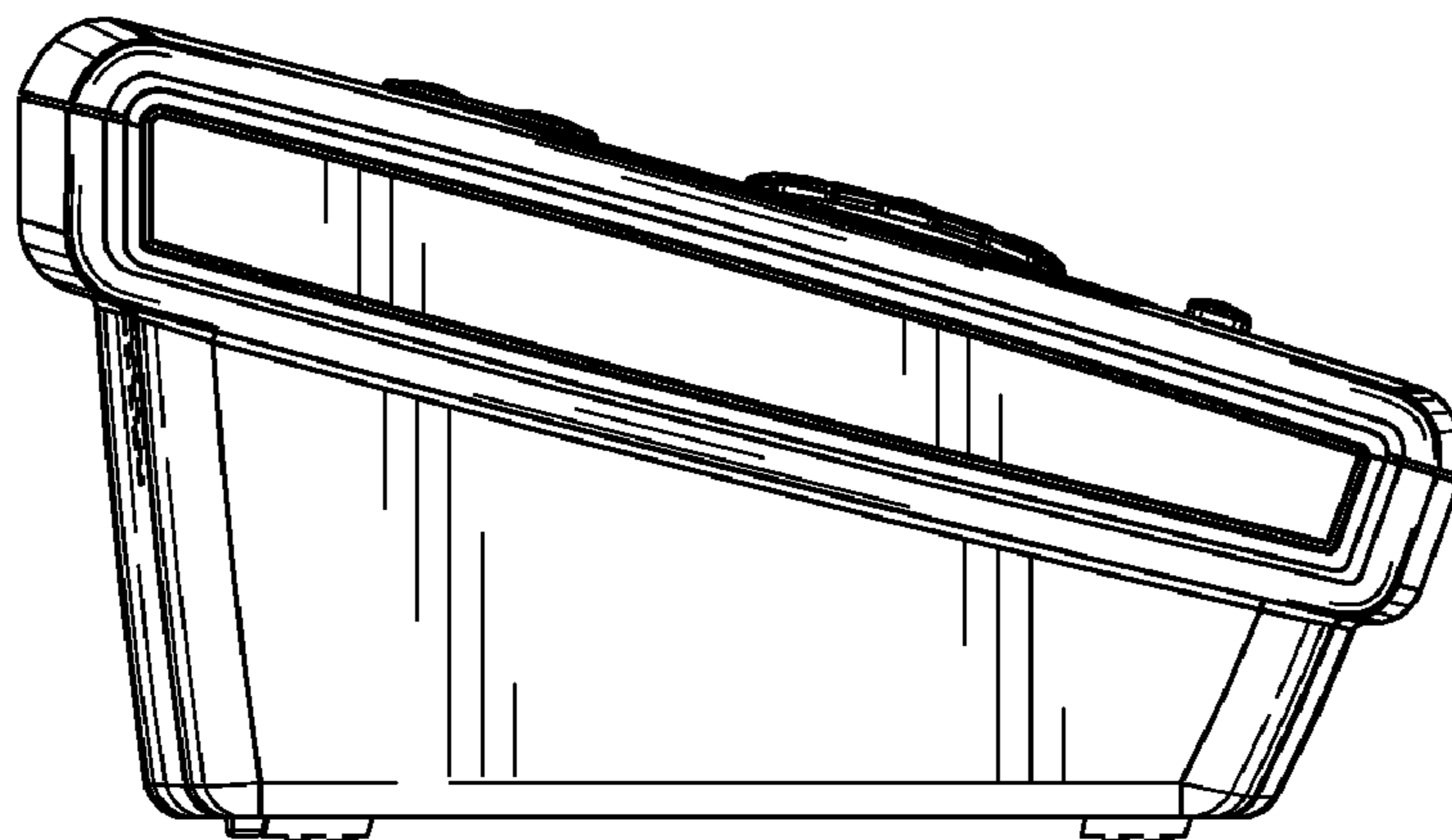
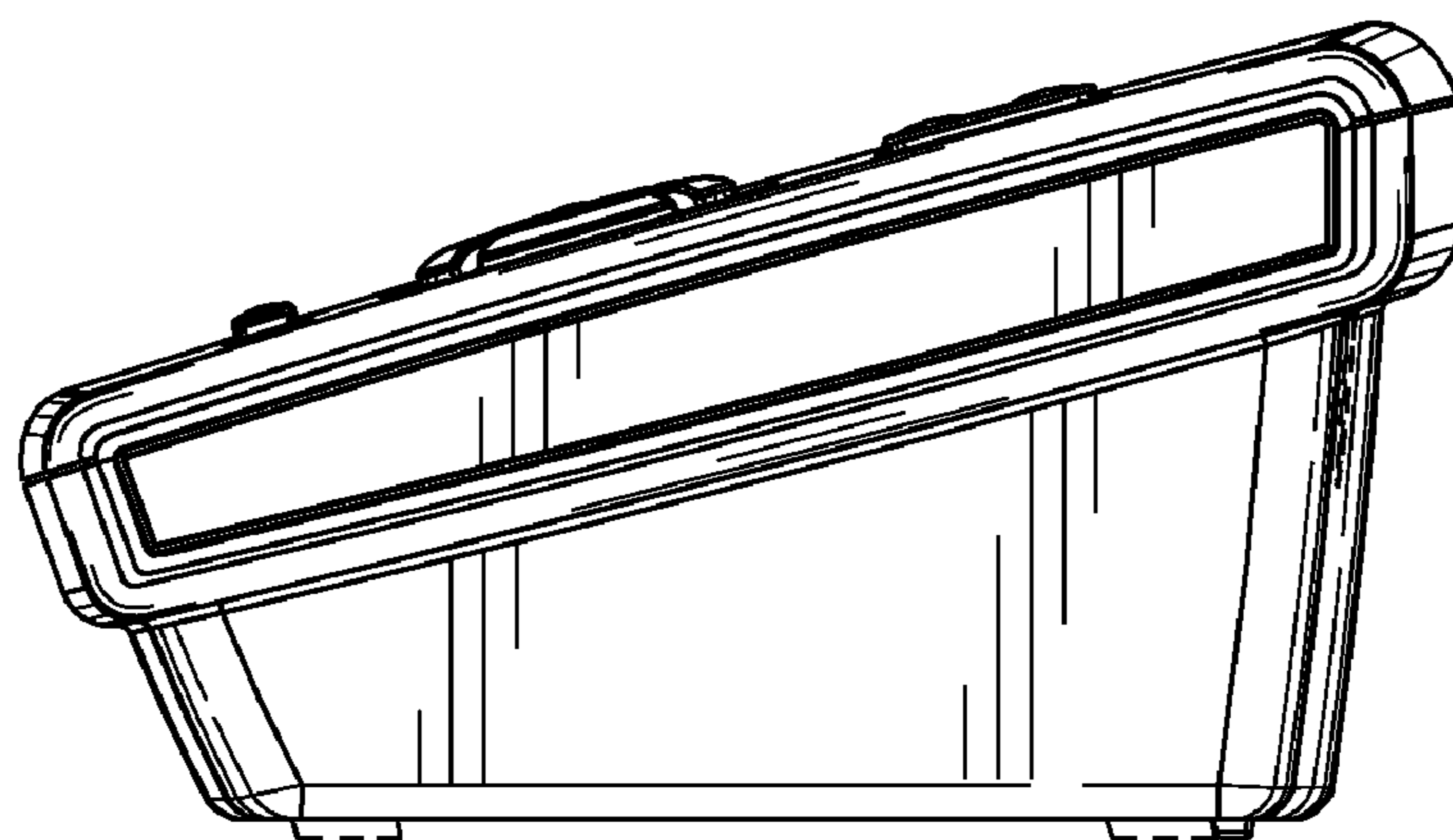

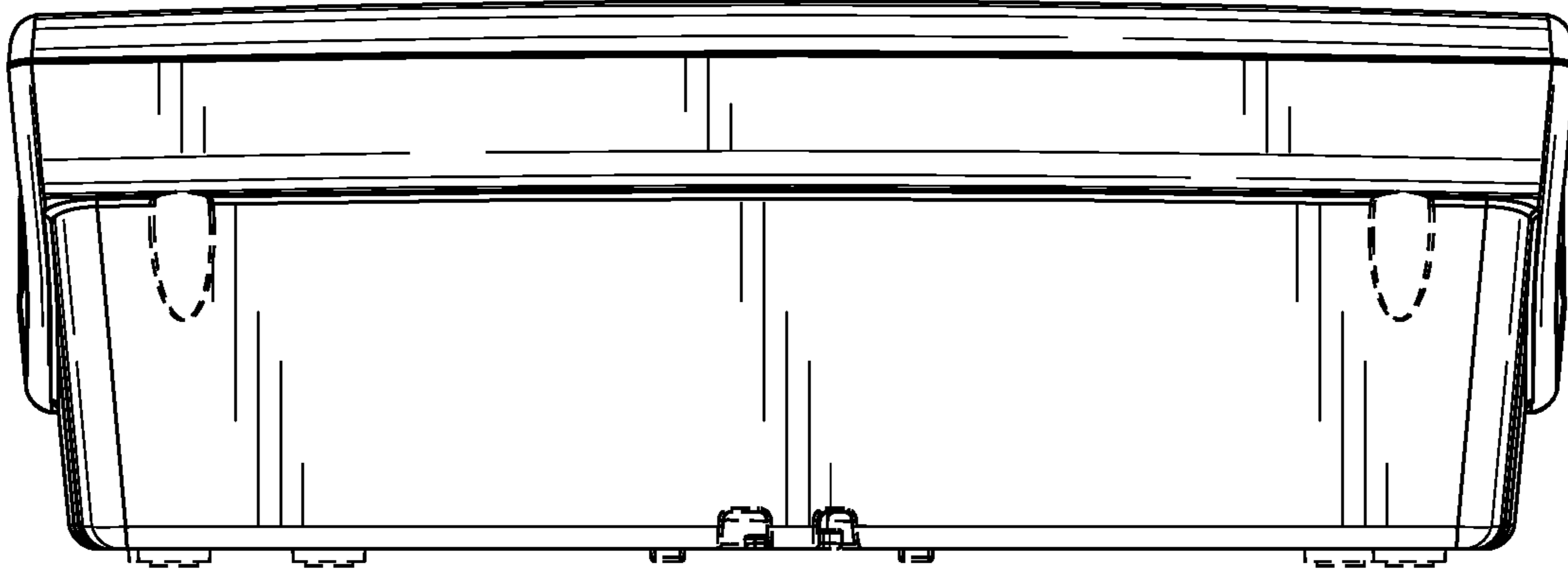

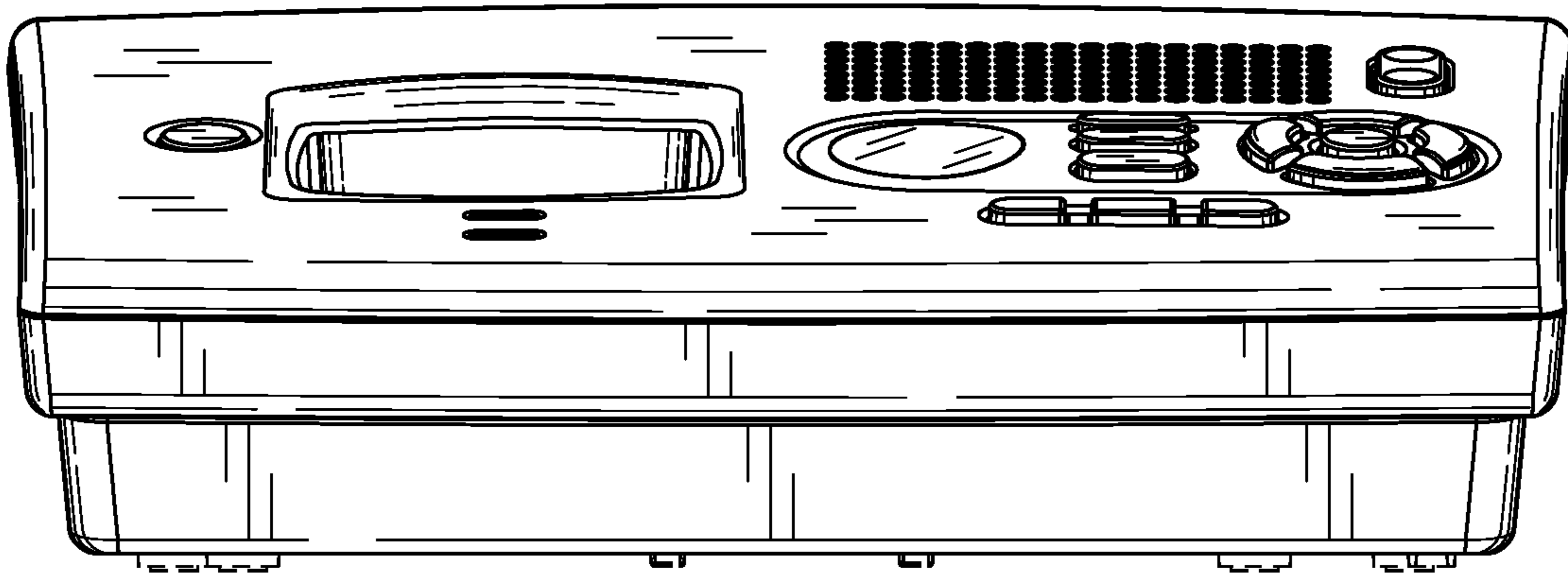
