FIG. 7 is a bottom plan view thereof.

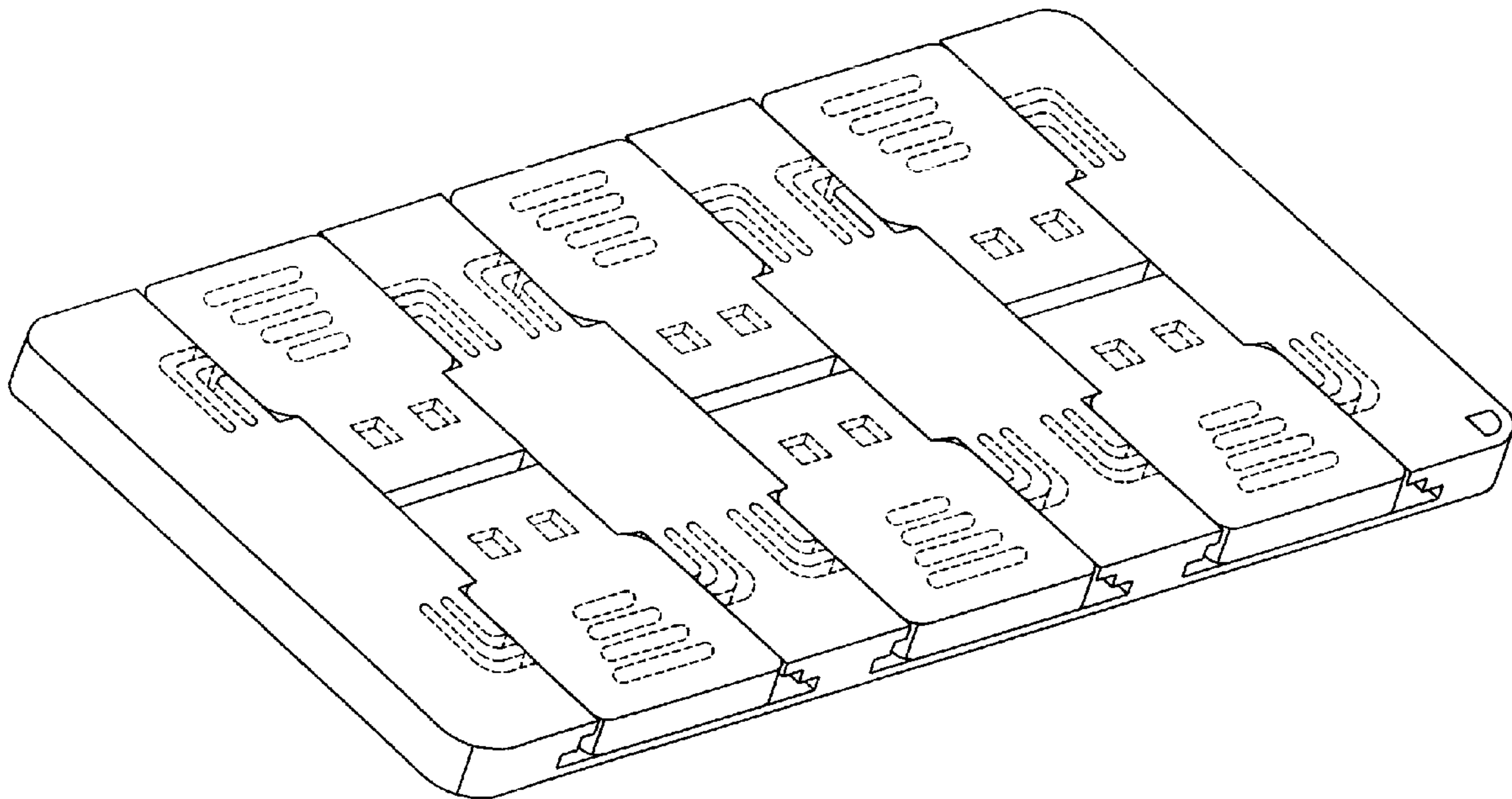
The broken lines showing of the gripping elements and

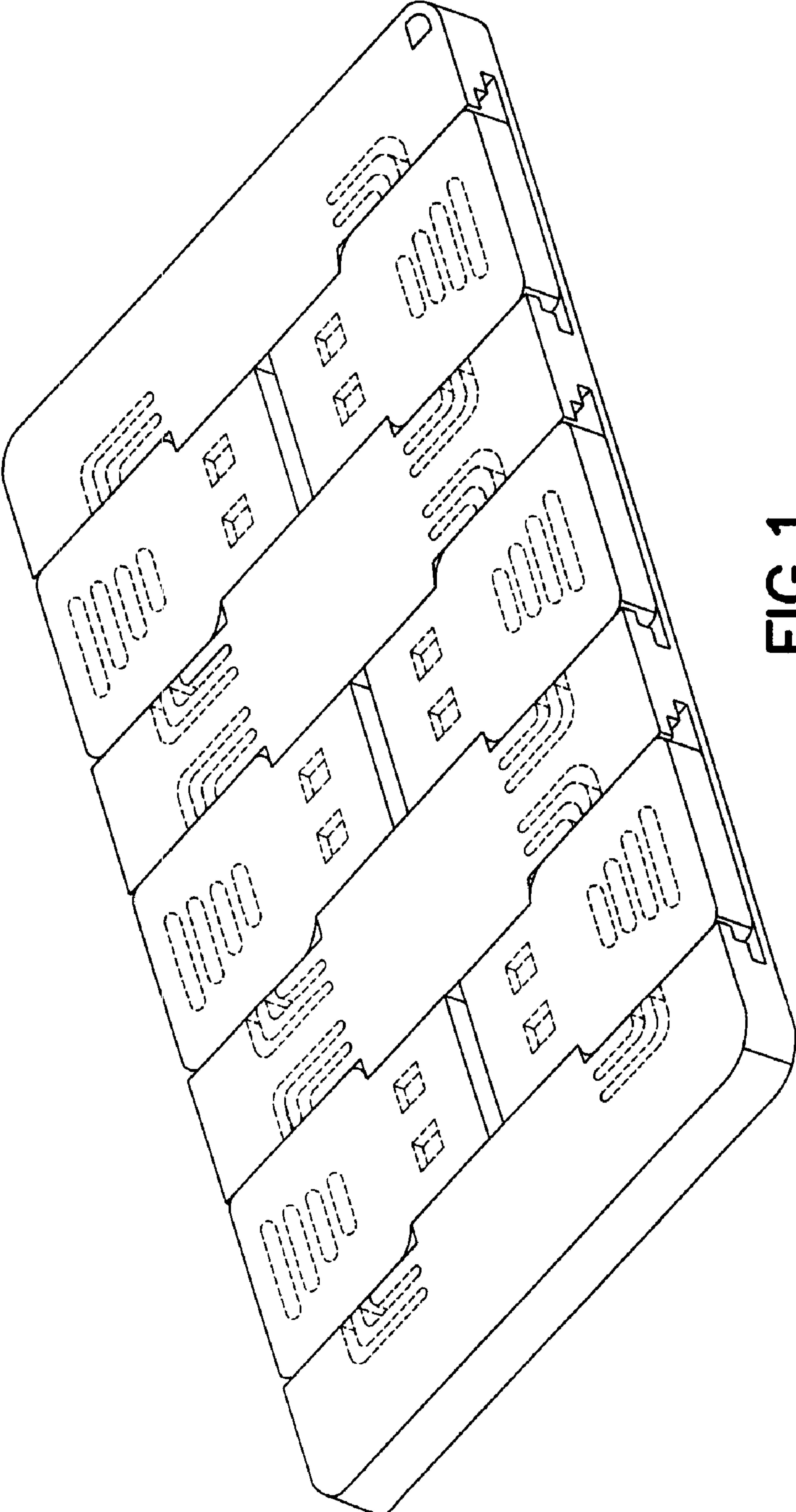

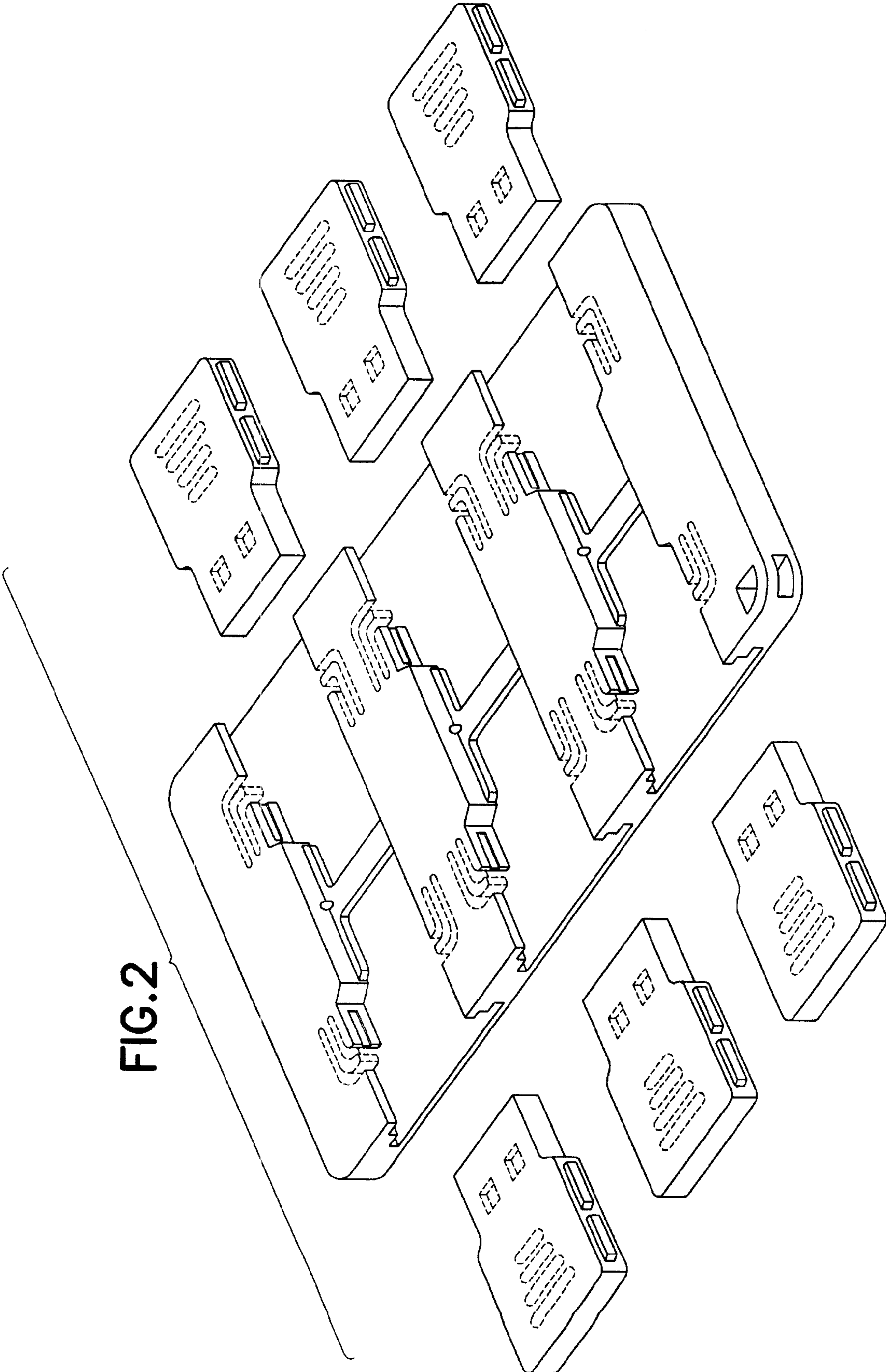

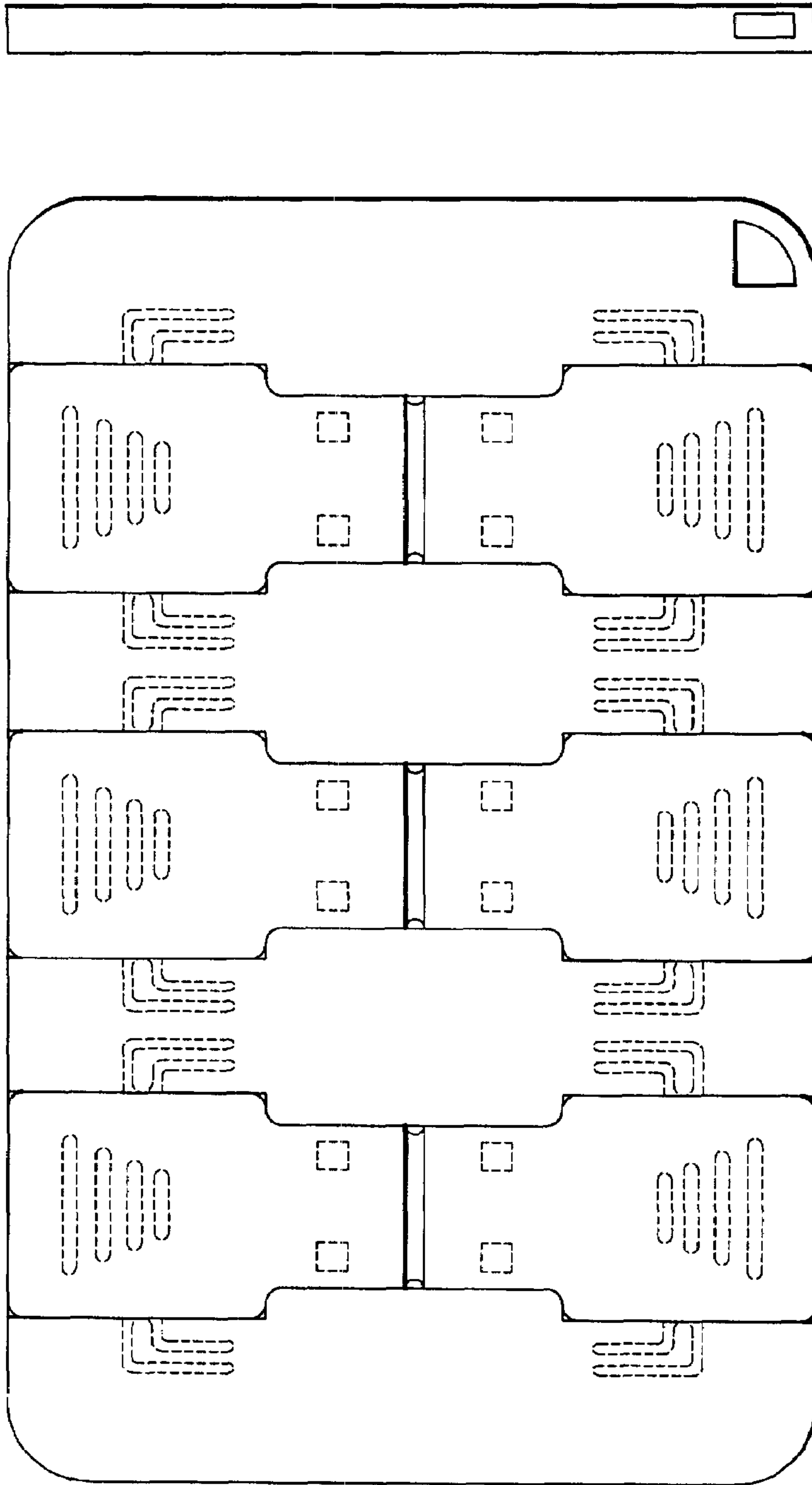

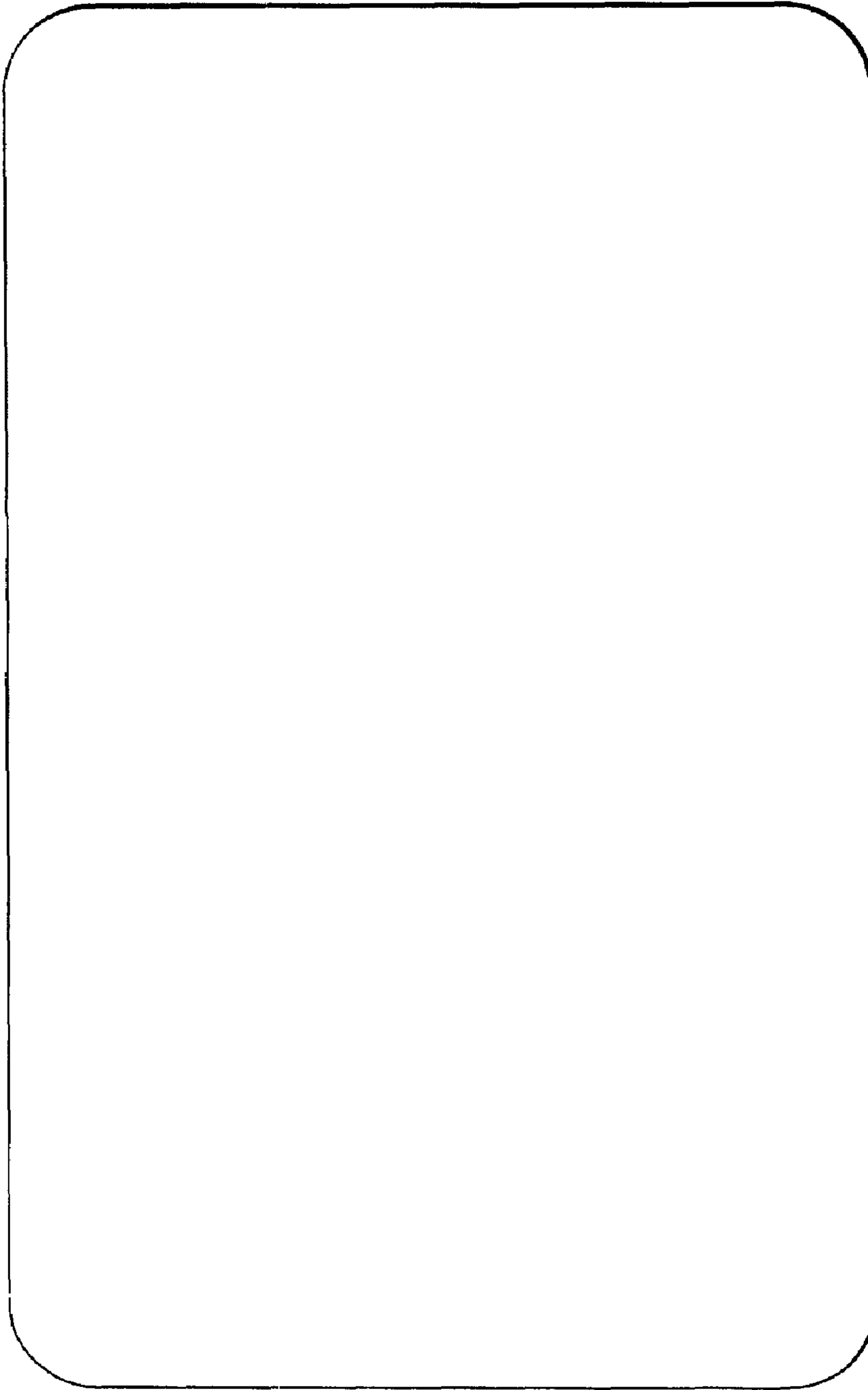
