An ornamental design for an optically readable card, substantially as shown and described.

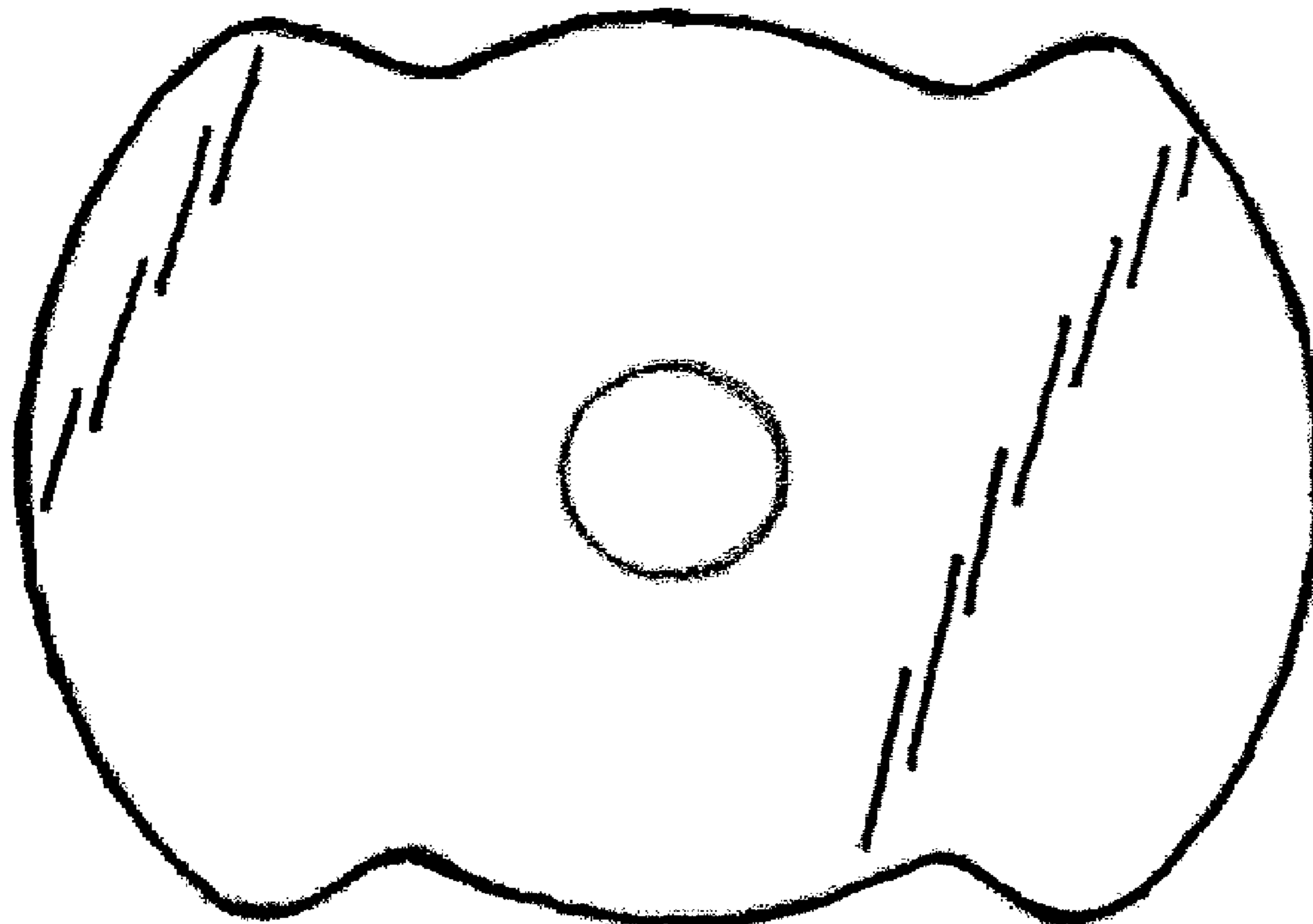

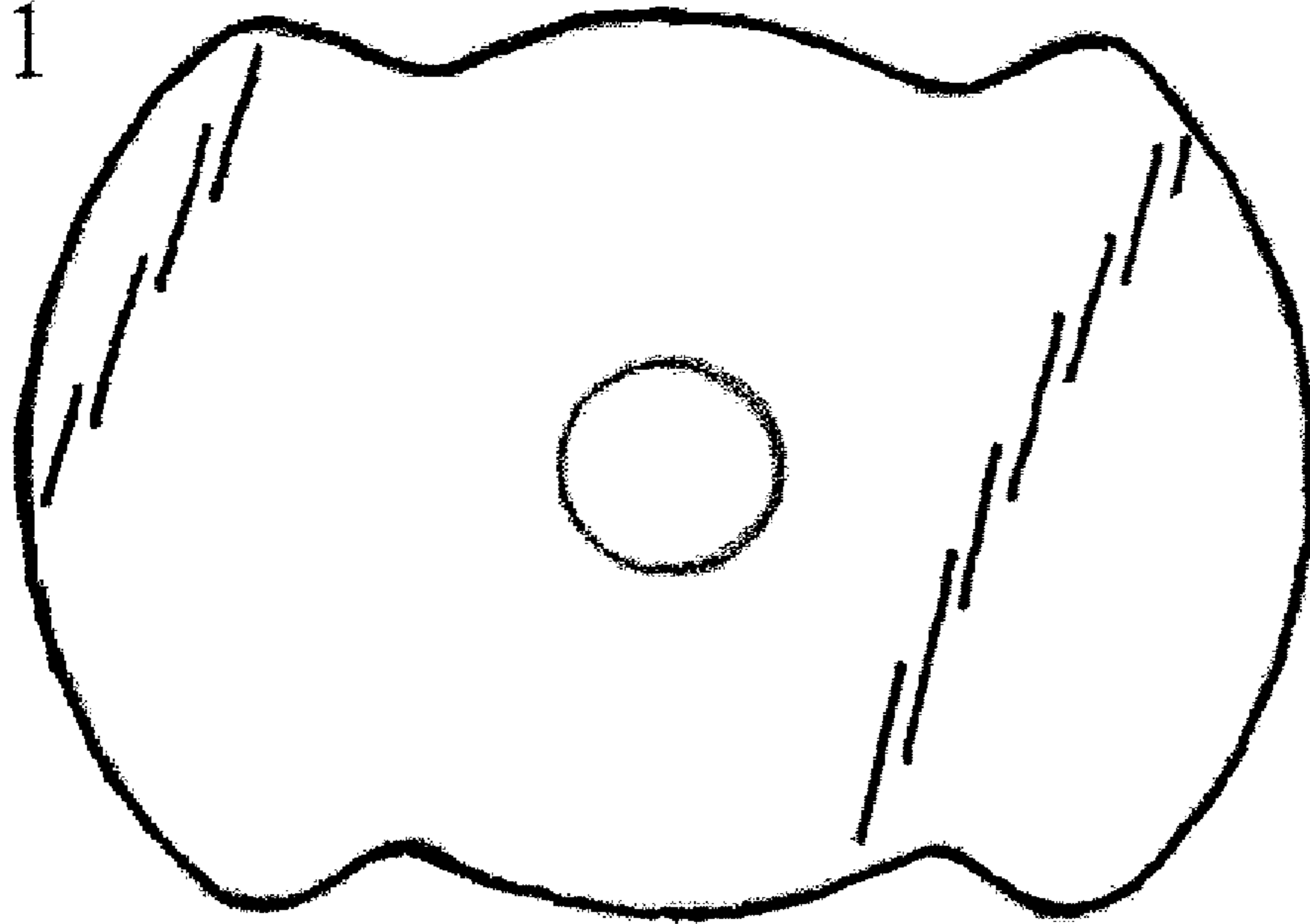
