FIG. 9 is a side view of the third embodiment thereof.

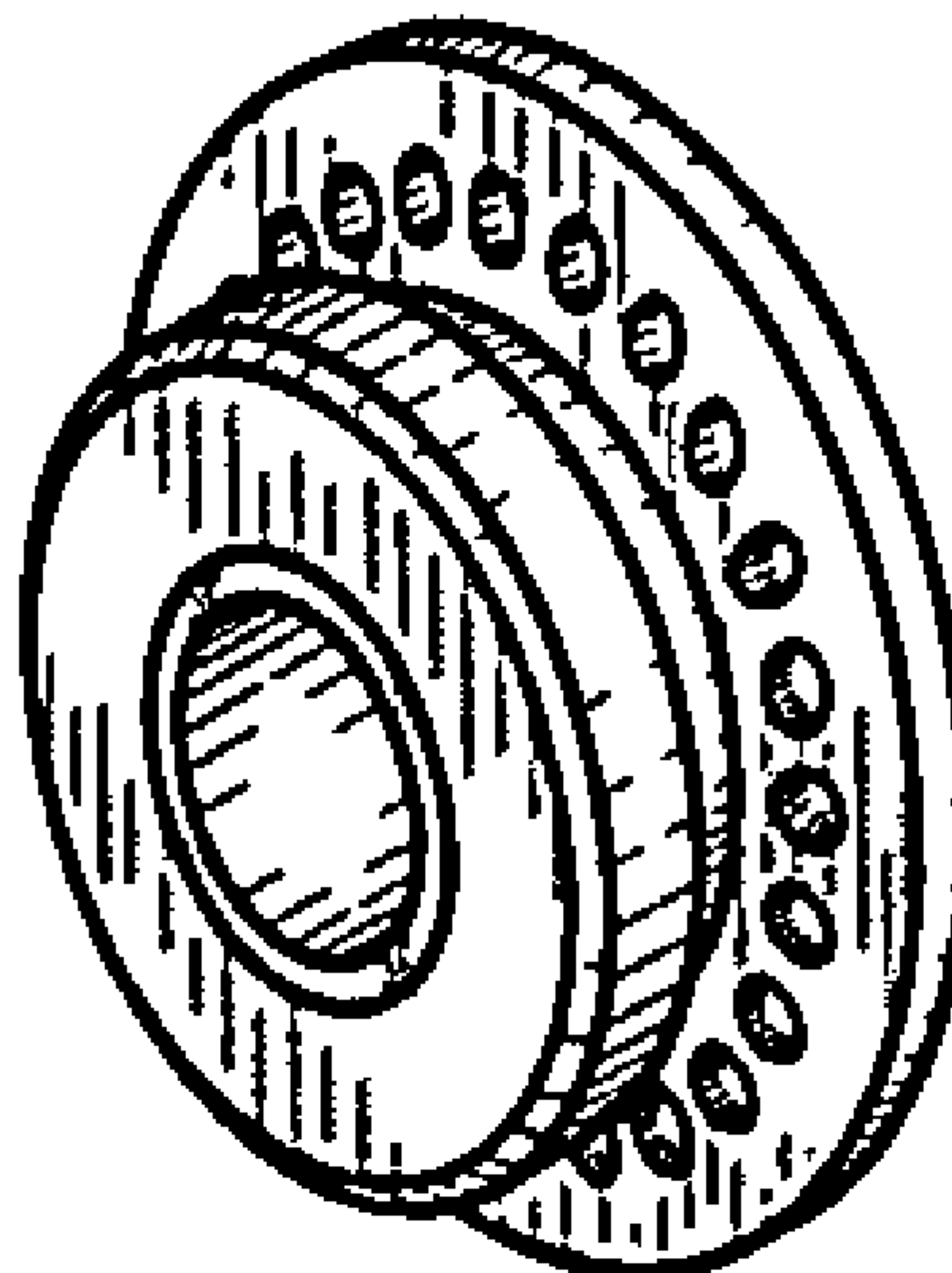

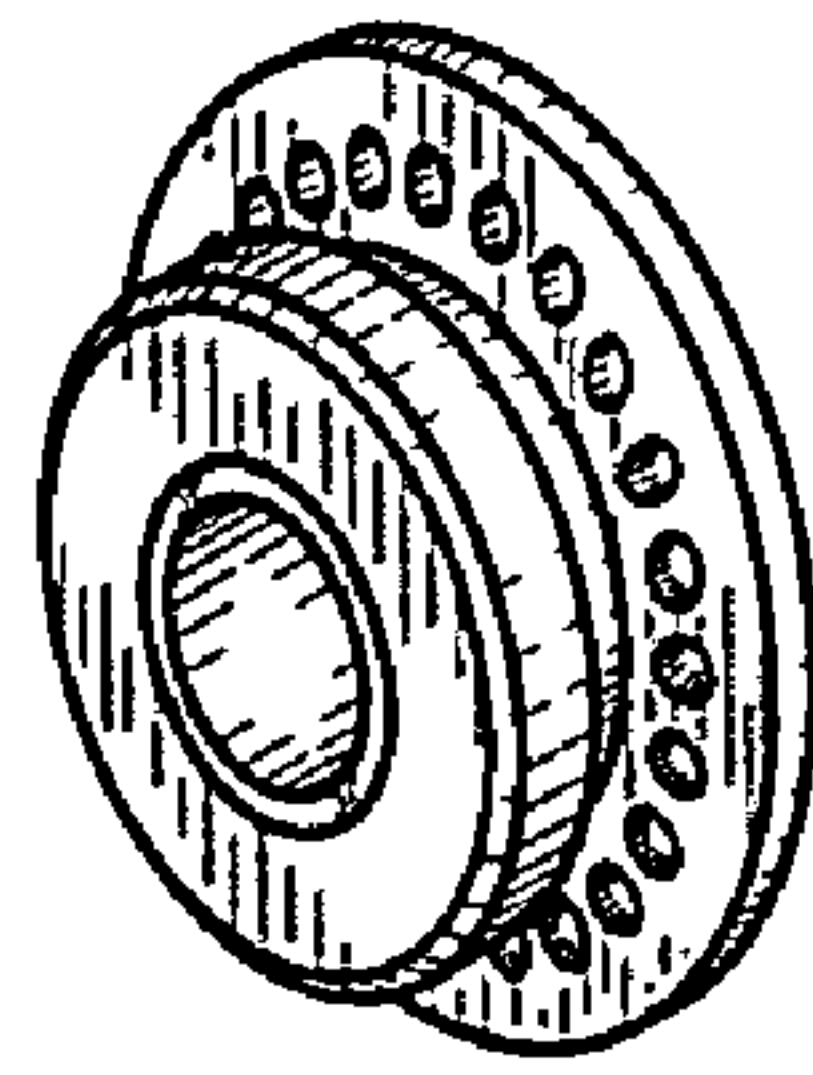

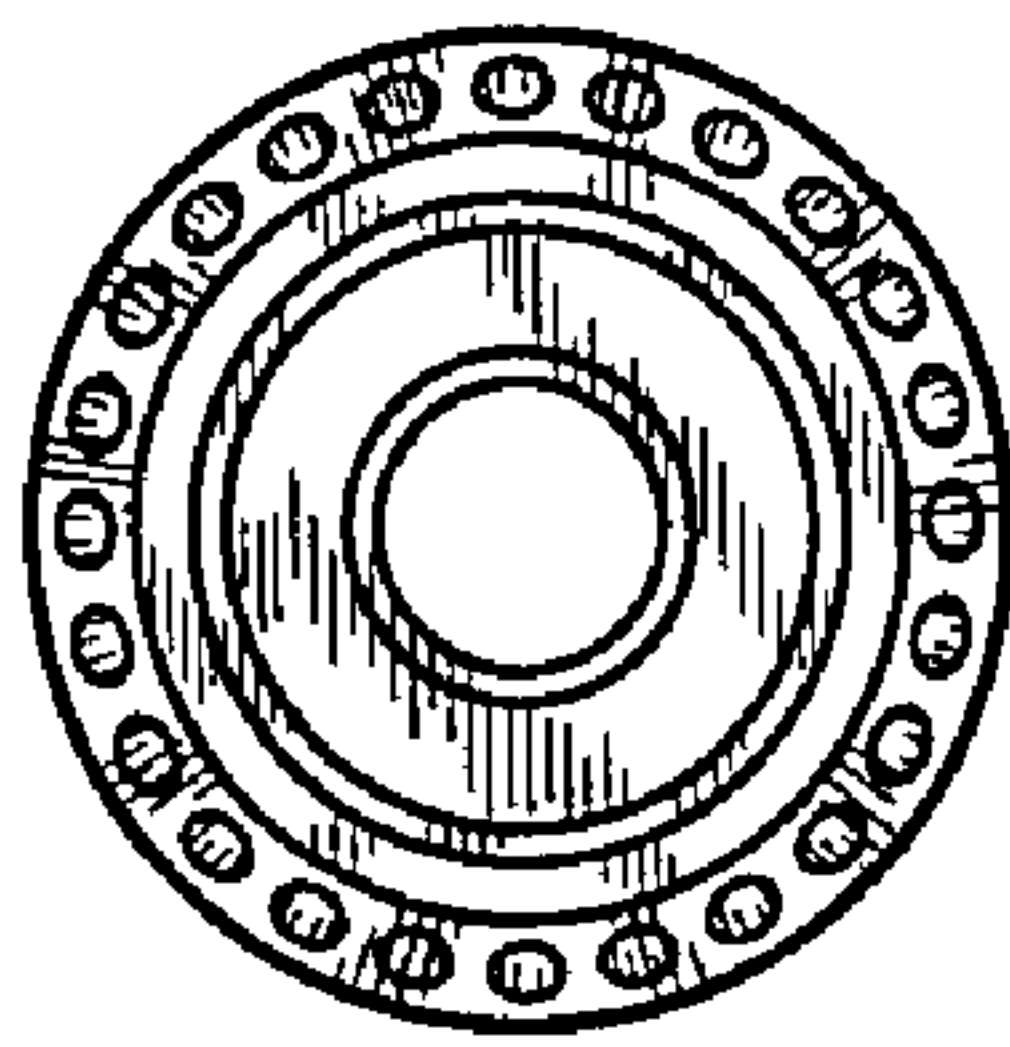

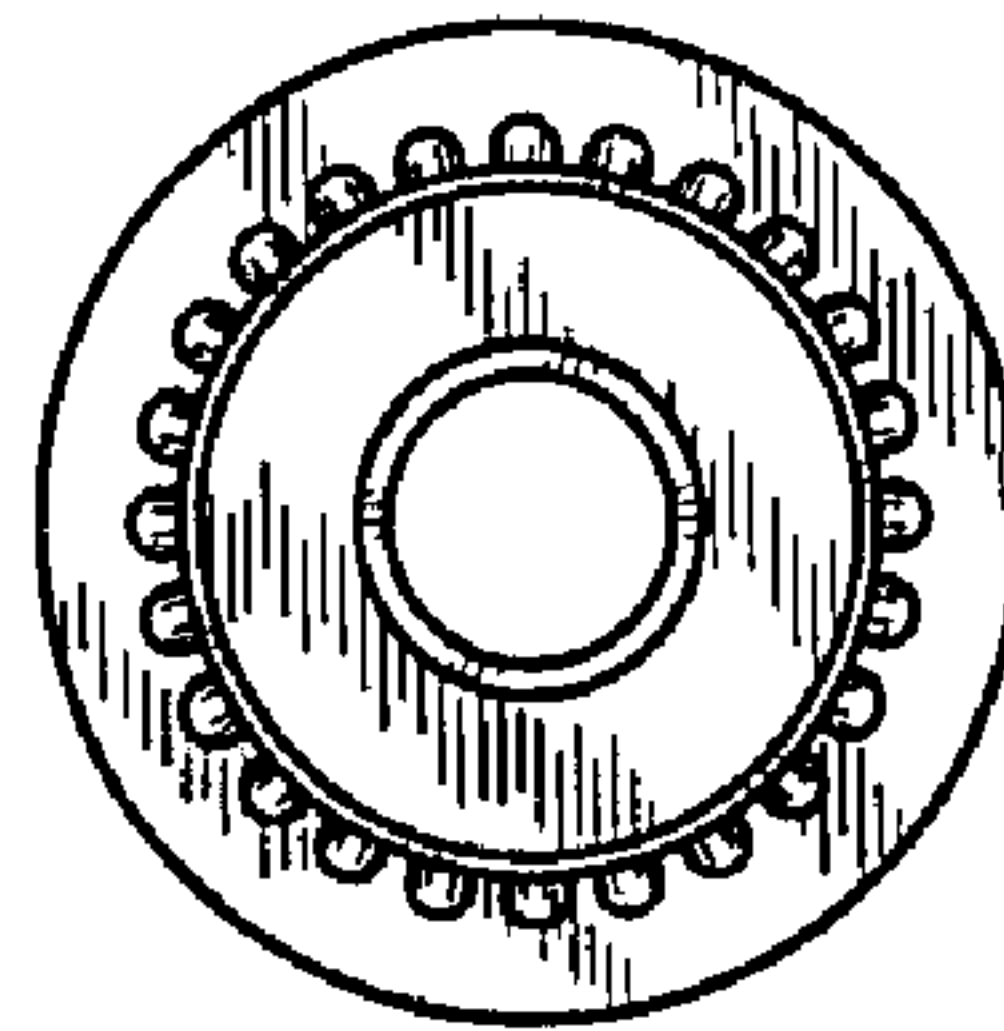

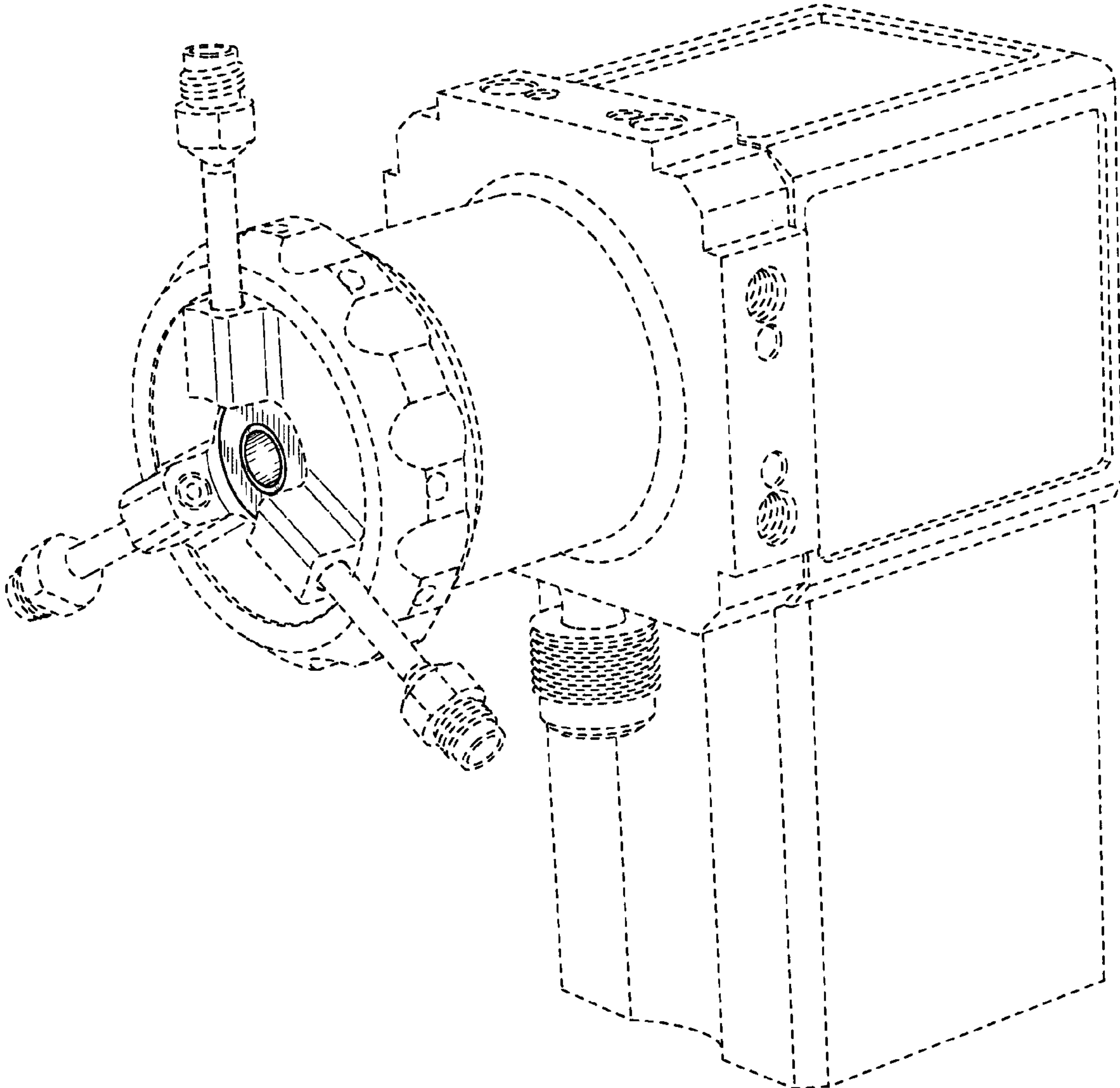

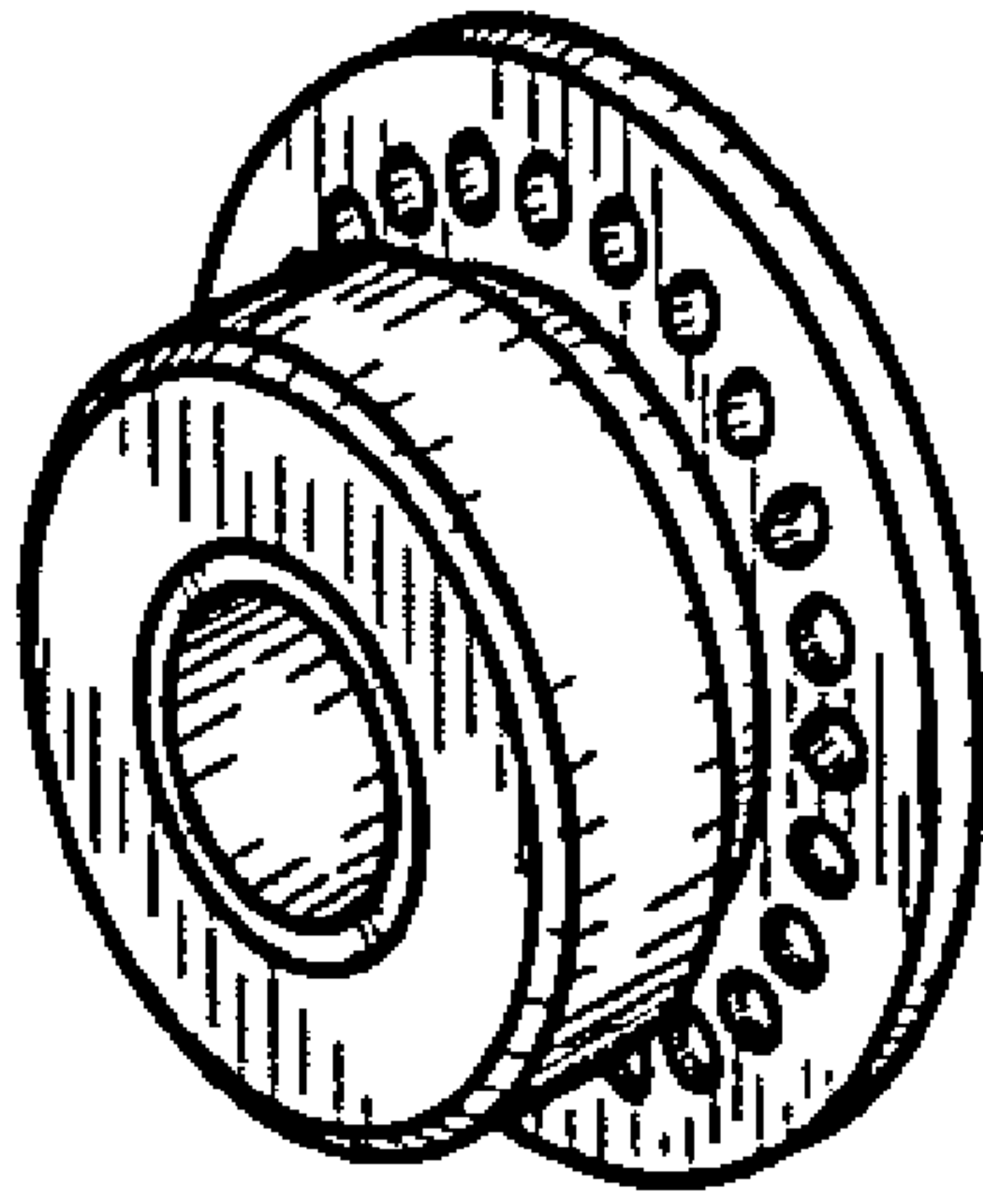

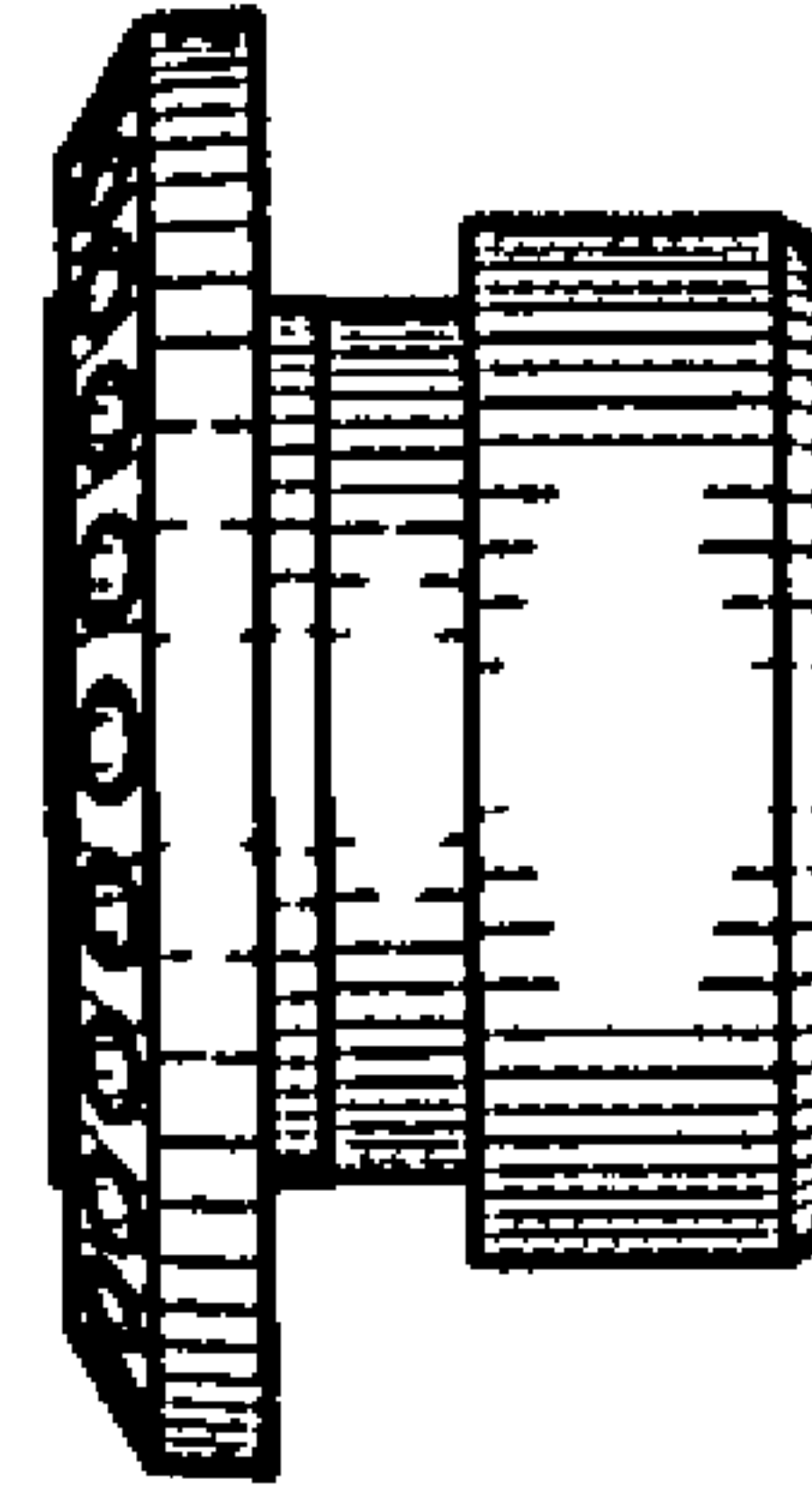

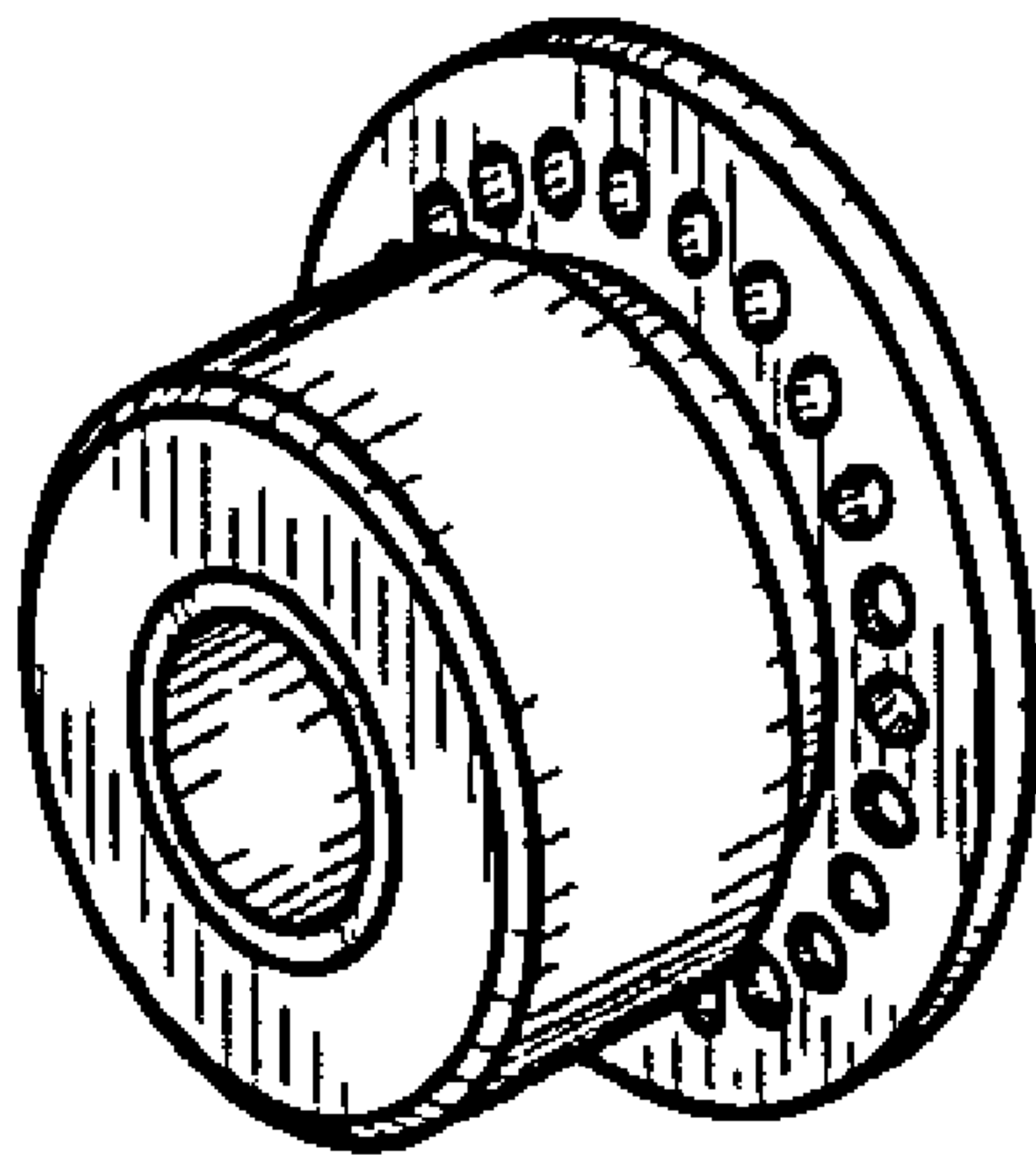

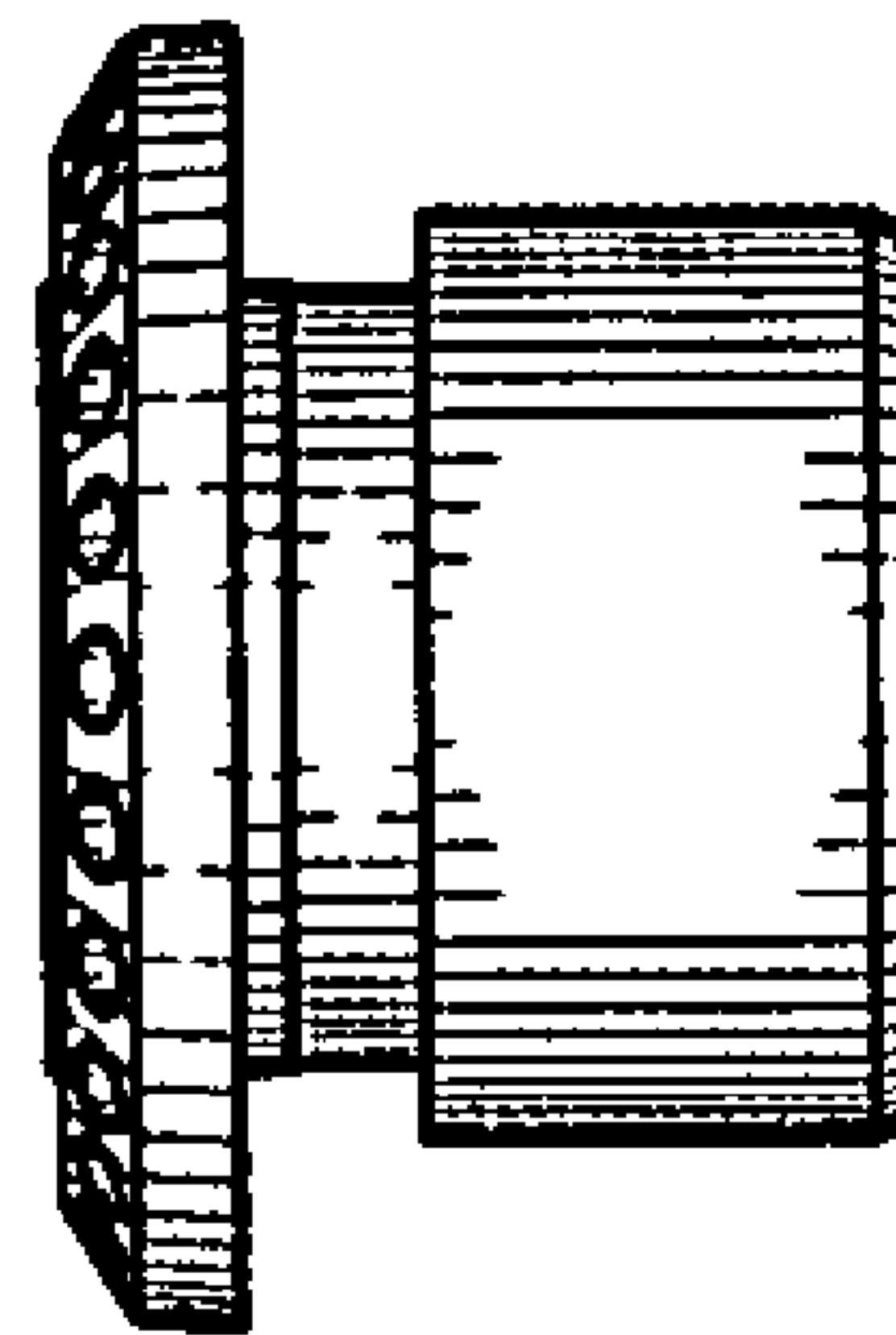
