FIG. 5 is a memory-end plan view of the birding acoustic feedback learning aid design;

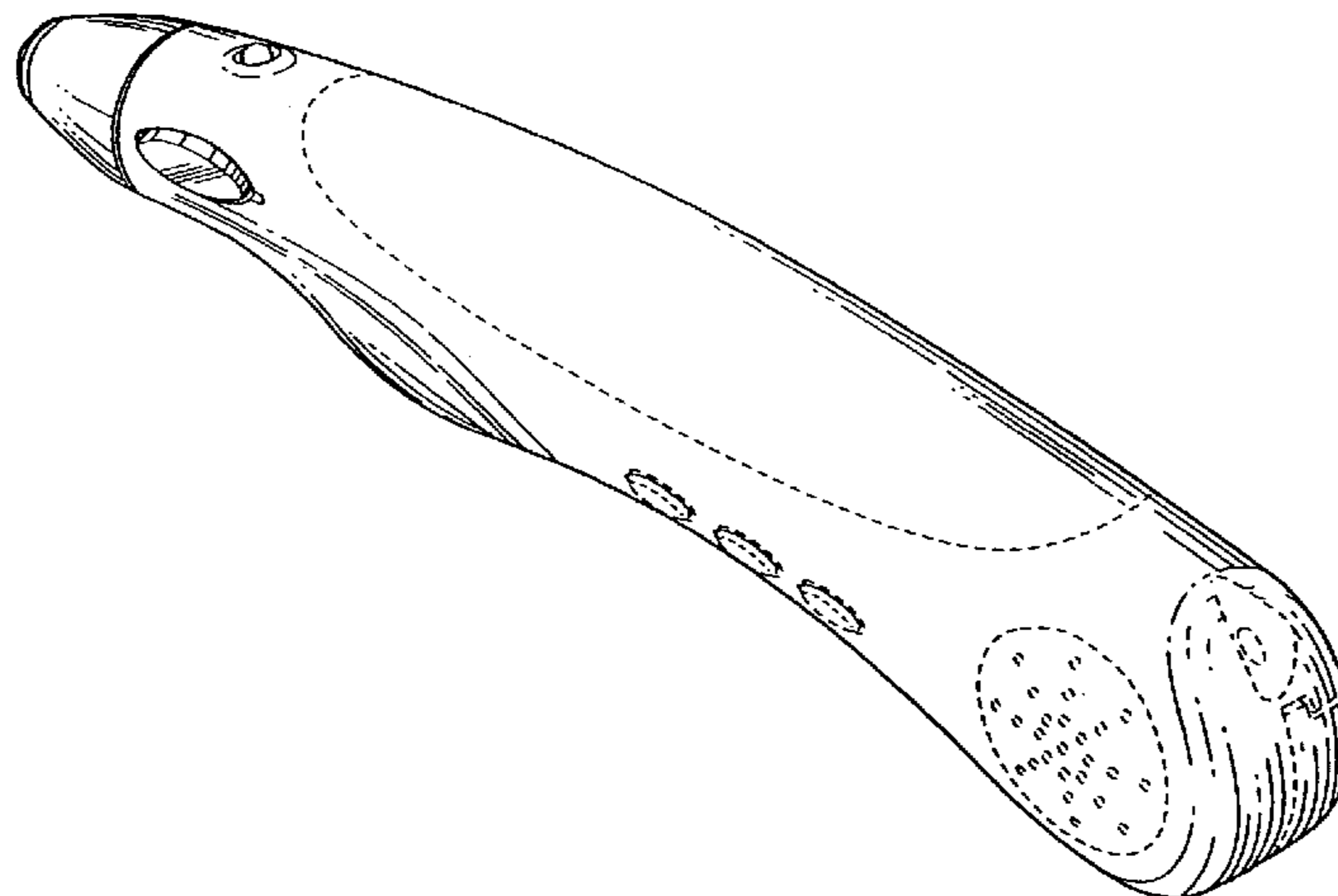
FIG. 6 is a scanner-end plan view of the birding acoustic feedback learning aid design;

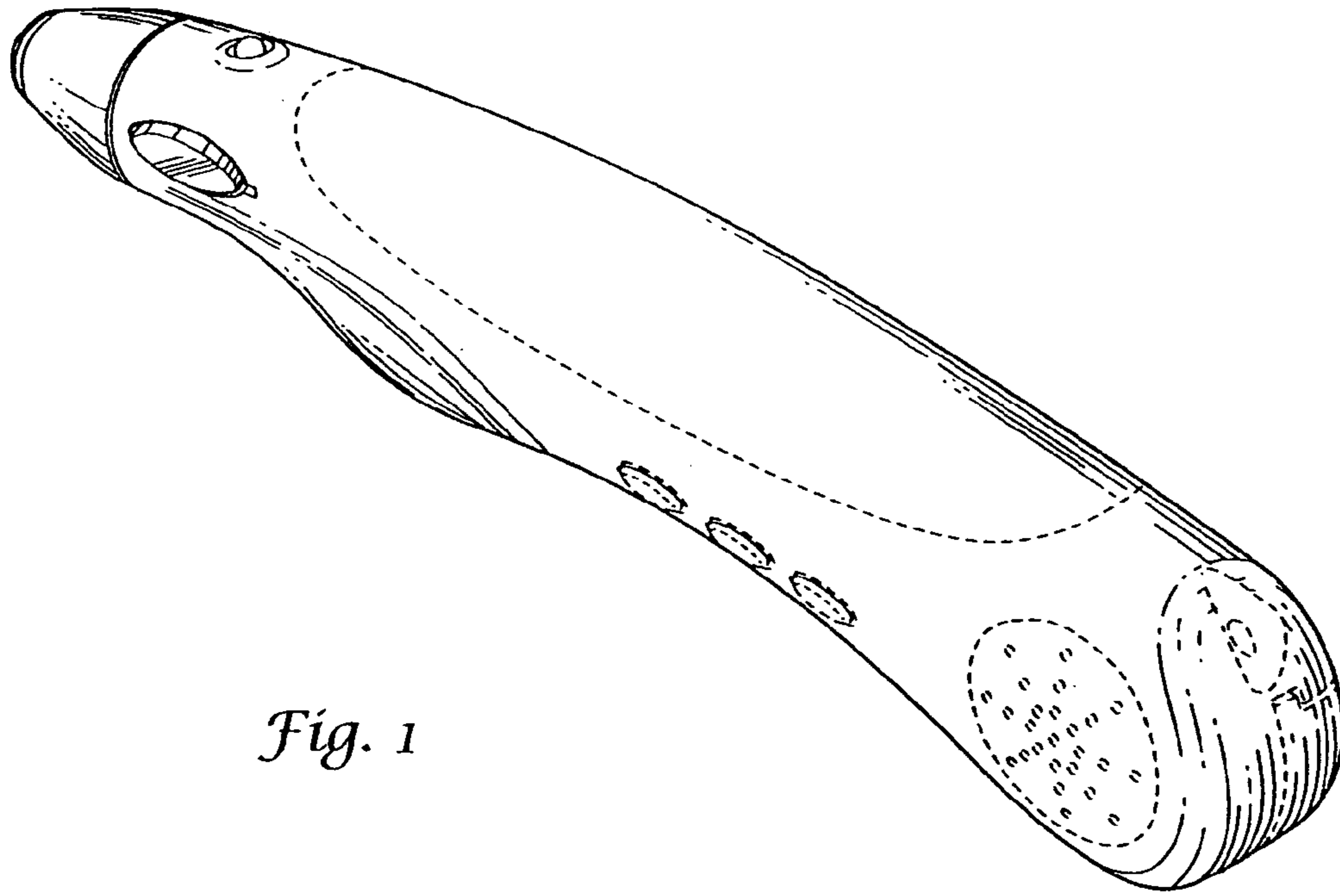

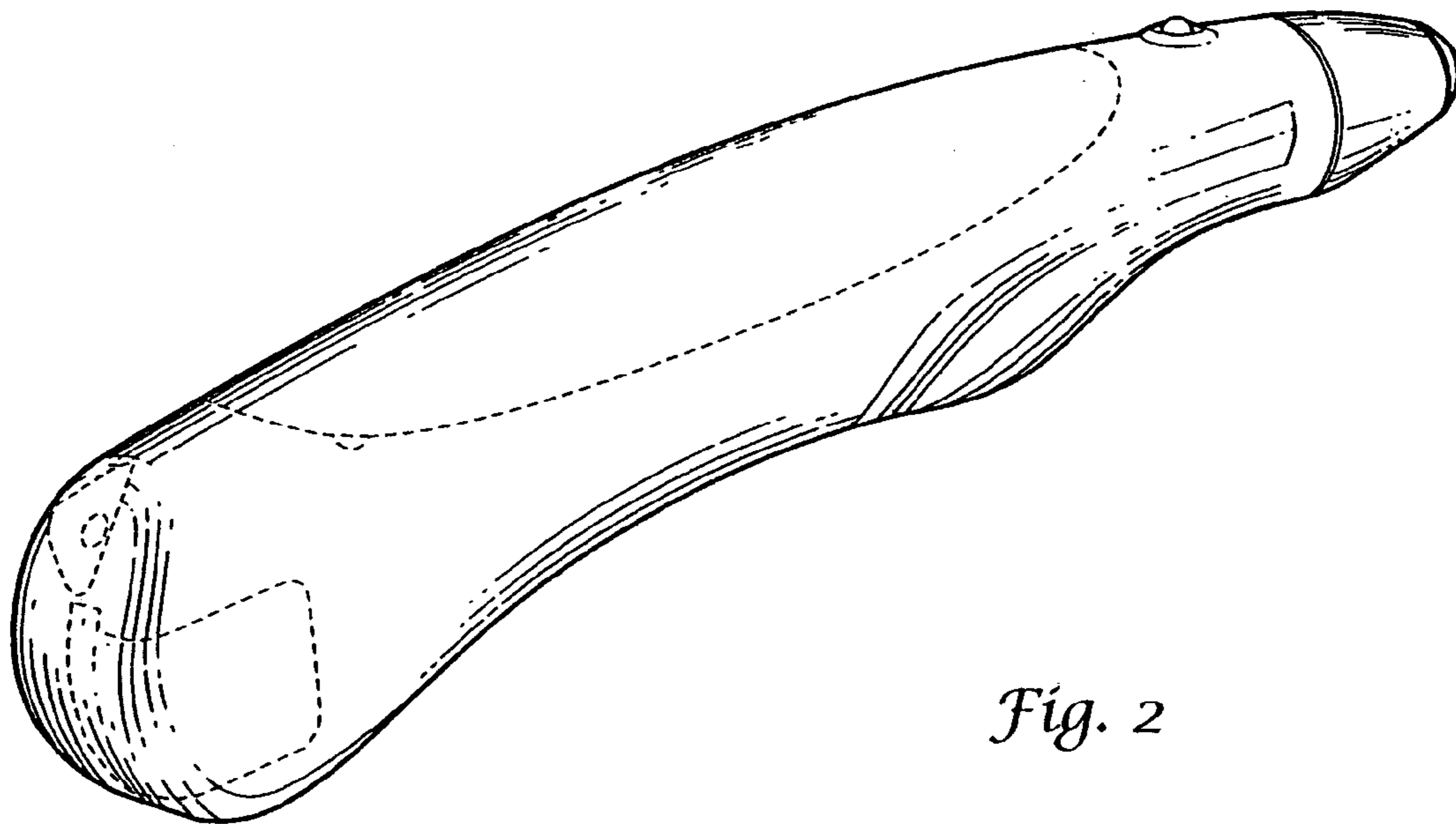

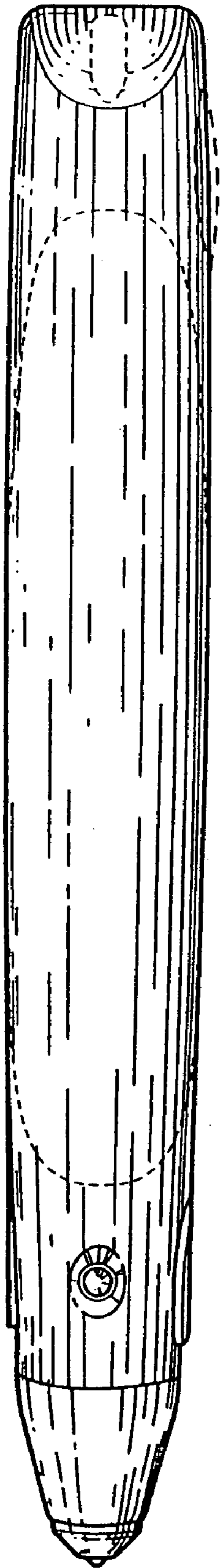

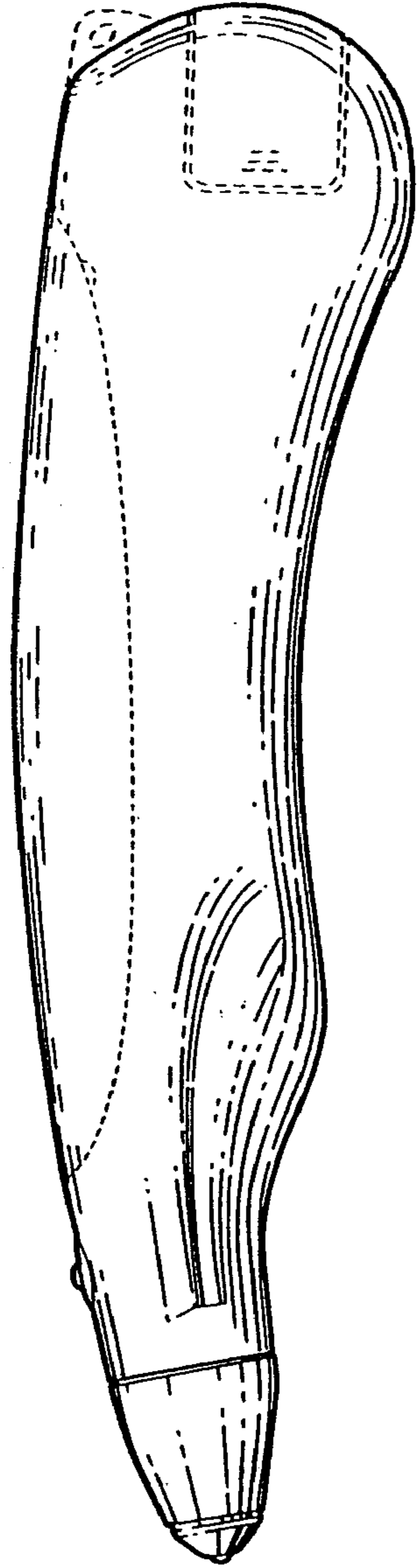

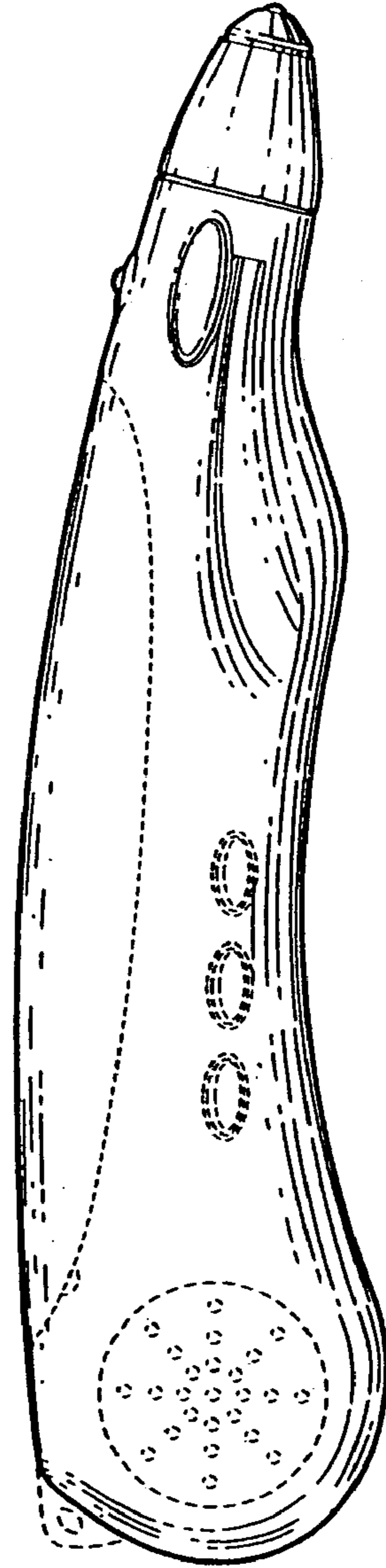

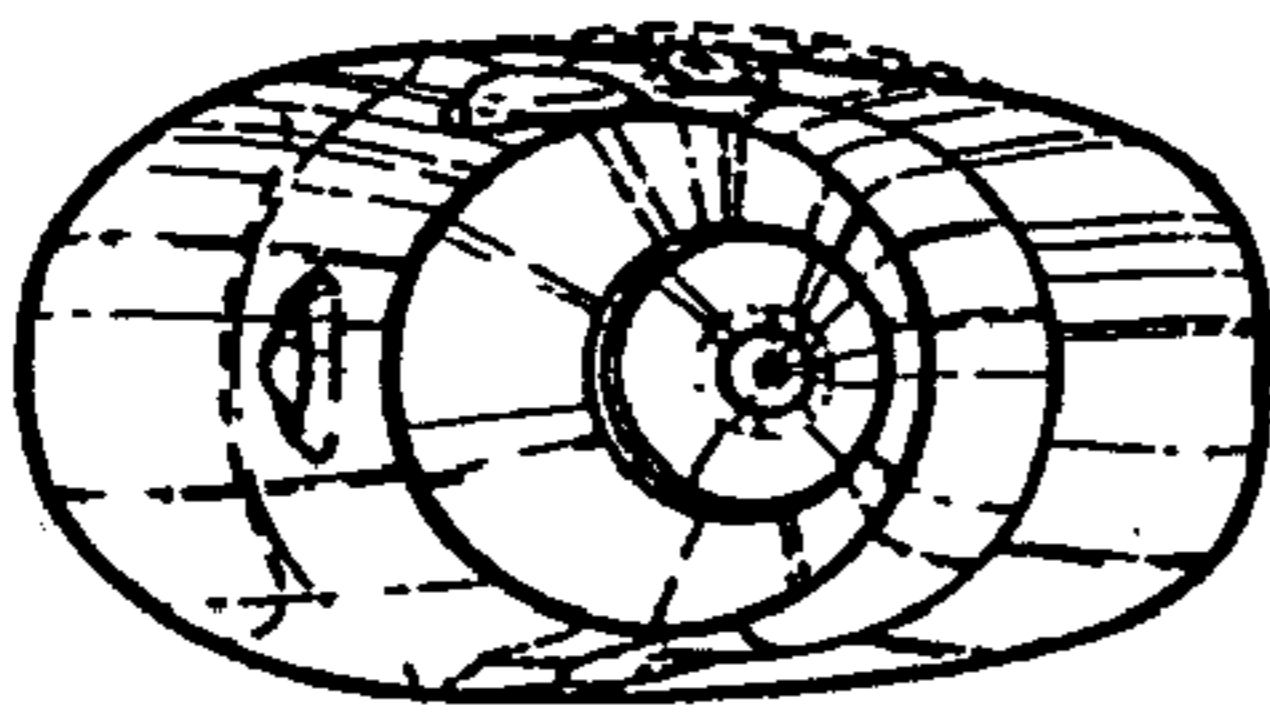

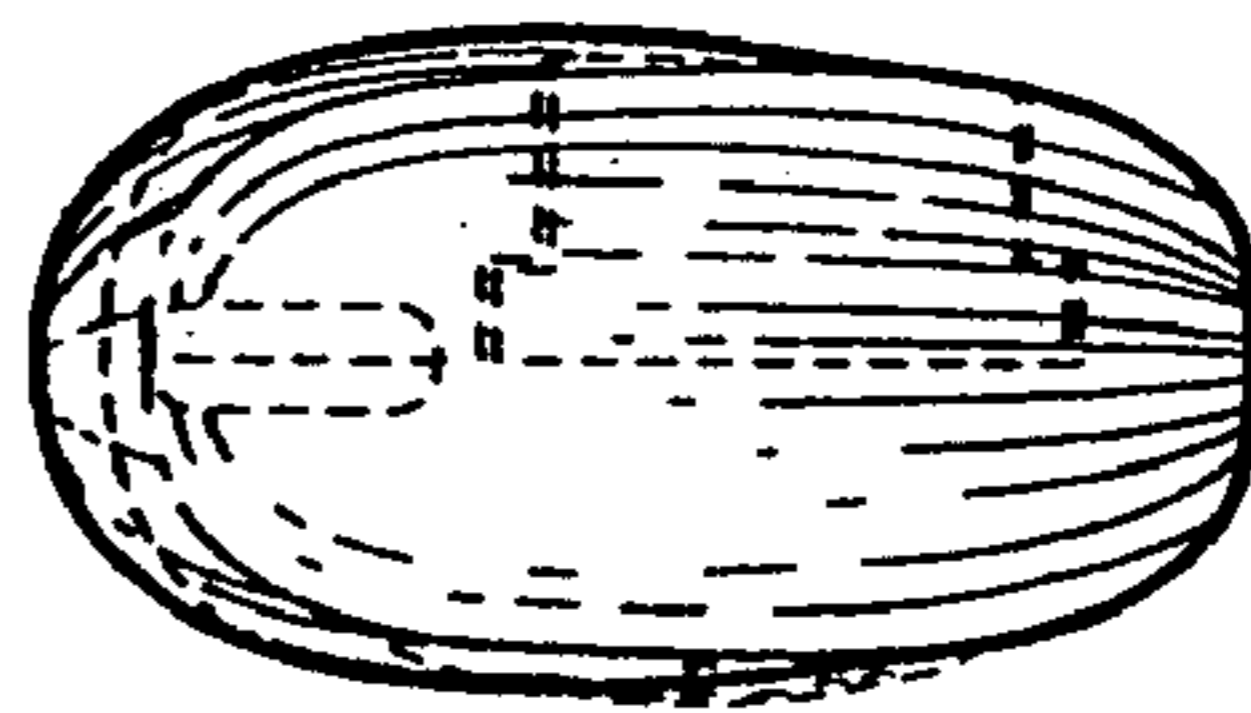
