The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the golf club head;
FIG. 2 is a left side elevational view of the golf club head;

FIG. 4 is a rear elevational view of the golf club head;

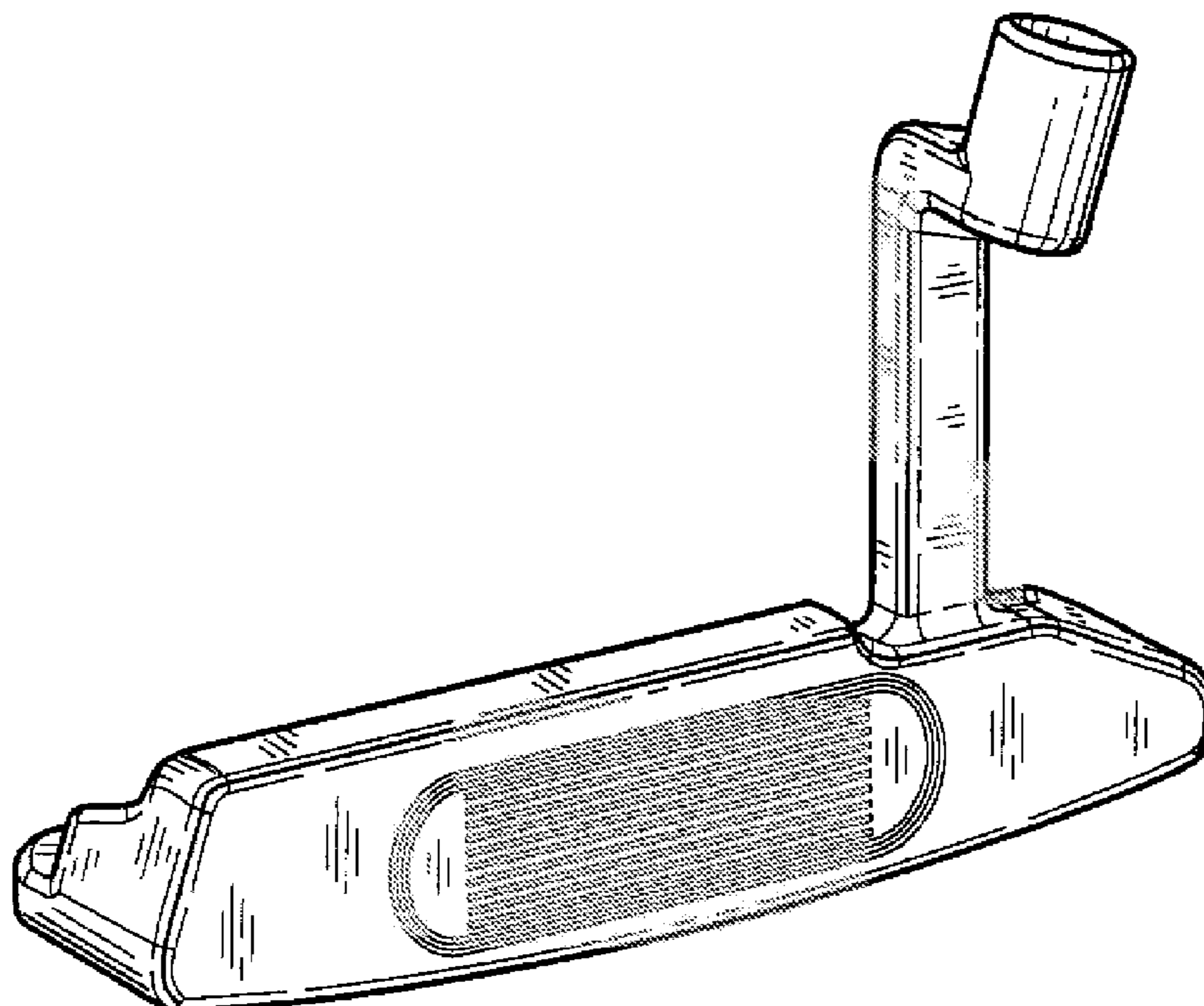

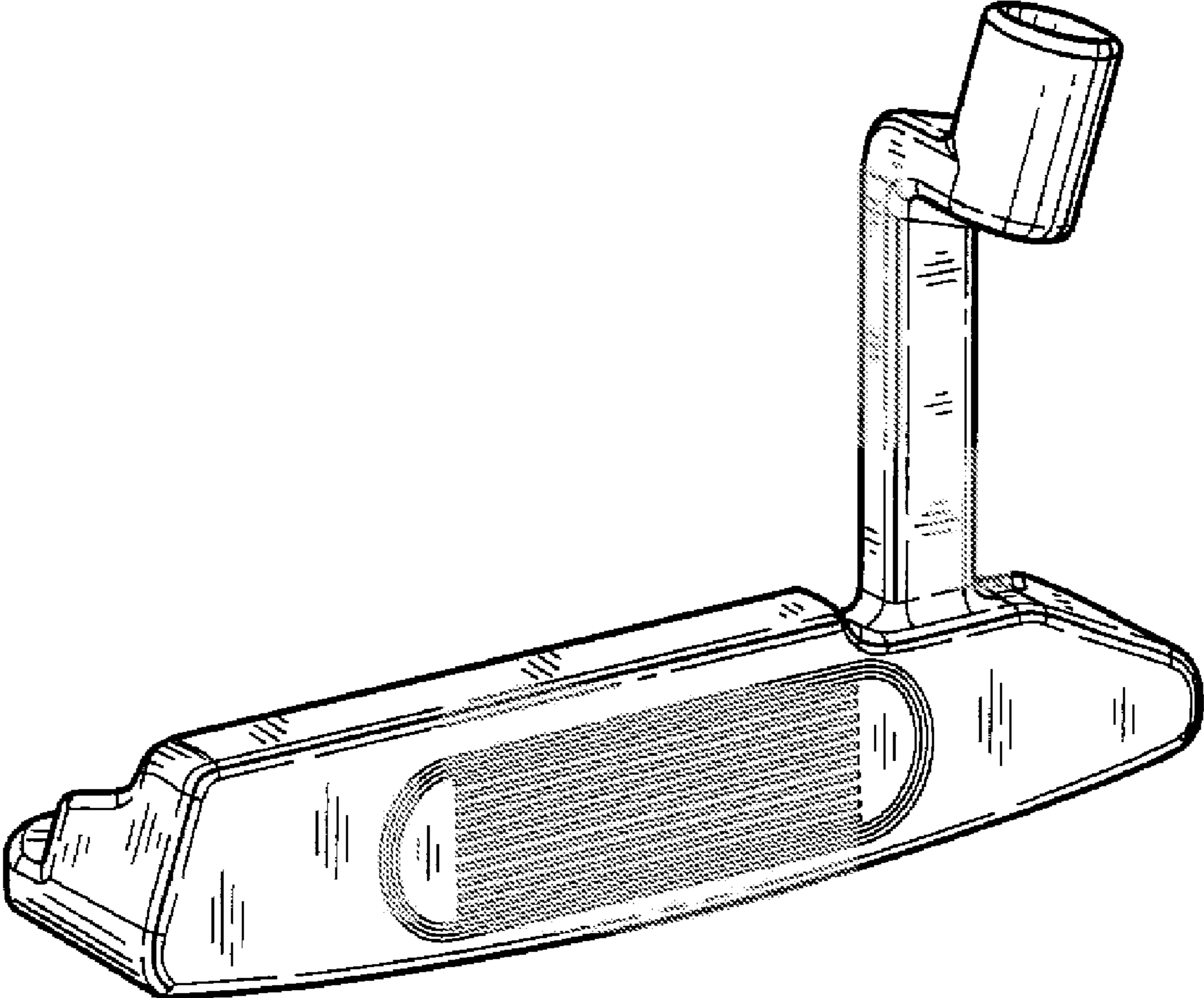

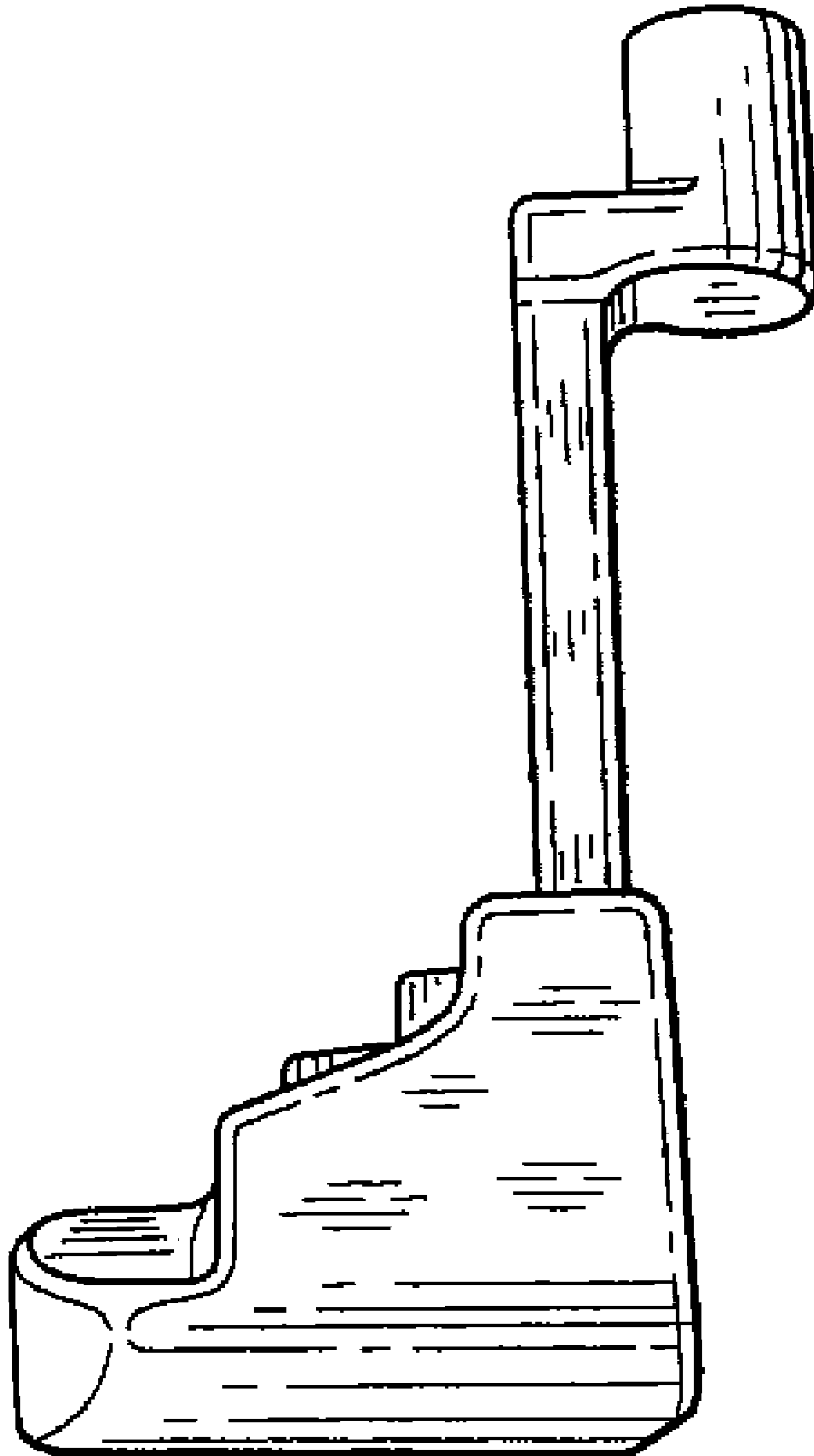

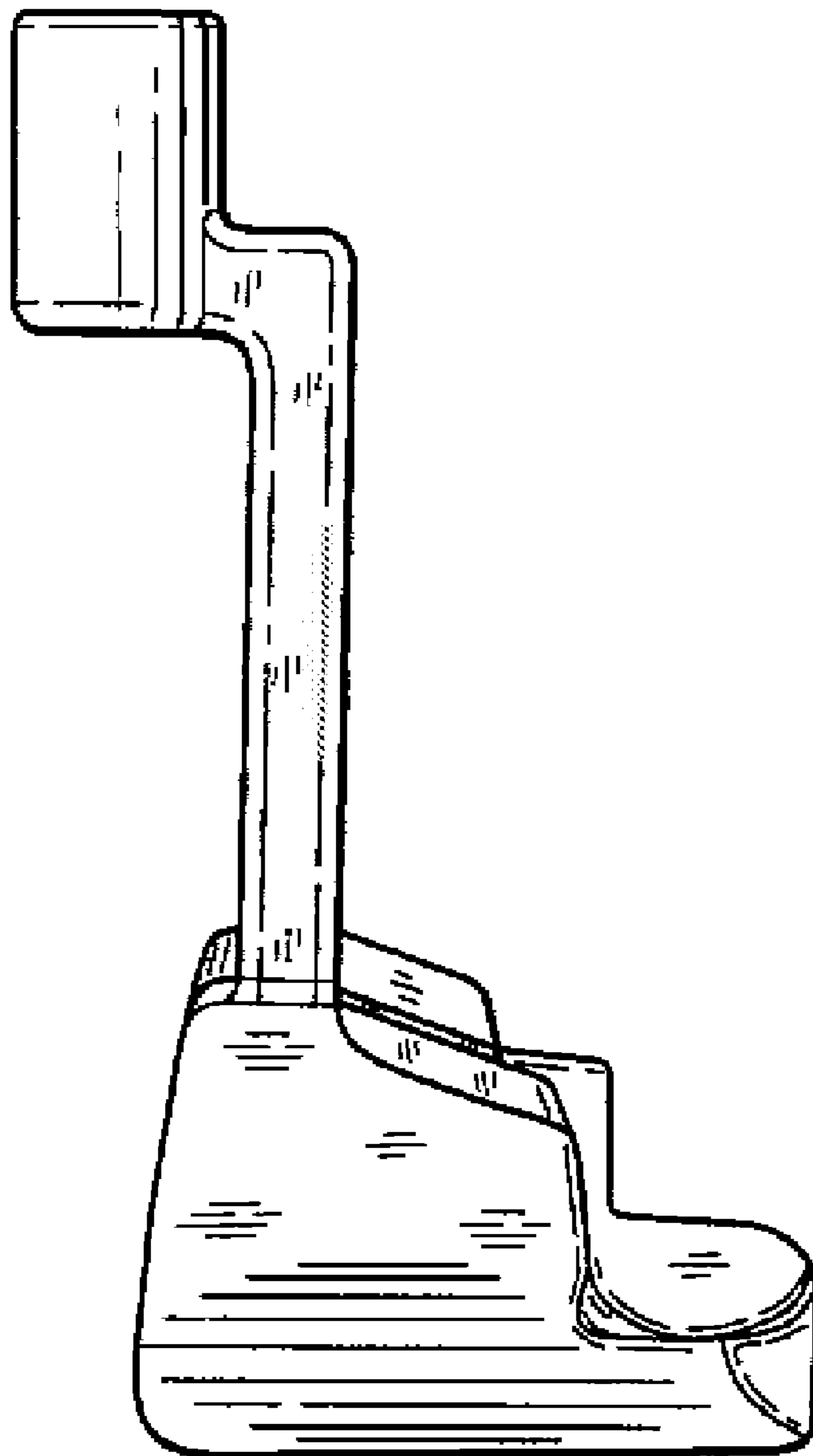

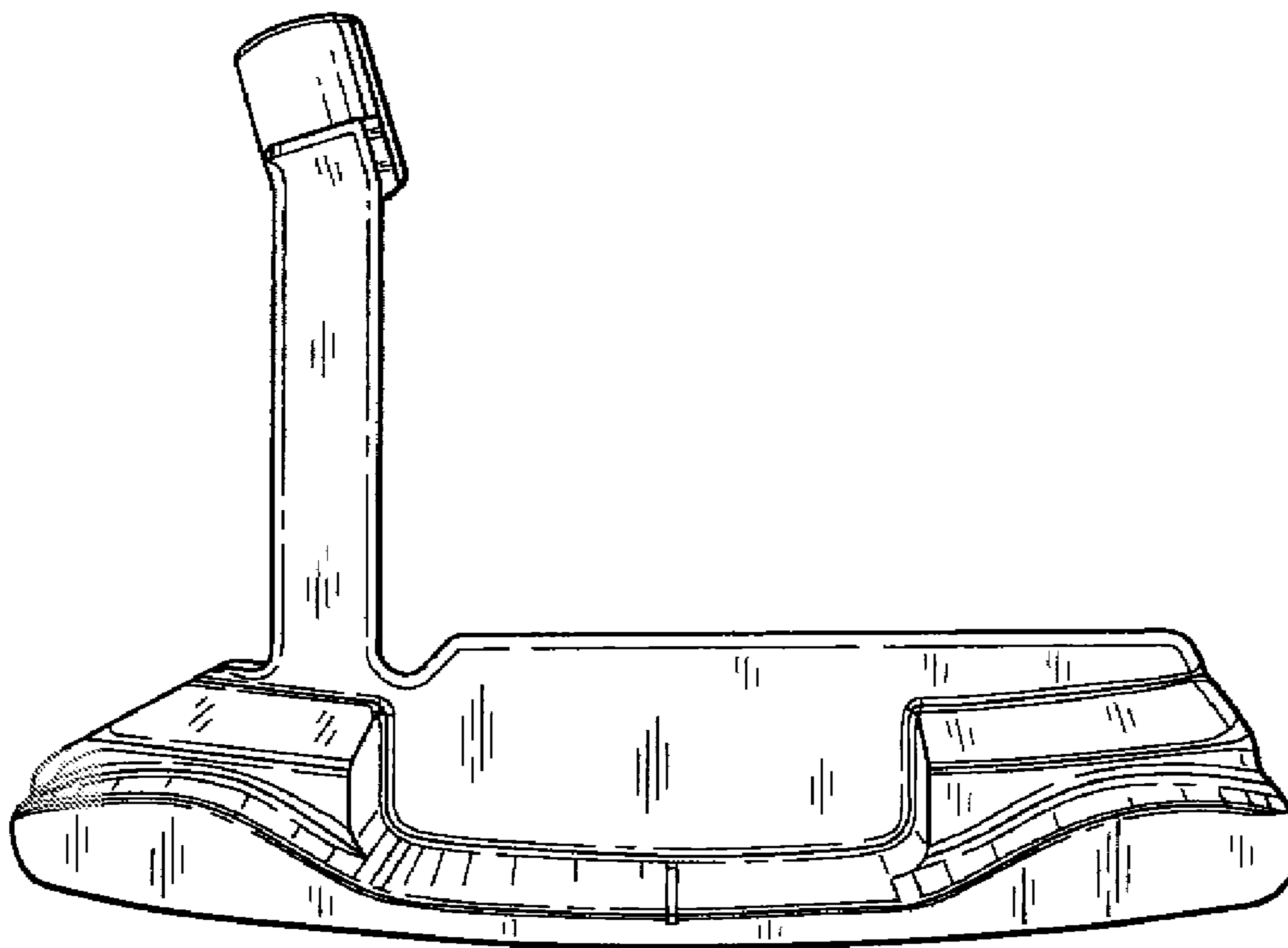

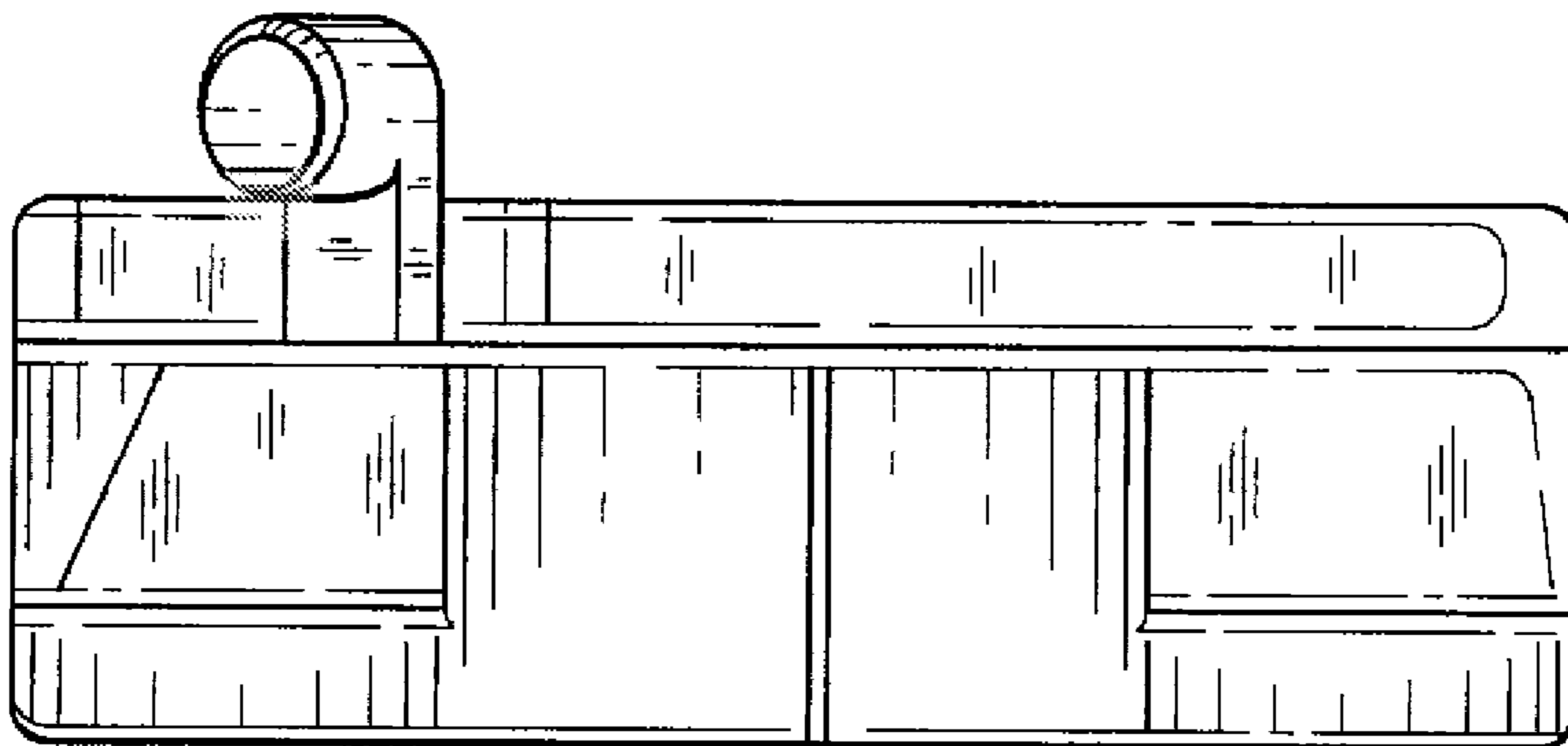

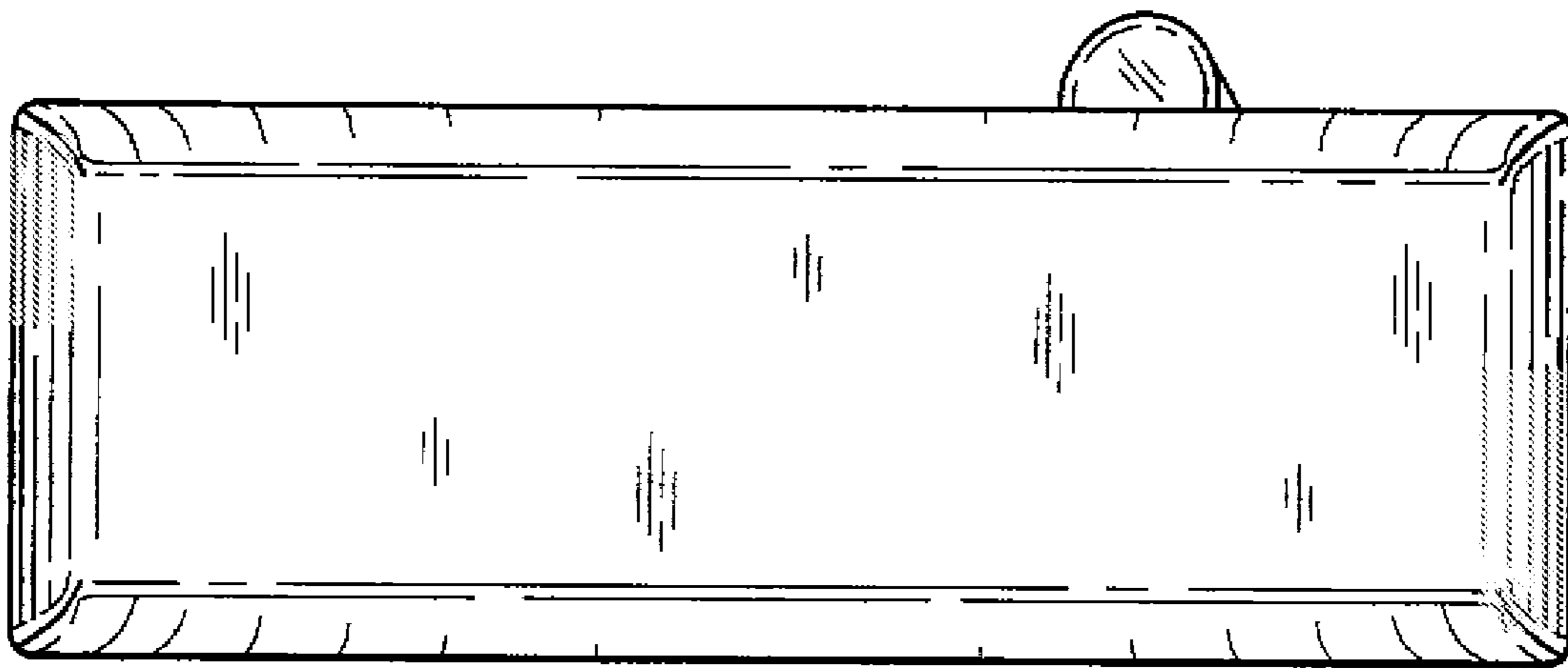
