The ornamental design for a cleaning star for M16/AR-15, as shown and described.

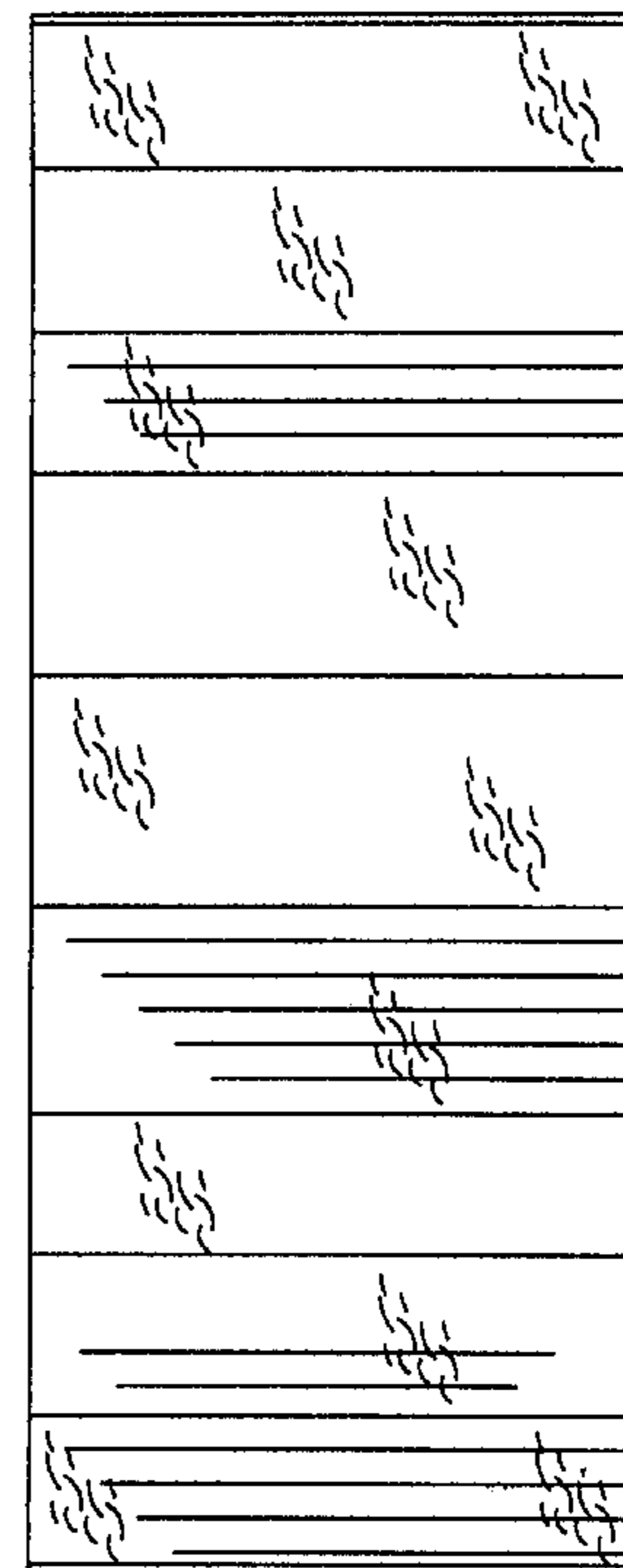
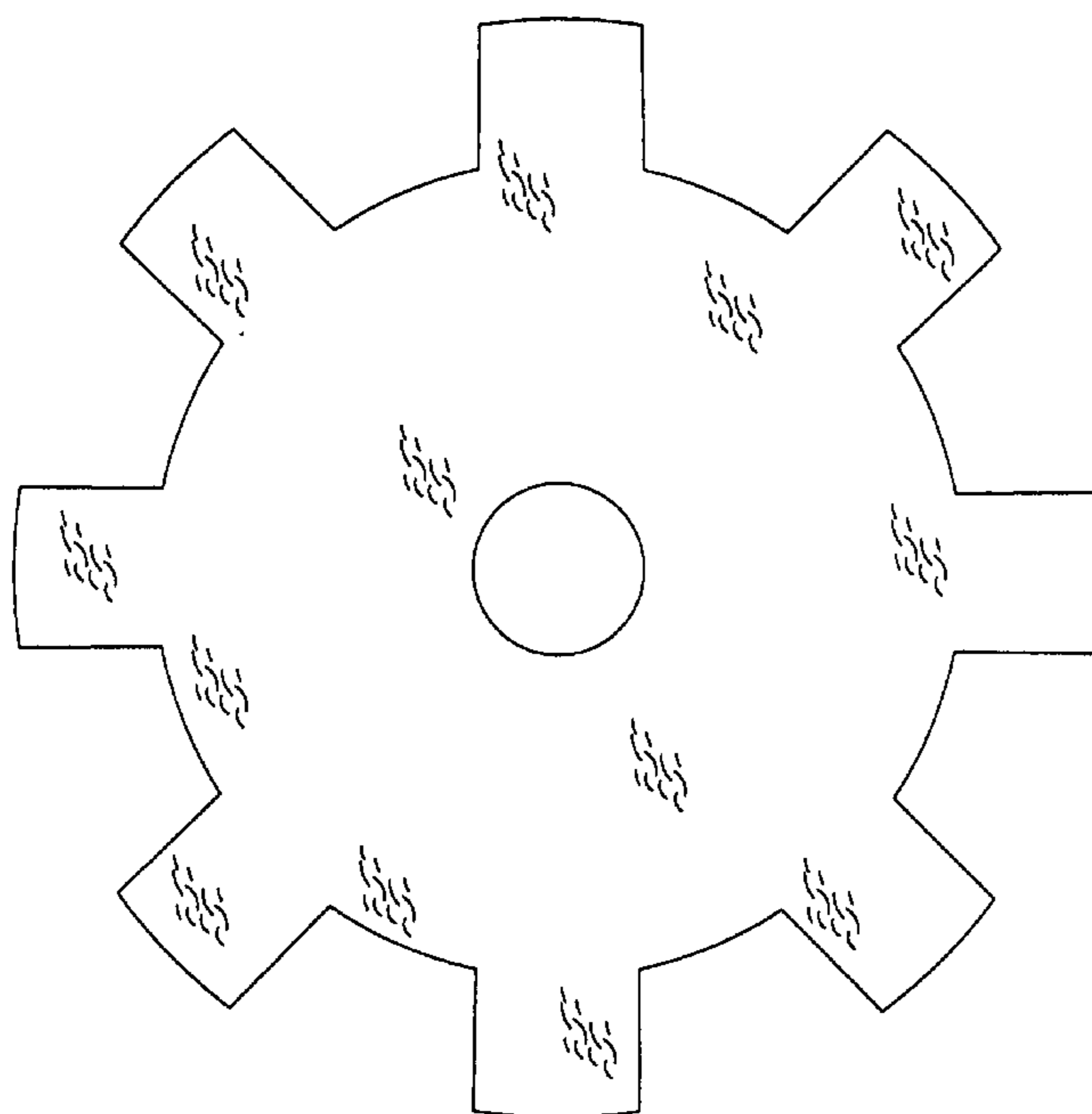
**DESCRIPTION**

FIG. 1 is an isometric drawing of the cleaning star for M16/AR-15.

FIG. 2 is a top and/or bottom view of the cleaning star for M16/AR-15, the top and bottom view being identical; and,

FIG. 3 is a side view of the cleaning star for M16/AR-15, the view from any side being symmetrical.

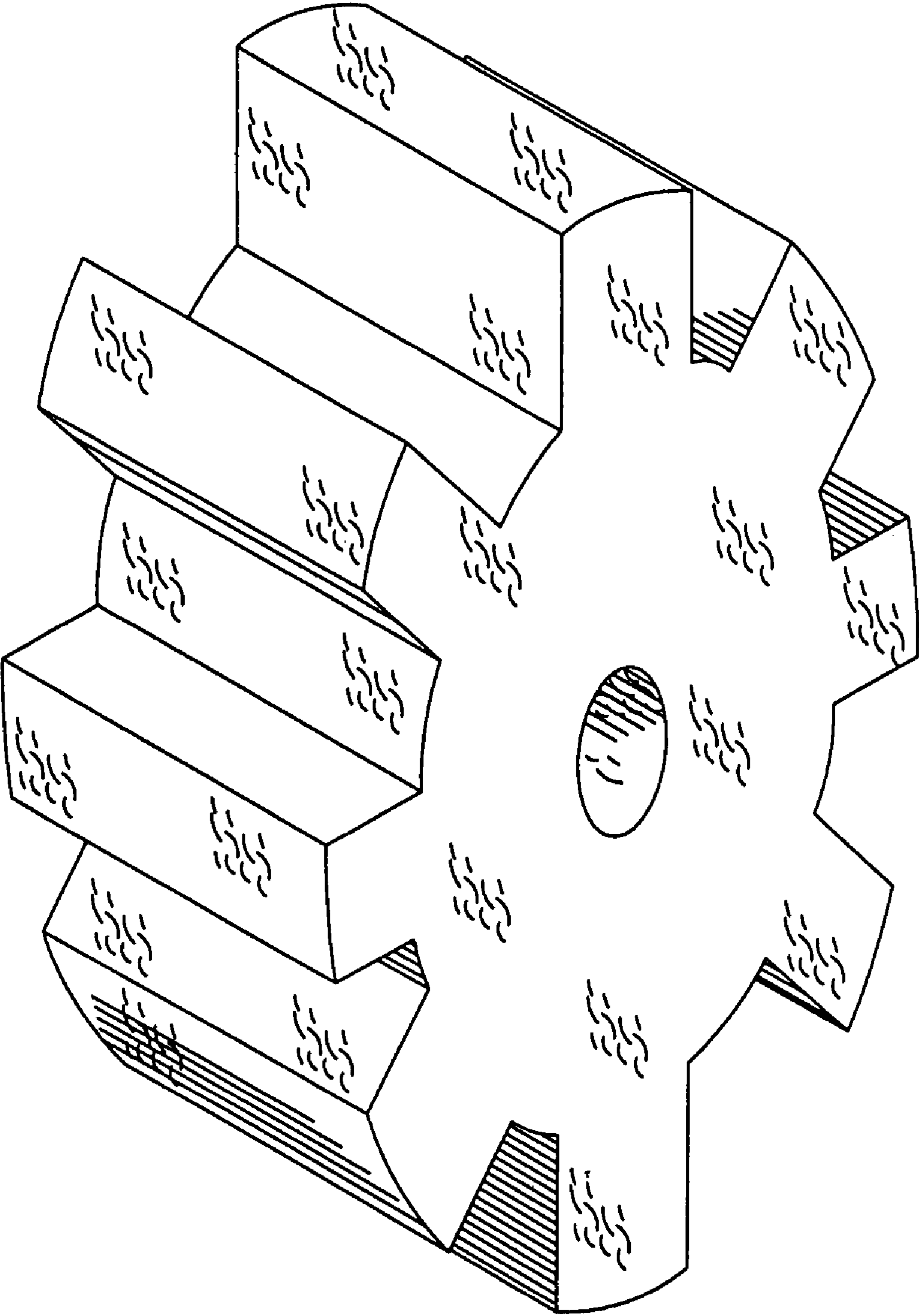

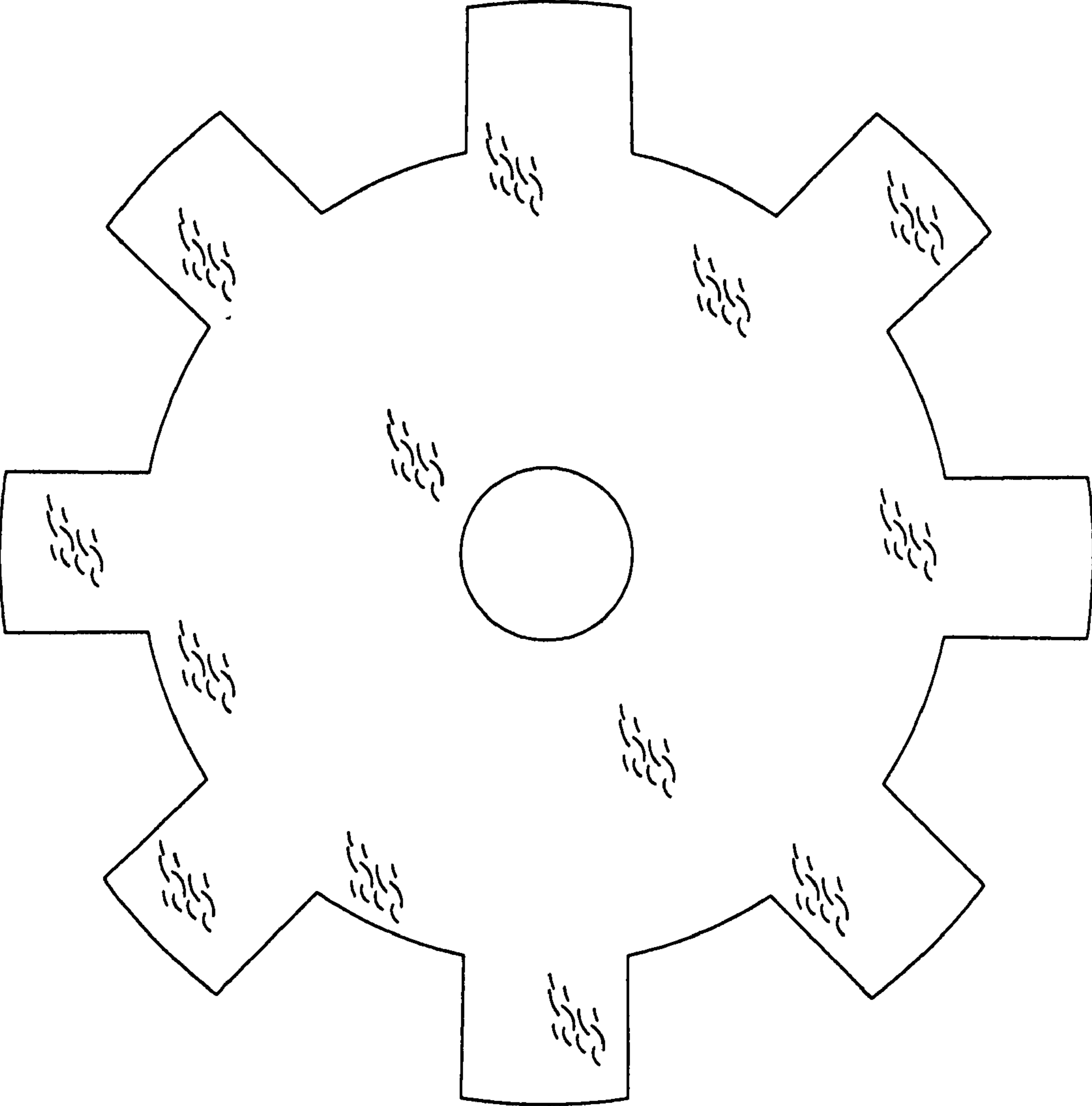

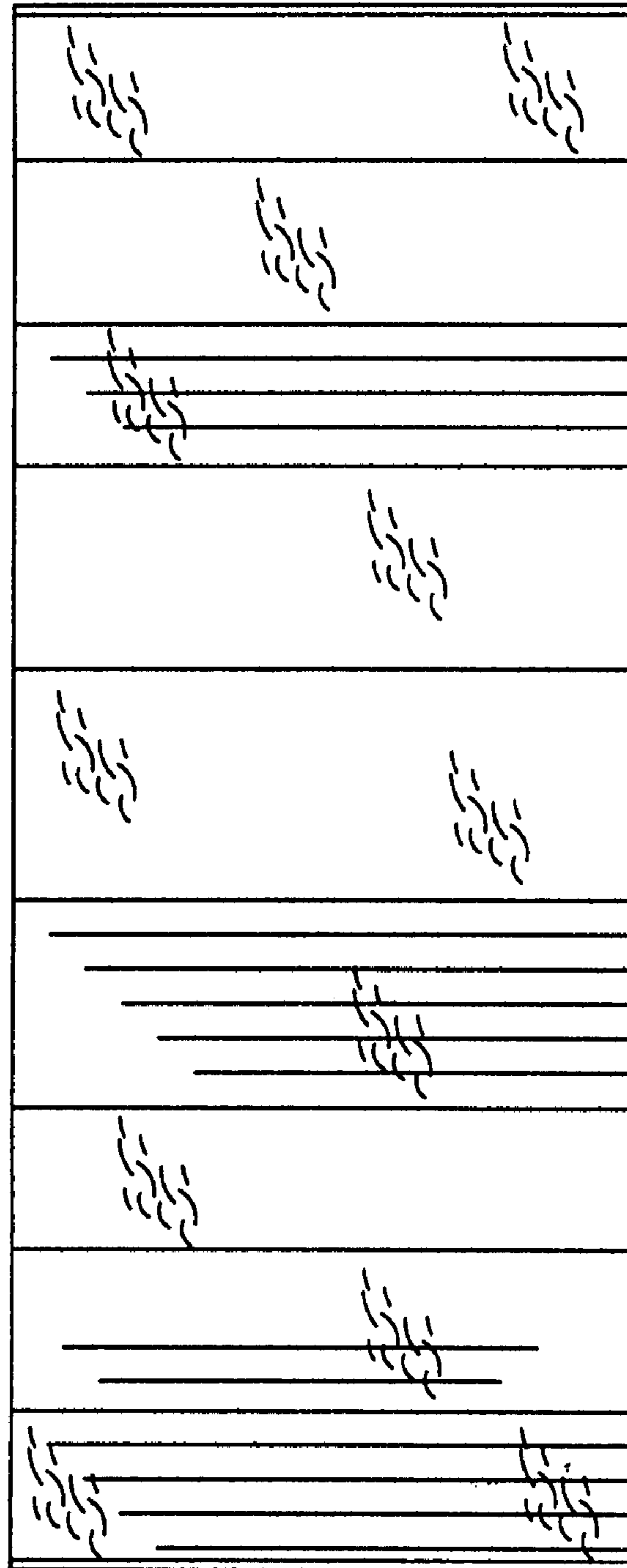
