FIG. 3 is a rear view thereof;

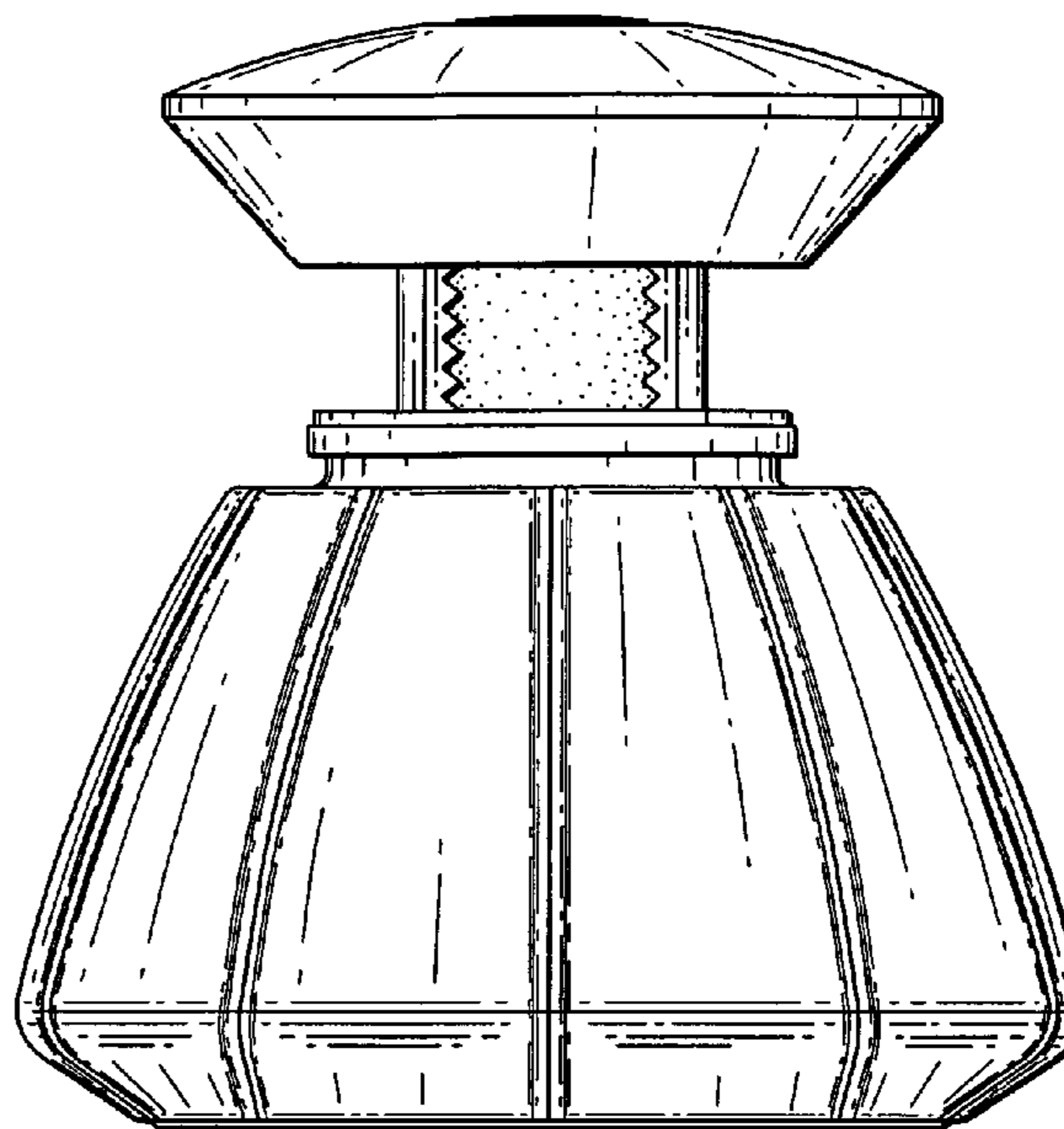
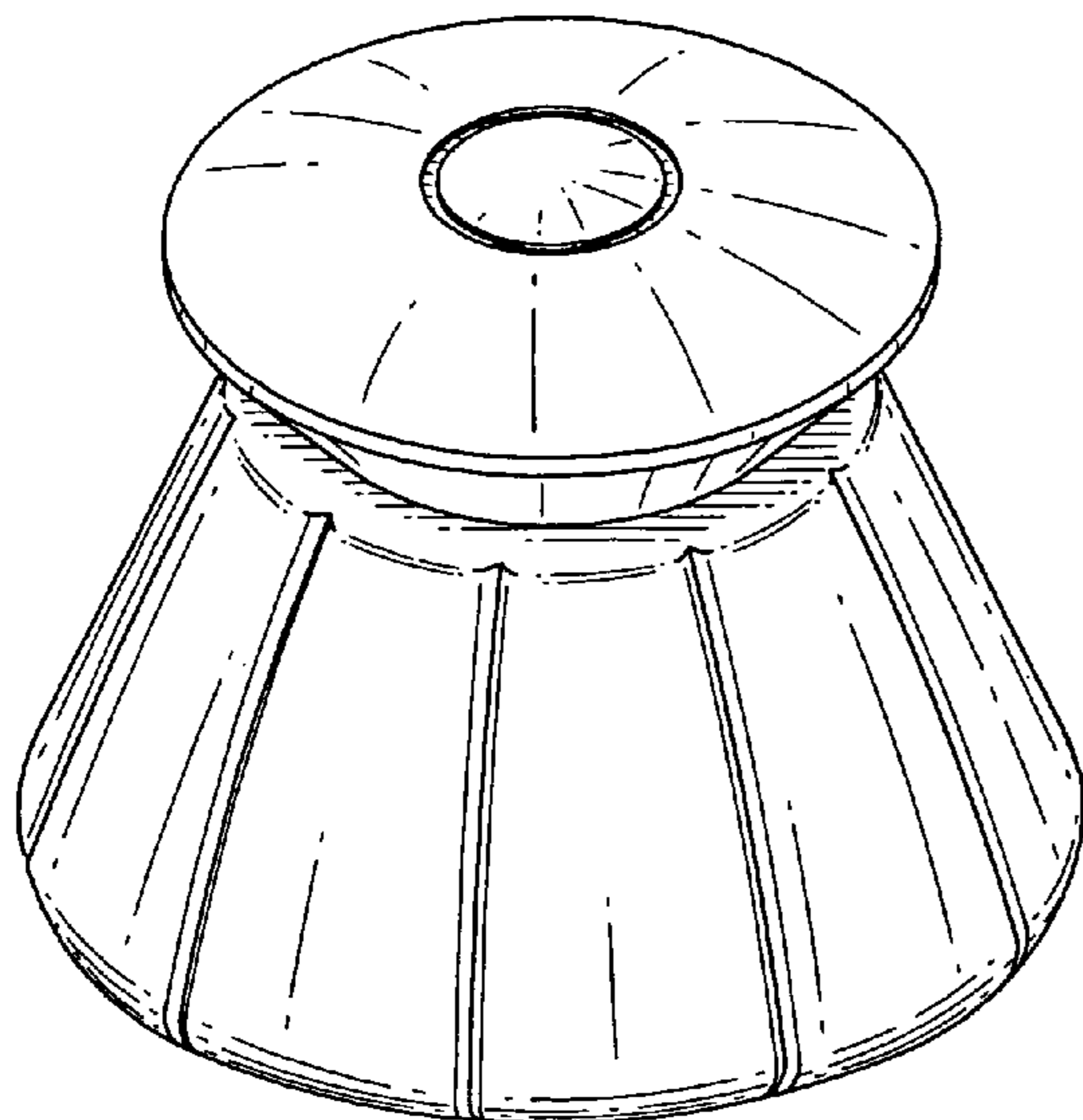
FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

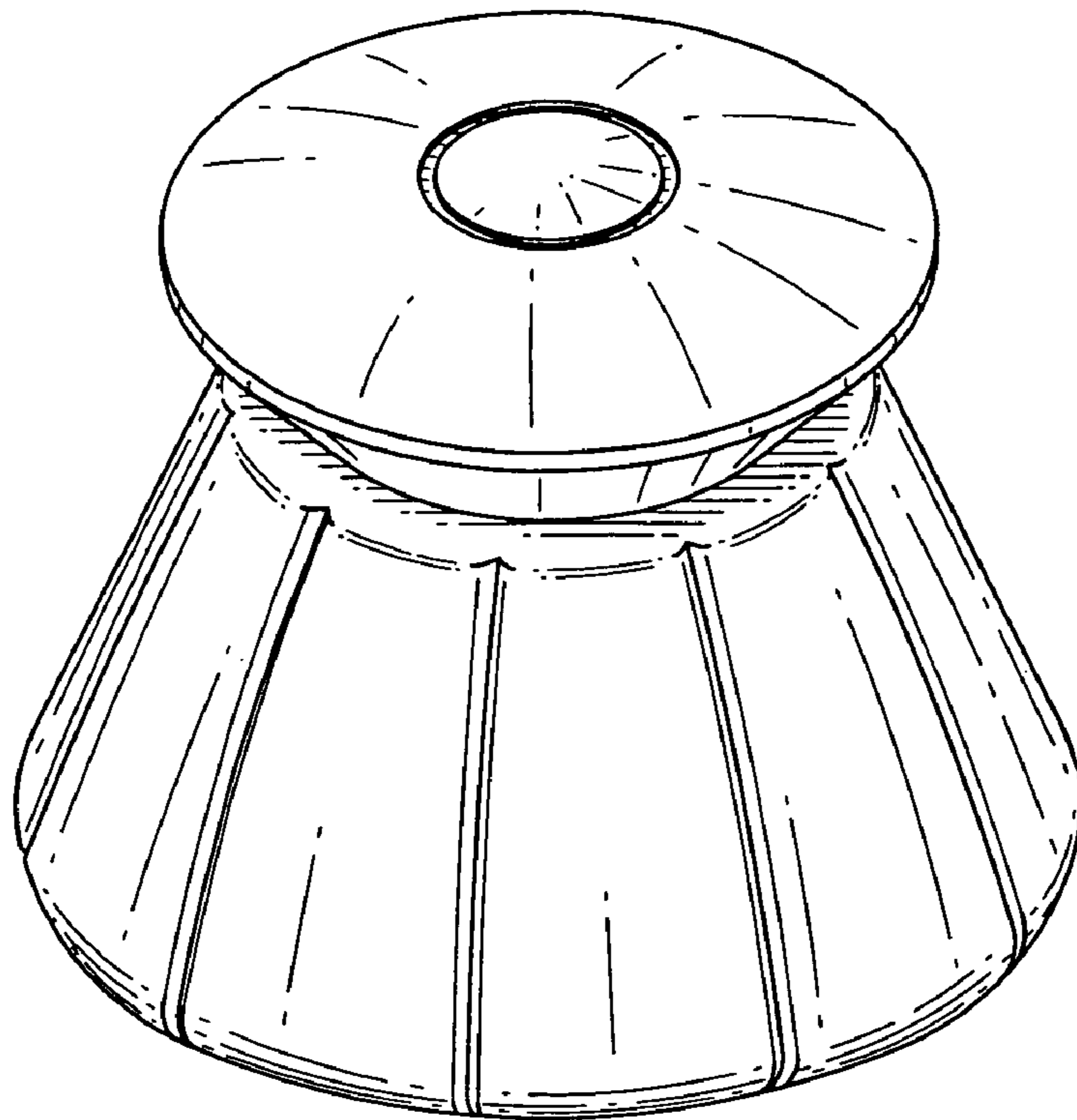
FIG. 6 is front view of the evaporator in the fully open position; and,

FIG. 7 is a side view of the evaporator in the fully open position.

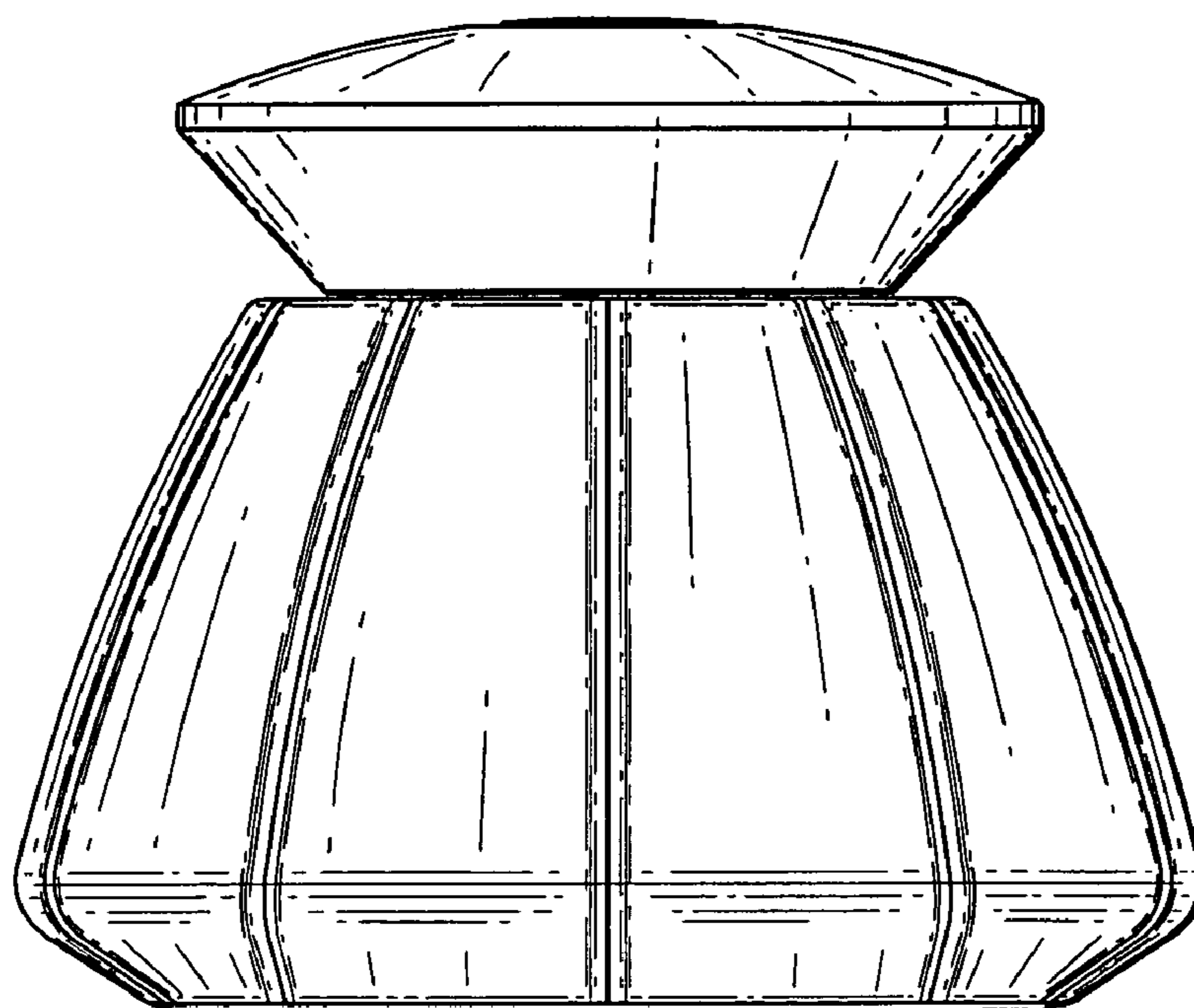

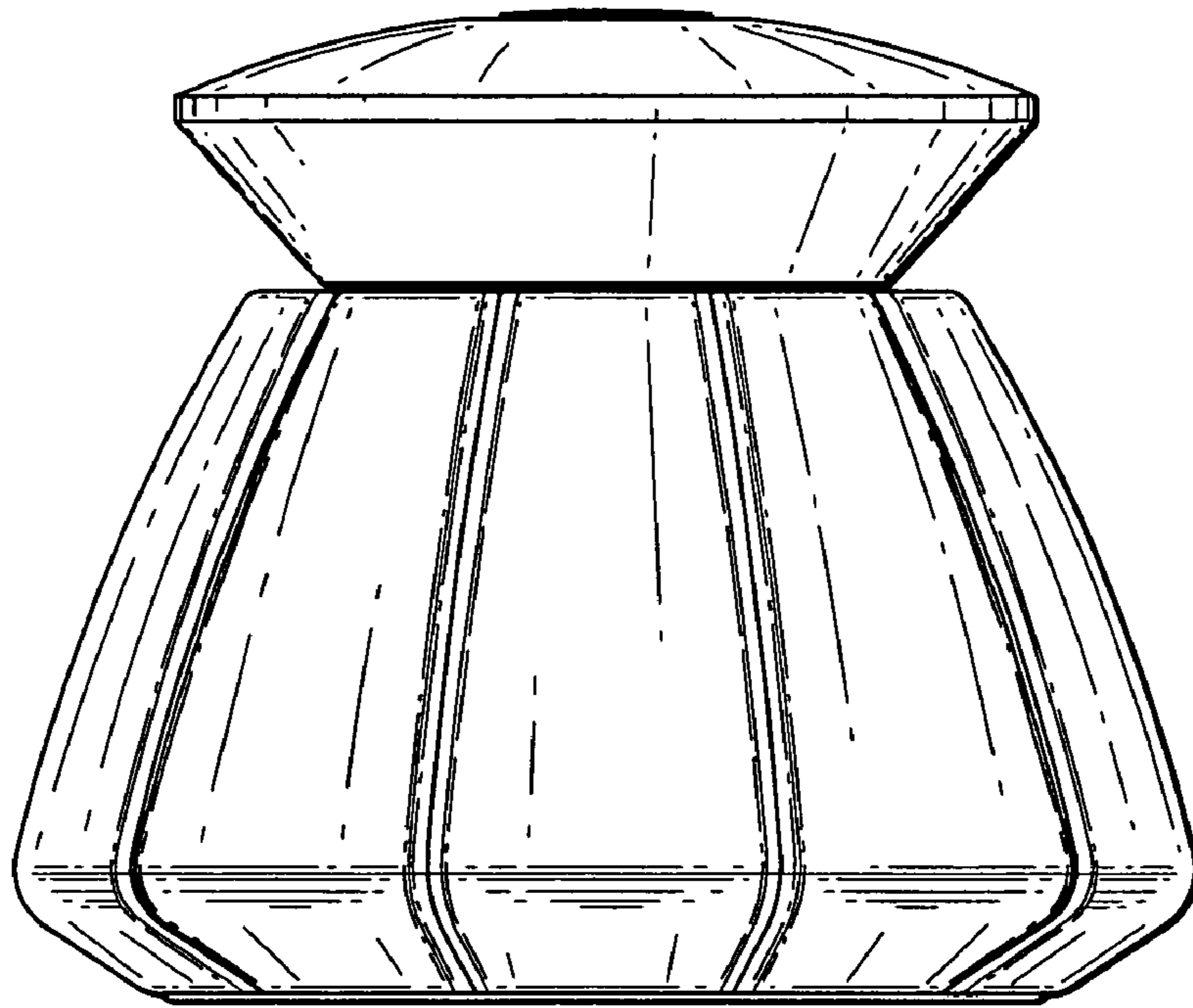

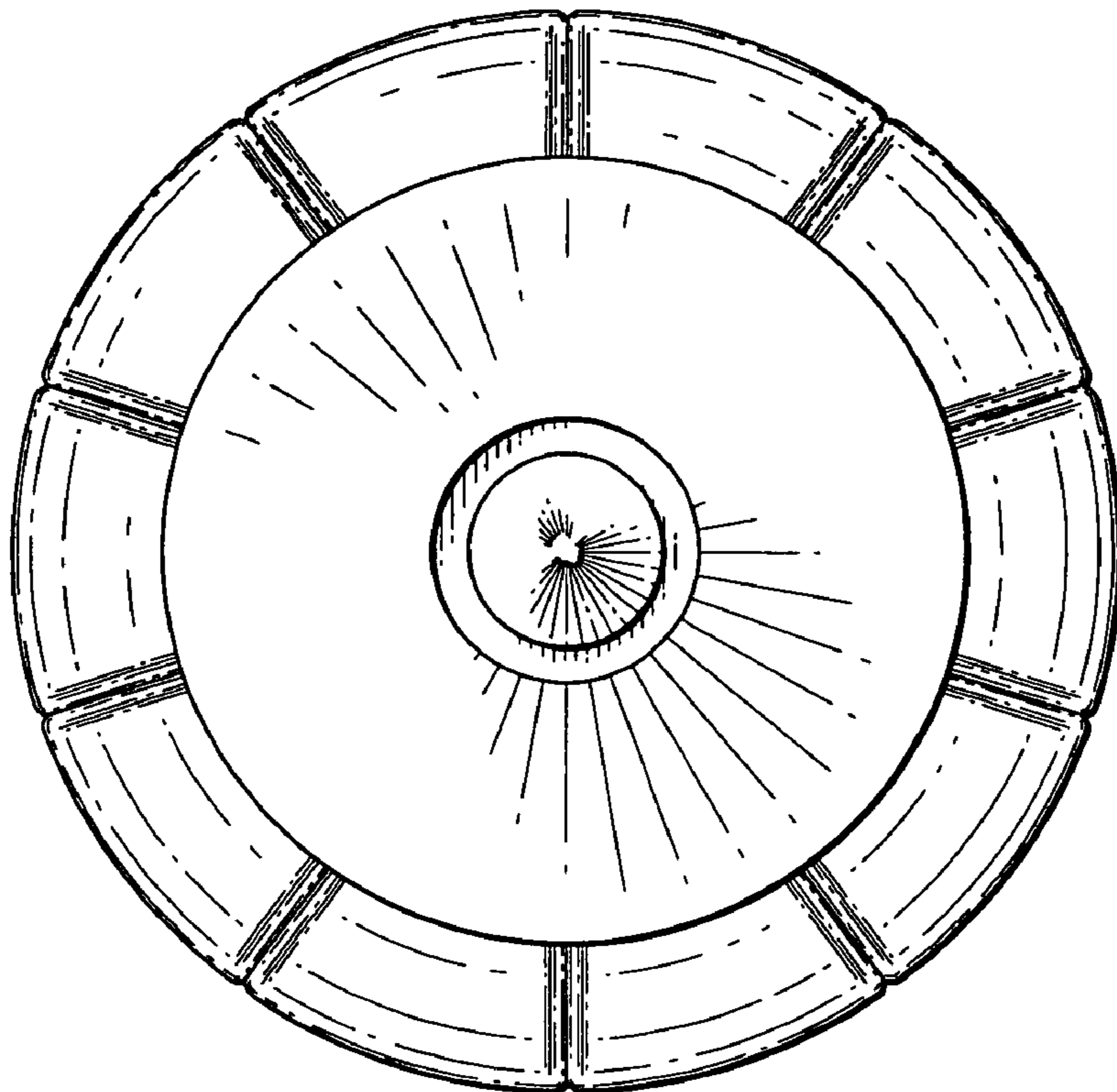

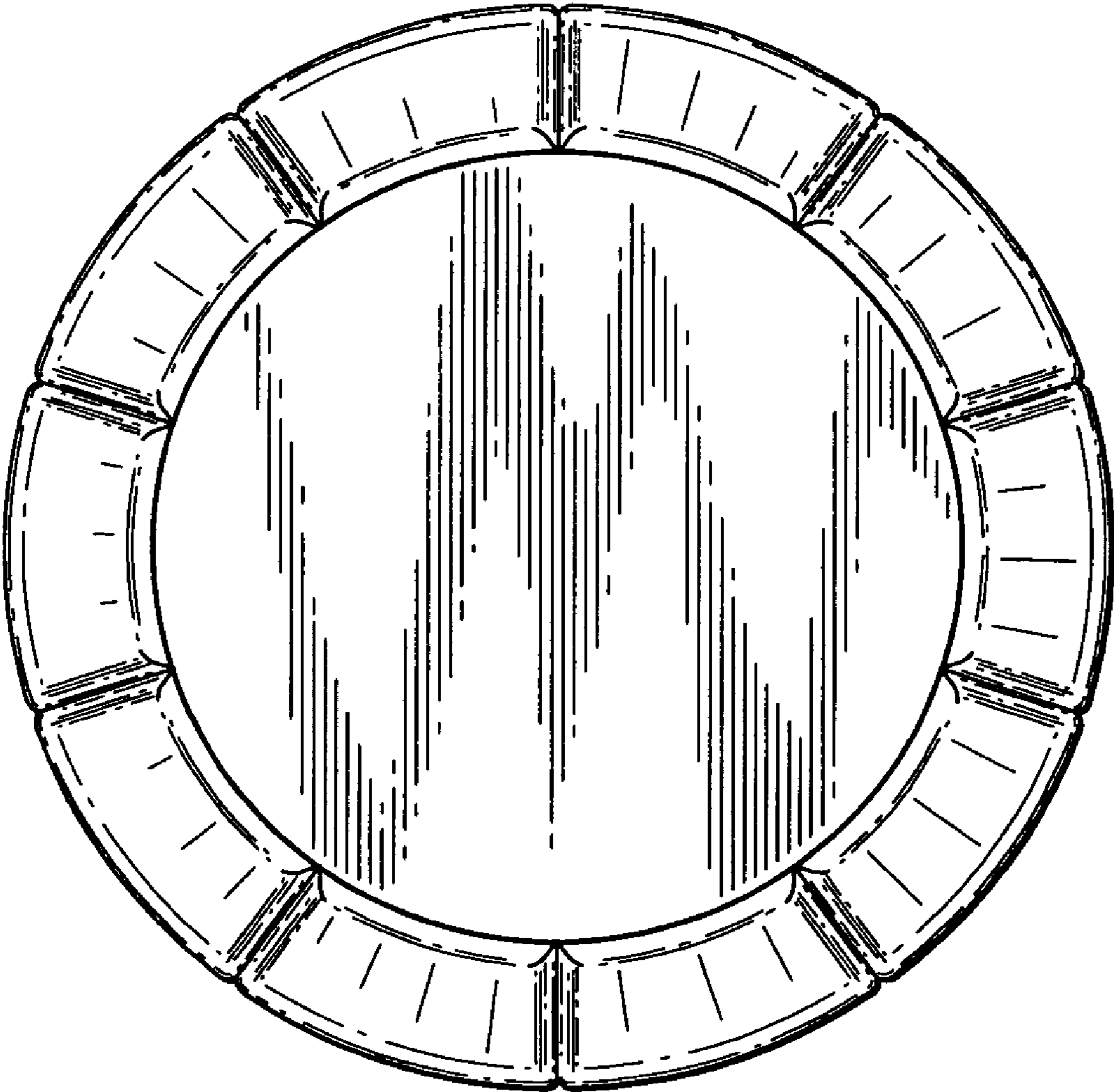

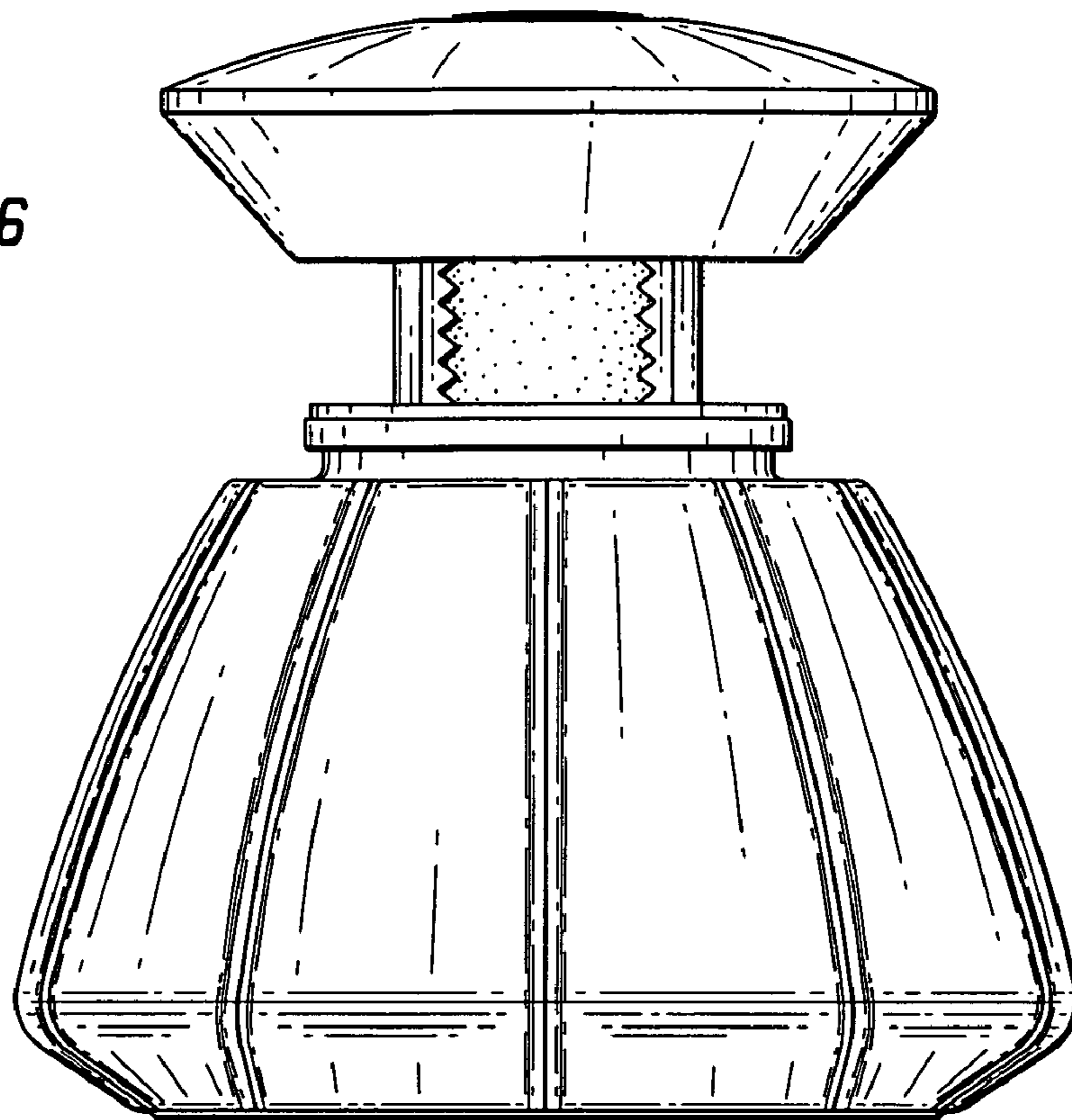
