FIG. 6 is a rear view thereof, the left side view being a mirror image of the right side view; and,

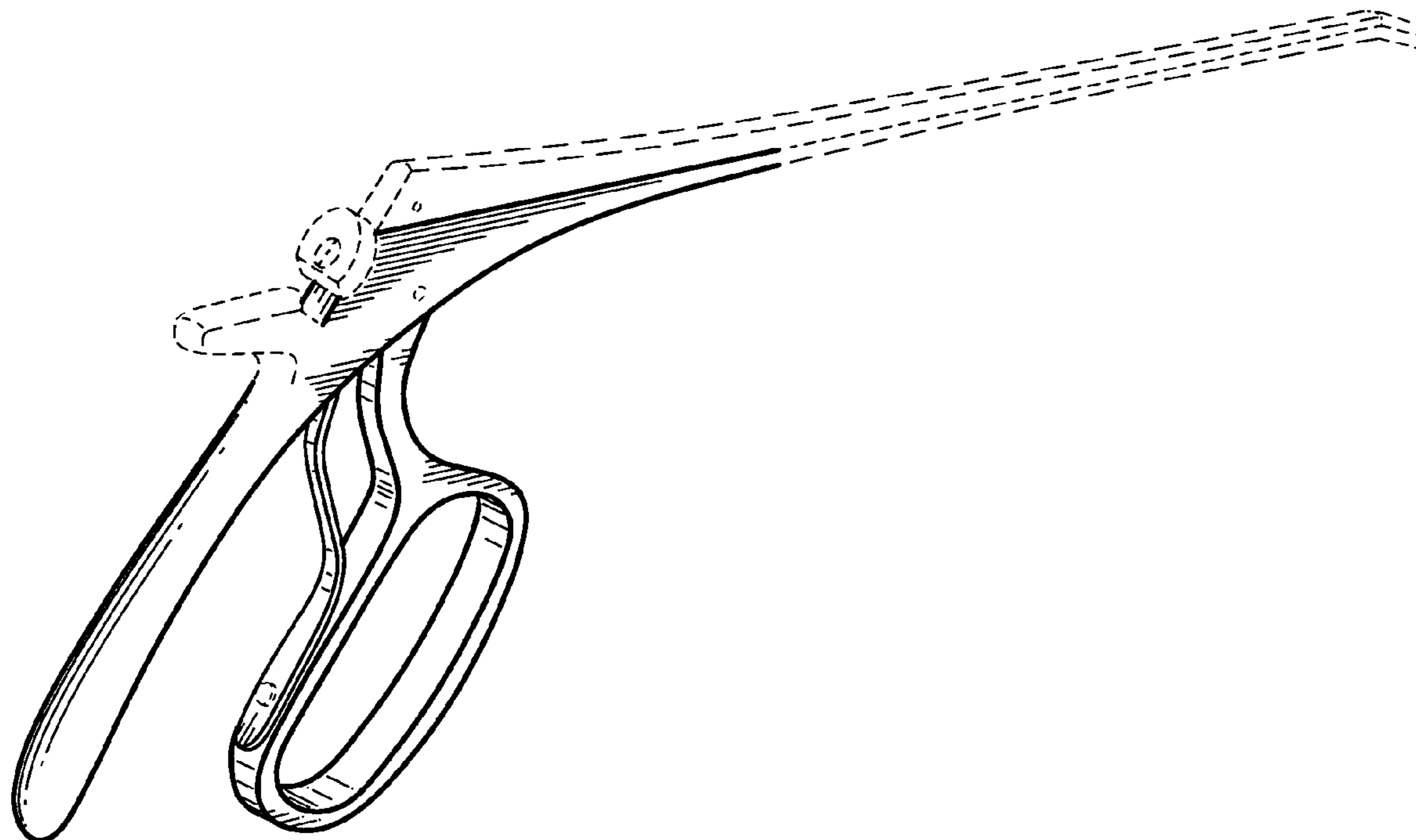
FIG. 7 is a front view thereof.

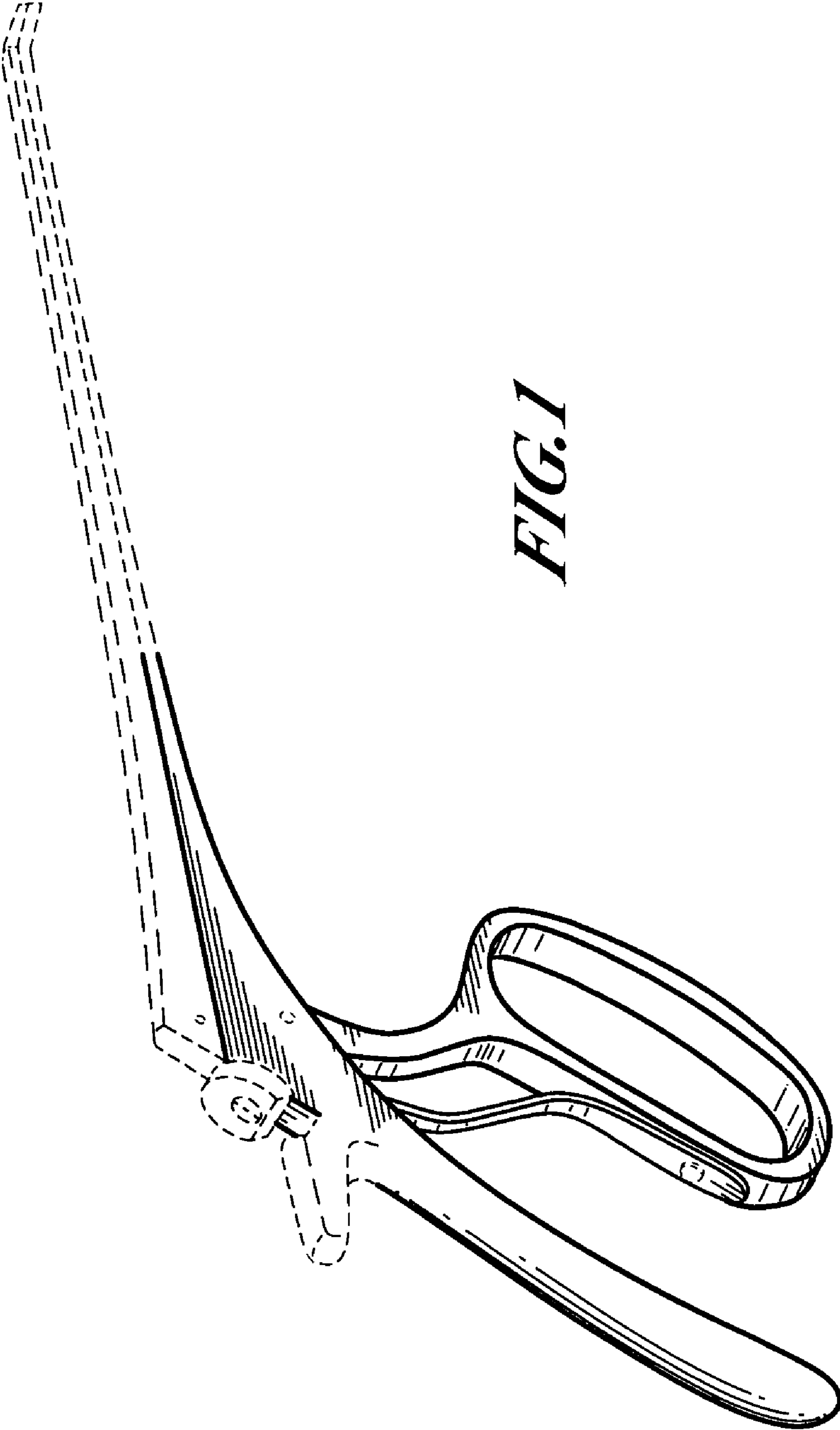

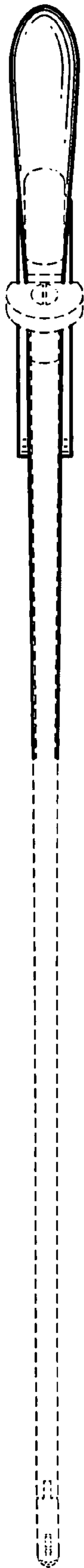

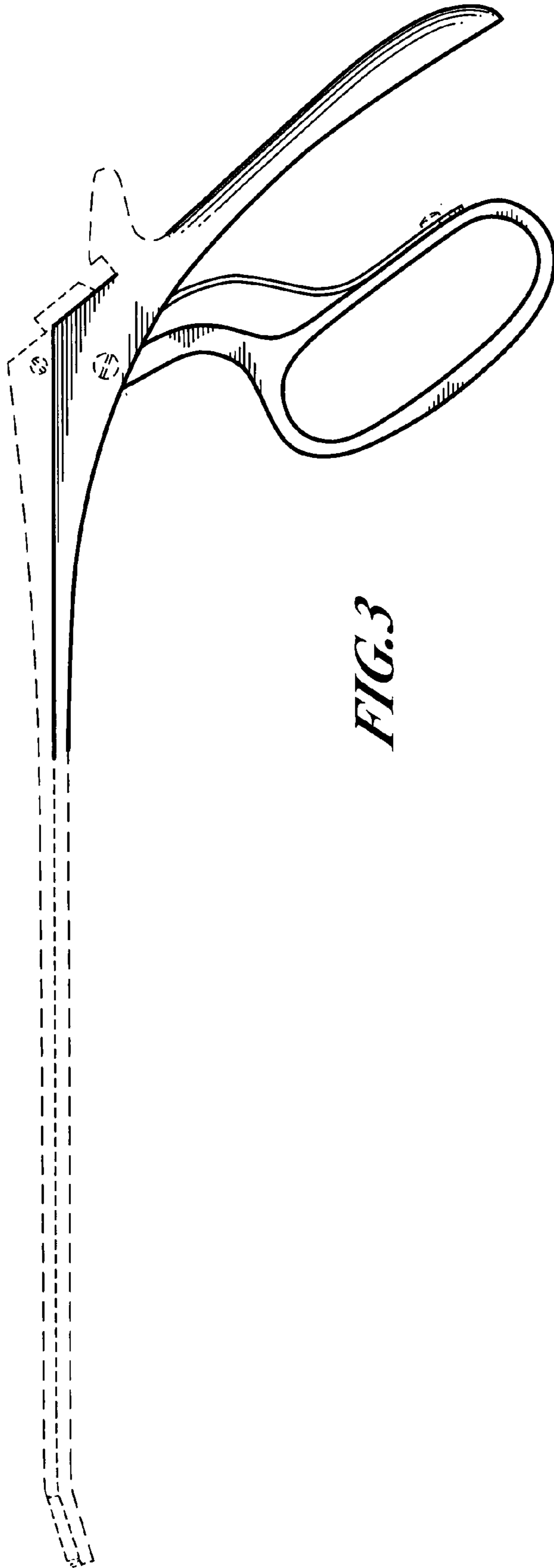

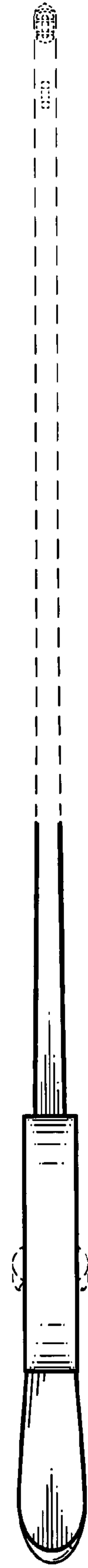
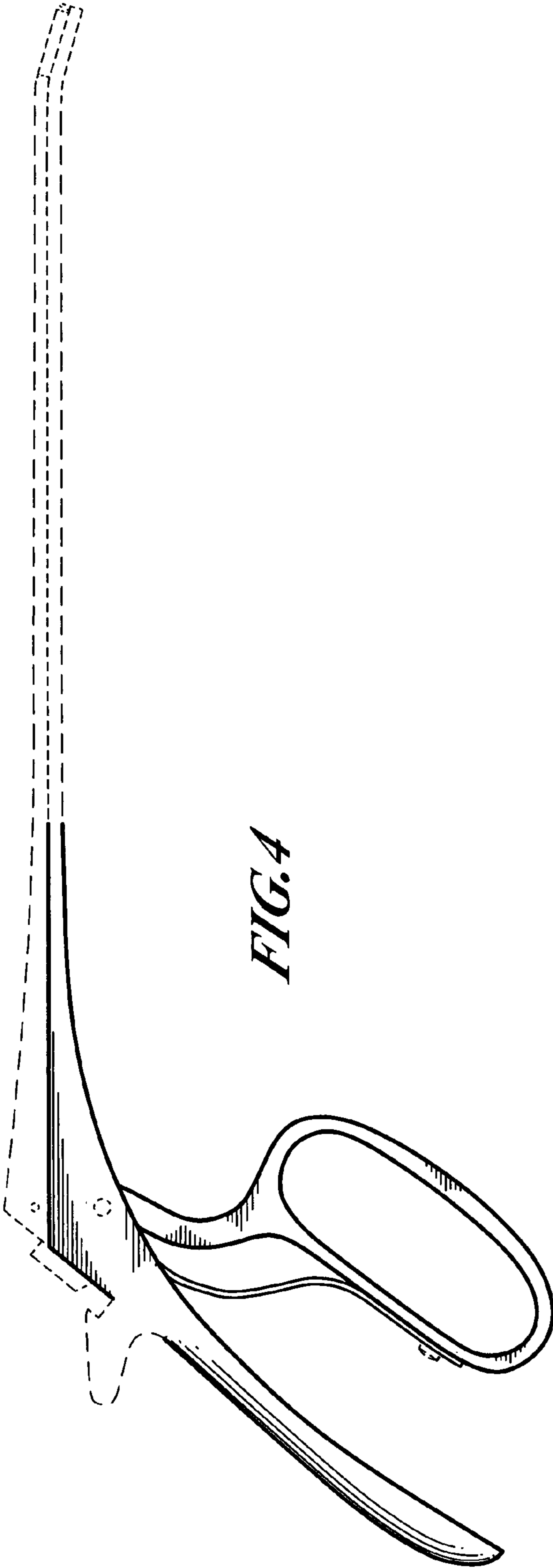

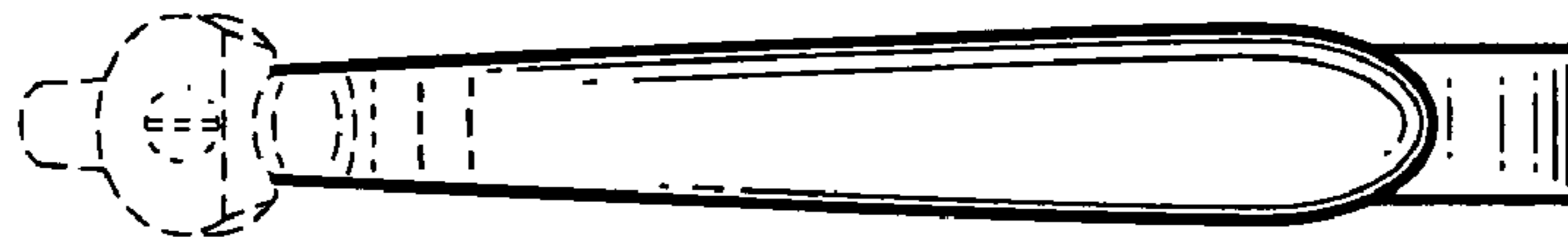
