(57) **CLAIM**

I claim the ornamental design for a behind the ear sound processor, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a behind the ear sound processor constructed in accordance with one embodiment of the present invention;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a top side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a bottom side elevation view thereof;

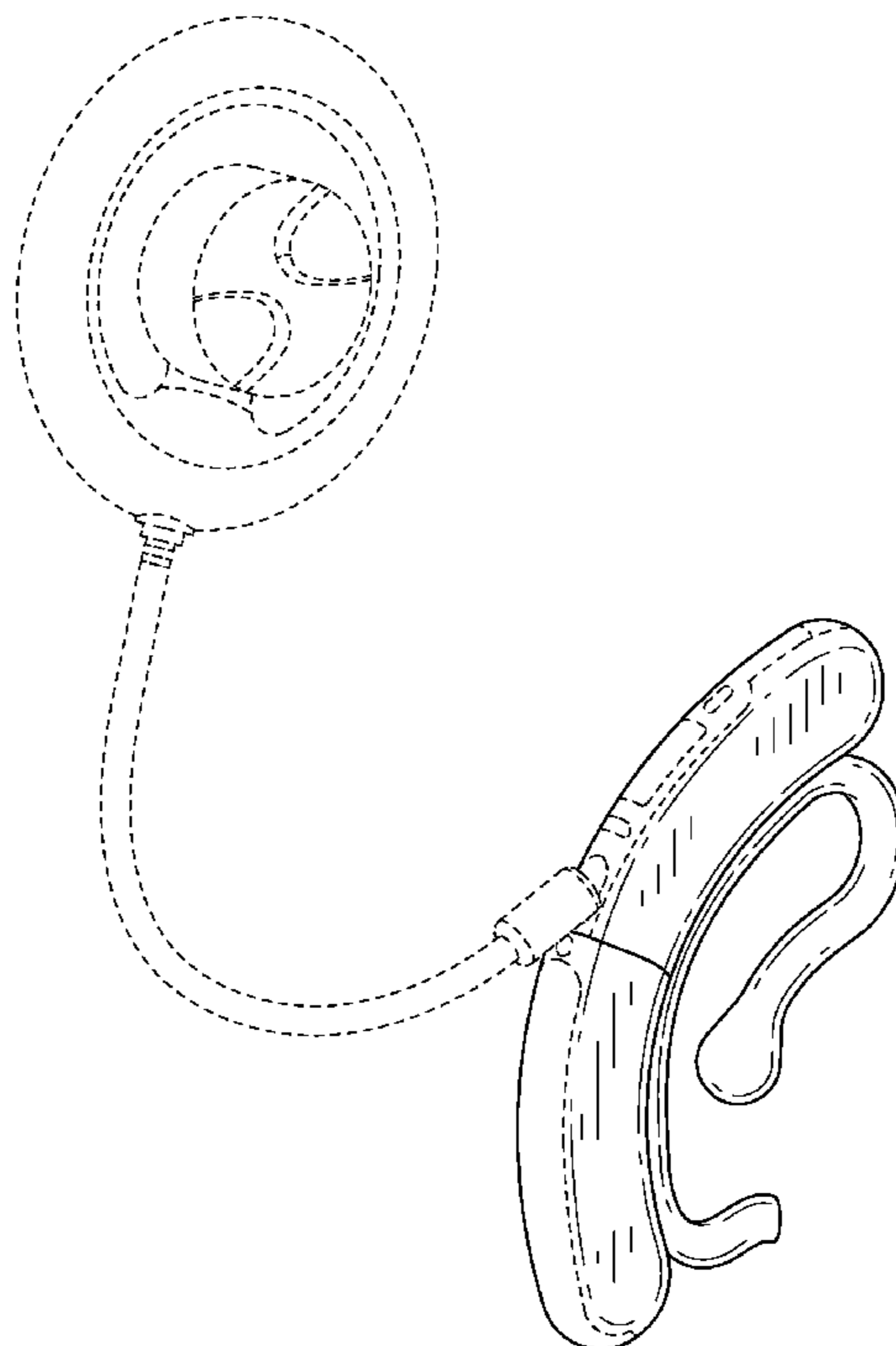

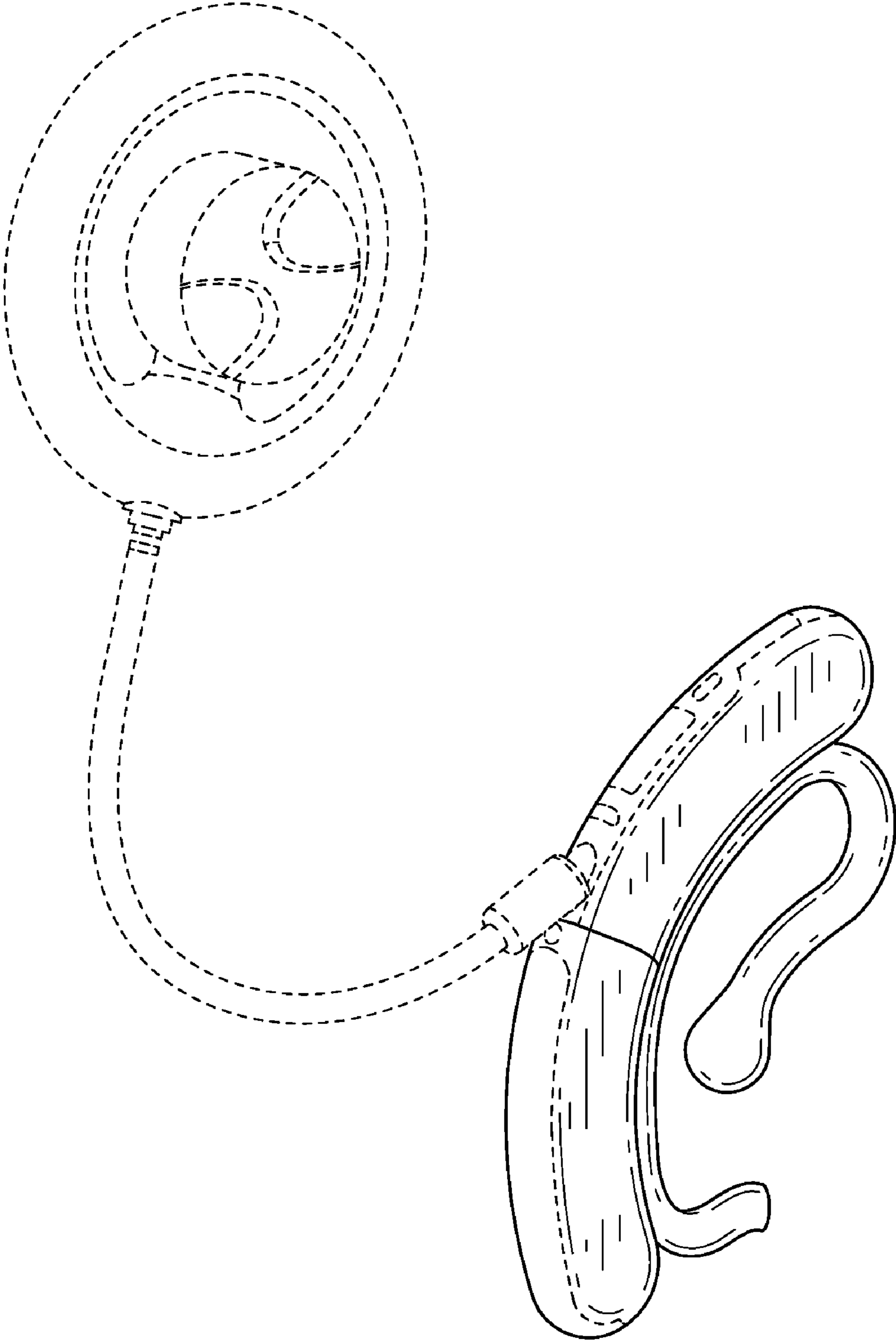

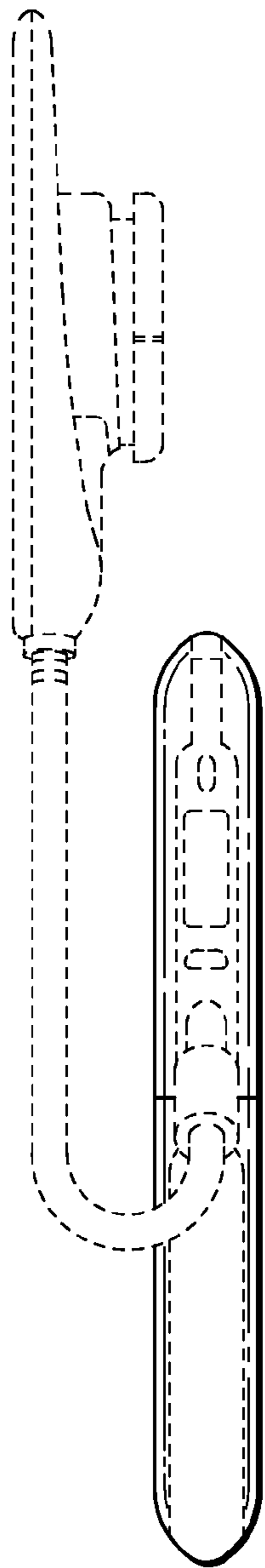

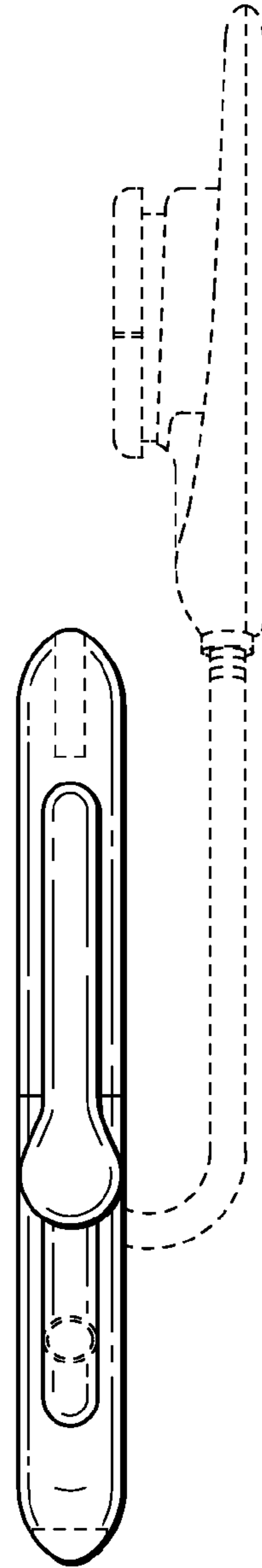

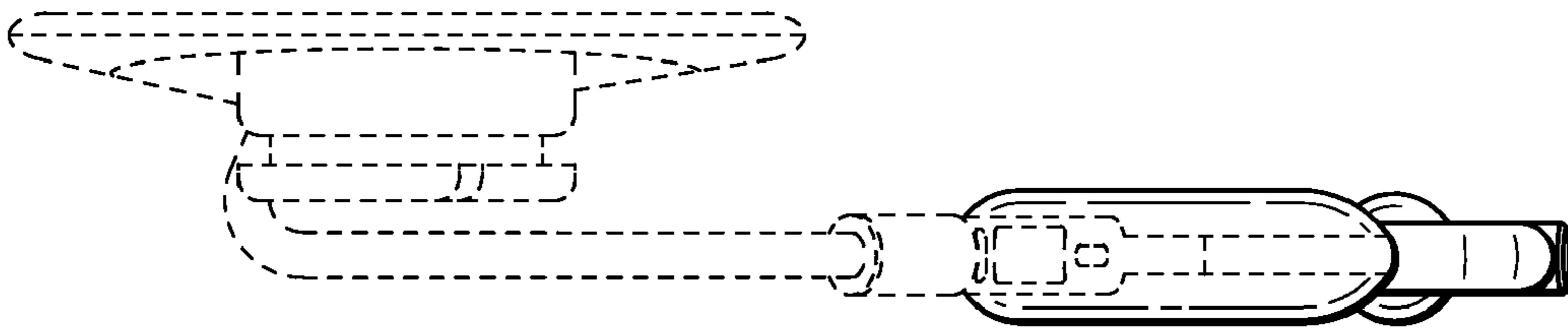

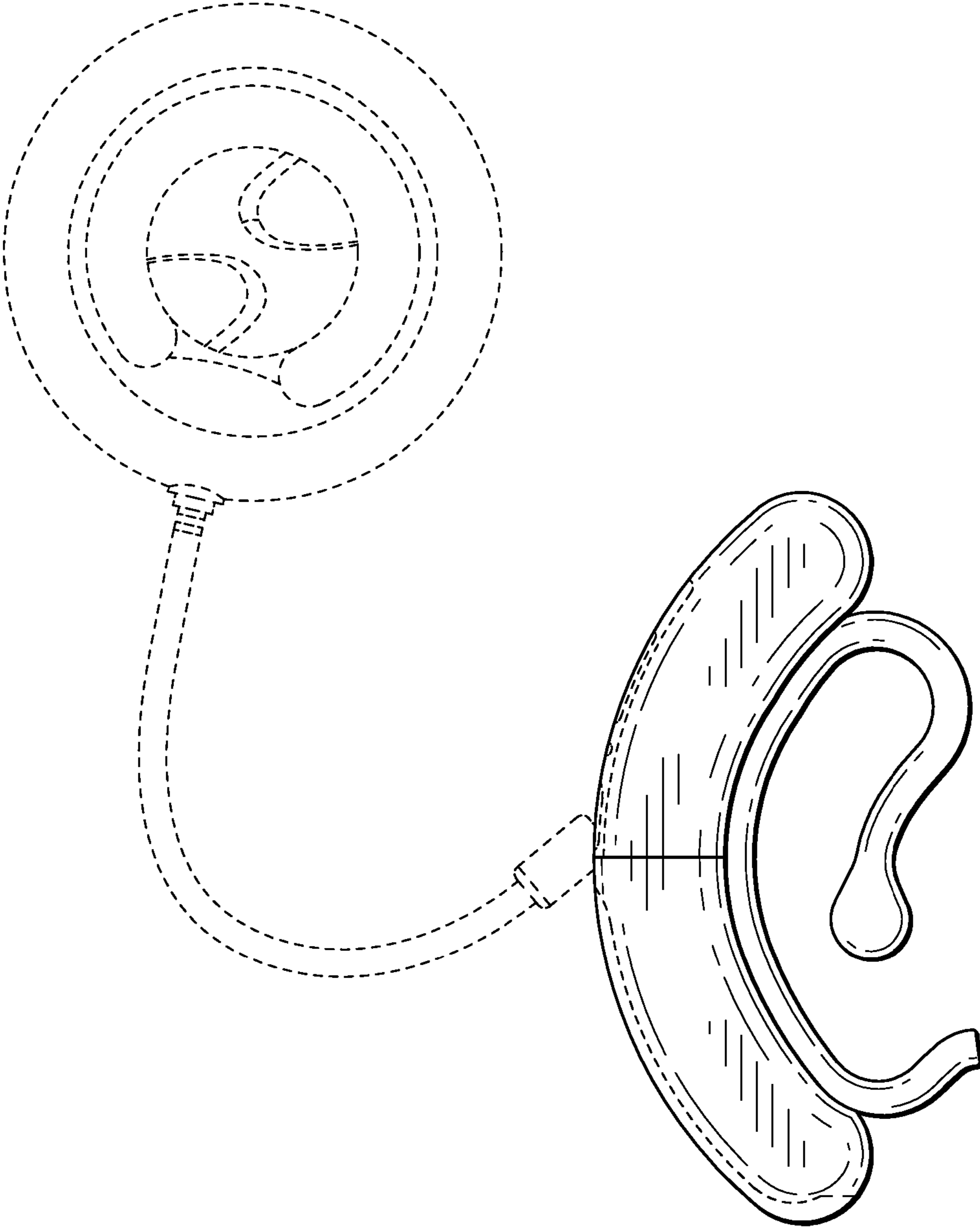

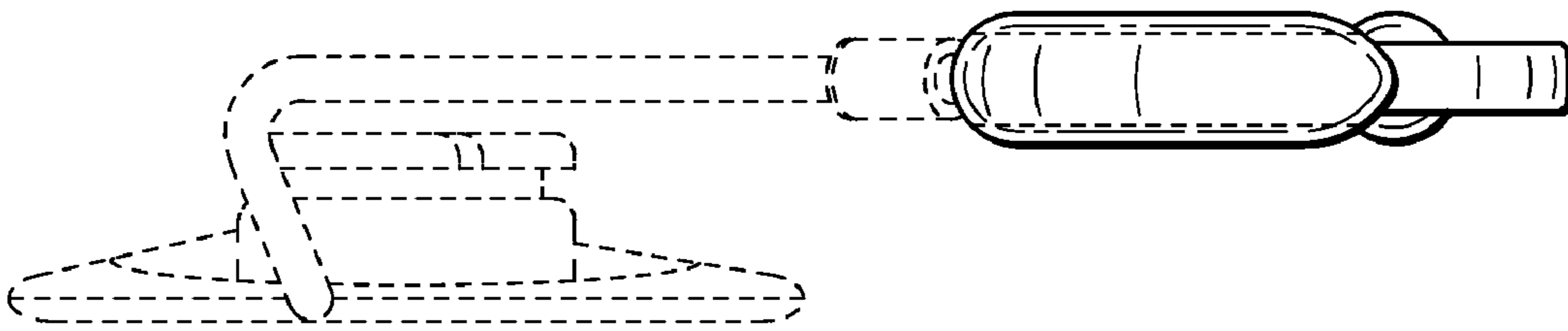

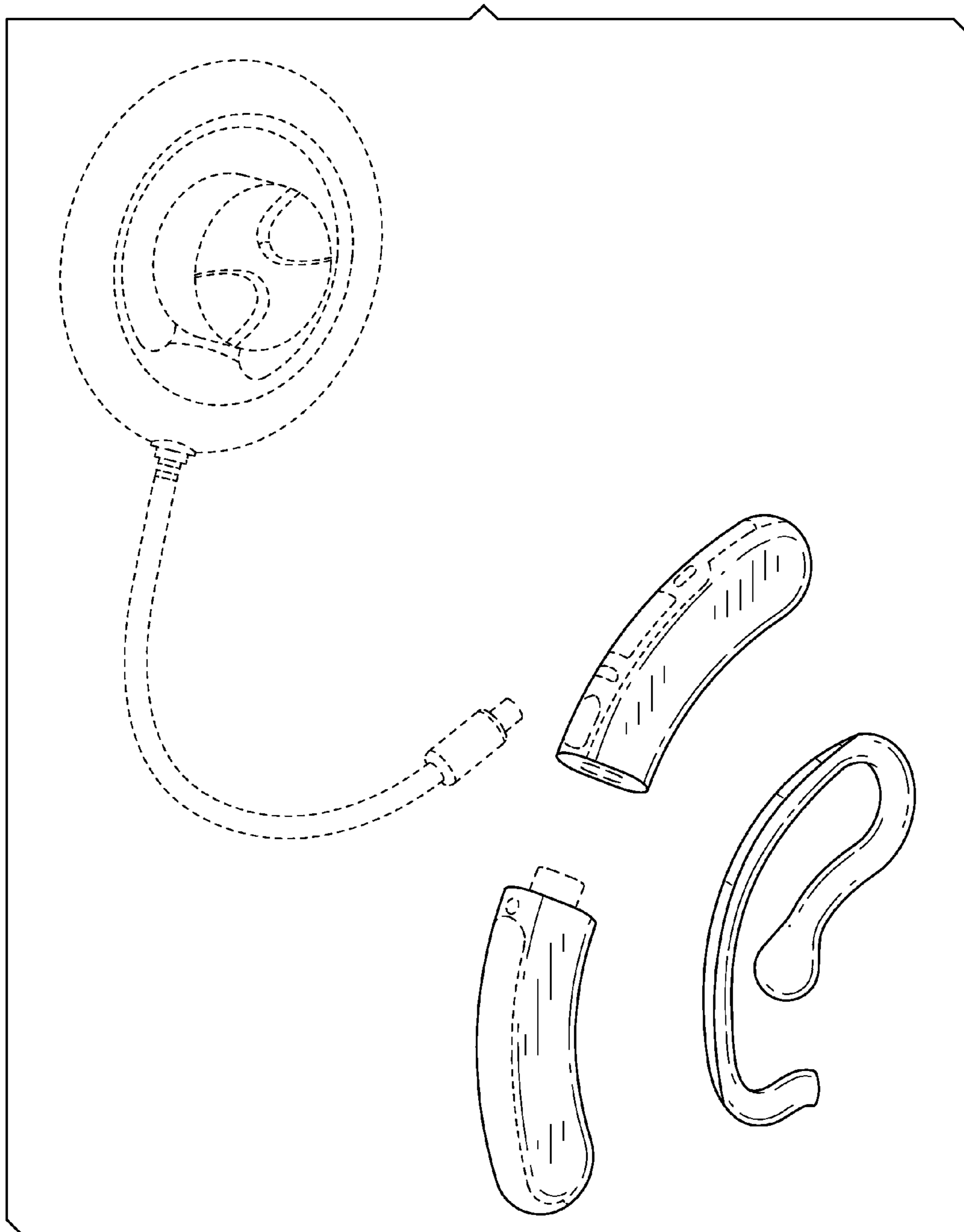

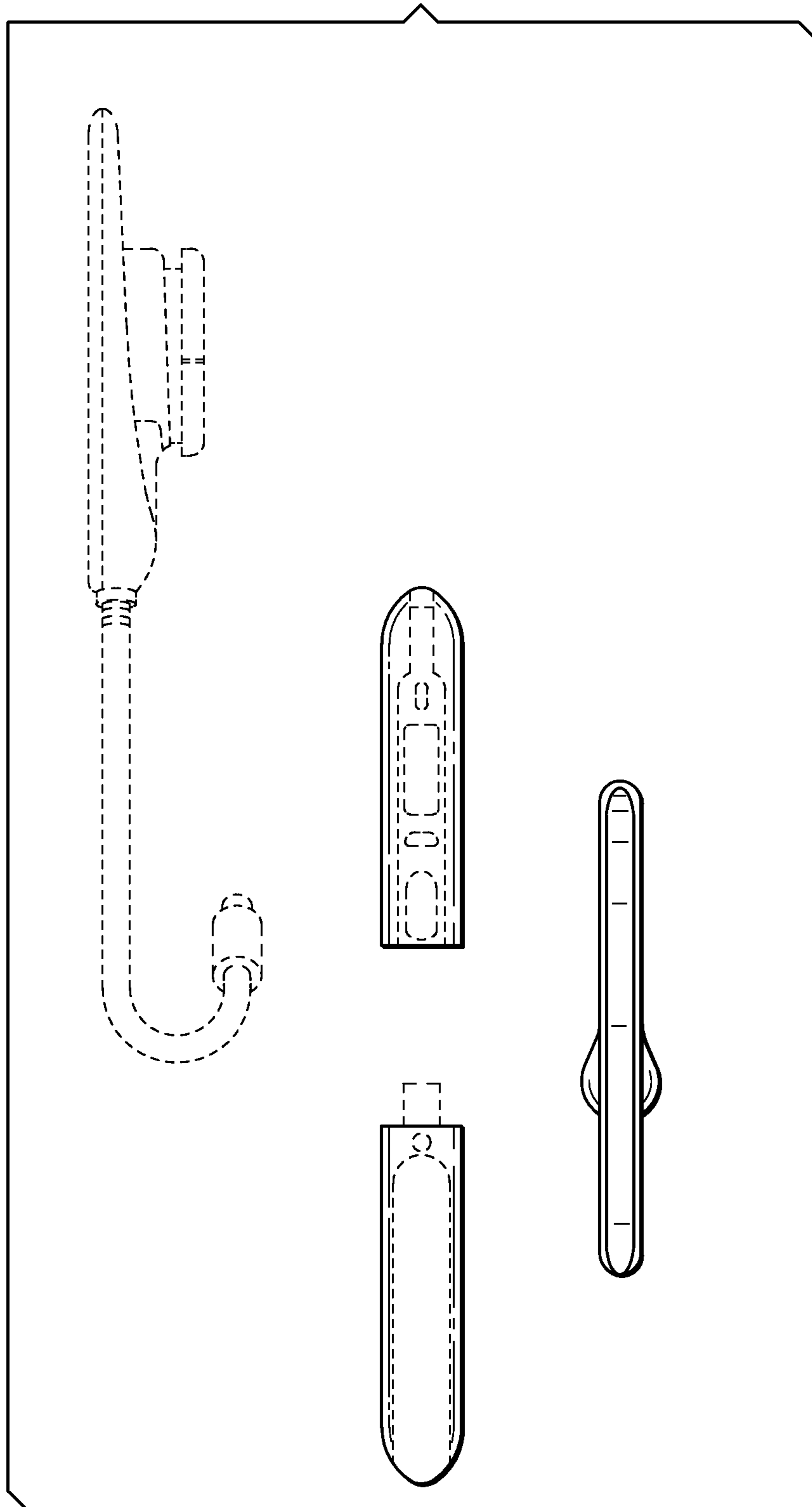

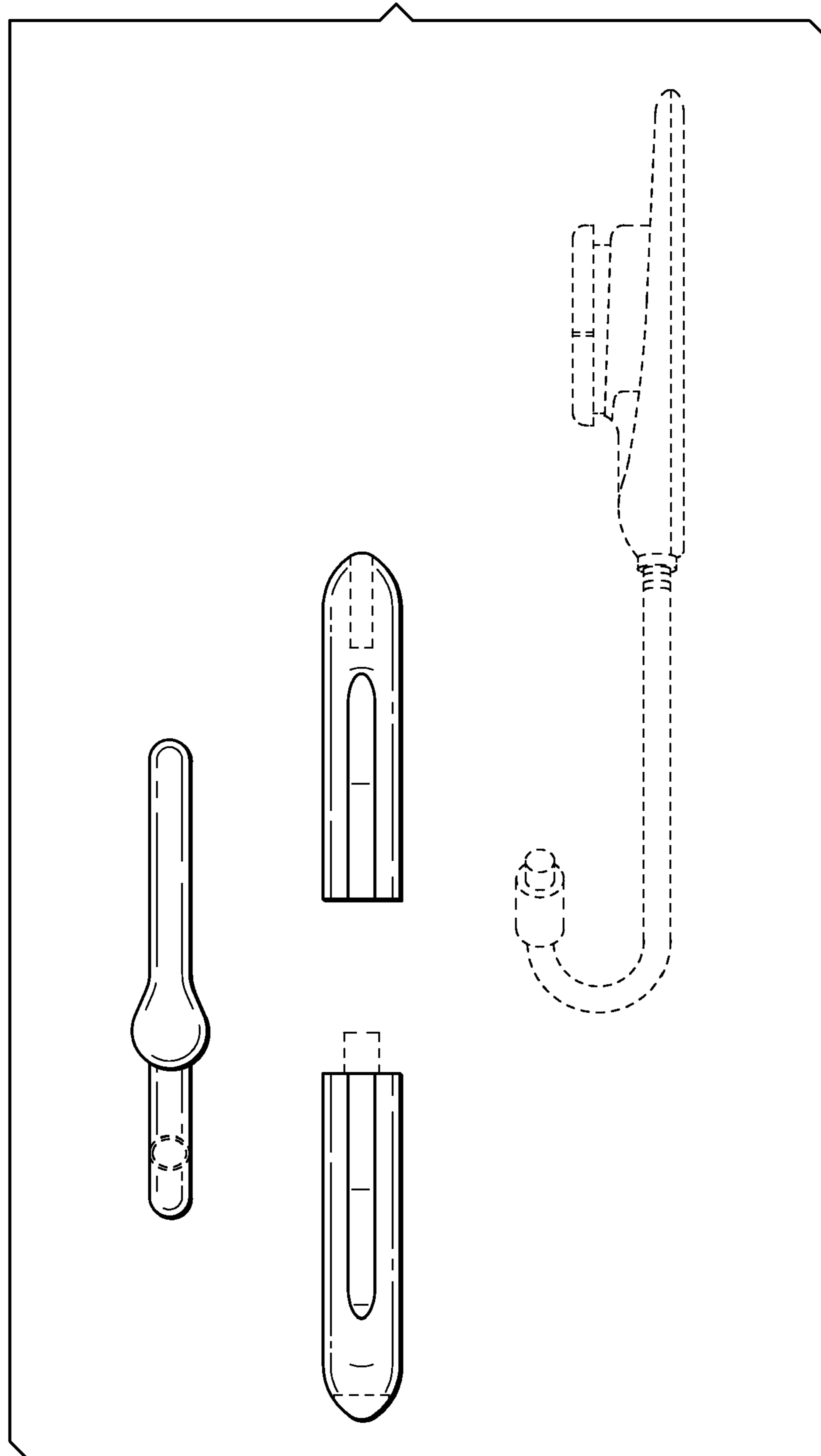

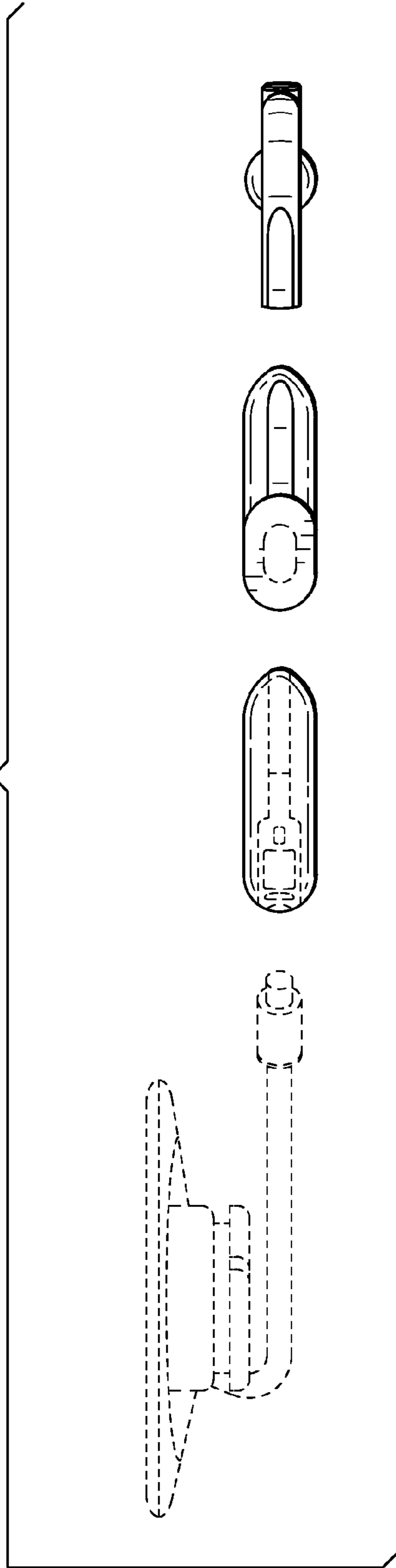

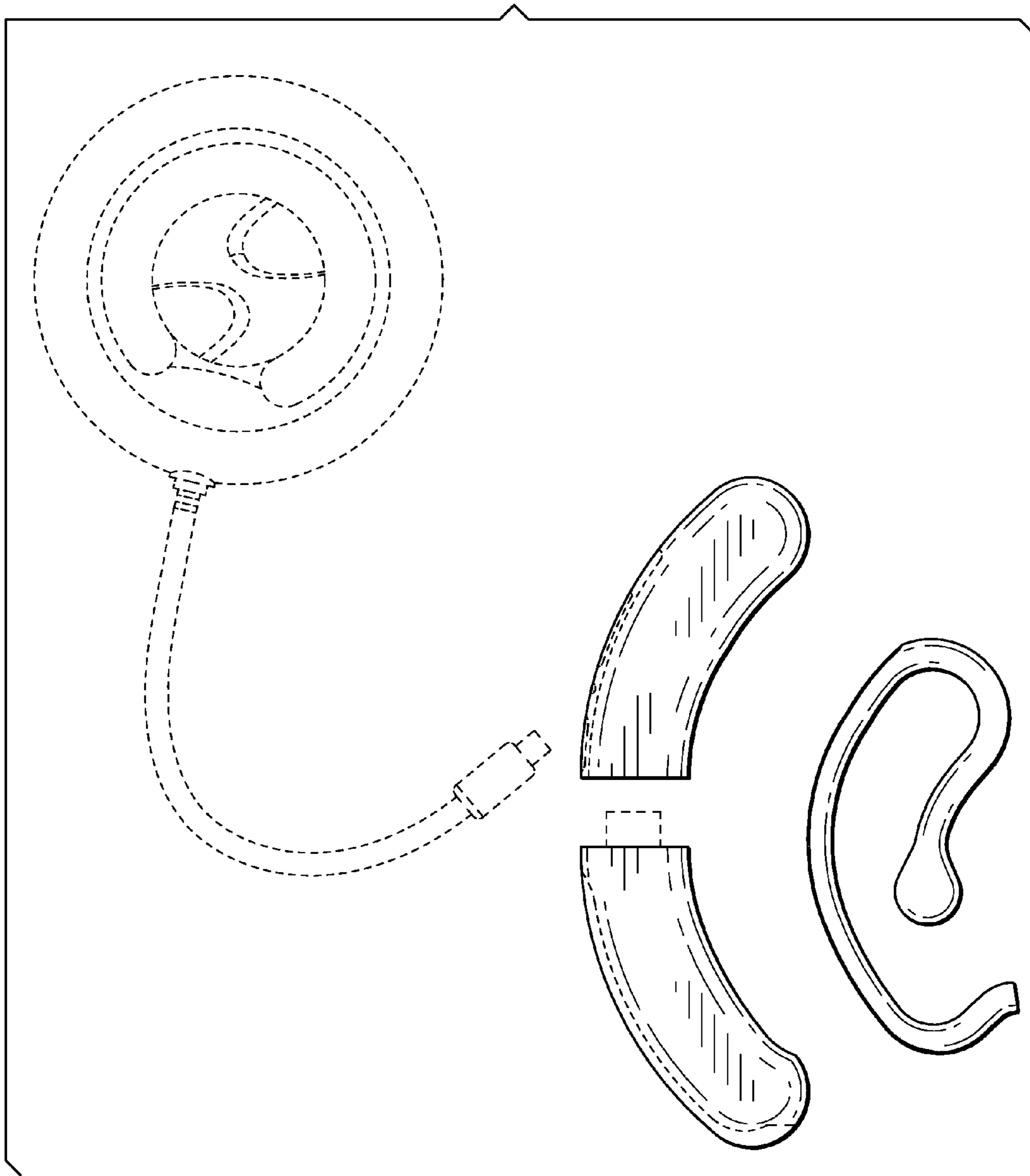
