**DESCRIPTION**

FIG. 1 is a perspective view as seen from the top, rear and right side of a razor handle showing my new design;

FIG. 4 is a bottom plan view thereof;

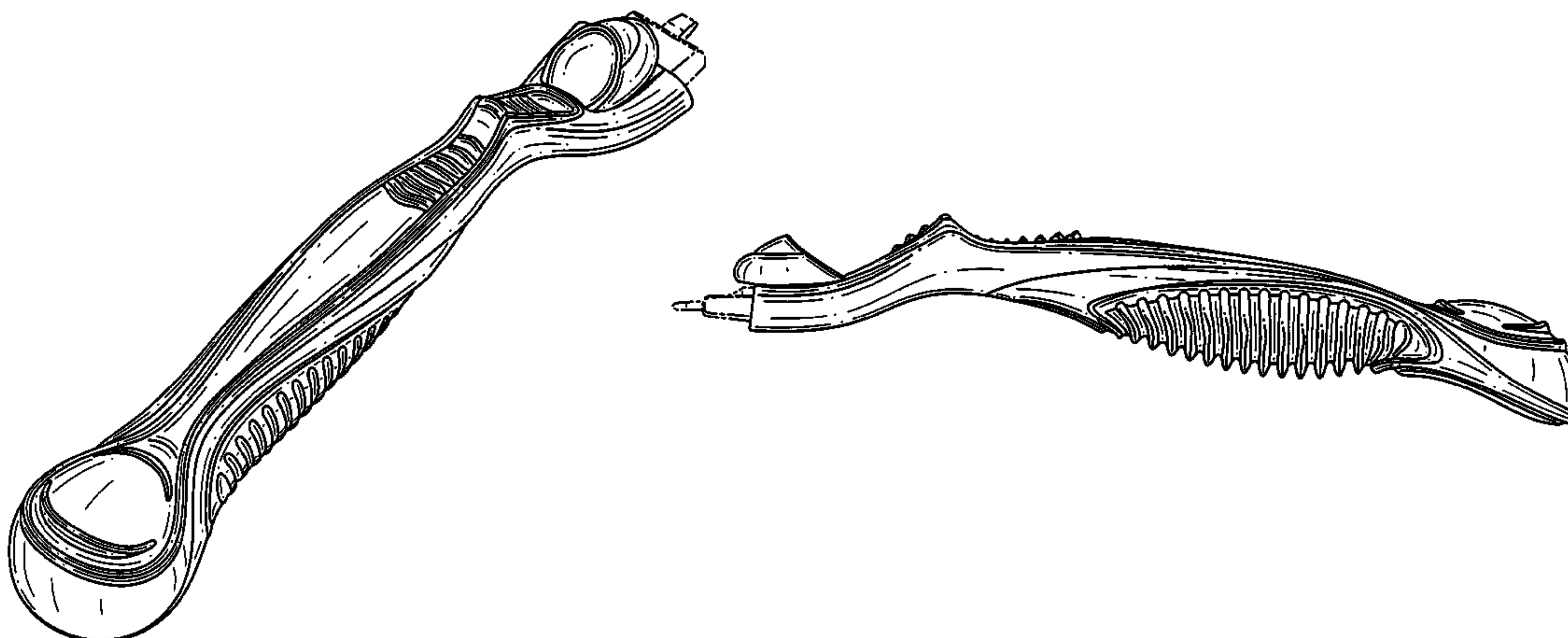
FIG. 5 is a left side elevational view, the right side elevation being a mirror image thereof;

FIG. 6 is a front elevational view thereof; and,

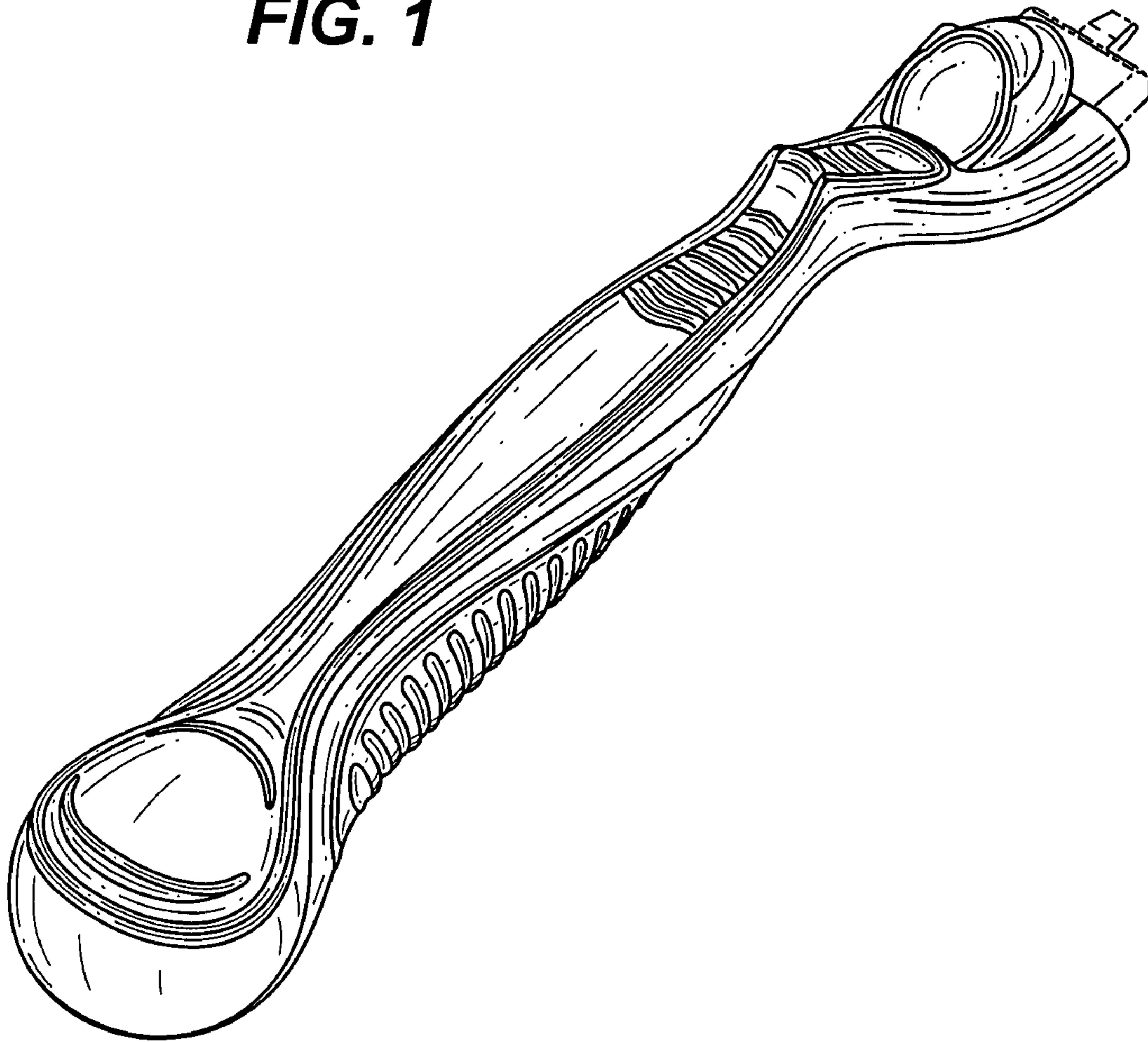
FIG. 7 is a rear elevational view thereof.

The broken lines are shown for illustrative purposes only and form no part of the claimed design.

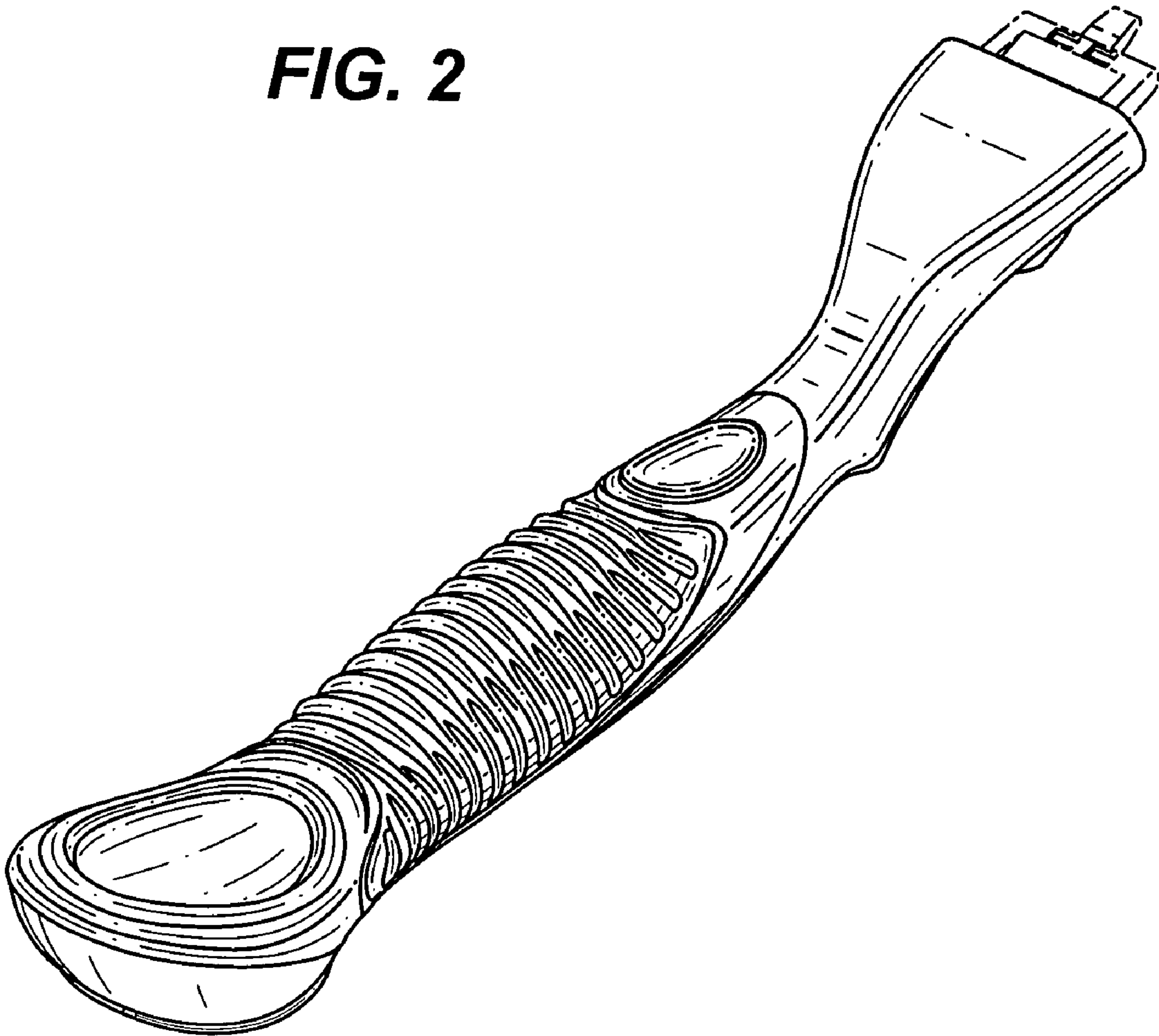

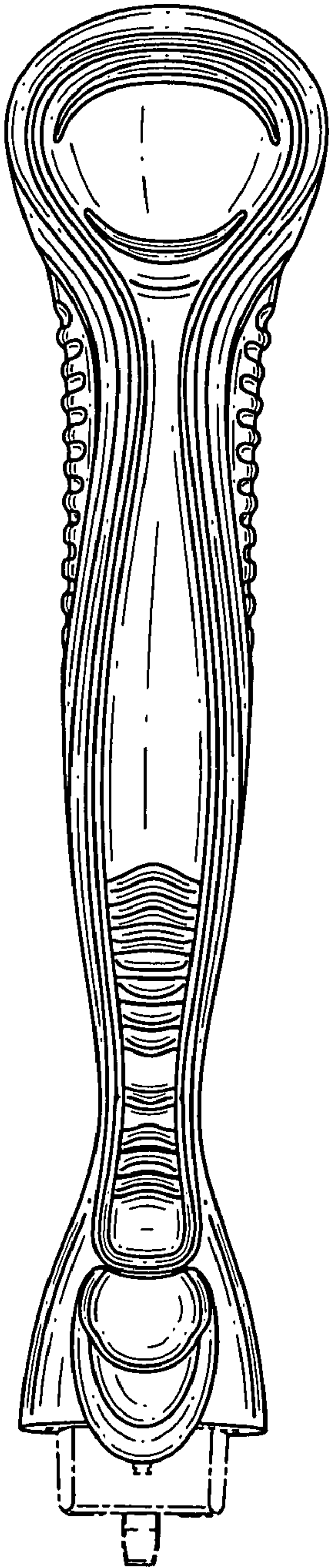

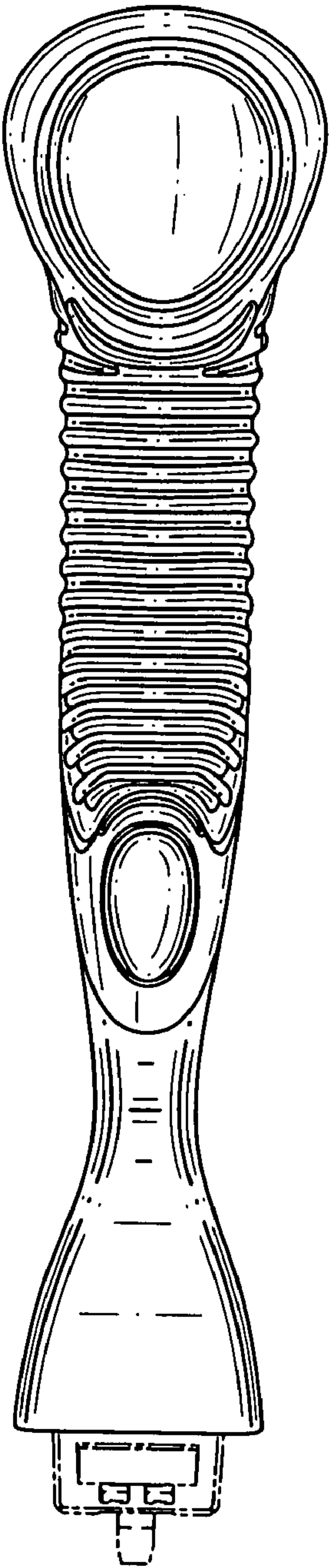

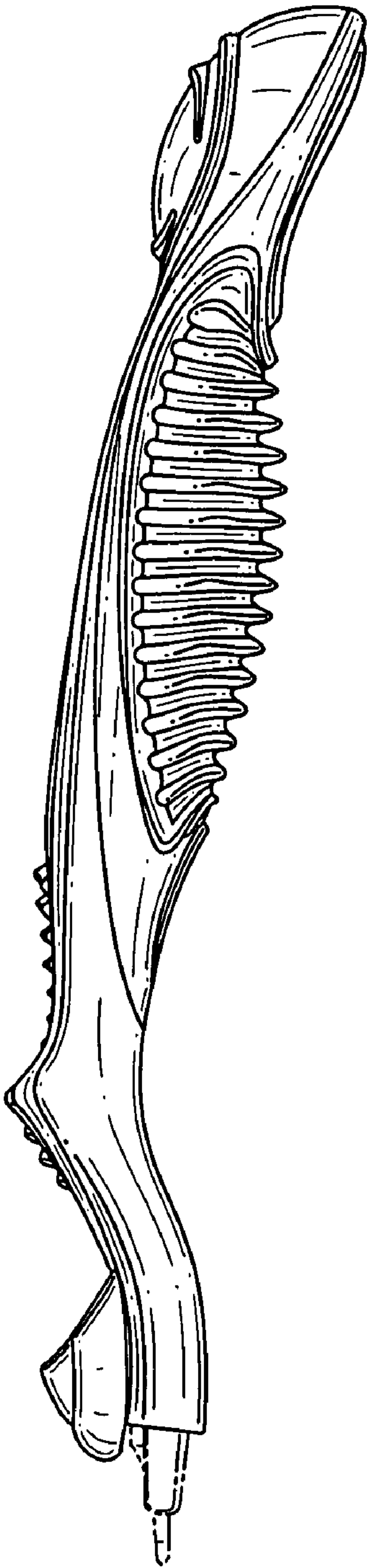

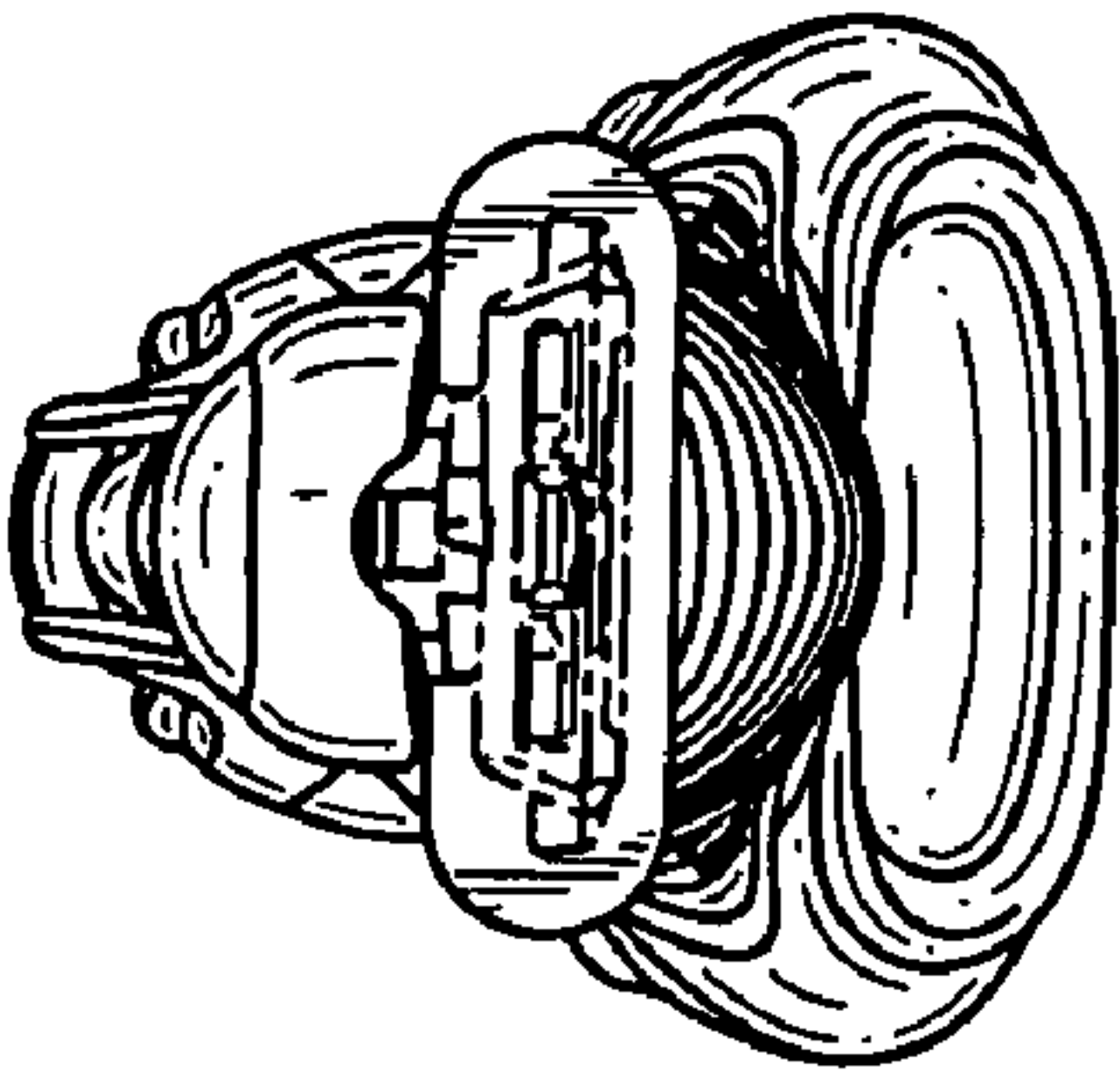
