I claim the ornamental design for a footwear sole, as shown and described.

DESCRIPTION

FIG. 2 is a rear elevational view thereof;

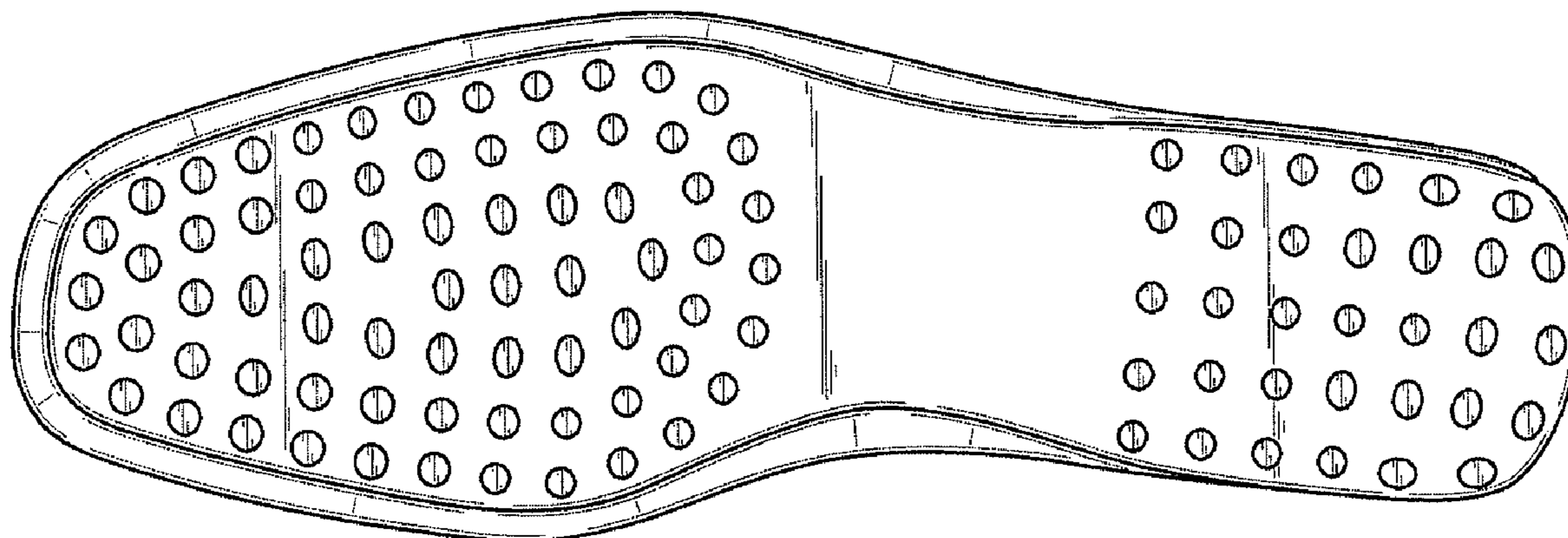
FIG. 3 is a right side elevational view thereof;

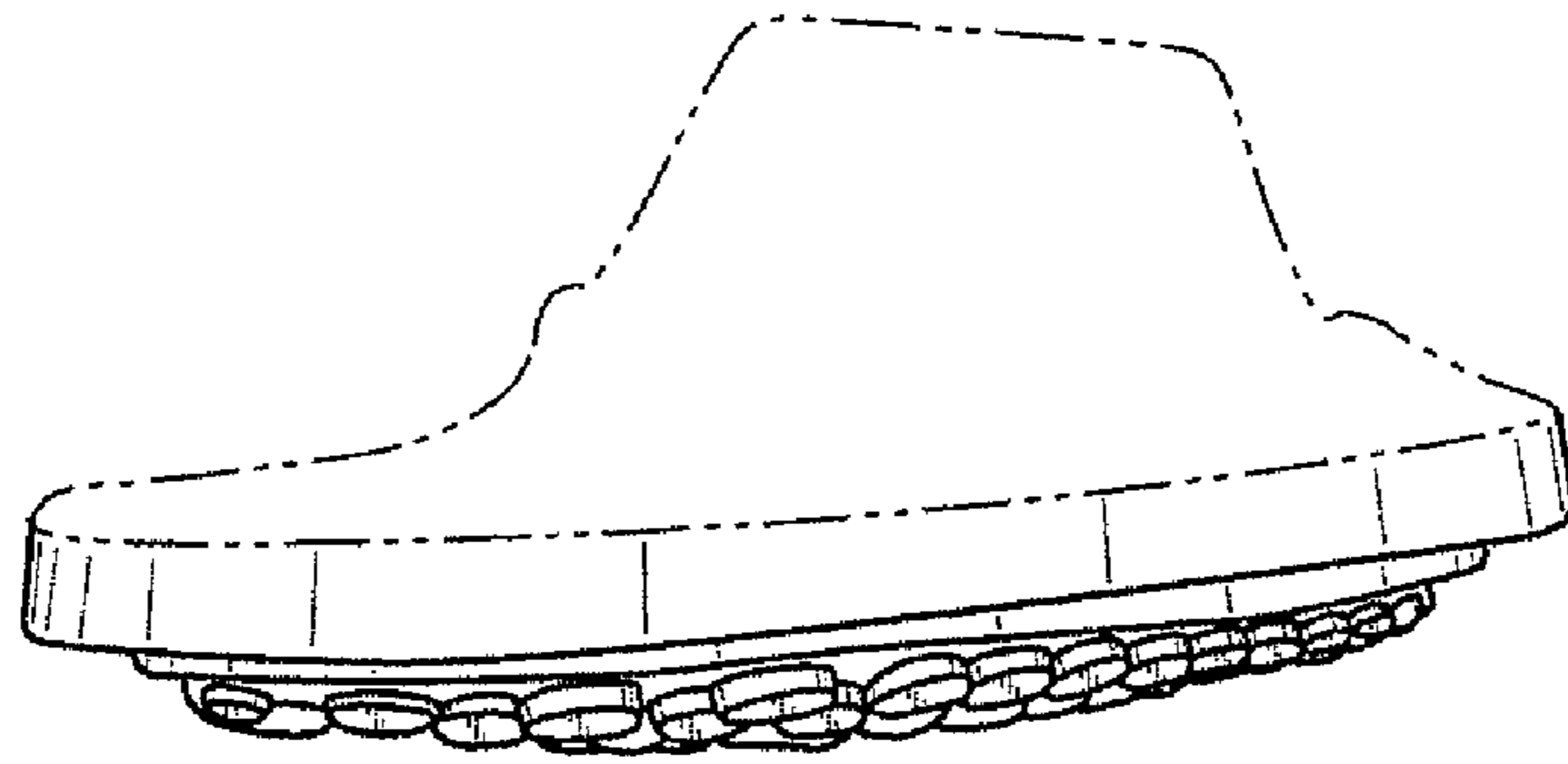

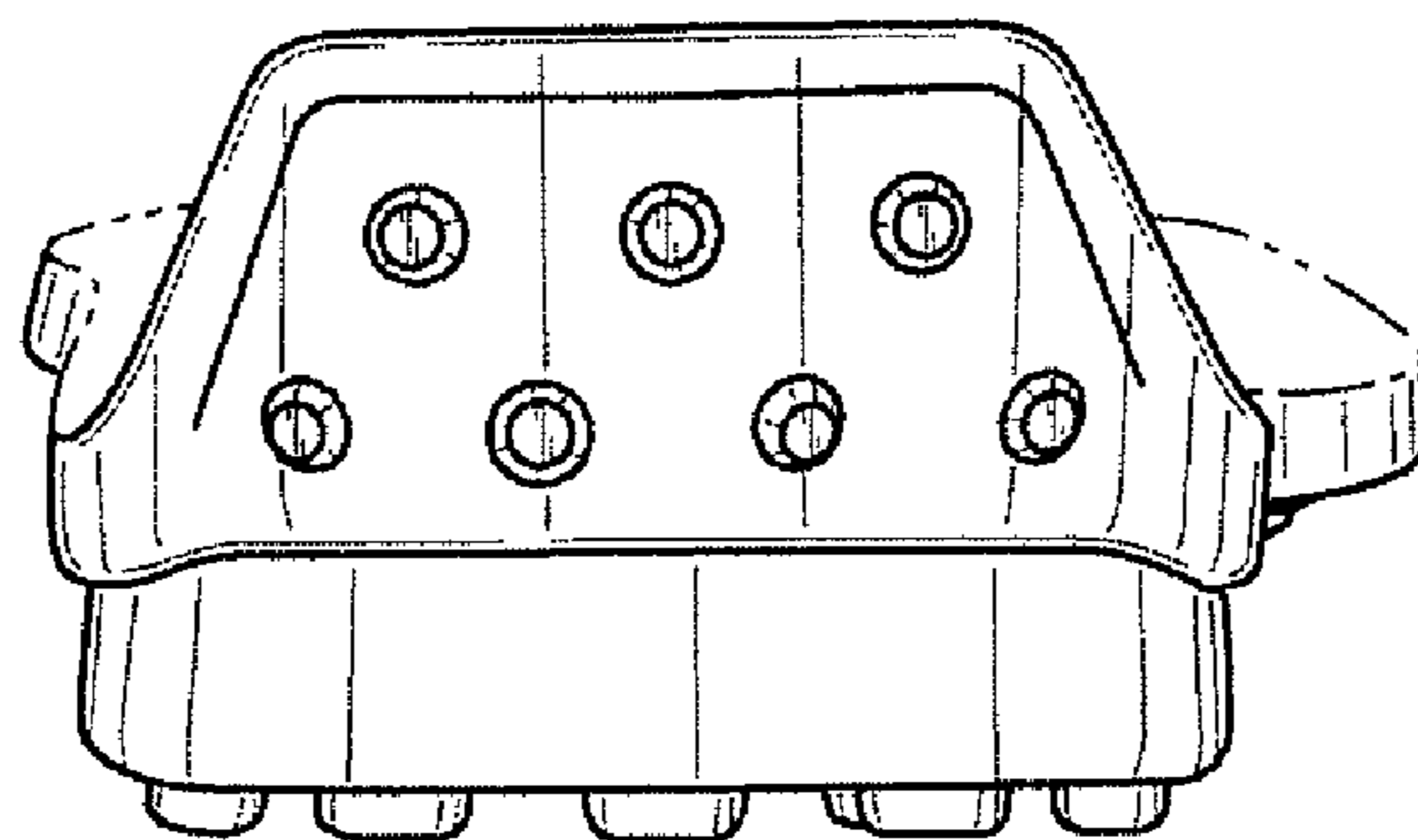

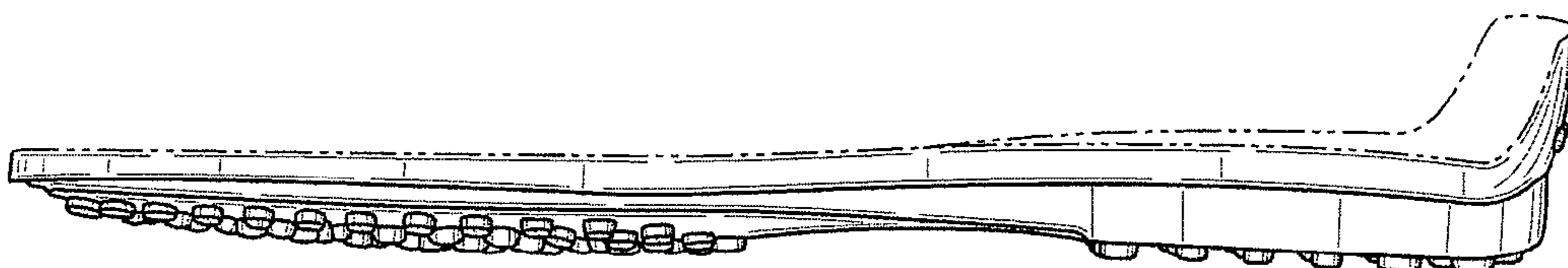

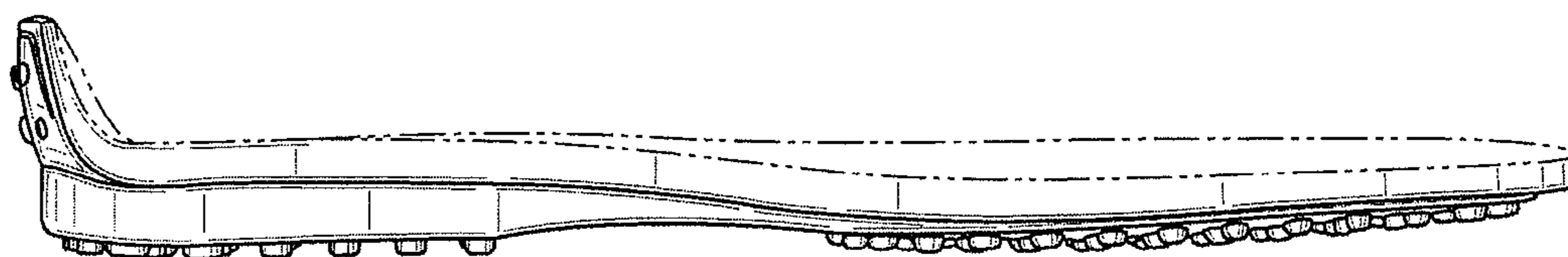

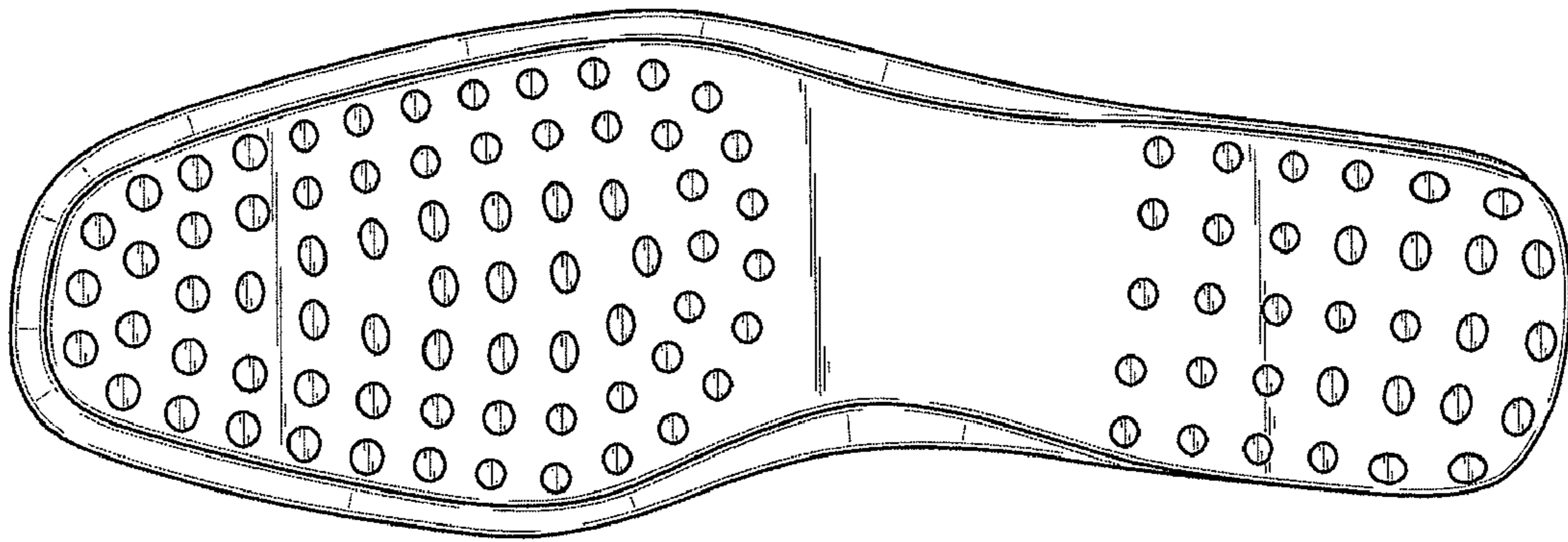
