The ornamental design for a device holster, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-side perspective view of said device holster showing my new design;

FIG. 9 is a rear, left-side perspective view thereof with top closure open;

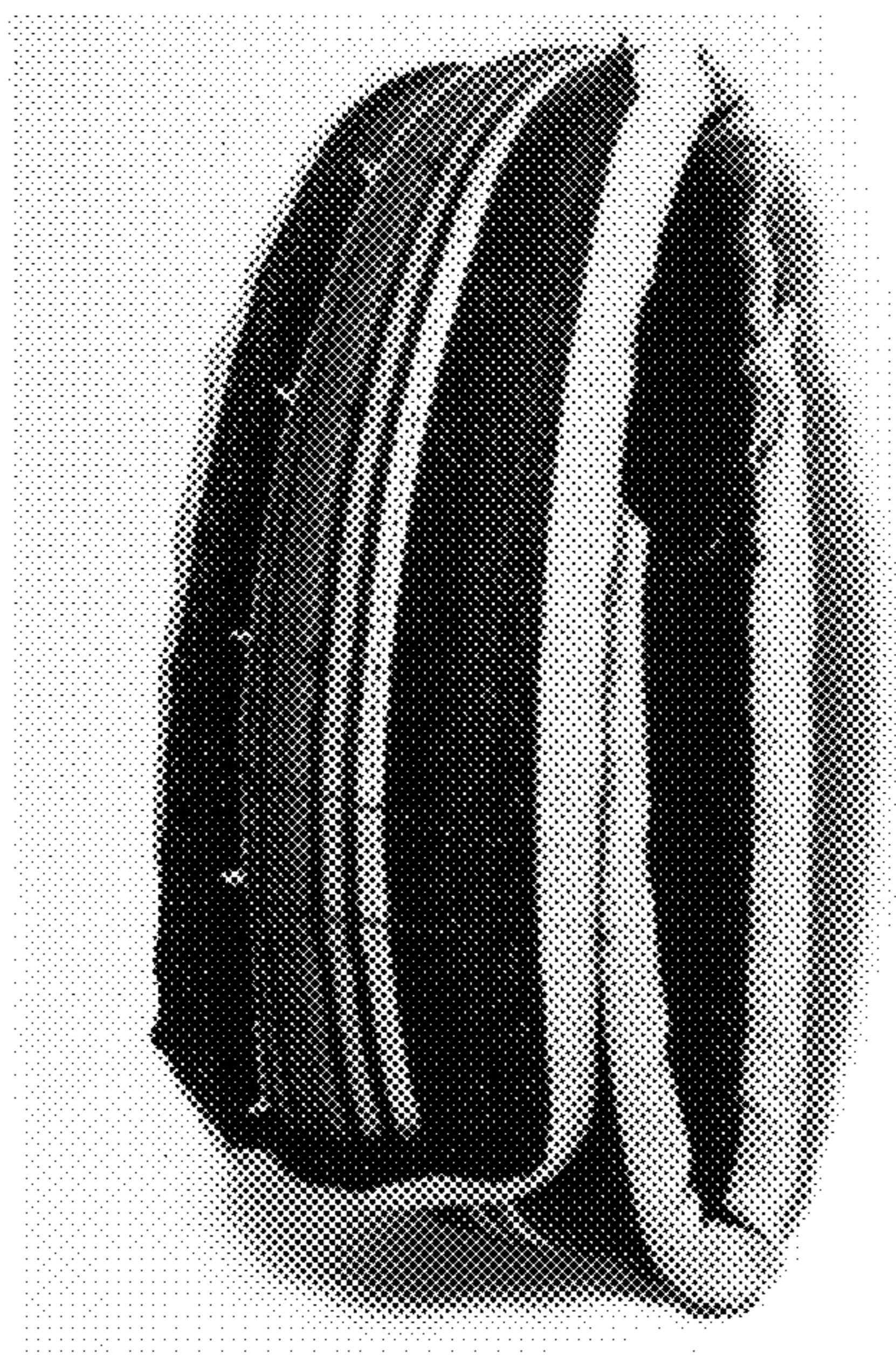
FIG. 10 is a right-side perspective view thereof with said closure open;

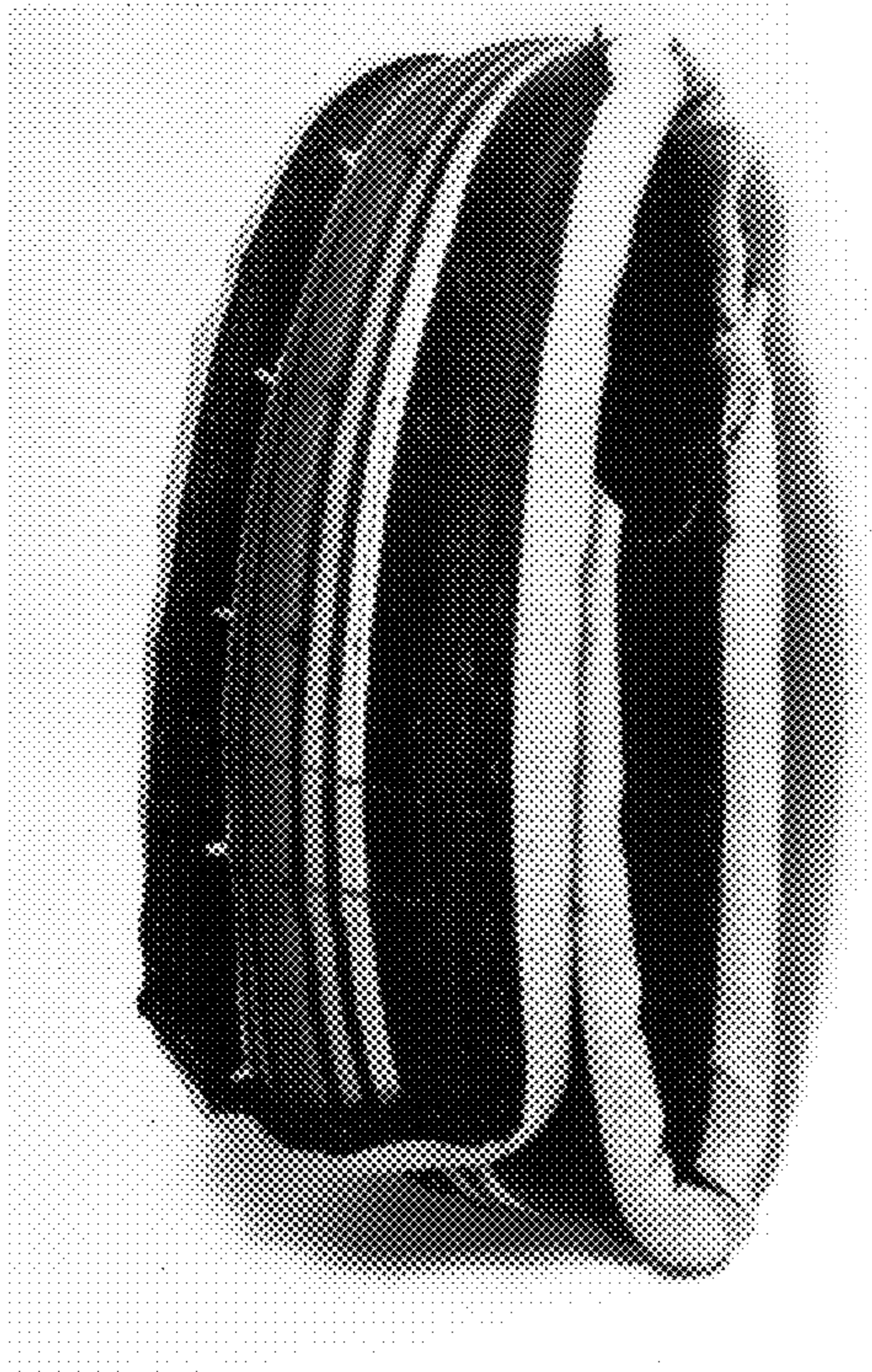

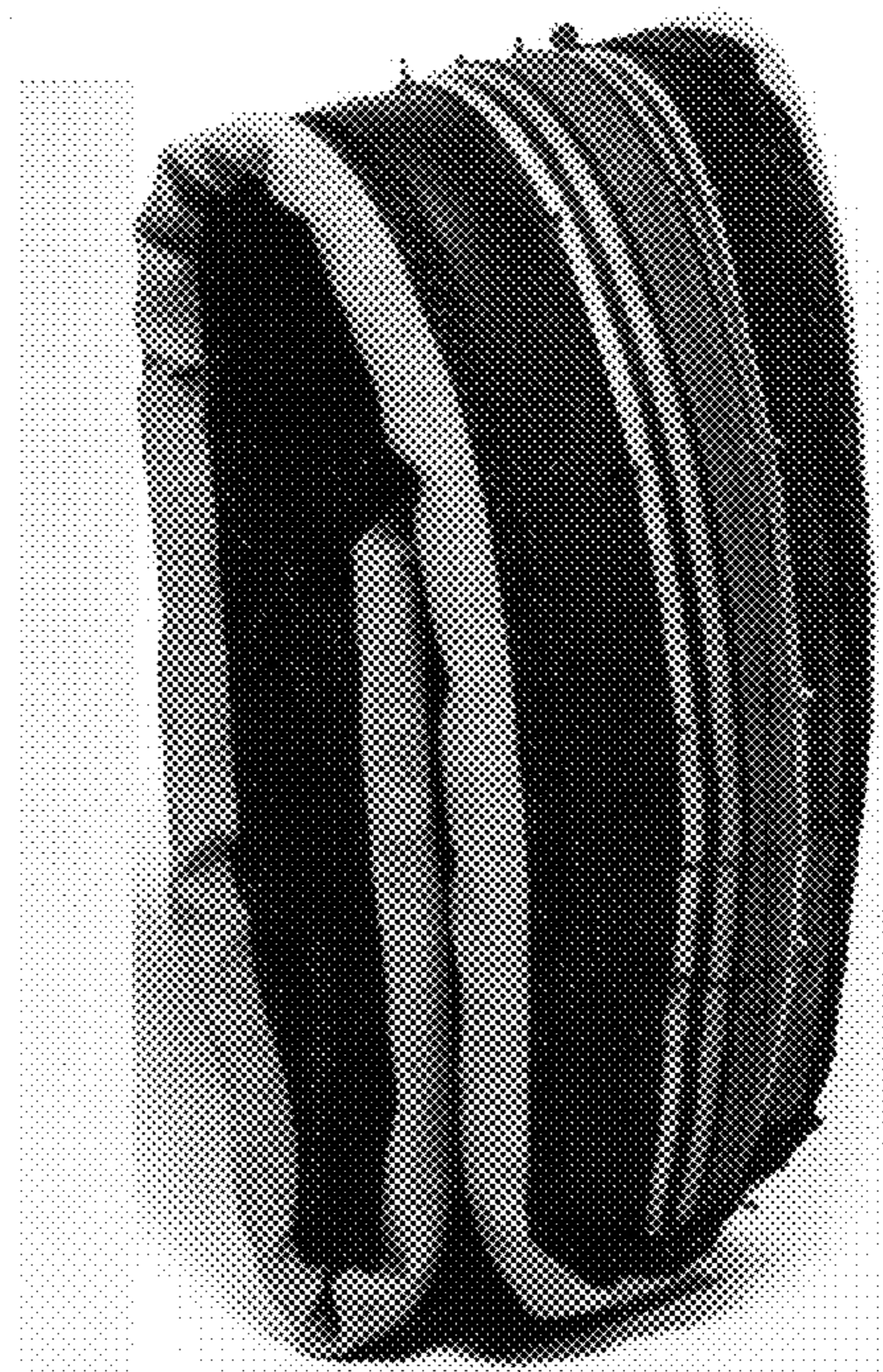

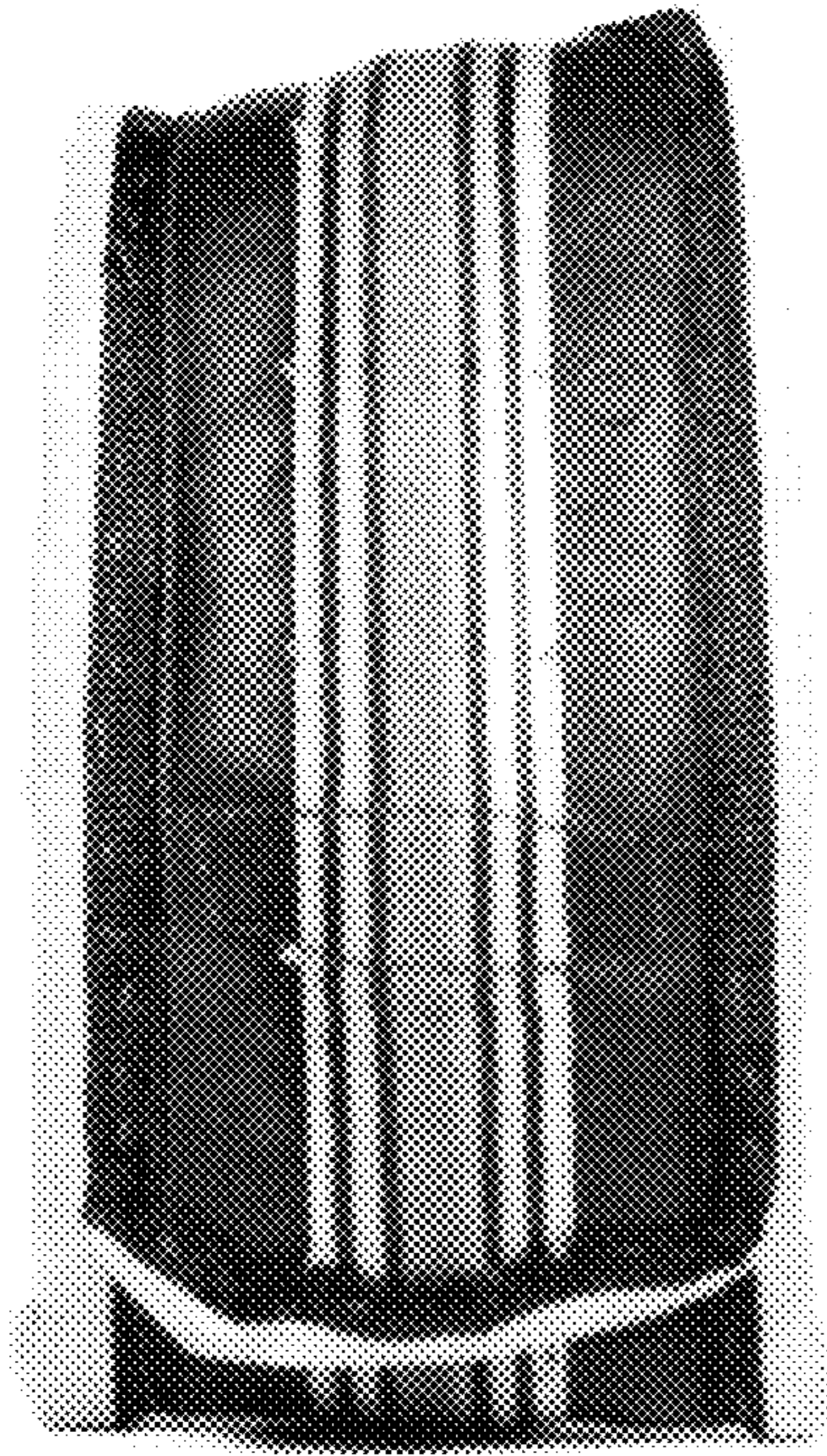

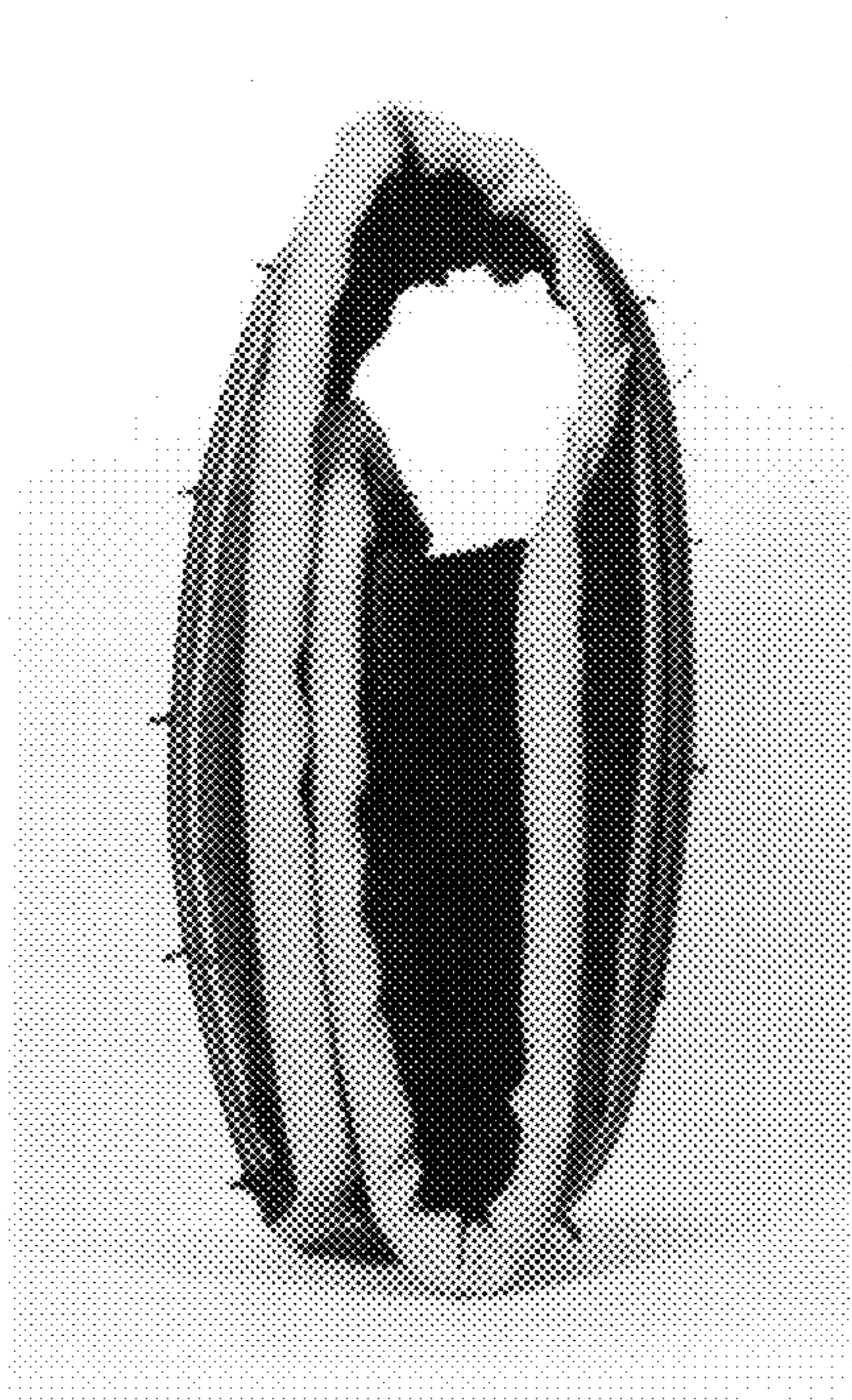

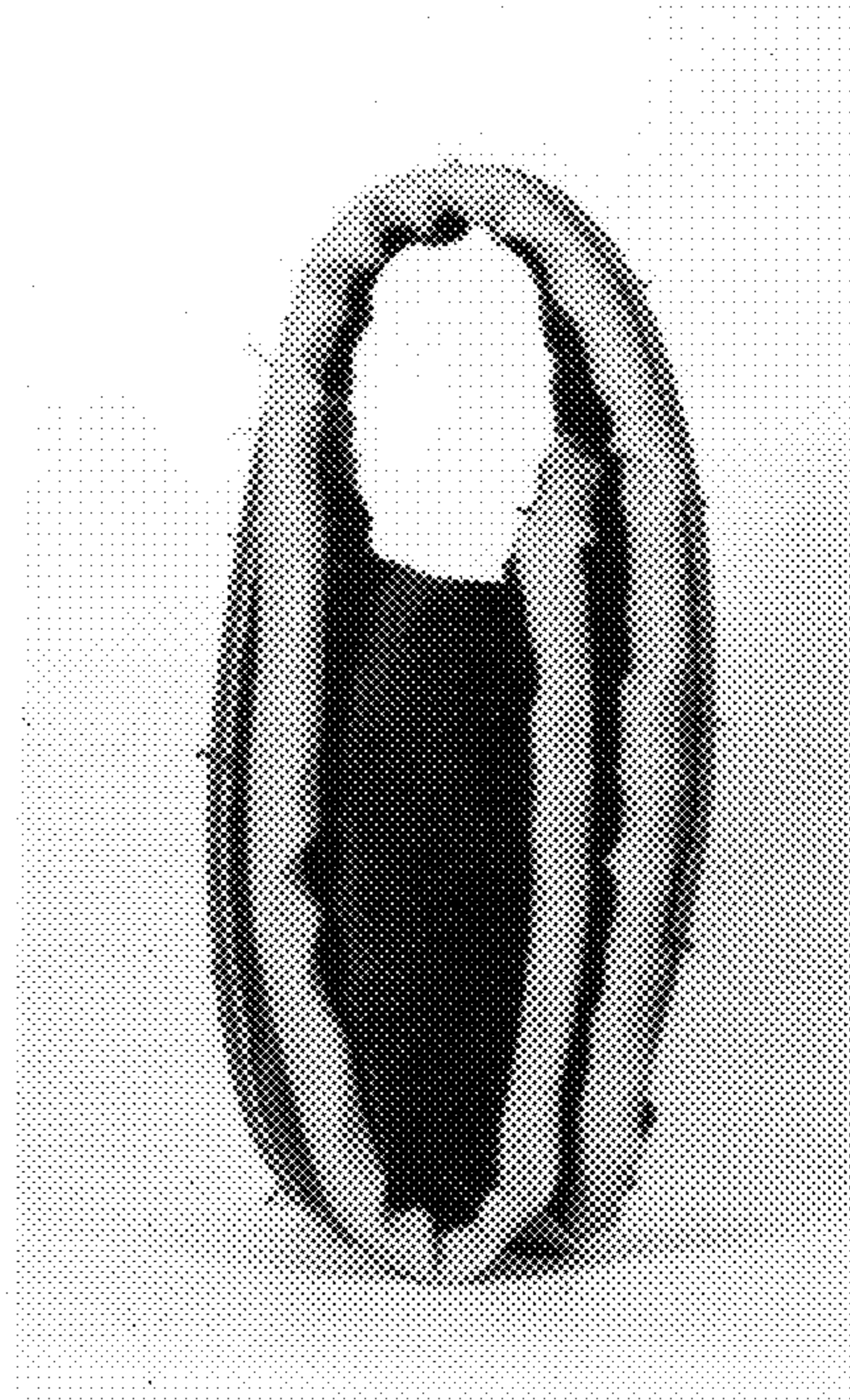

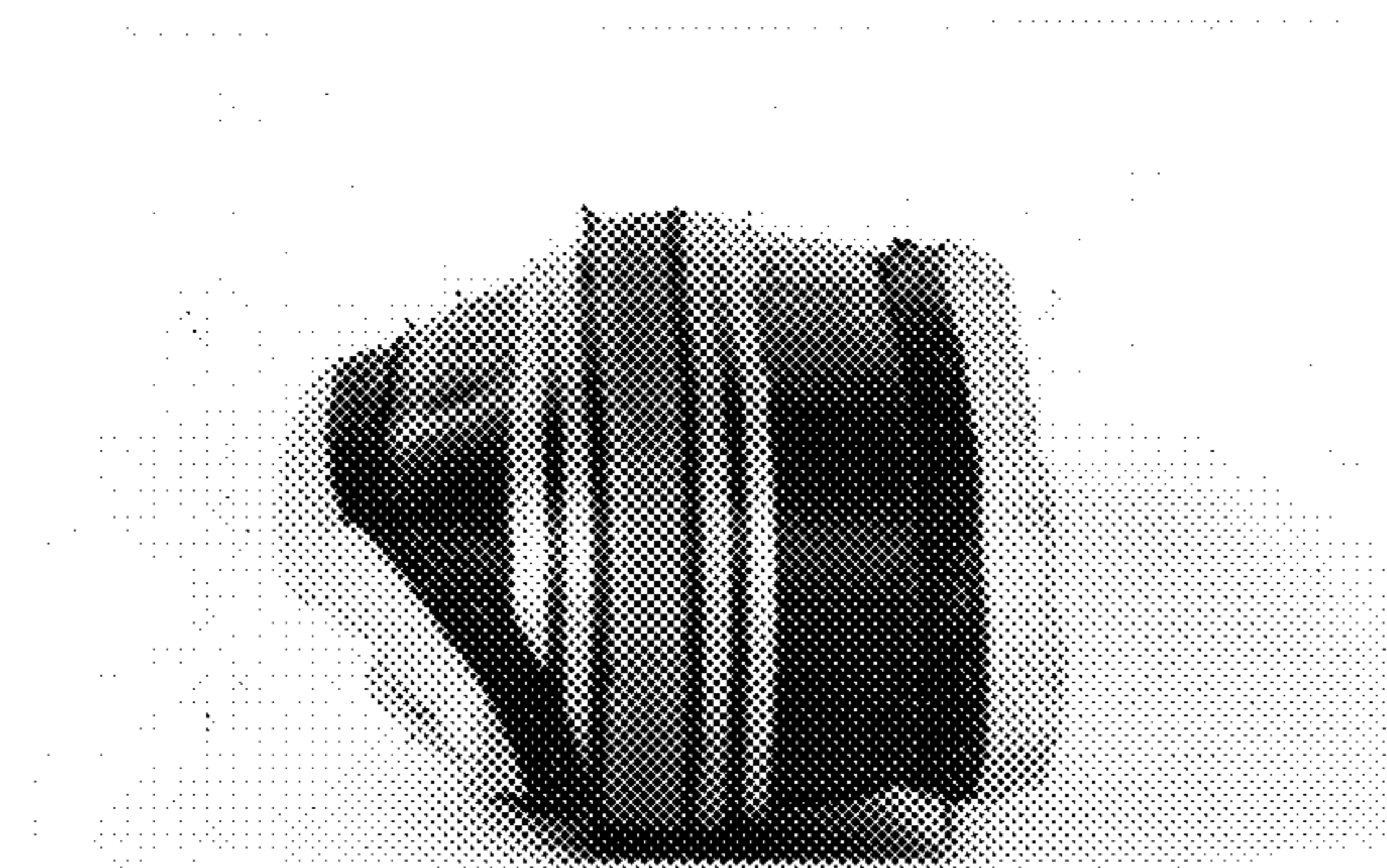

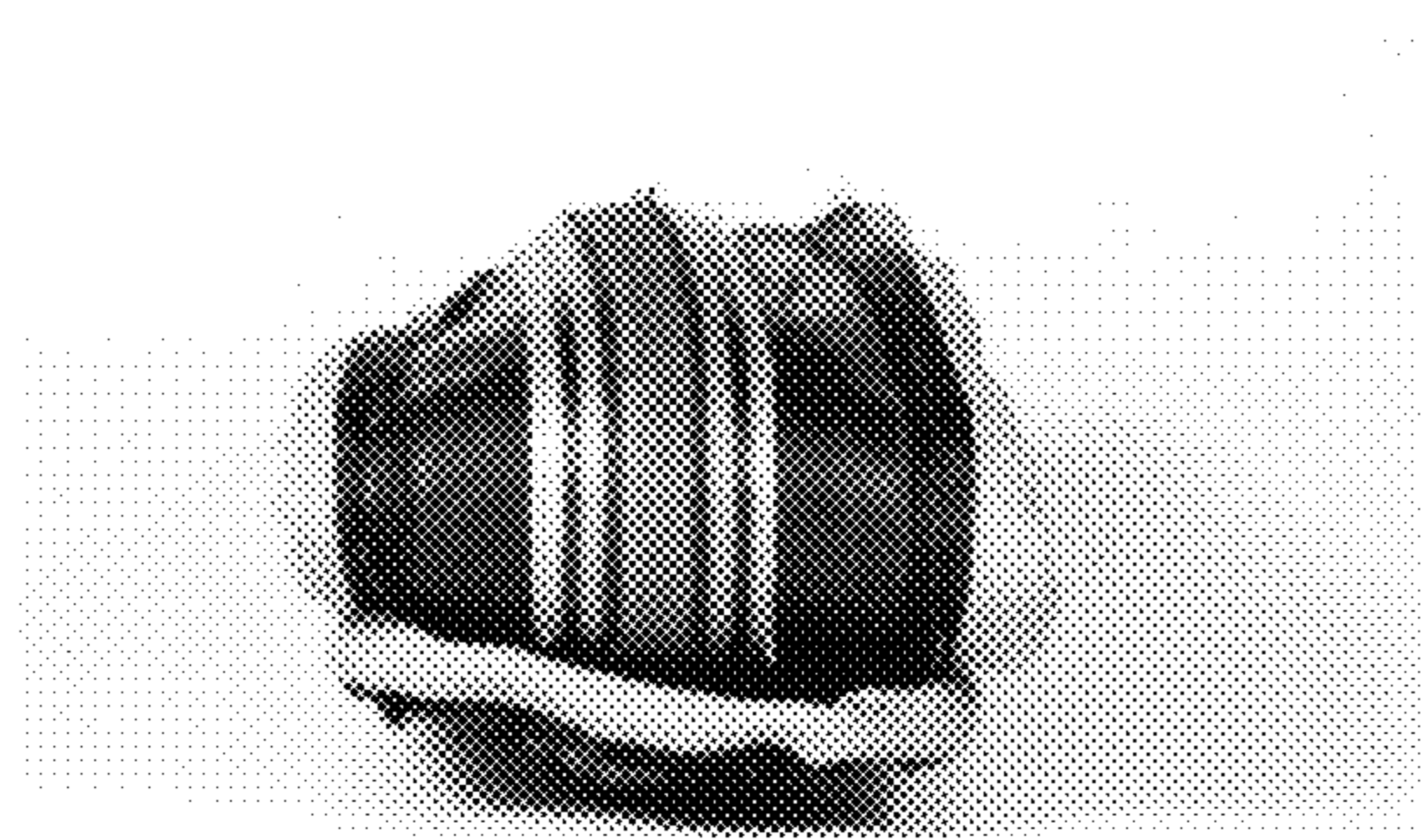

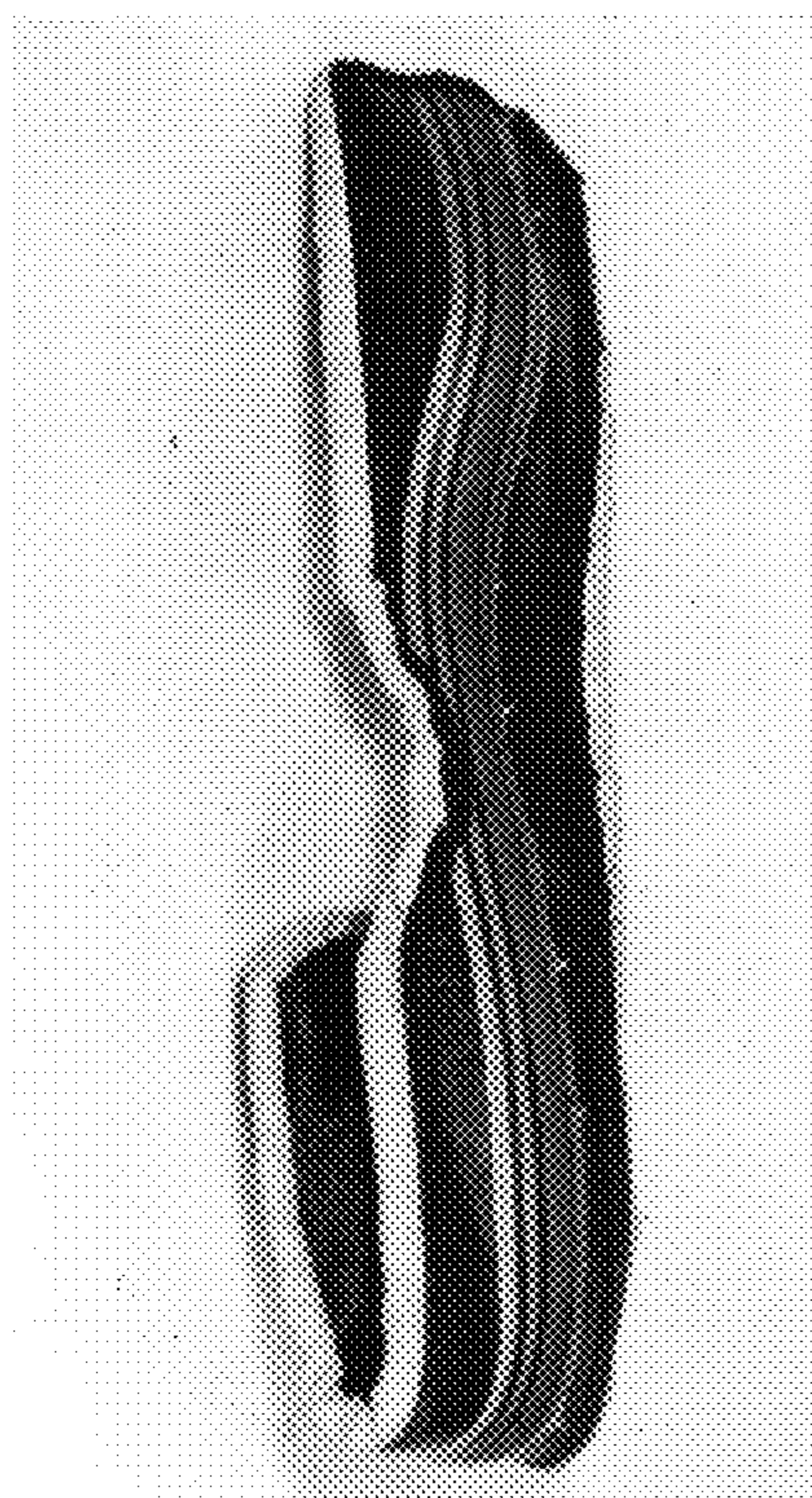

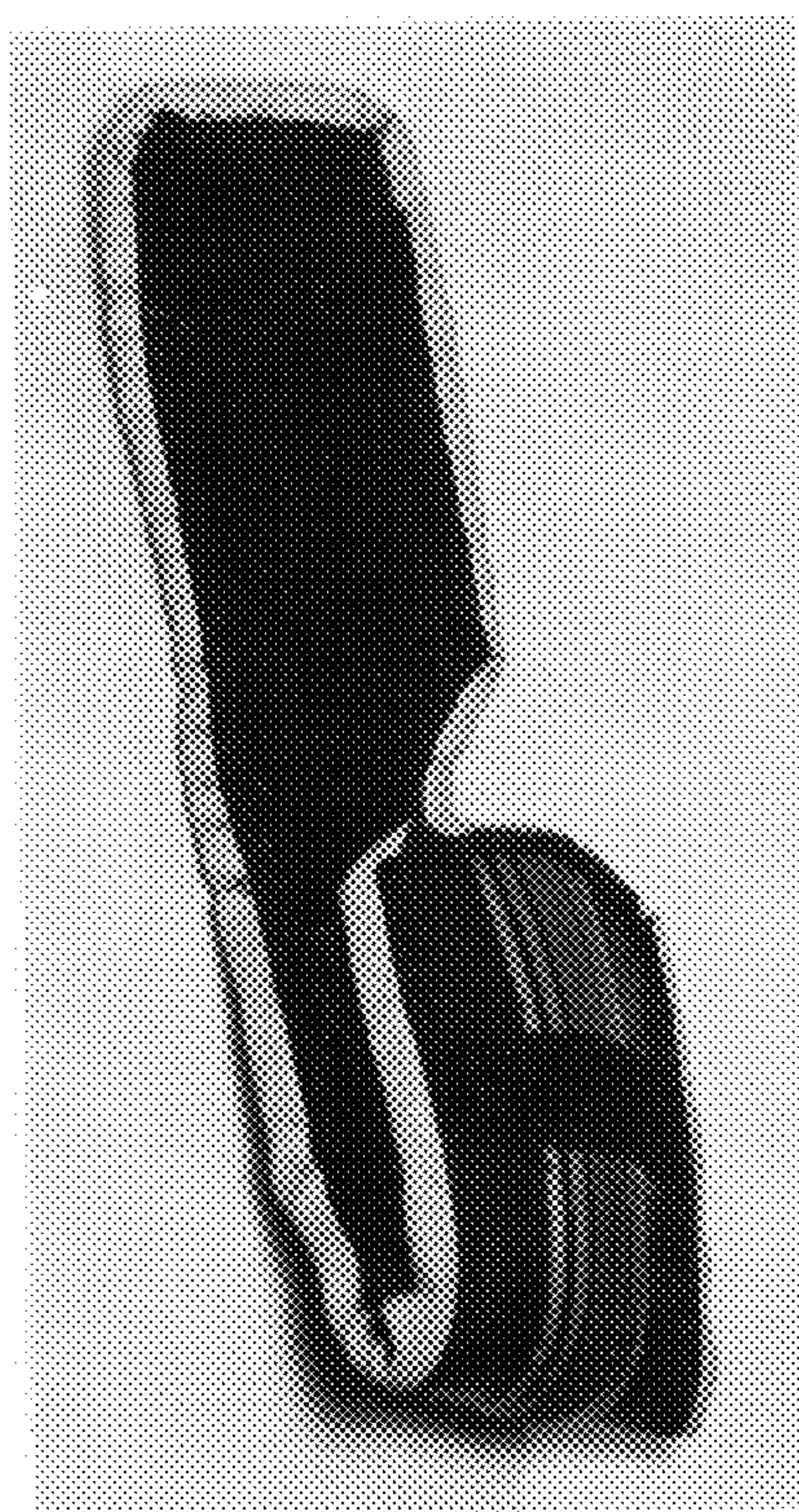

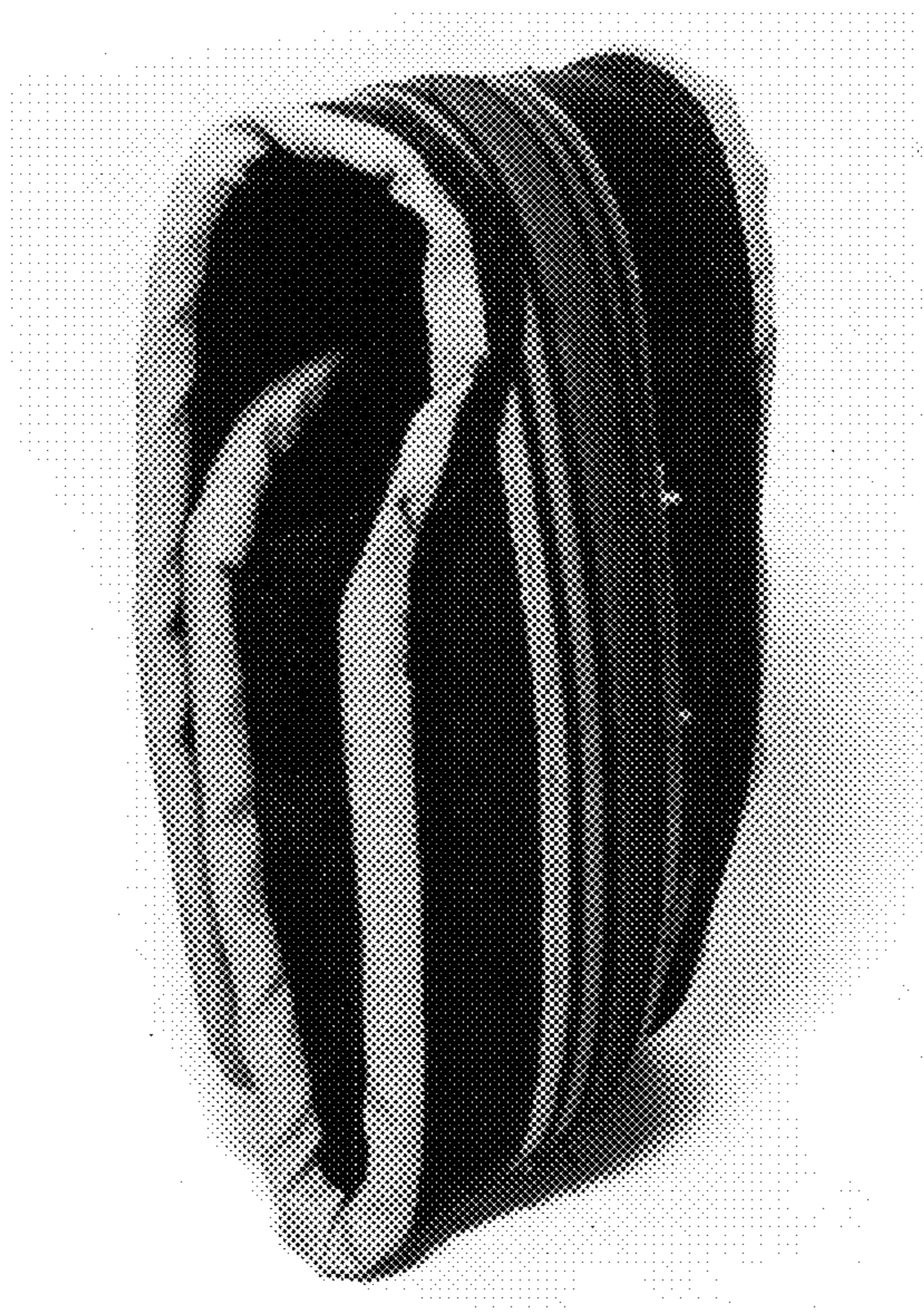

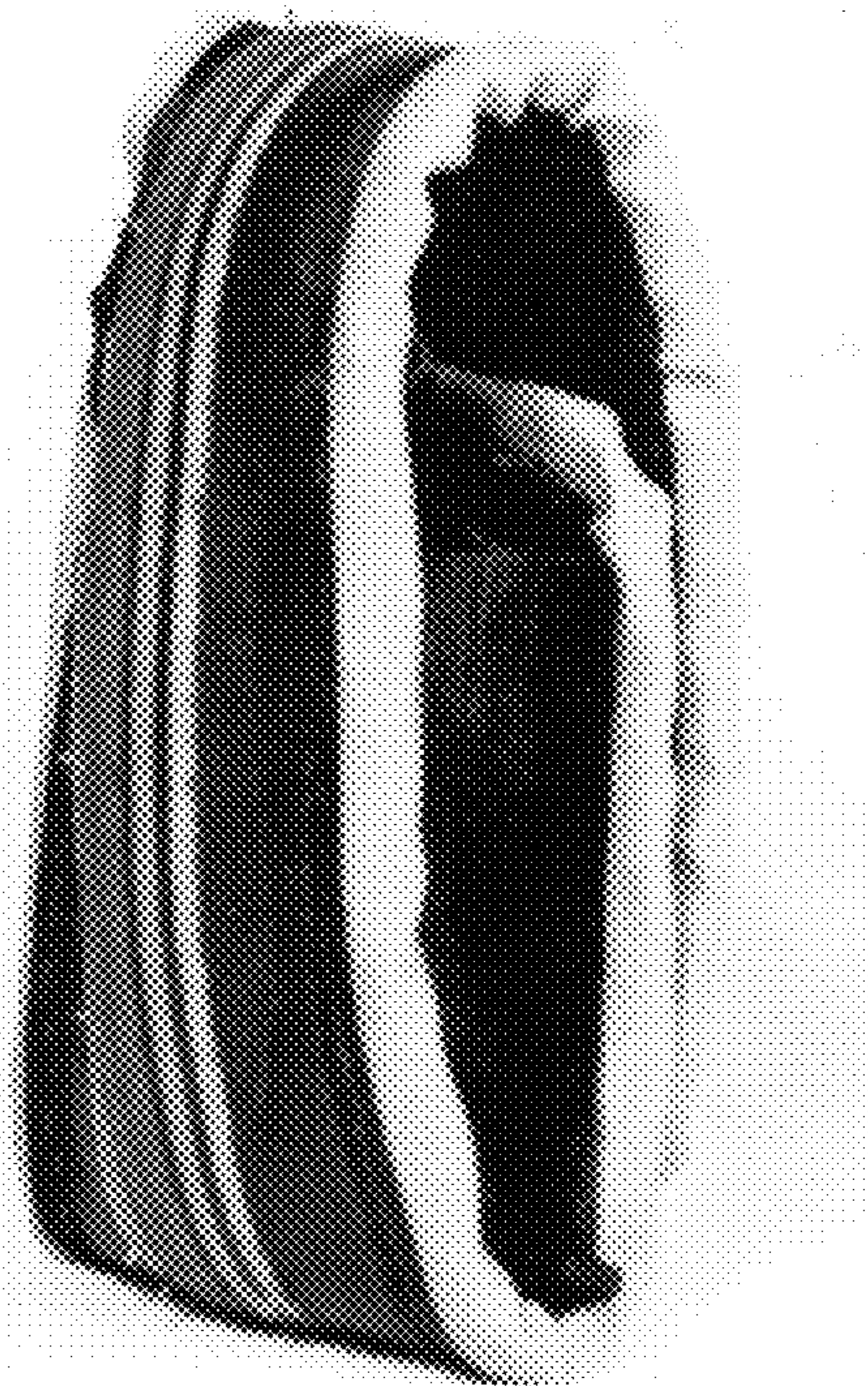
