(57) **CLAIM**

The ornamental design for a bocce ball case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and side perspective view of a bocce ball case showing my new design in the closed position;

FIG. 2 is a left side elevation view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a front and side perspective view thereof showing my new design in the open position.

The broken lines shown in all figures represent stitching and form part of the claimed design.

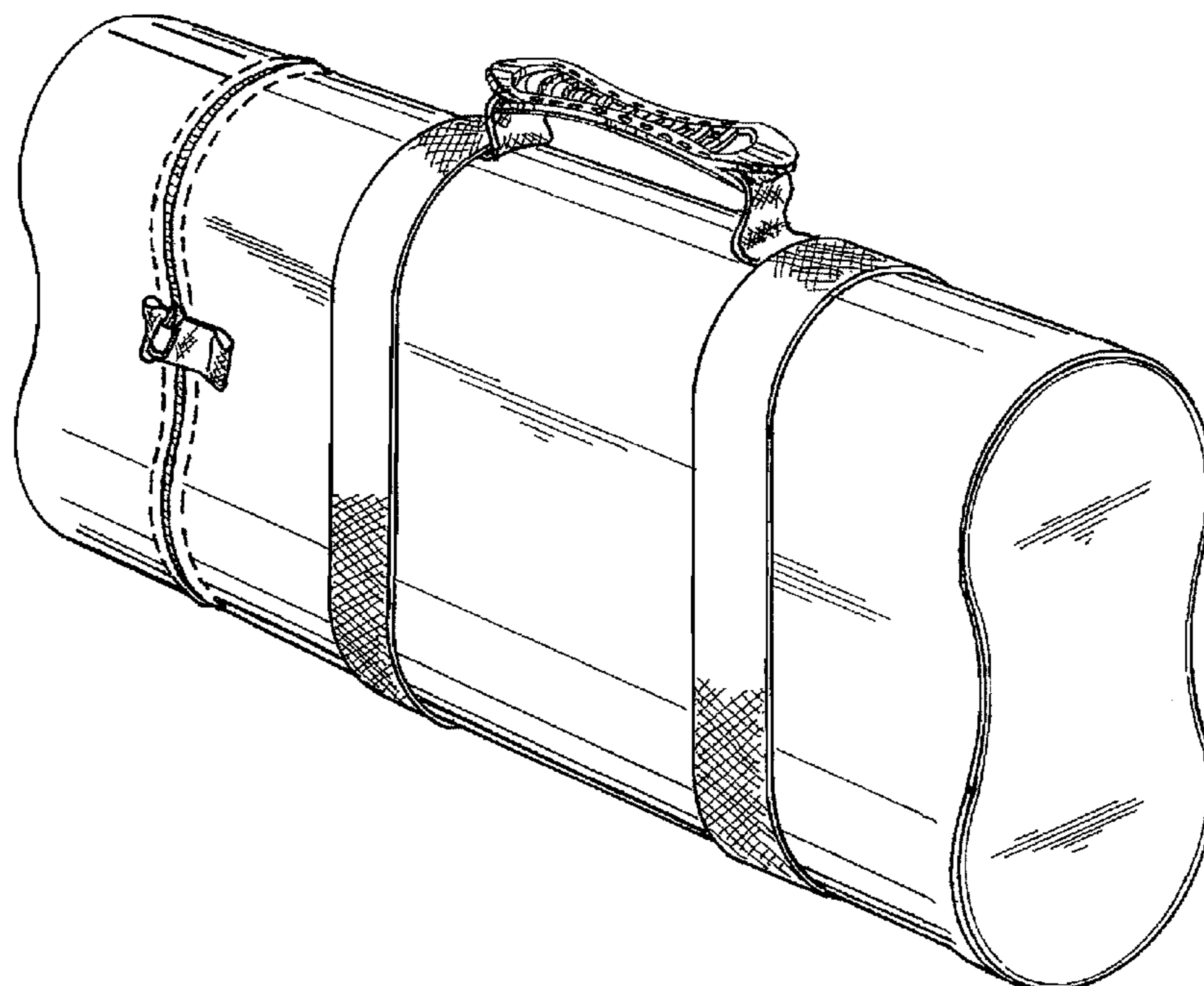

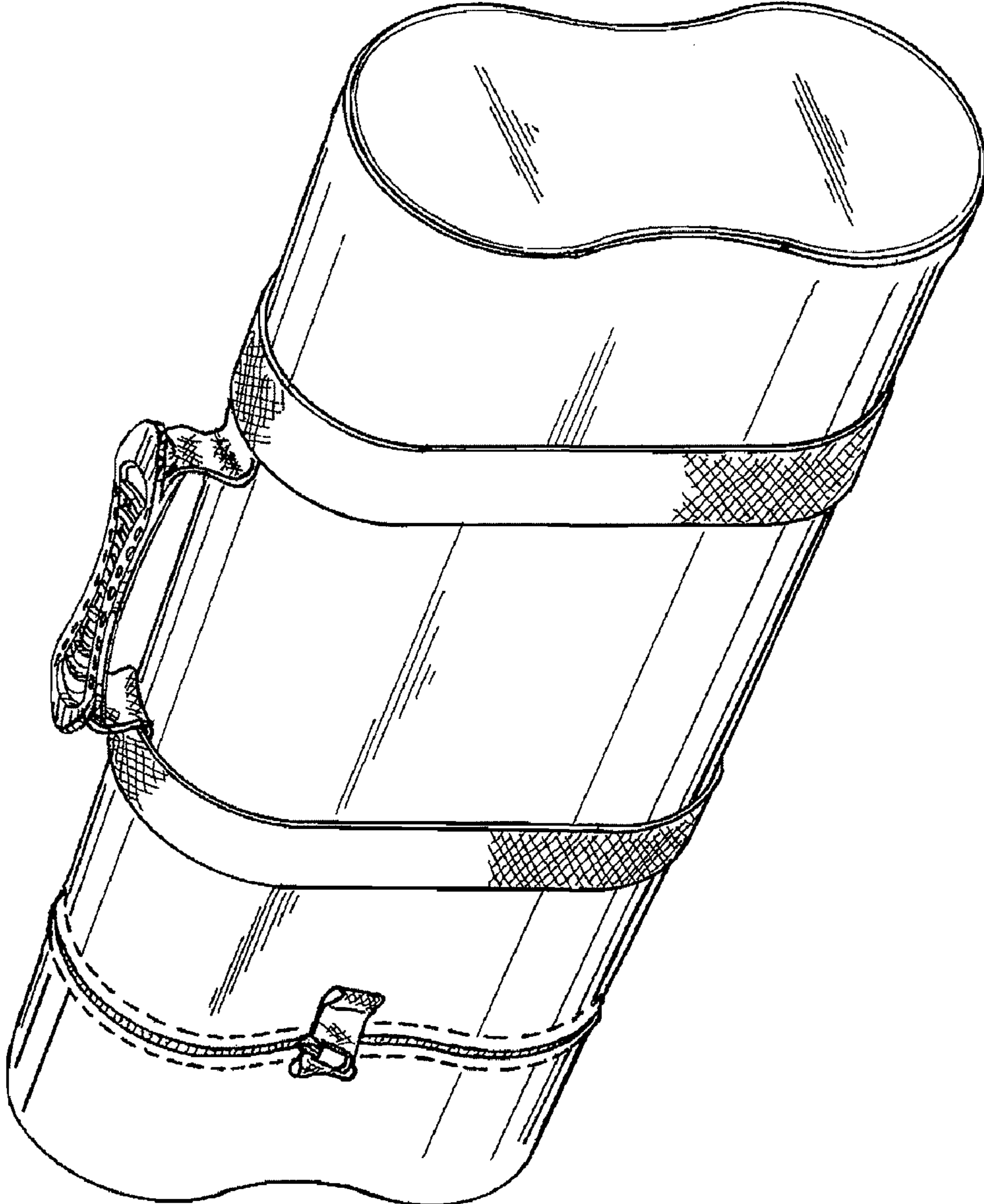

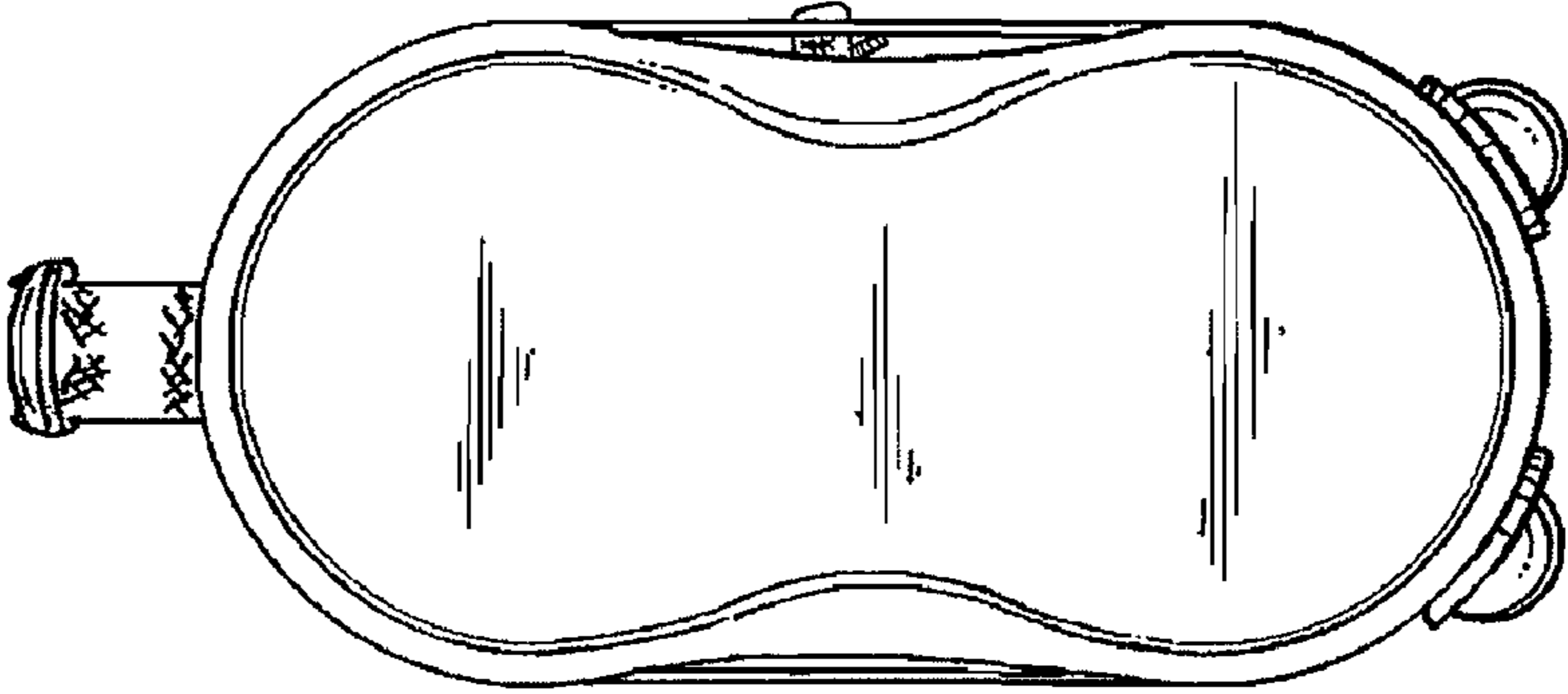

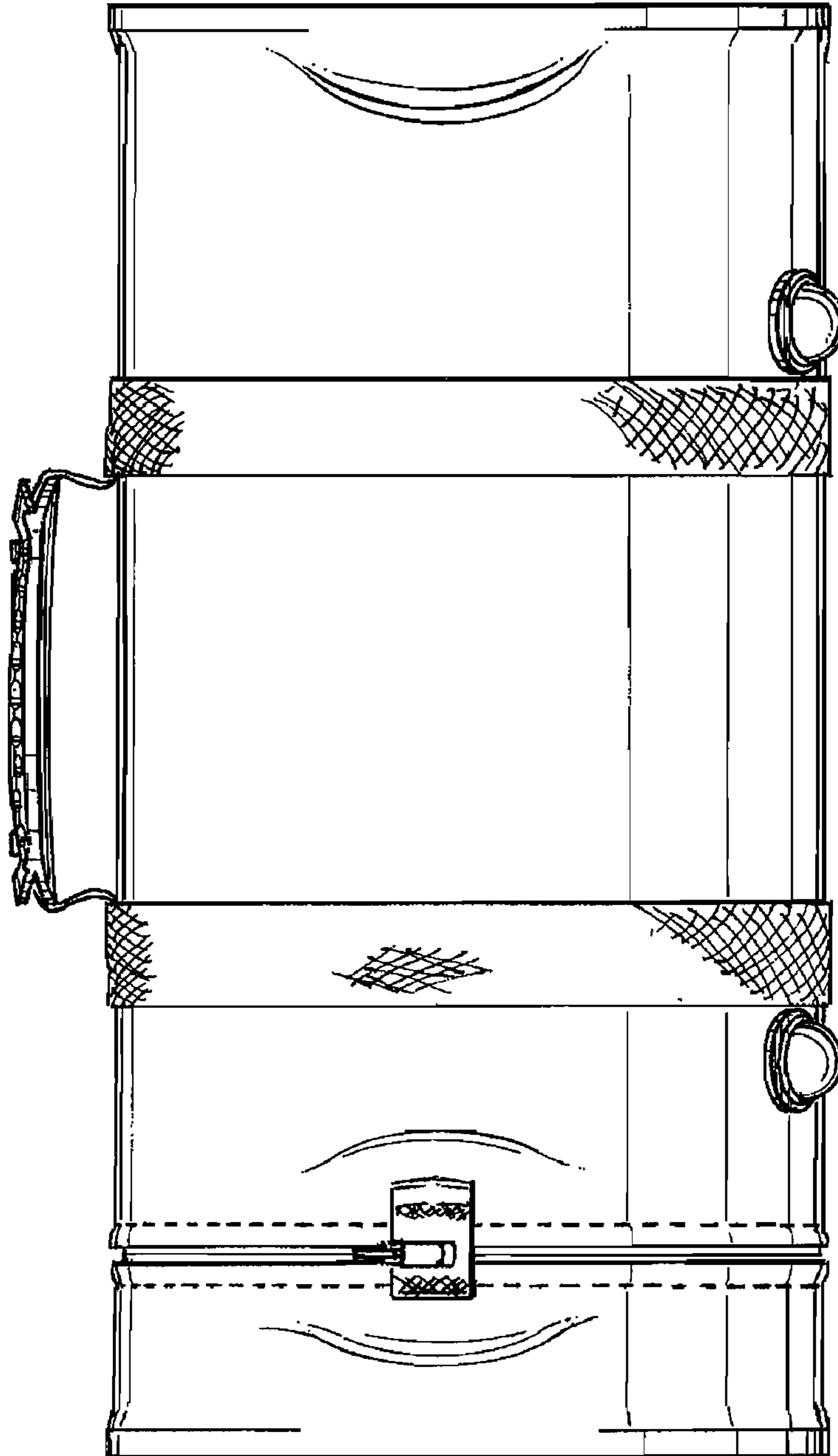

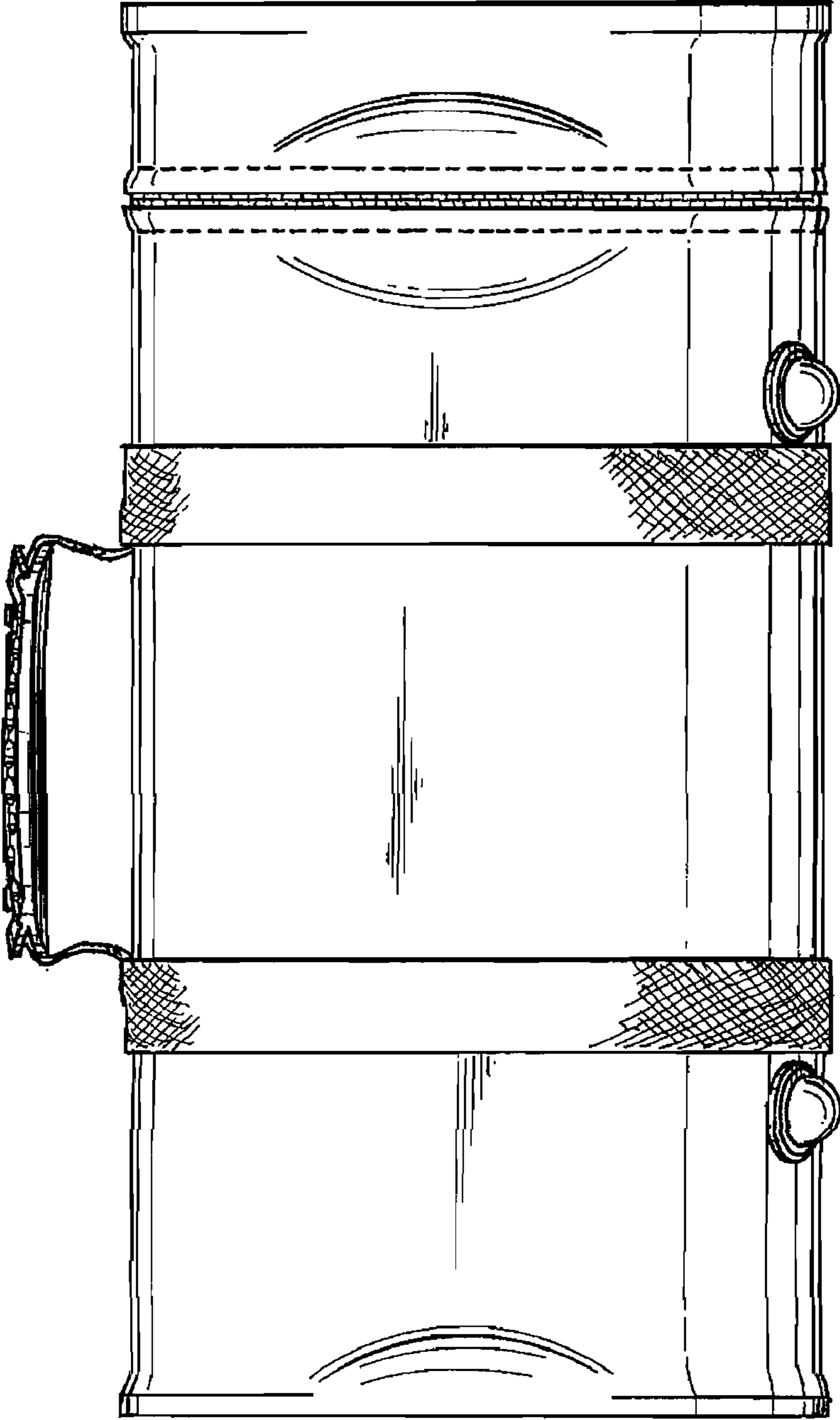

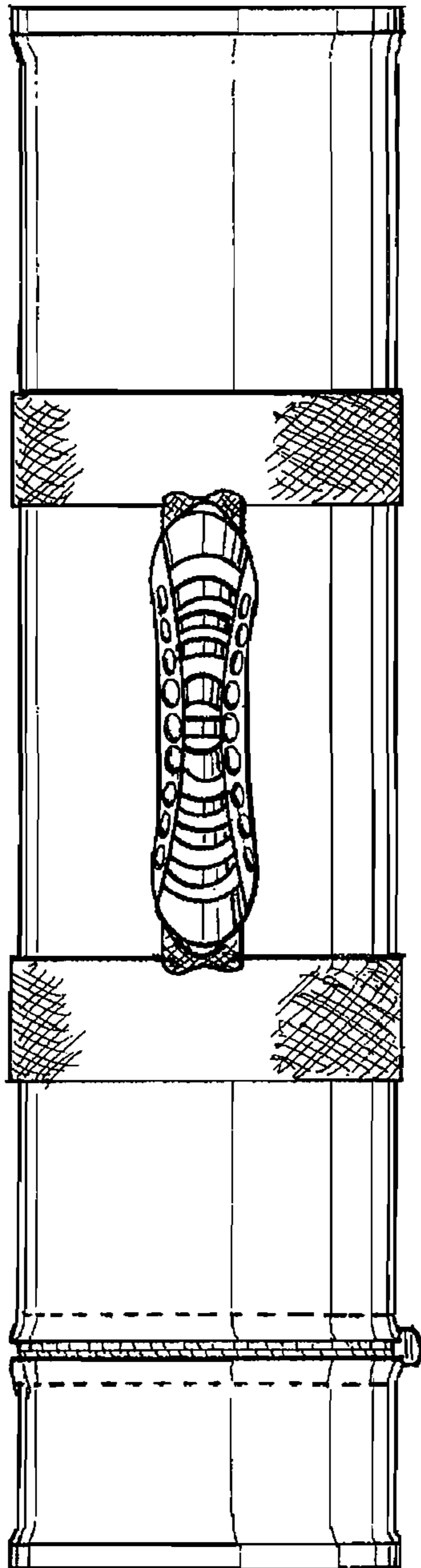

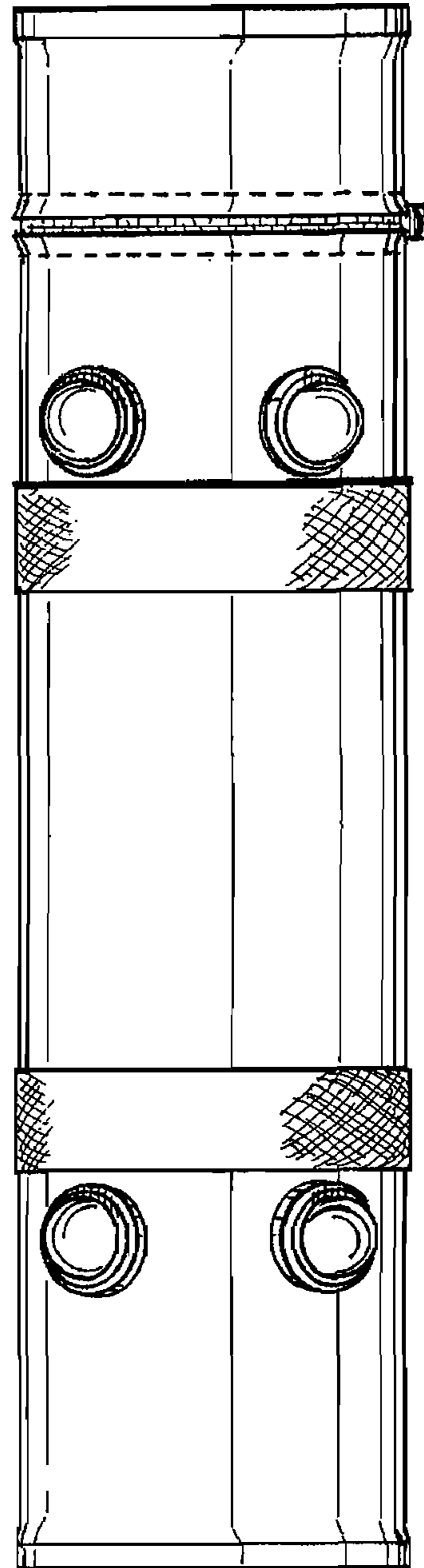
