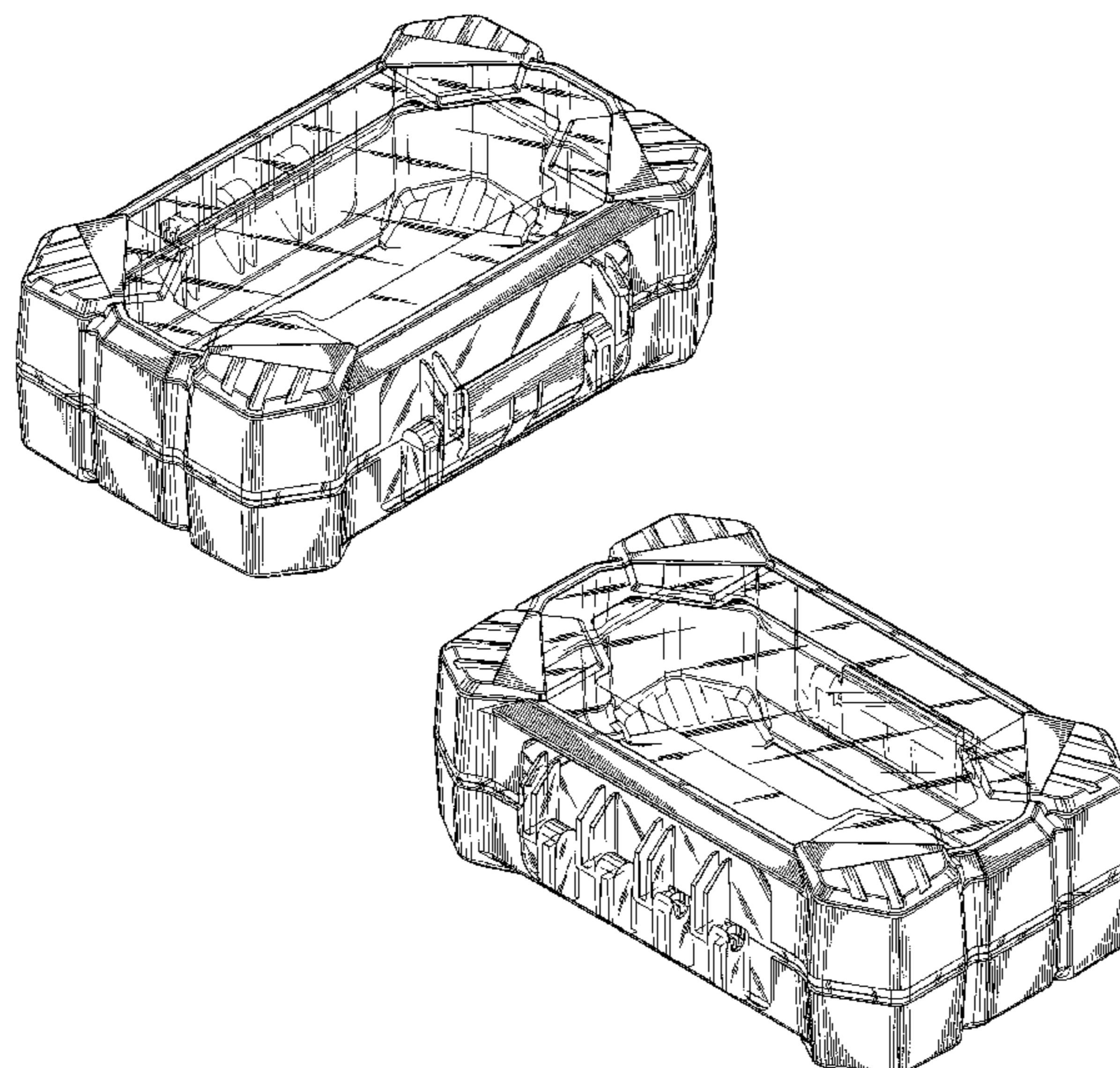
(57) **CLAIM**

The ornamental design for a tool carrying case with transparent cover, as shown.

DESCRIPTION

FIG. 1 is an isometric view of a tool carrying case with transparent cover, showing a first side;
 FIG. 2 is an isometric view of the tool carrying case with transparent cover of FIG. 1, showing a second side;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a side elevation view thereof, showing the first side;
 FIG. 6 is a side elevation view thereof, showing the second side;
 FIG. 7 is an end elevation view thereof; and,
 FIG. 8 is a second end elevation view thereof.

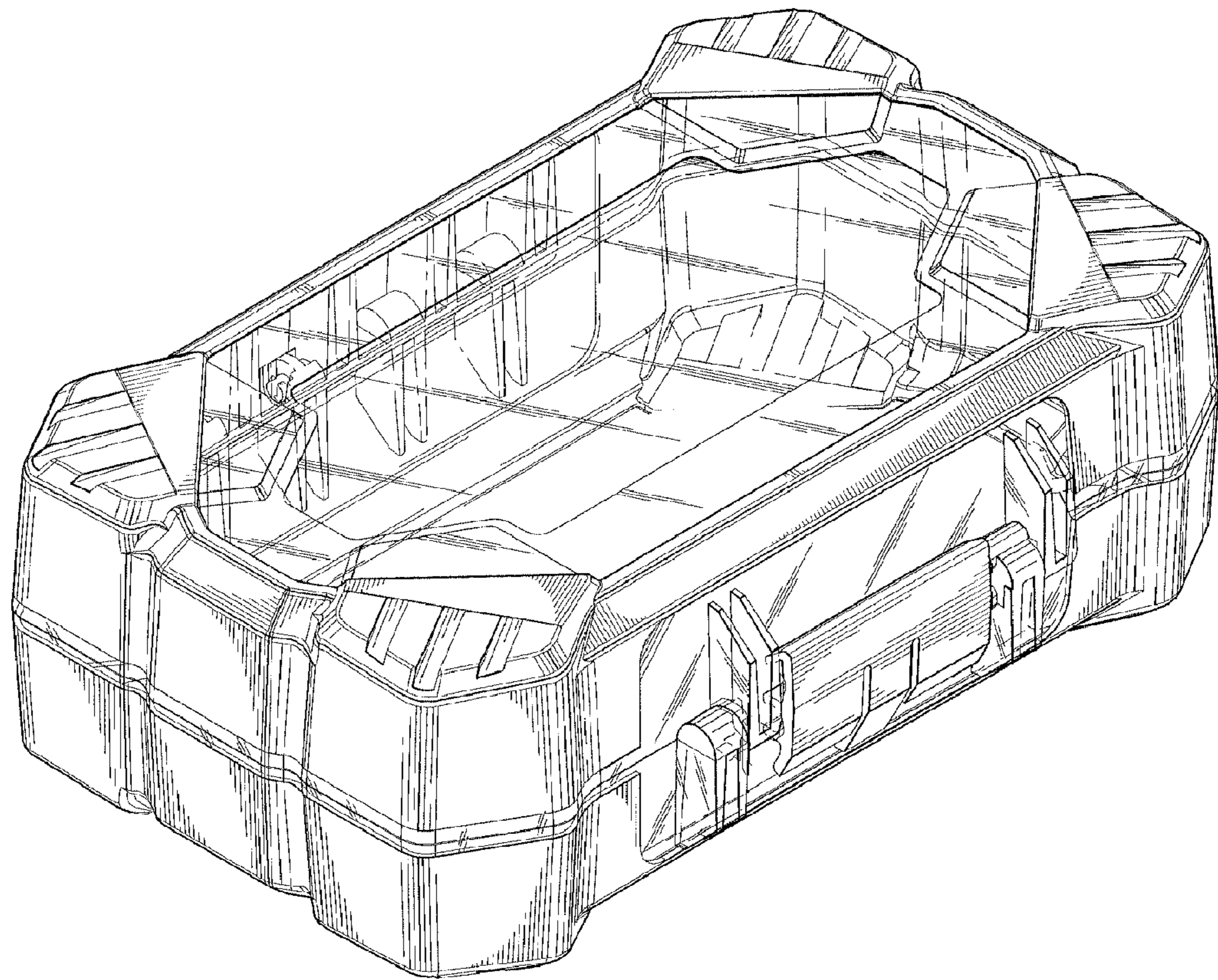

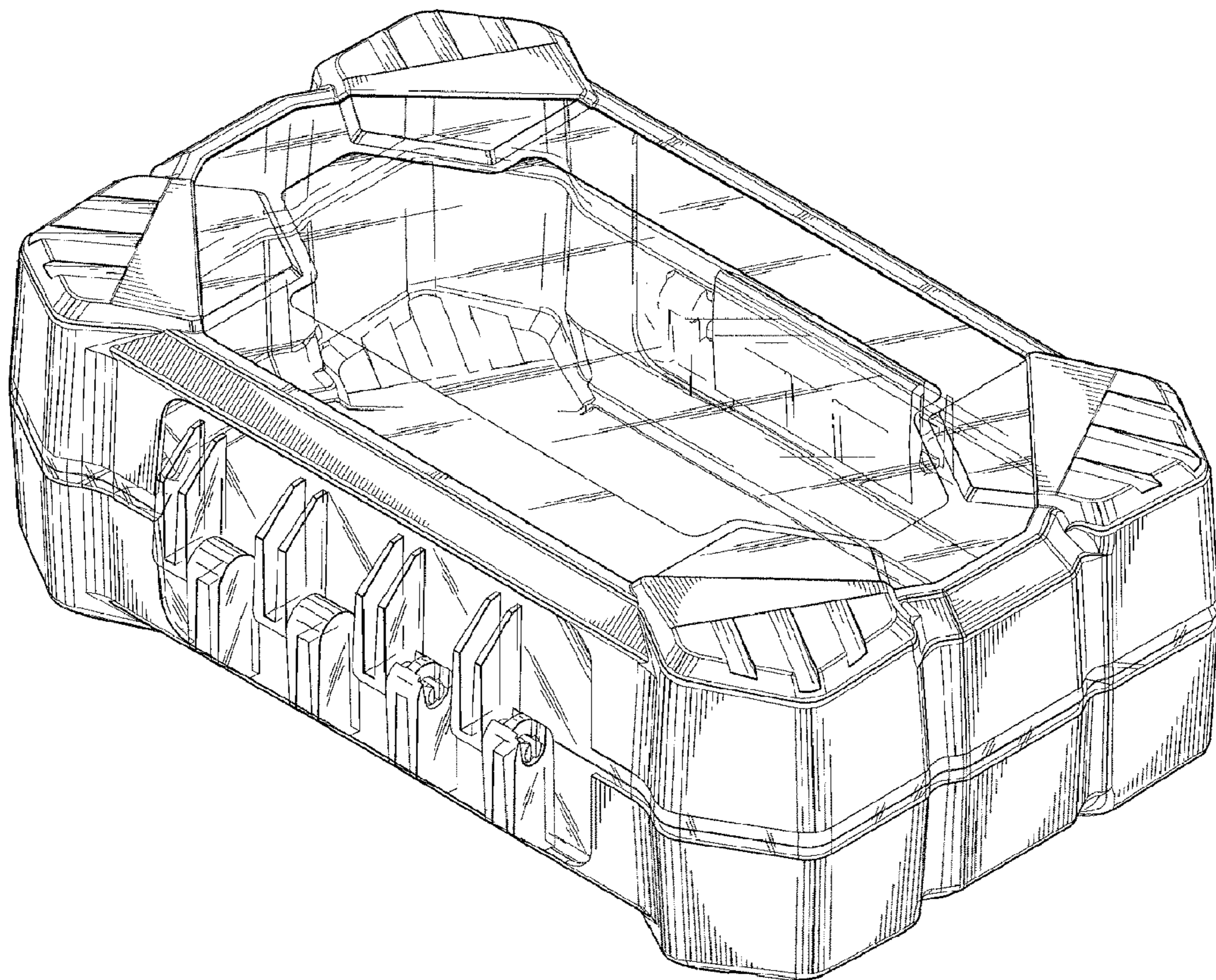

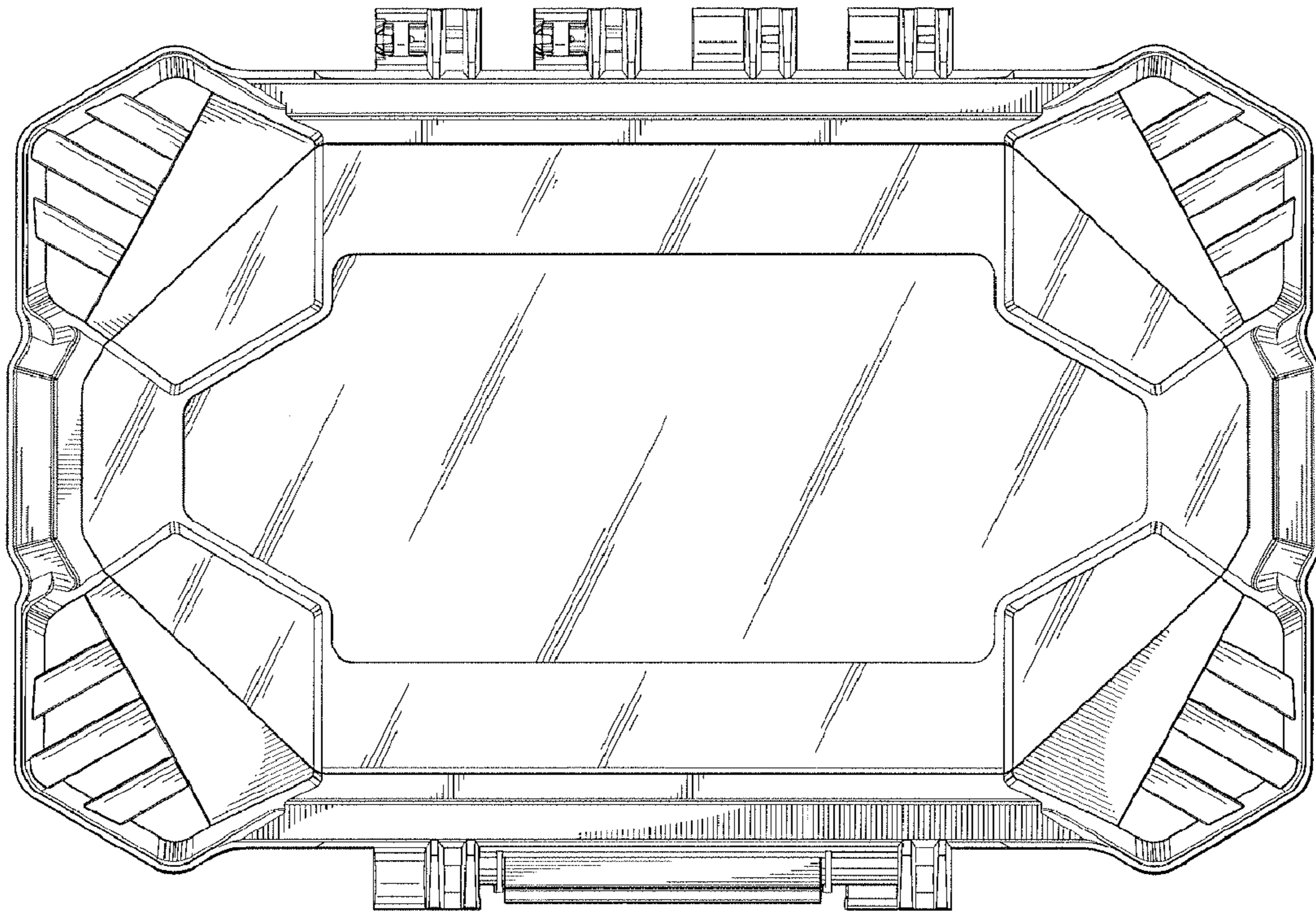

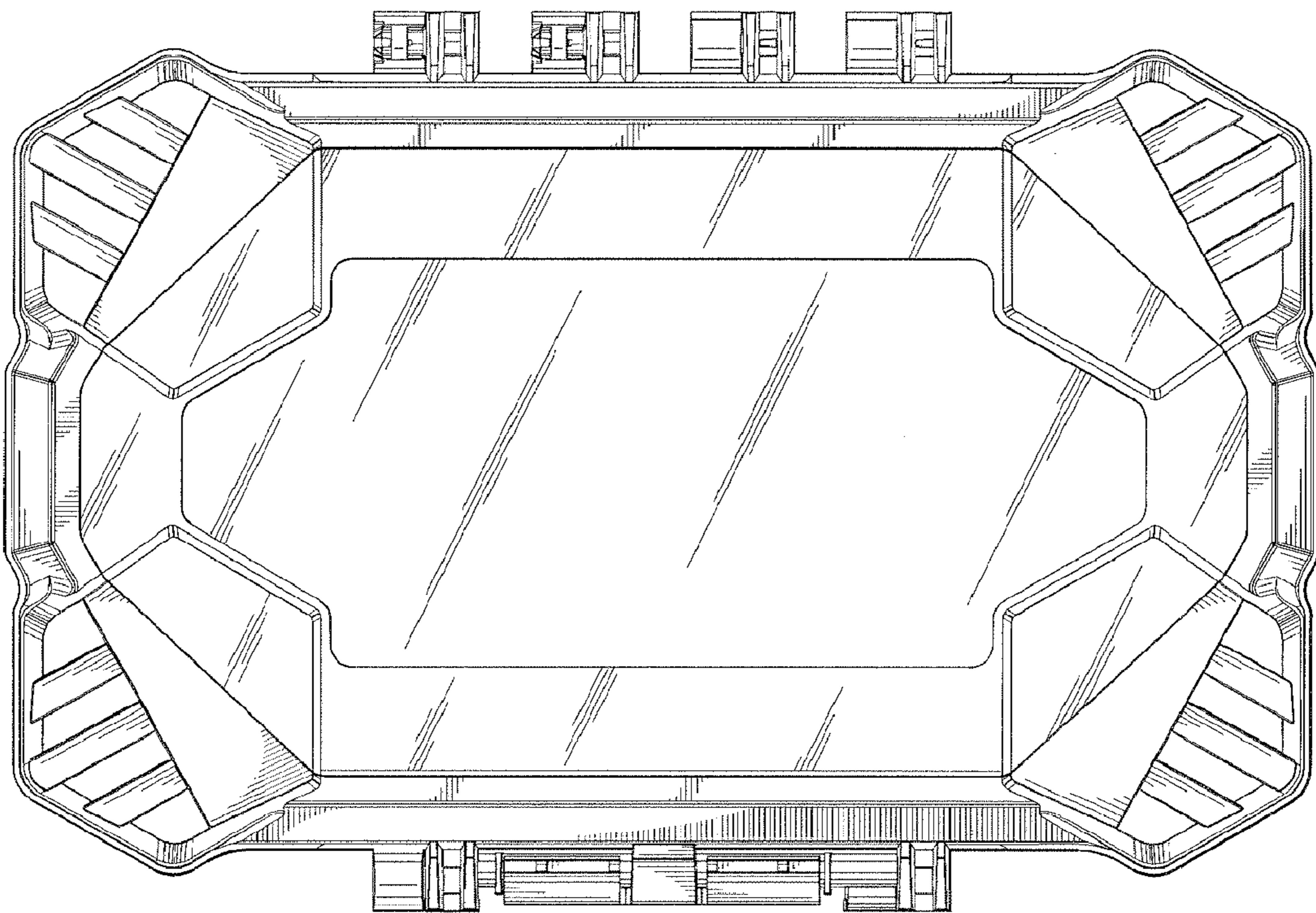

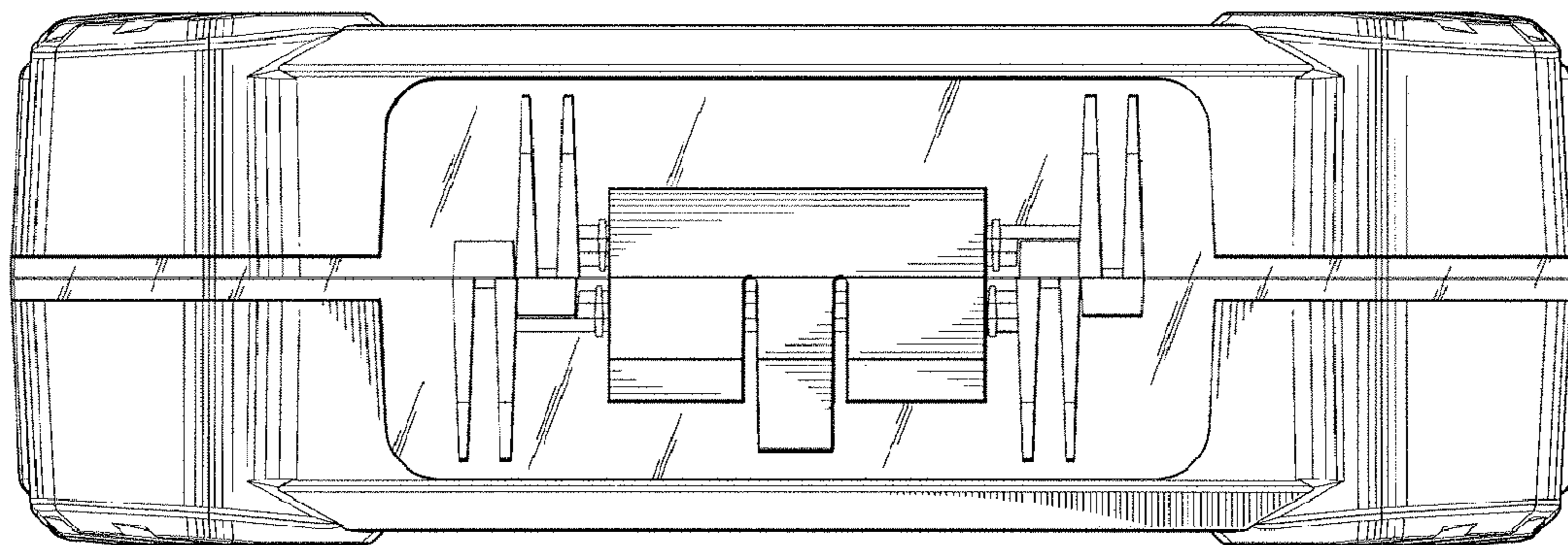

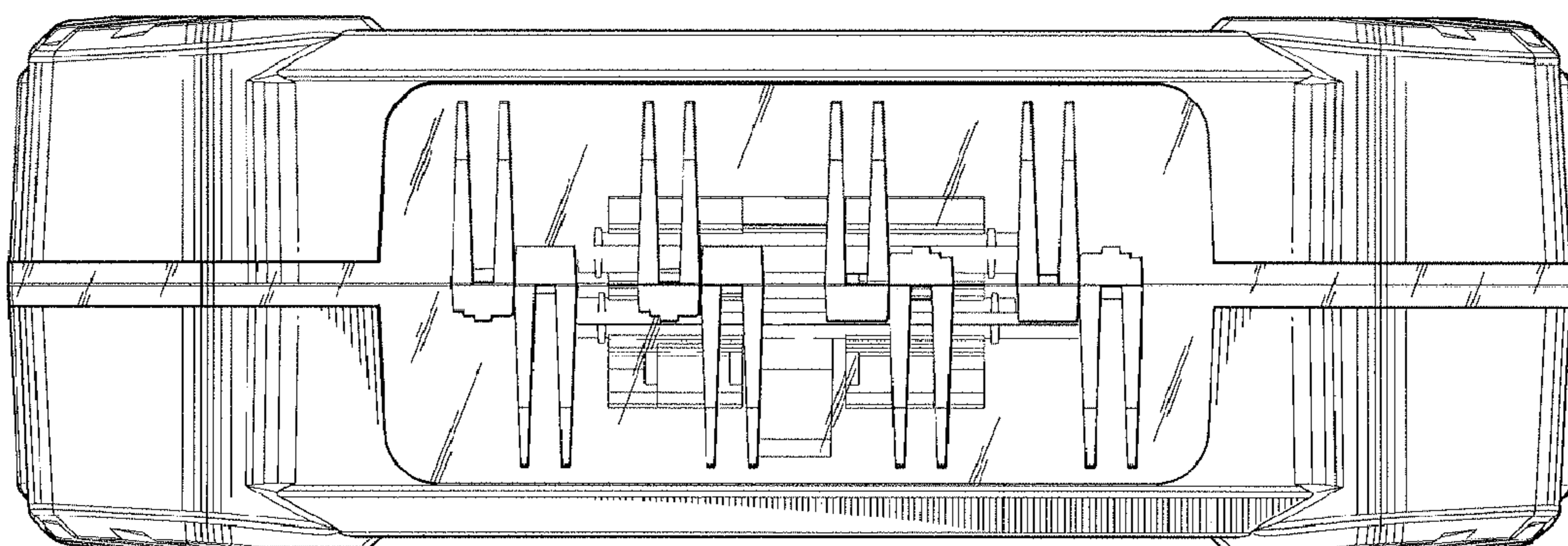

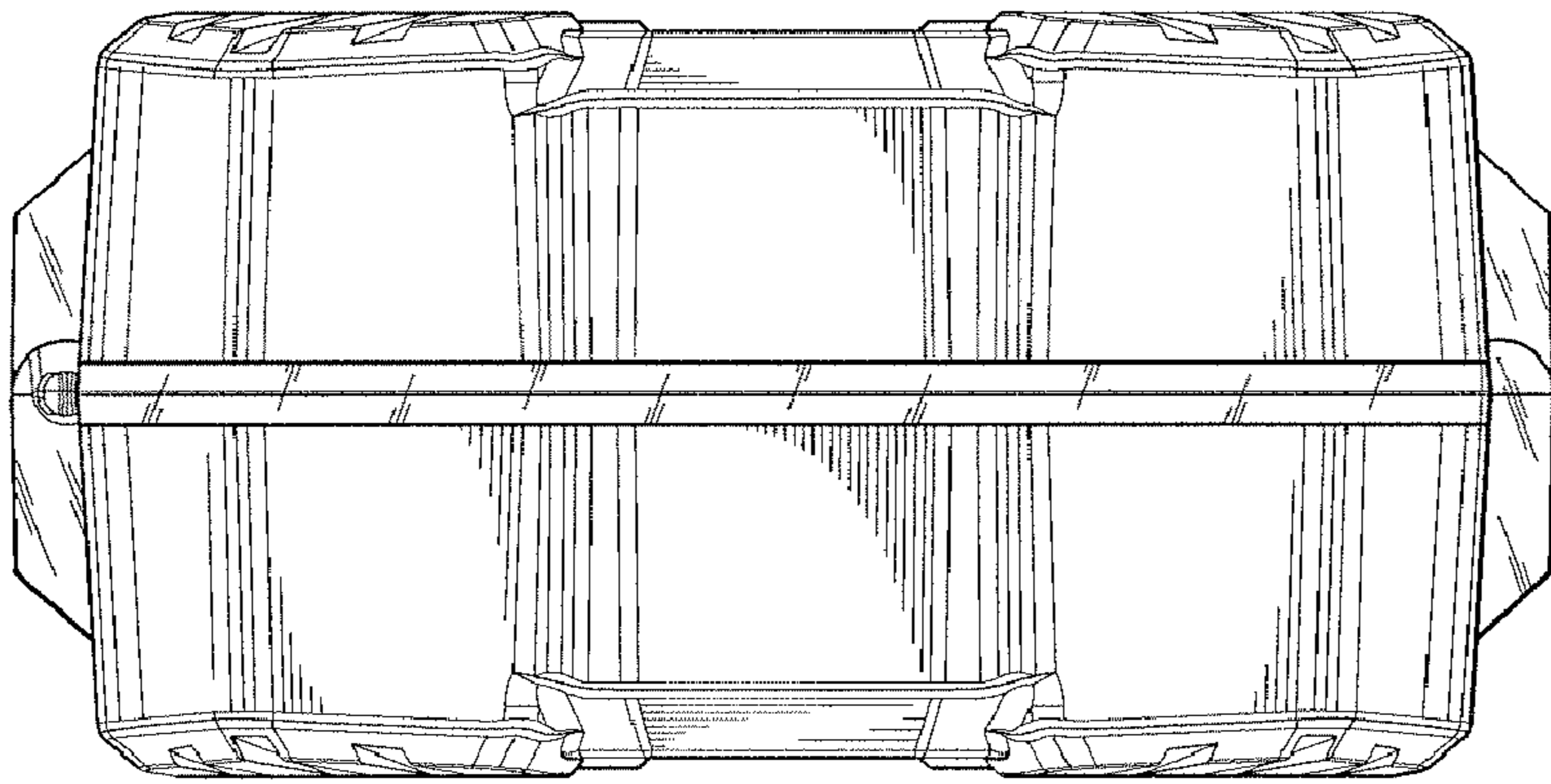

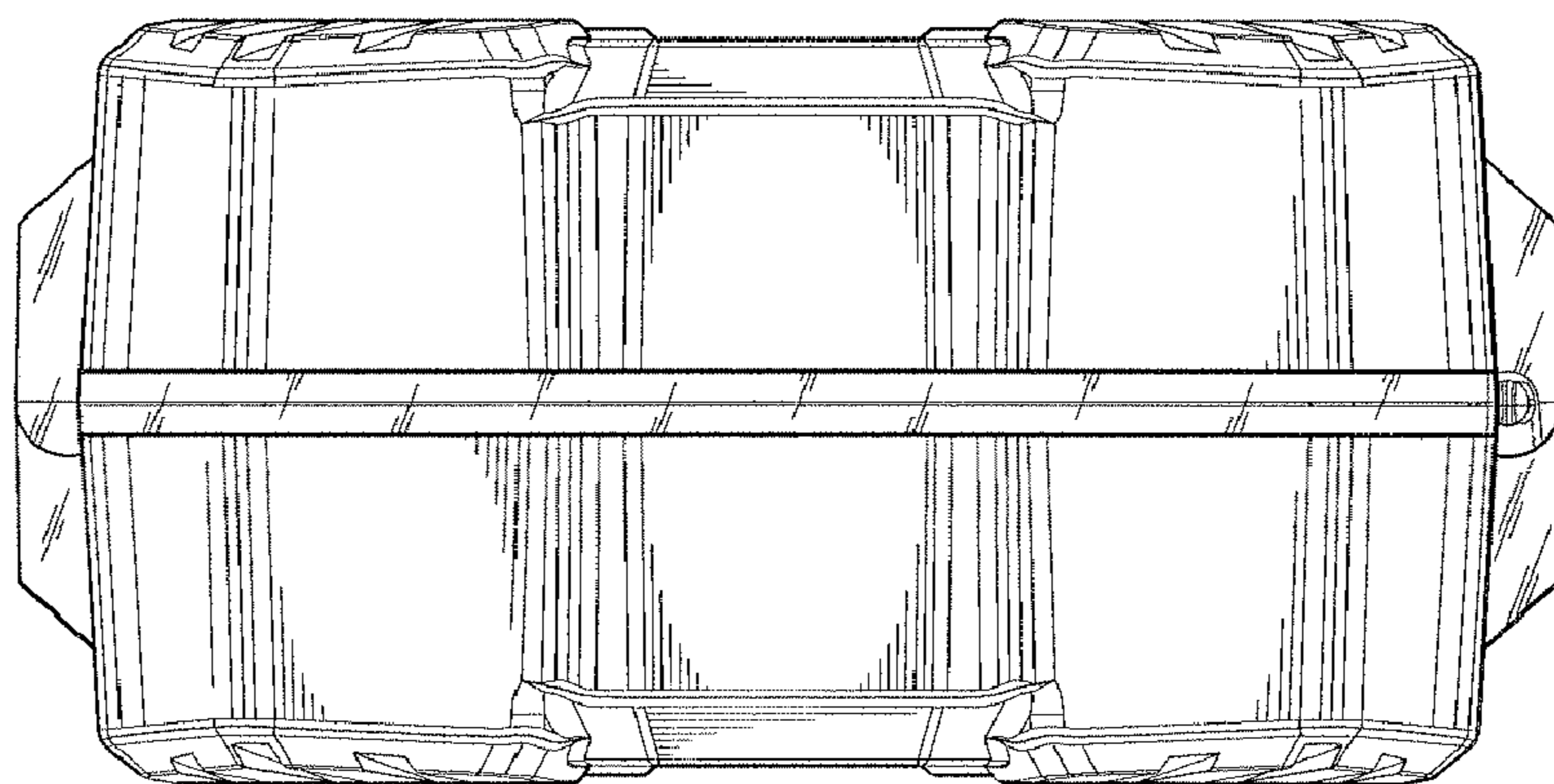
