The ornamental design for a hanger expansion hook, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the claimed design of a hanger expansion hook;

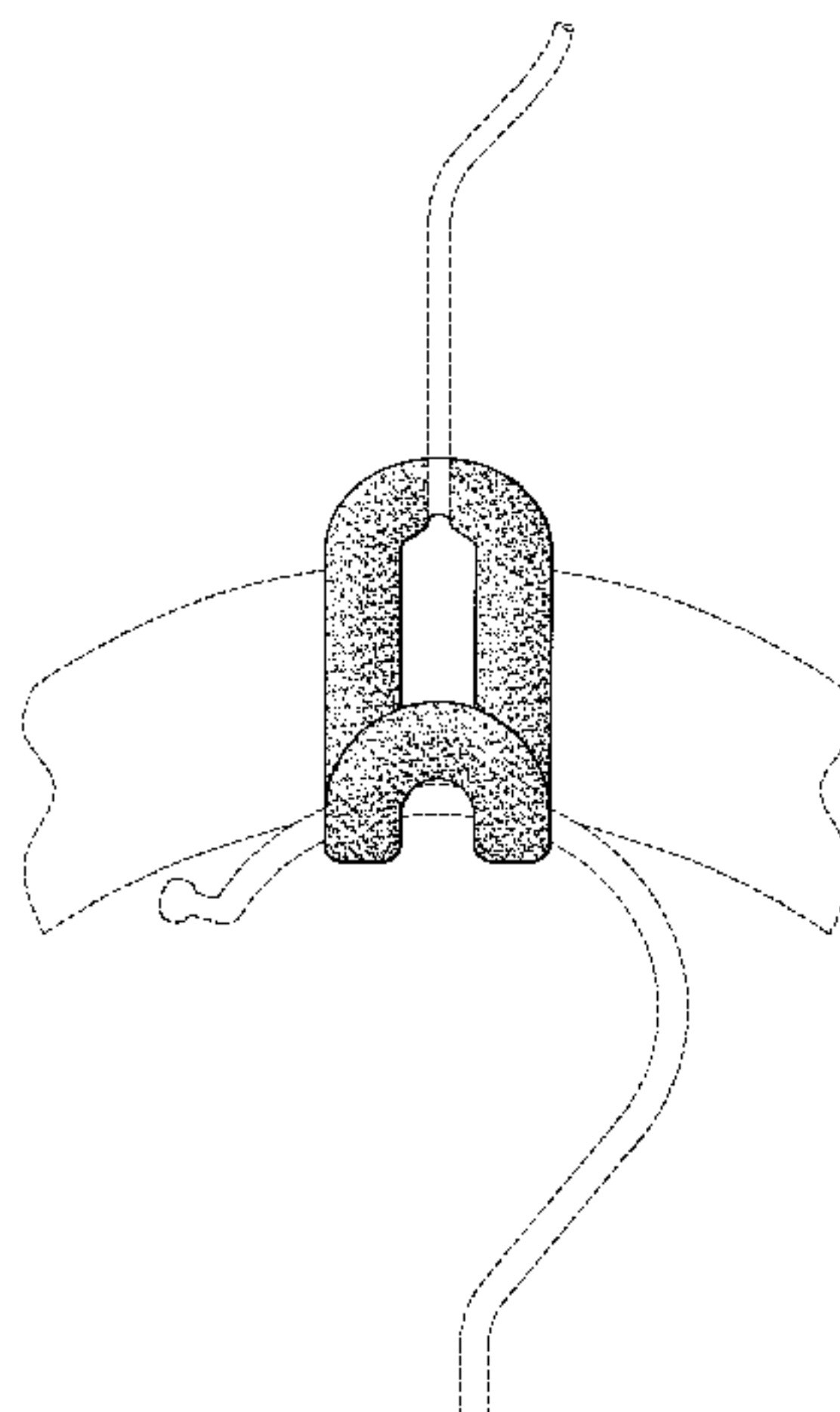
FIG. 2 is a side view thereof, the opposite side being a mirror image;

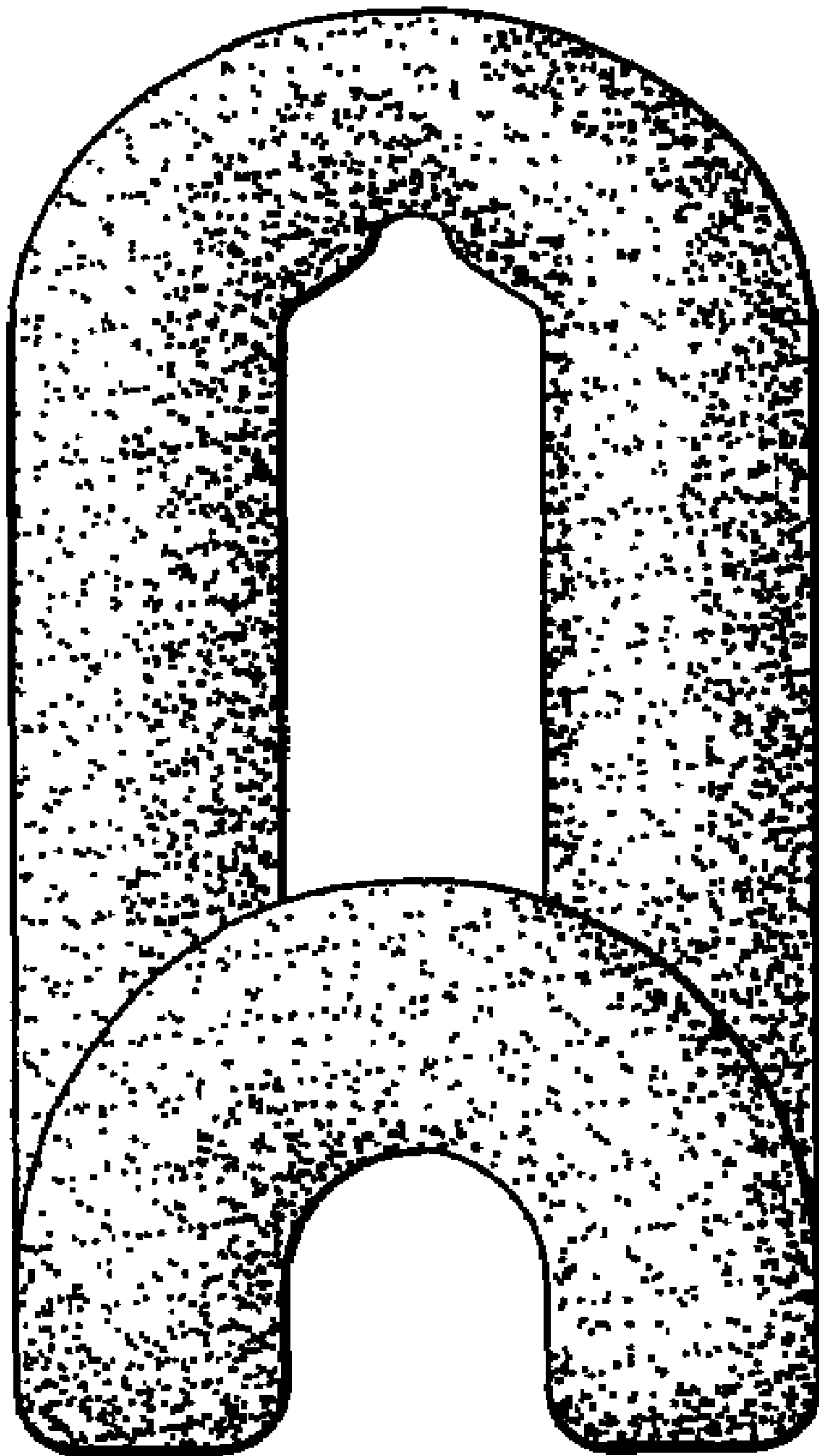

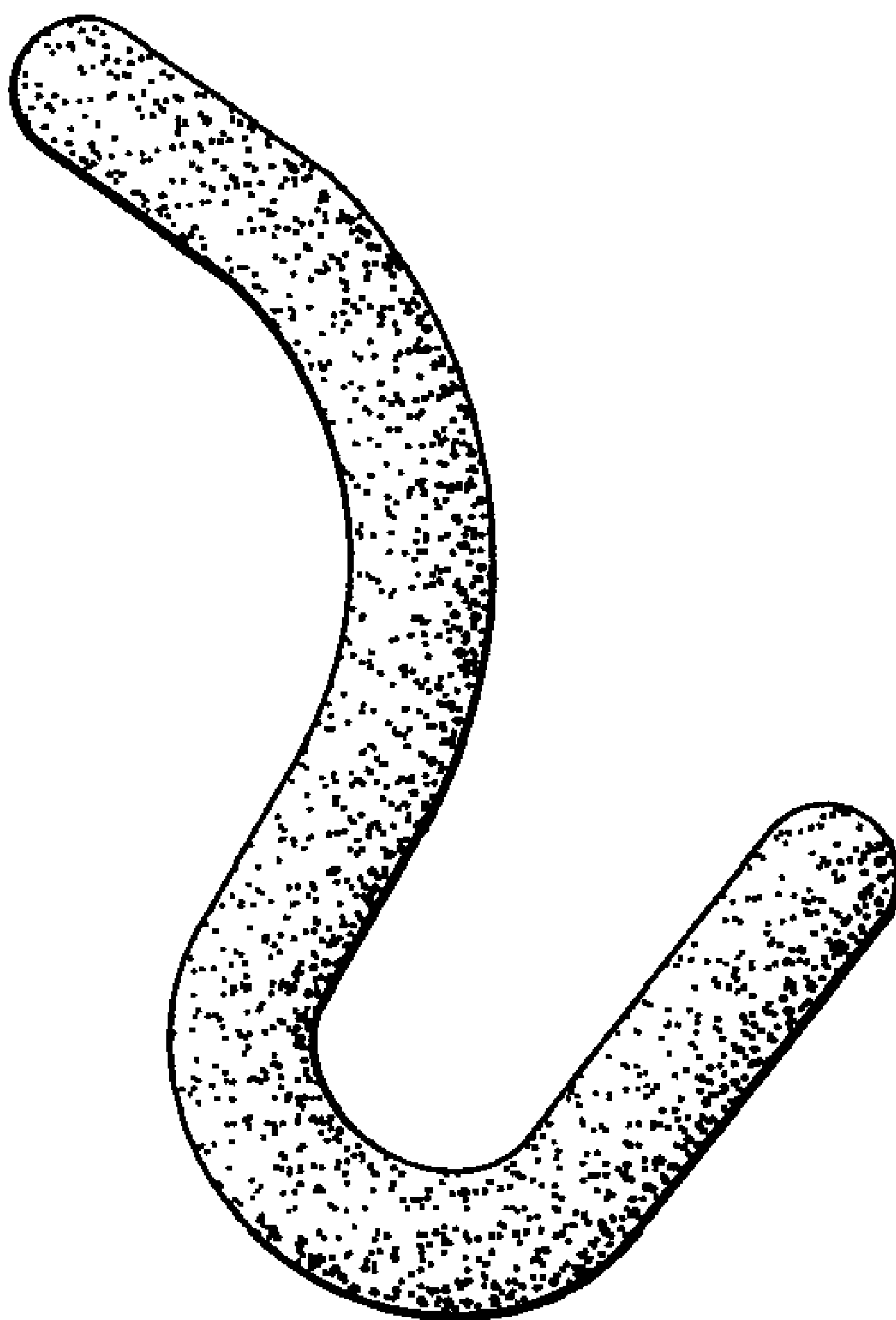

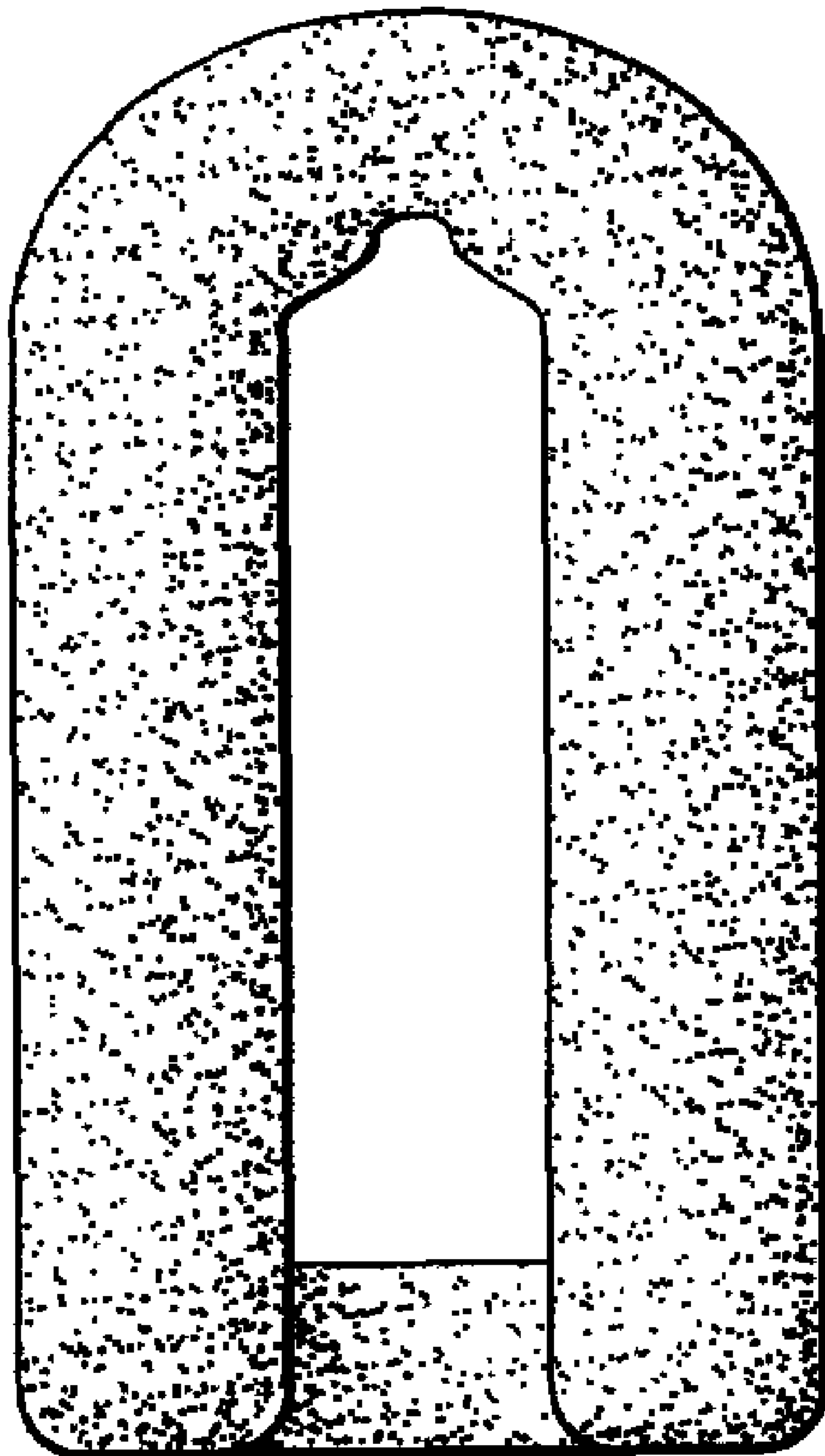
