(57) **CLAIM**

I claim the design for a handle for a saw, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation side view of a handle for a saw showing my new design, wherein the dotted line showing of saw blade is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a left side view thereof, drawn without the dotted lines;

FIG. 5 is a rear view thereof; and,

FIG. 6 is a bottom view thereof.

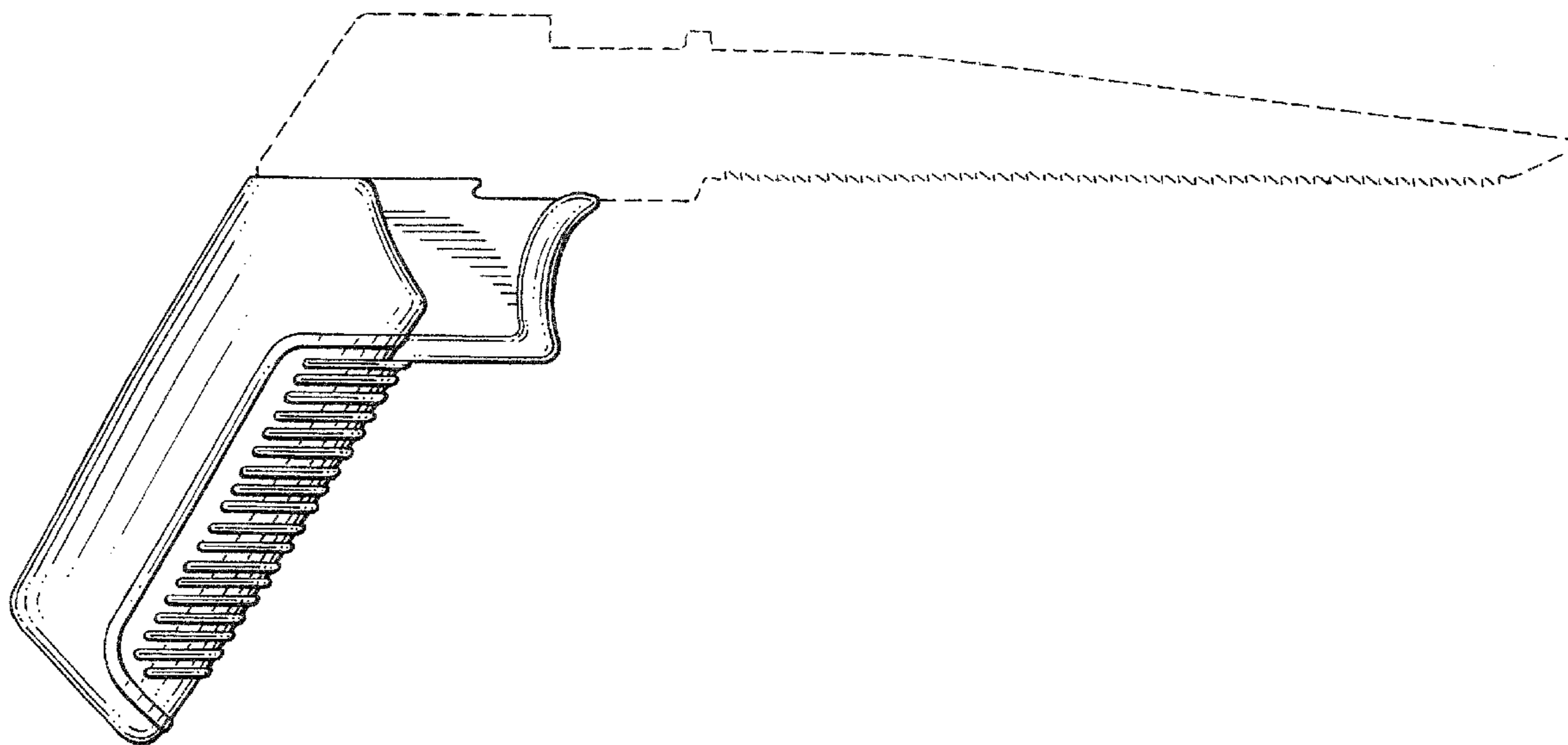

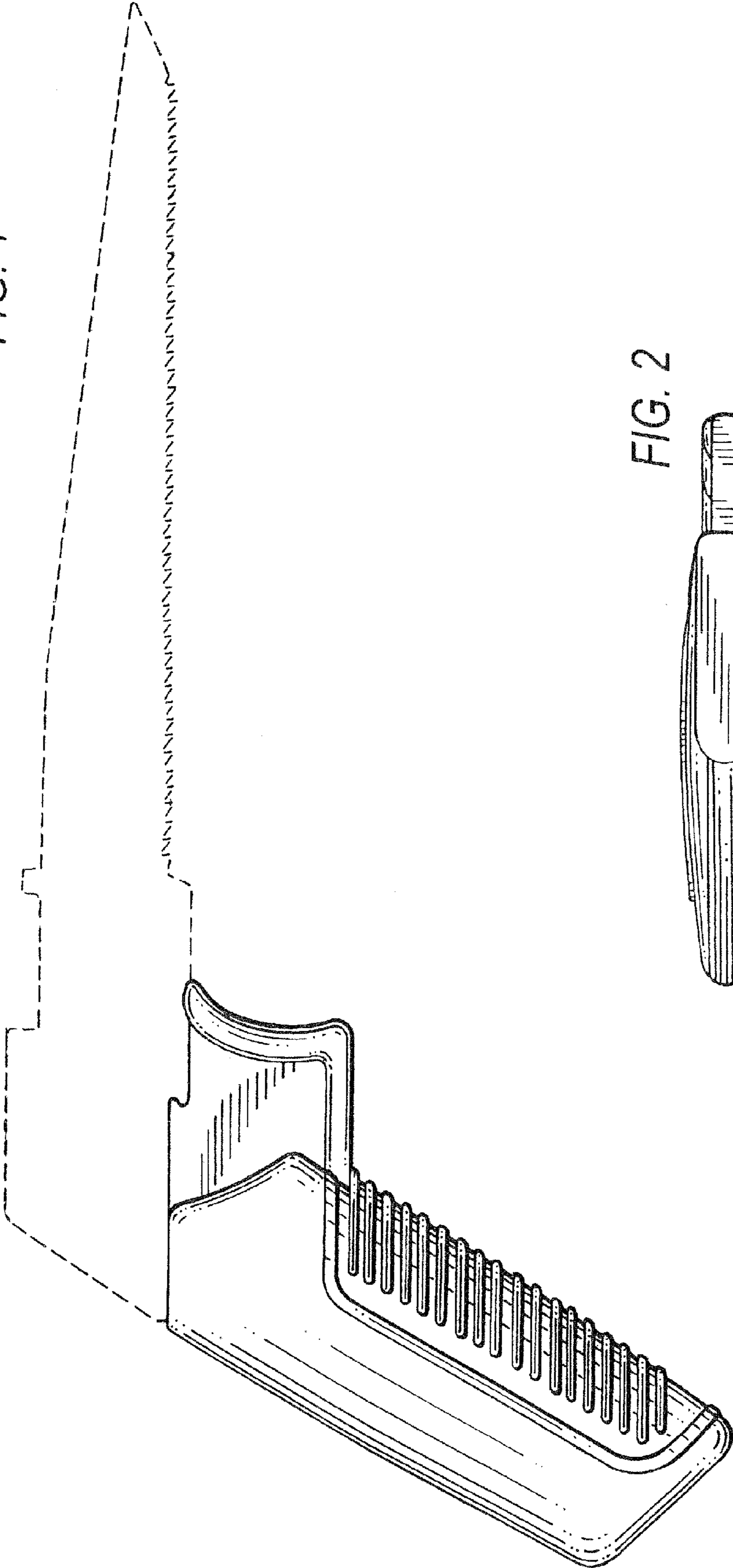

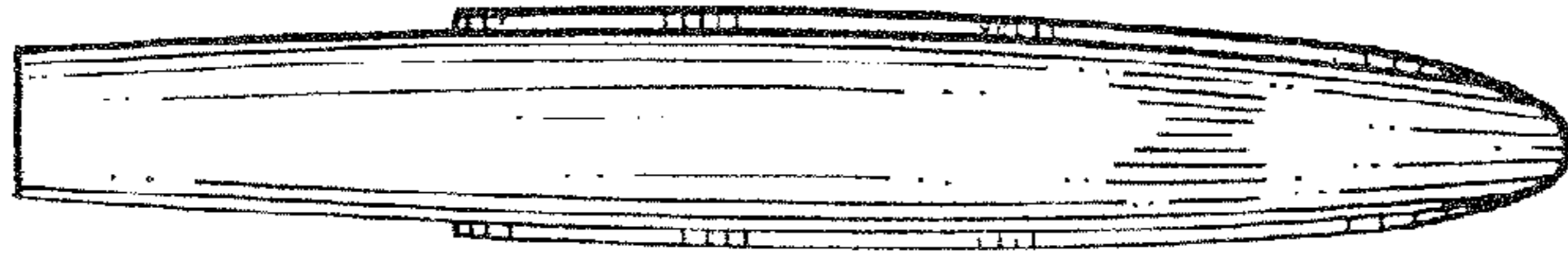

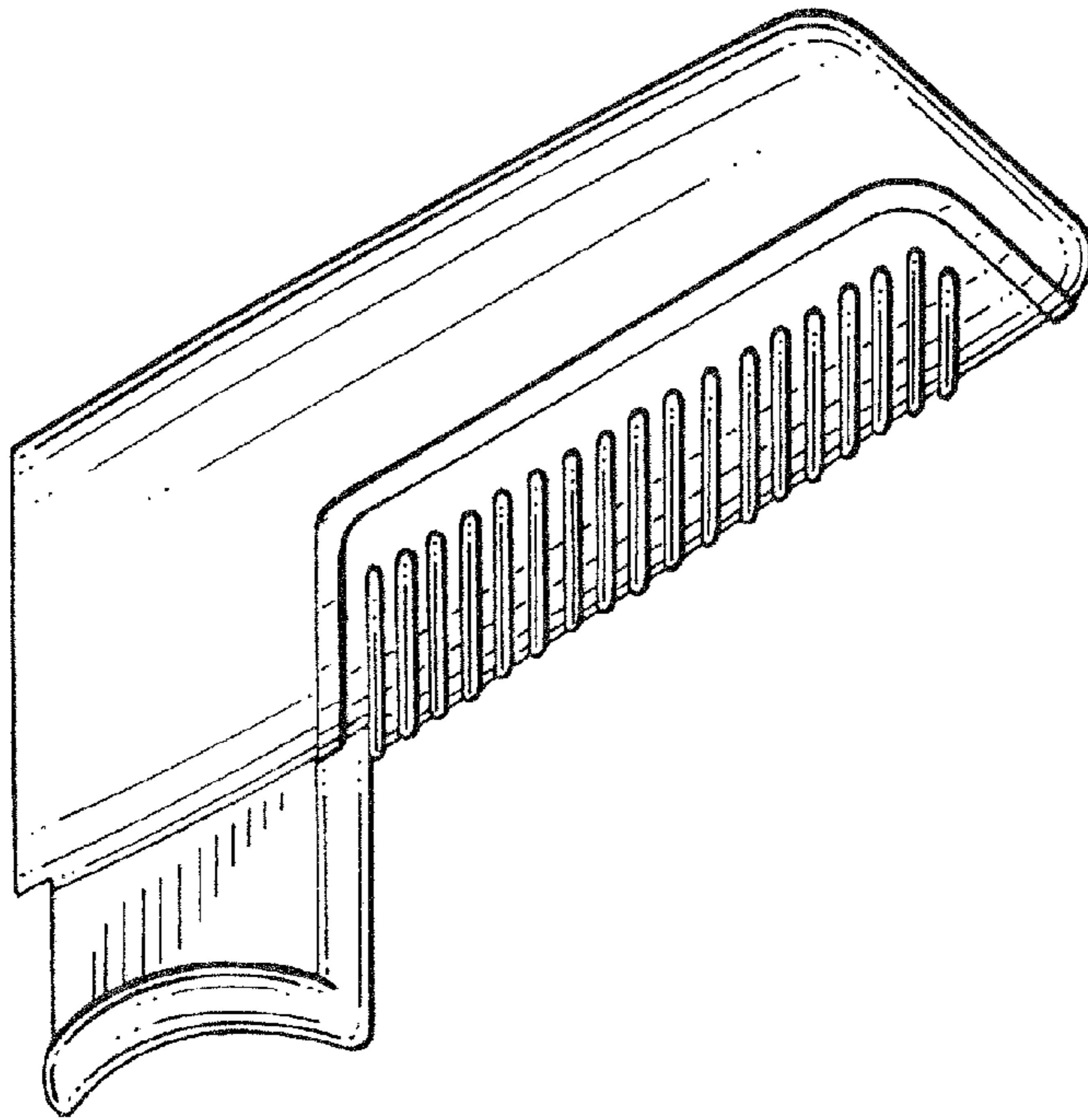

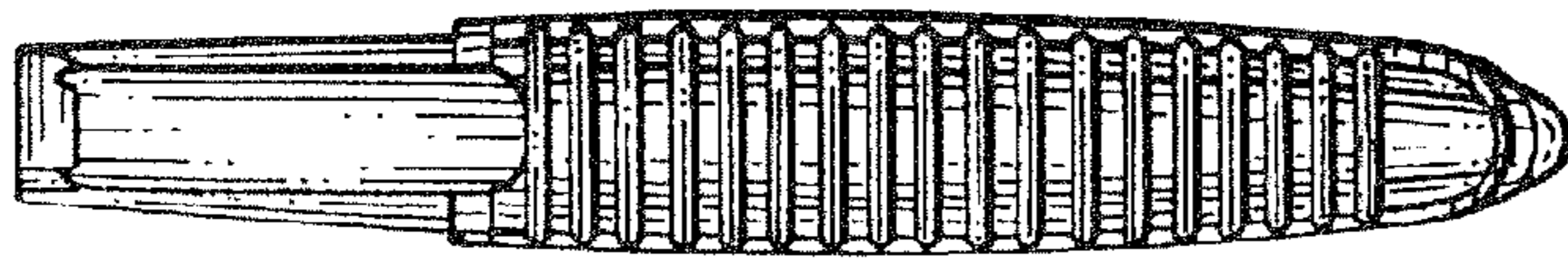
